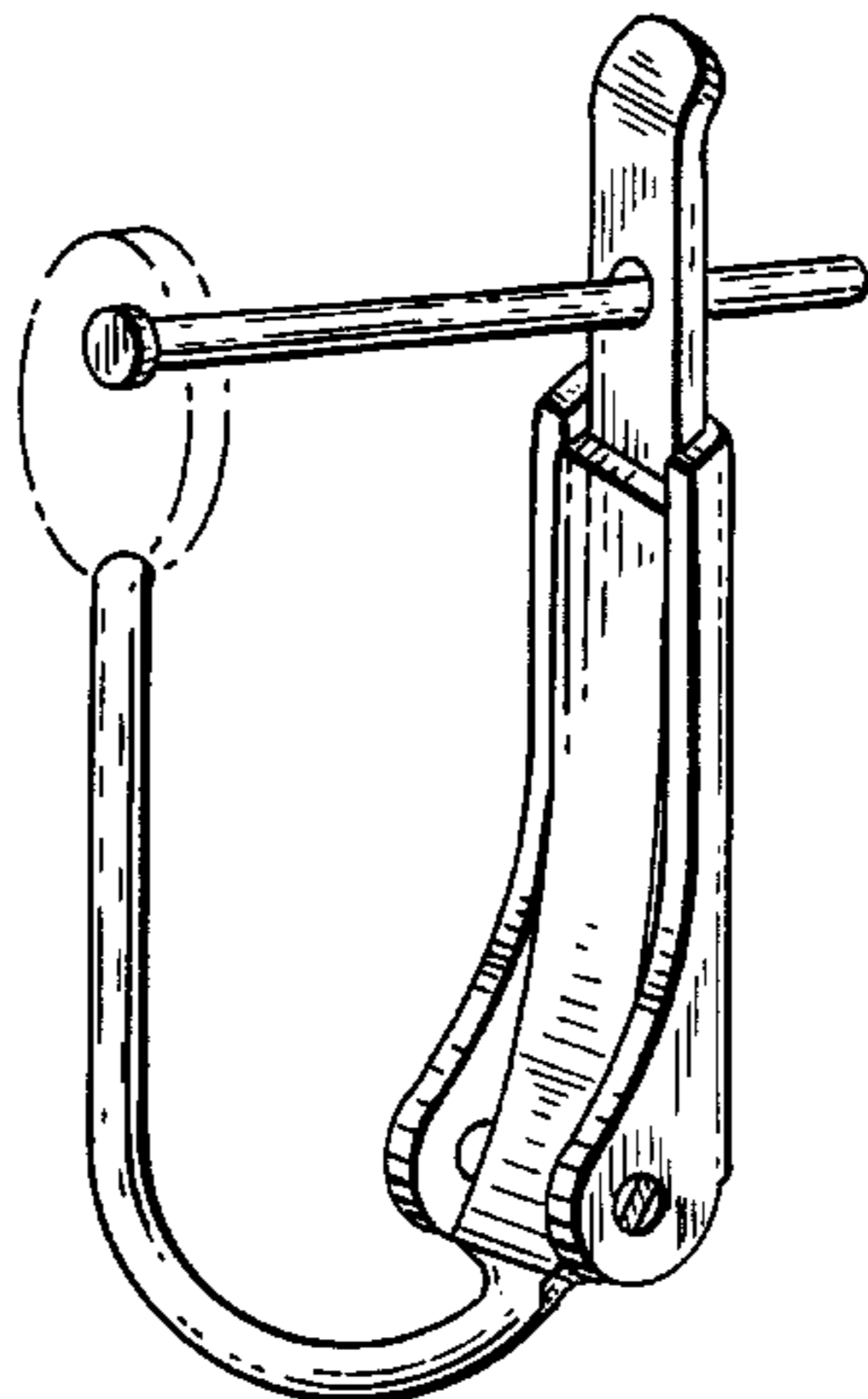

[57] CLAIM

The ornamental design of a, earring clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an earring clip embodying the present invention;
FIG. 2 is a side elevational view thereof;
FIG. 3 is an end view of the clip taken from the left of FIG. 2;
FIG. 4 is an end view of the clip taken from the right of FIG. 2;
FIG. 5 is a top plan view; and,
FIG. 6 is a bottom plan view.



The broken line showing in FIGS. 1-6 is illustrative of environmental structure only and forms no part of the claimed design.

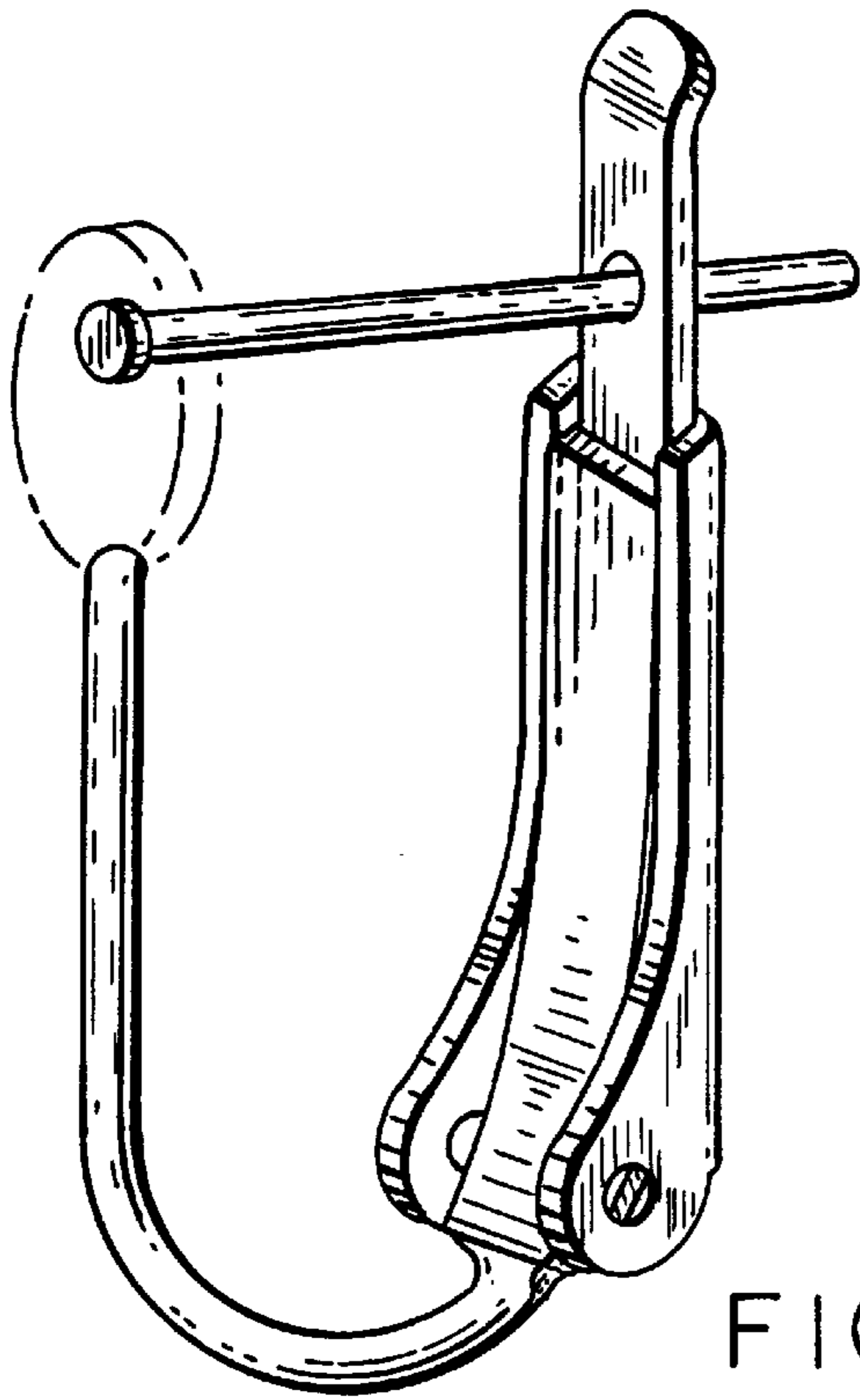

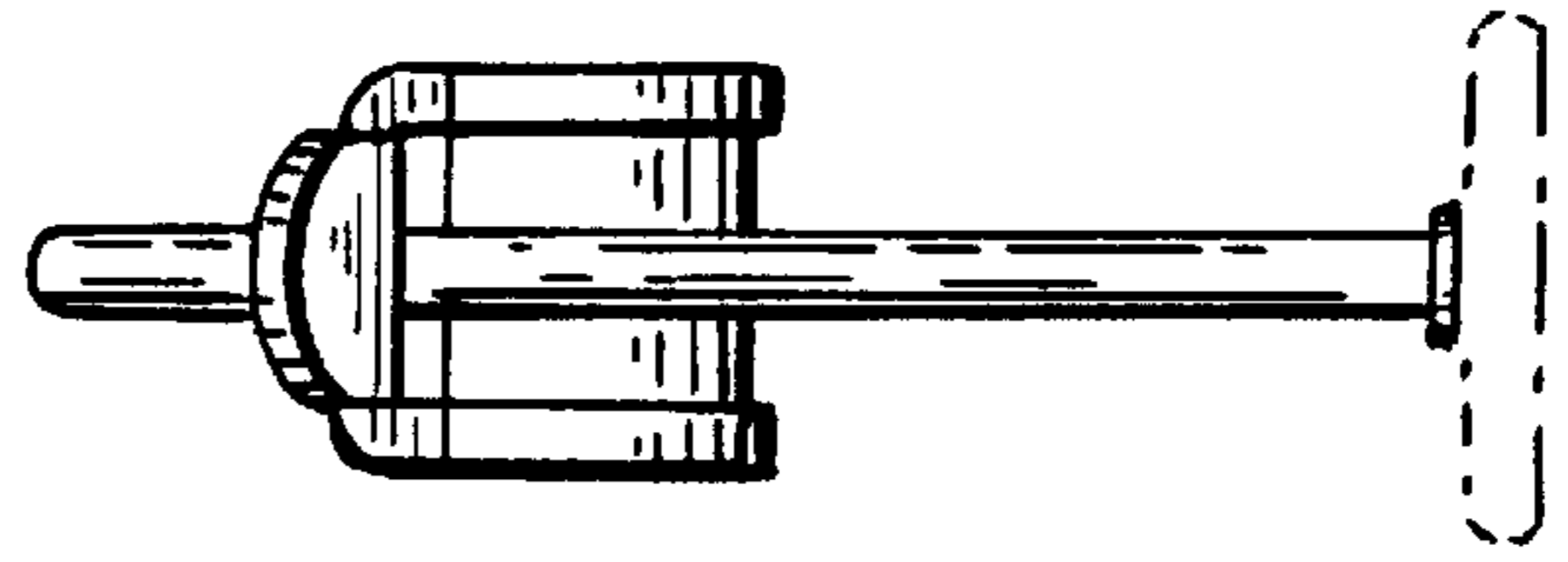

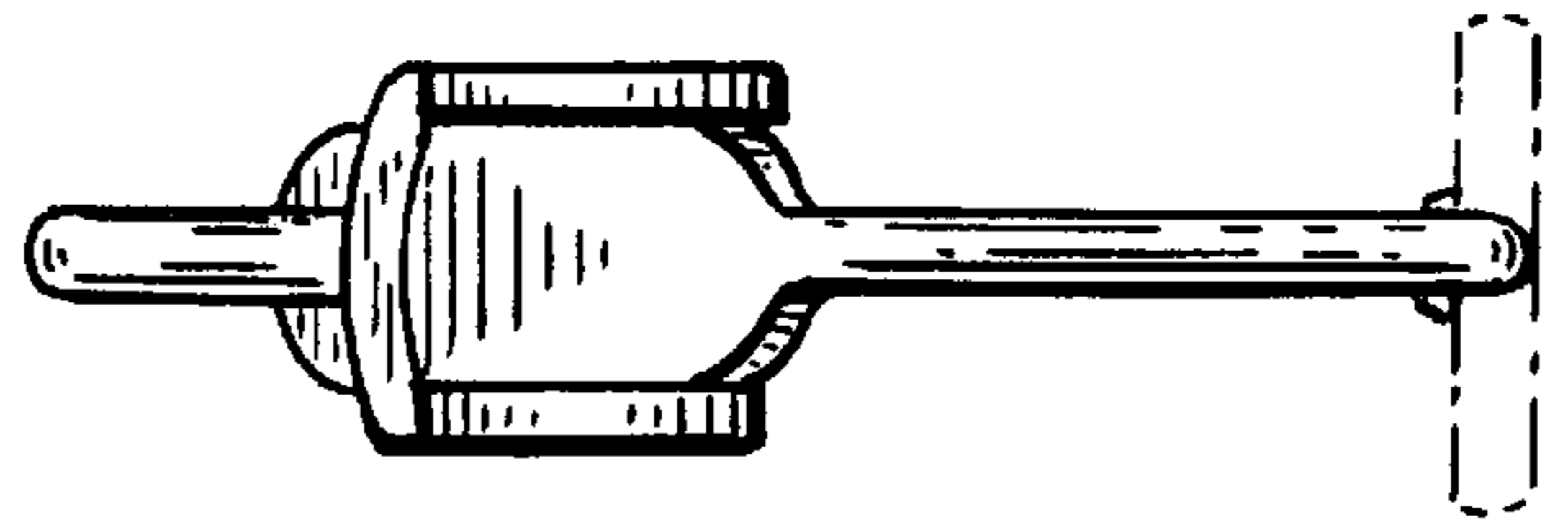

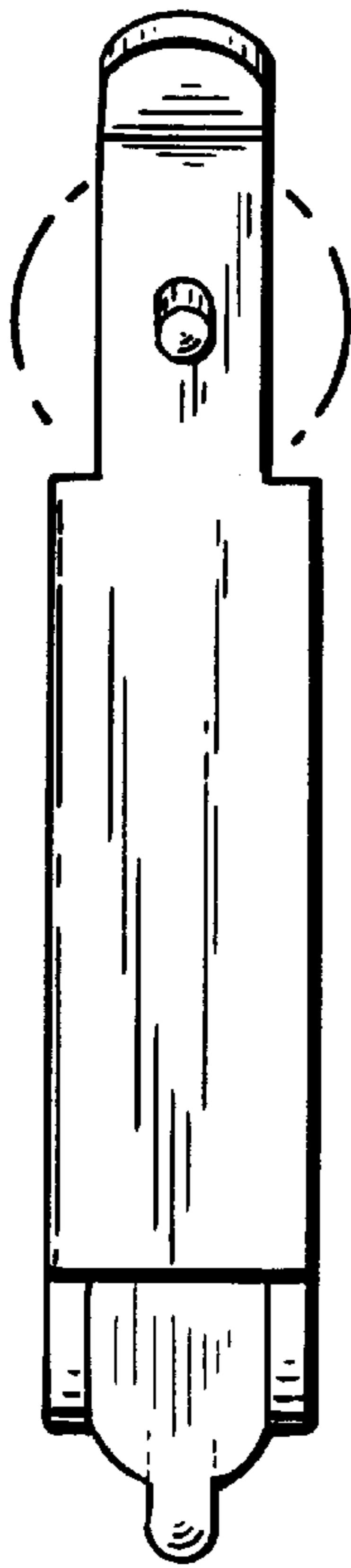

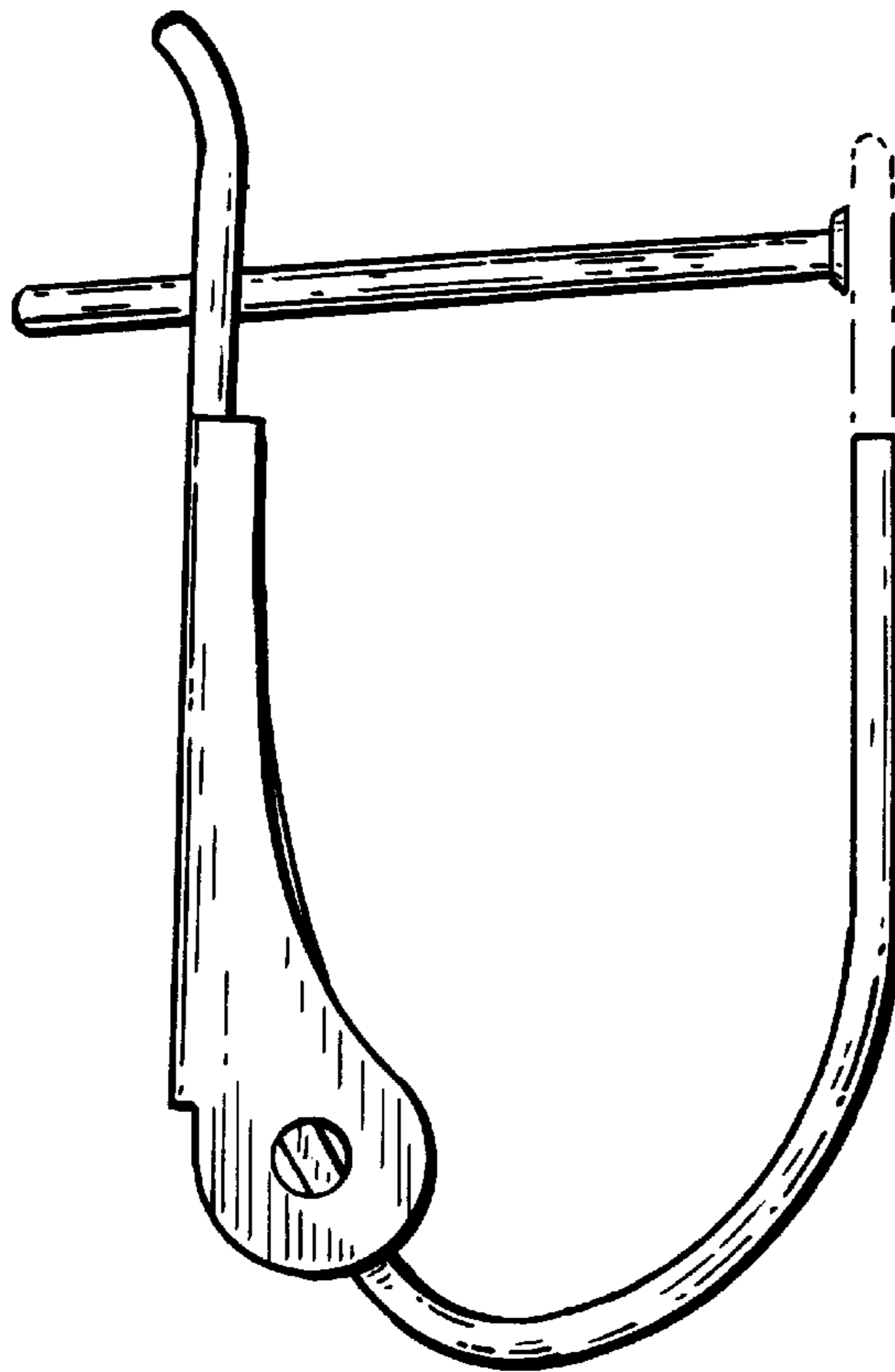

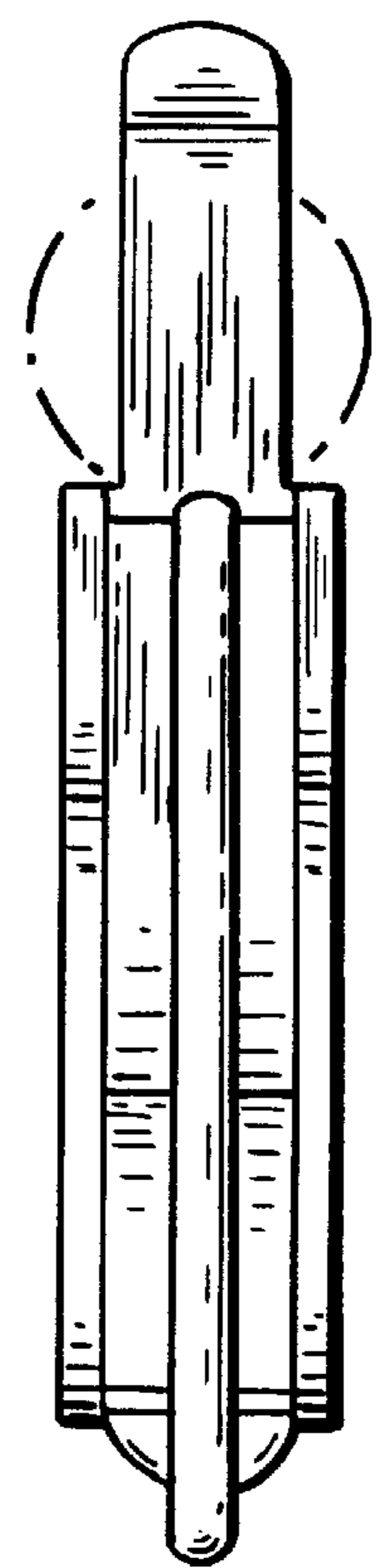
