The ornamental design for a vehicle floor mat, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a vehicle floor mat of the present invention;
 FIG. 2 is a bottom plan view of the floor mat of FIG. 1;
 FIG. 3 is a right side elevational view of the floor mat of FIG. 1;
 FIG. 4 is a left side elevational view of the floor mat of FIG. 1;
 FIG. 5 is a front elevational view of the floor mat of FIG. 1;
 FIG. 6 is a rear elevational view of the floor mat of FIG. 1;
 FIG. 7 is a top plan view of a second embodiment of a vehicle floor mat, showing our new design;
 FIG. 8 is a bottom plan view of the floor mat of FIG. 7;
 FIG. 9 is a right side elevational view of the floor mat of FIG. 7;
 FIG. 10 is a left side elevational view of the floor mat of FIG. 7;
 FIG. 11 is a front elevational view of the floor mat of FIG. 7; and,
 FIG. 12 is a rear elevational view of the floor mat of FIG. 7.

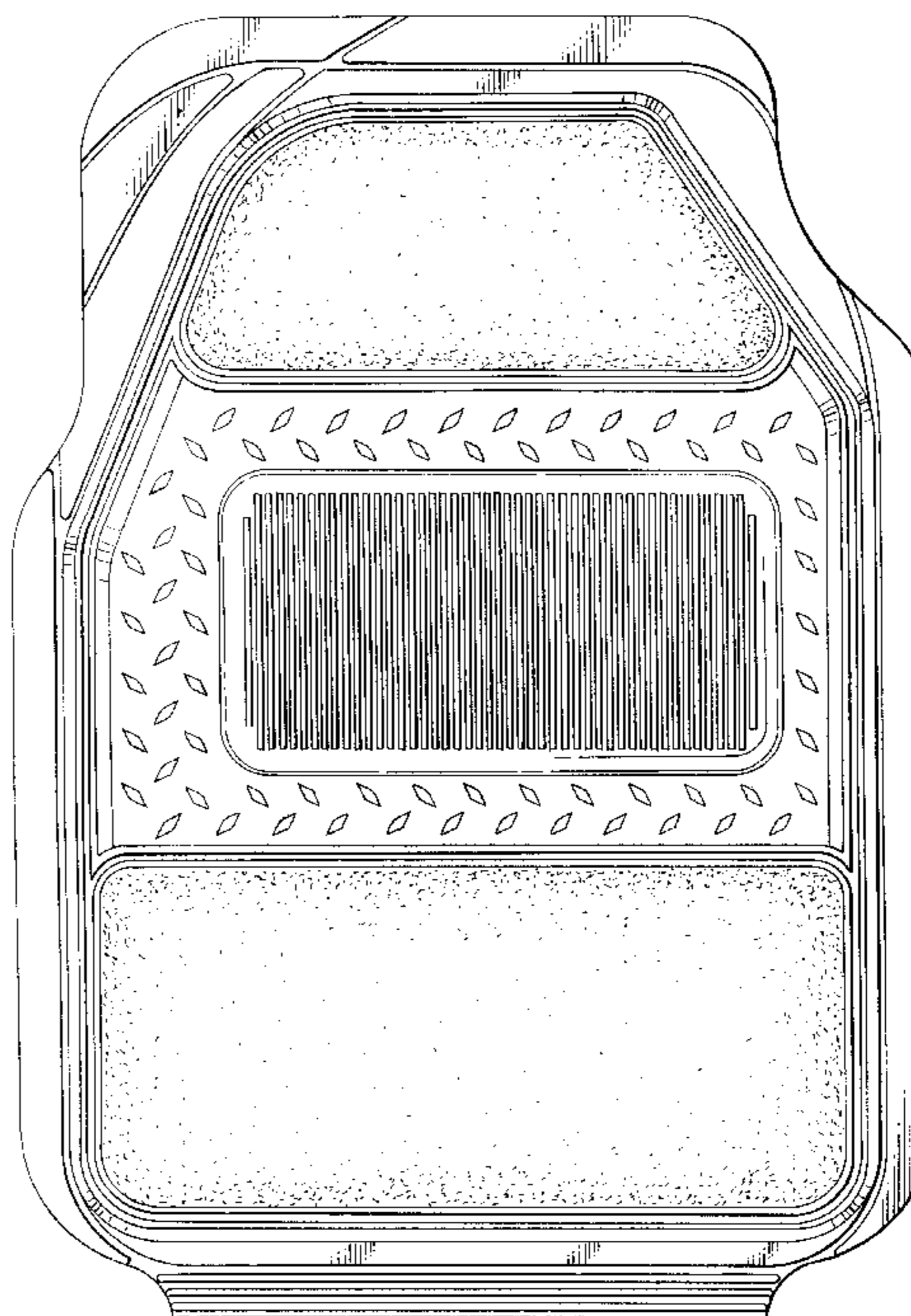
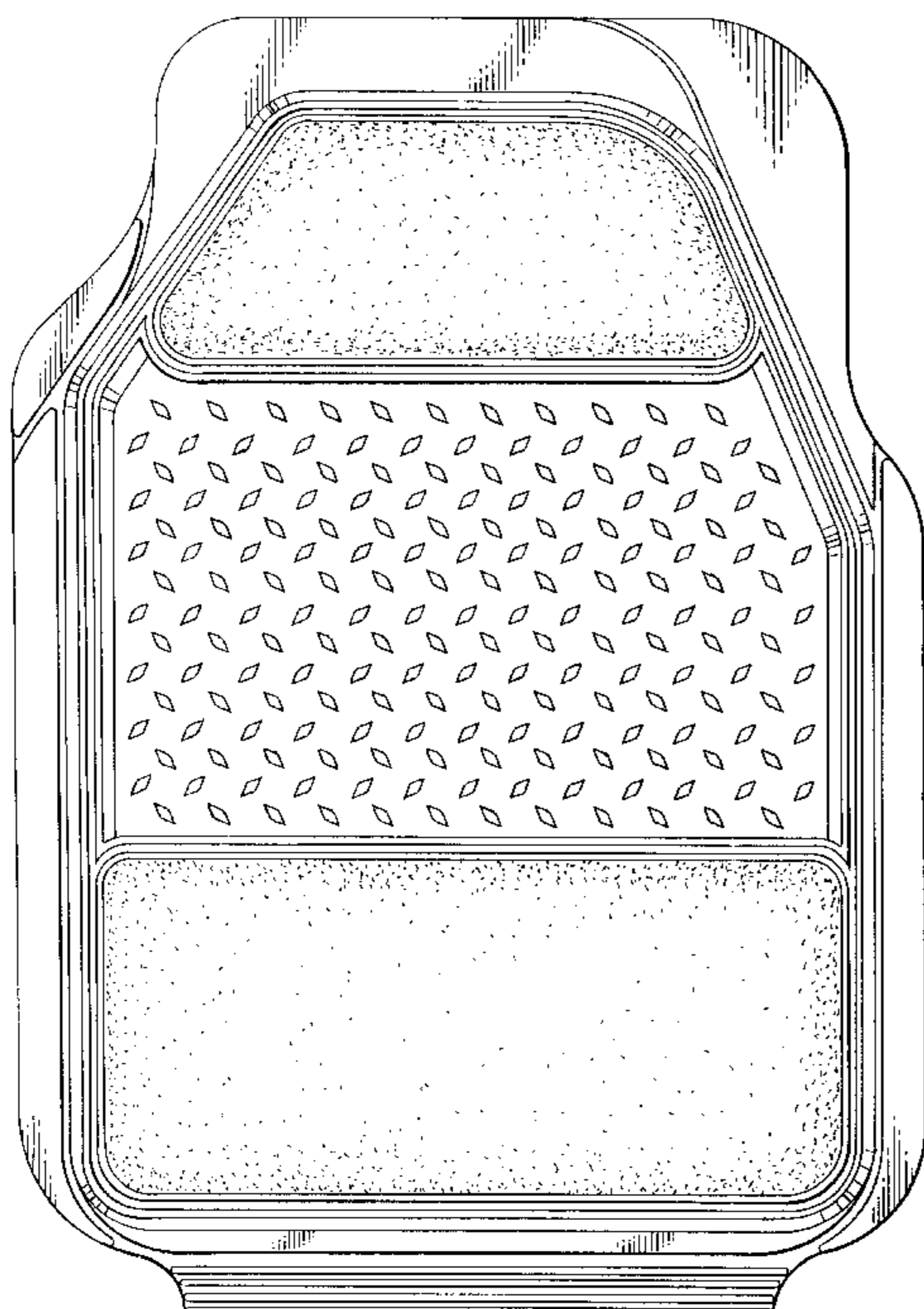

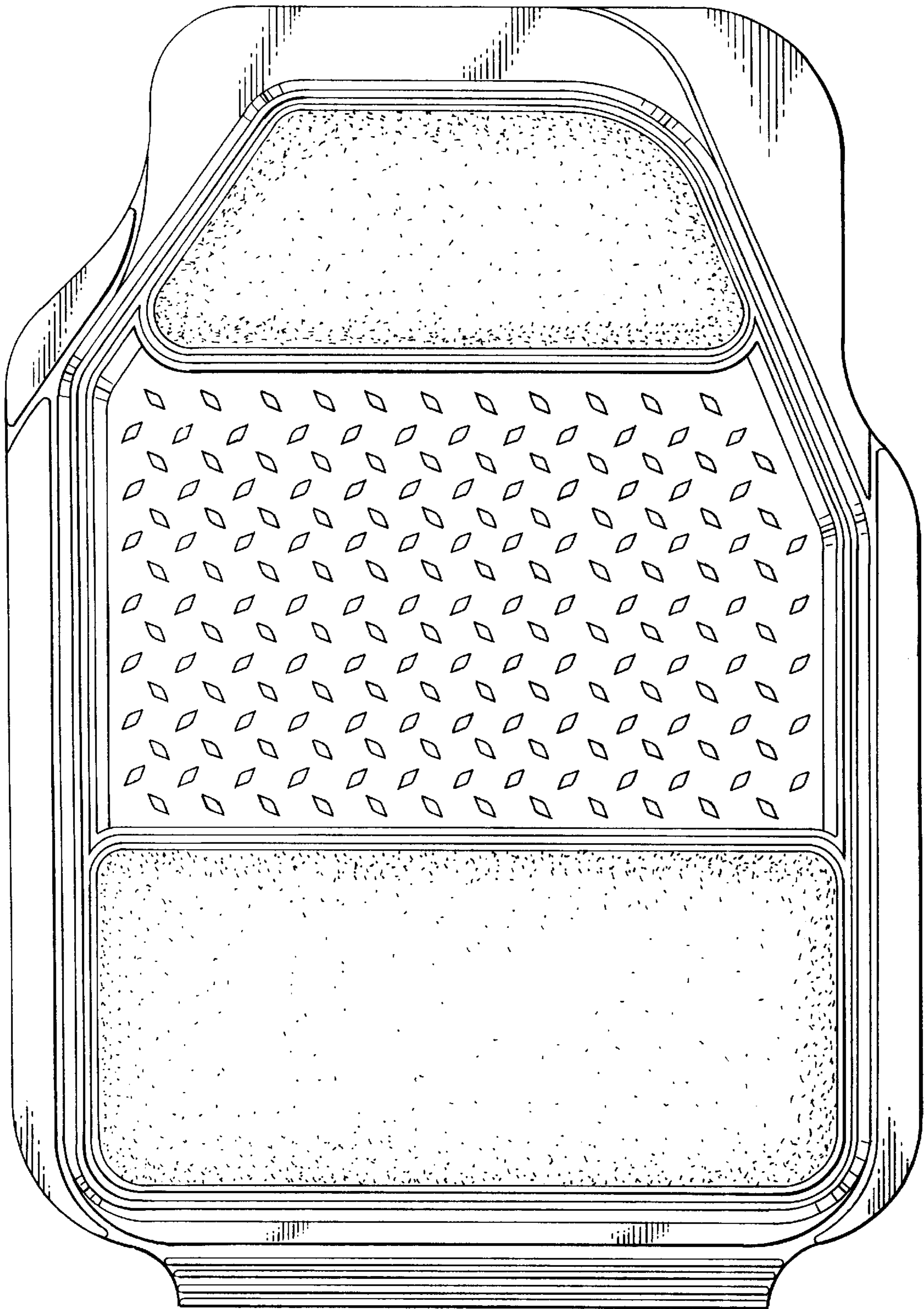

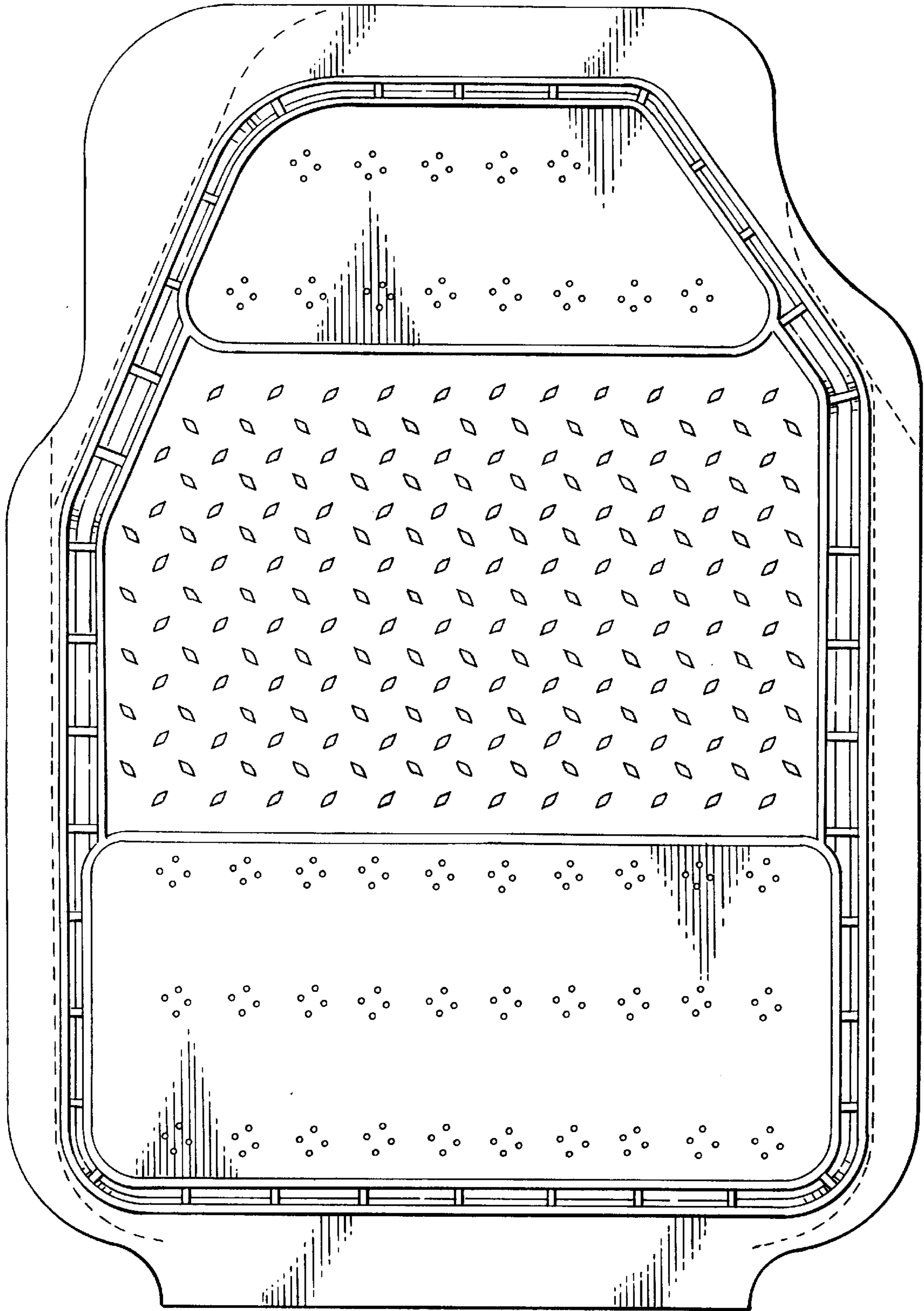

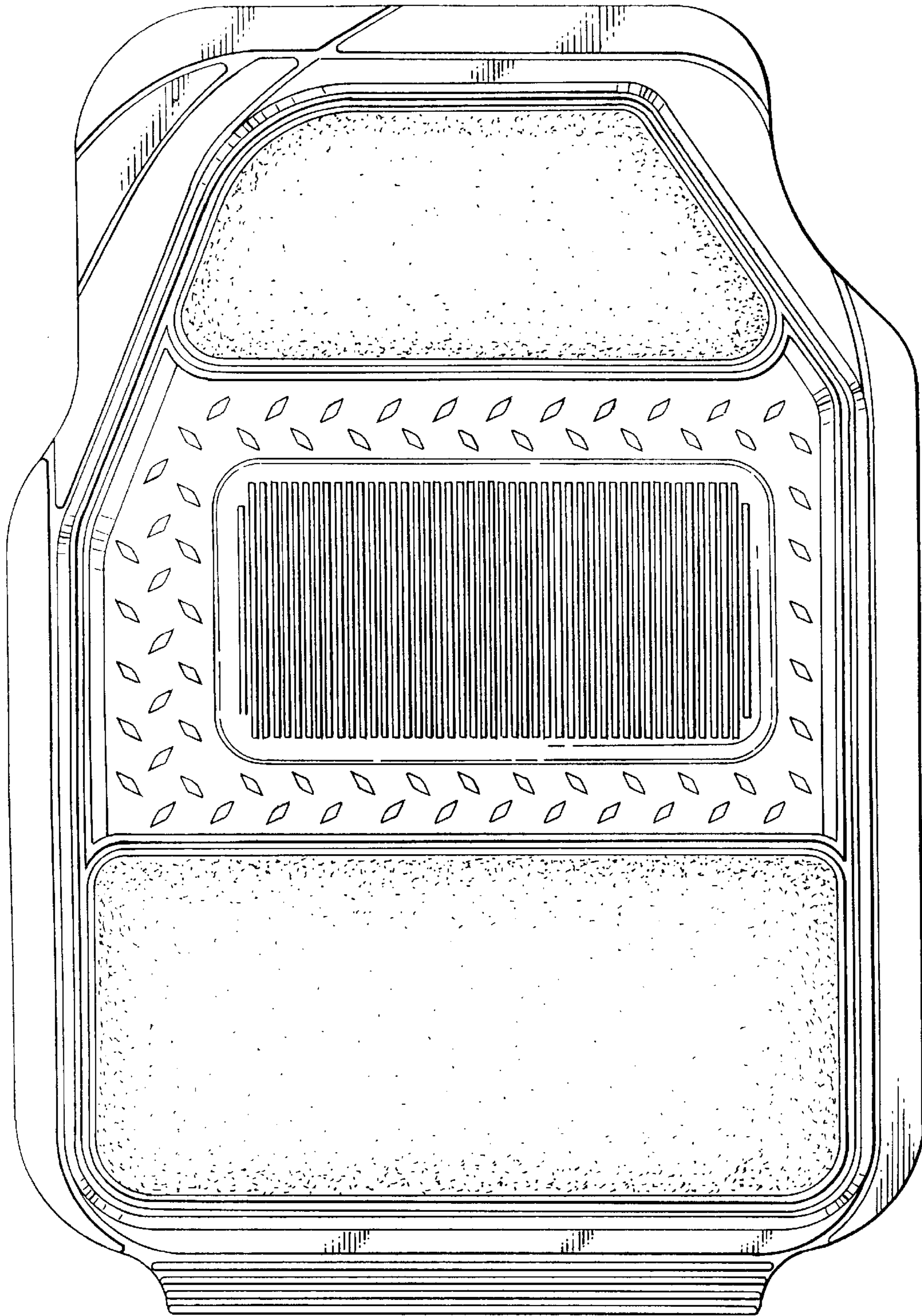

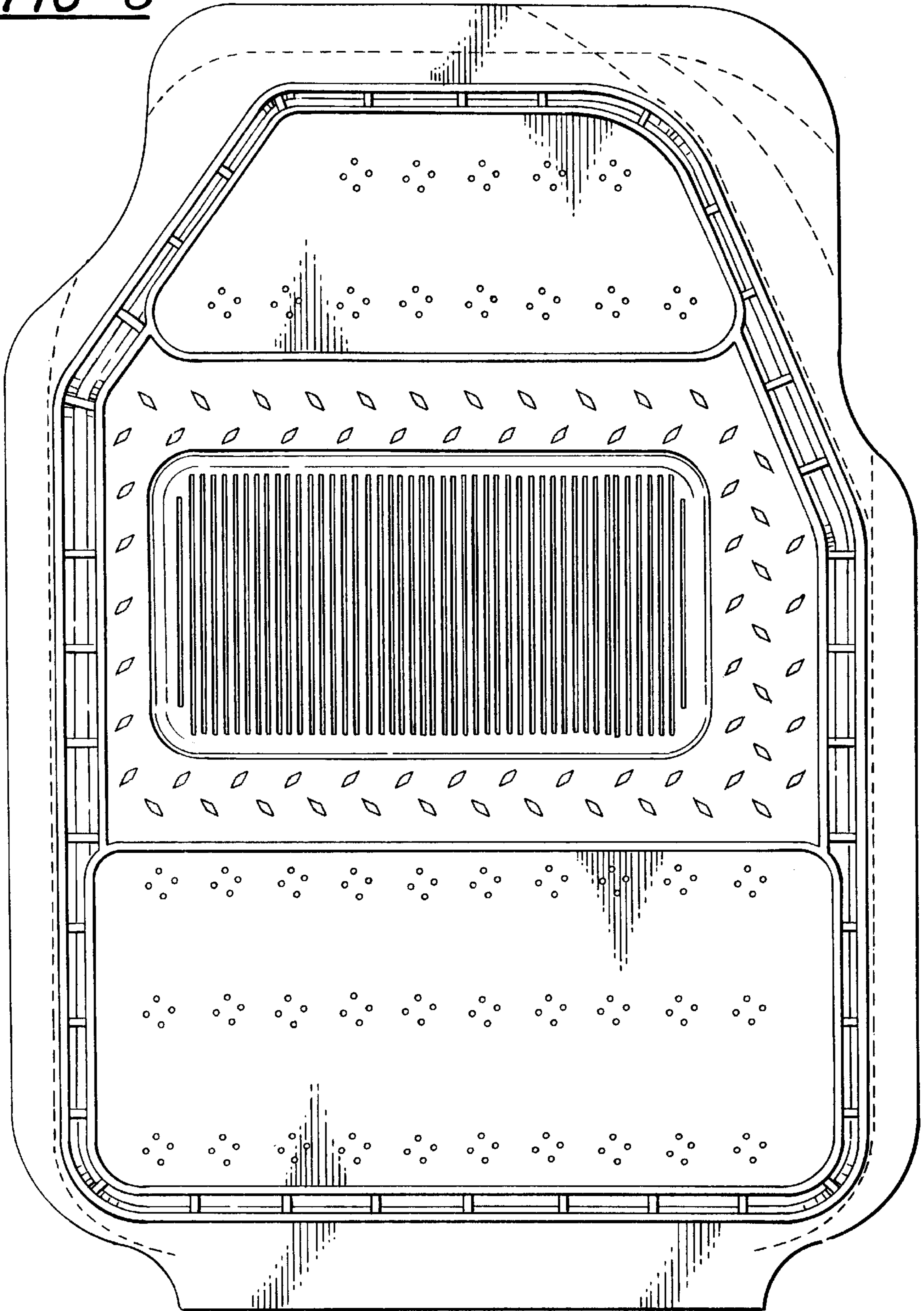

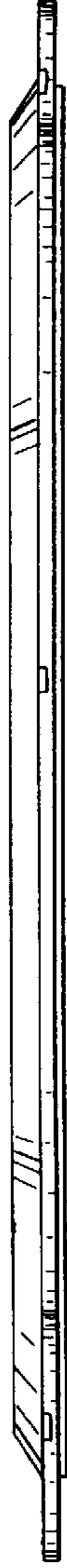
