### [57] CLAIM

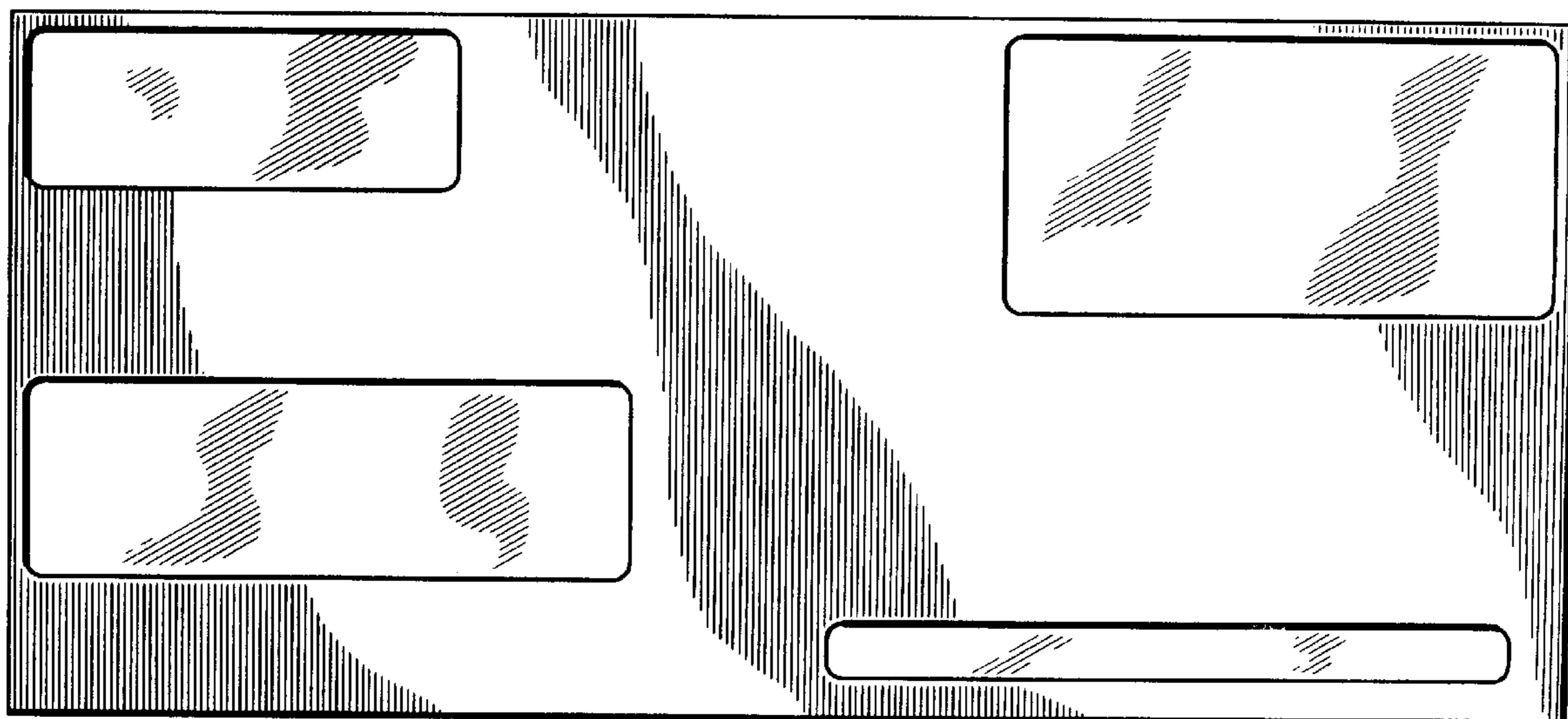
The ornamental design for a front surface of a stampless envelope, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a front surface of a stampless envelope showing my new design; and, FIG. 2 is a front elevational view of an alternate embodiment of my design of FIG. 1.

The indicia depicted by means of broken lines in the upper left hand corner of FIG. 2 has been shown for illustrative purposes only and forms no part of the claimed design.

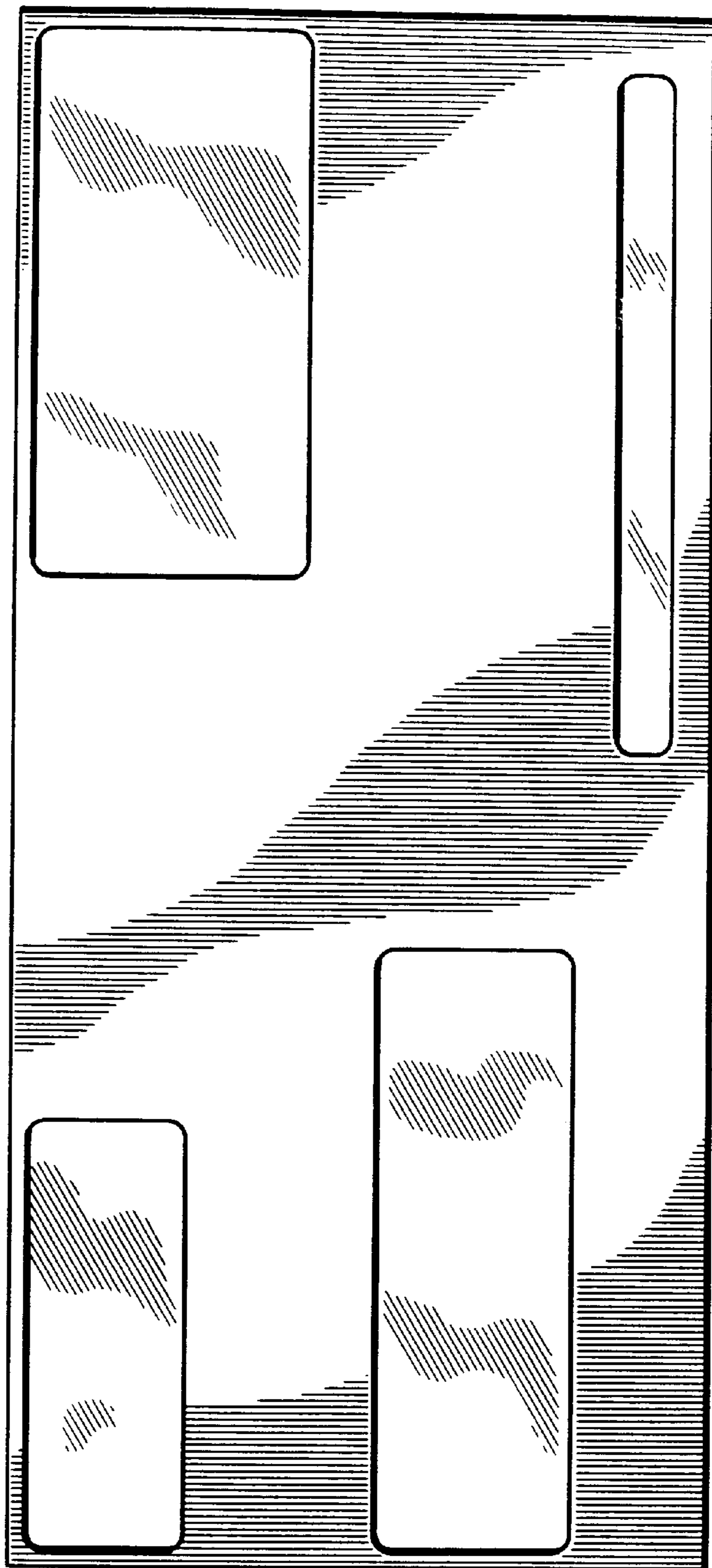

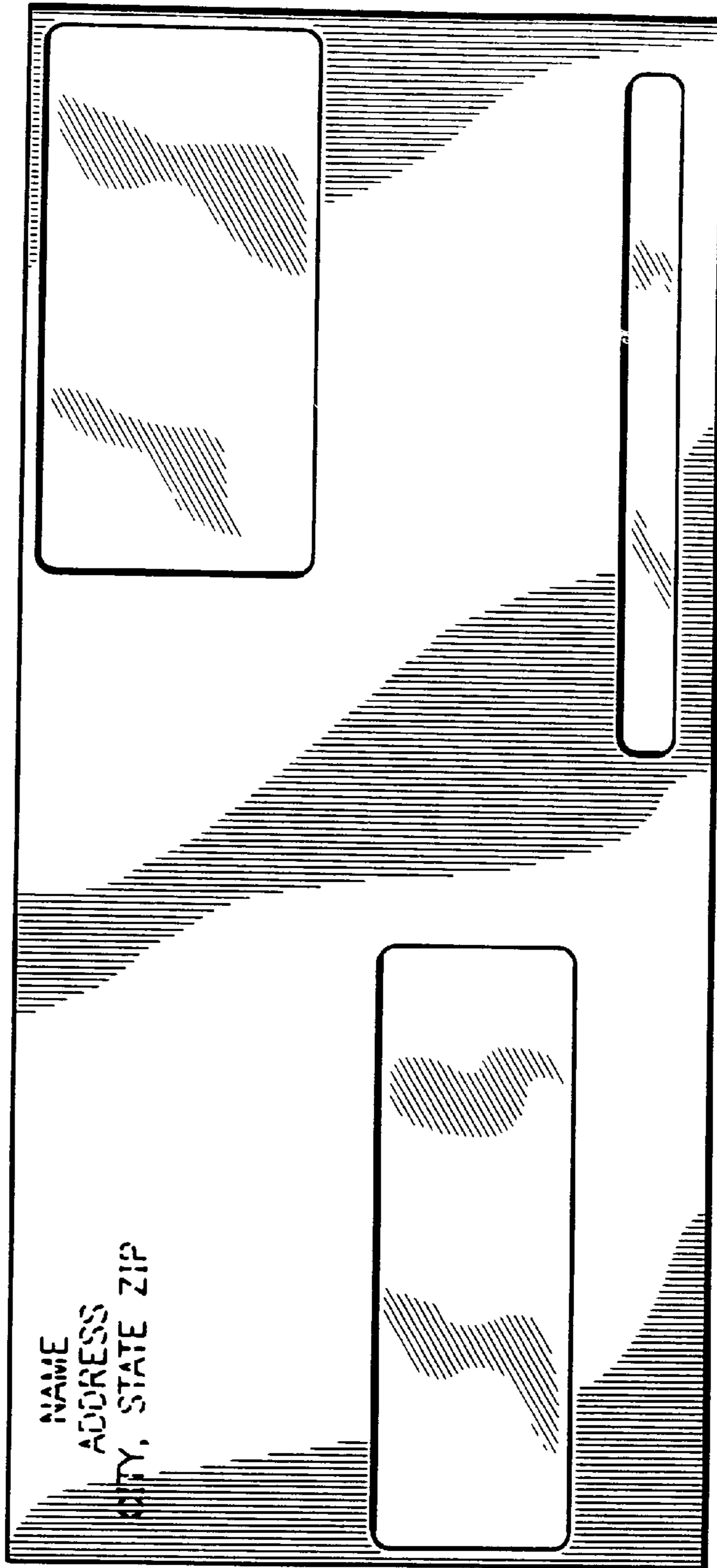
