FIG. 9 is an elevational perspective view of the barbell plate shown in FIG. 7.

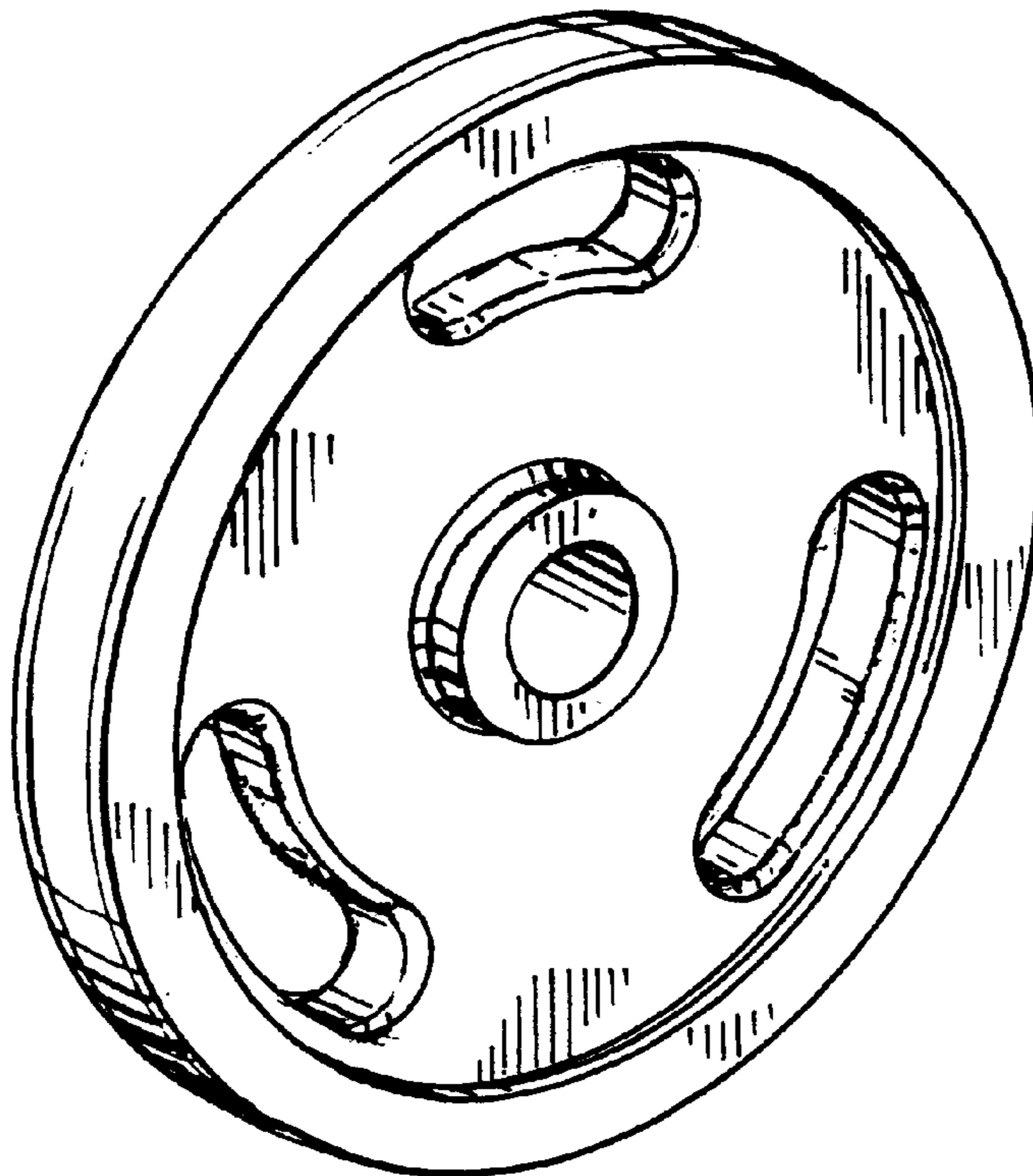

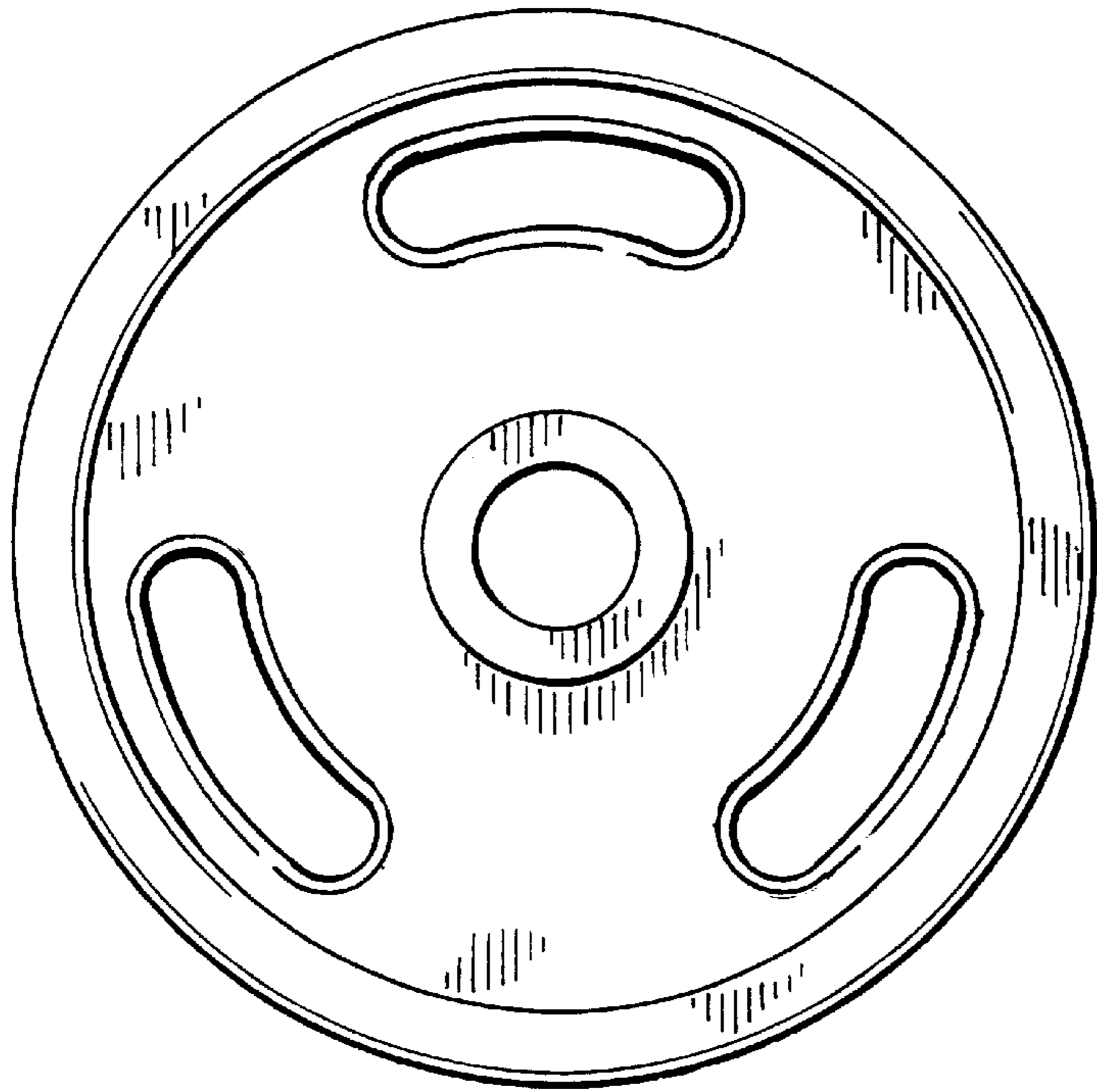

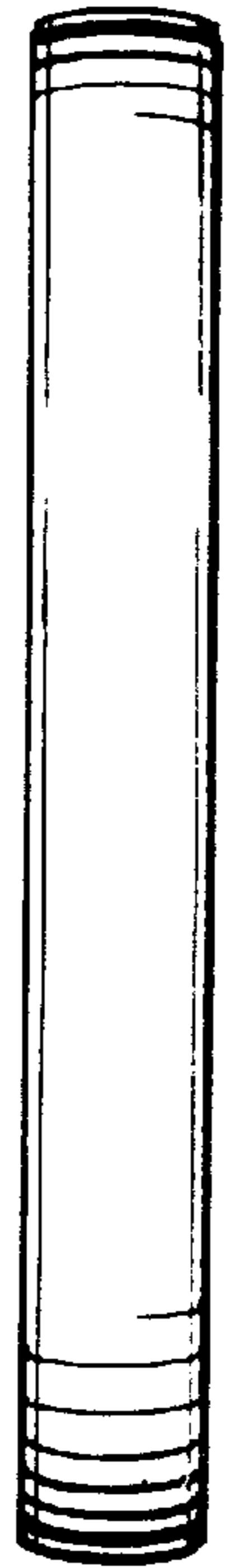

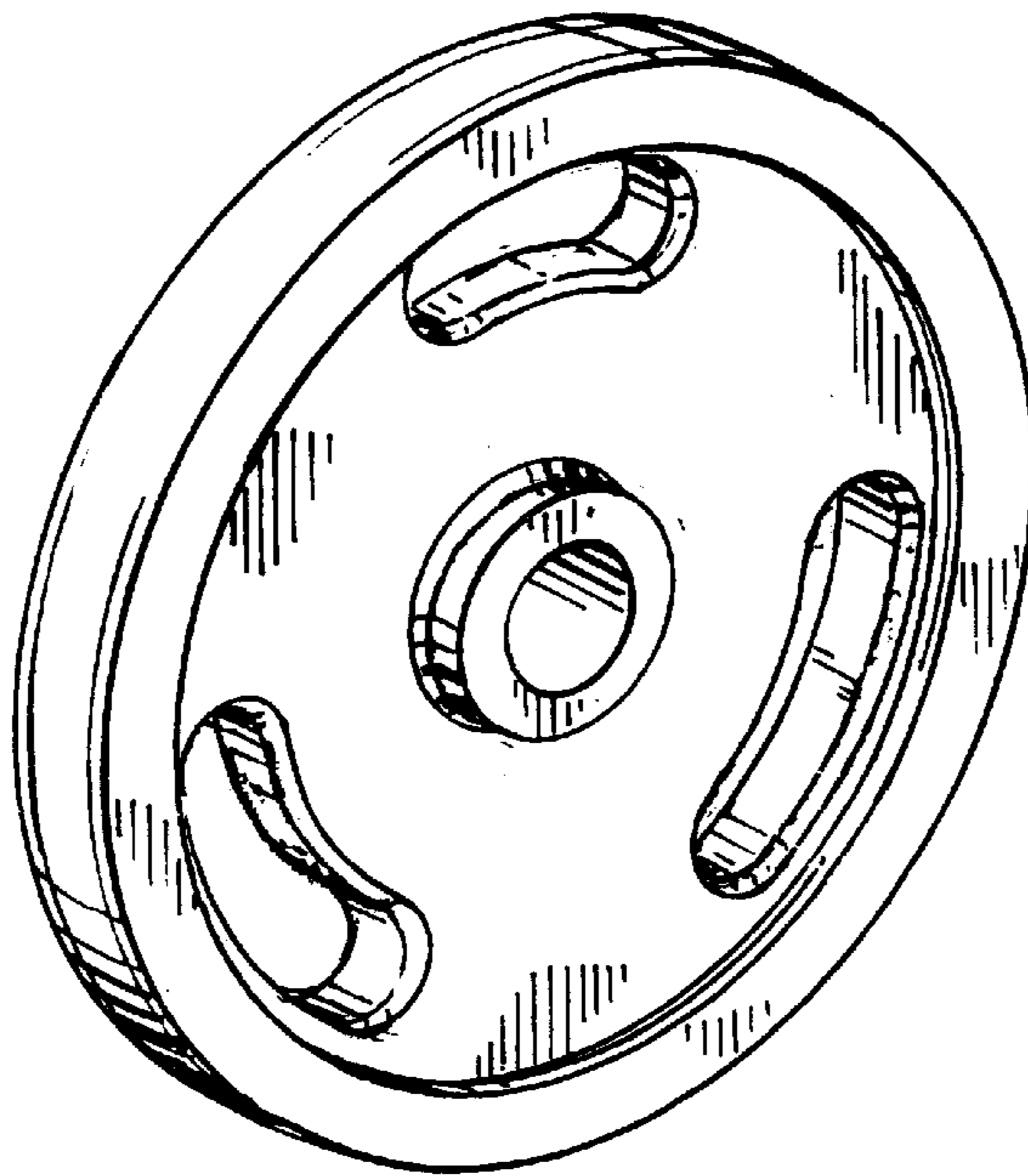




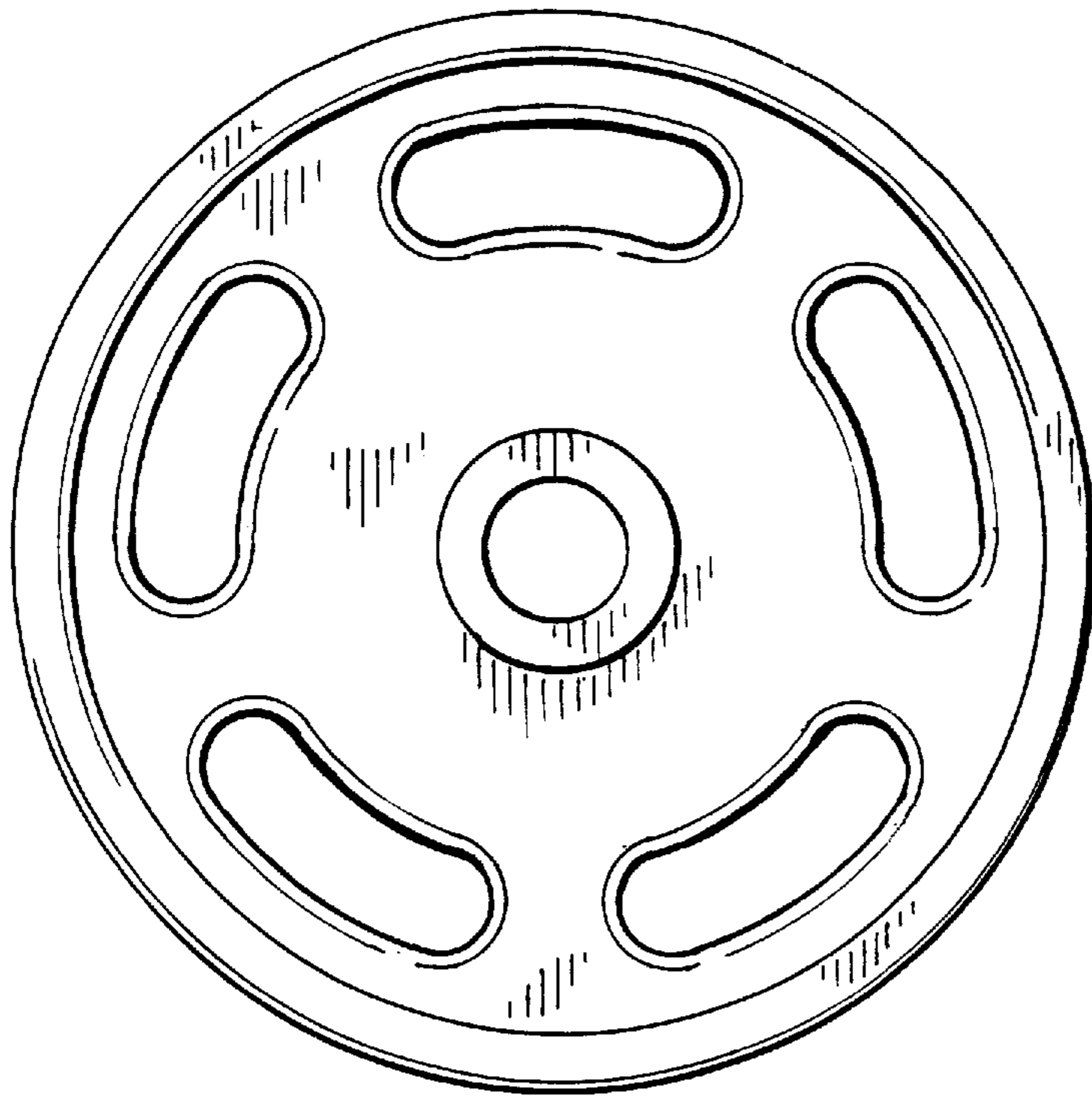

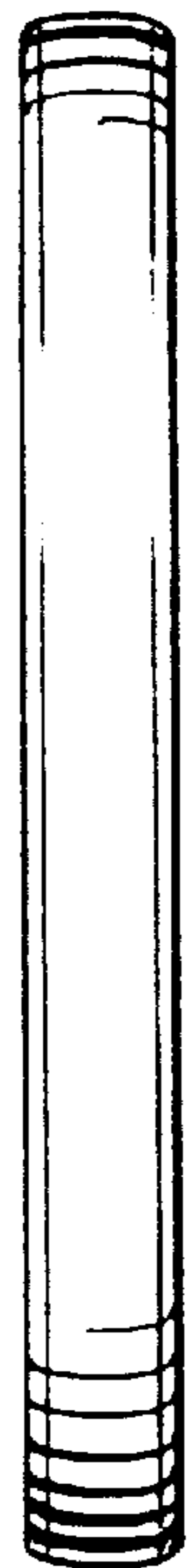

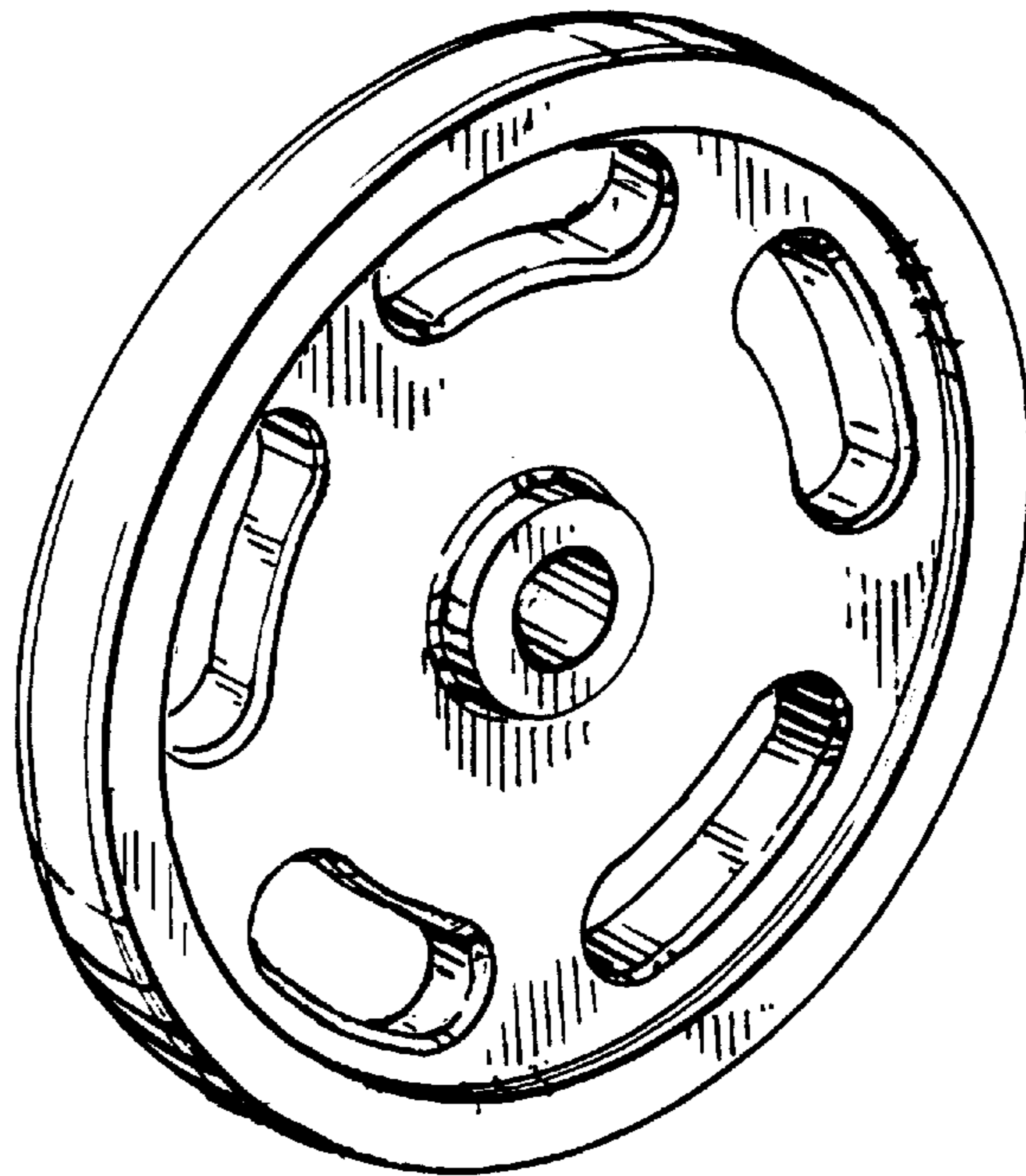

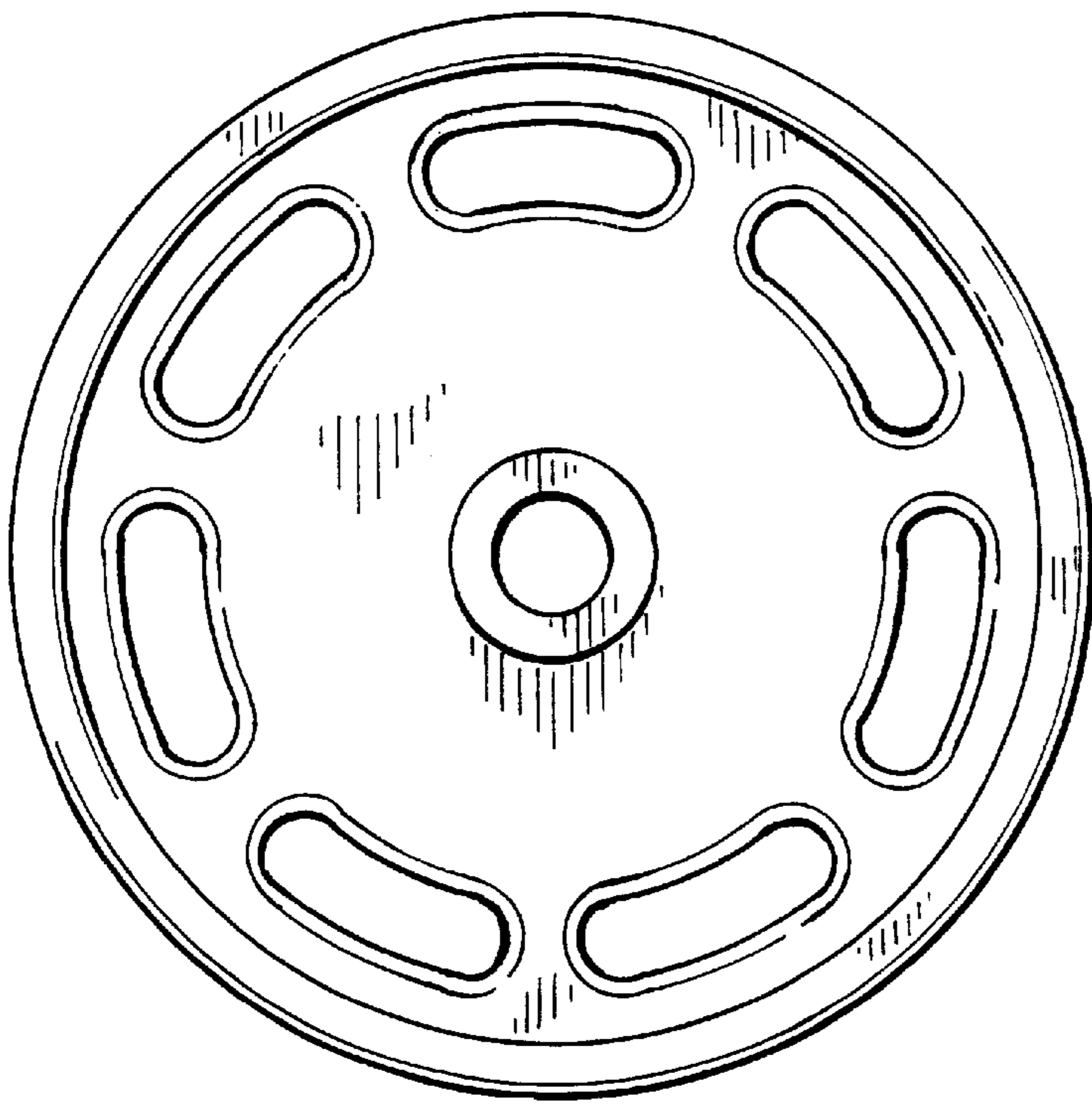

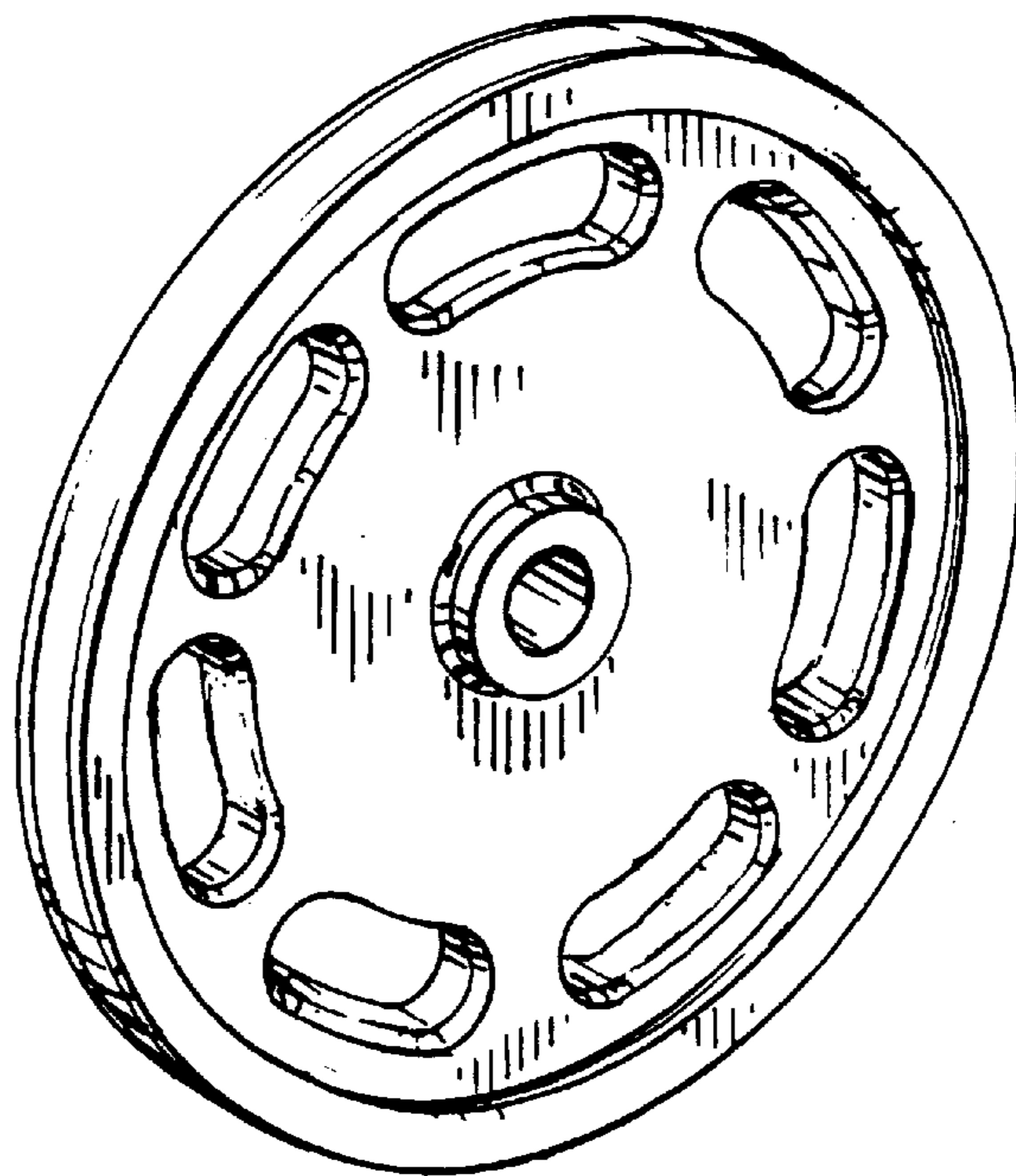
