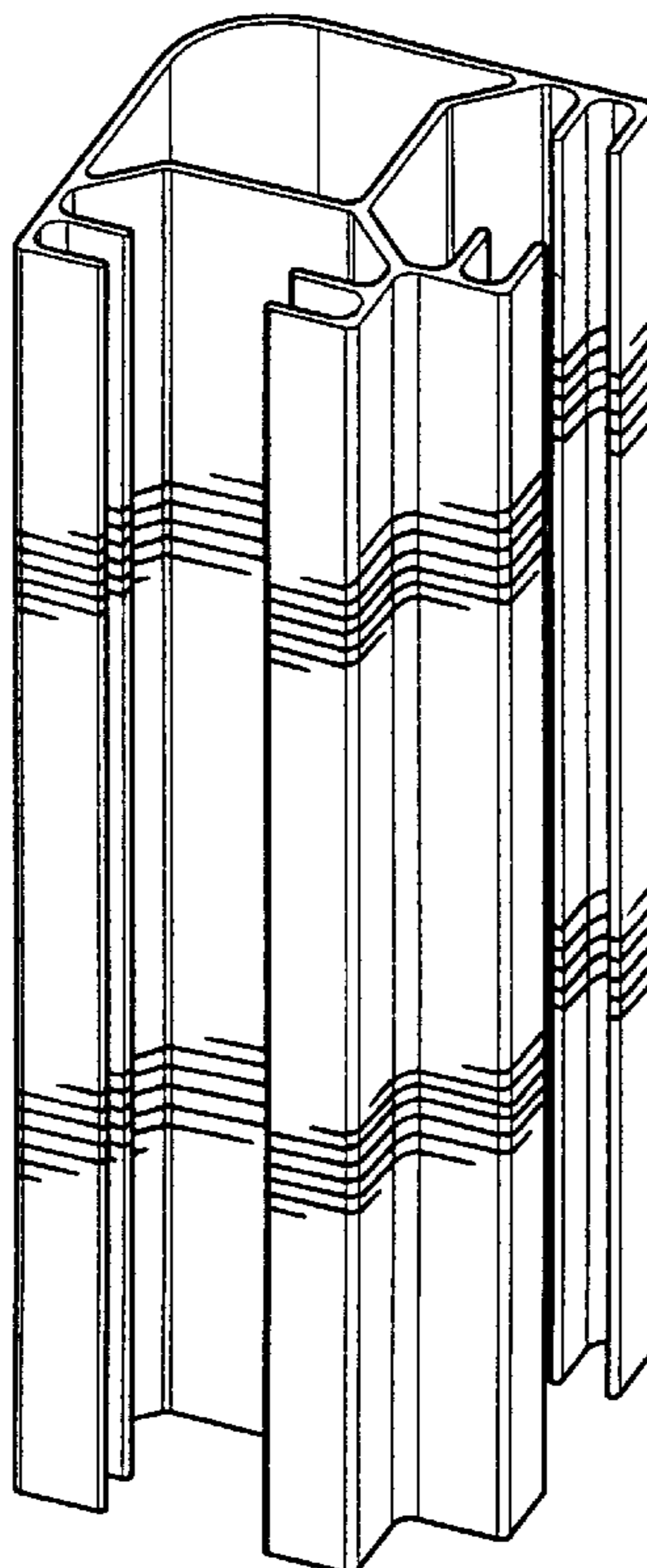
[57] **CLAIM**

The ornamental design for a corner connector strip, as shown and described.

**DESCRIPTION**

FIG. 1 is a top right front perspective view of a corner connector strip showing my new design;  
 FIG. 2 is a front elevational view thereof; the right side elevational view being a mirror image;  
 FIG. 3 is a left side elevational view thereof; the rear elevational view being a mirror image; and,  
 FIG. 4 is a top plan view thereof; the bottom plan view being a mirror image.

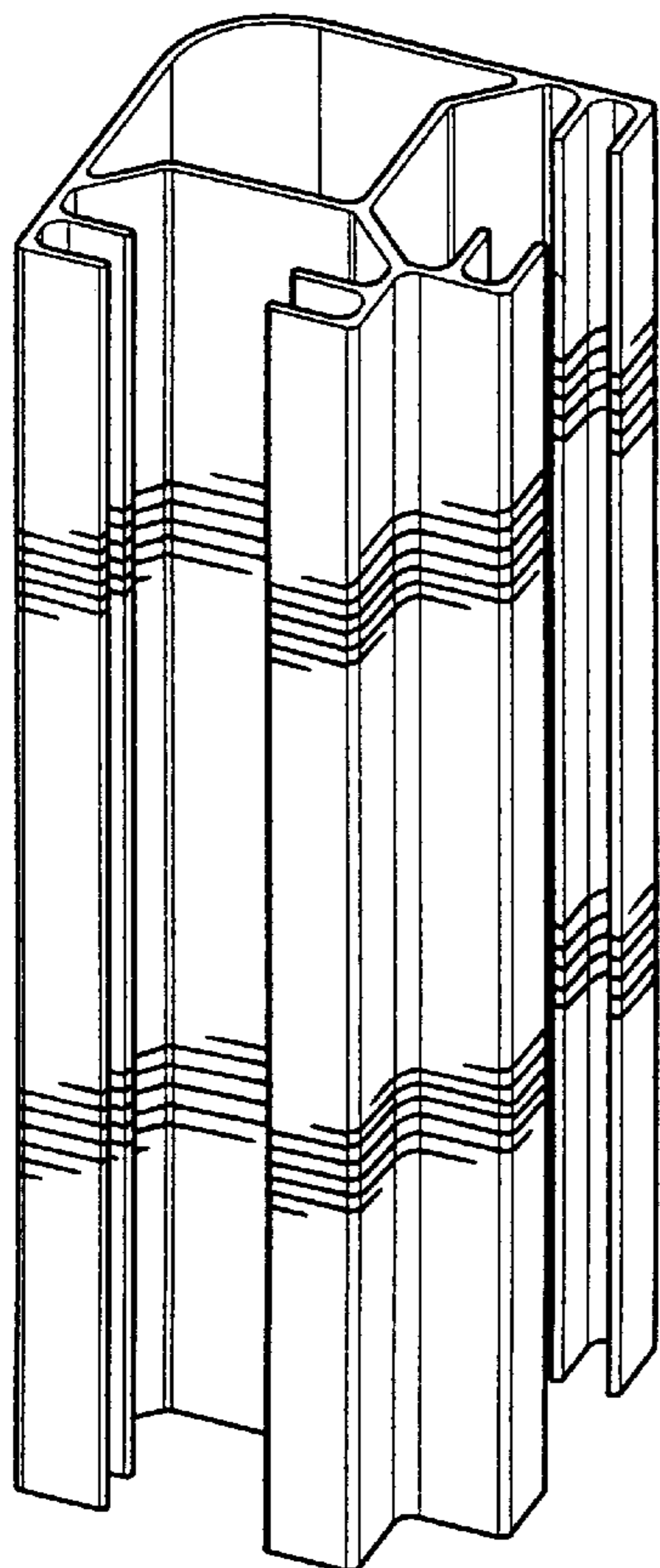

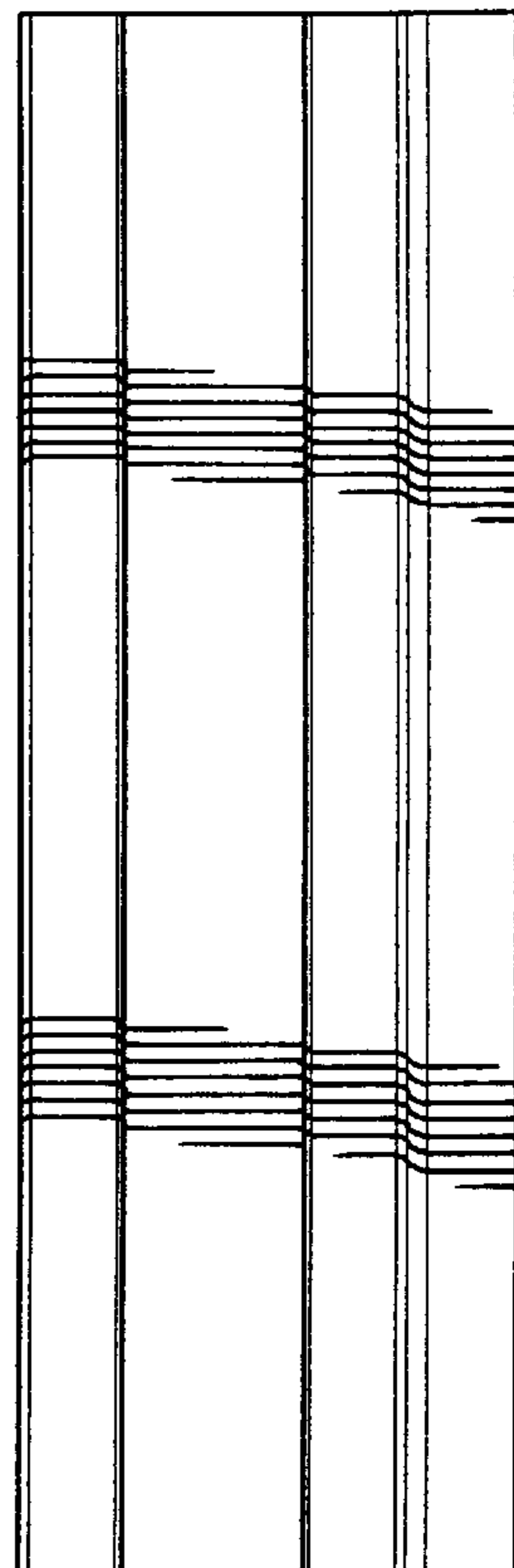

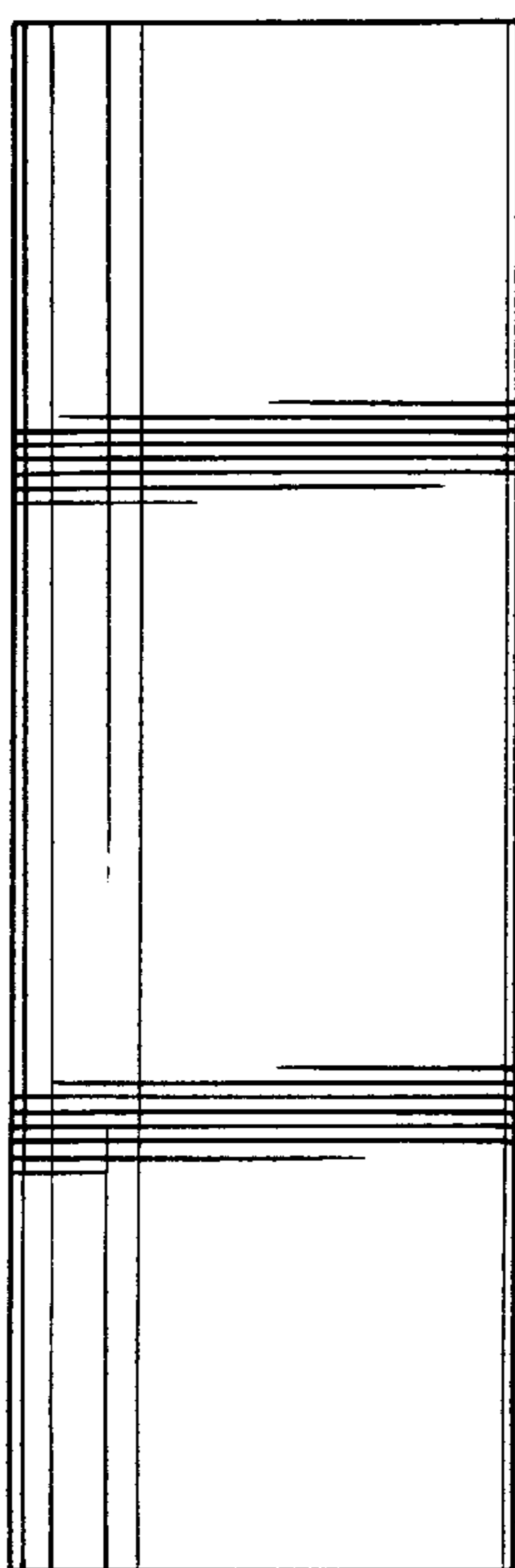

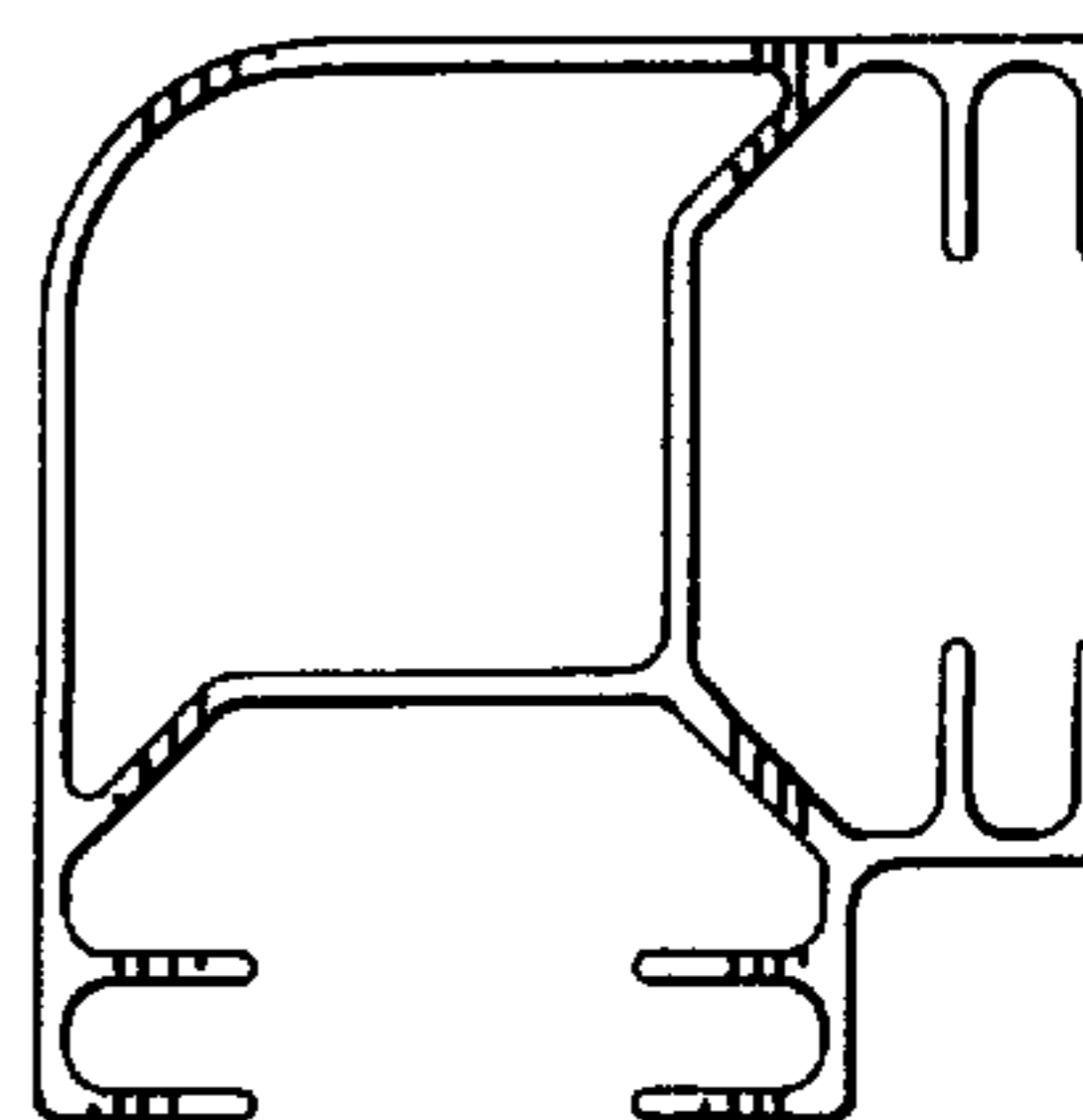
