[57] CLAIM

We claim the ornamental design for a dishwasher door having curved top edge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the dishwasher door. The broken line showing of the kitchen counter, cabinets and floor is for illustrative purposes only and forms no part of the claim design.

FIG. 2 is a top plan view of the door.

FIG. 3 is a front elevational view of the door.

FIG. 4 is a bottom view of the door.

FIG. 5 is a rear elevational view of the door; and,

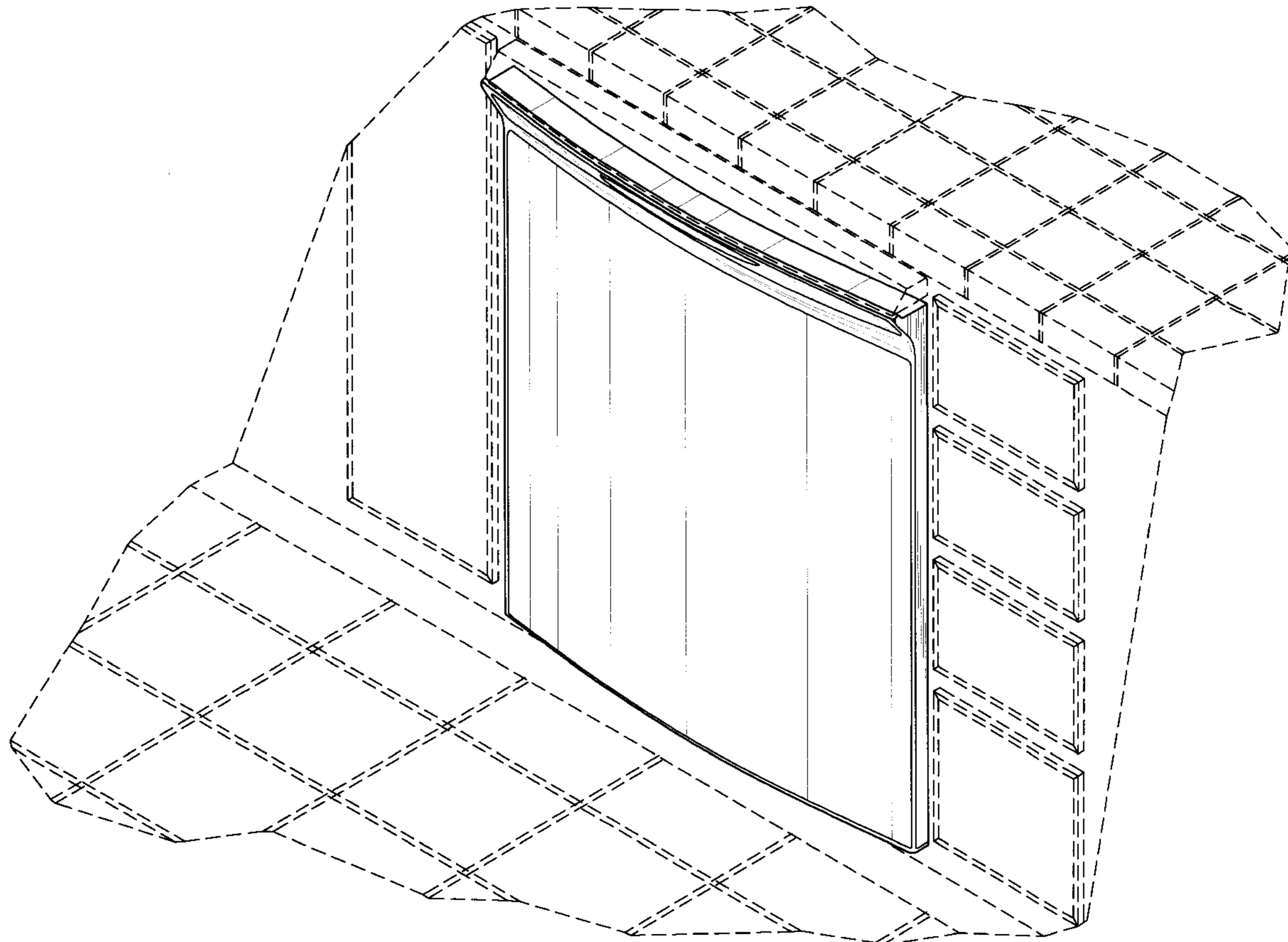
FIG. 6 is a side elevational view of the door taken from the right-hand side of FIG. 3, the opposite side view being the same.

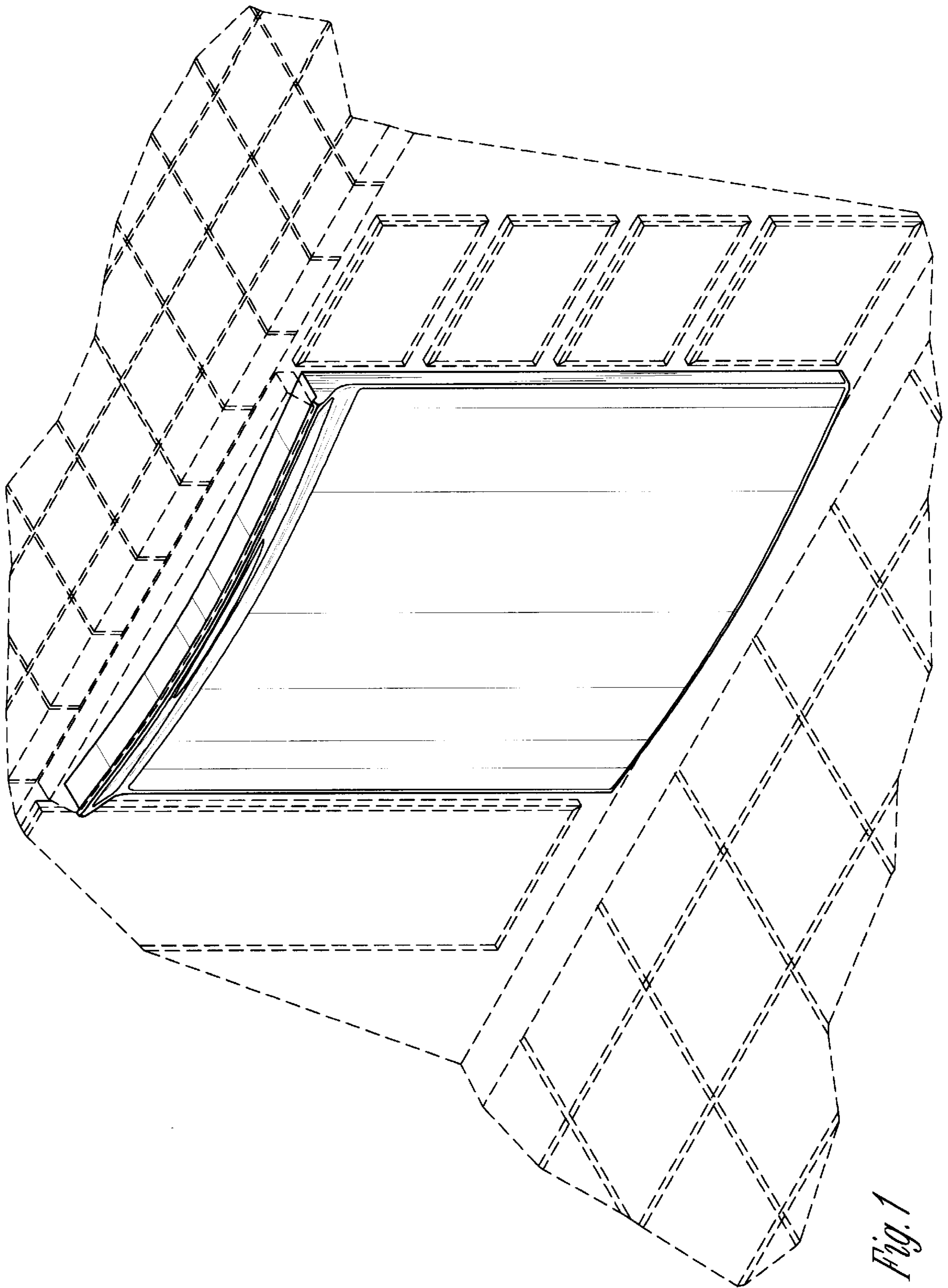

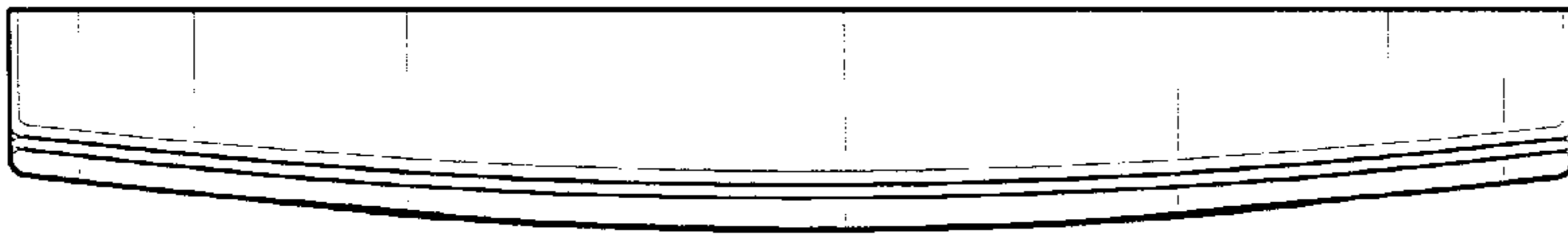

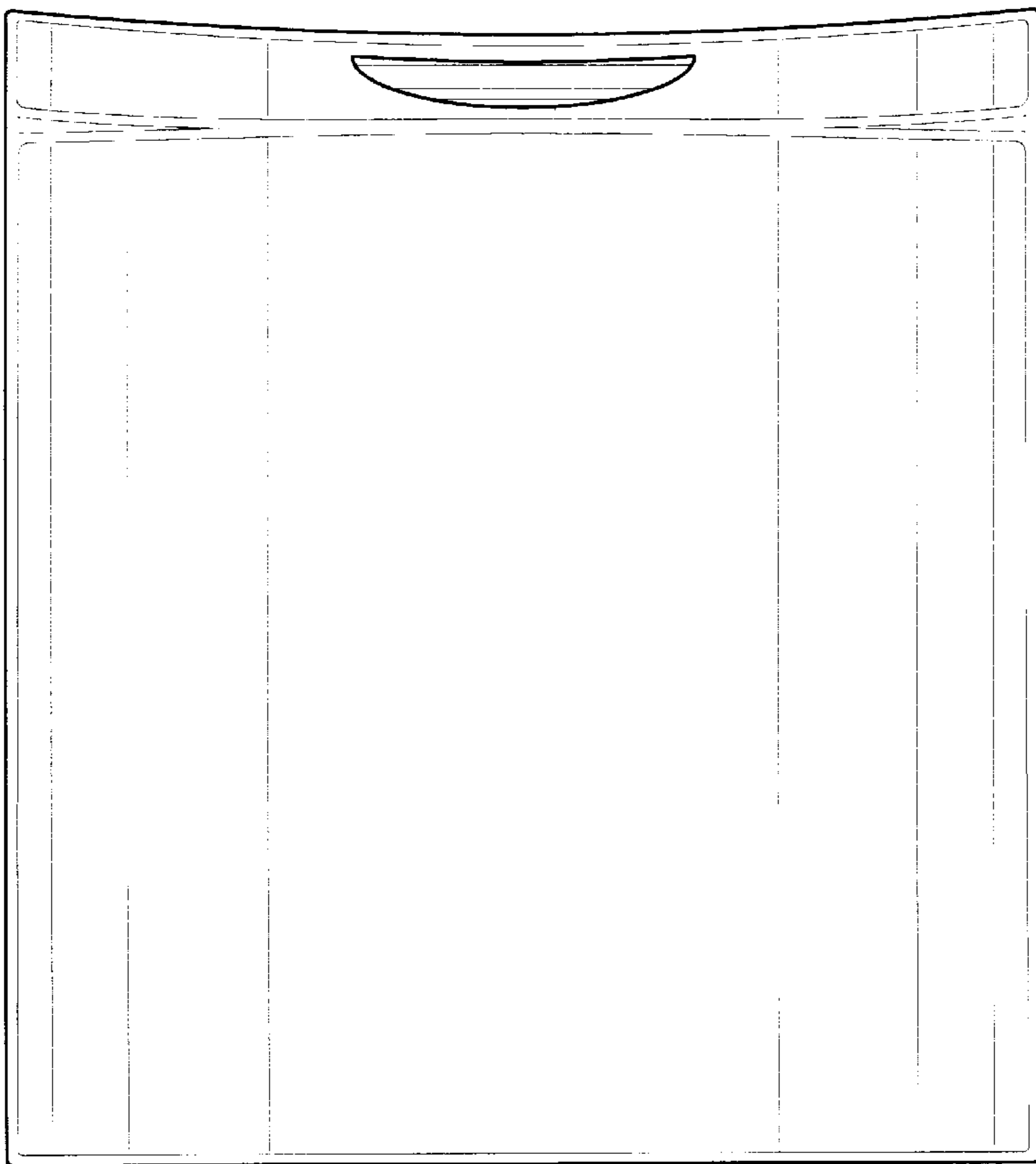

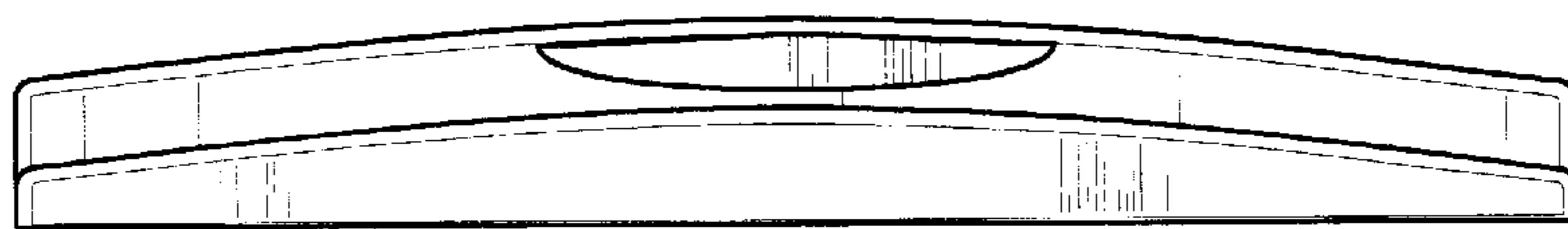

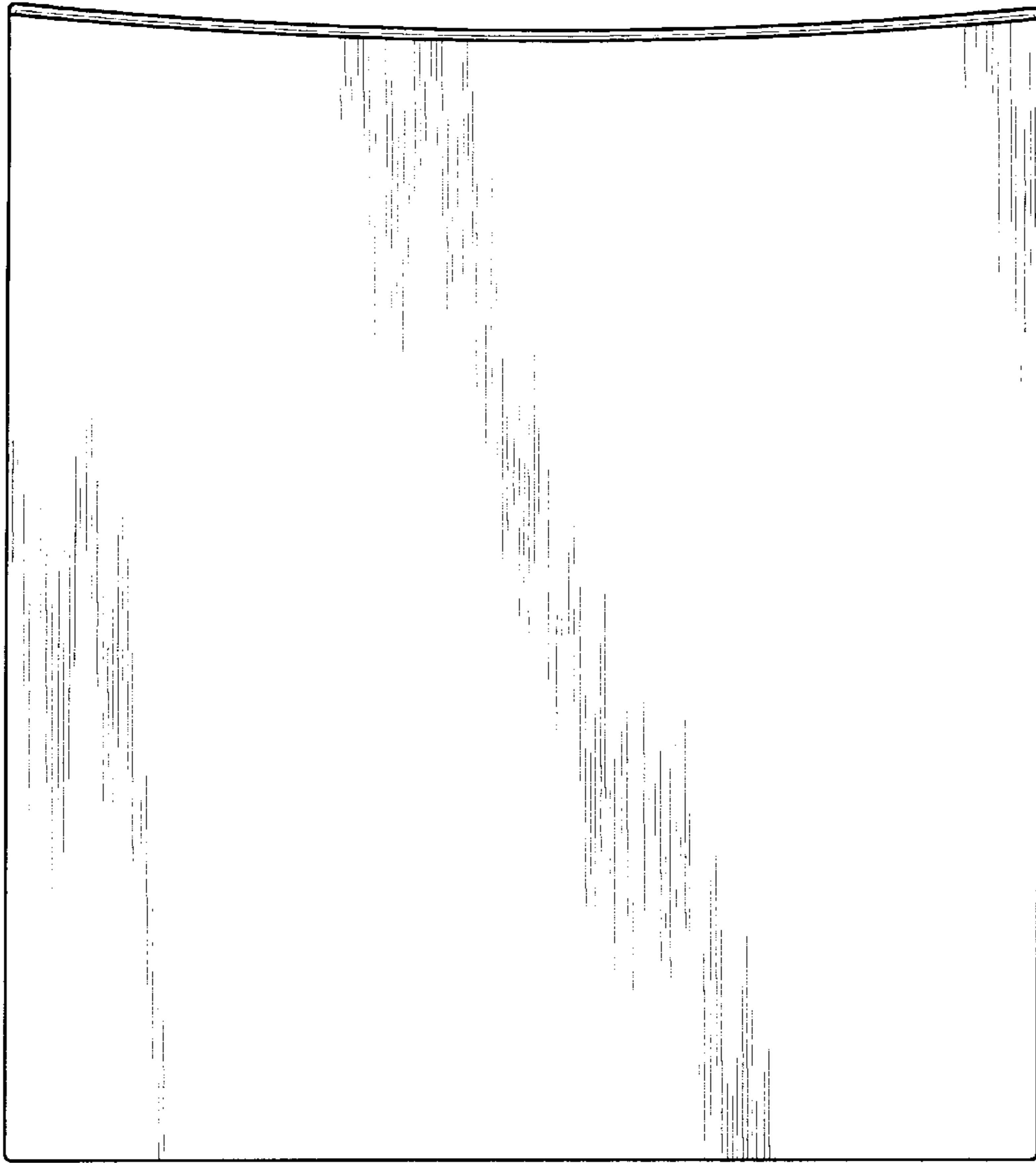

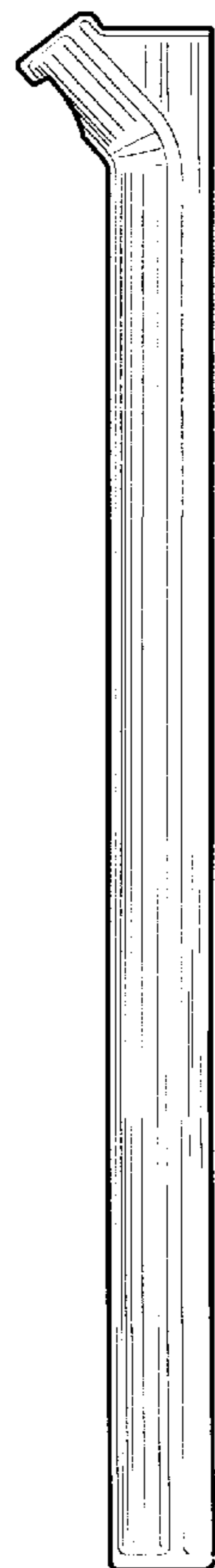
