DESCRIPTION

FIG. 1 is a perspective view of a cordless telephone, showing my new design;

FIG. 2 is a top view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a side view, opposite to that shown in FIG. 3;

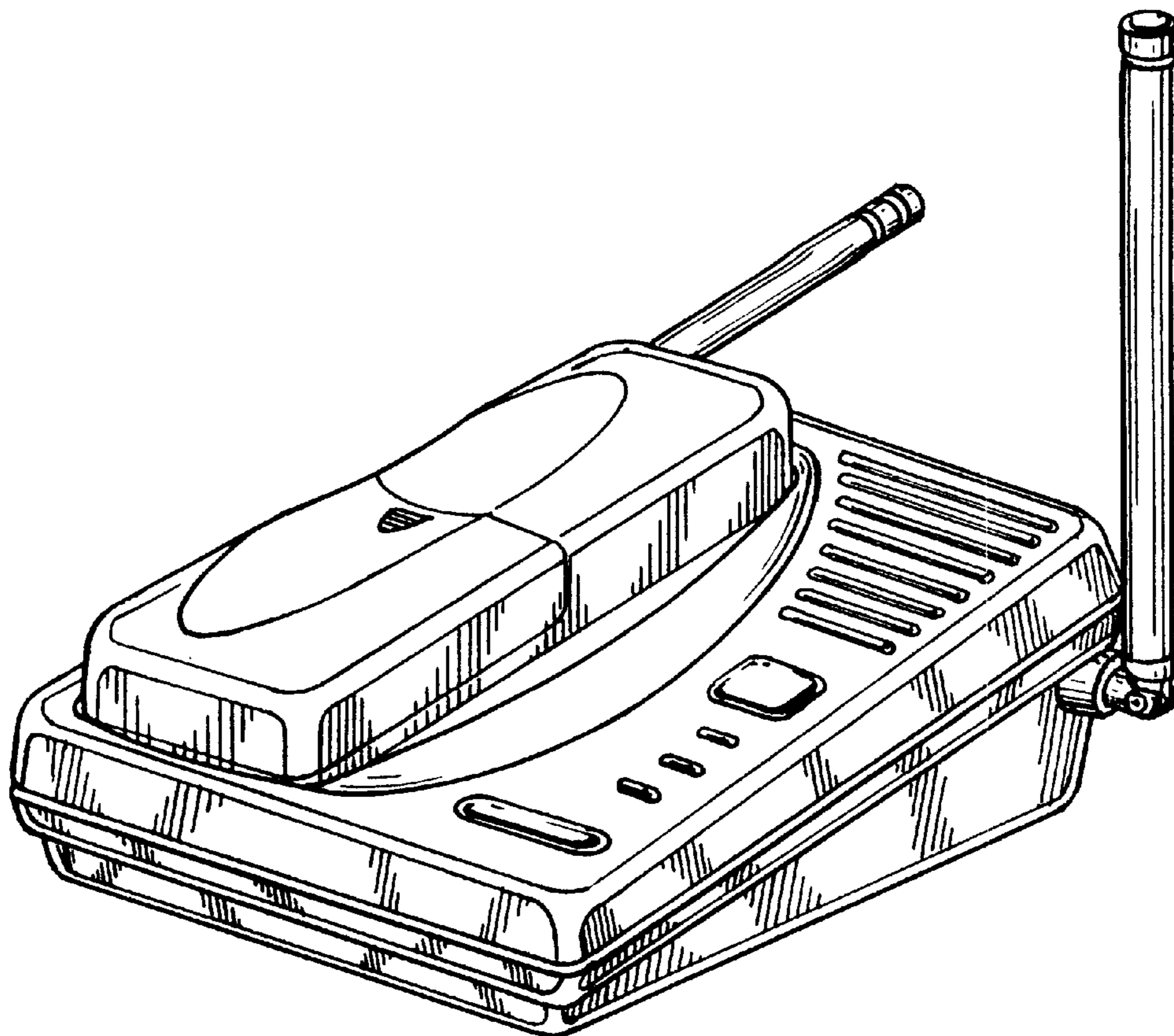
FIG. 5 is a bottom view thereof;

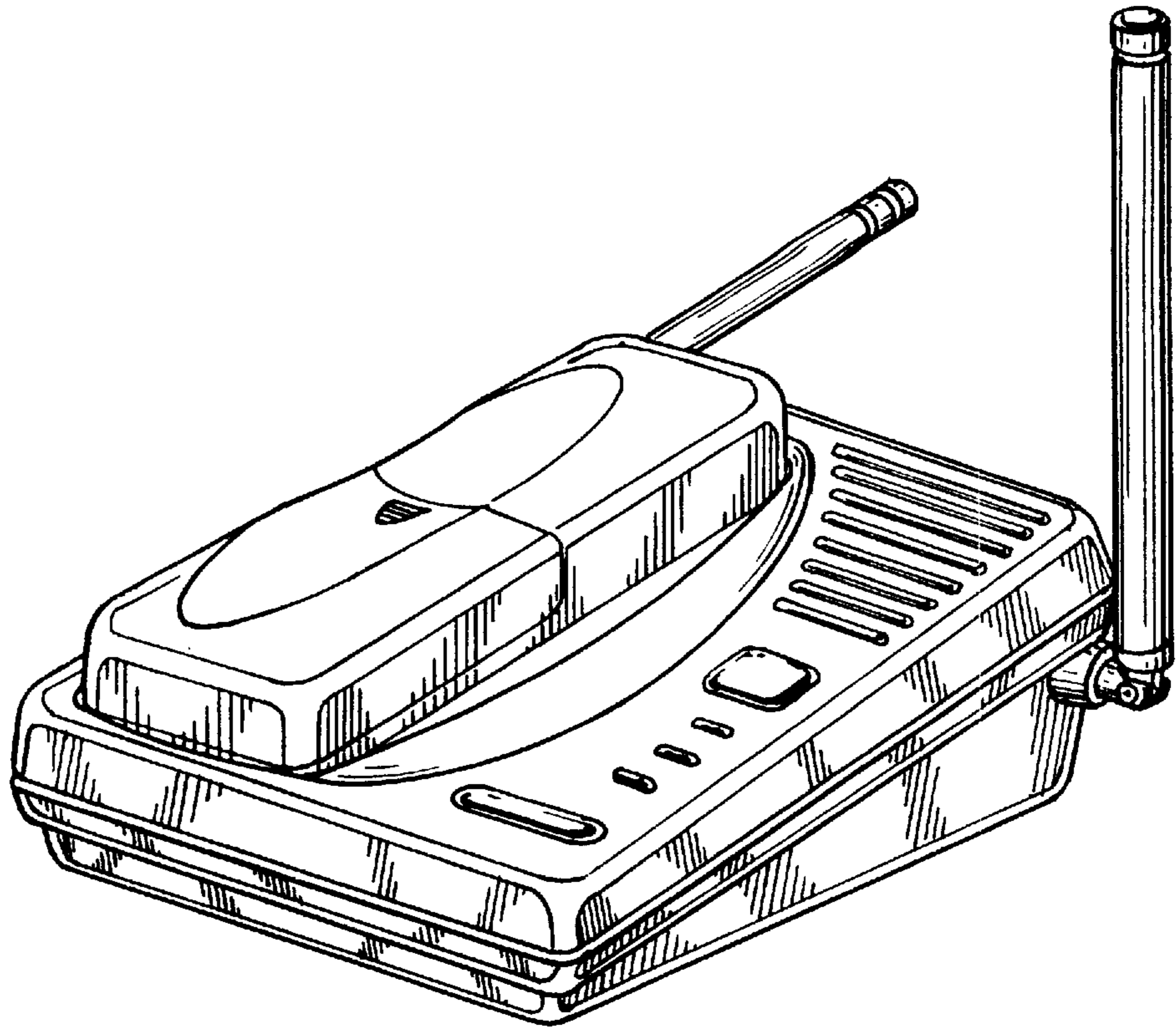

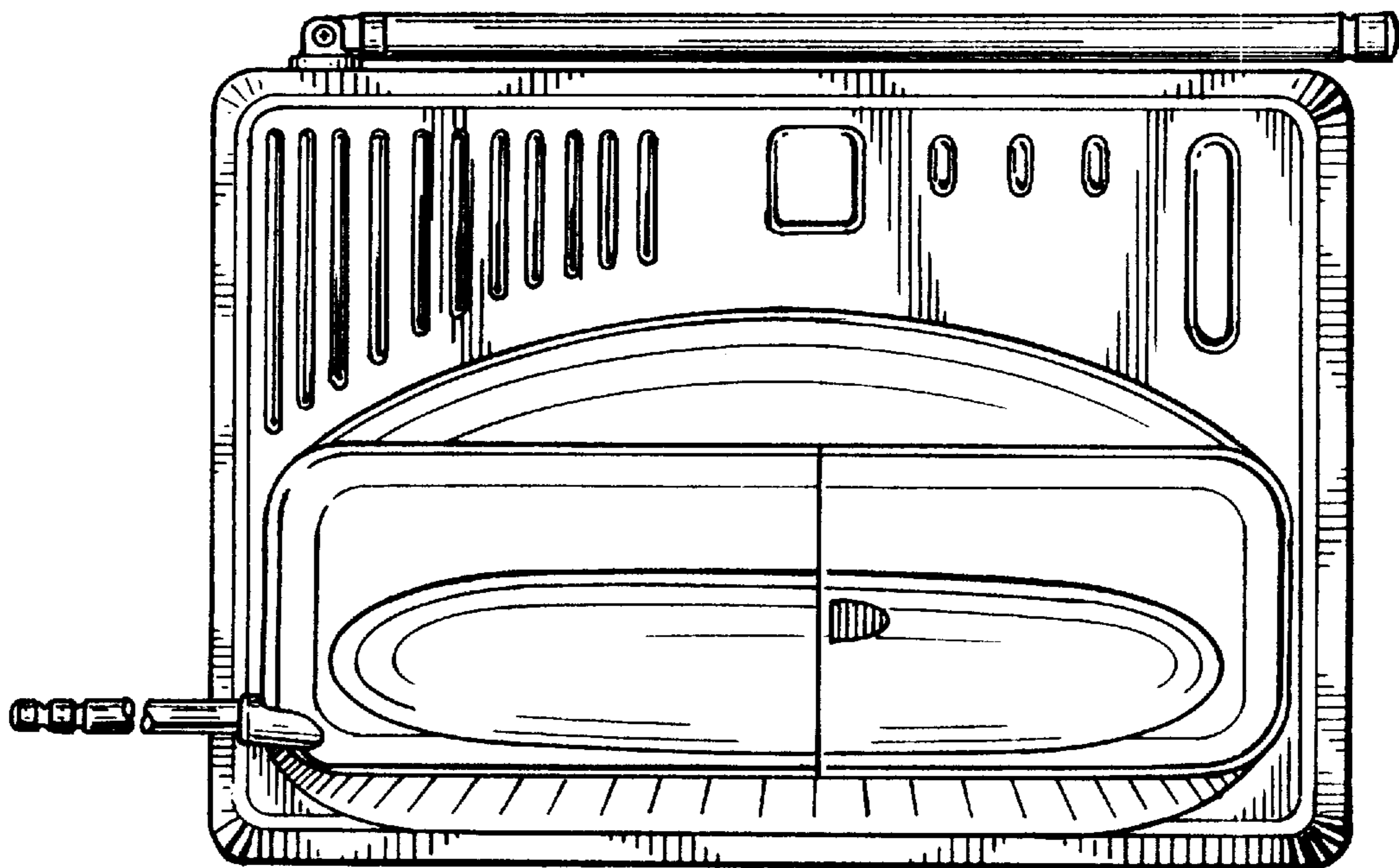

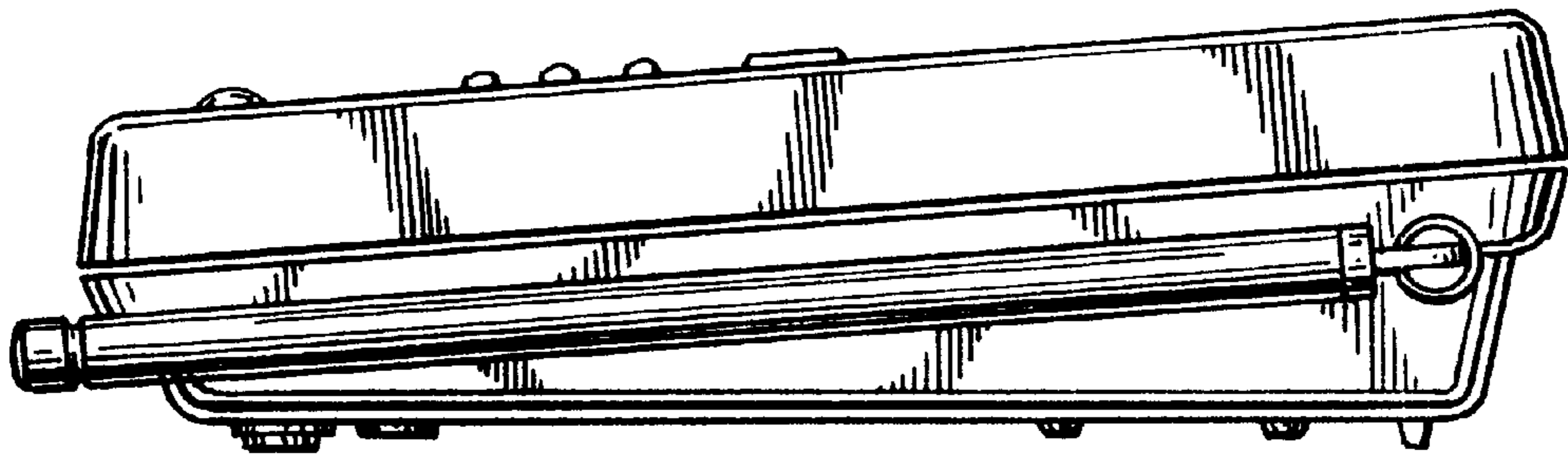

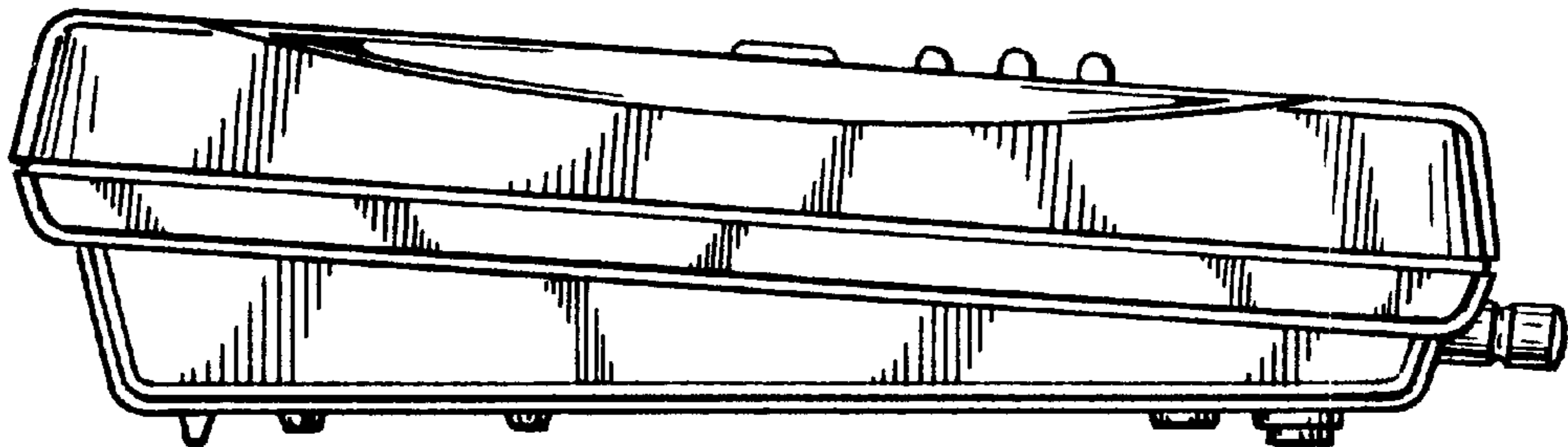

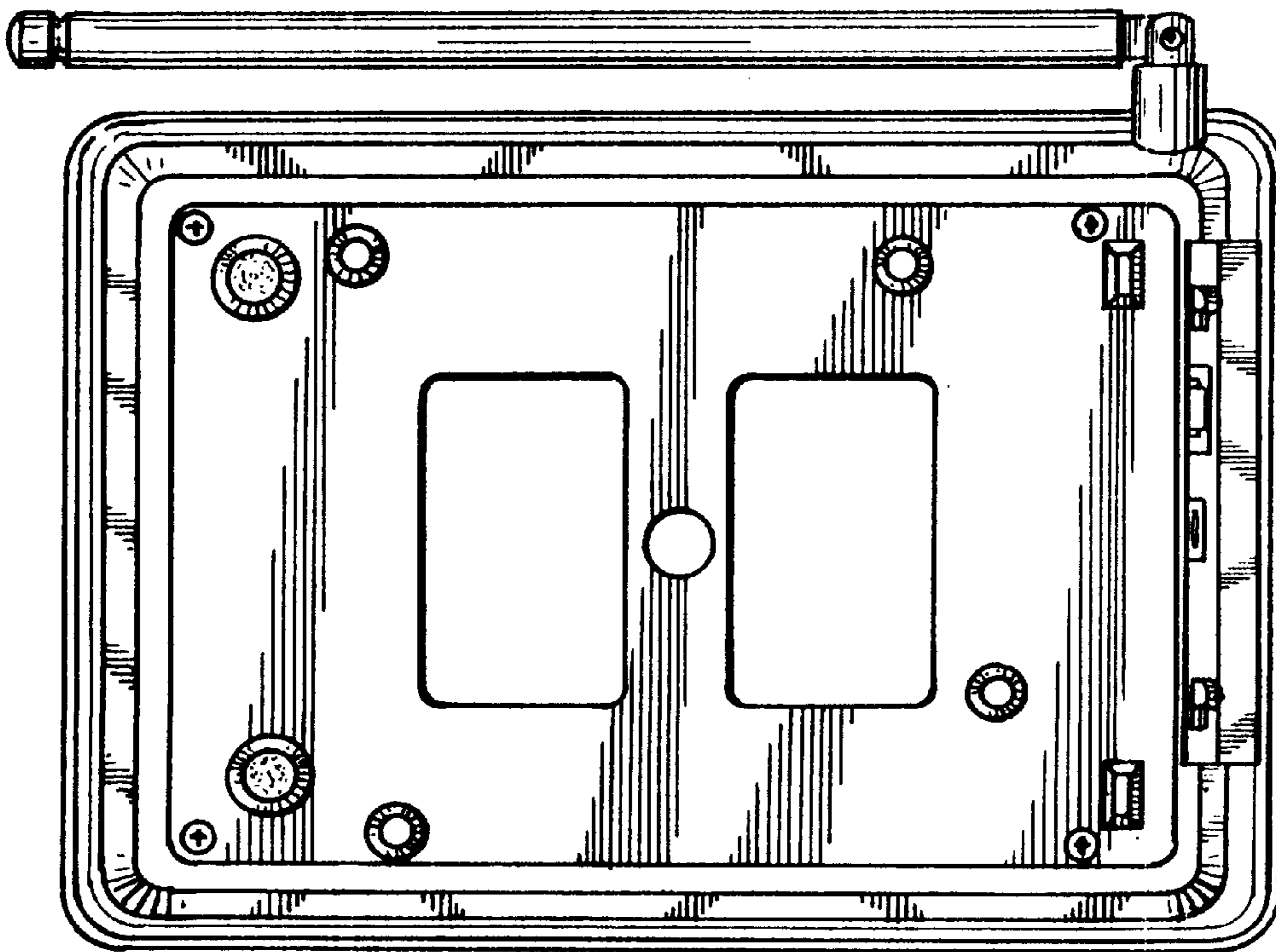

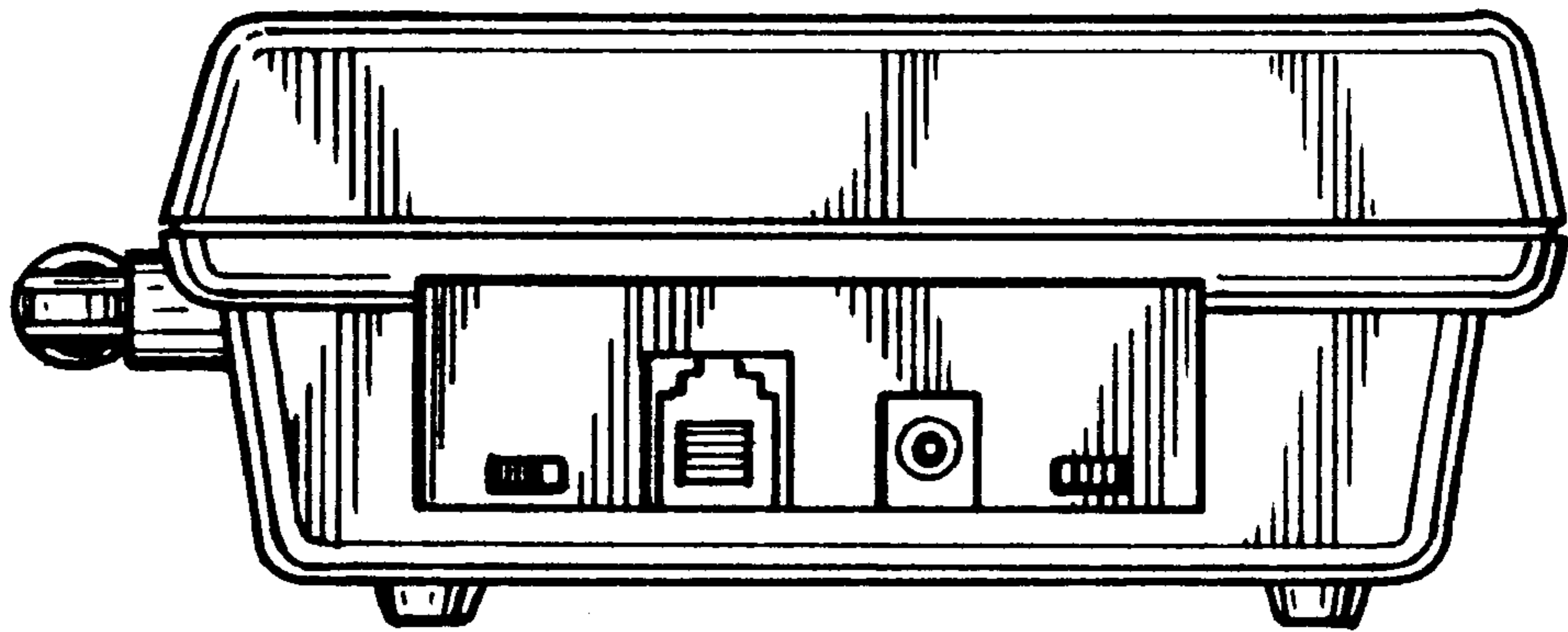

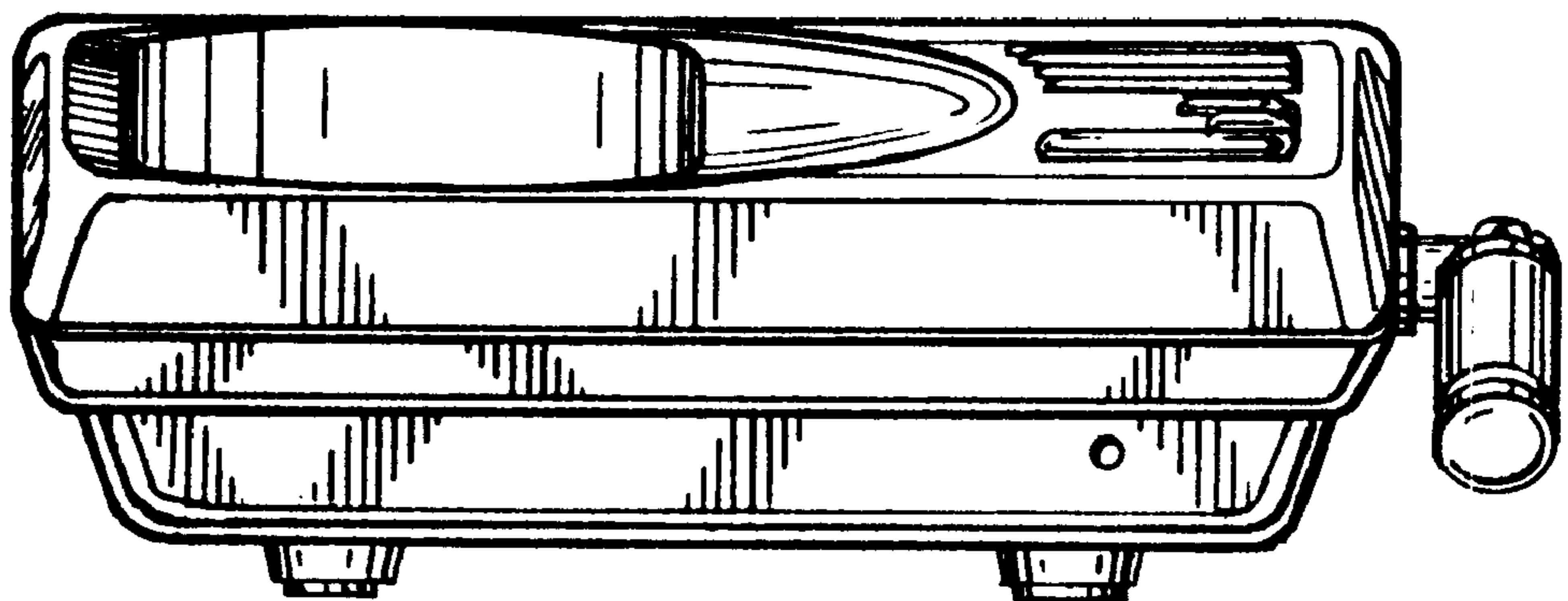
