DESCRIPTION

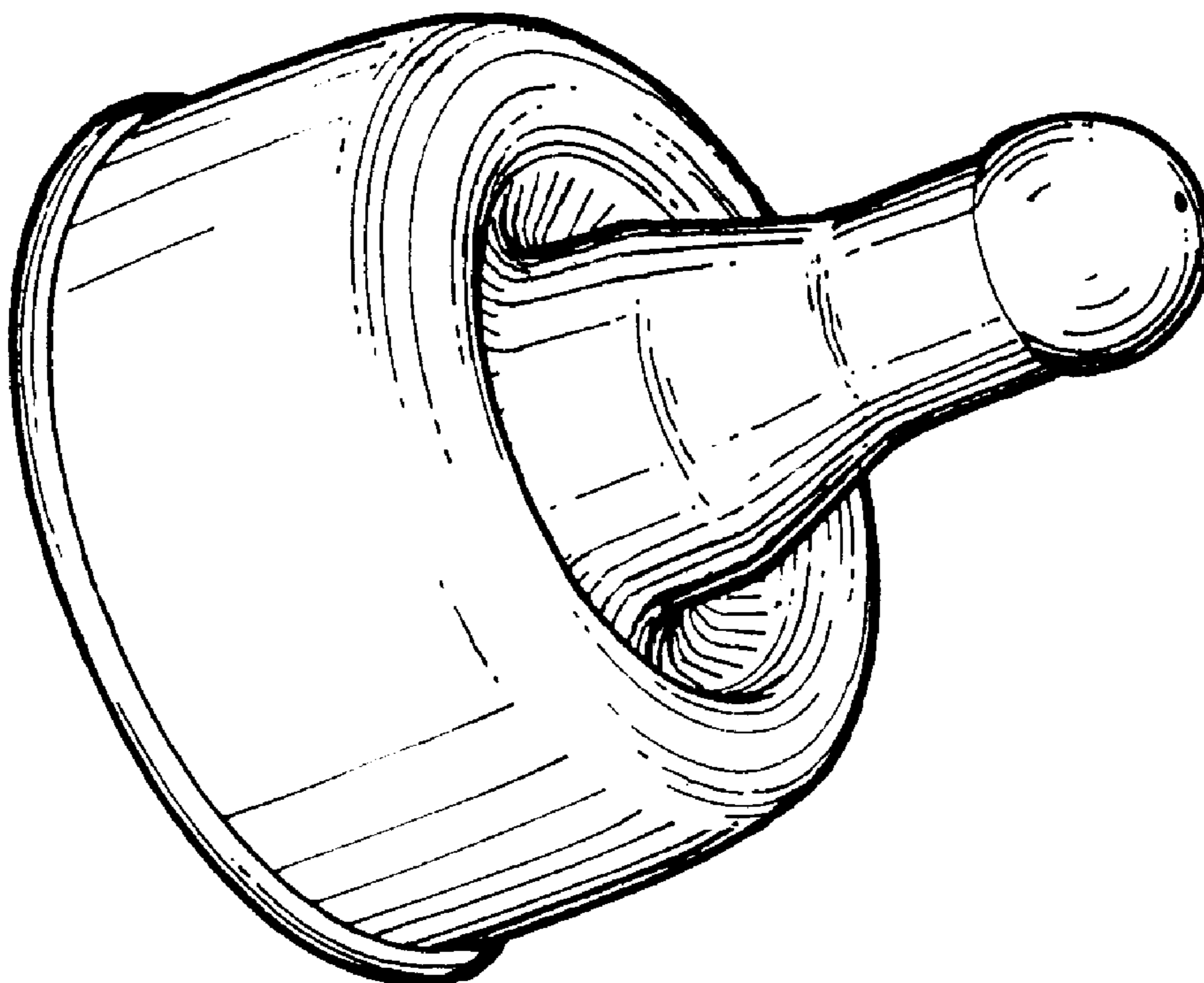
FIG. 1 is perspective view of a combined nipple and collar, showing our new design;

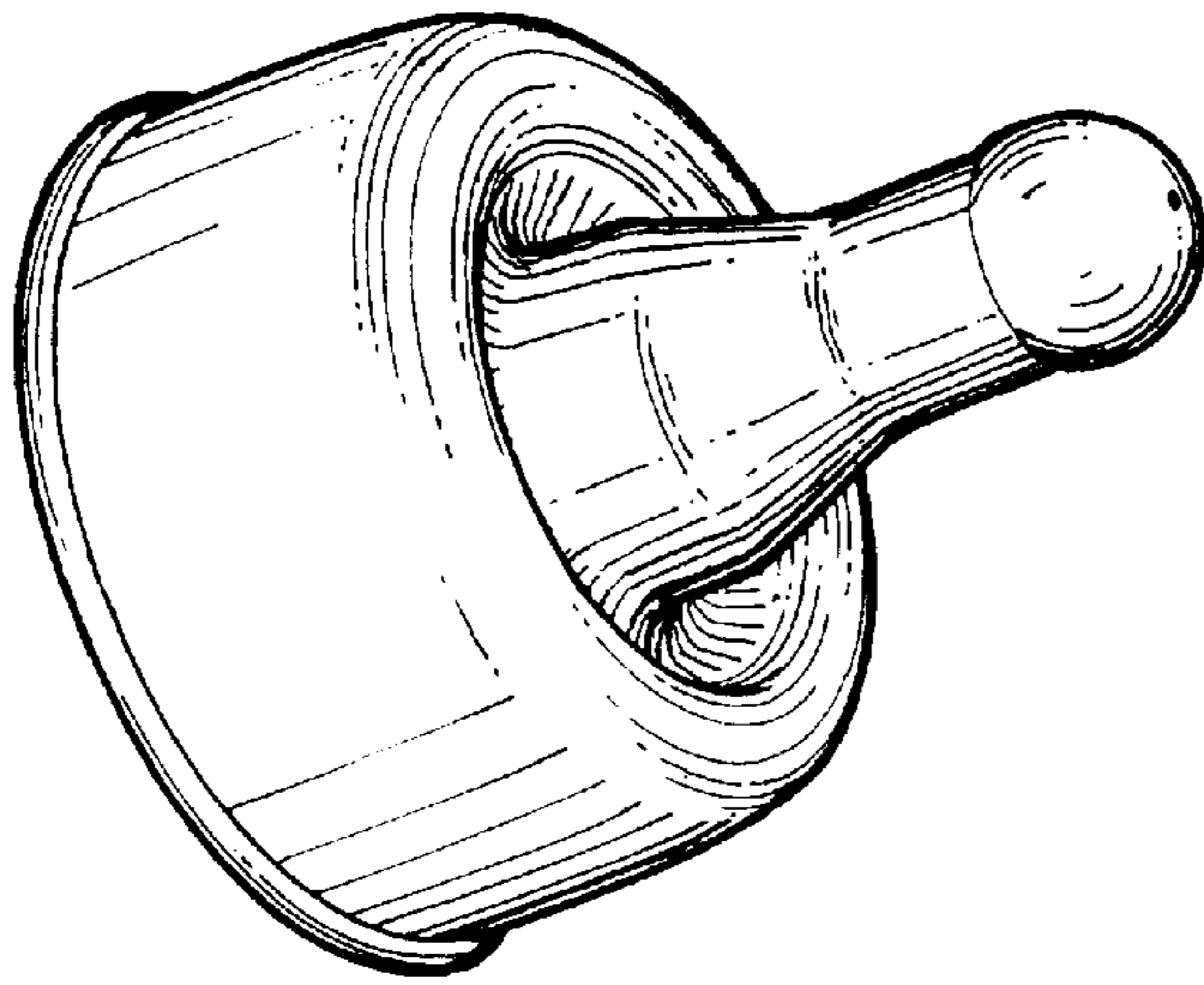

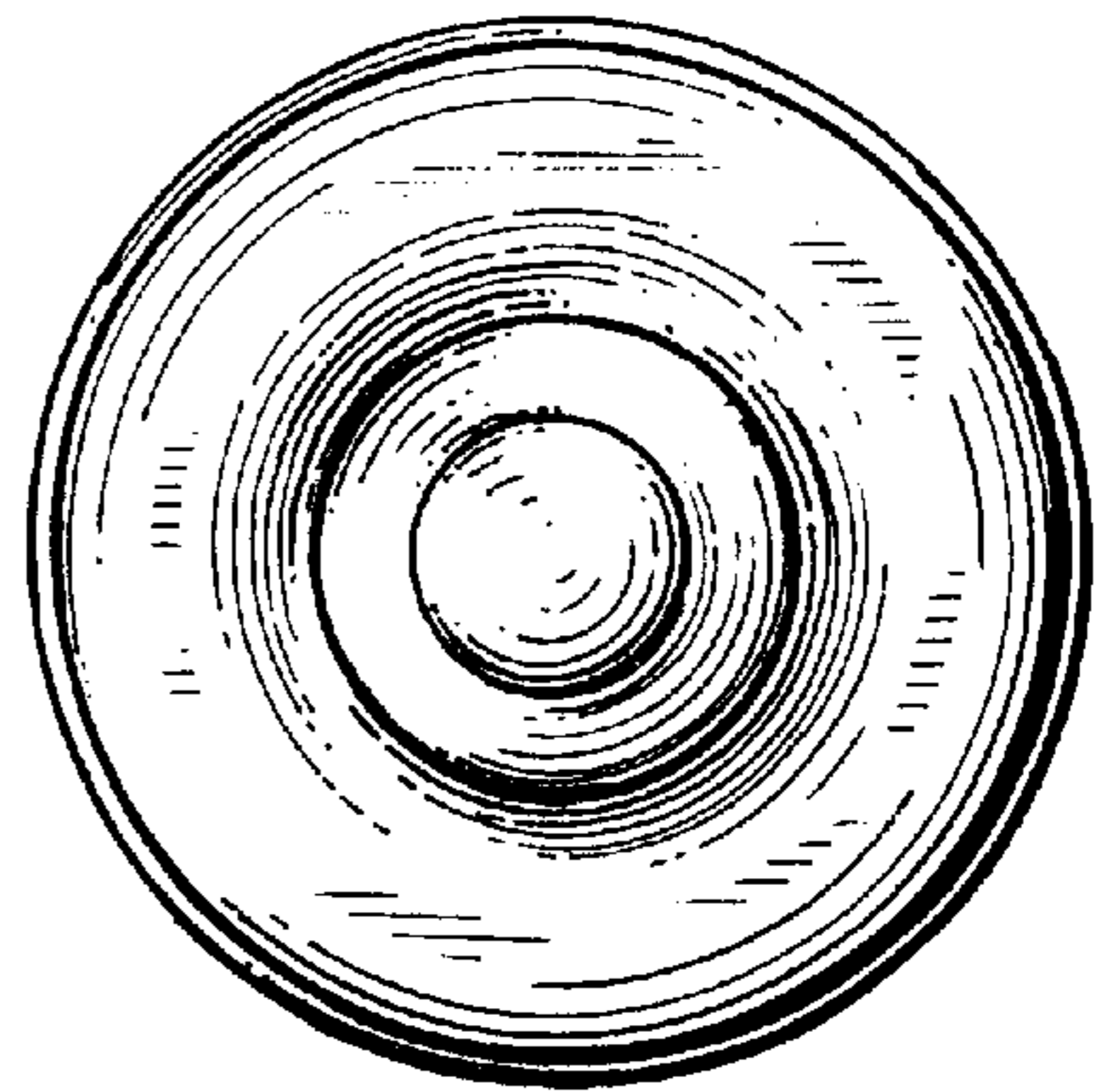

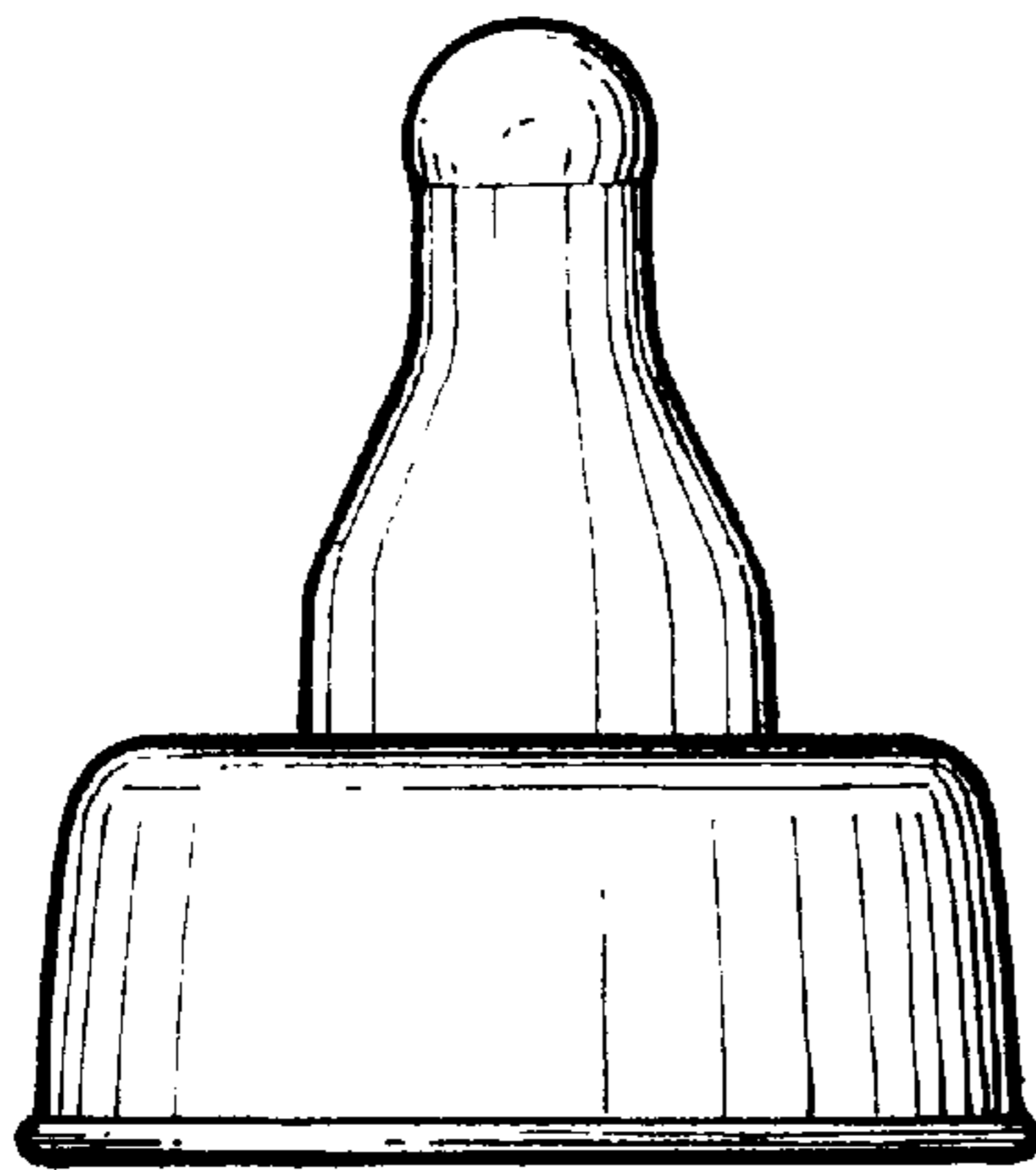

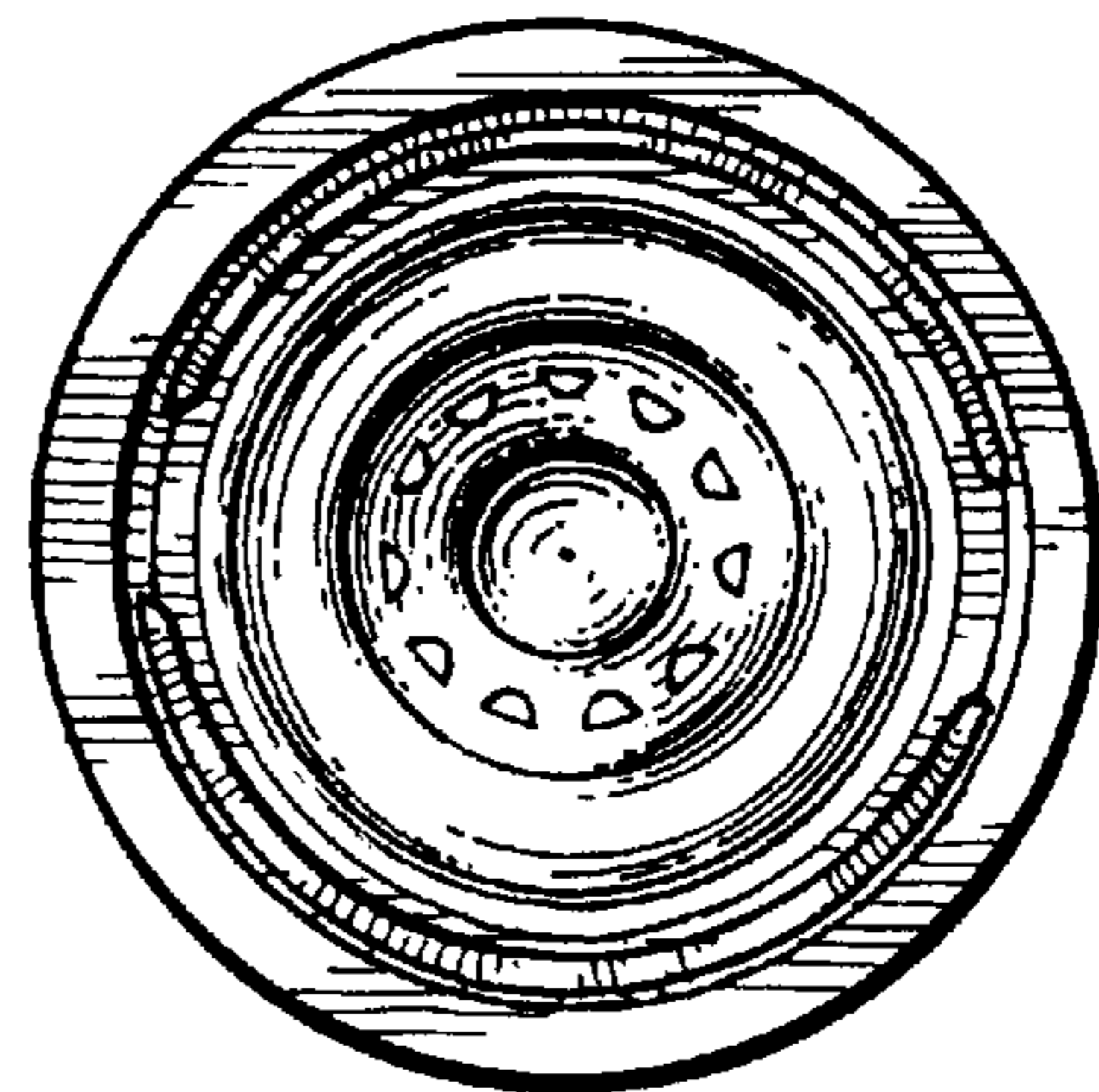

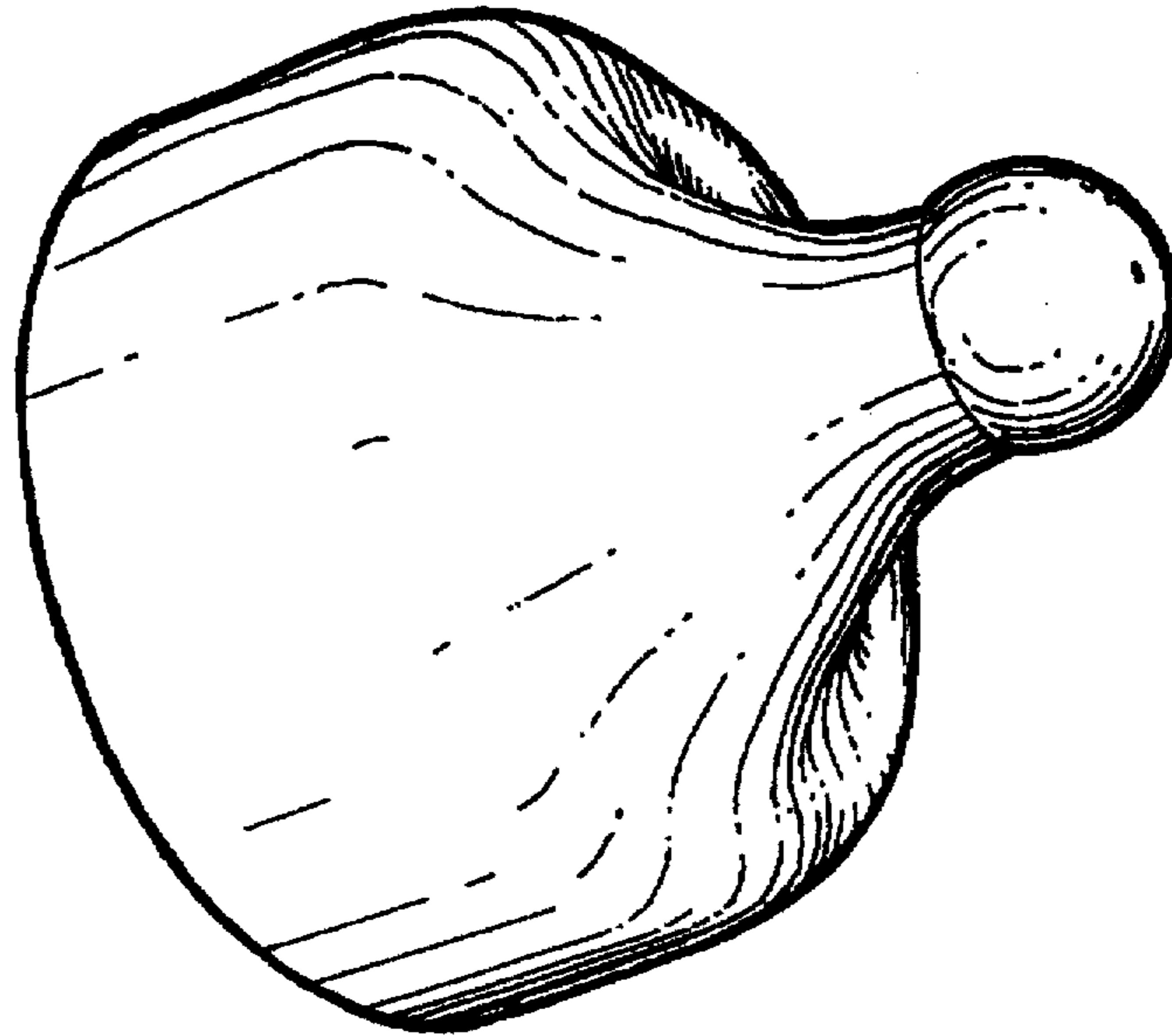

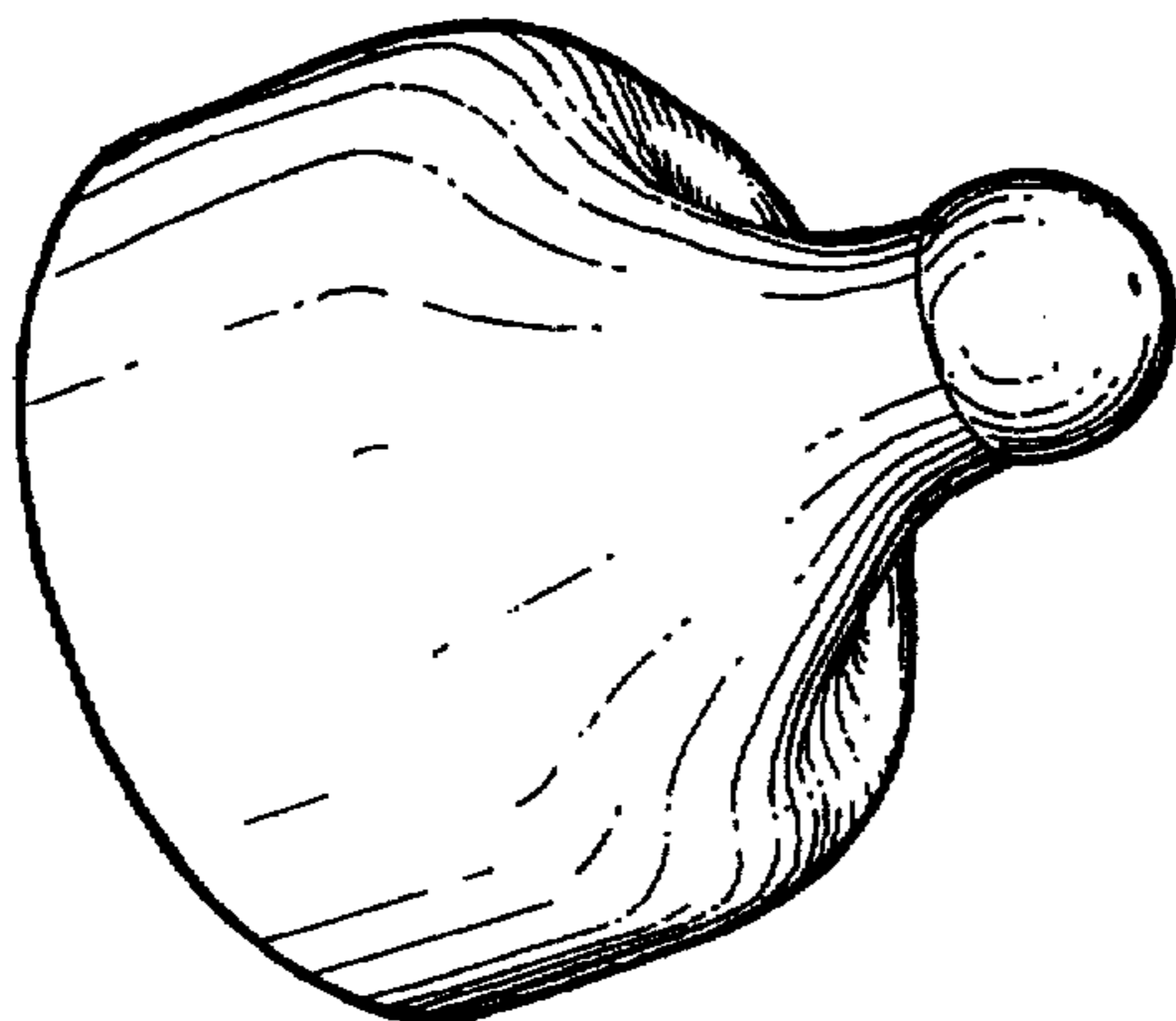

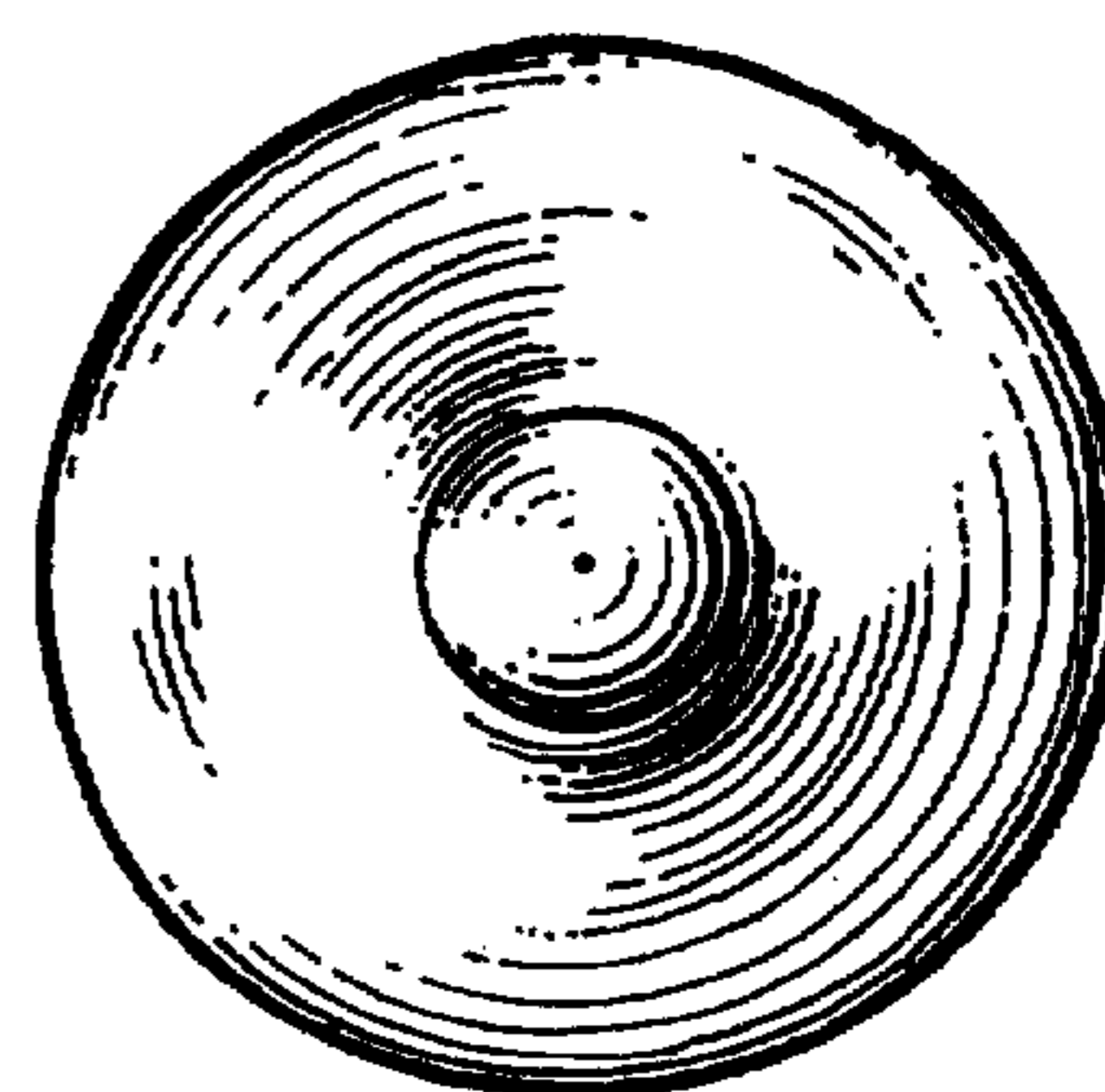

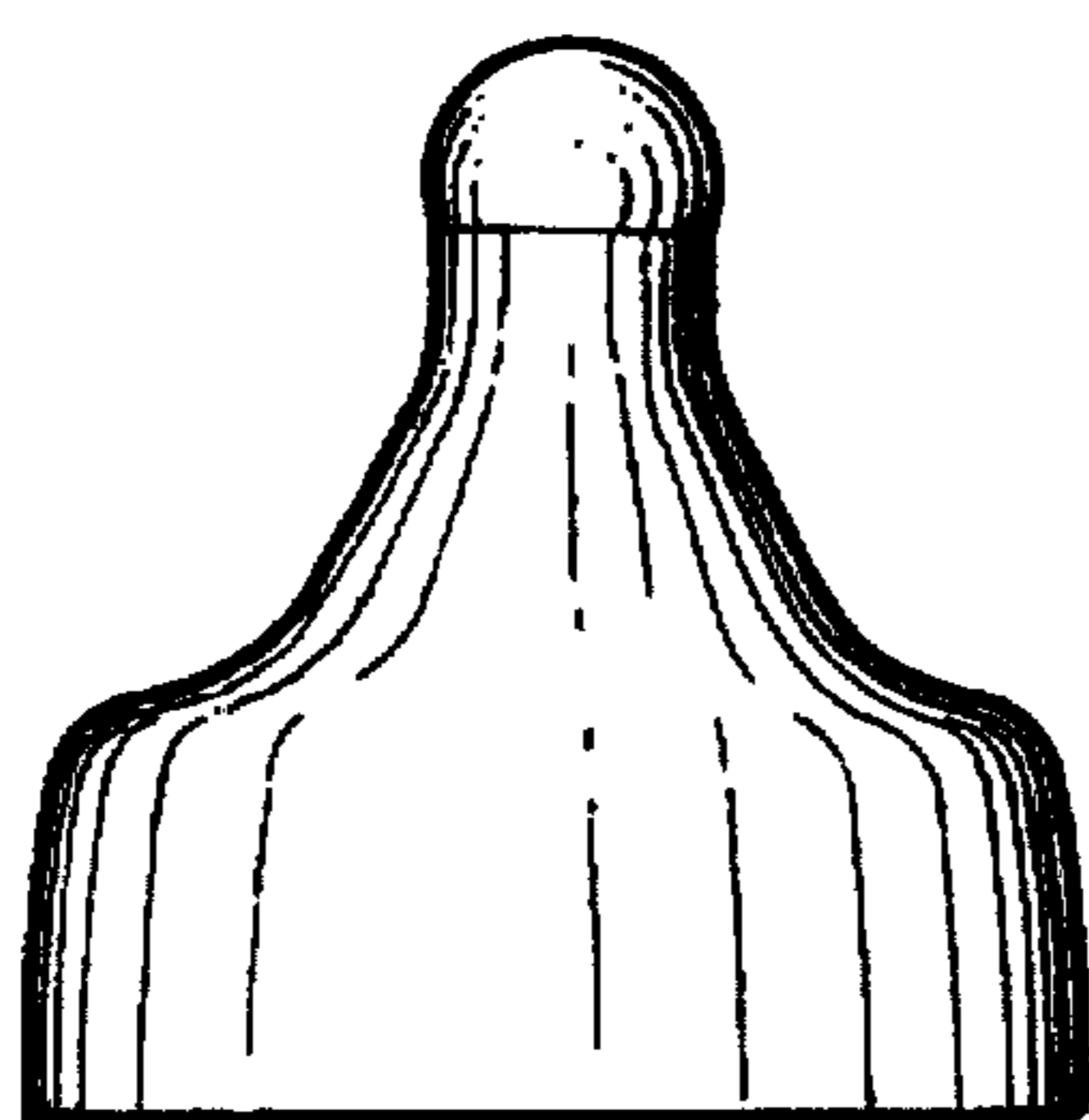

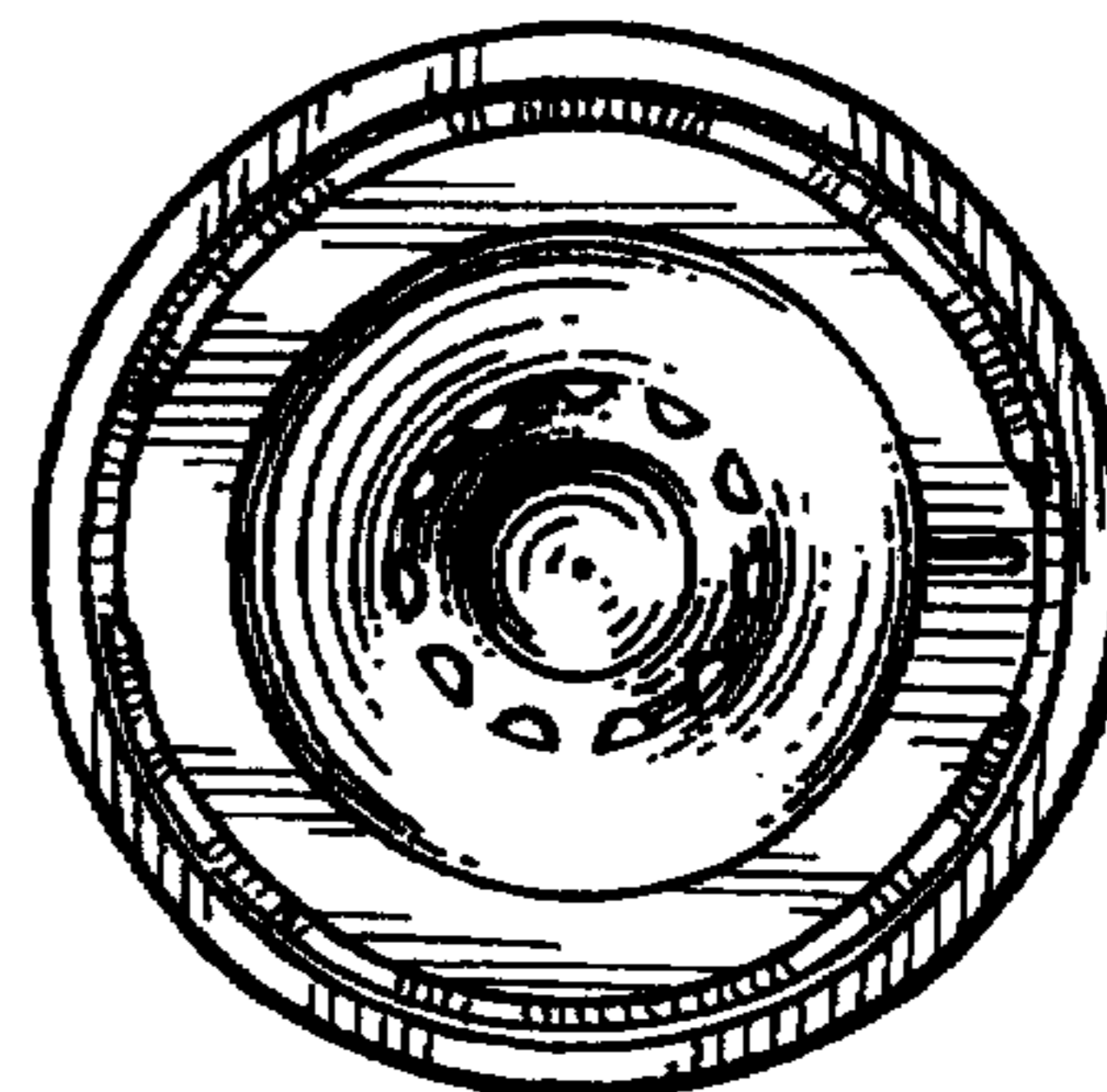
