[57] **CLAIM**

The ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the razor handle; FIG. 2 is a front perspective view of the razor handle; FIG. 3 is a top end view of the razor handle; FIG. 4 is a bottom end view of the razor handle; FIG. 5 is a rear view of the razor handle; FIG. 6 is a side view of the razor handle; FIG. 7 is a front view of the razor handle; and, FIG. 8 is a perspective view of the razor handle in a holder. The broken line showing of the holder is for illustrative purposes only and forms no part of the claimed design.

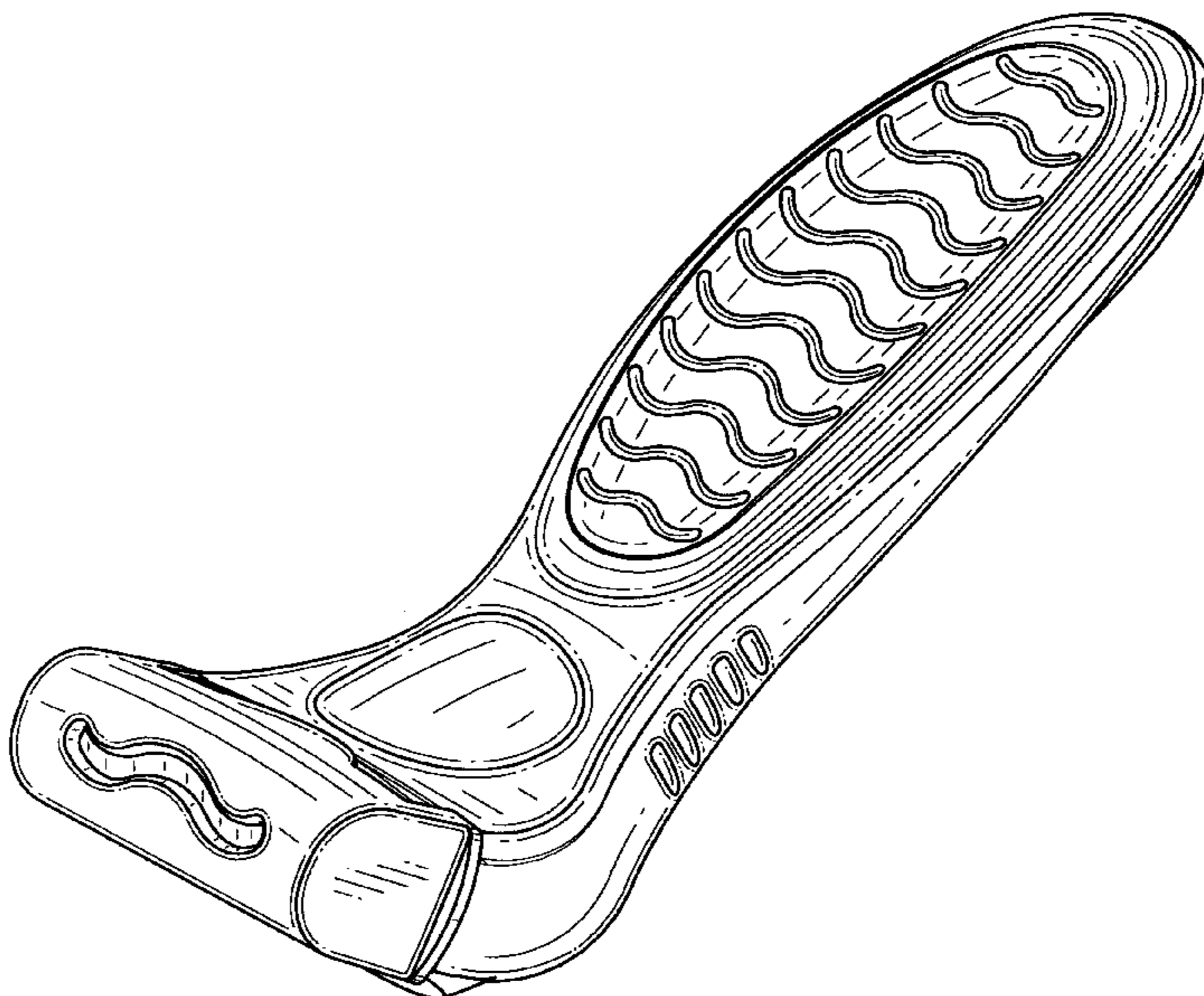
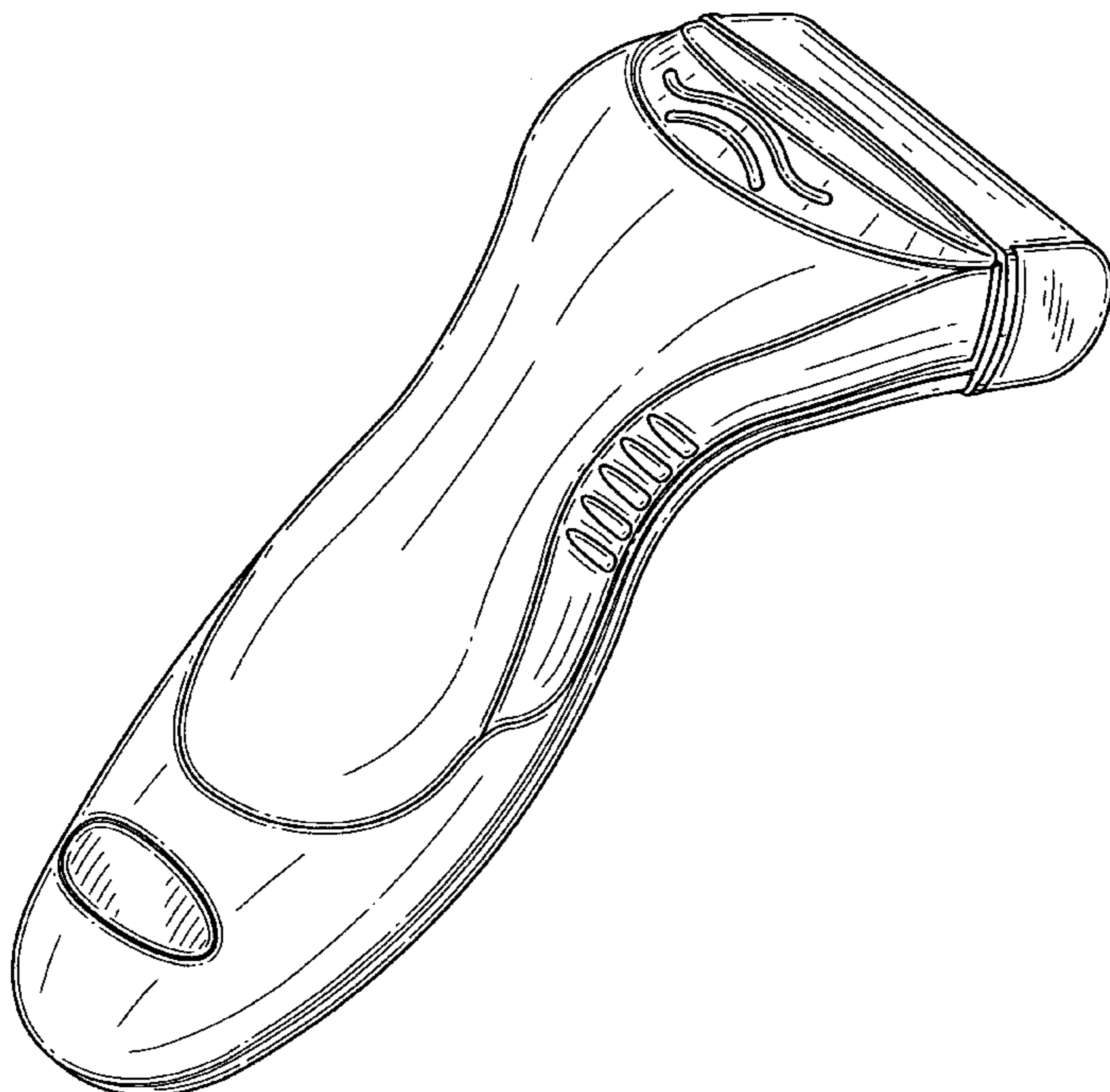

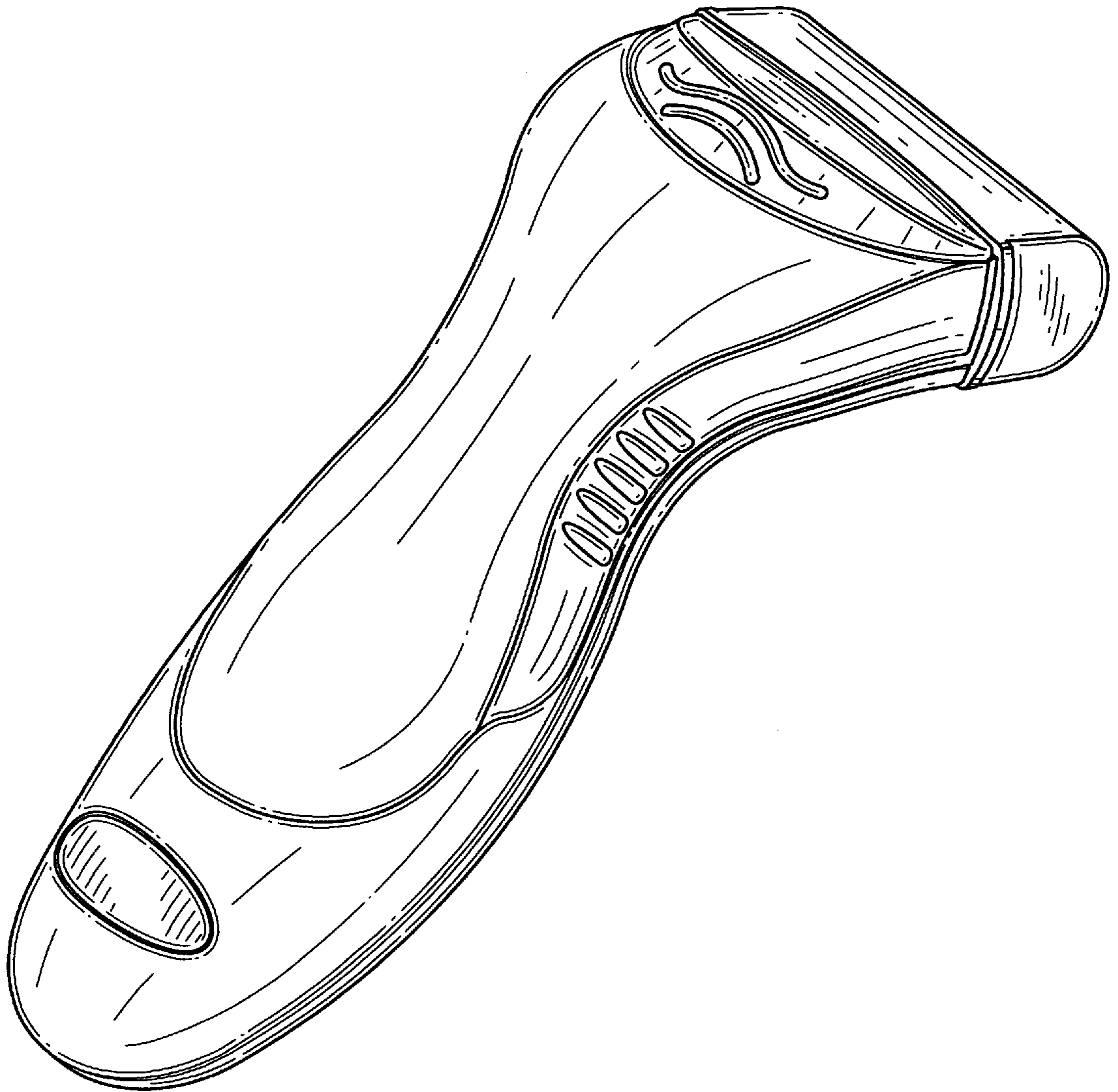

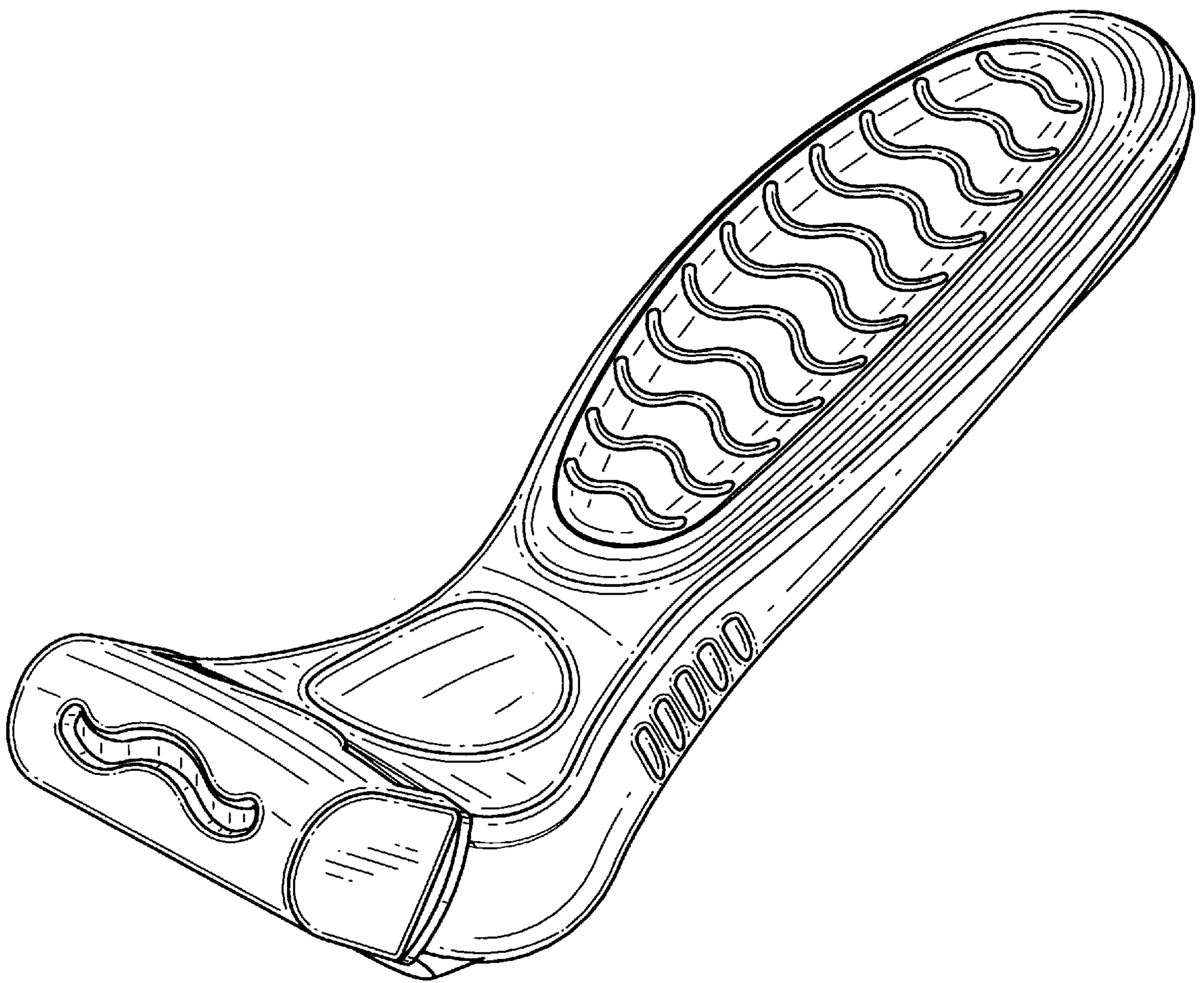

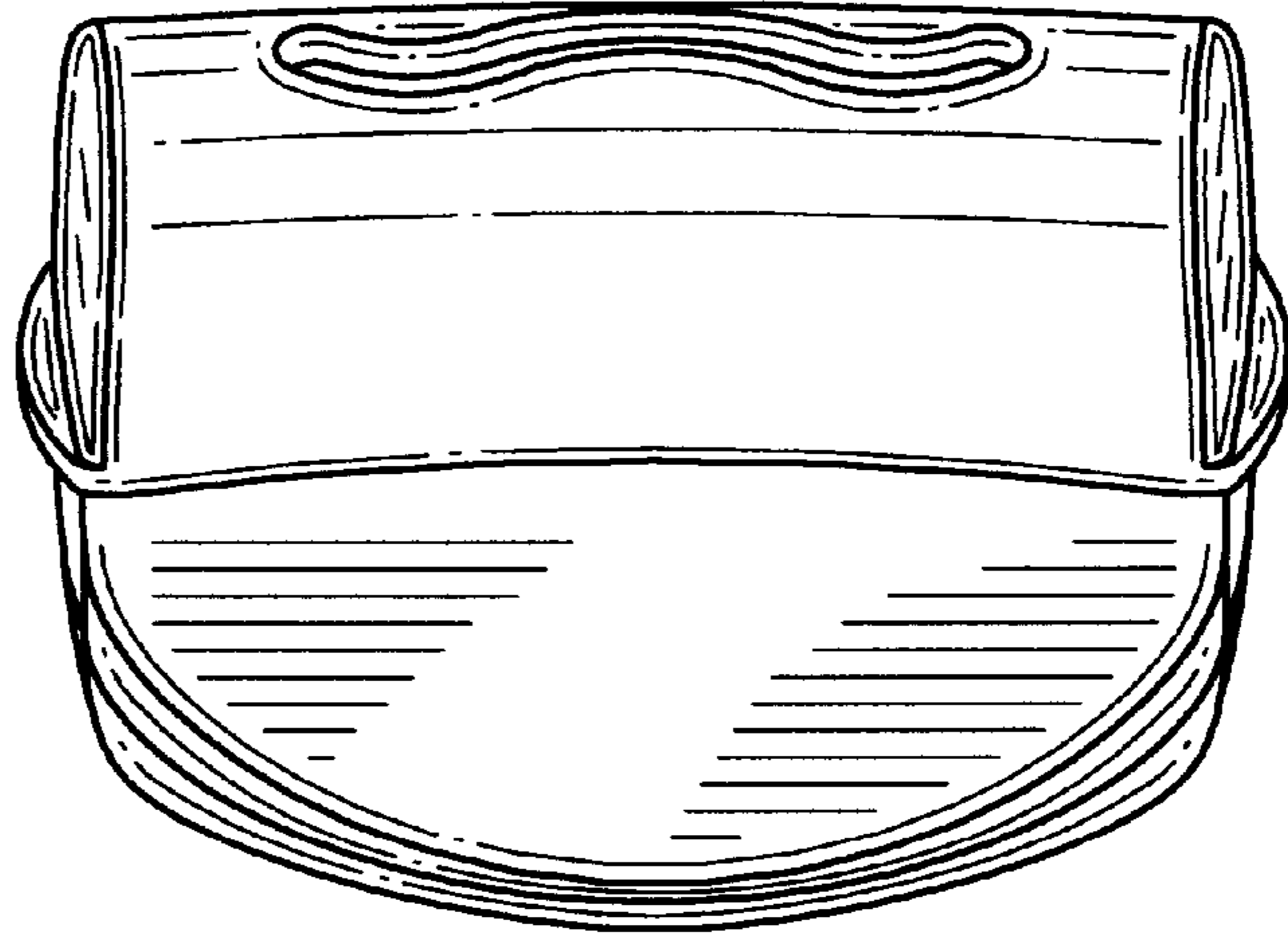

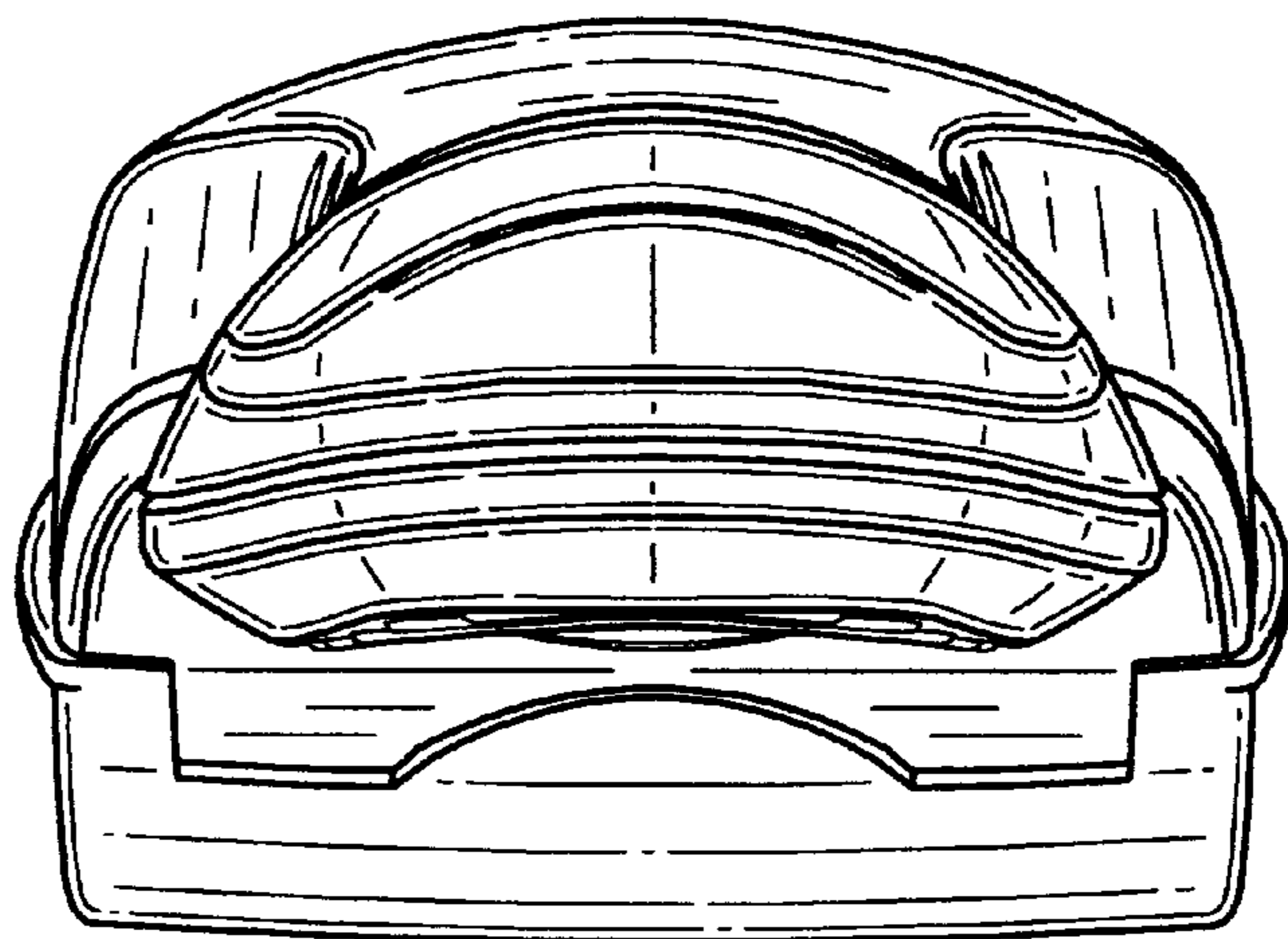

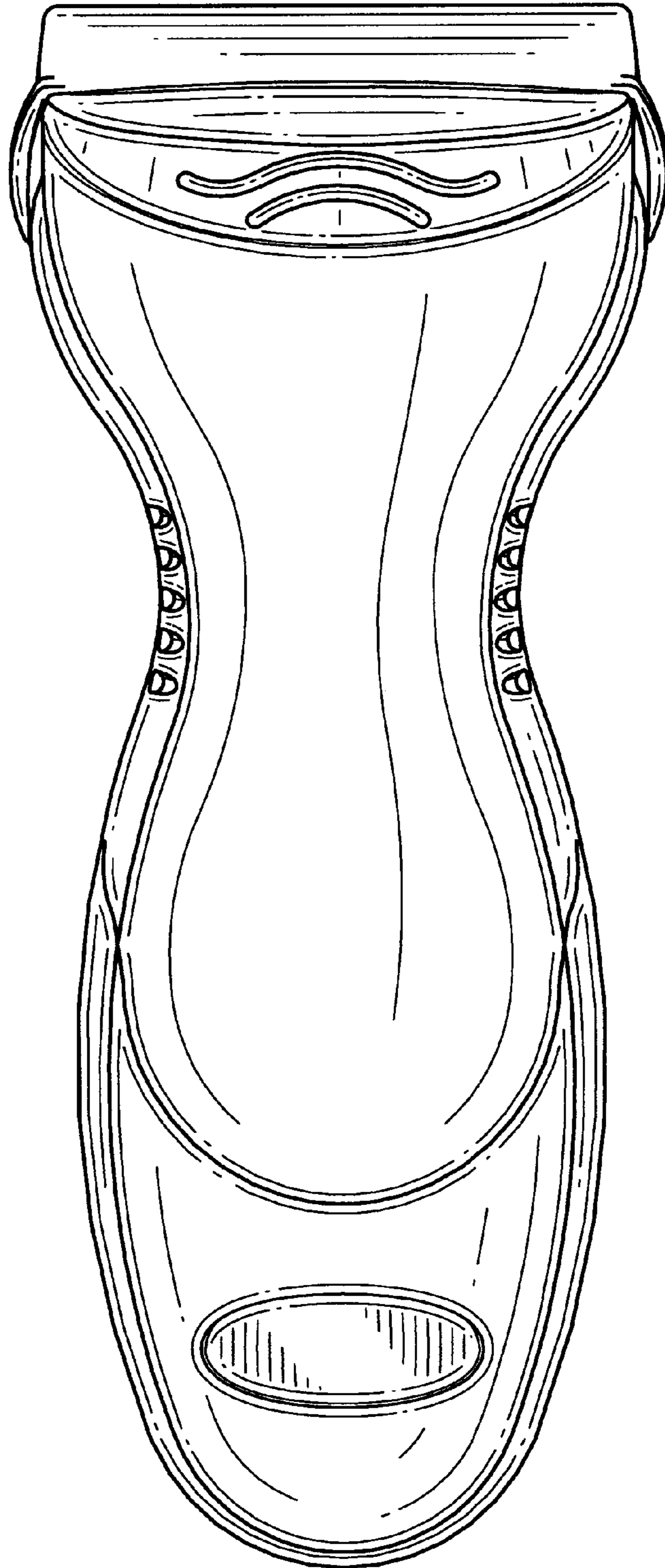

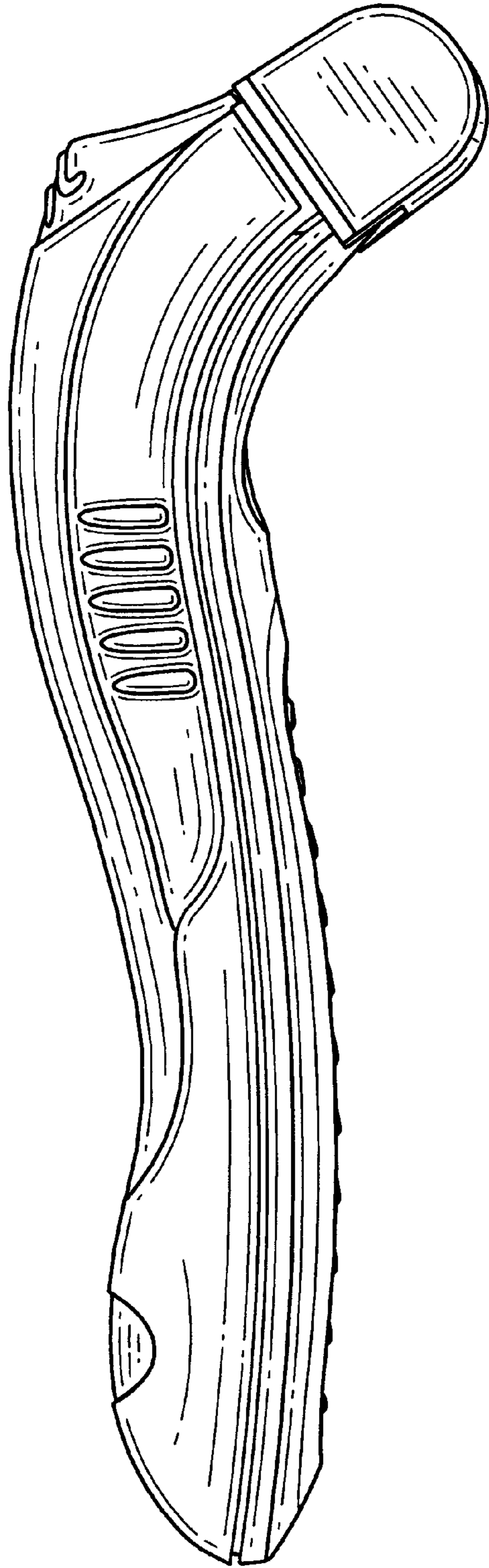

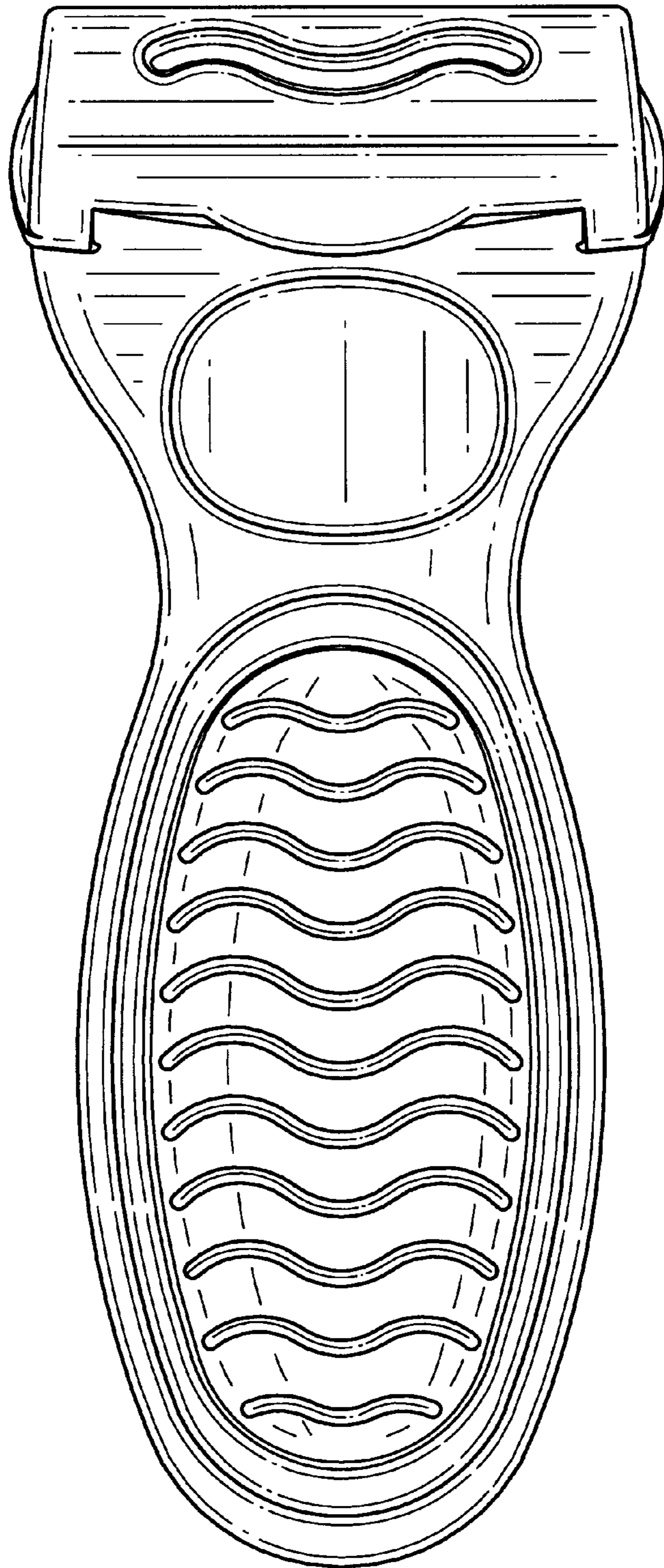
