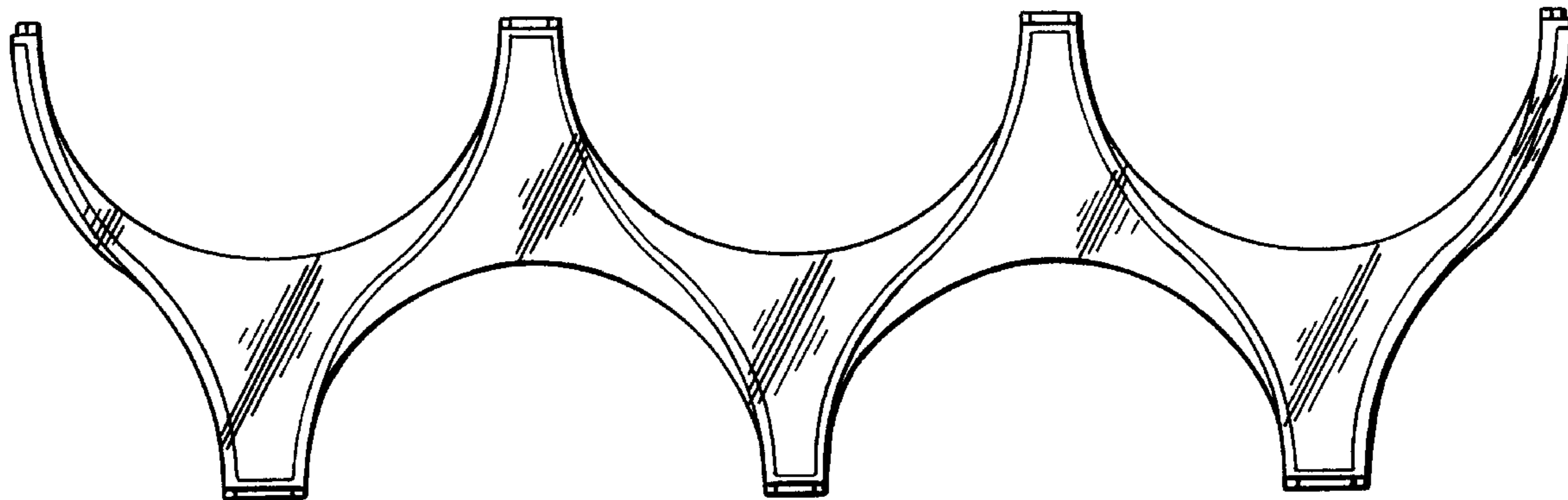
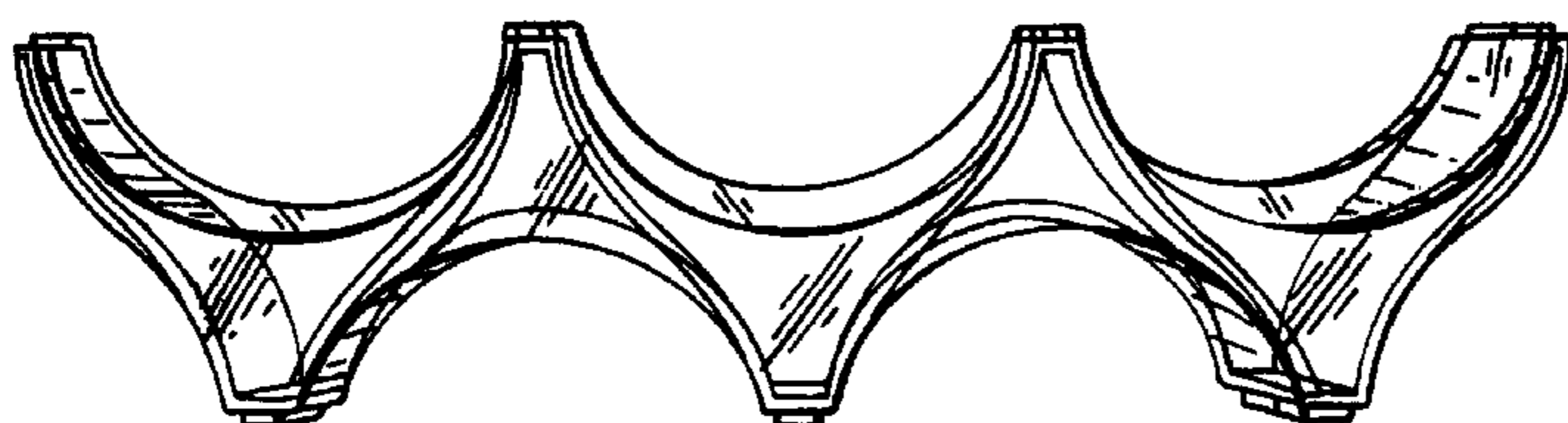
FIG. 9 is a bottom plan view thereof; and,

FIG. 10 is a side view thereof which is a mirror image of the opposite side thereof.

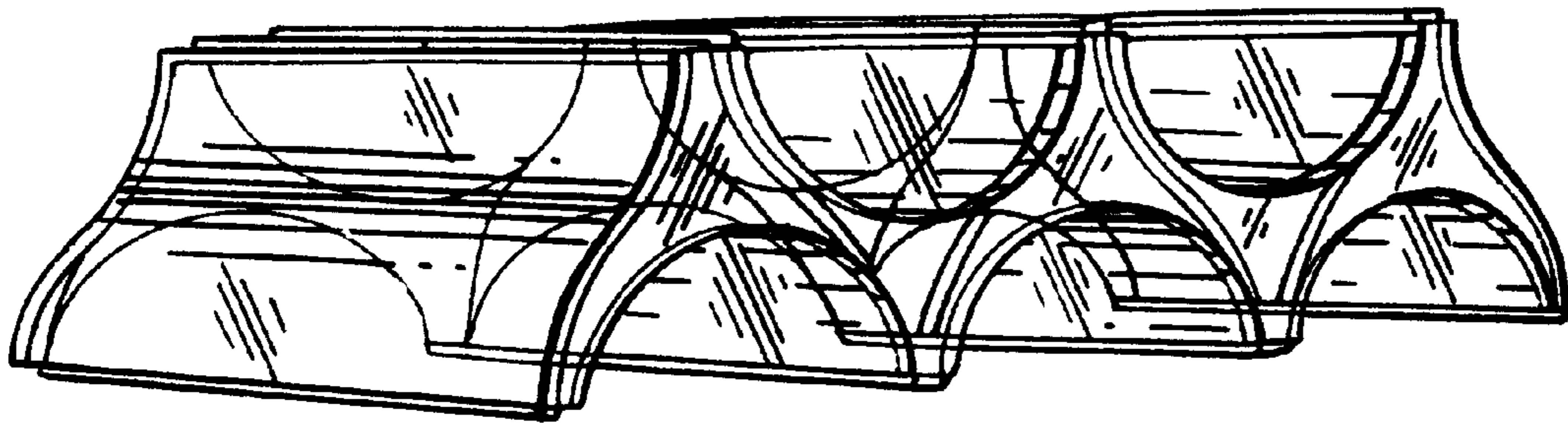
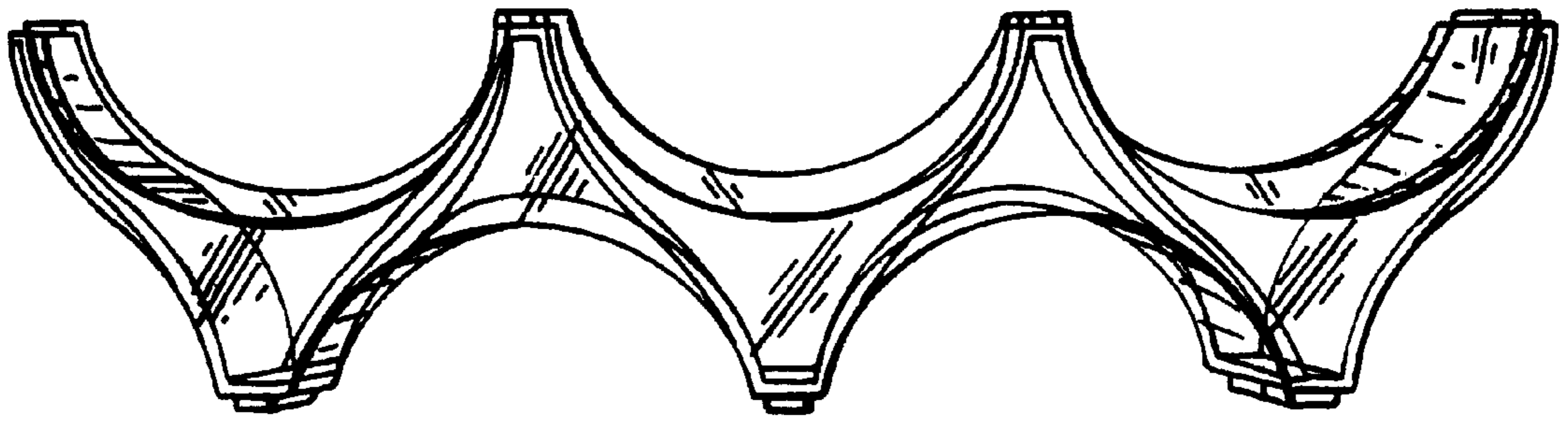

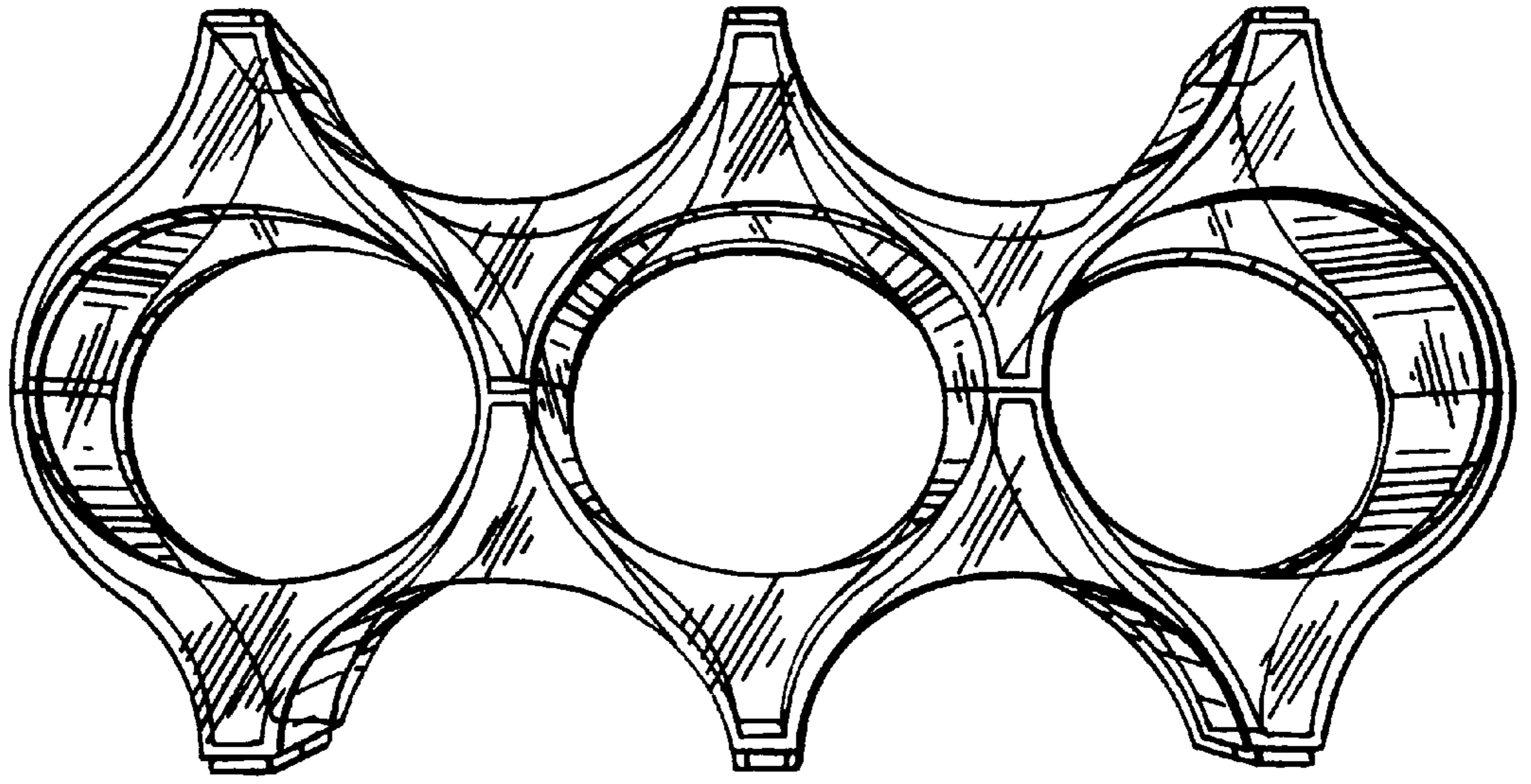

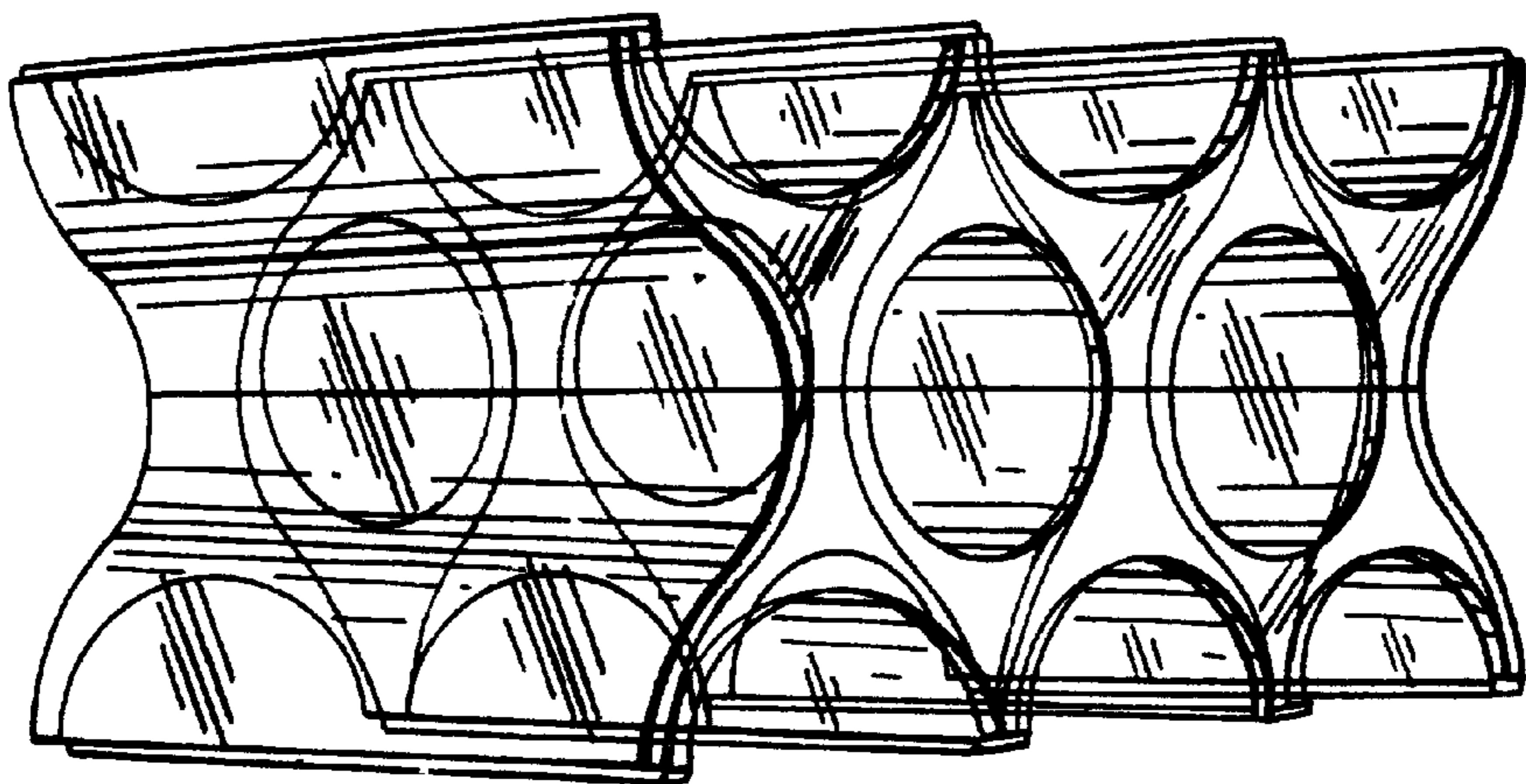

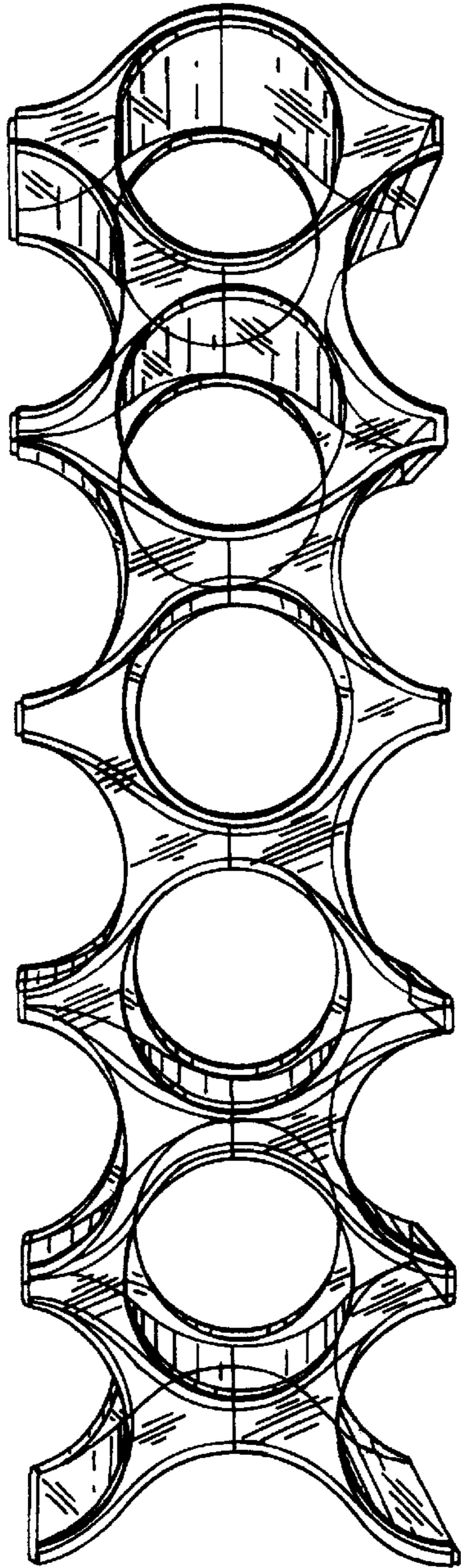

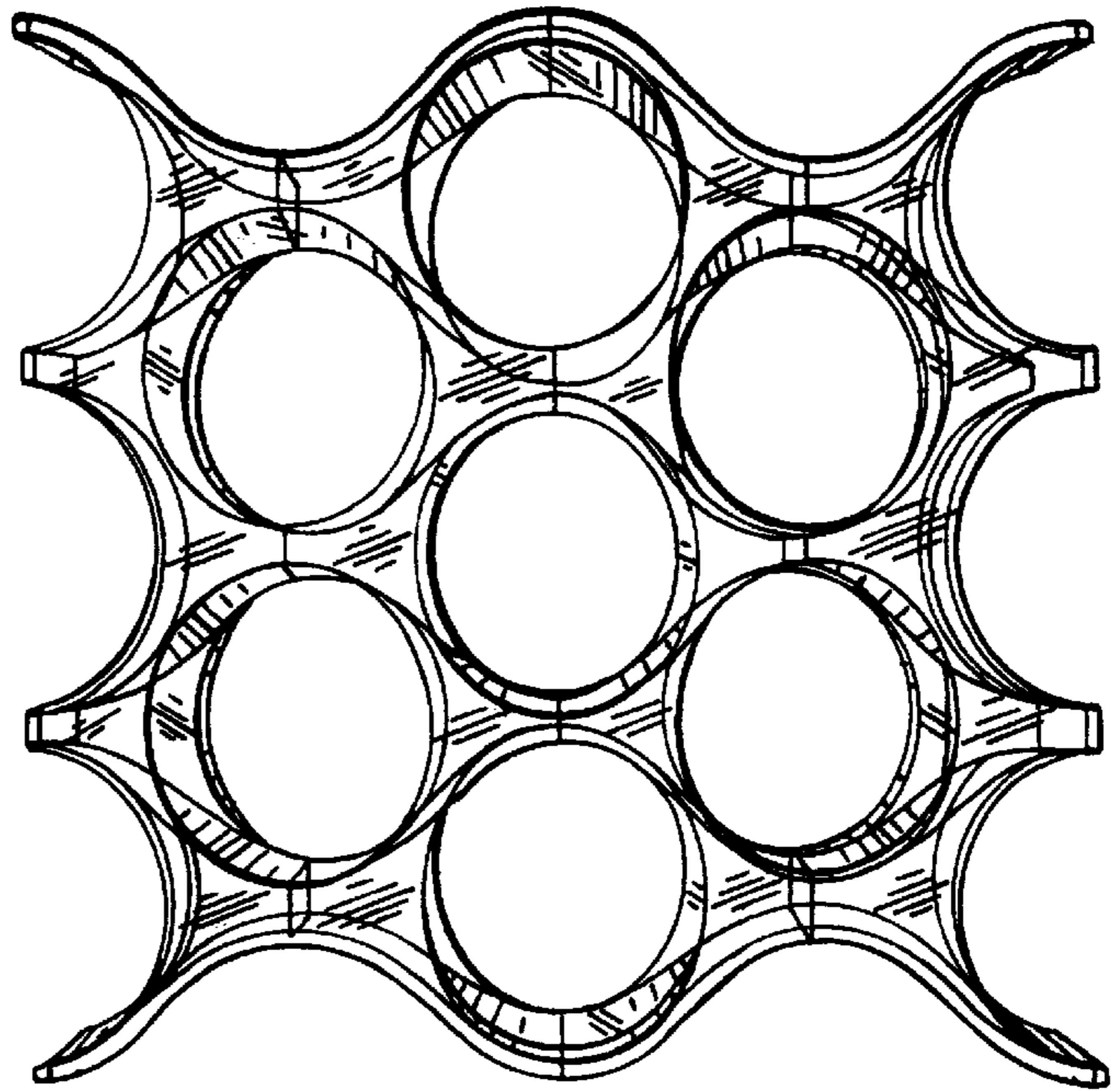
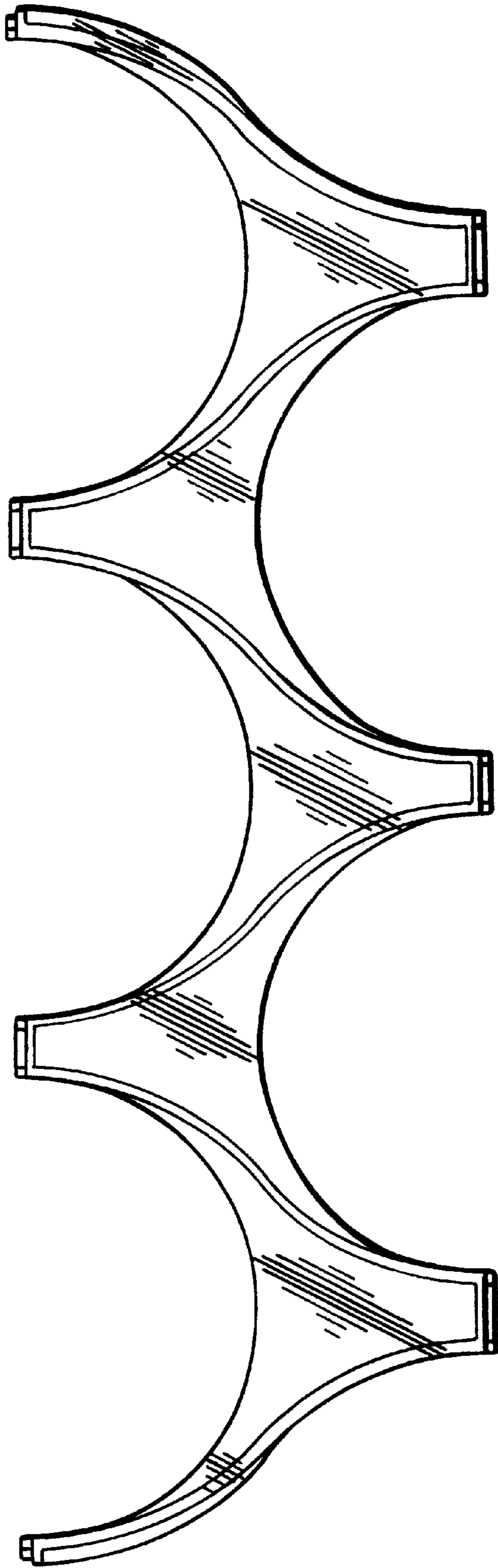

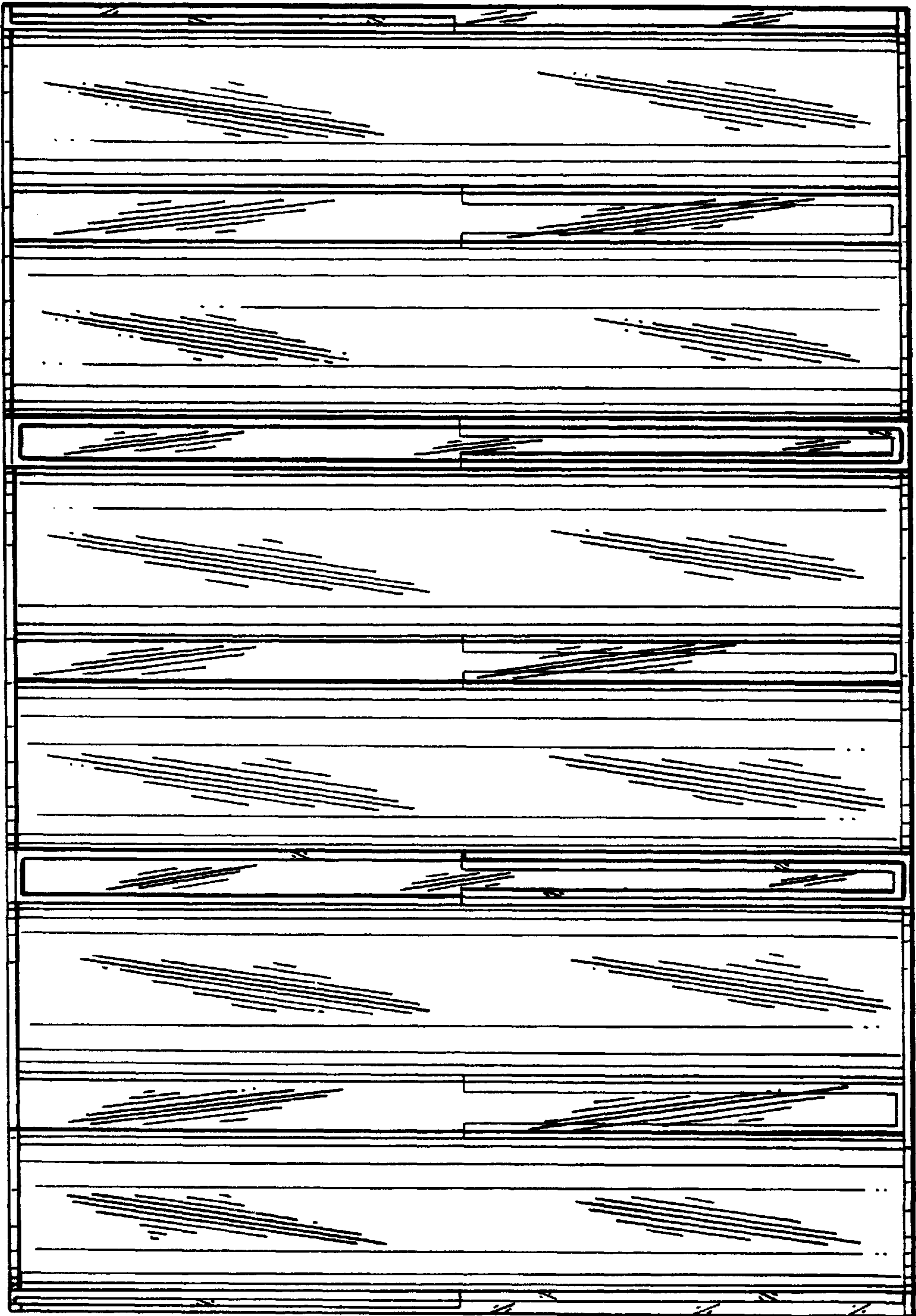

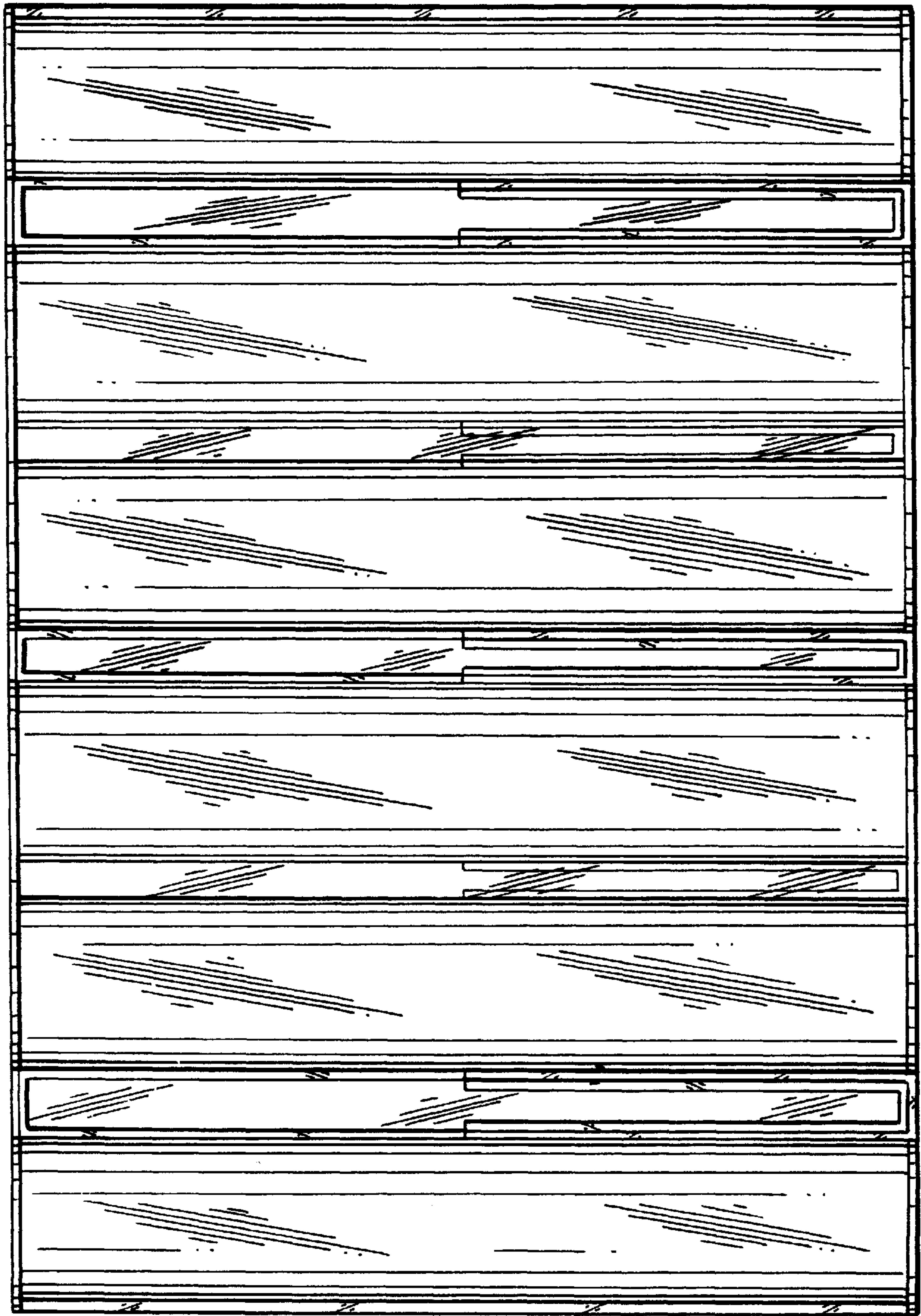
