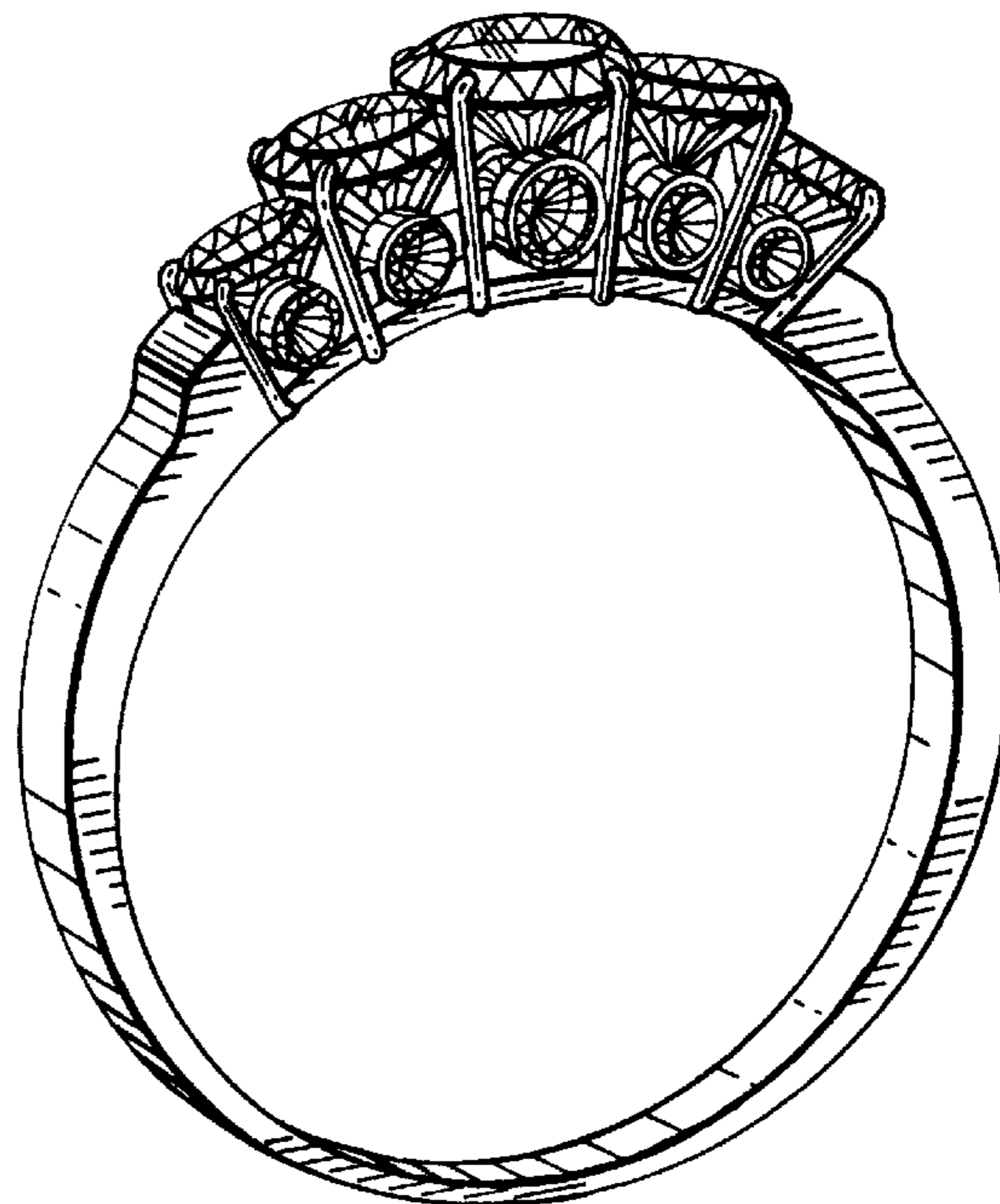
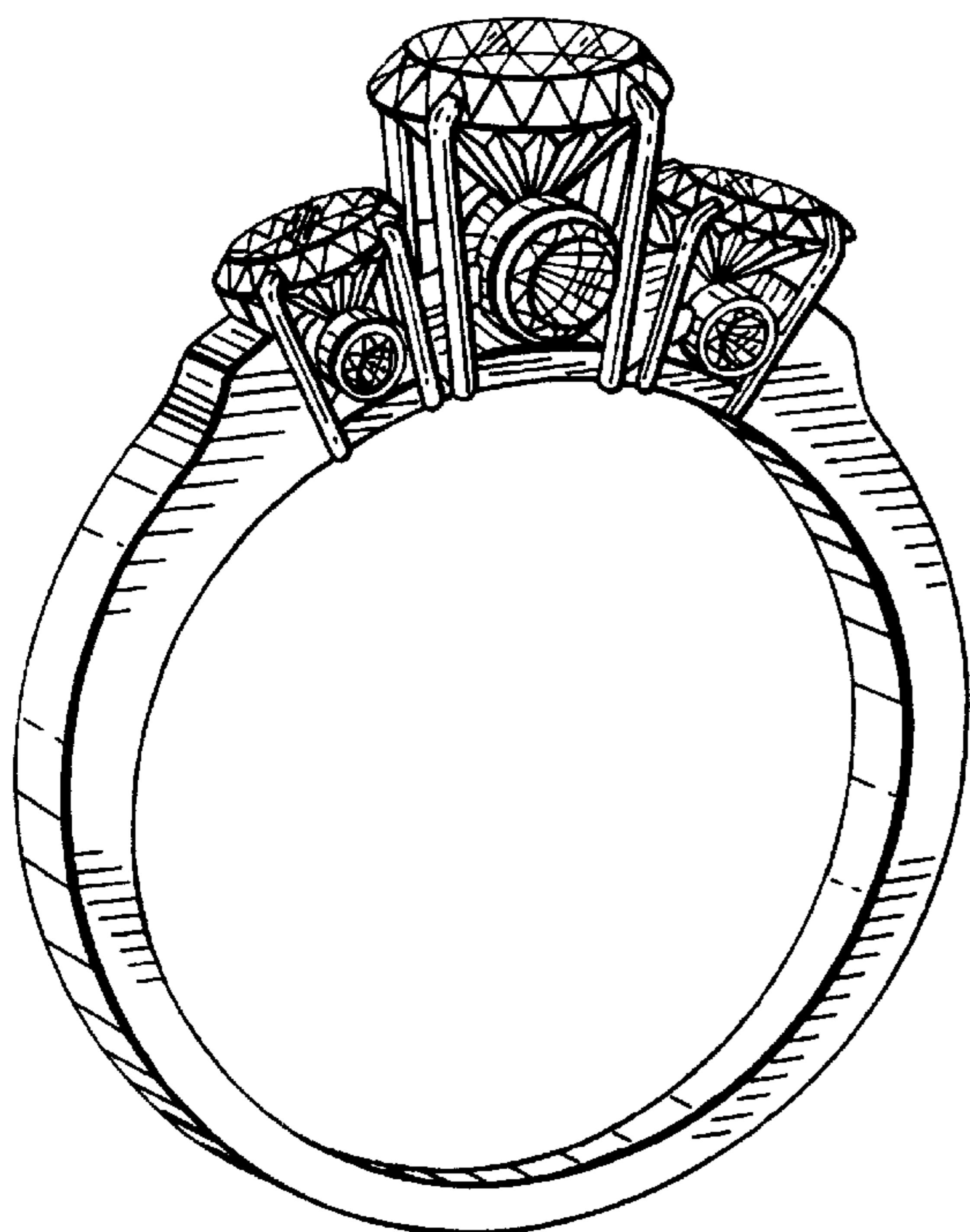

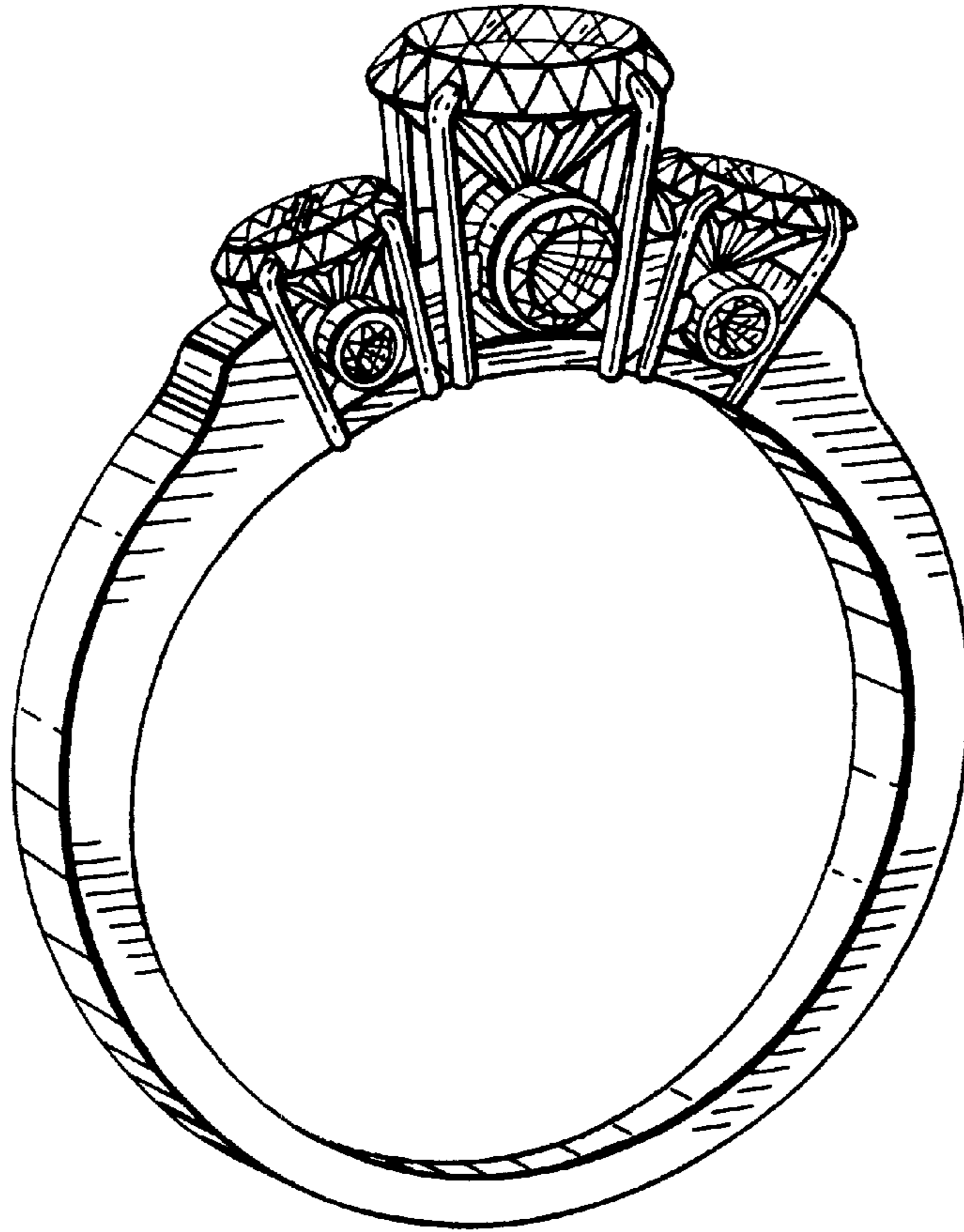
The ornamental design for a ring, as shown and described.

FIG. 10 is a bottom plan view of an alternative embodiment thereof.

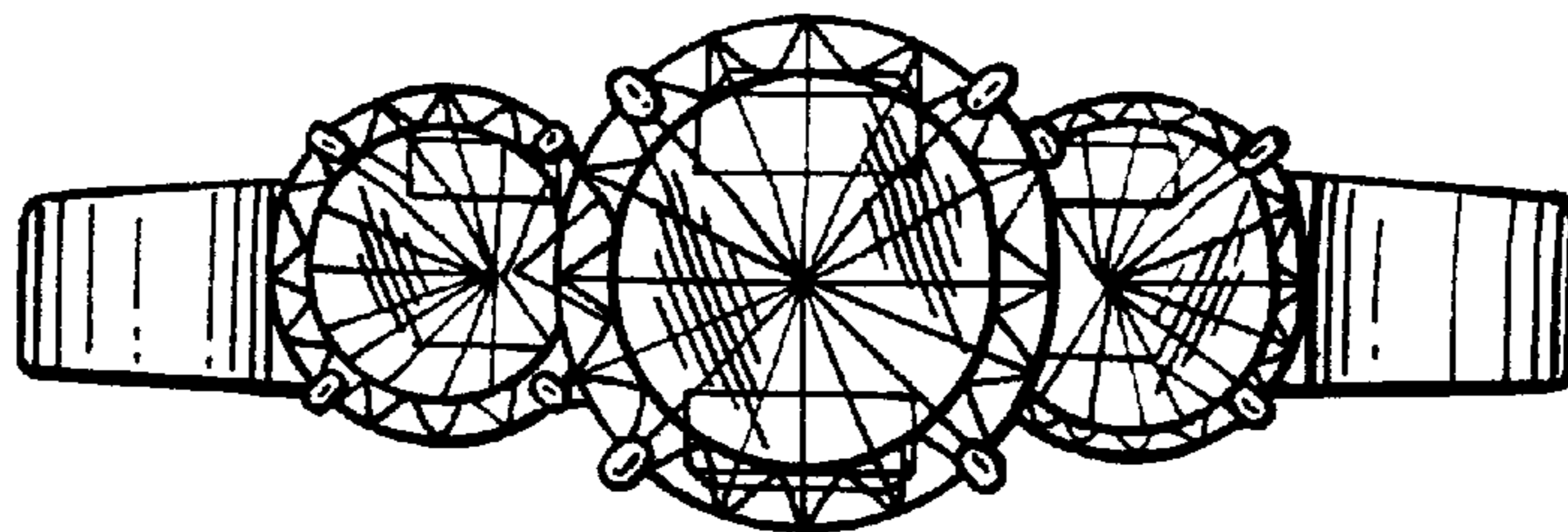

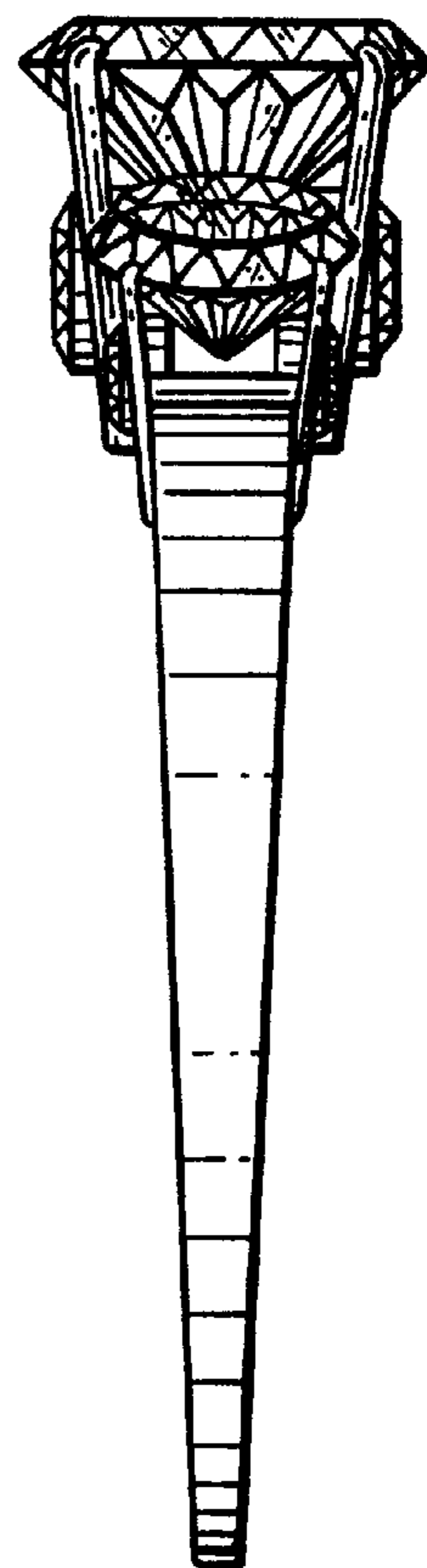
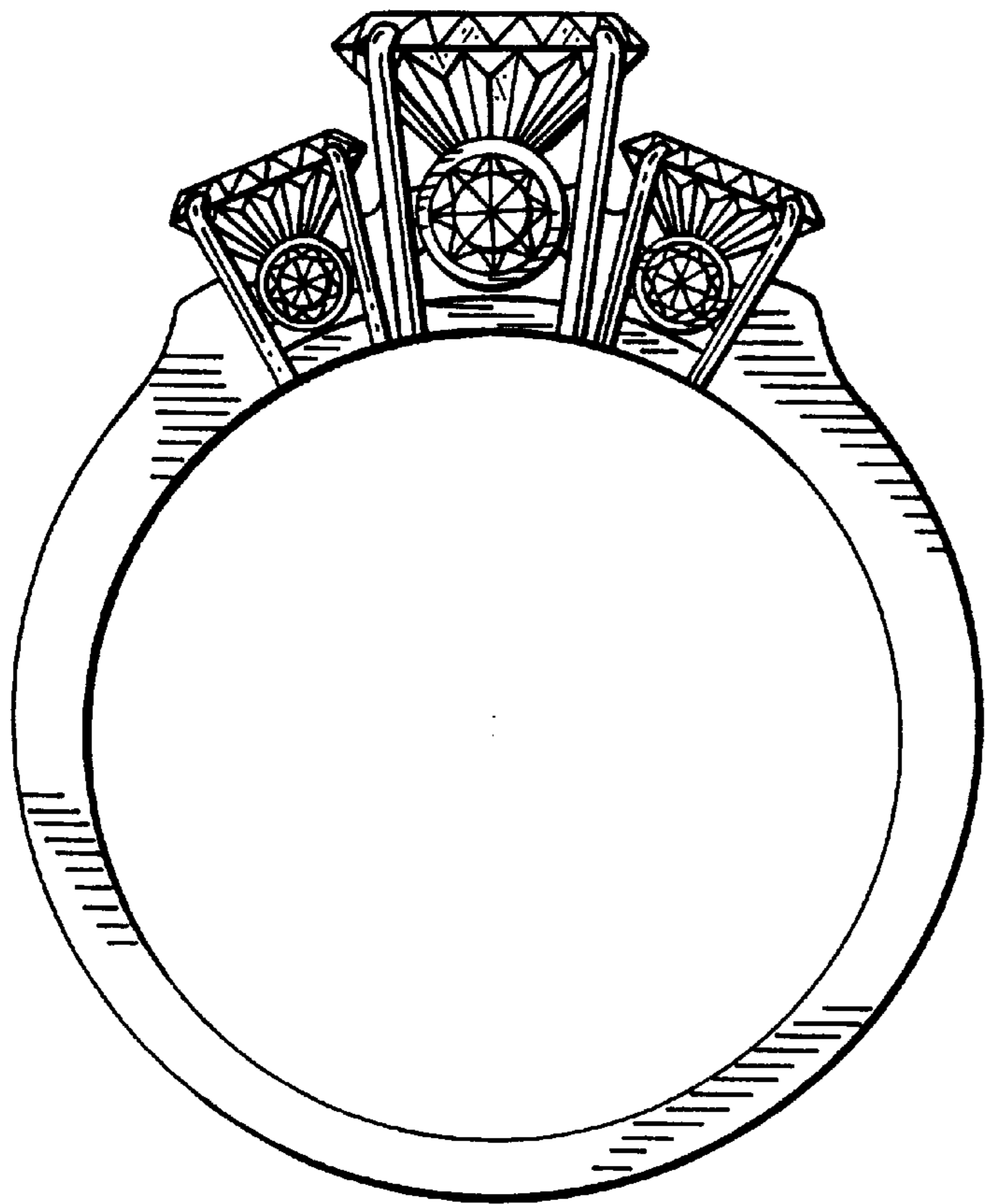

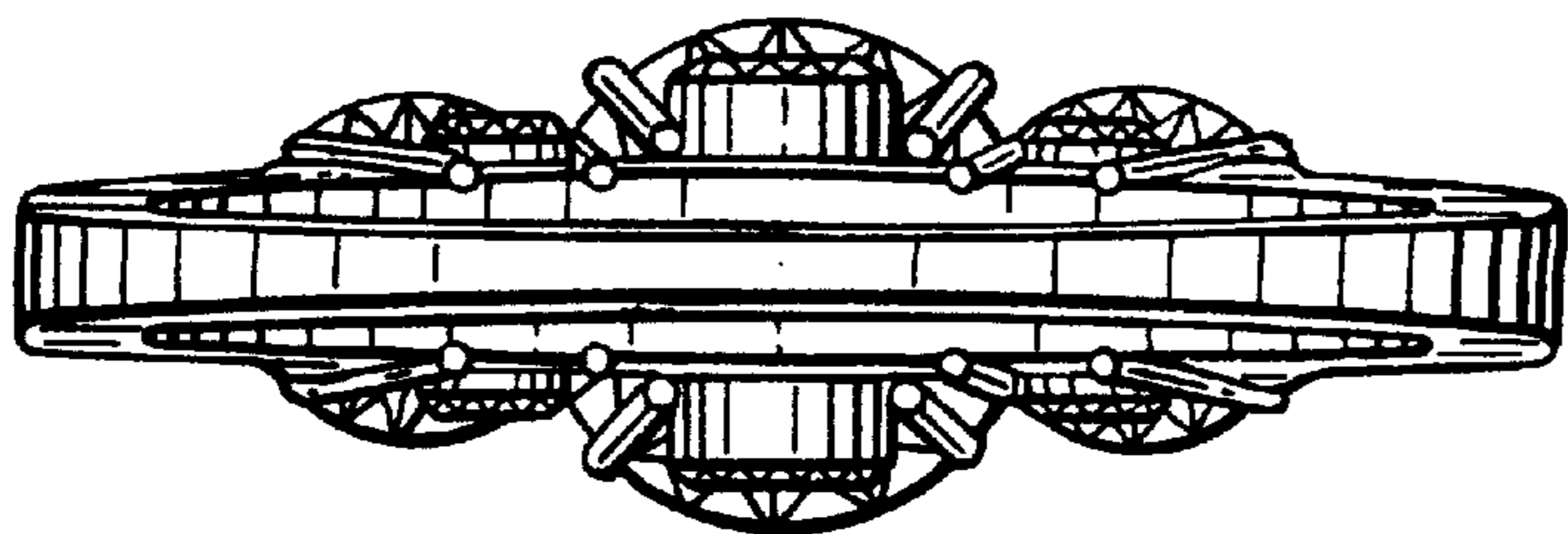

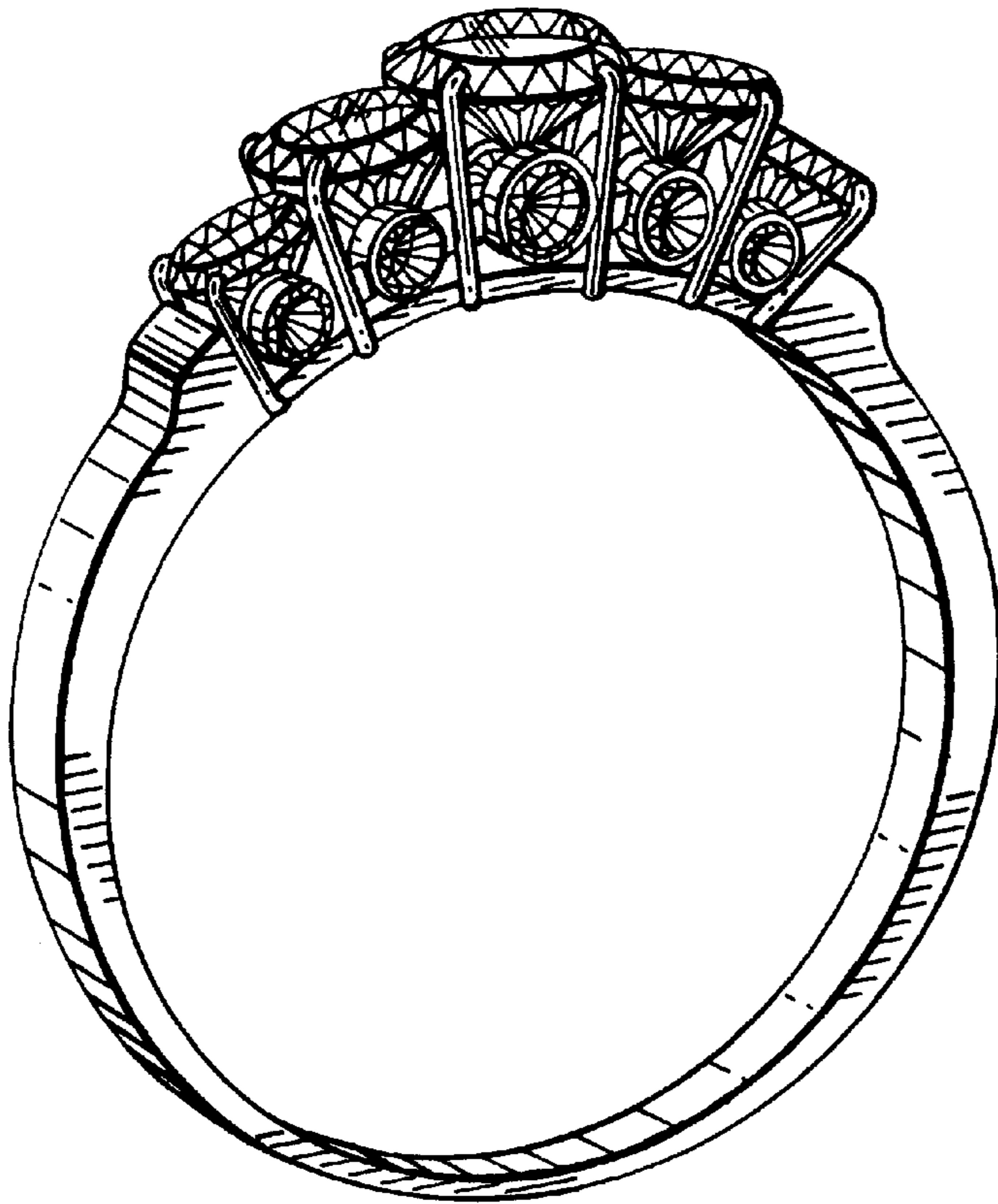

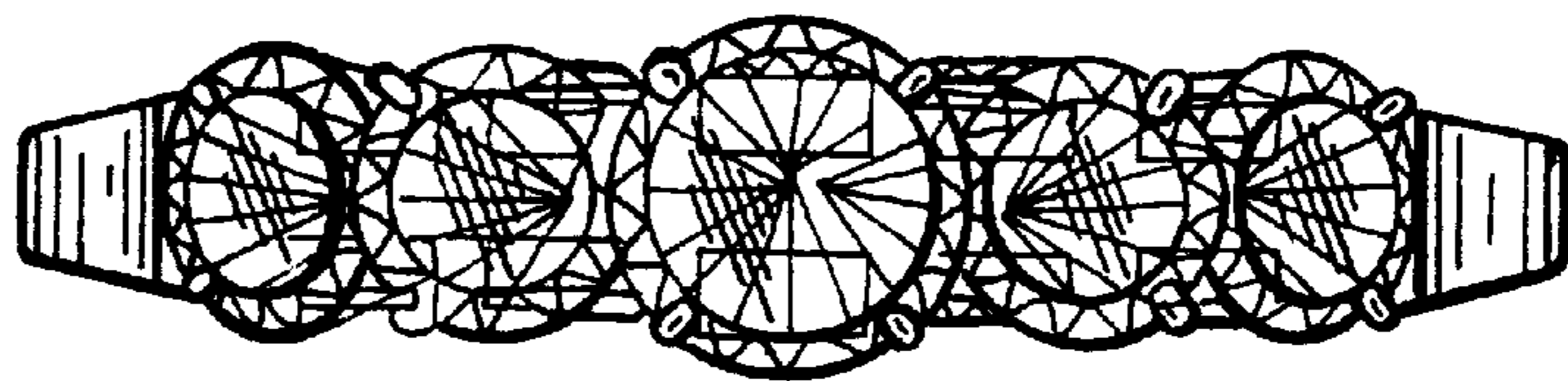

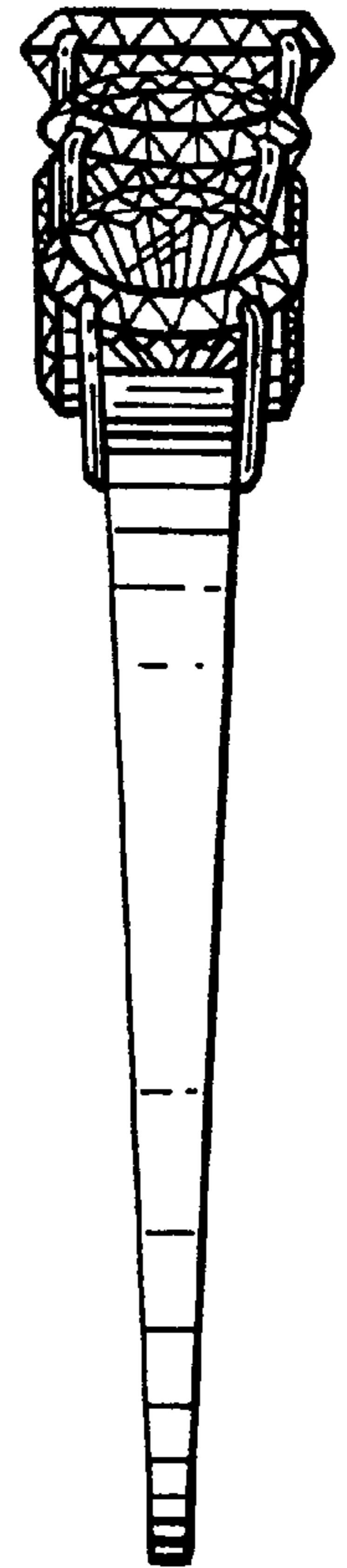
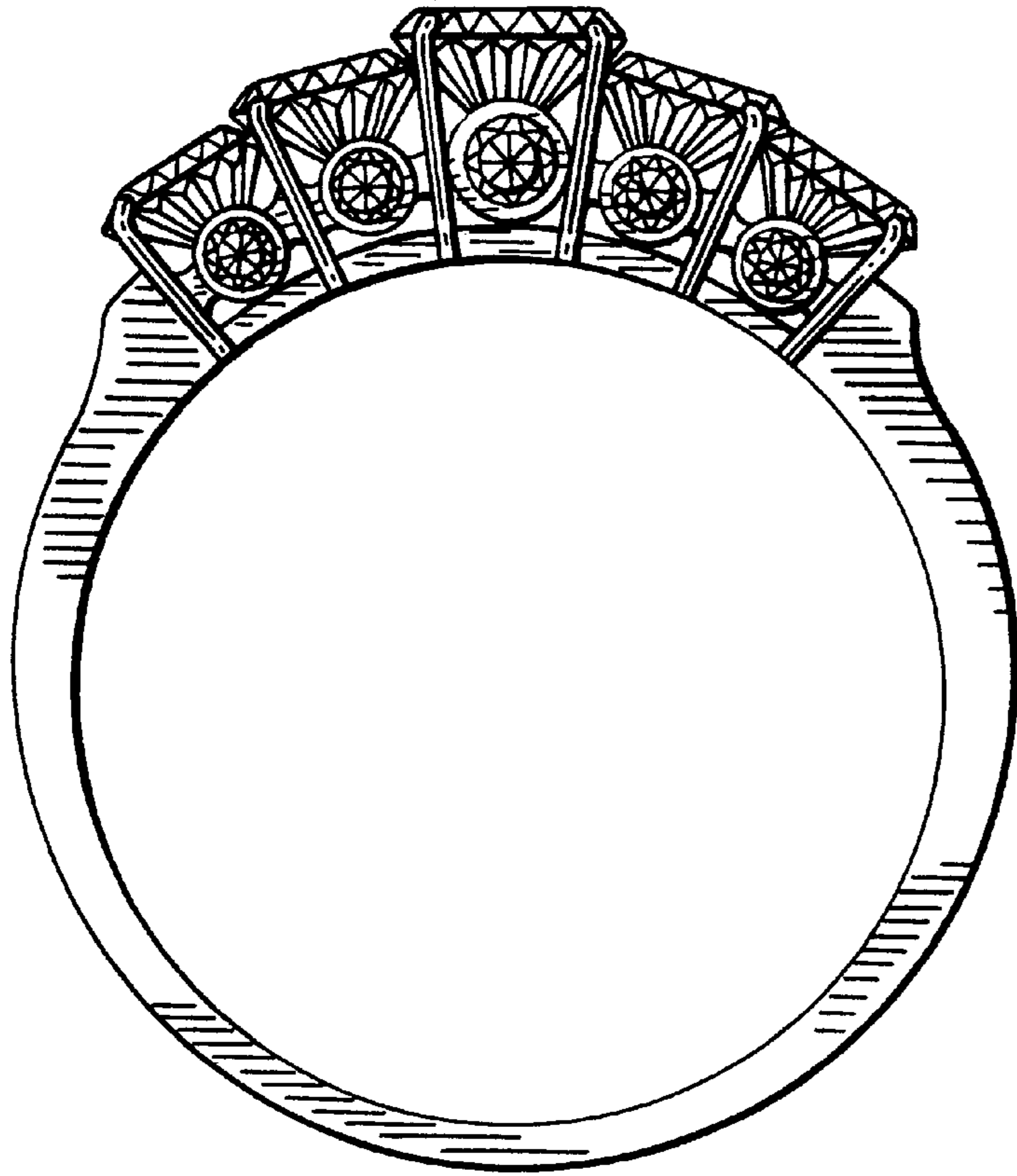

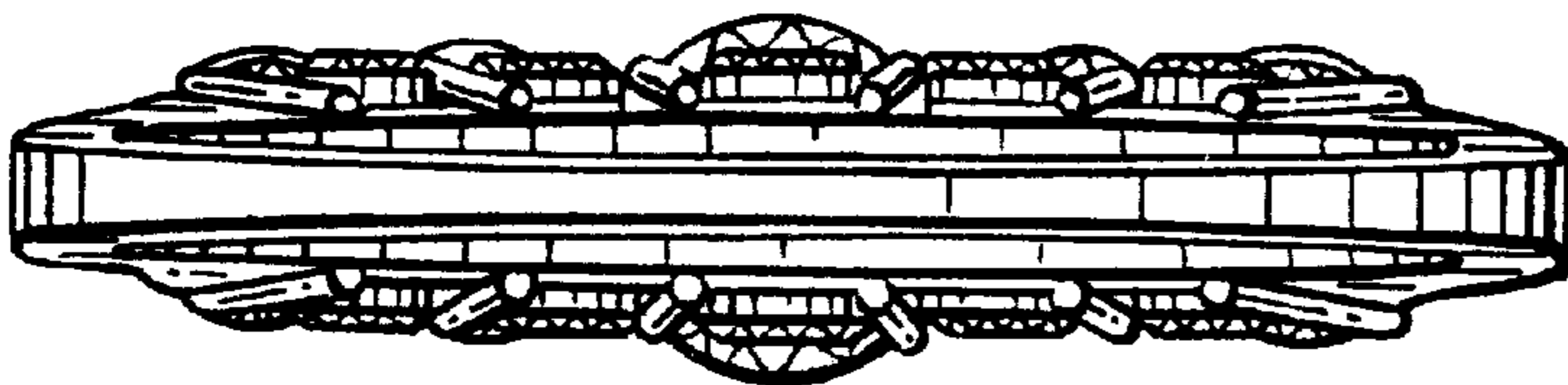
