The ornamental design for a mailing system, as shown and described.

**DESCRIPTION**

FIG. 1, is a front, top and left side perspective view of a mailing system which incorporates the new design; FIG. 2, is a front, top and right side perspective view thereof; FIG. 3, is a front view thereof; FIG. 4, is a top view thereof; FIG. 5, is a right side view thereof; FIG. 6, is a left side view thereof; FIG. 7, is a rear view thereof; and, FIG. 8, is a bottom view thereof.

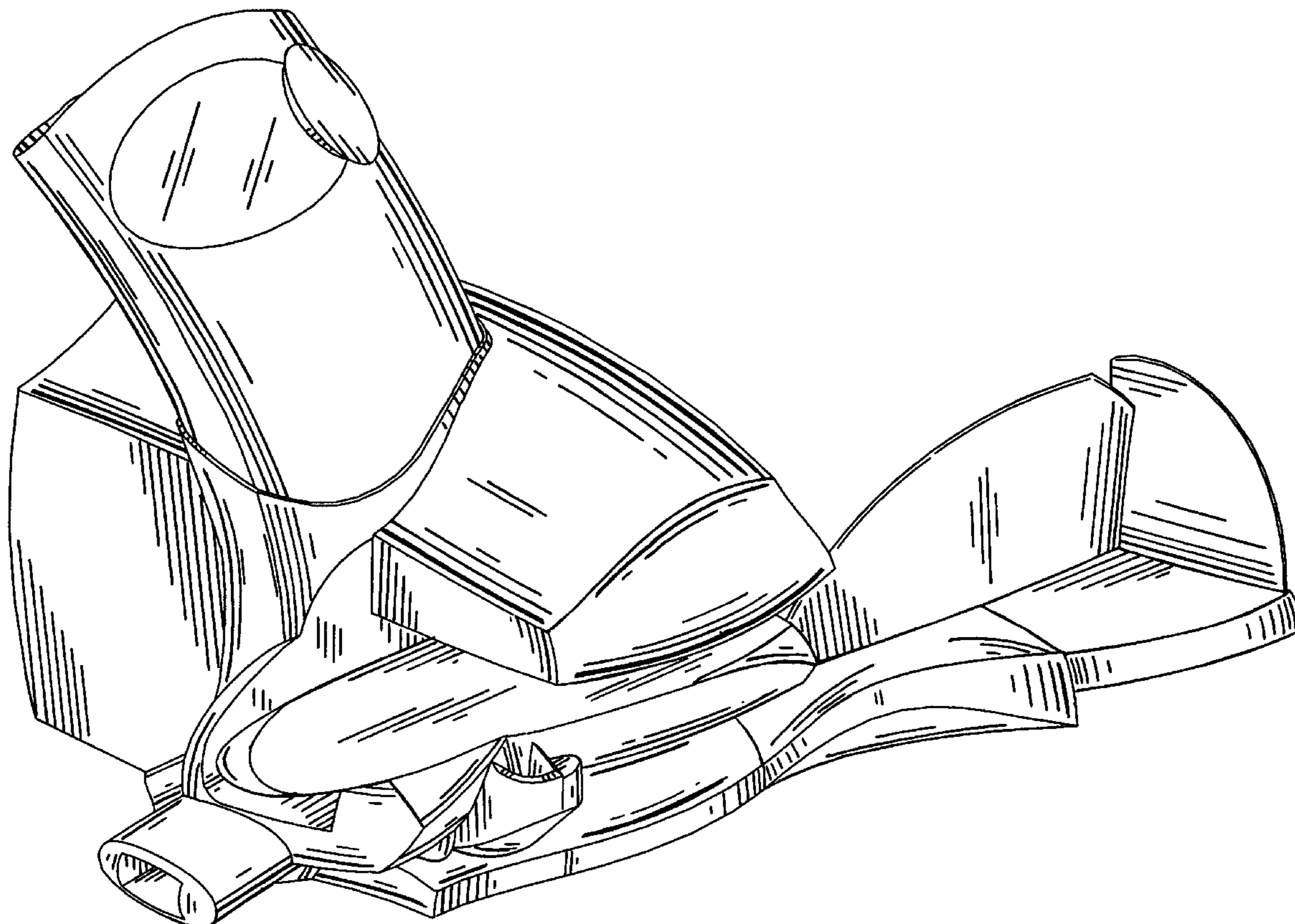

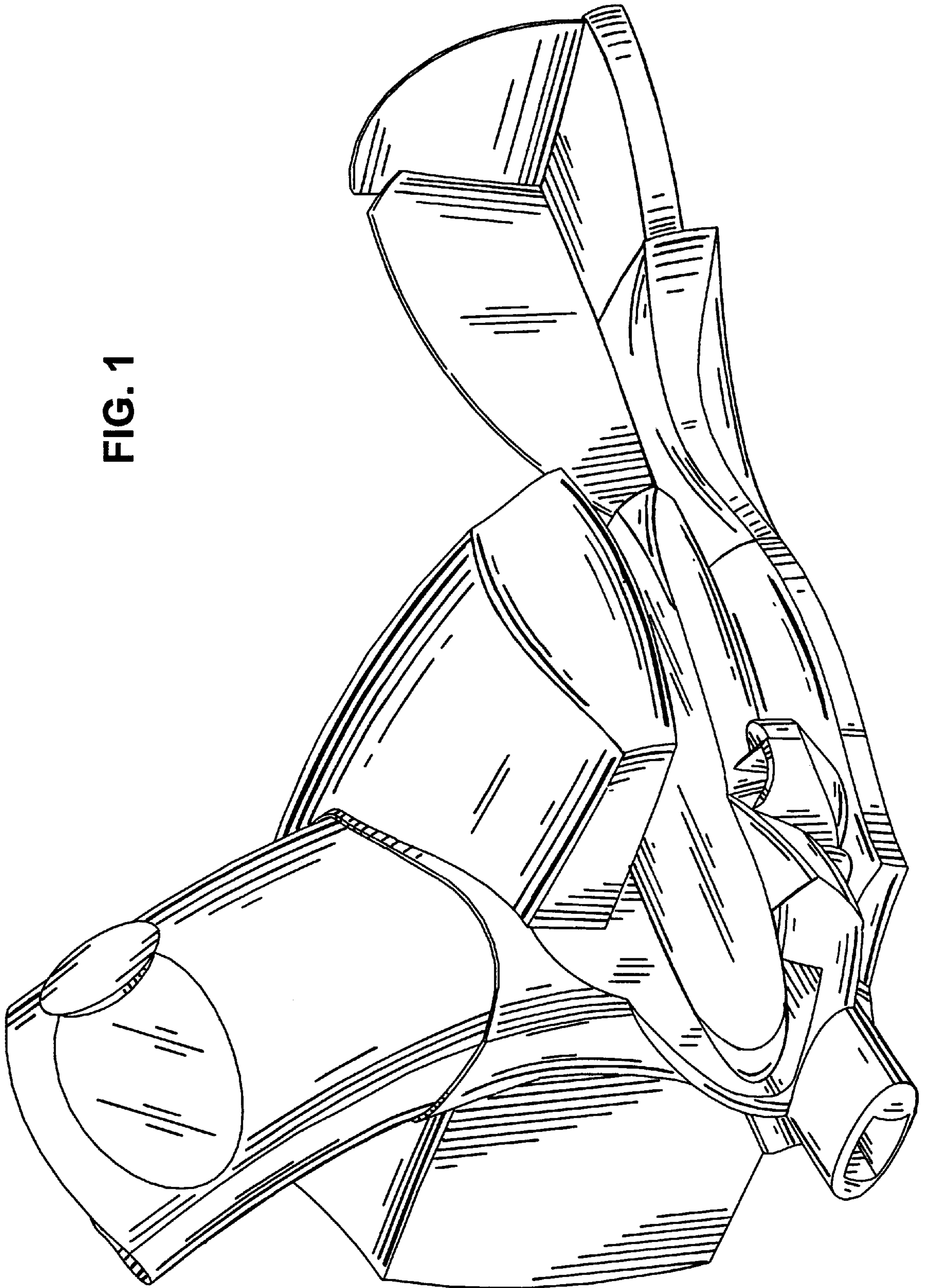

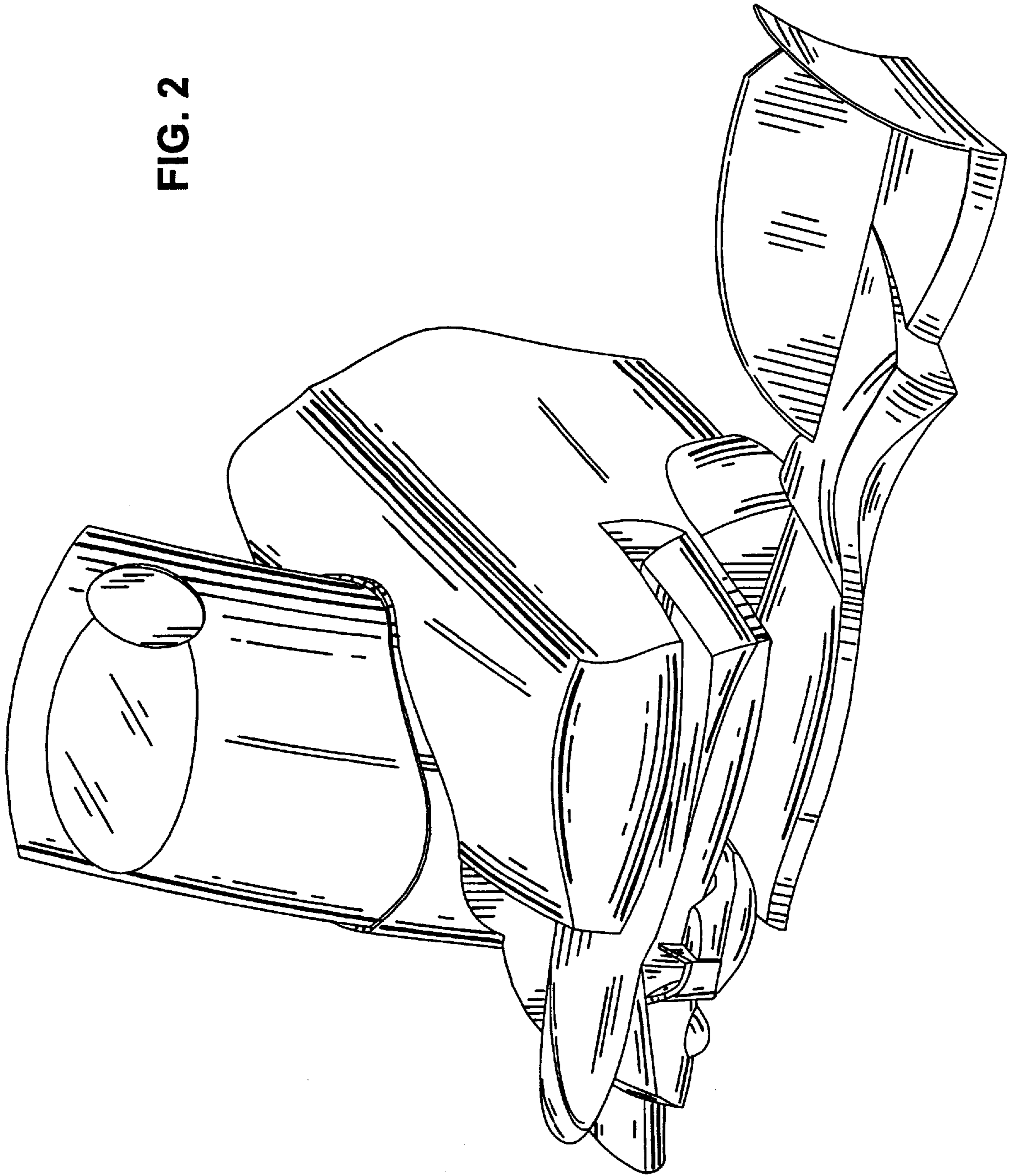

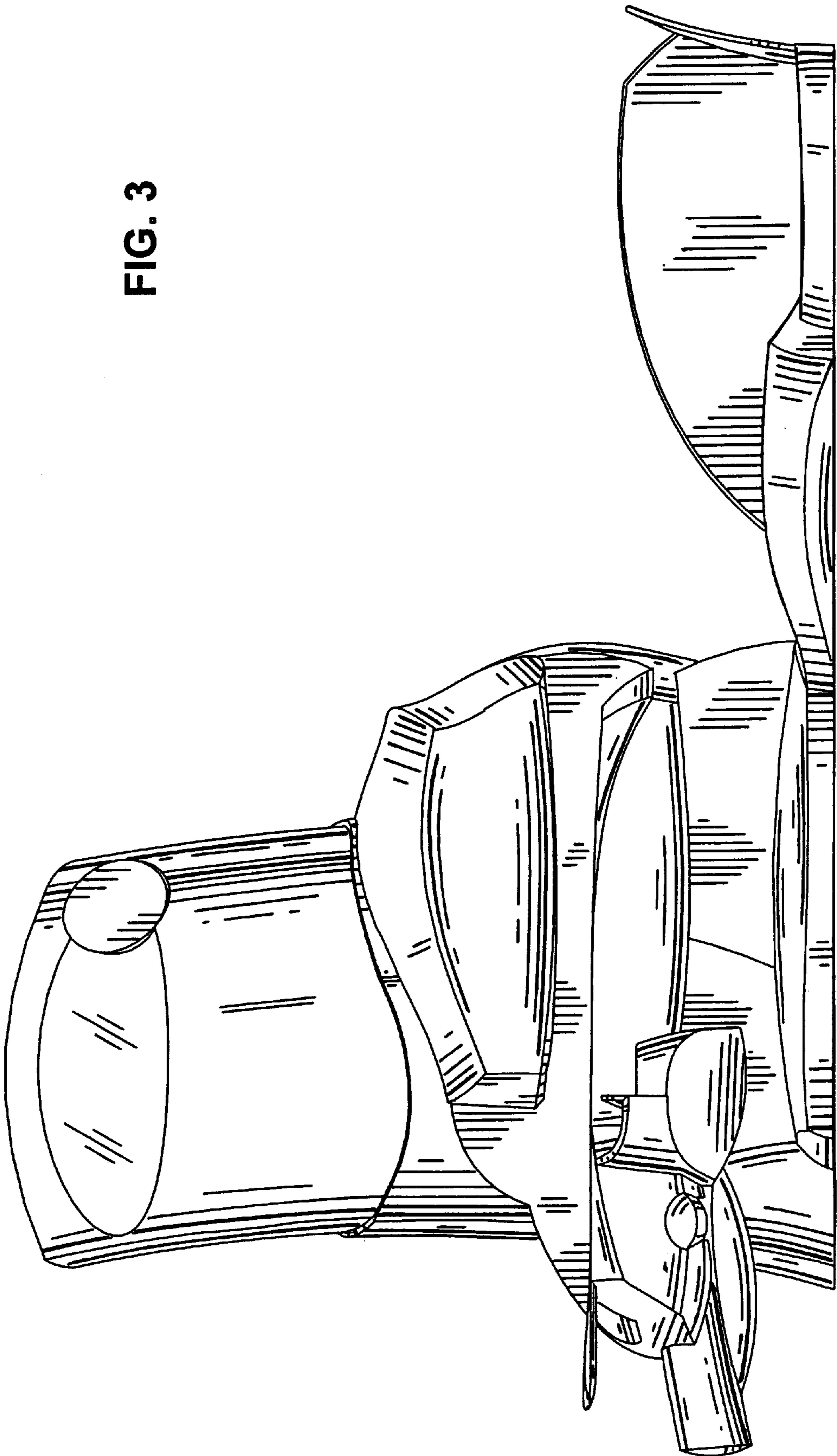
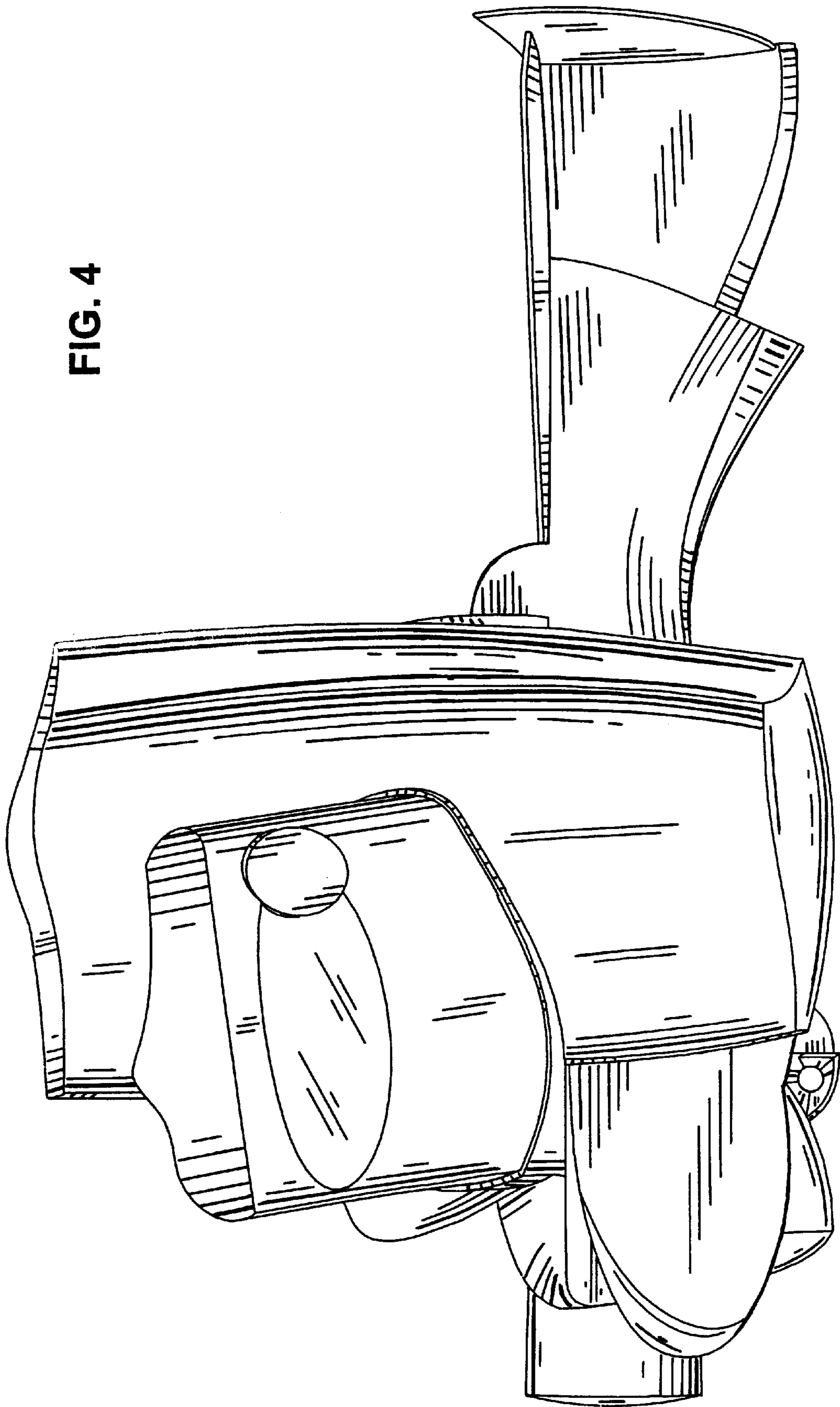

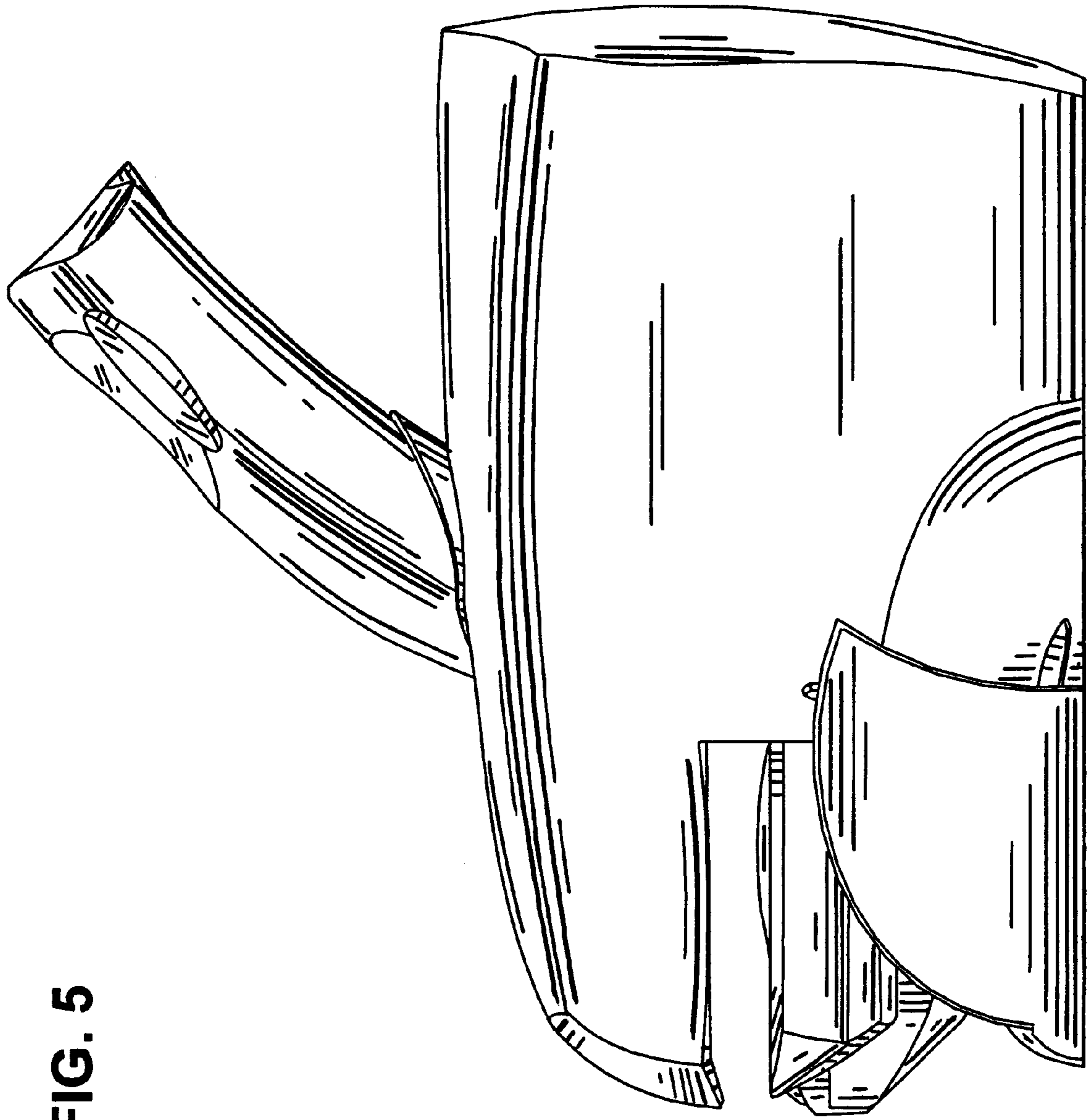
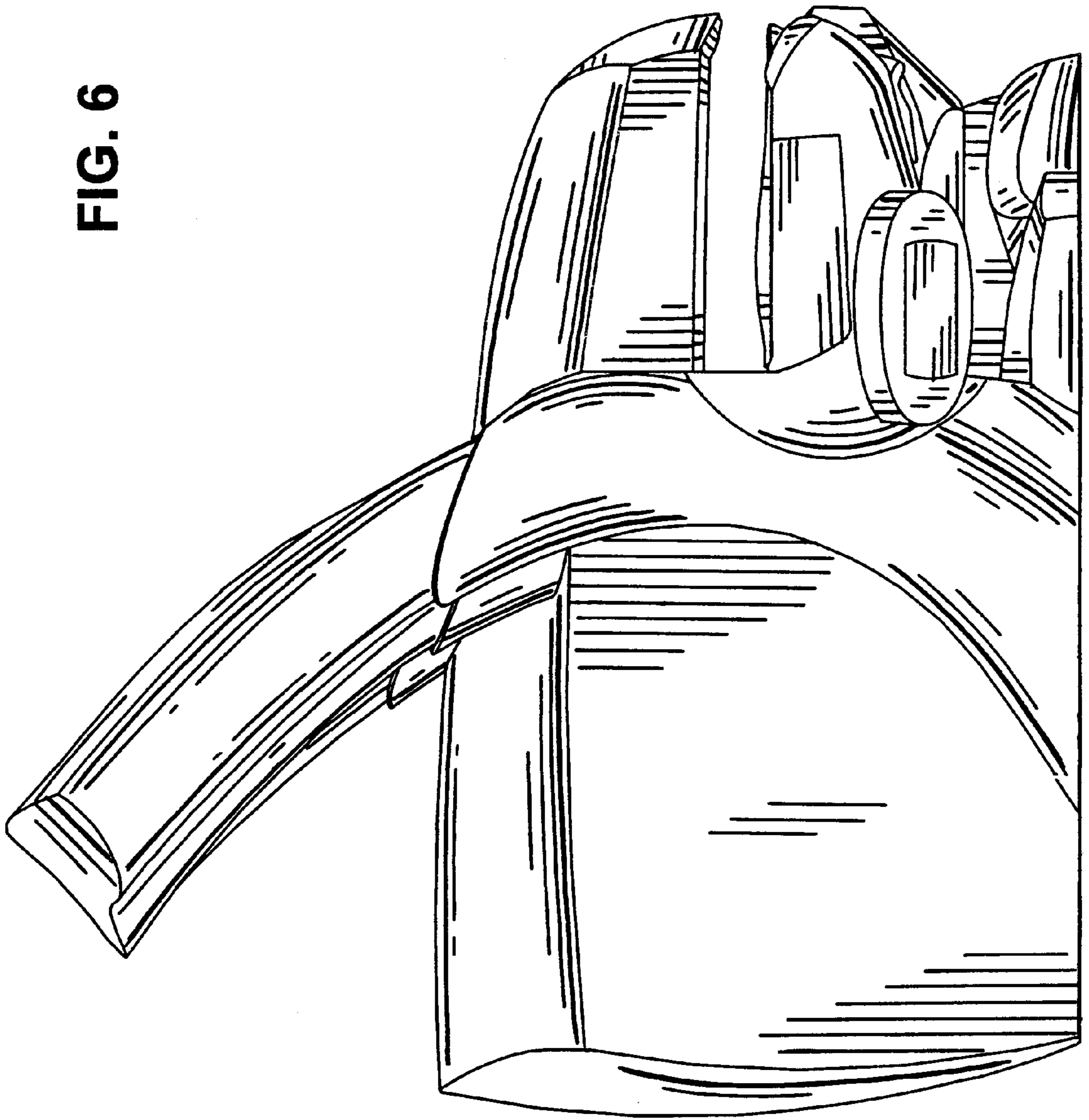

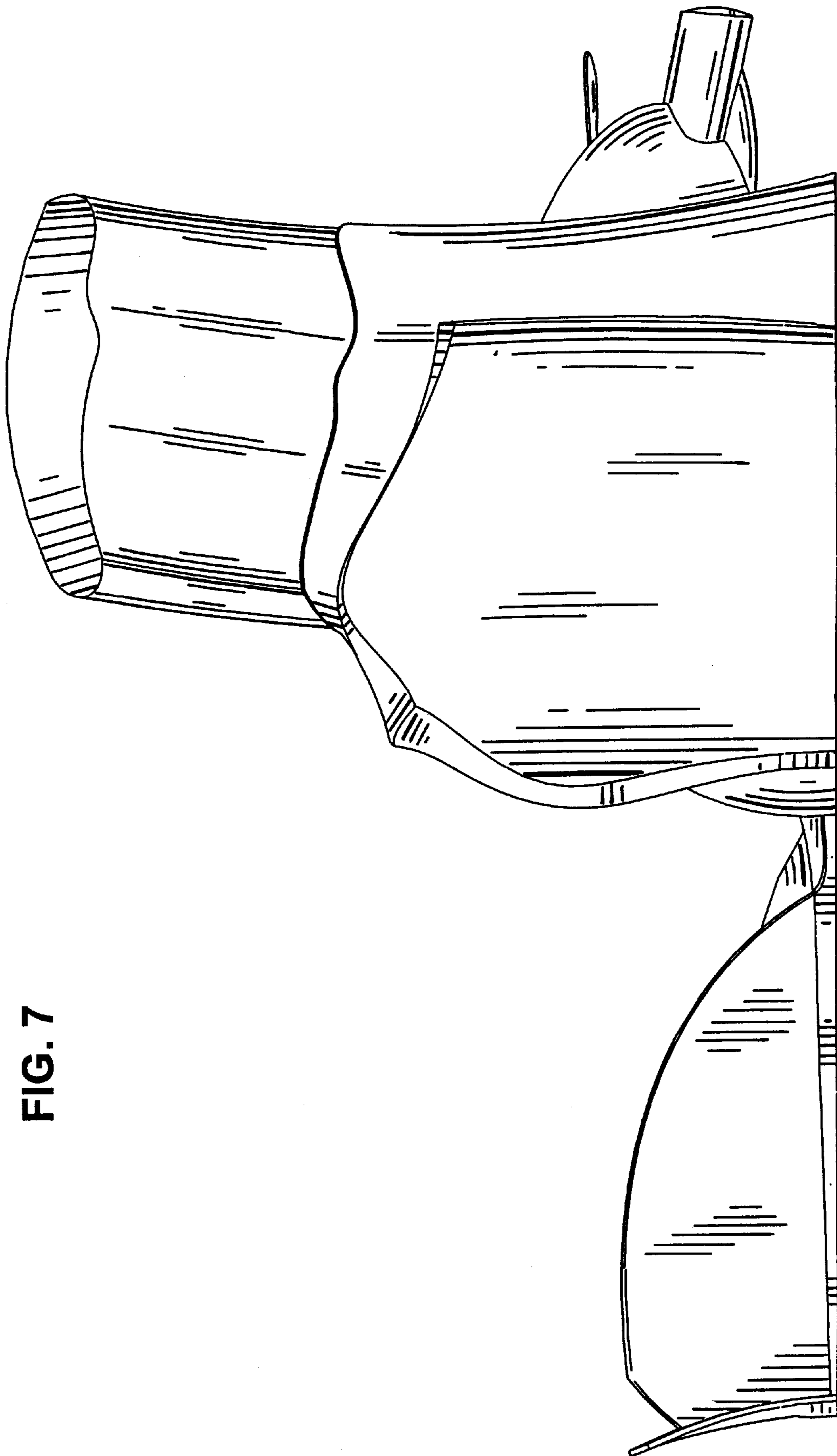

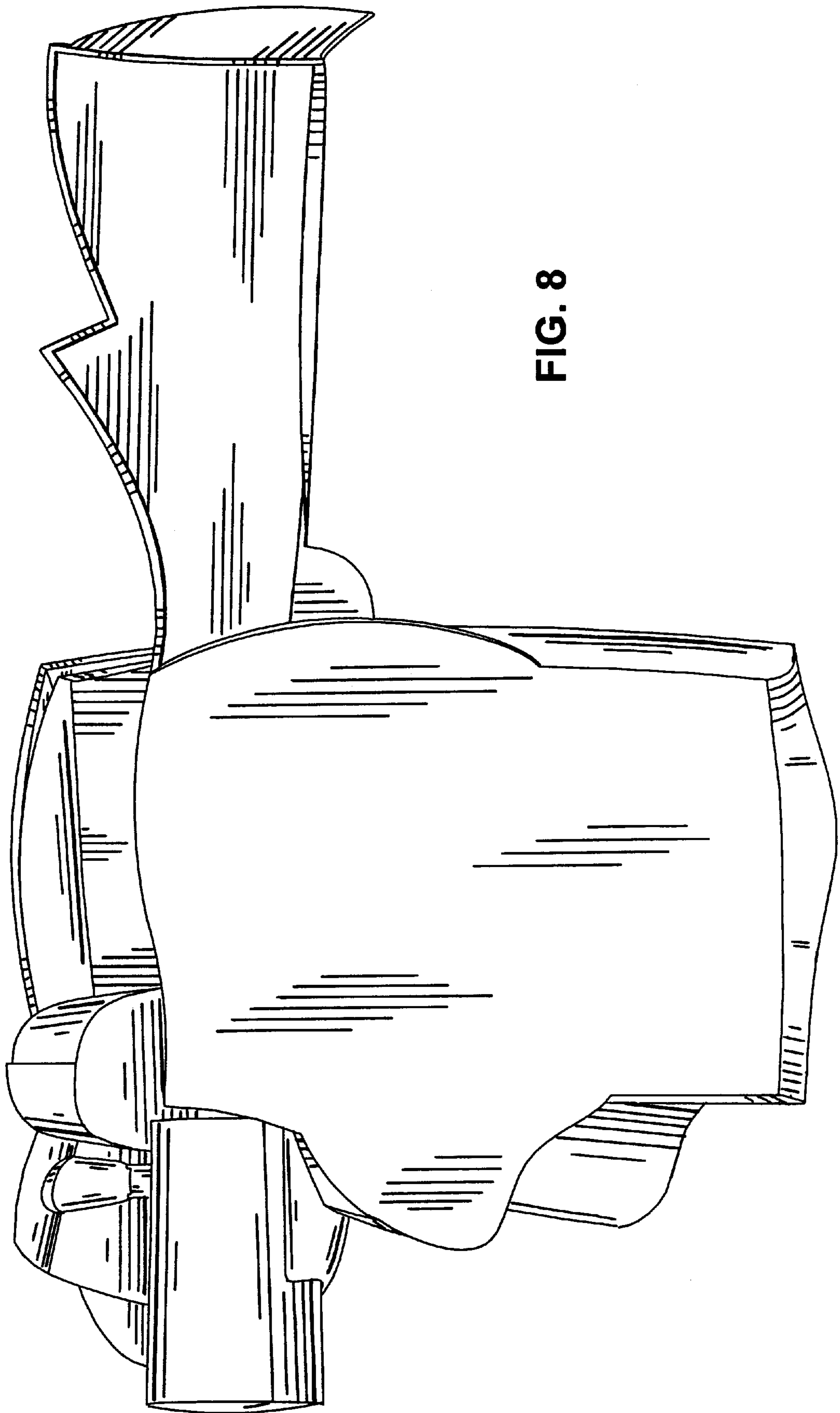
