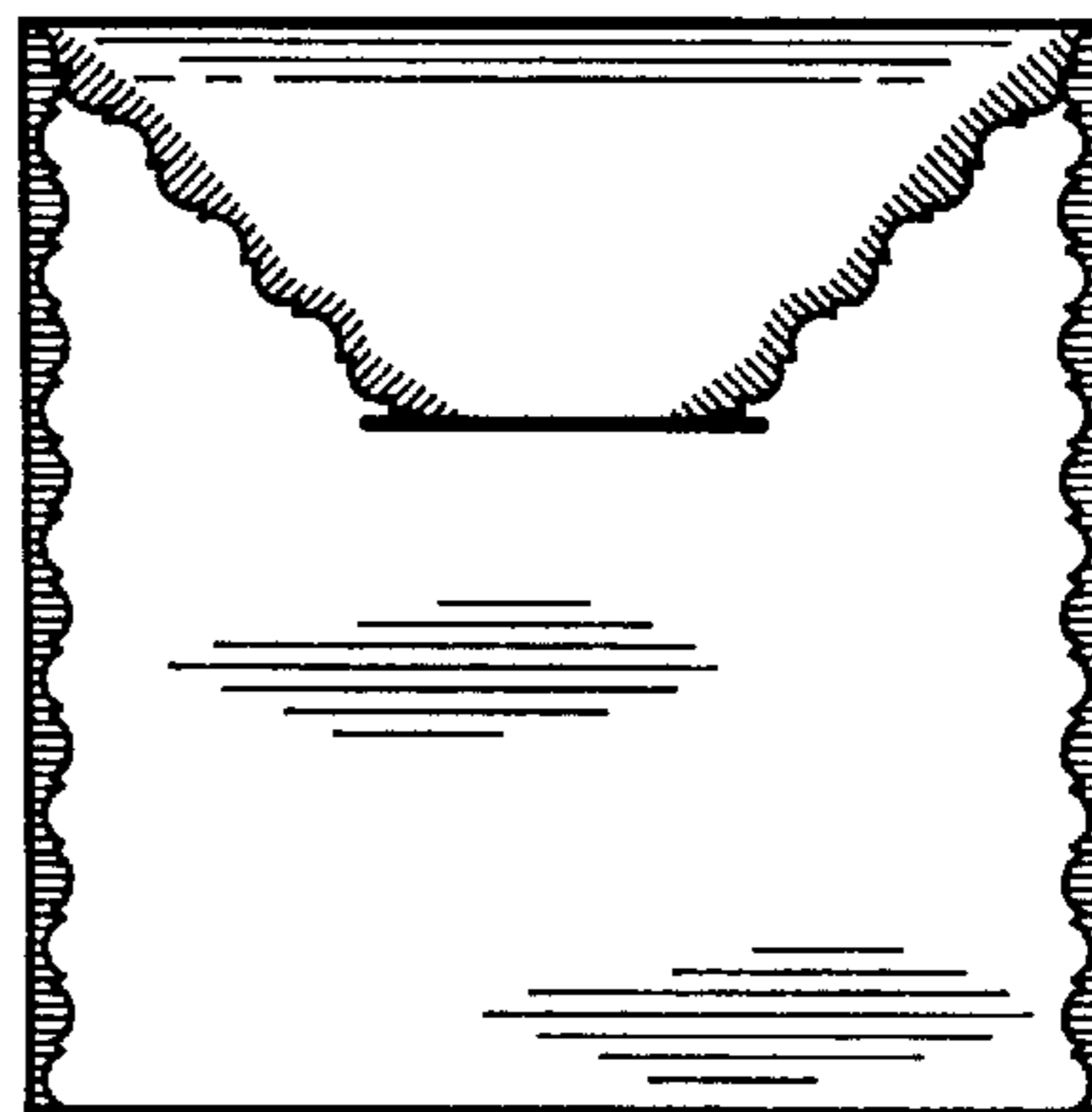
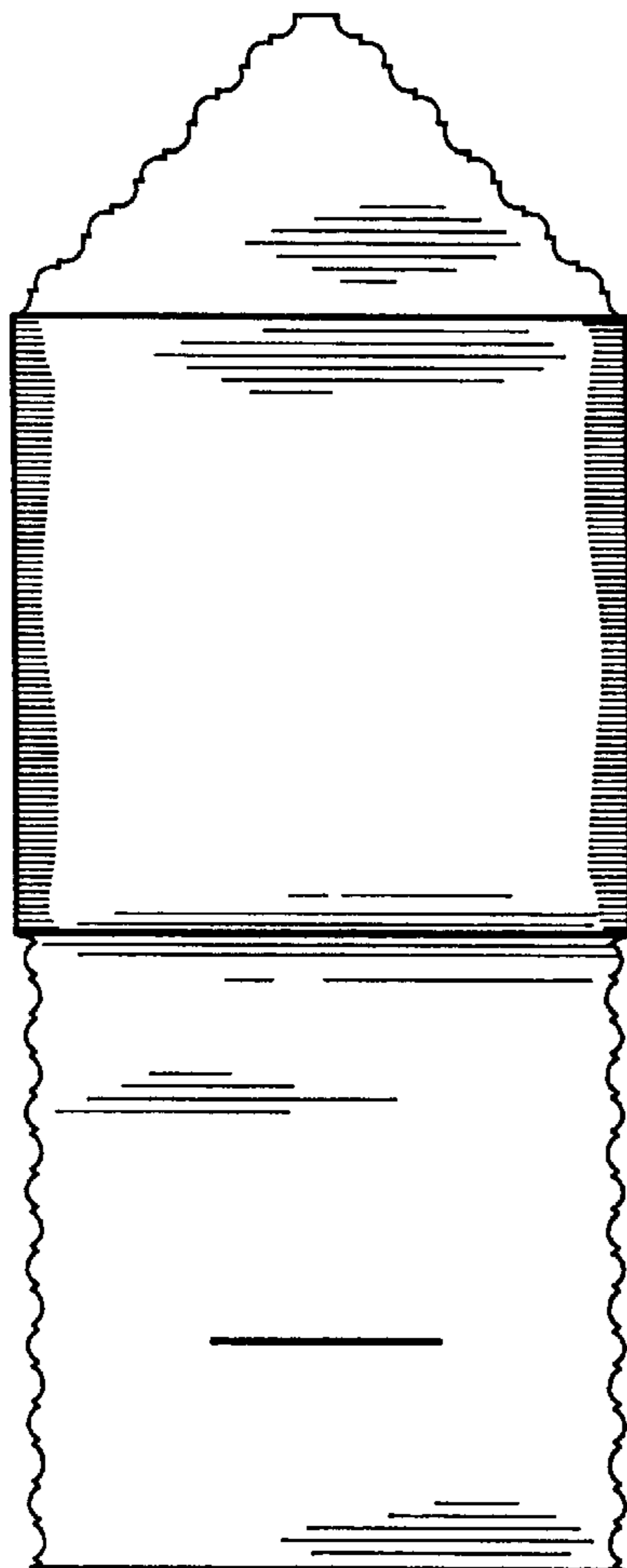

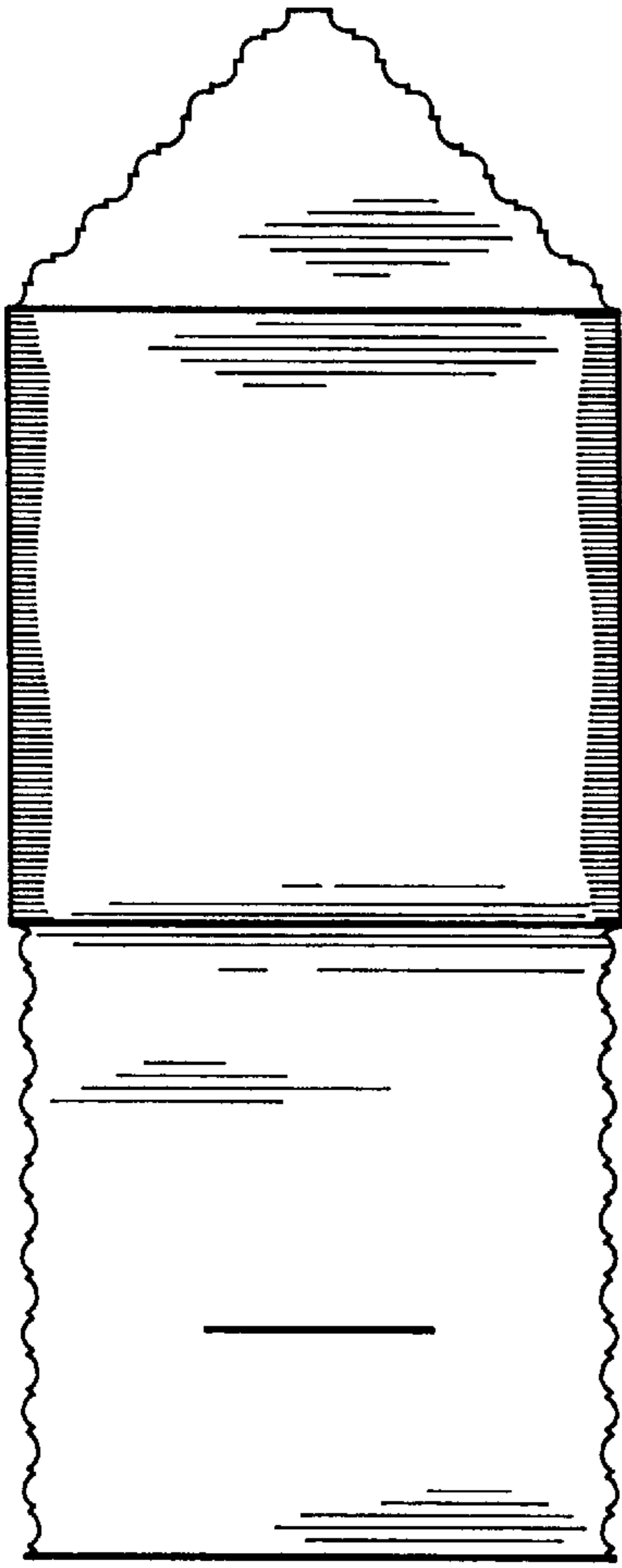
The ornamental design for a “greeting card”, as shown and described.

**DESCRIPTION**

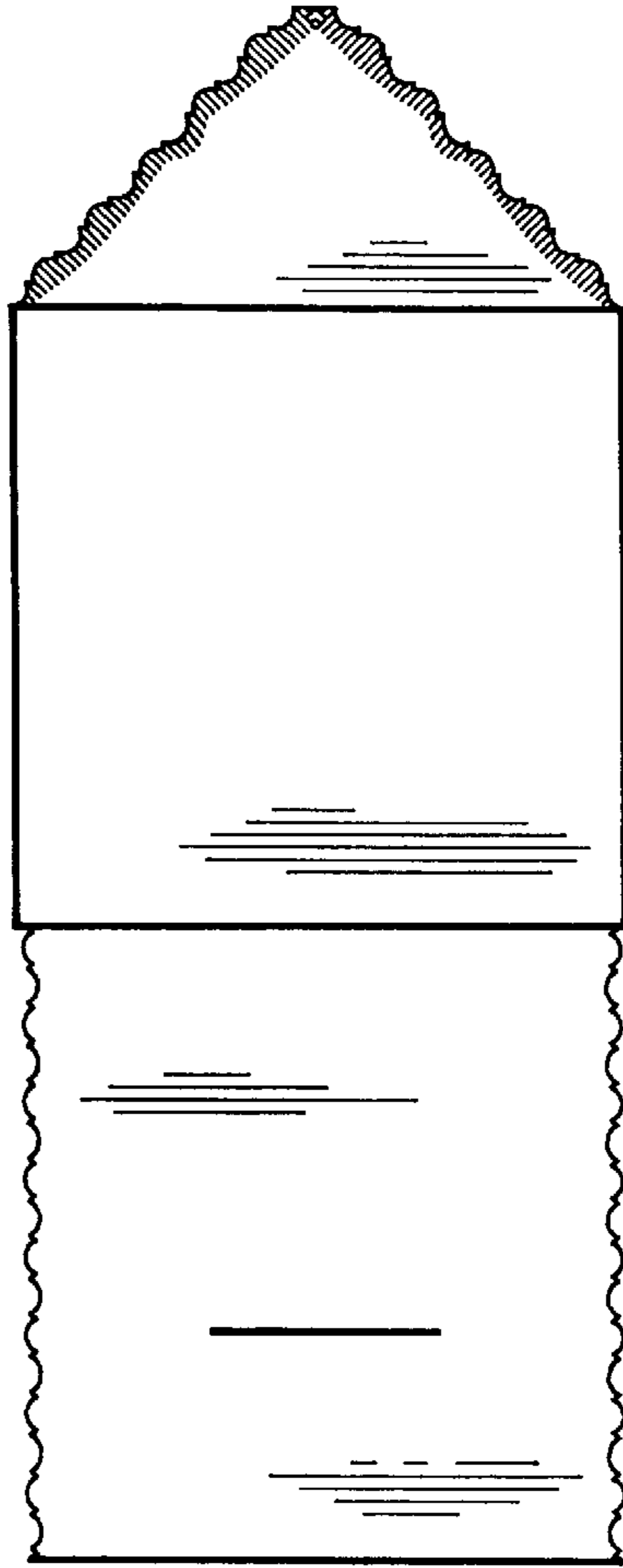
FIG. 1 is a front plan view of greeting card unfolded.

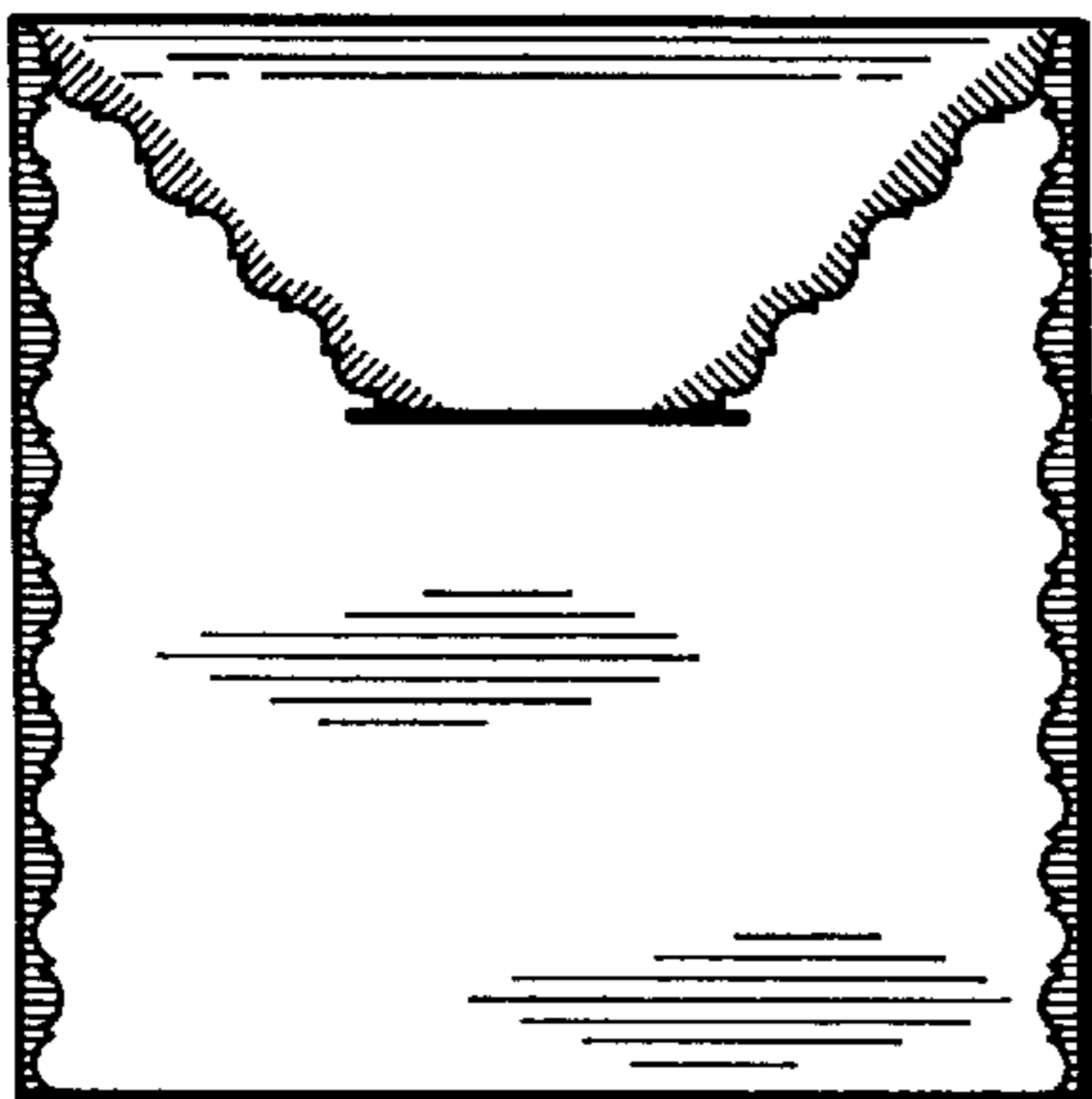




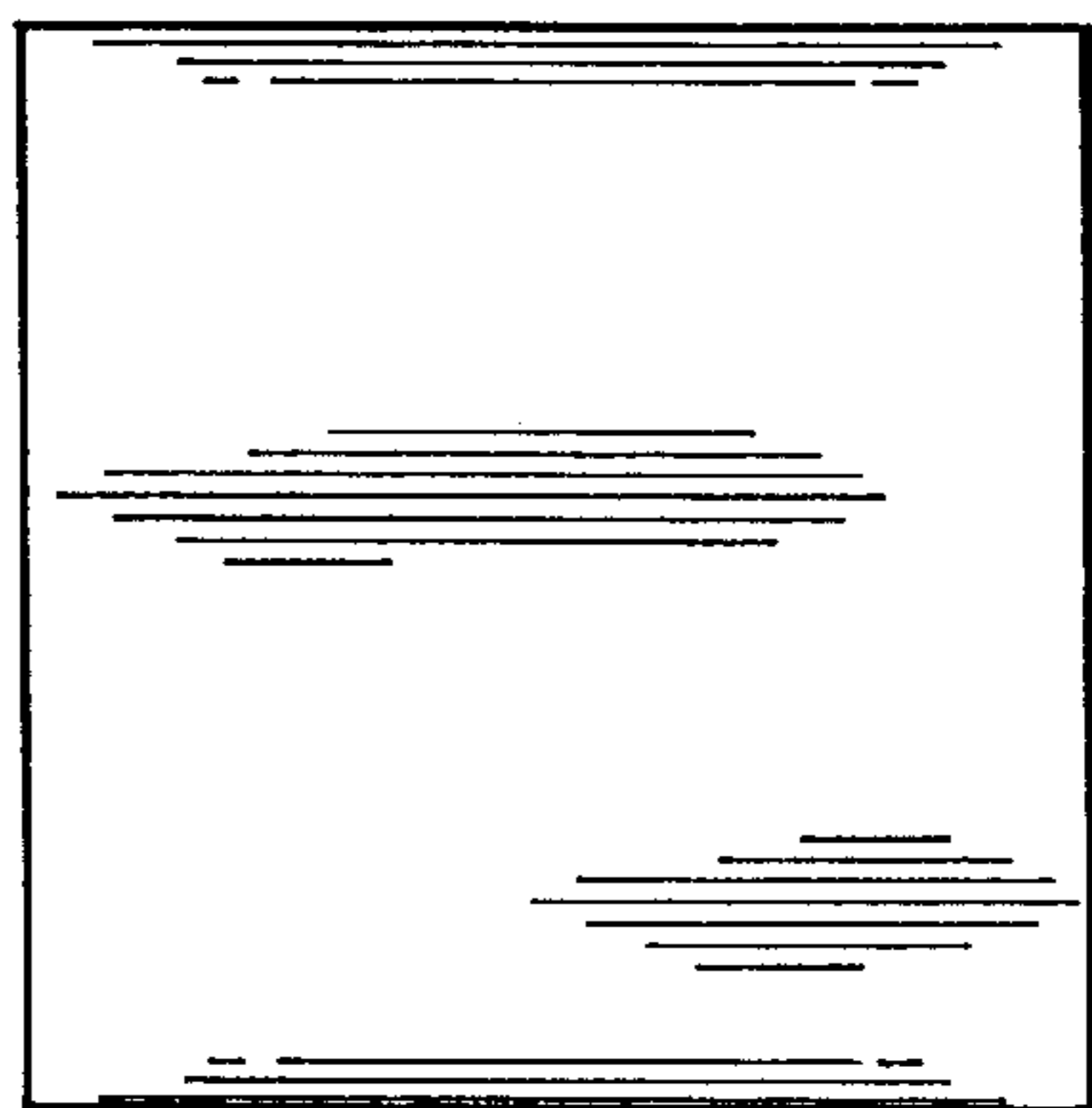
