The broken line showing of portions of a binder mechanism is for illustrative purposes only and forms no part of the claimed design.

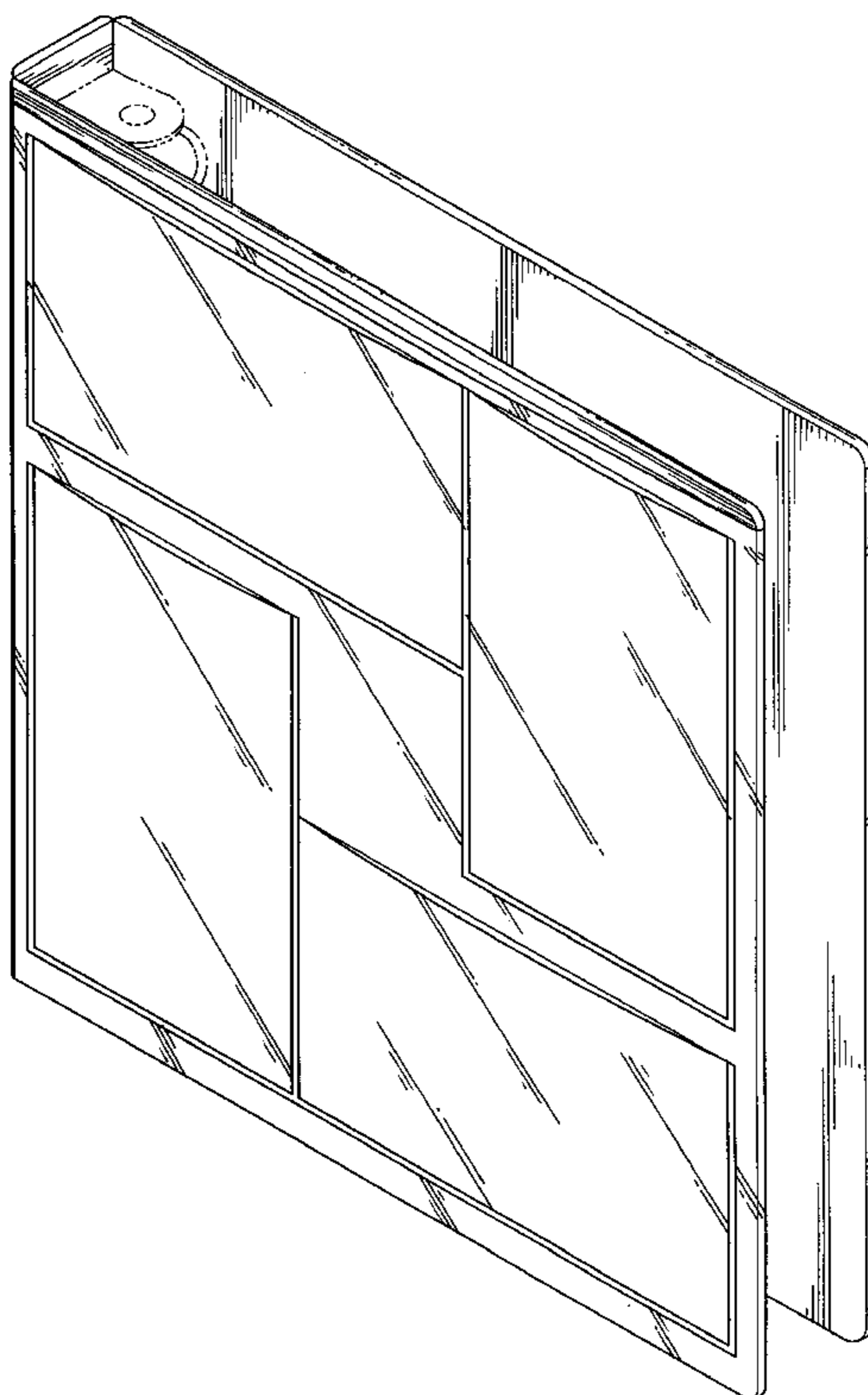

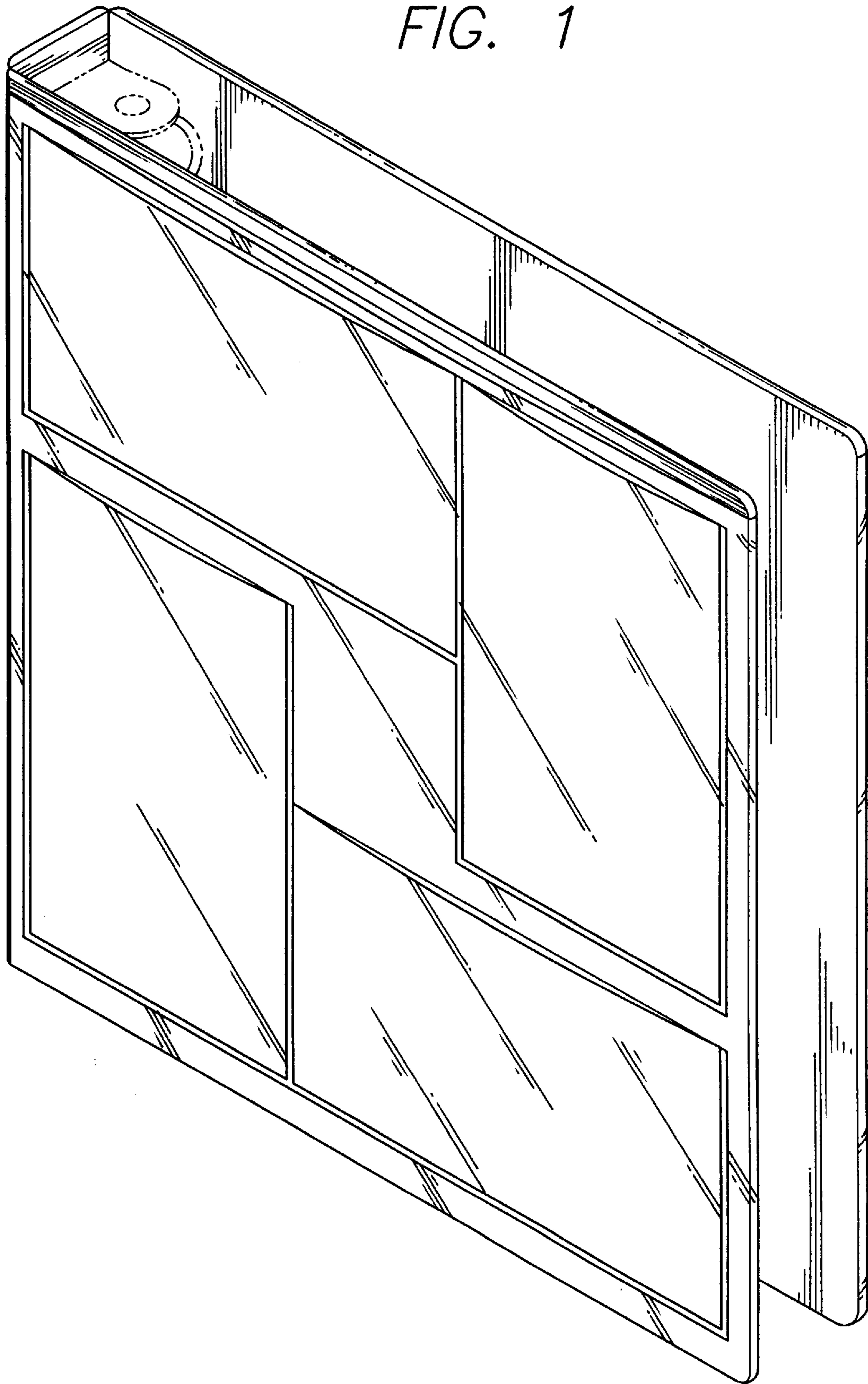

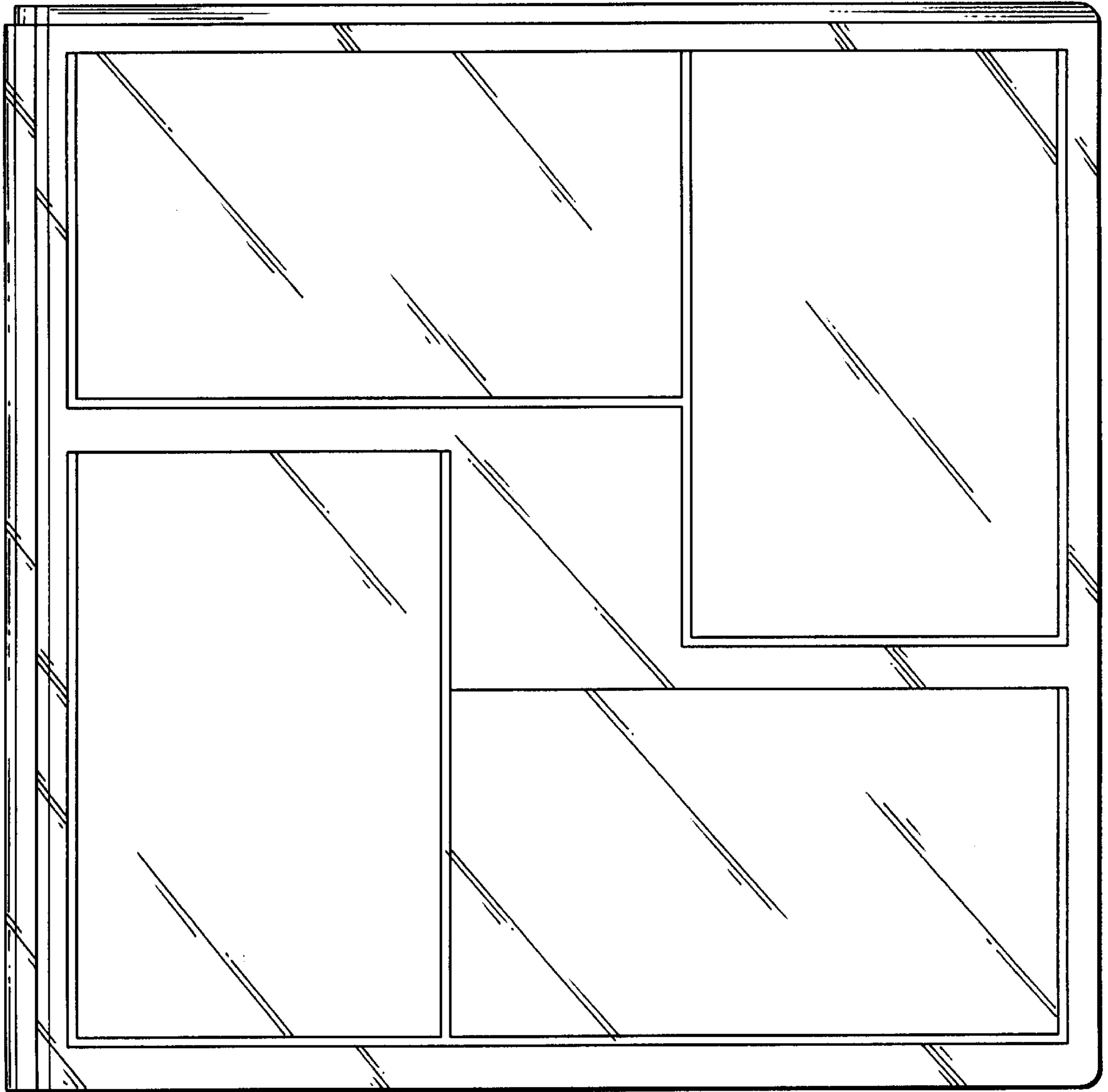
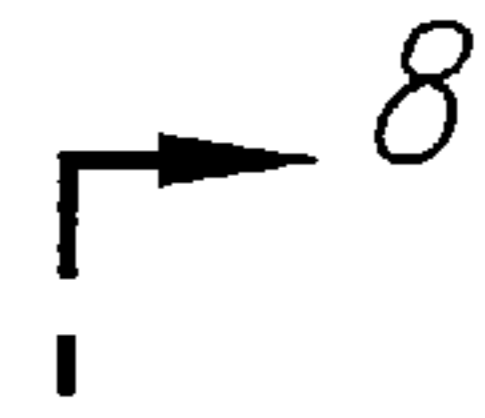

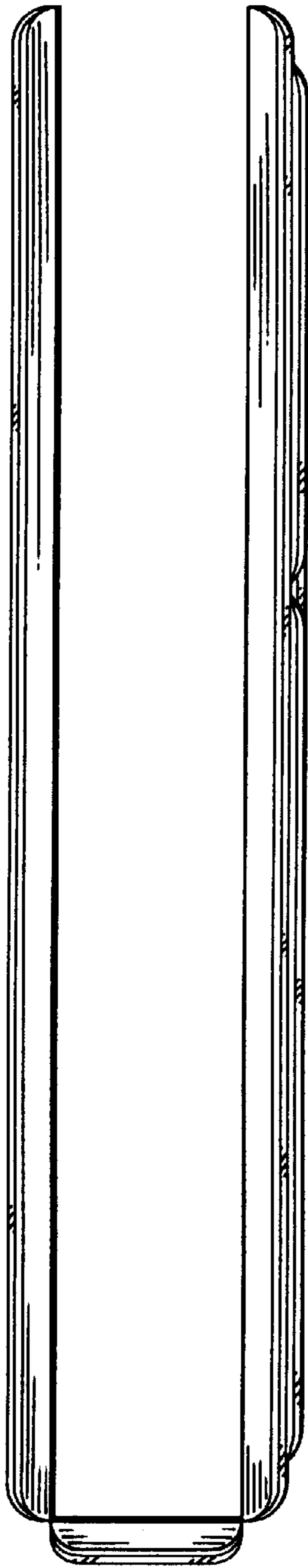
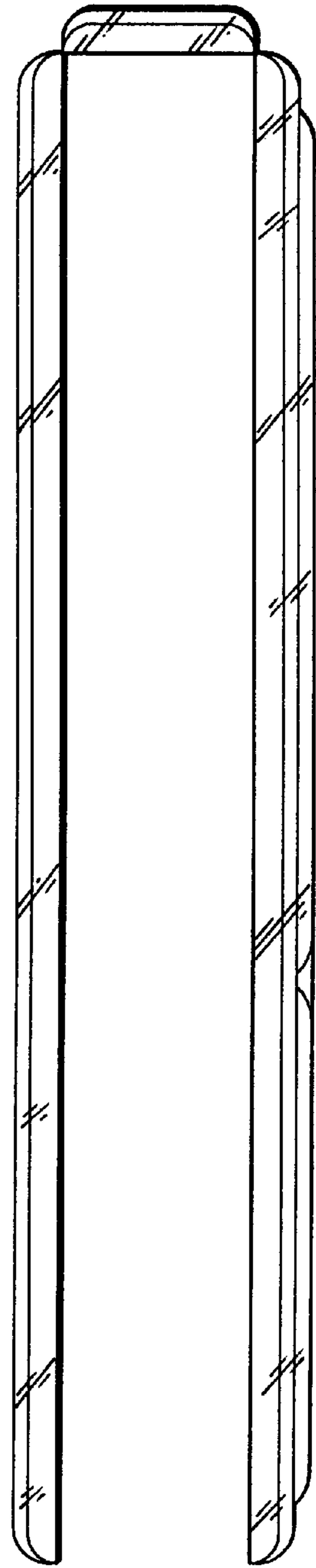

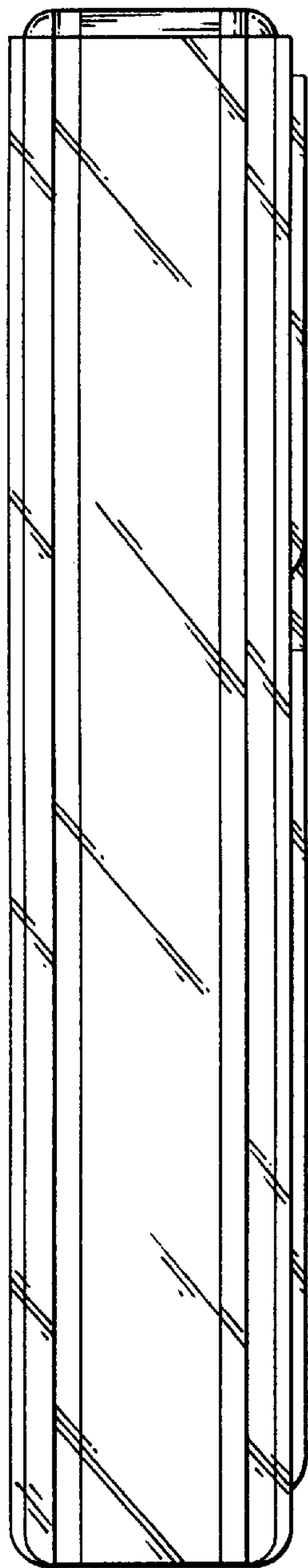

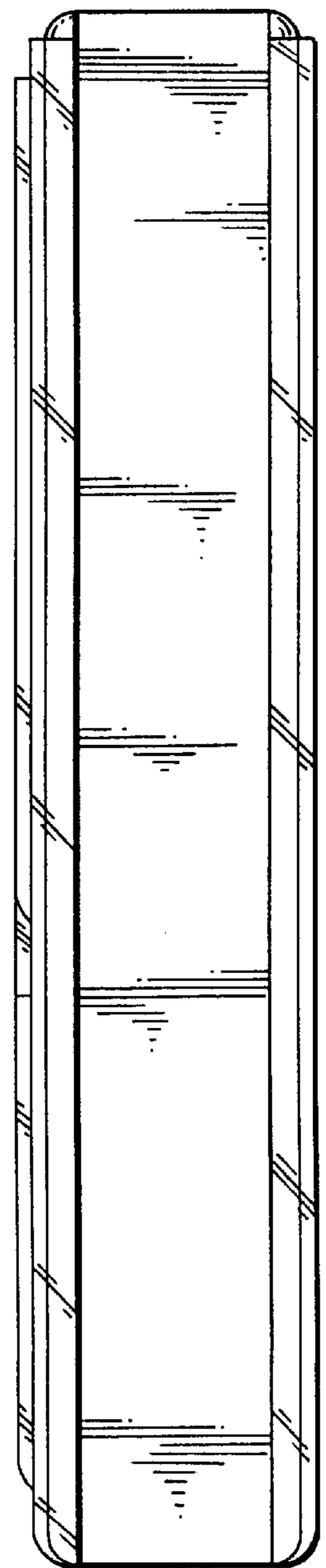

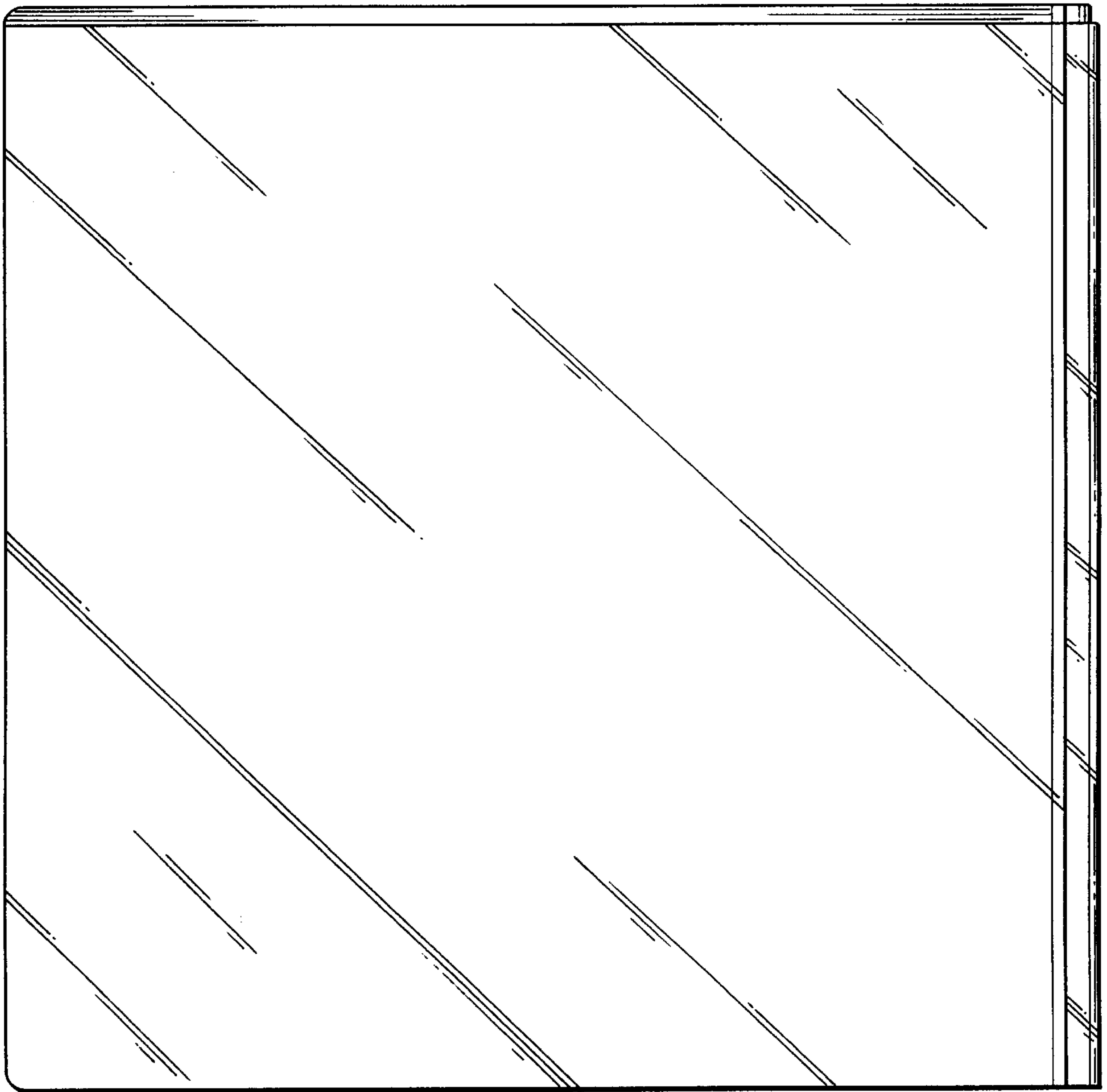
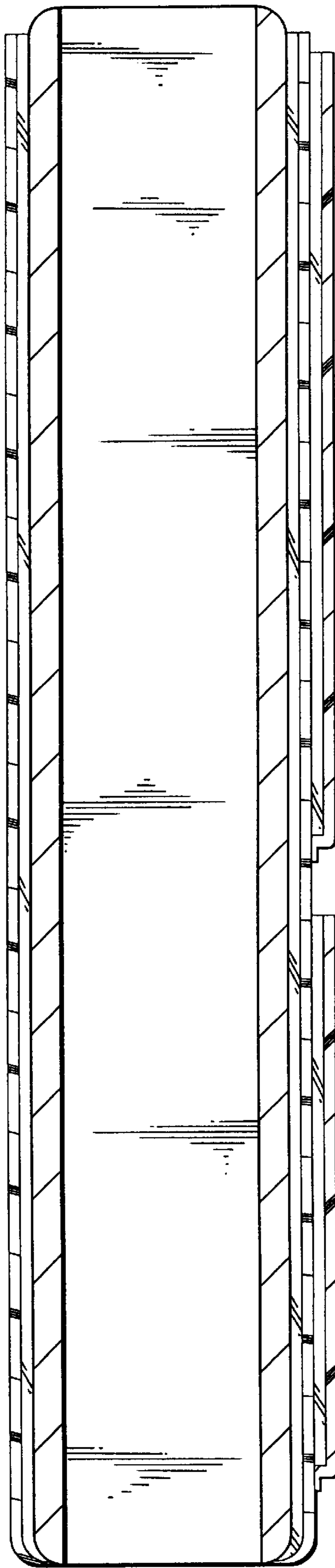

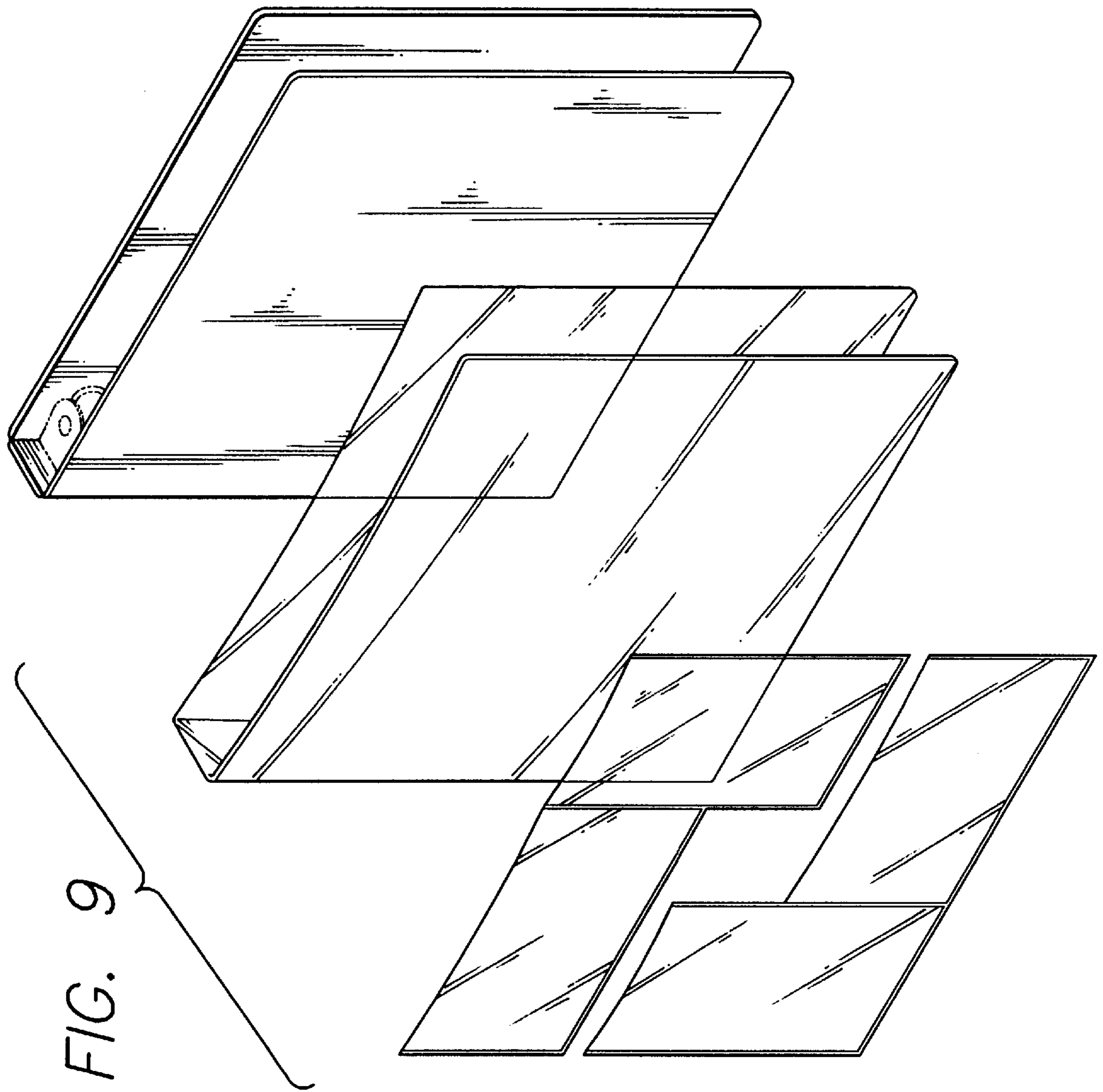

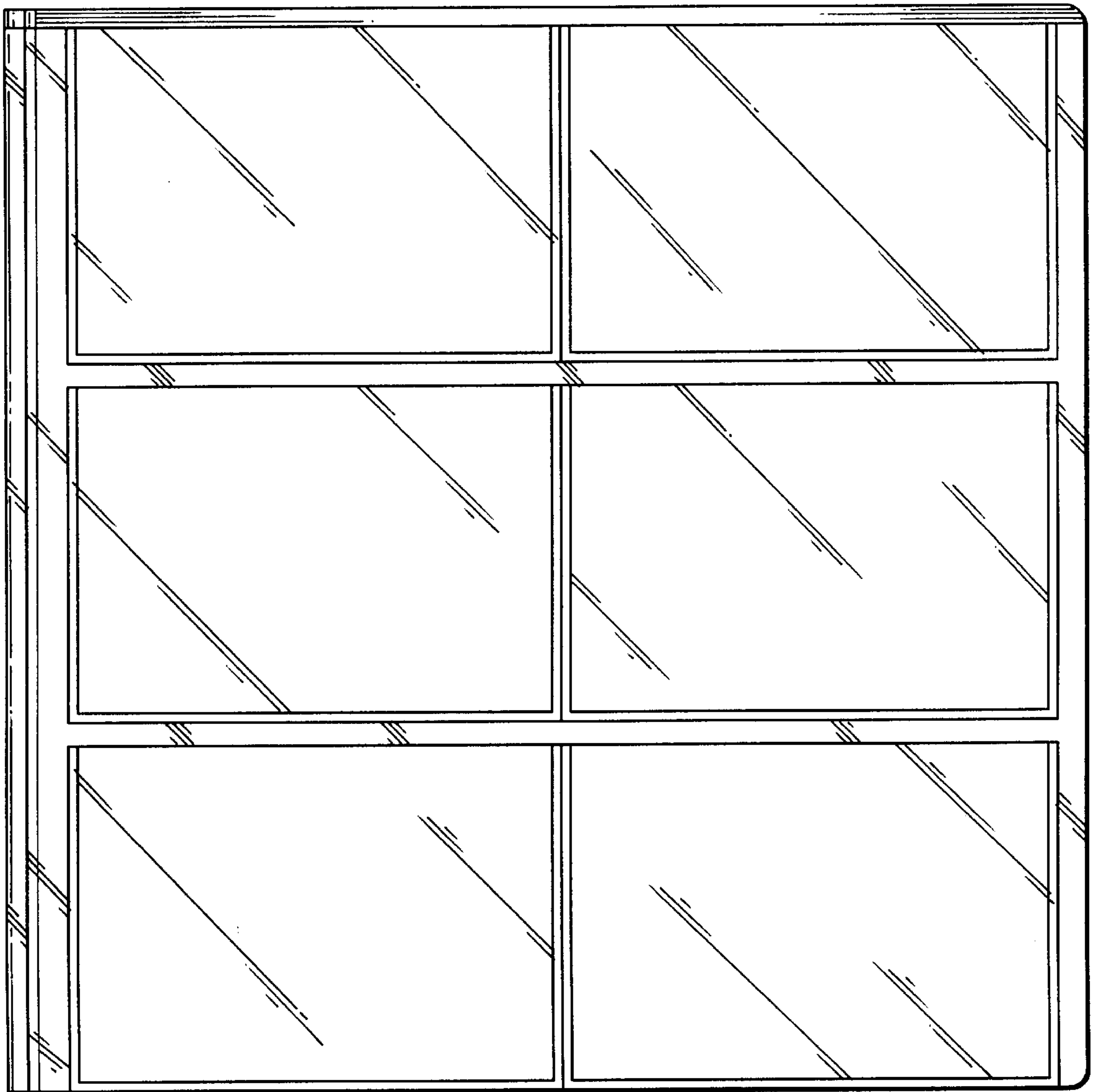

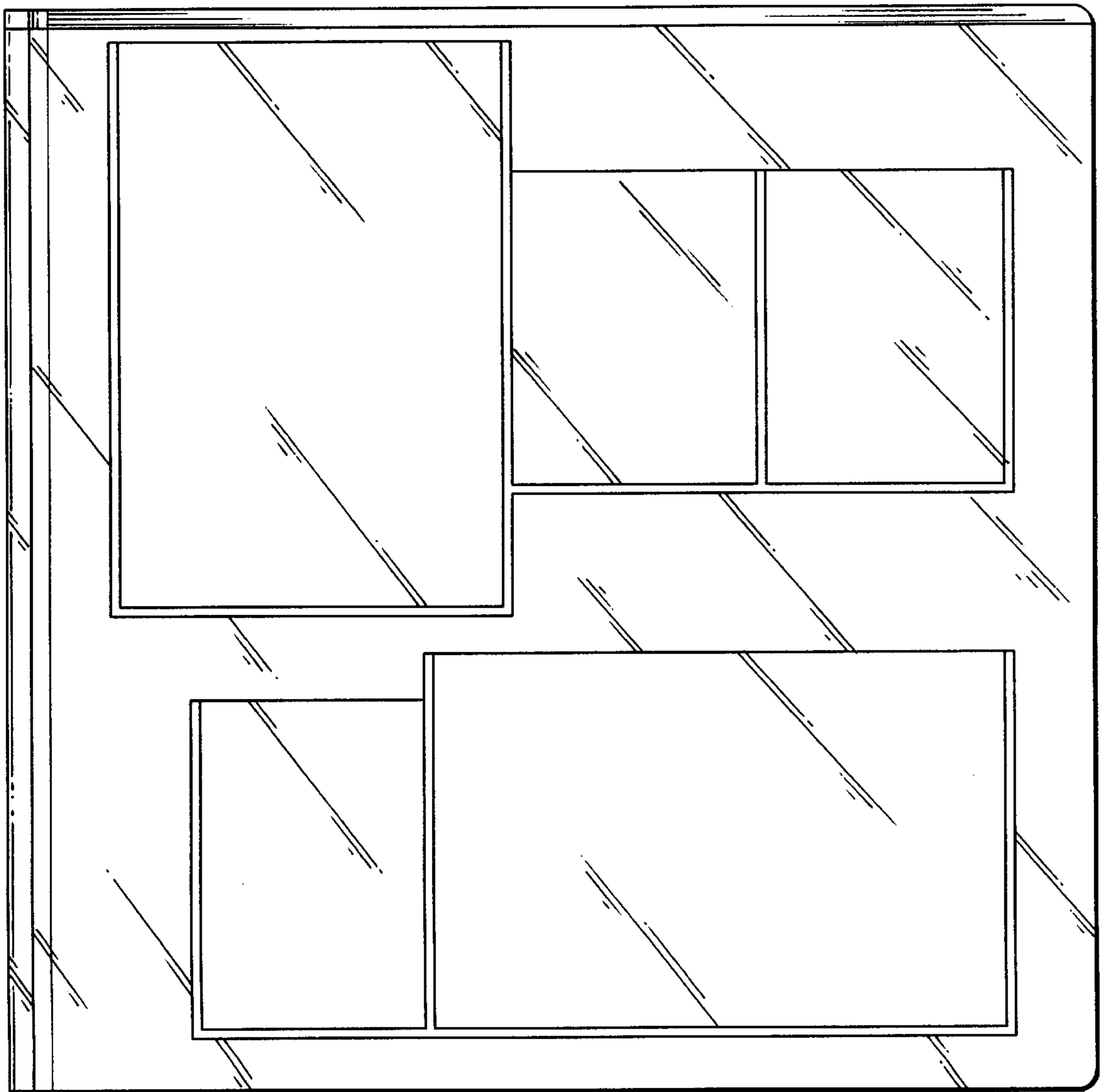

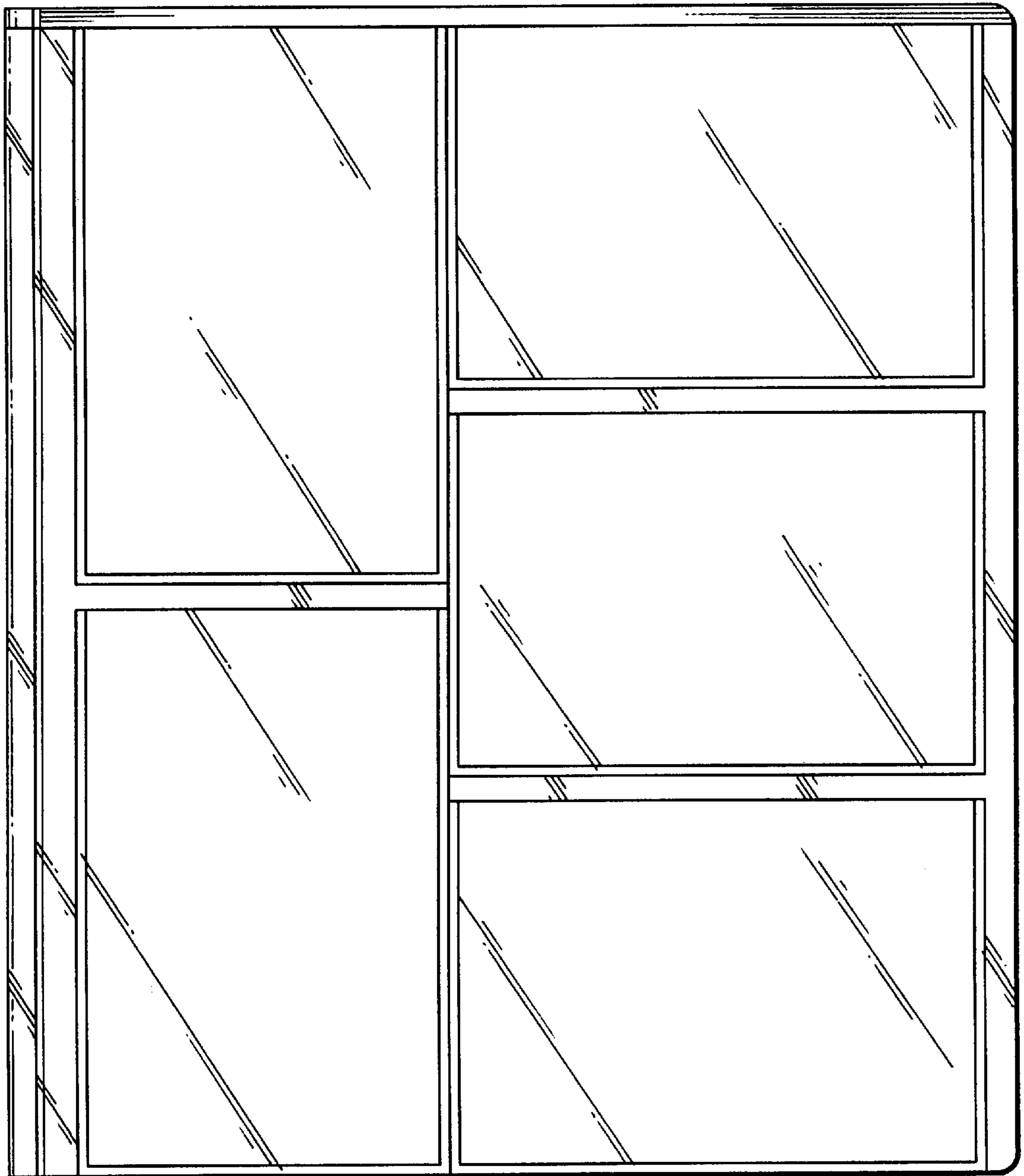
