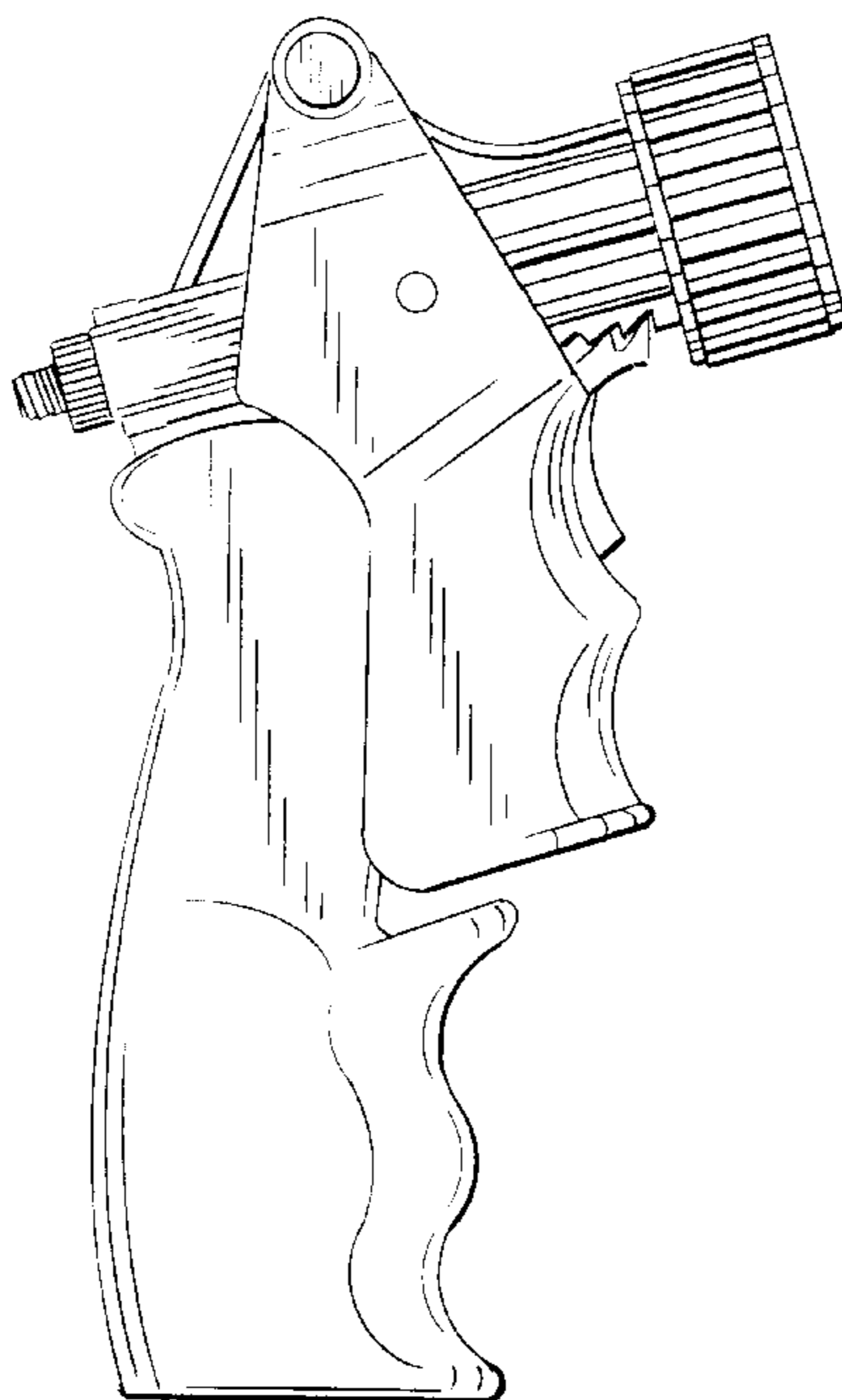
[57] **CLAIM**

The ornamental design for a hose end trigger spray nozzle, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a hose end trigger spray nozzle embodying my new design, it being understood that the opposite end is substantially a mirror image thereof; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof.

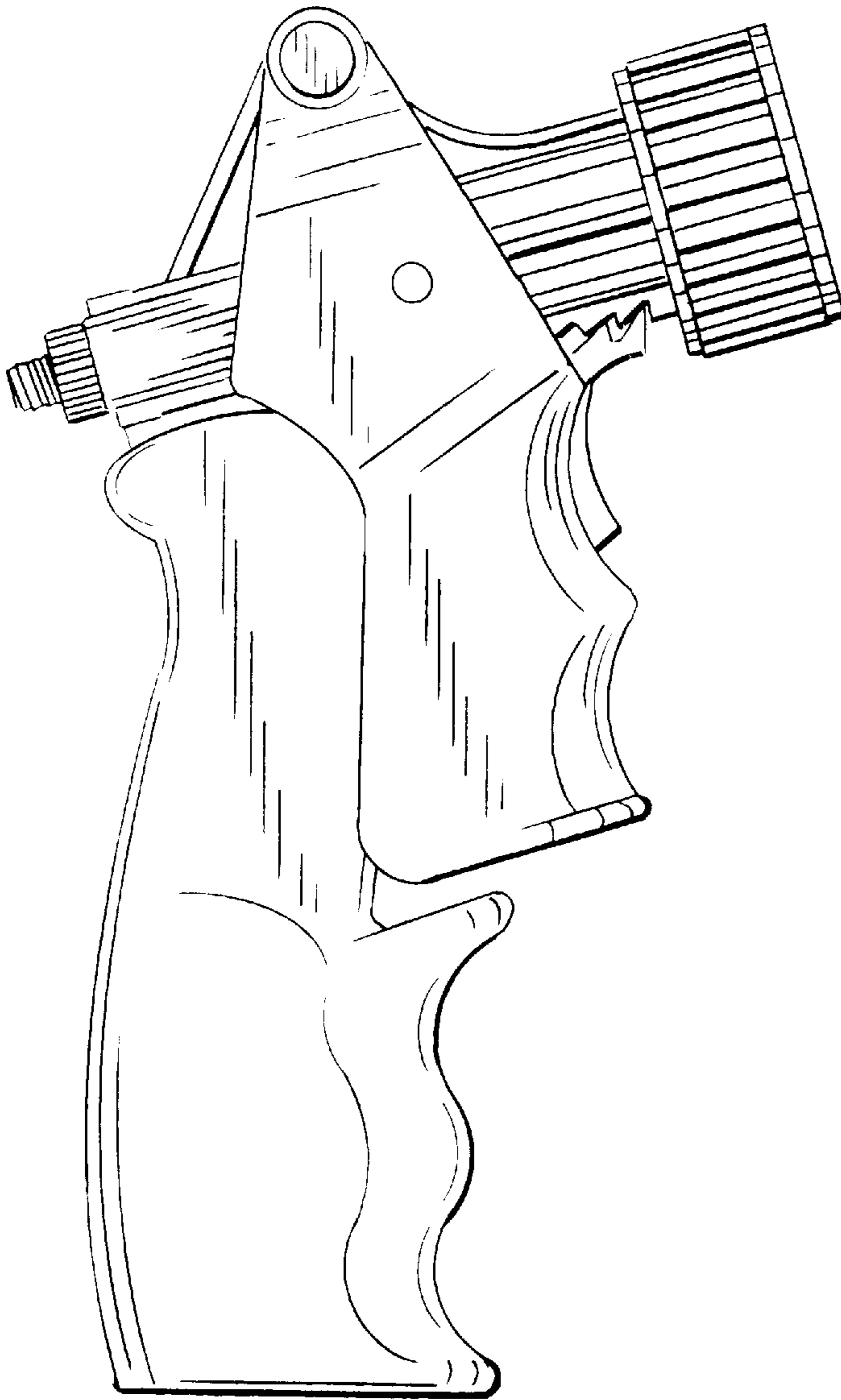

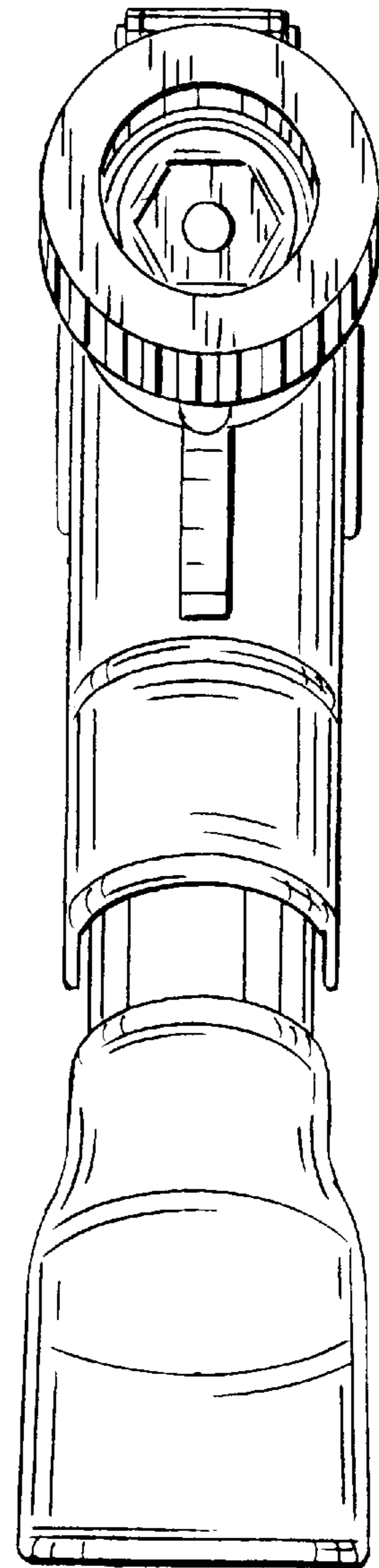

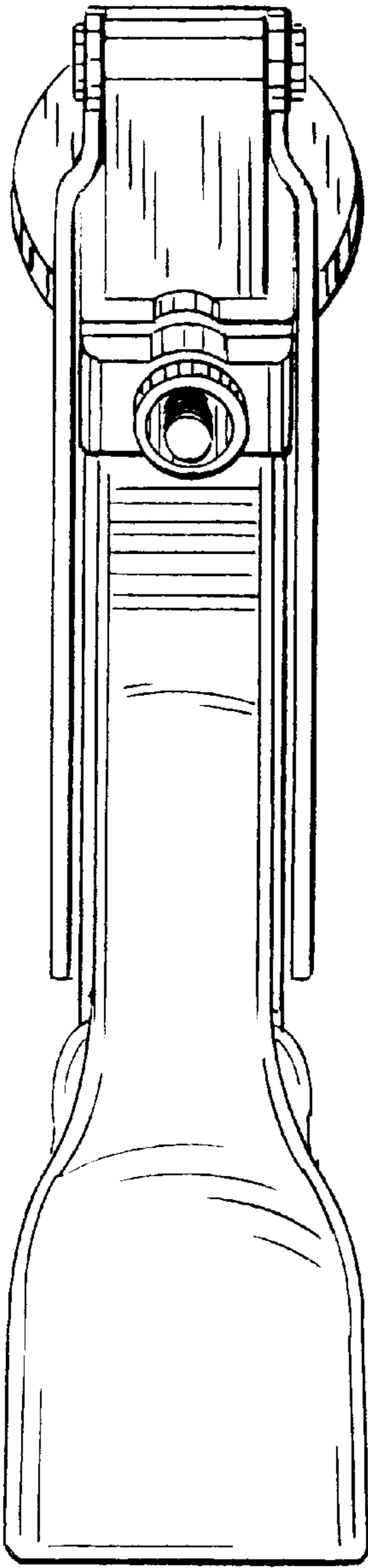

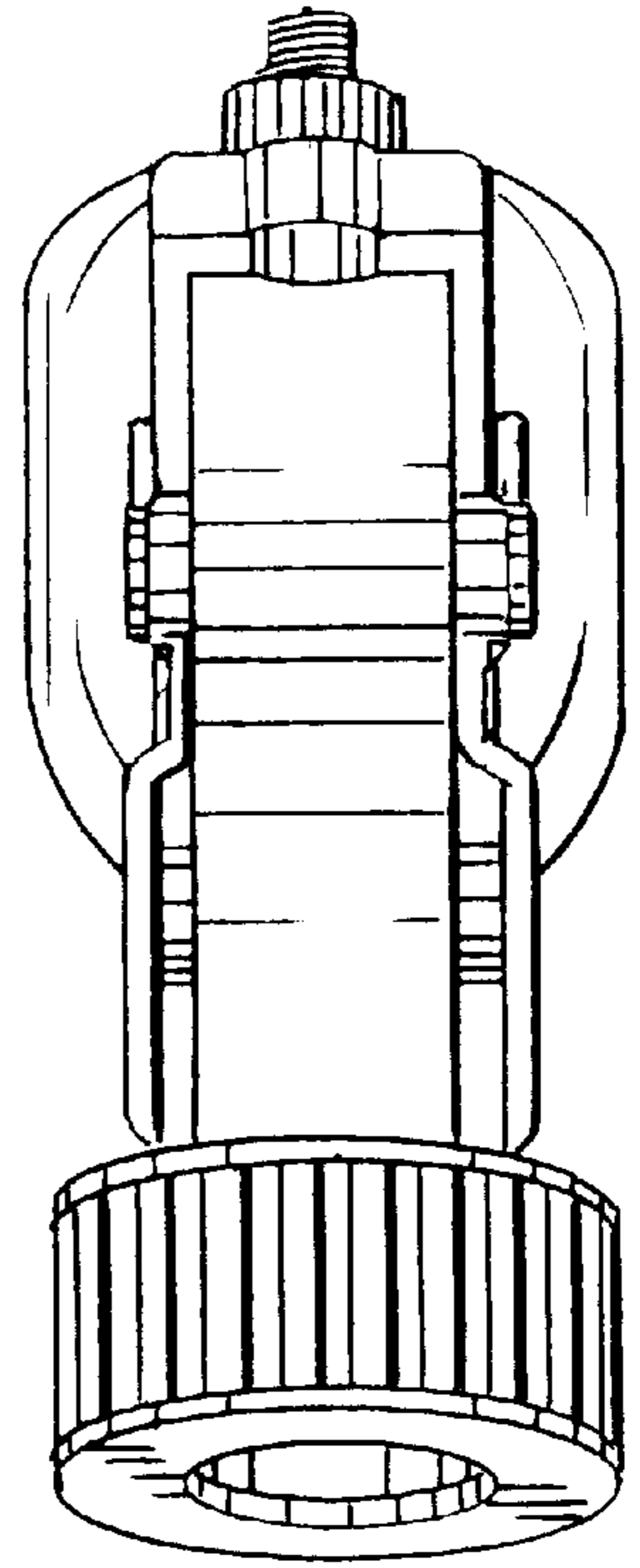

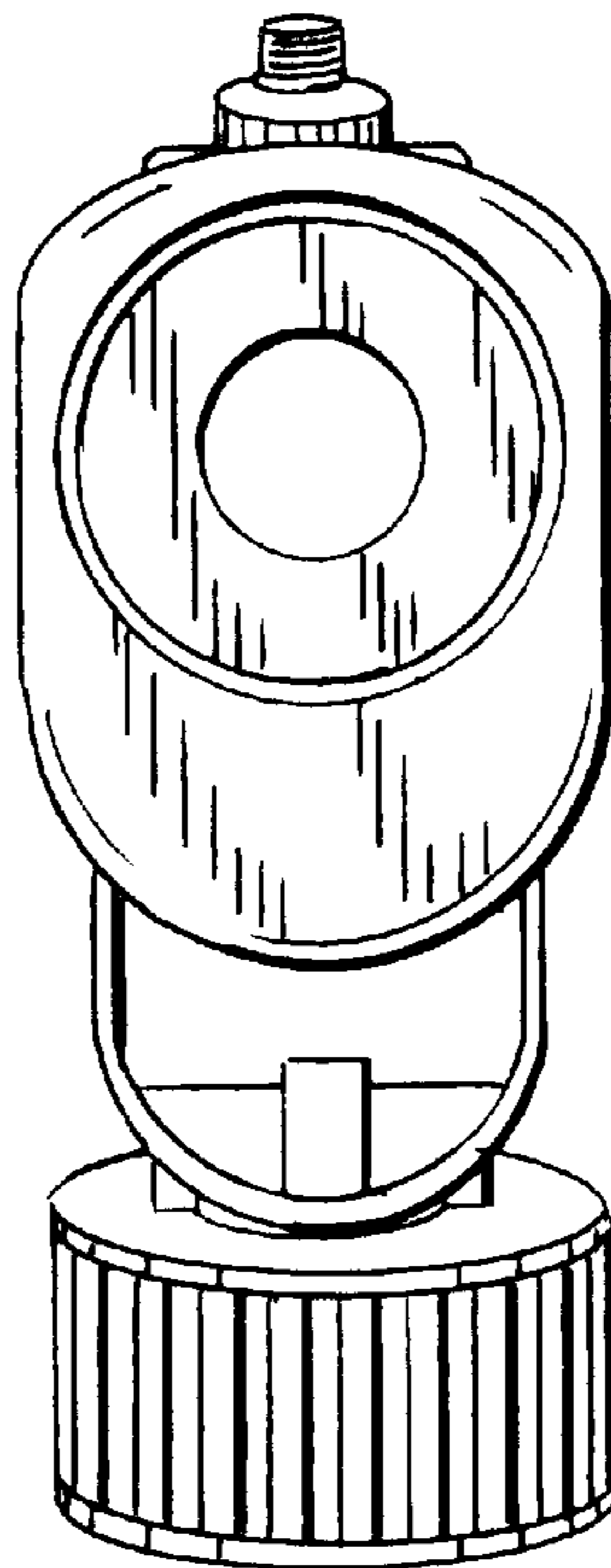
