### **DESCRIPTION**

FIG. 1 is a front perspective view of an outdoor lantern showing our new design;

FIG. 2 is a front elevational view thereof;

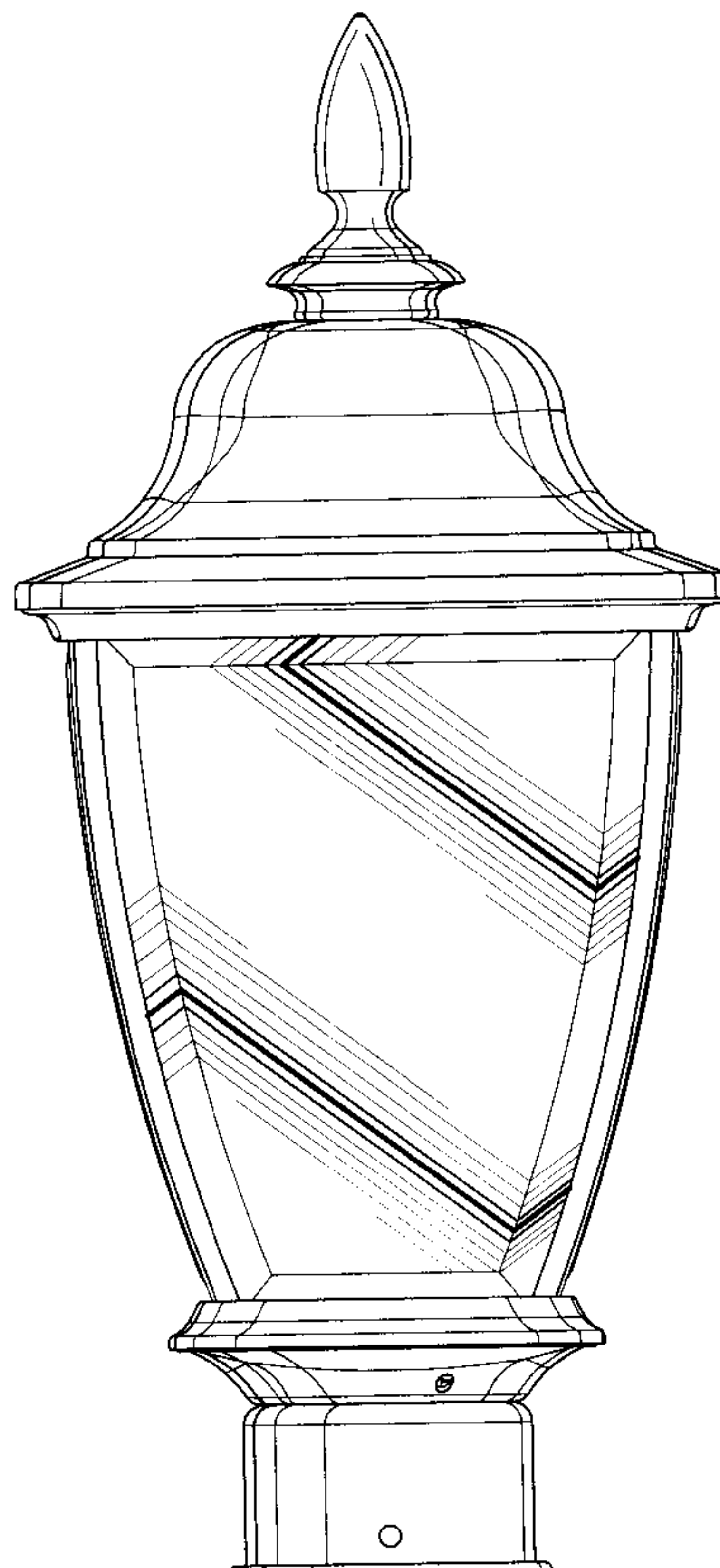
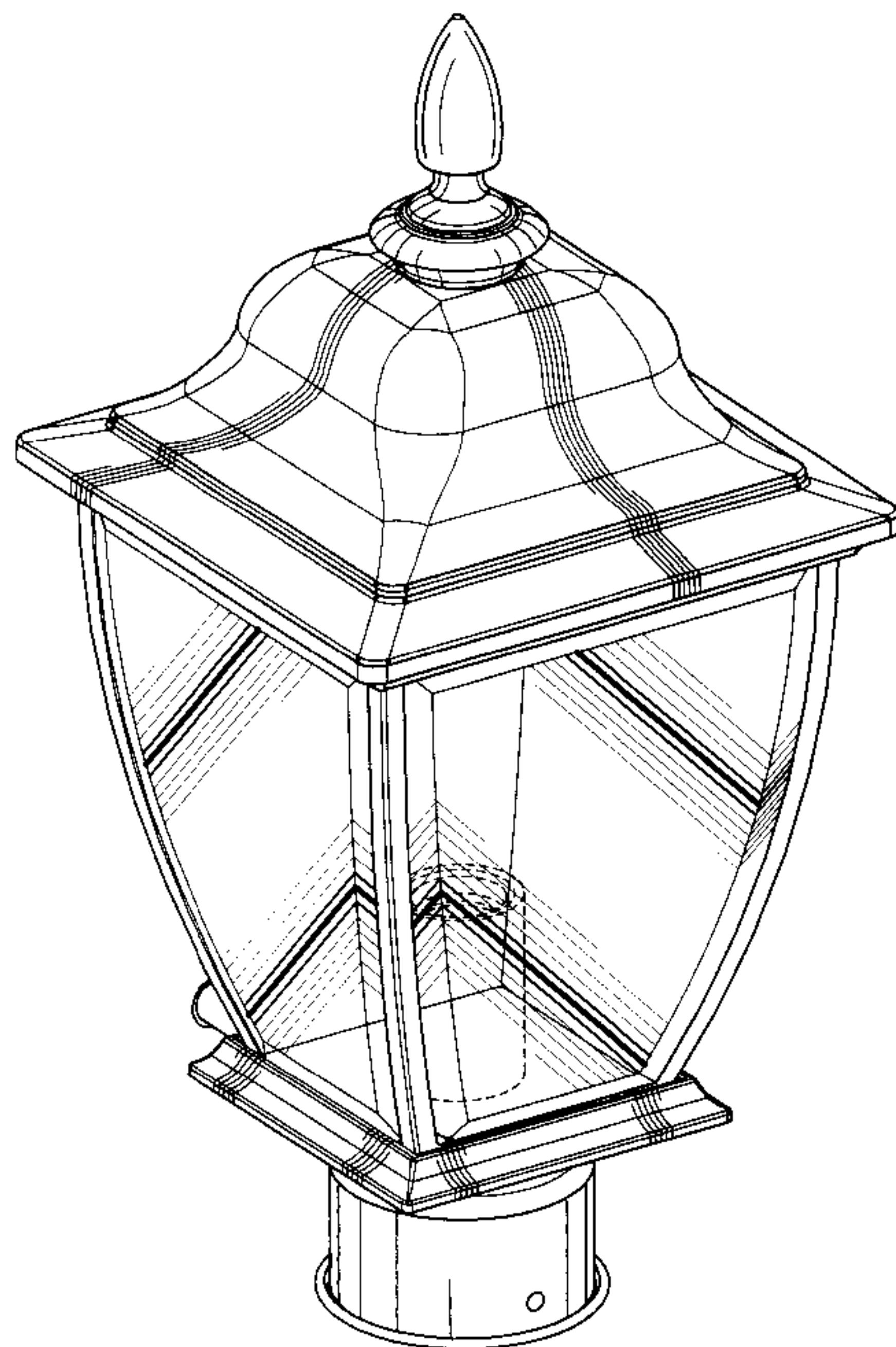
FIG. 3 is a right side elevational view thereof, the left side being a mirror image;

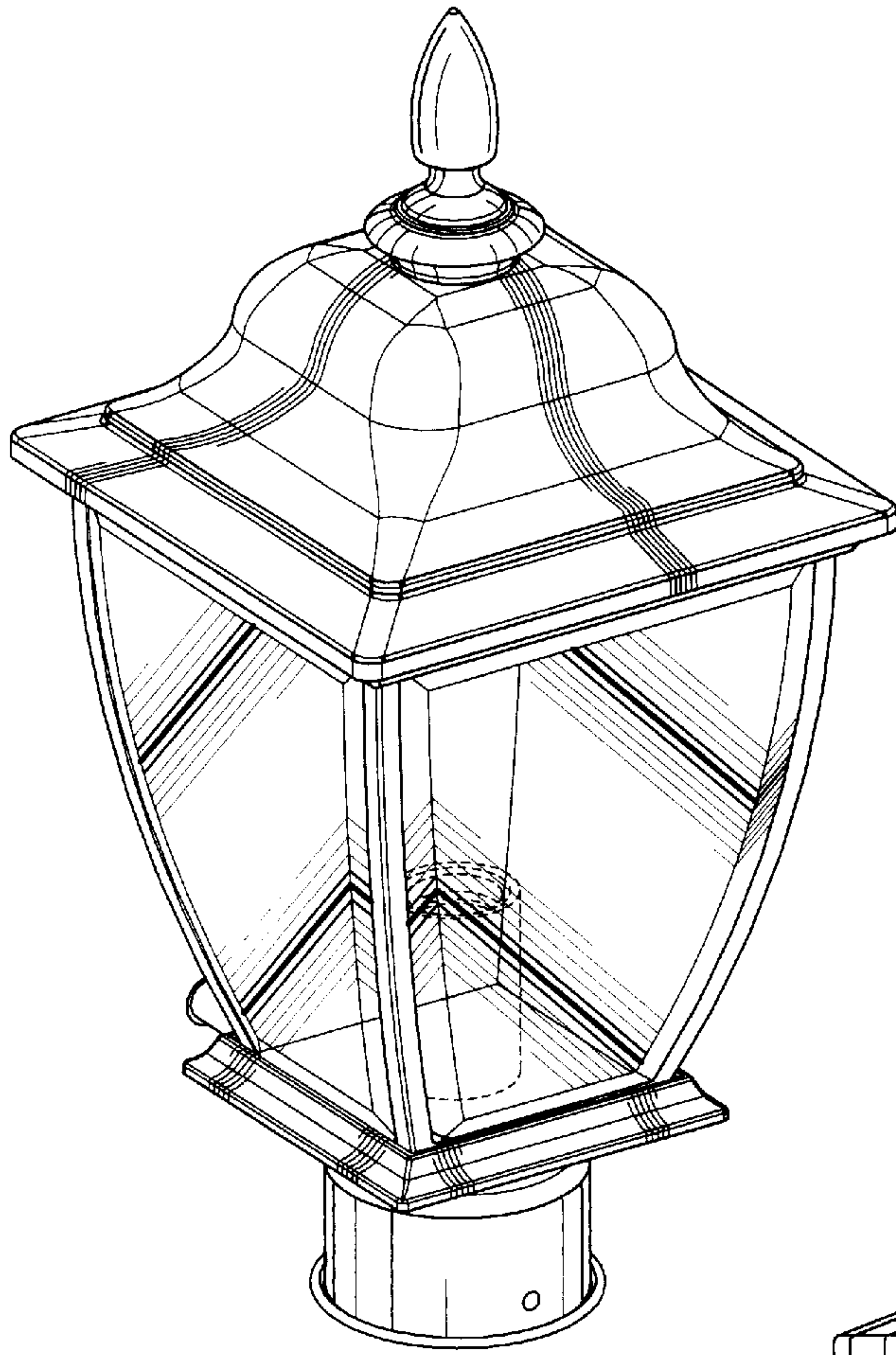

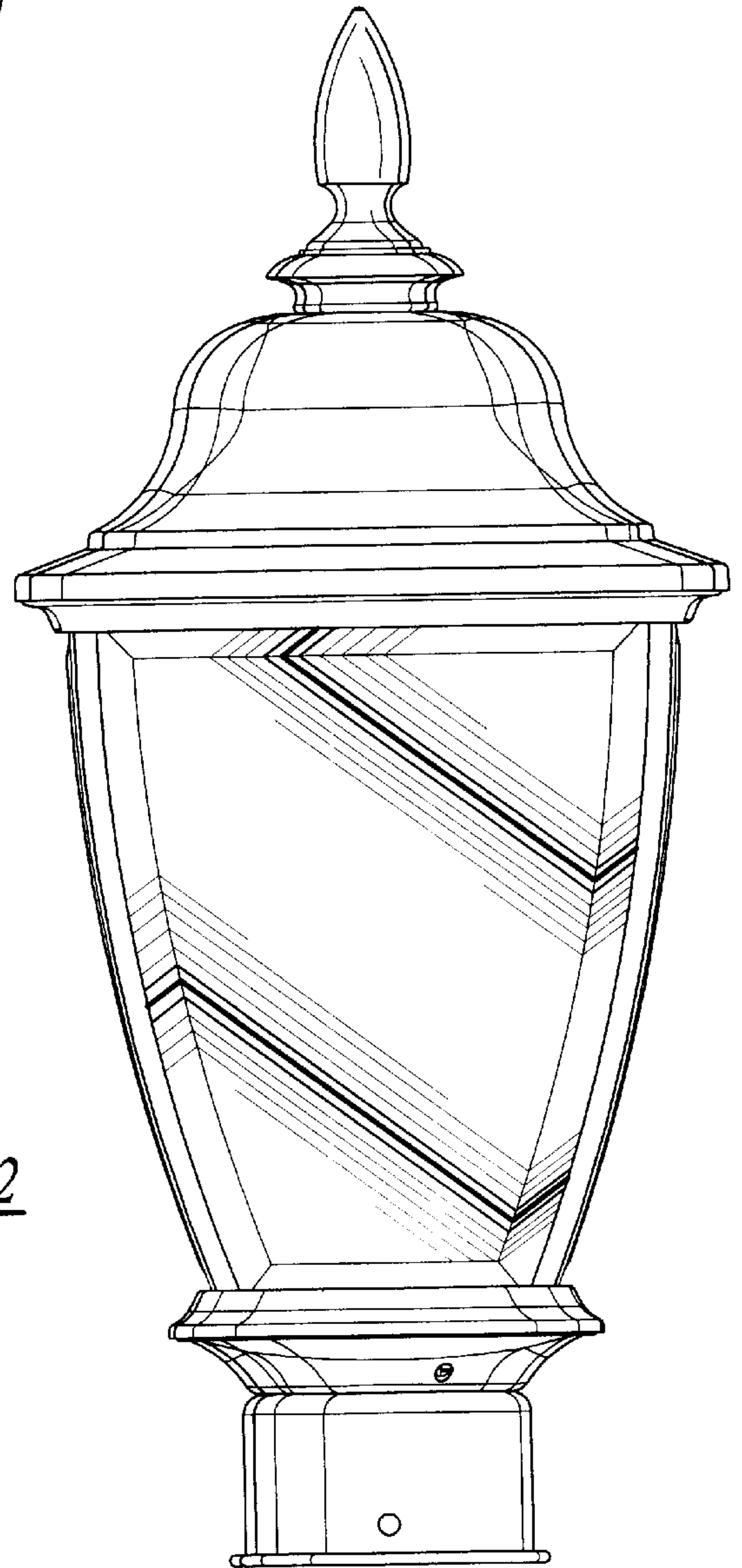

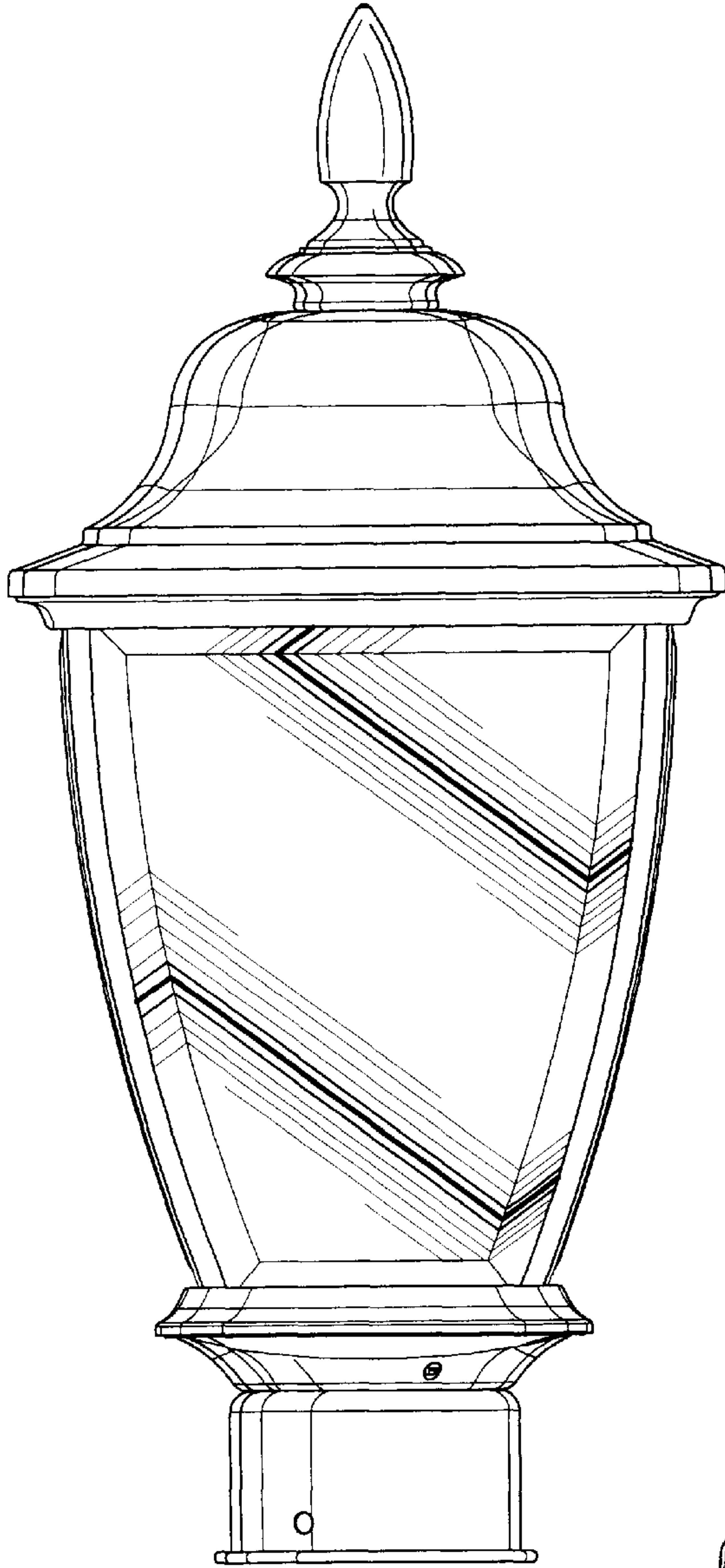

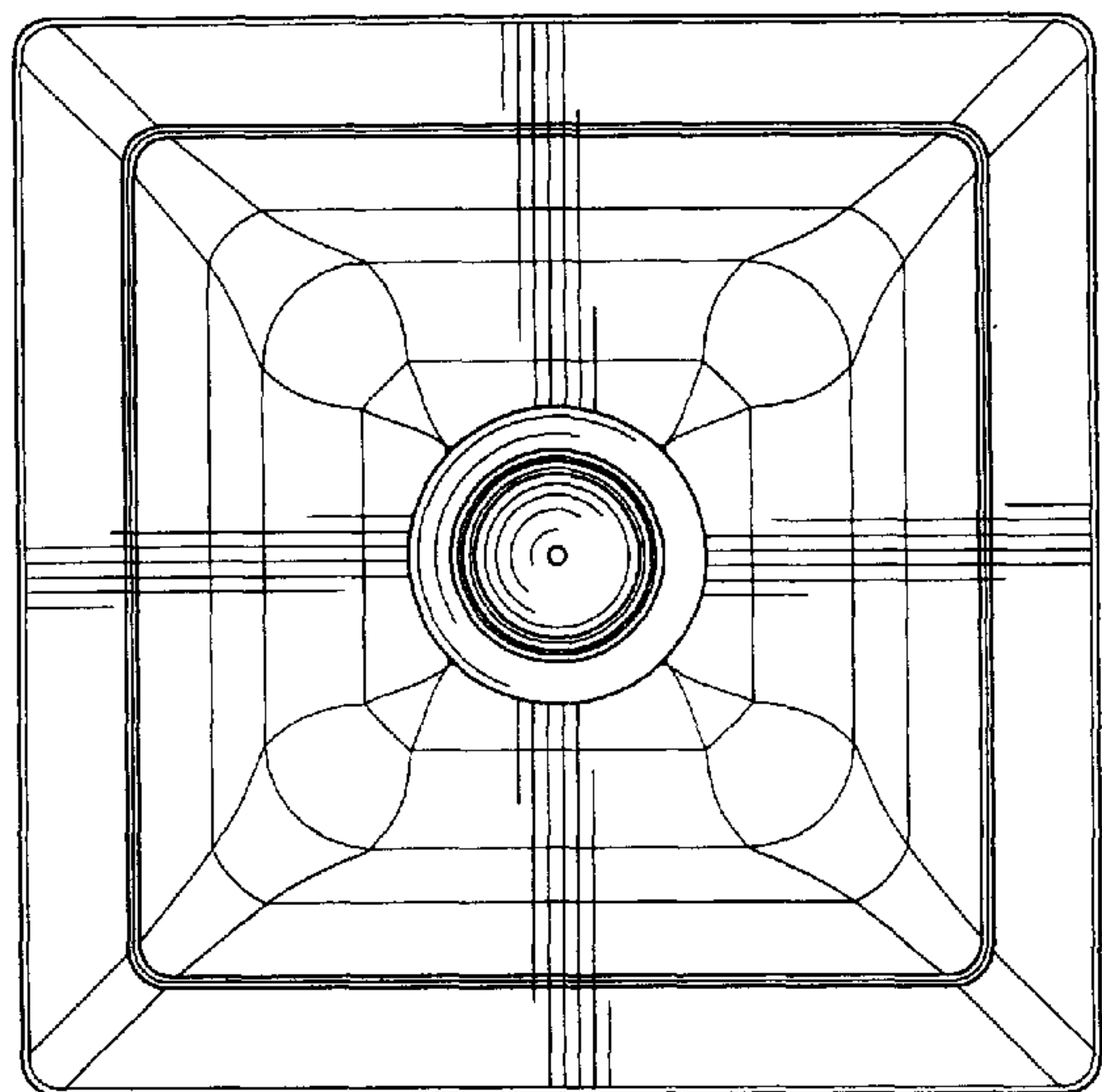
