FIG. 6 is a bottom plan view of the novelty baseball cap of FIG. 1.

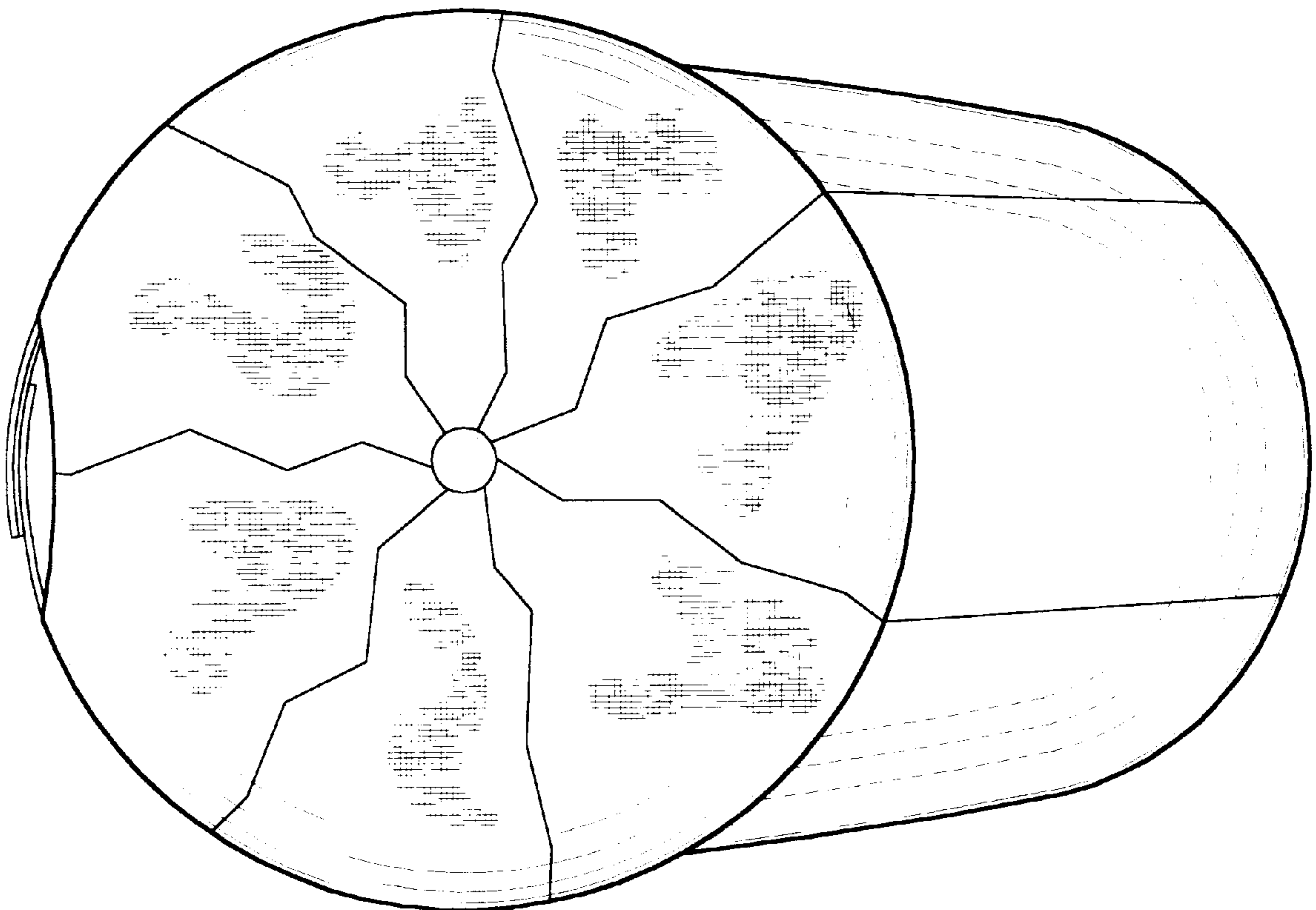
The broken line showing of the logo patches in FIGS. 1, 2, and 4 is for illustrative purposes only and form no part of the claimed design.

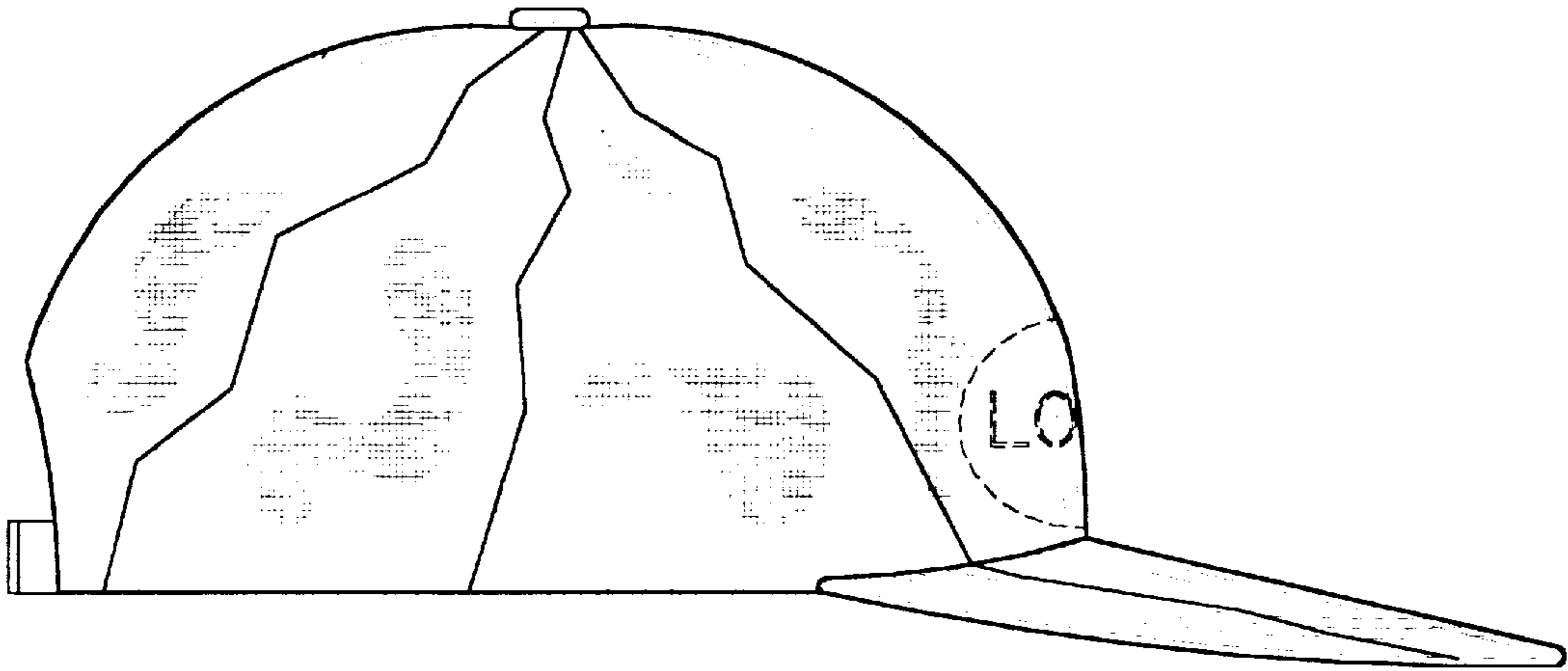

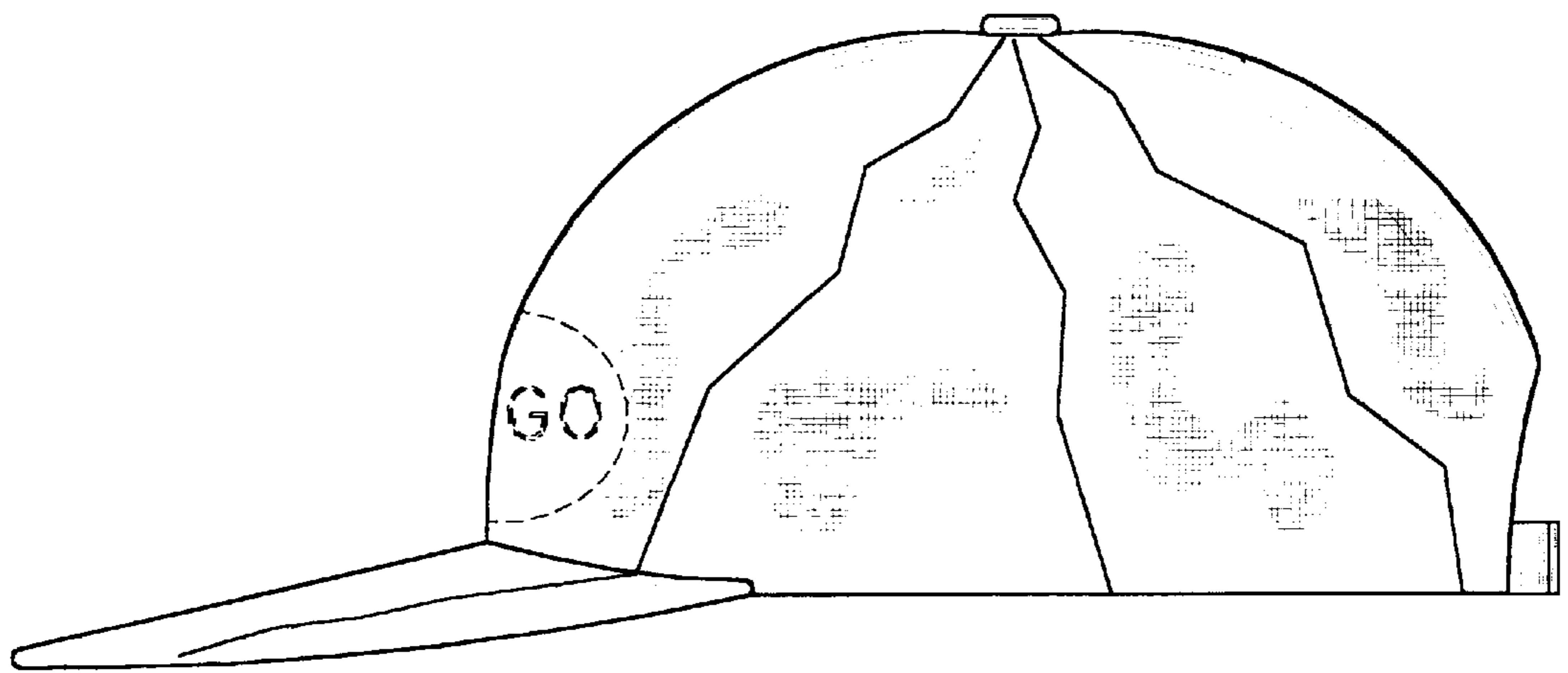

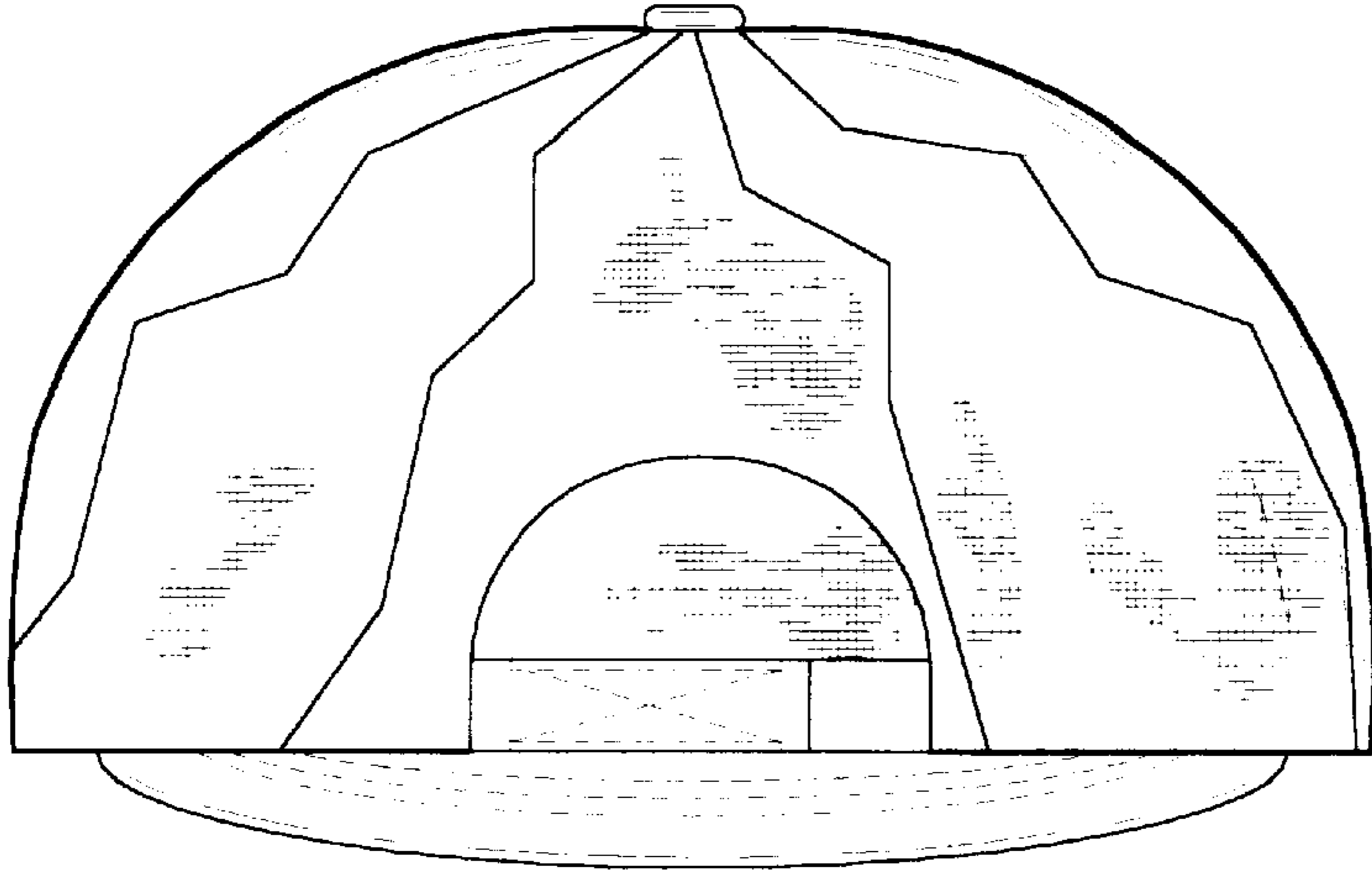




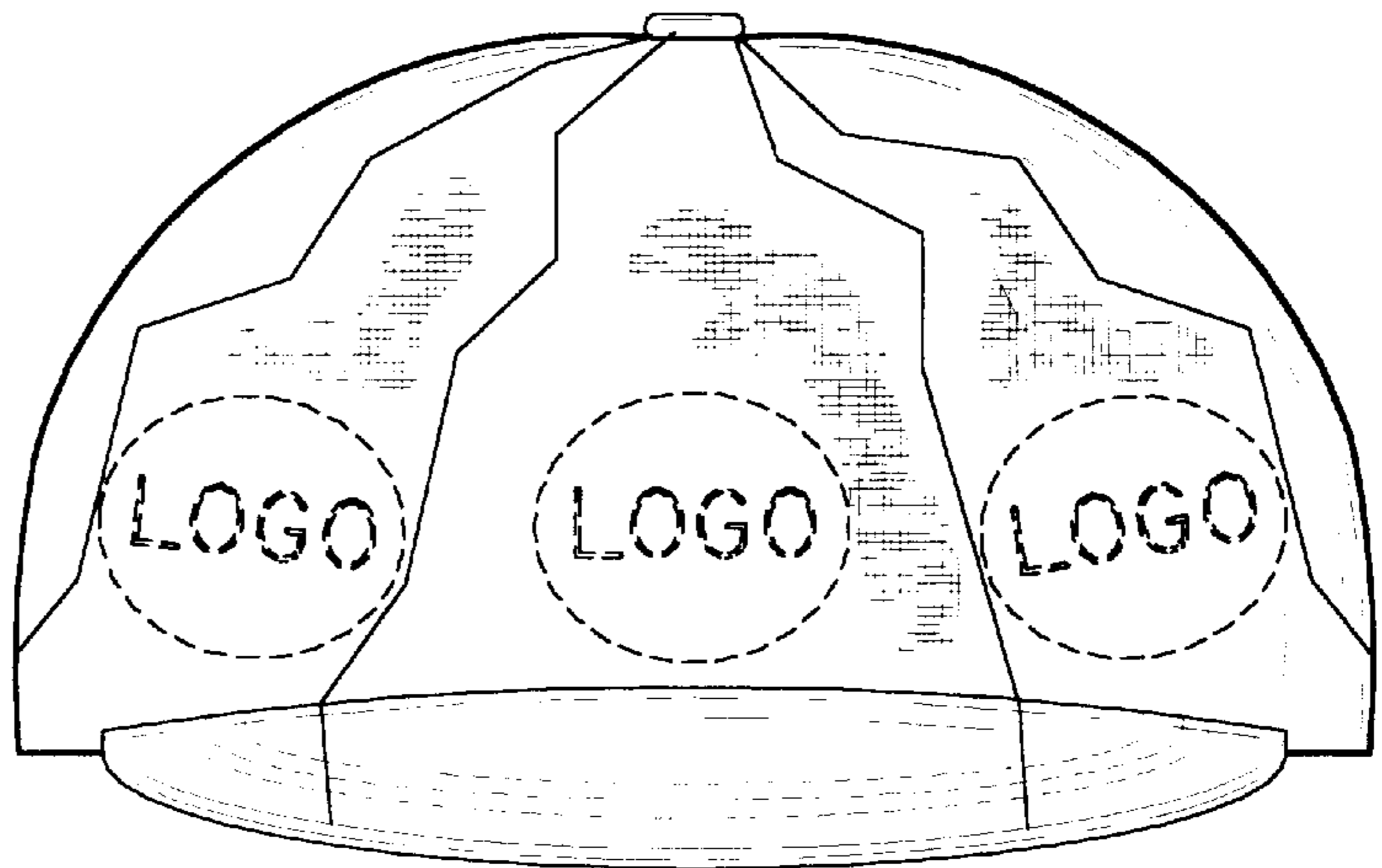

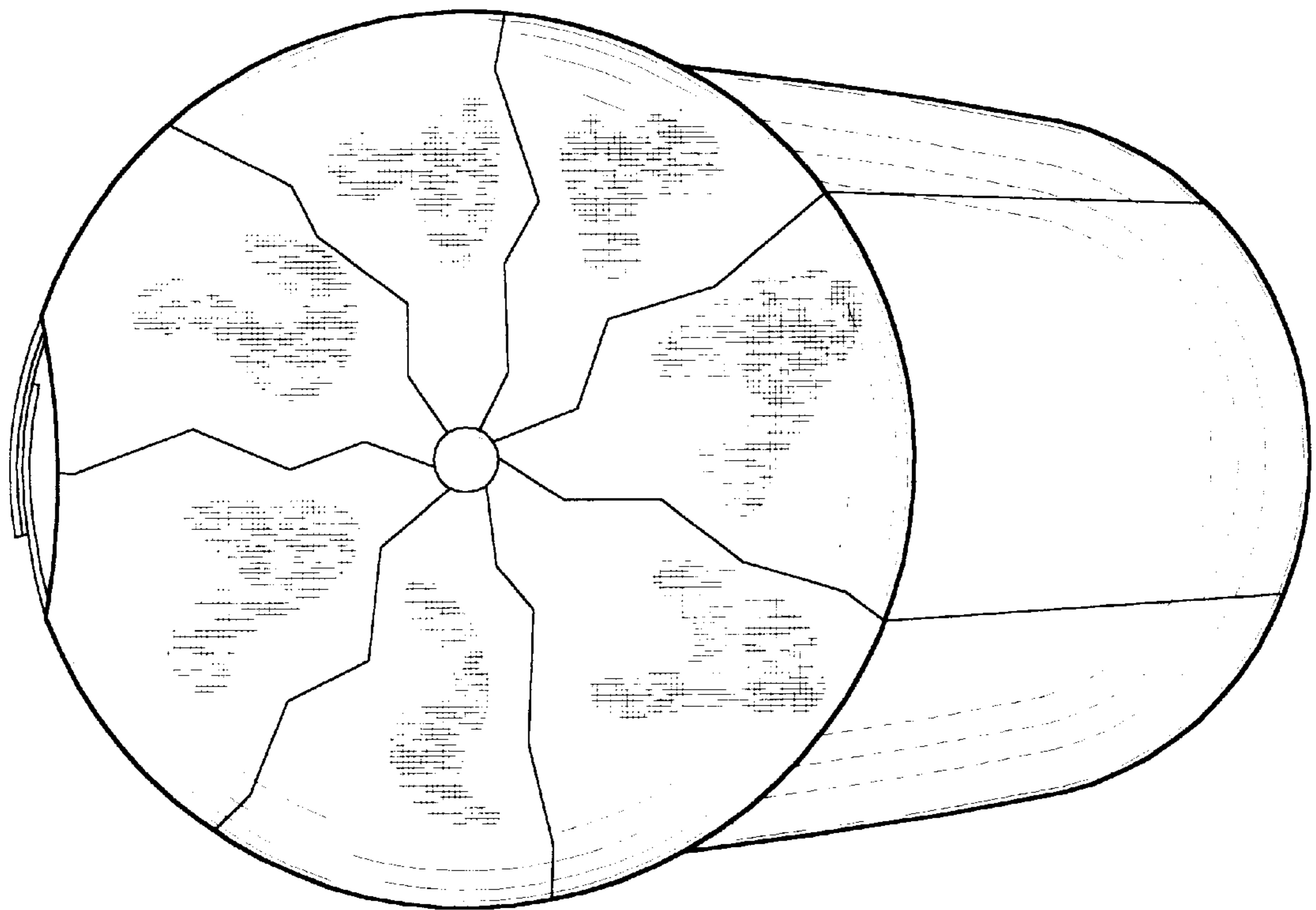

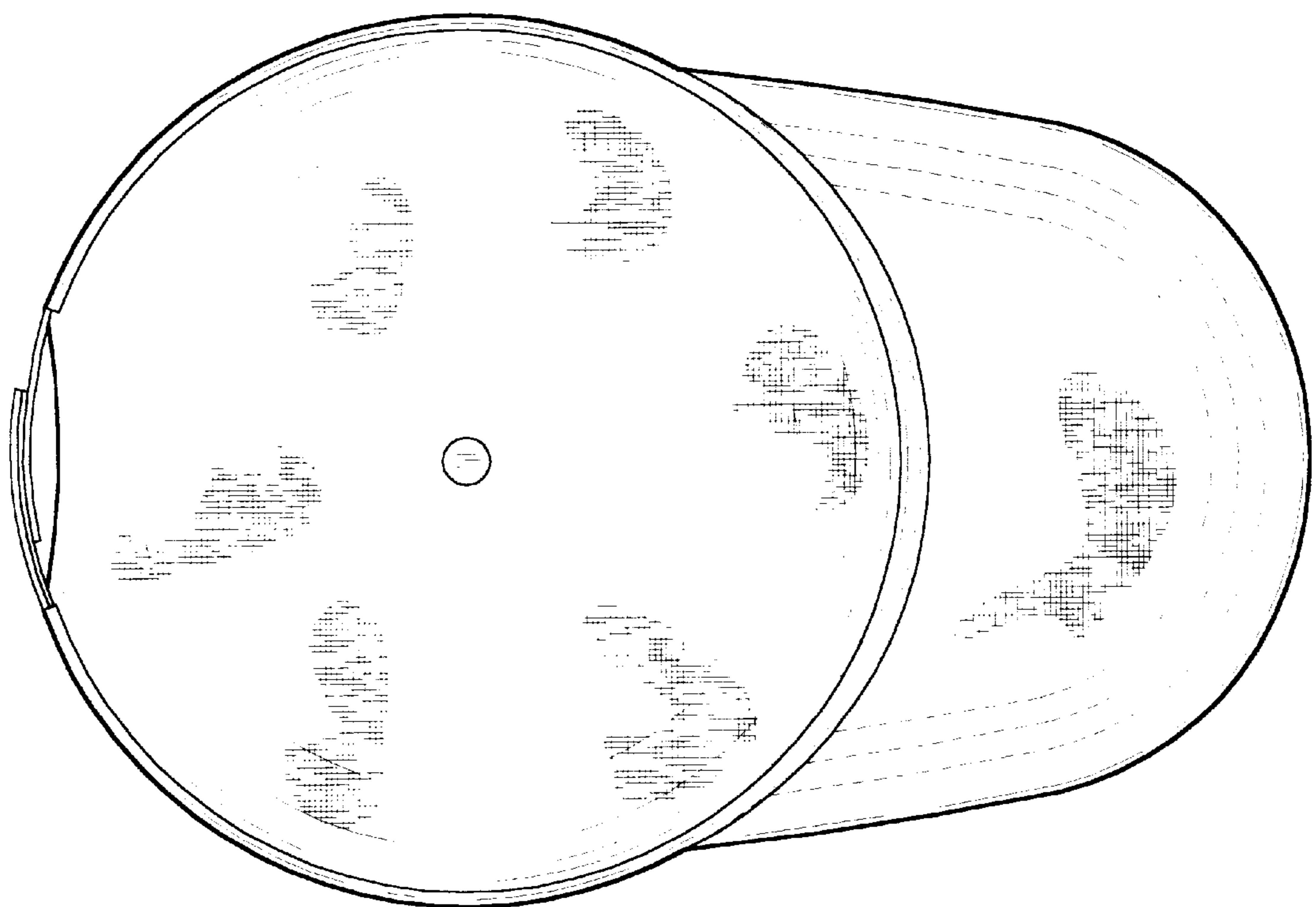
