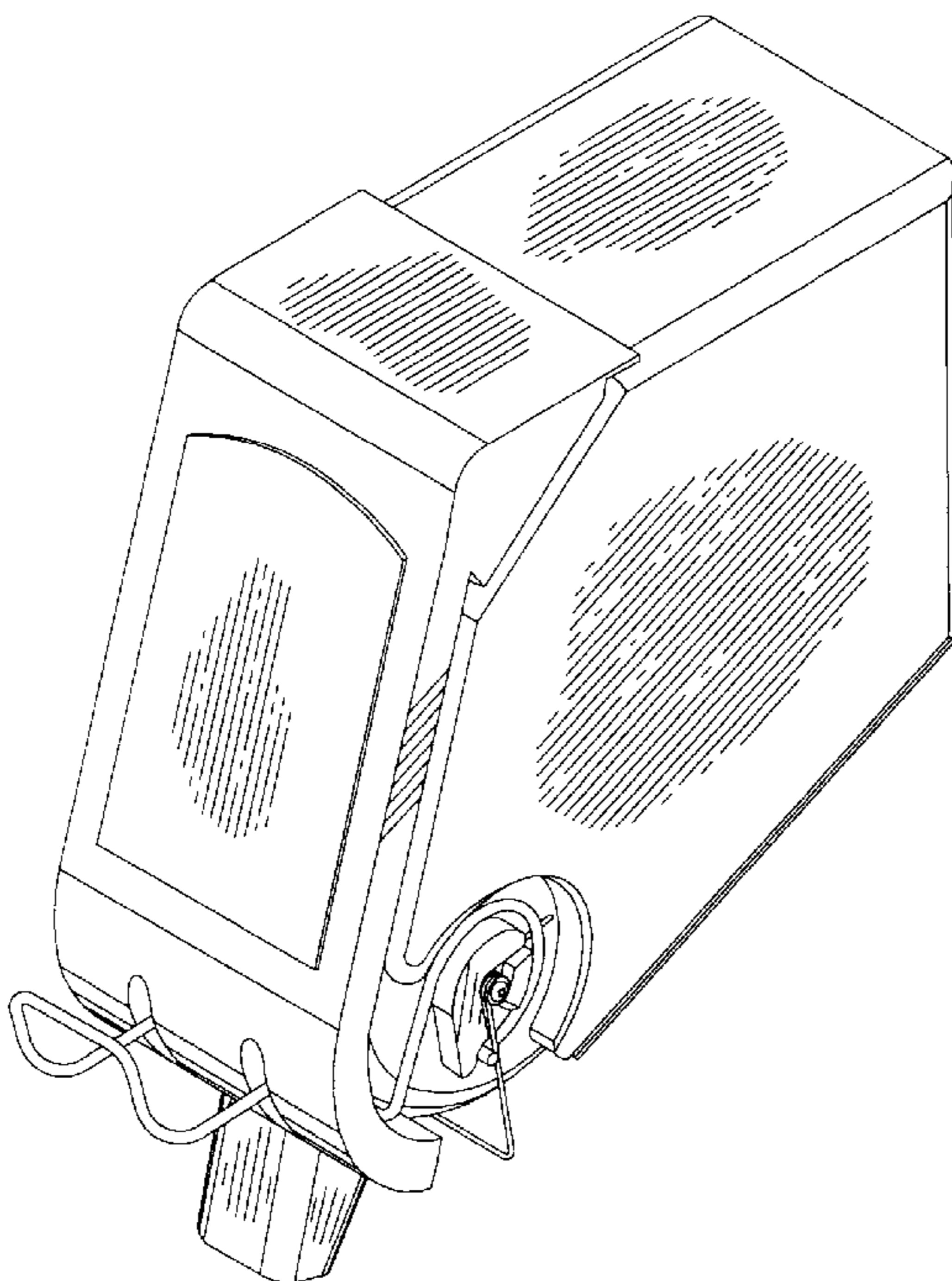
[57] CLAIM

The ornamental design for a bulk bin, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bulk bin, embodying our new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a side elevational view thereof, the opposite side elevational view being a mirror image thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIGS. 7–11 are views corresponding to FIGS. 2–6, respectively, of an embodiment of the bulk bin having certain features depicted in broken lines for illustrative purposes only, and which form no part of the claimed invention of FIGS. 7–11; and,
FIG. 12 is a perspective view thereof, the remaining bins are shown in broken lines for illustrative purposes only and form no part of the claimed design.

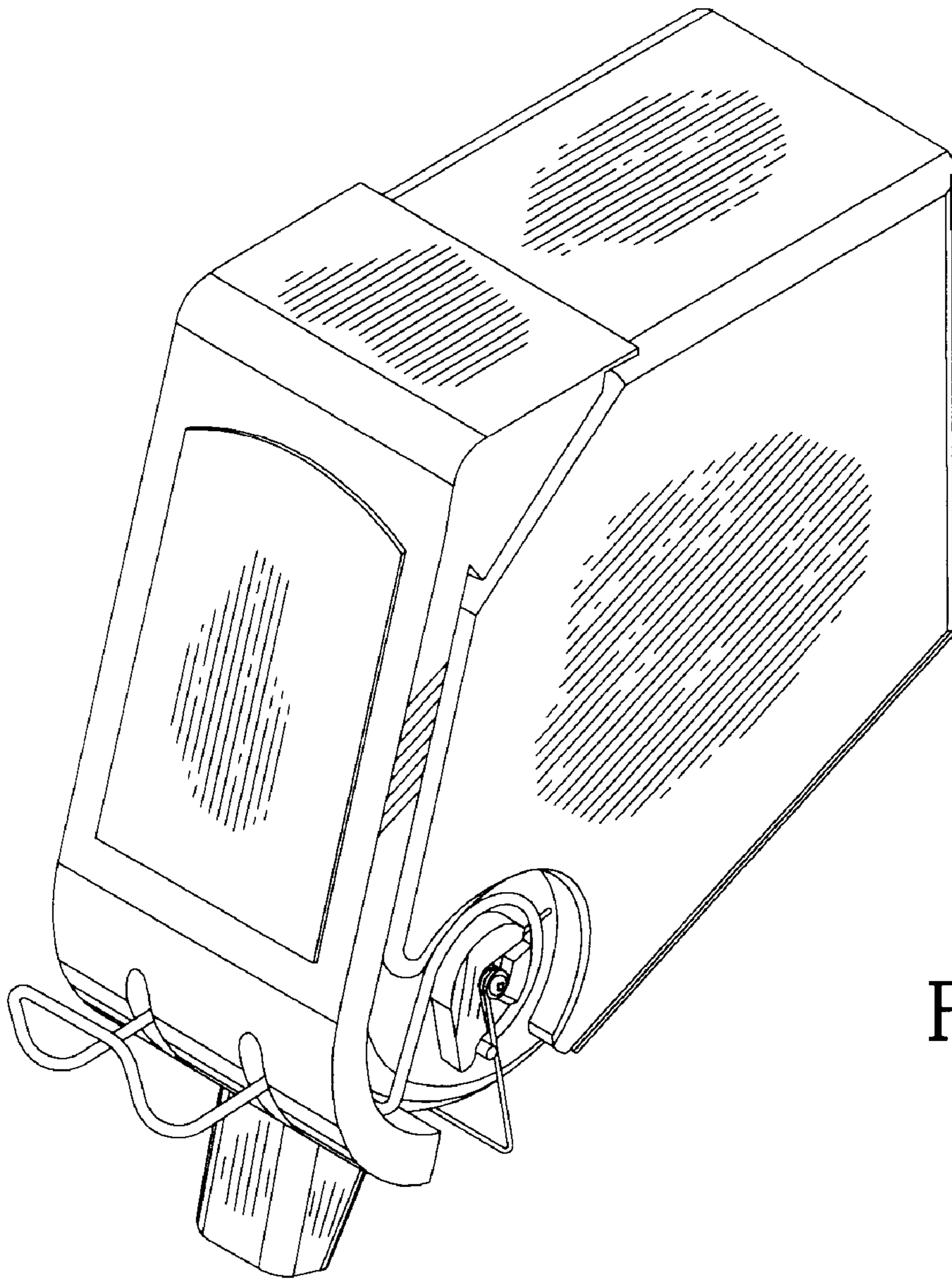

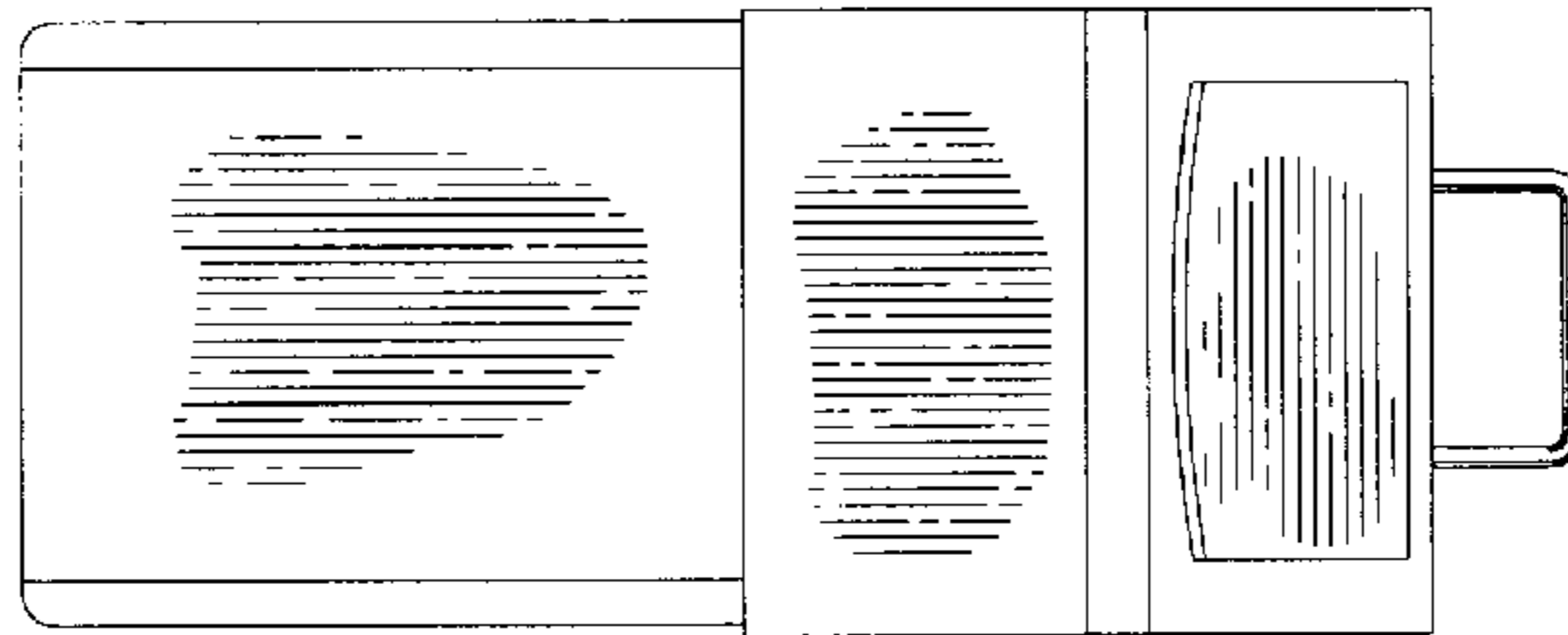

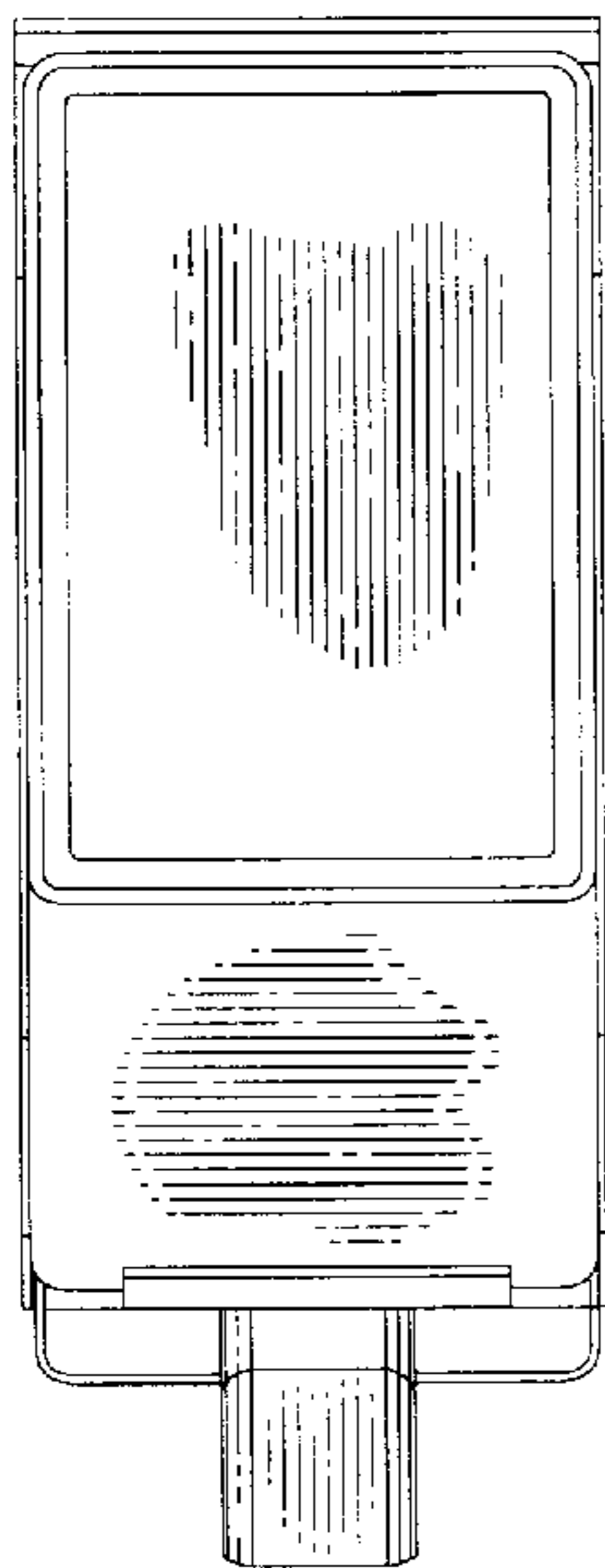

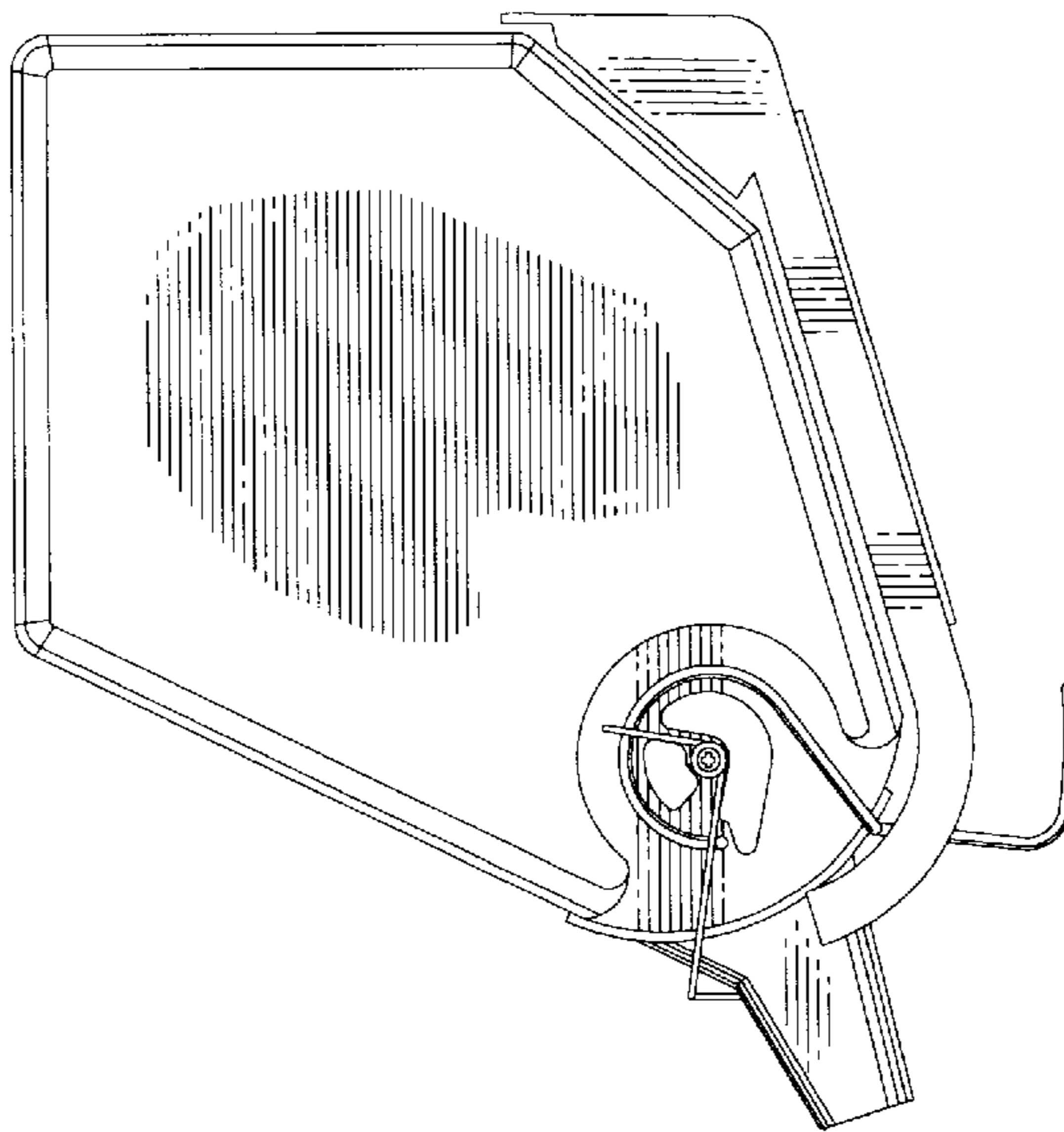

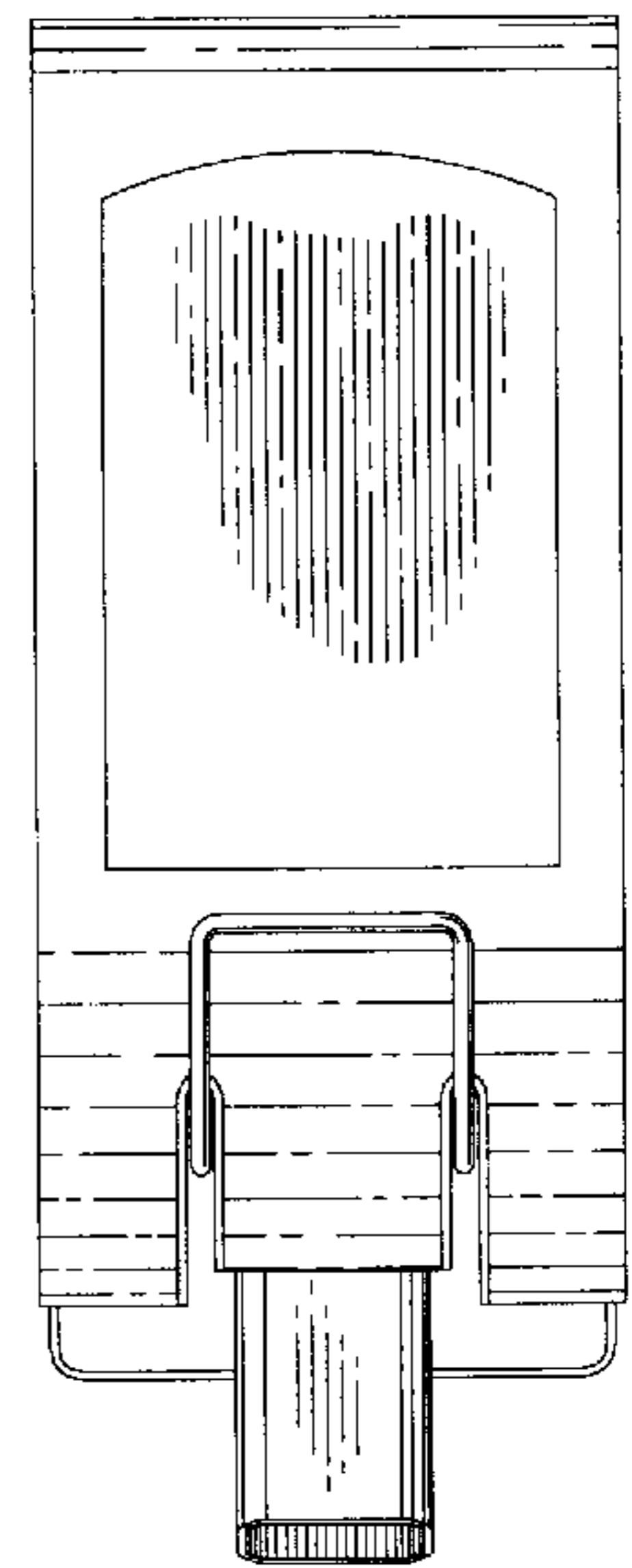

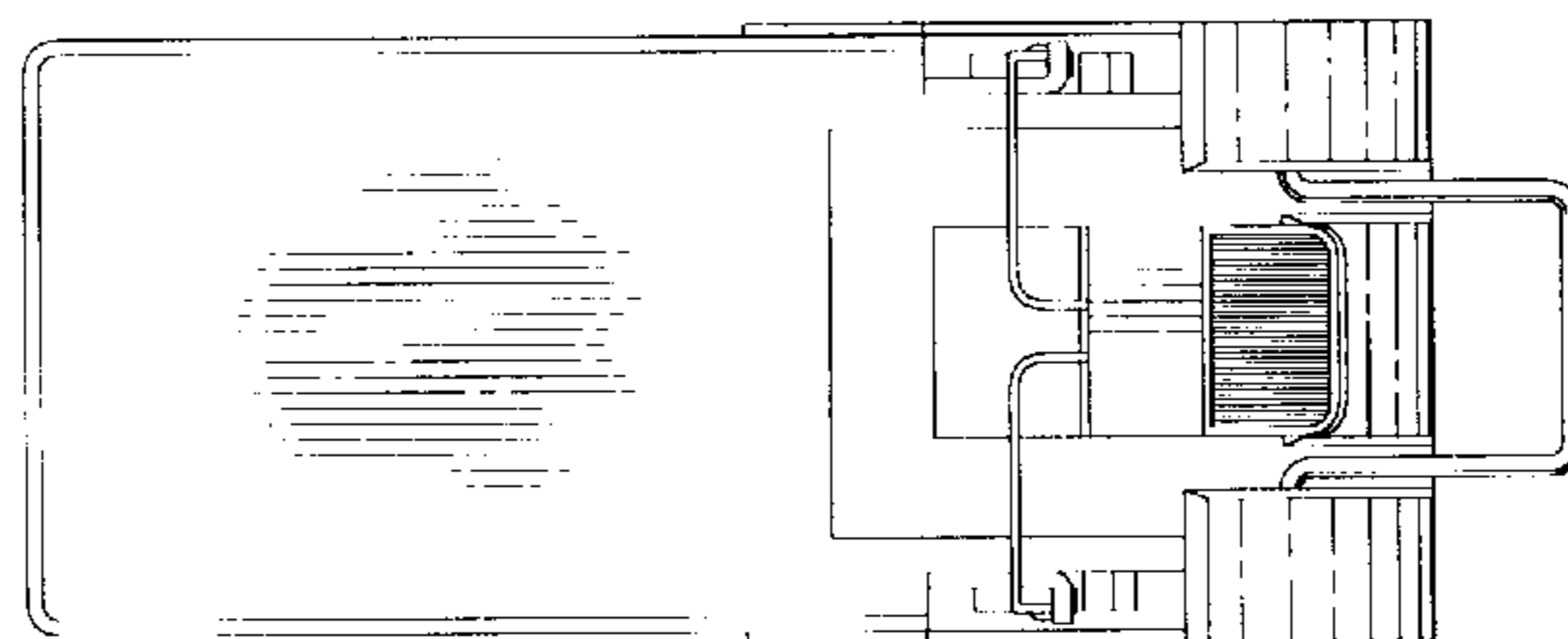

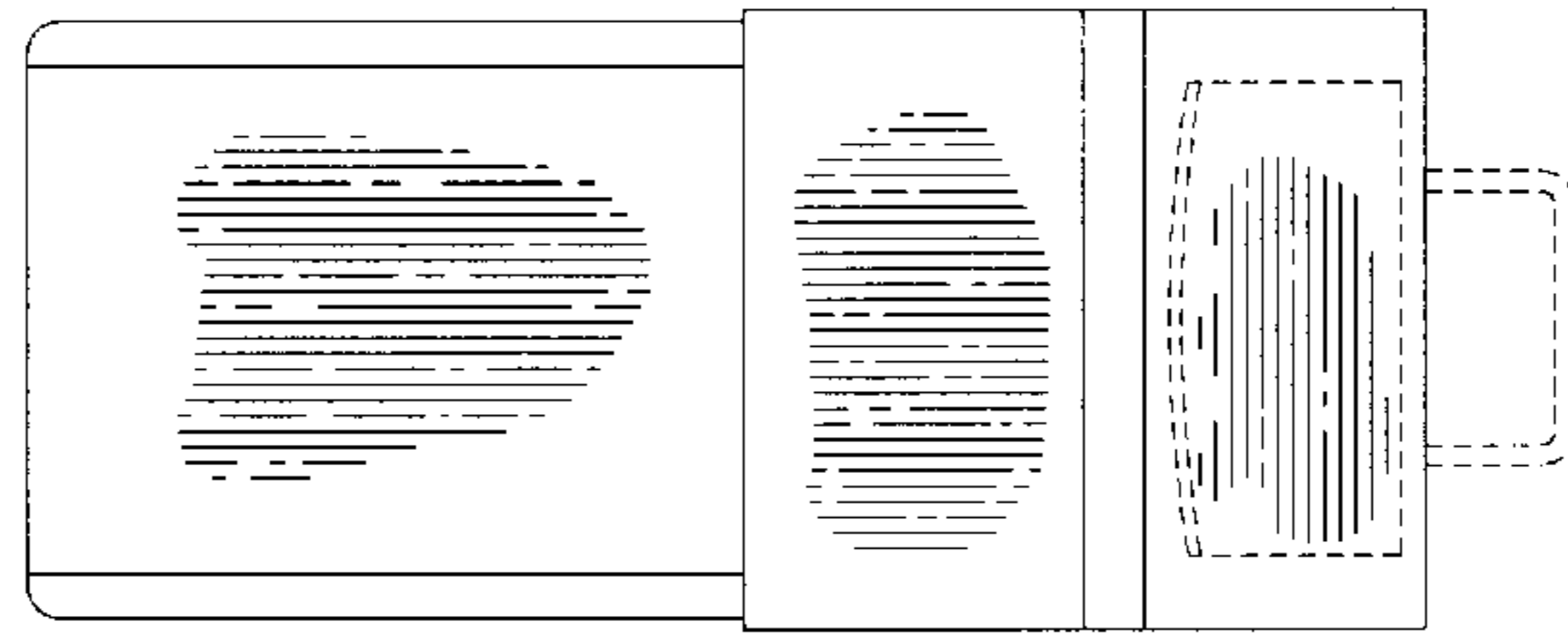

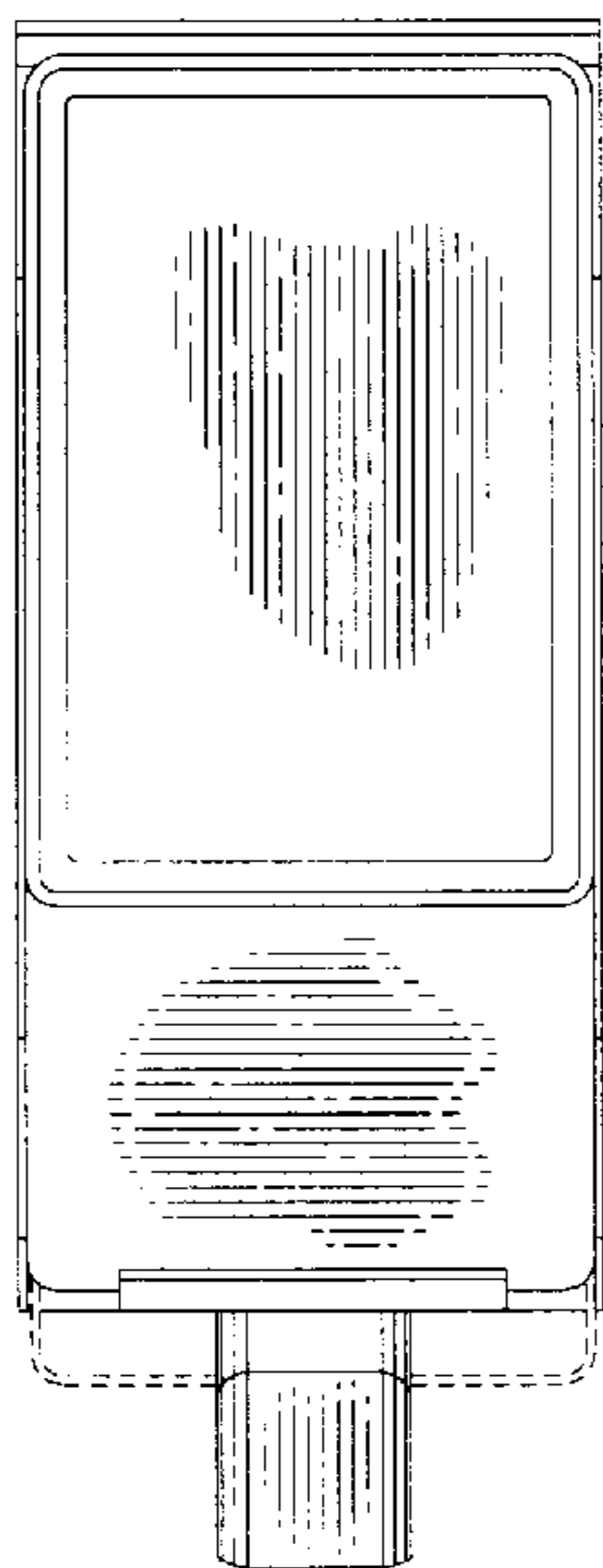

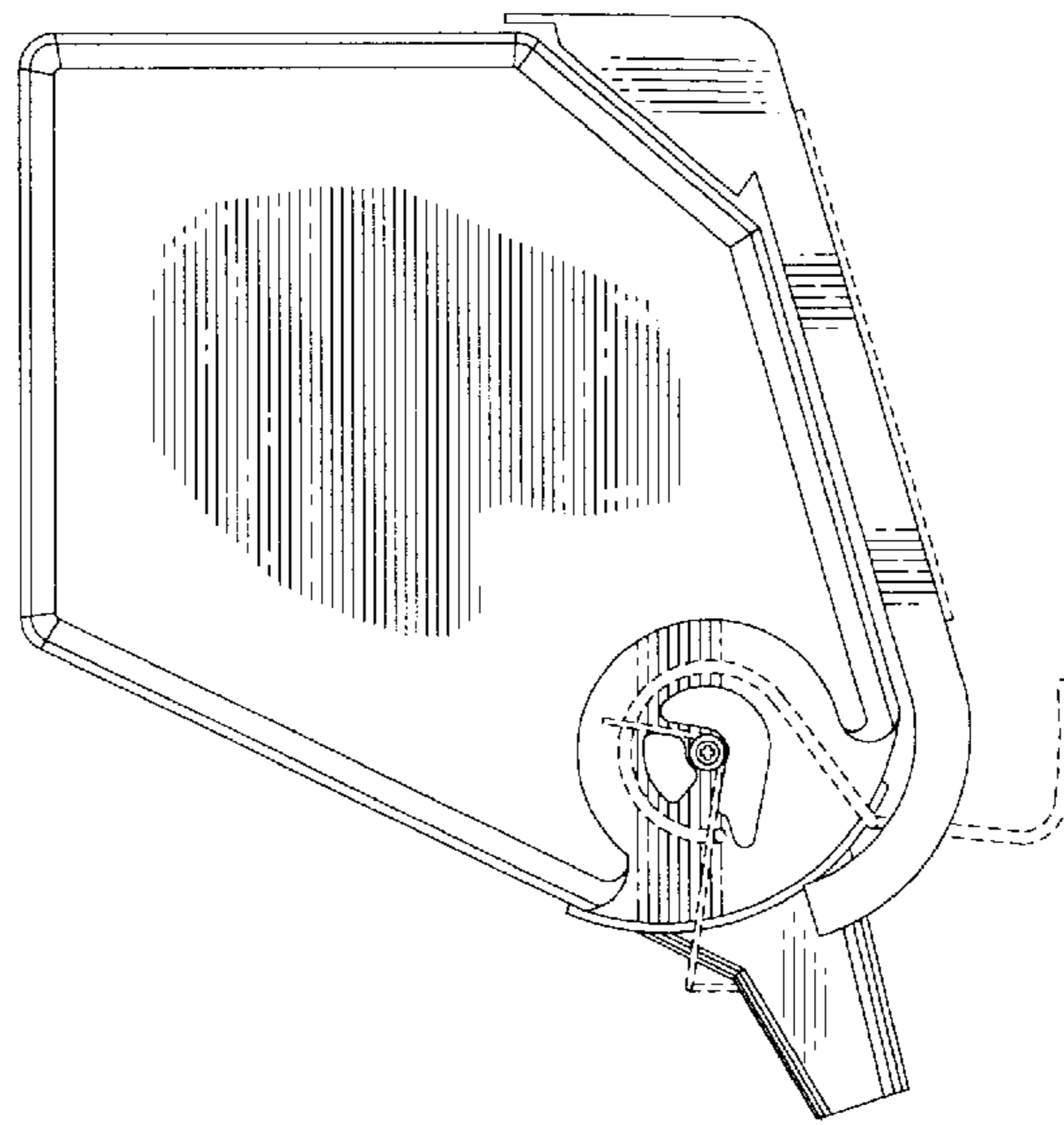

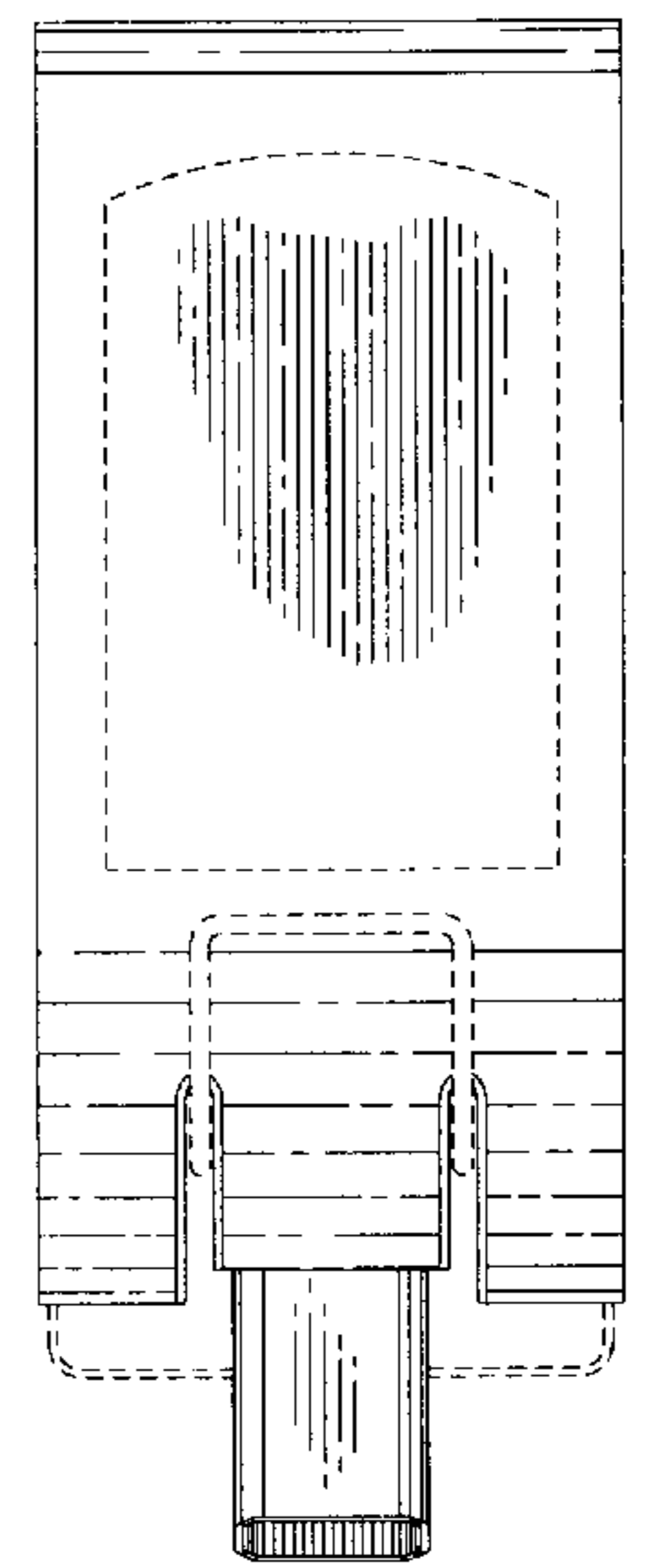

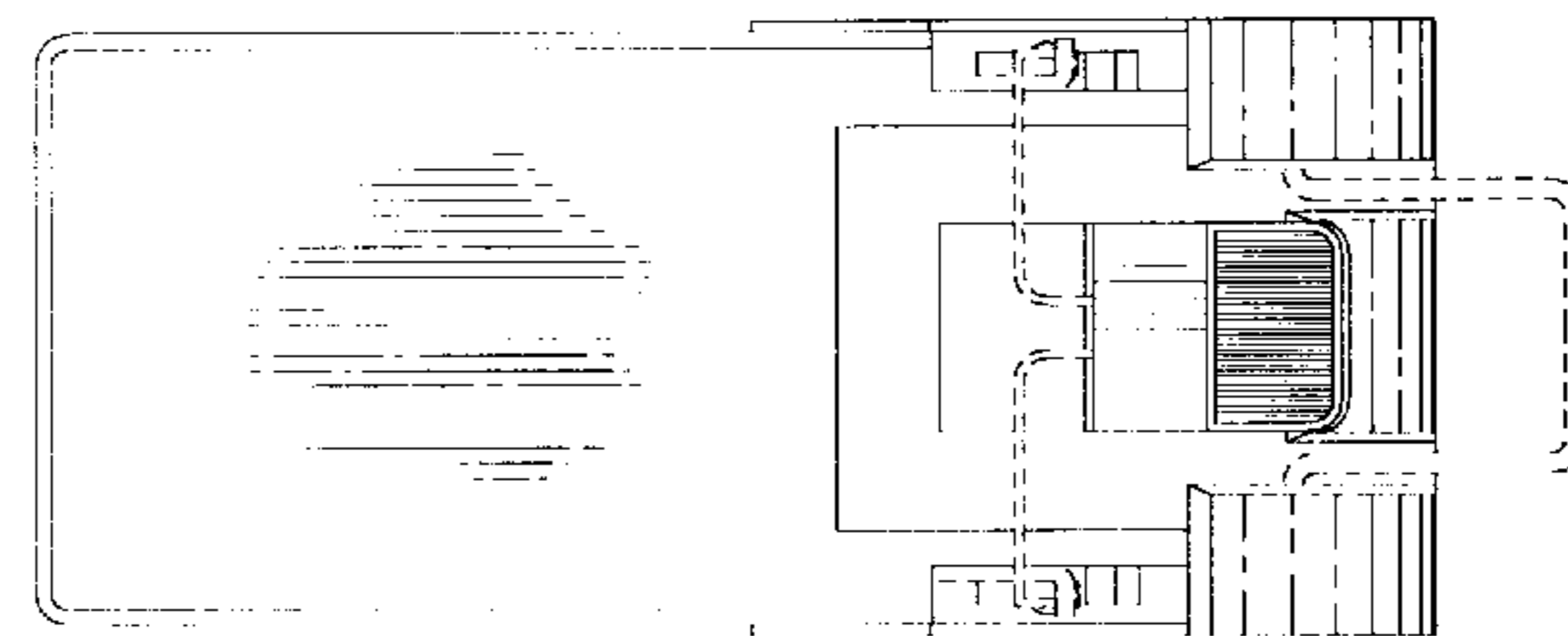

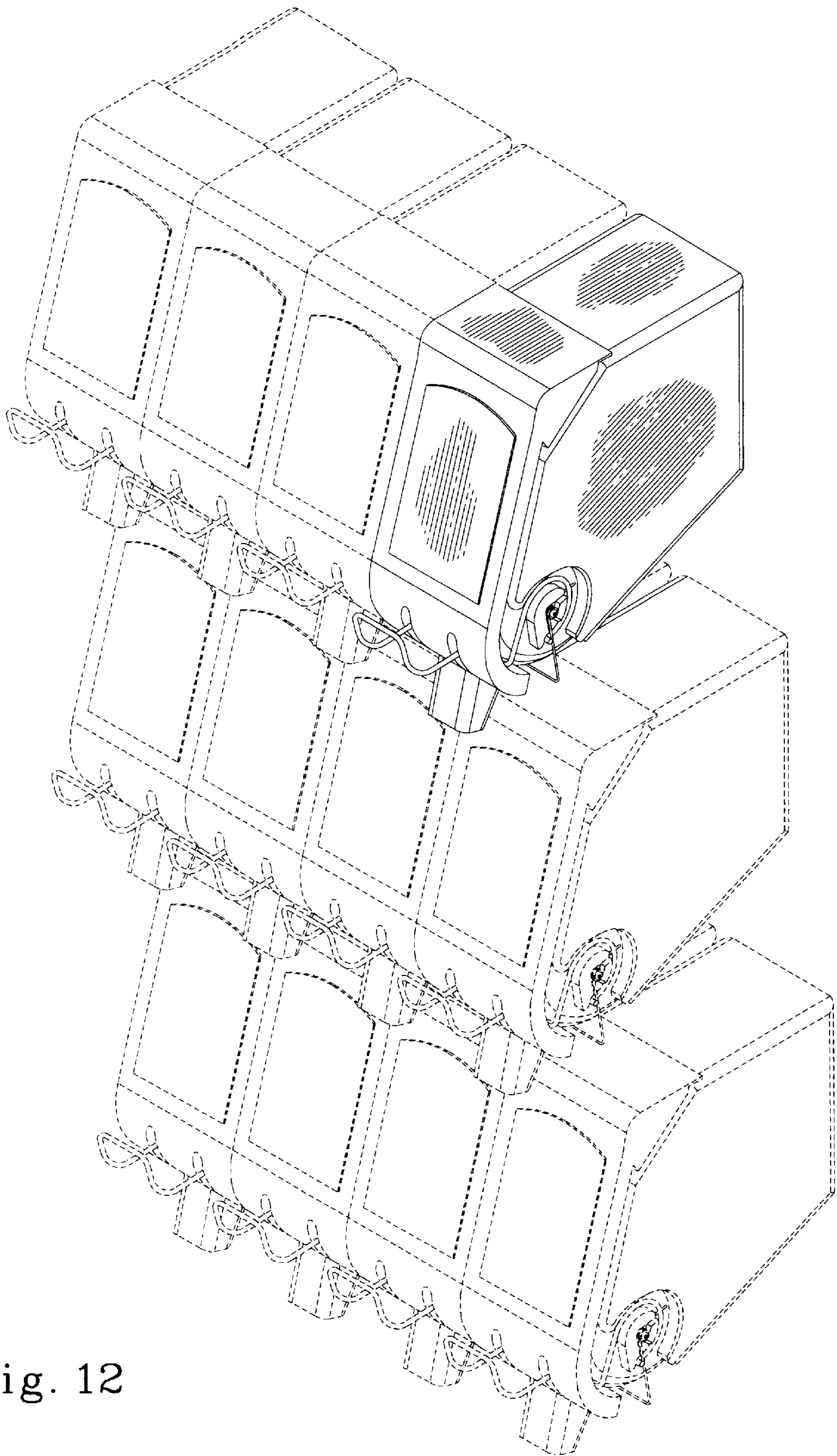

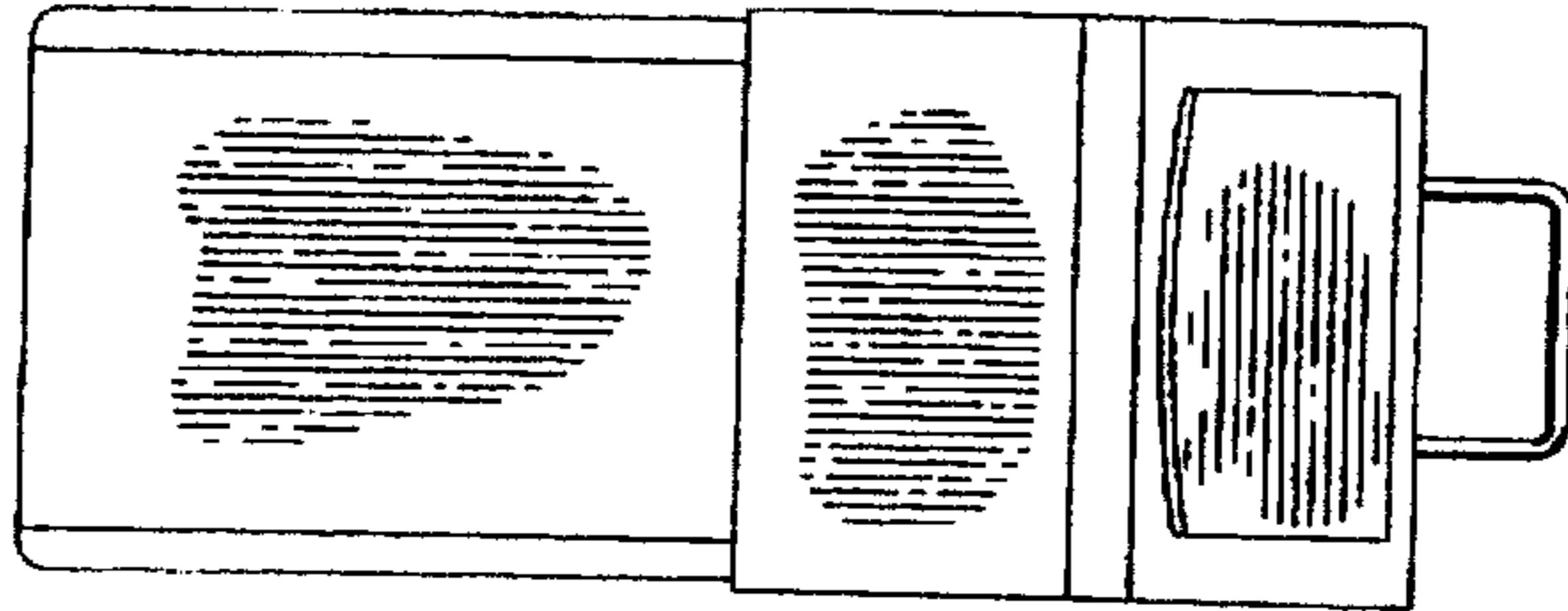

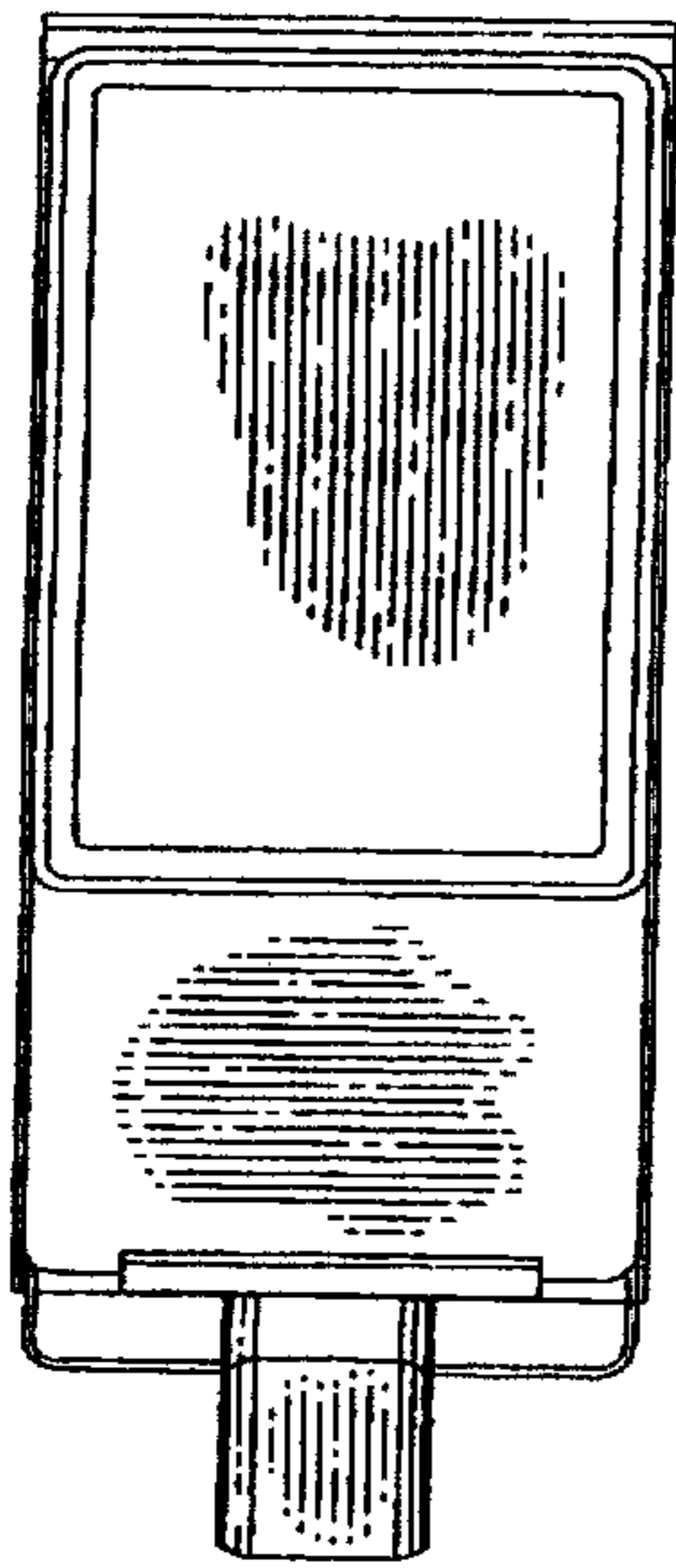

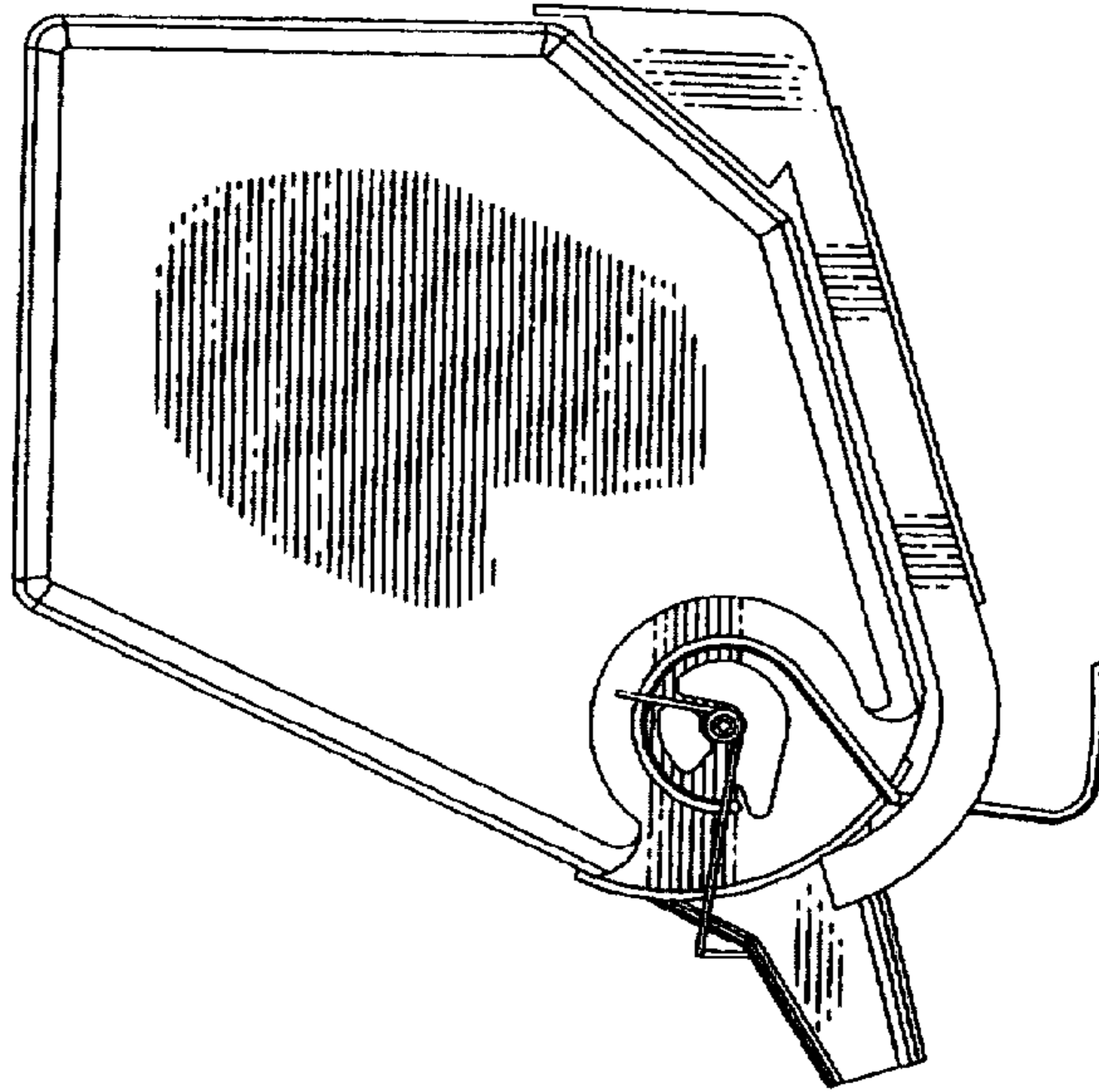

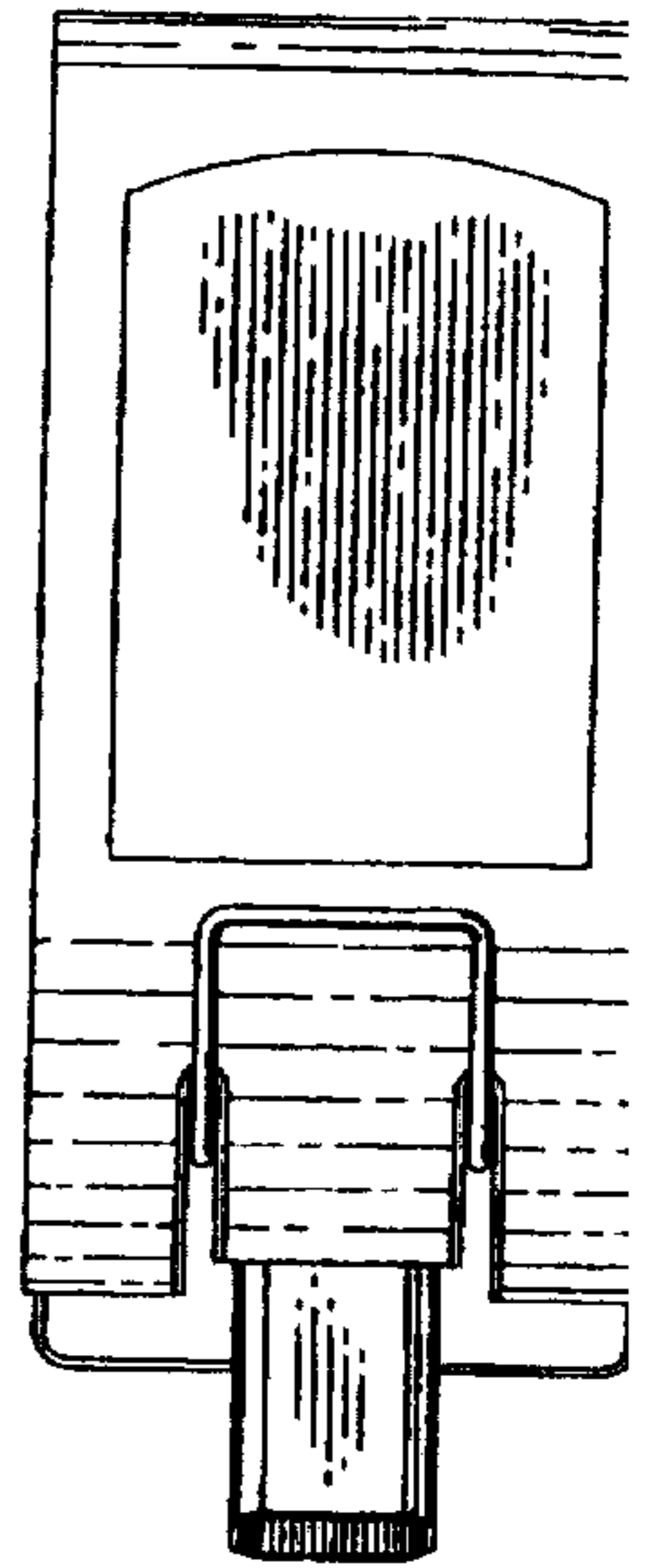

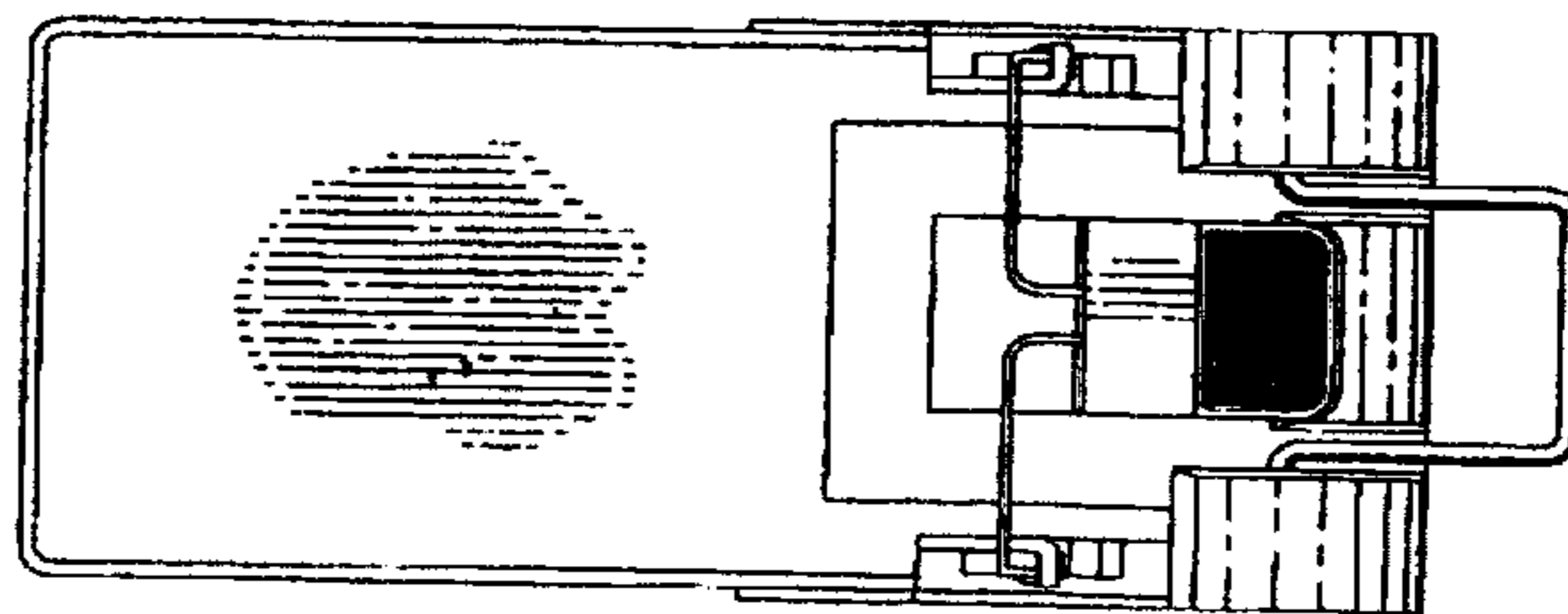

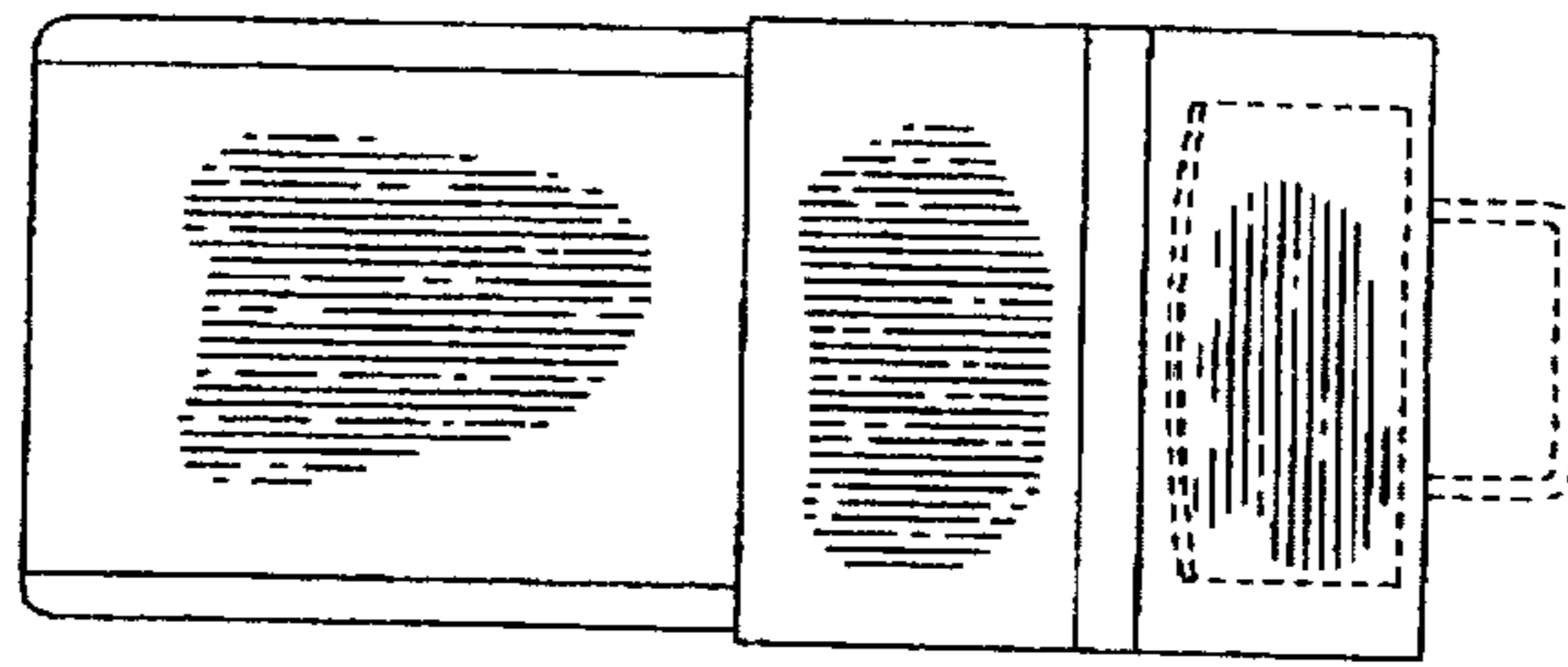

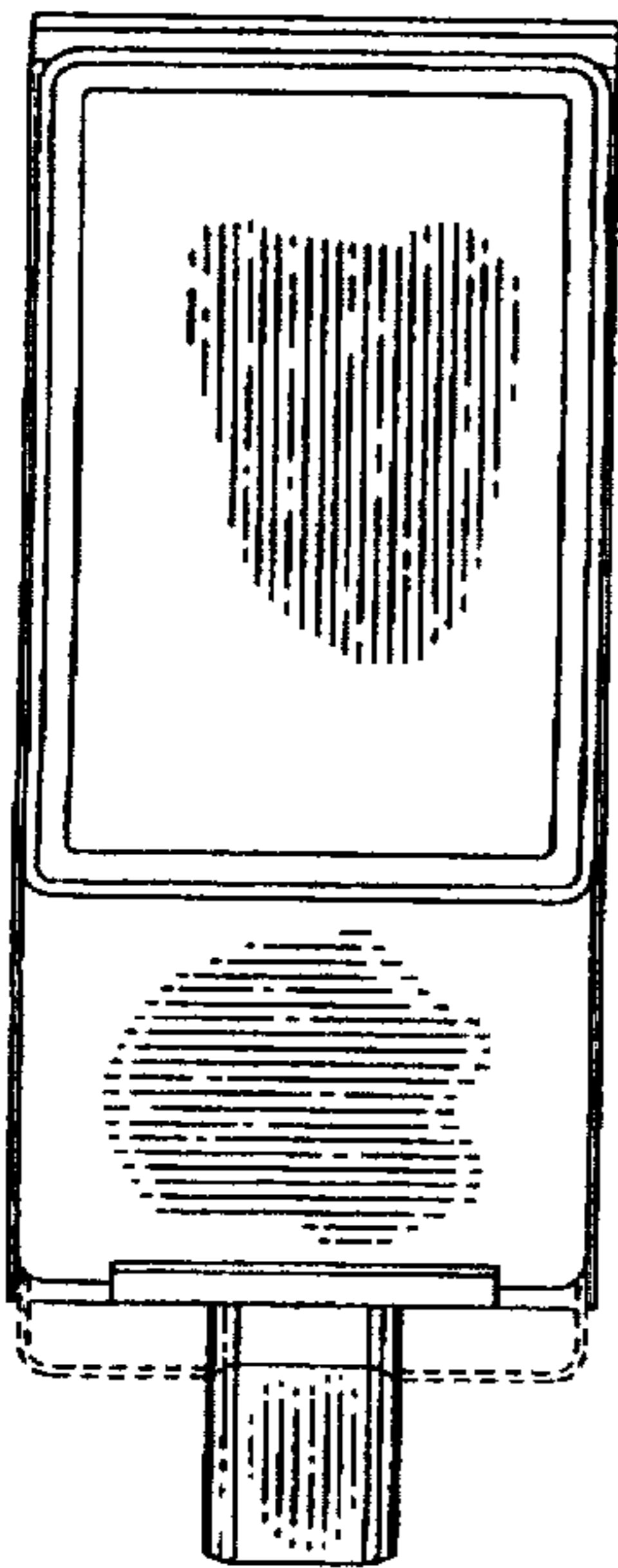

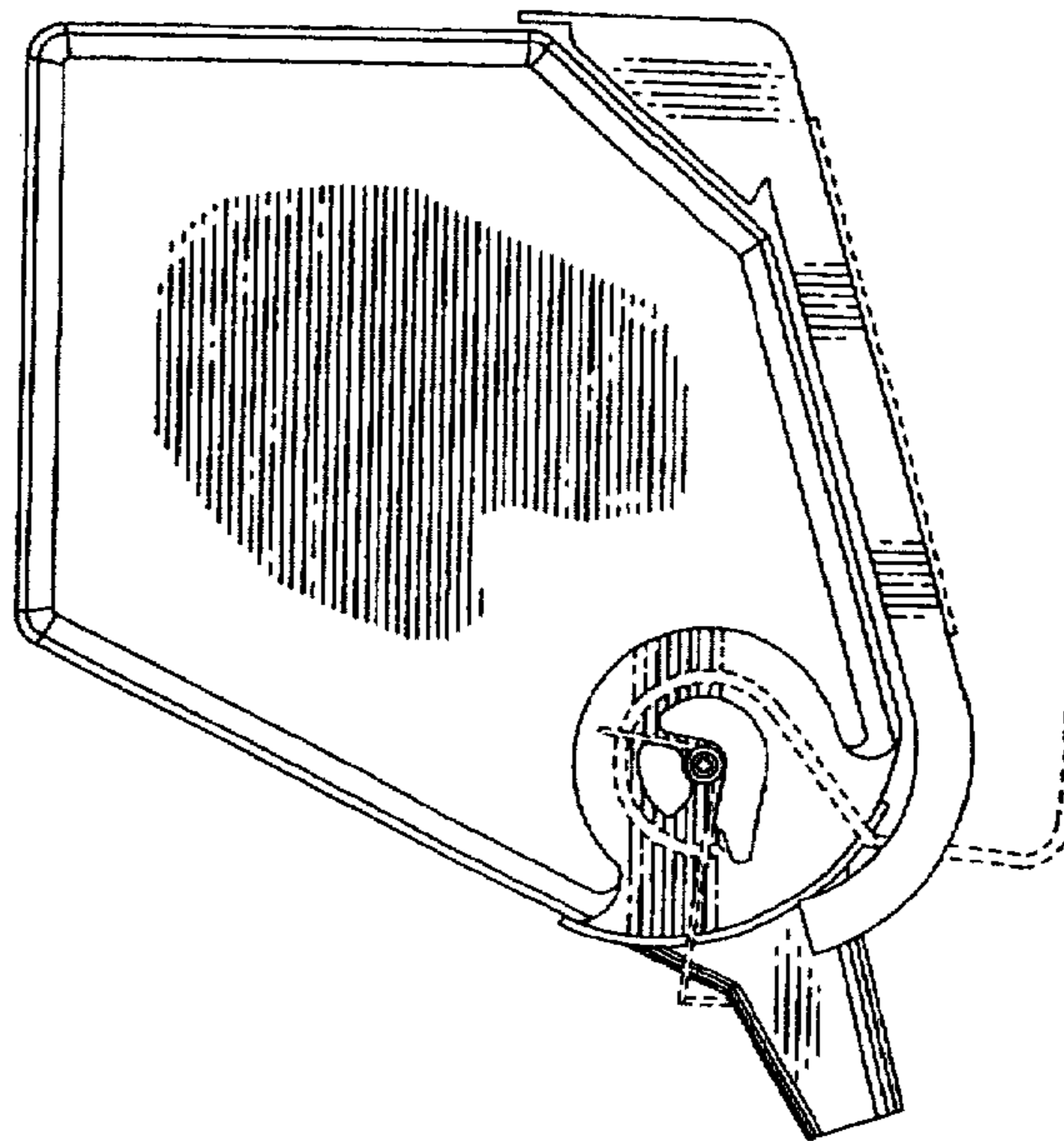

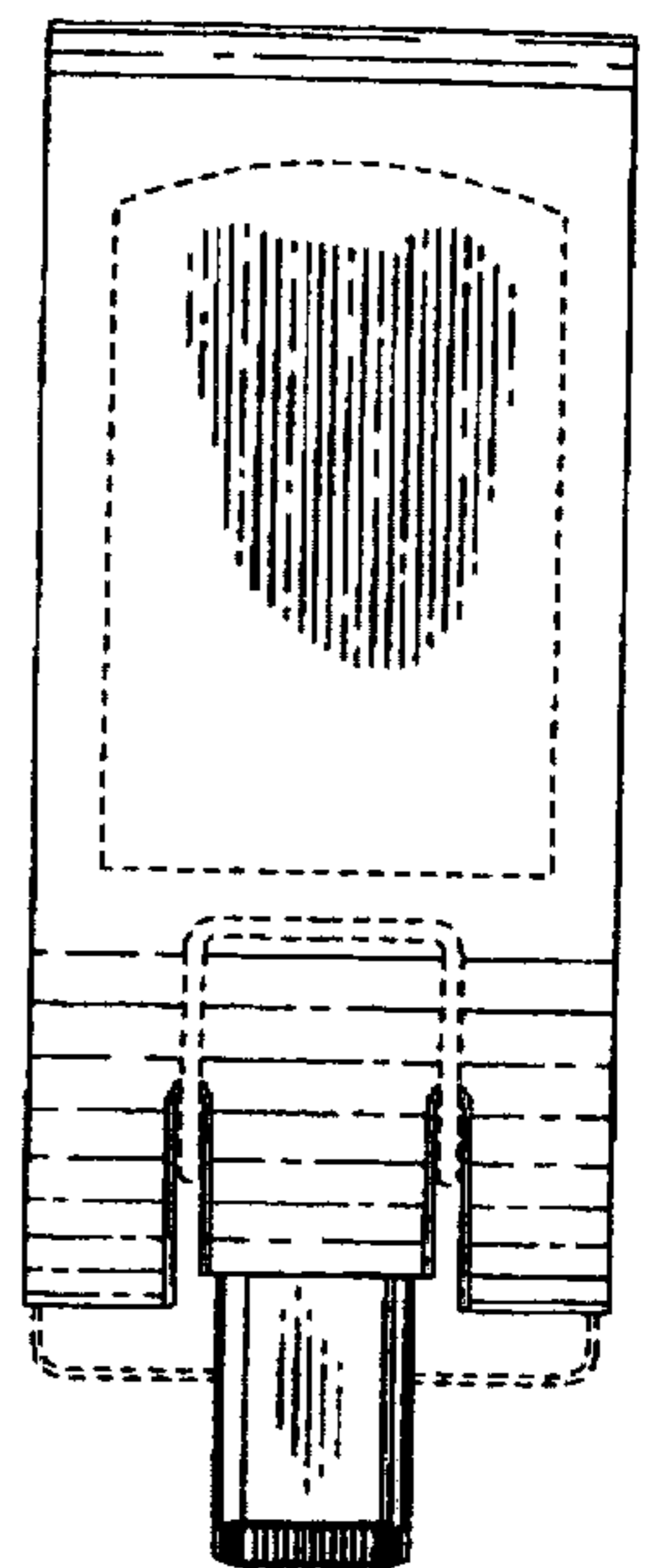

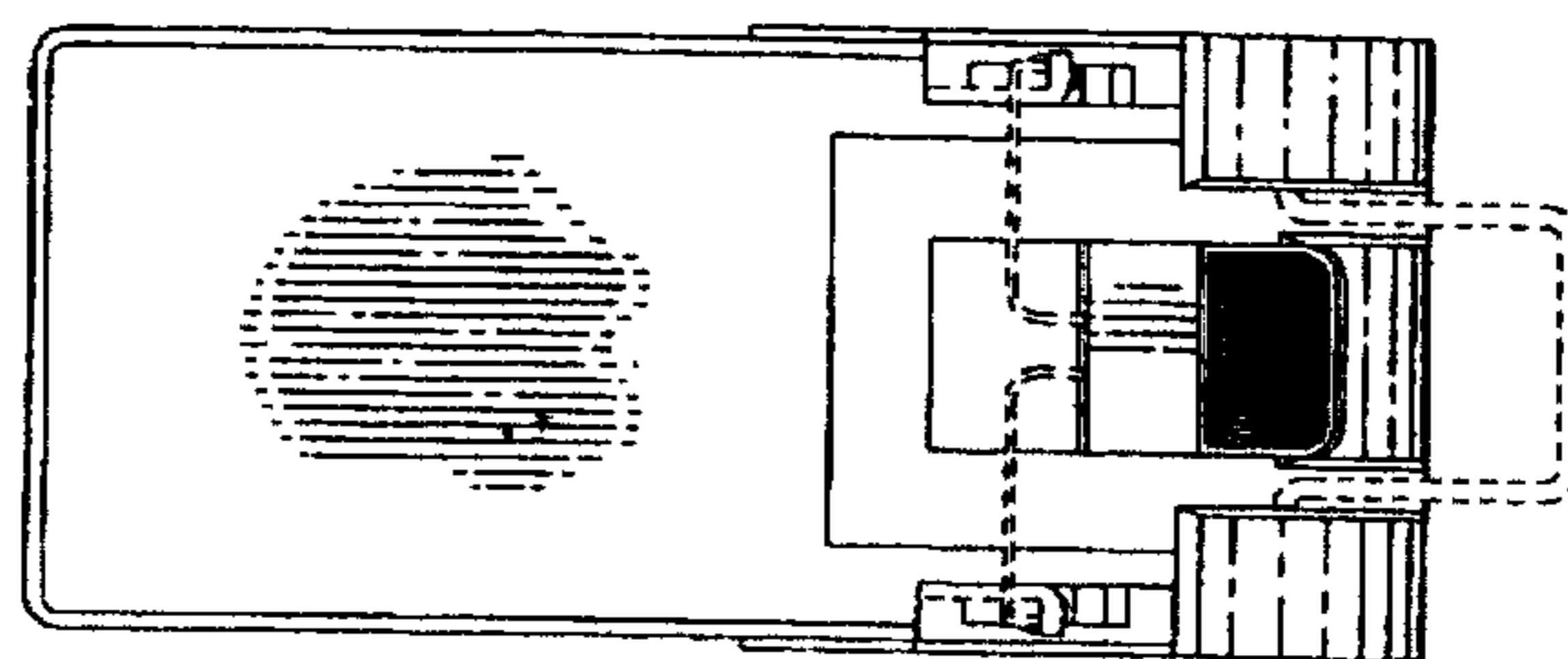
