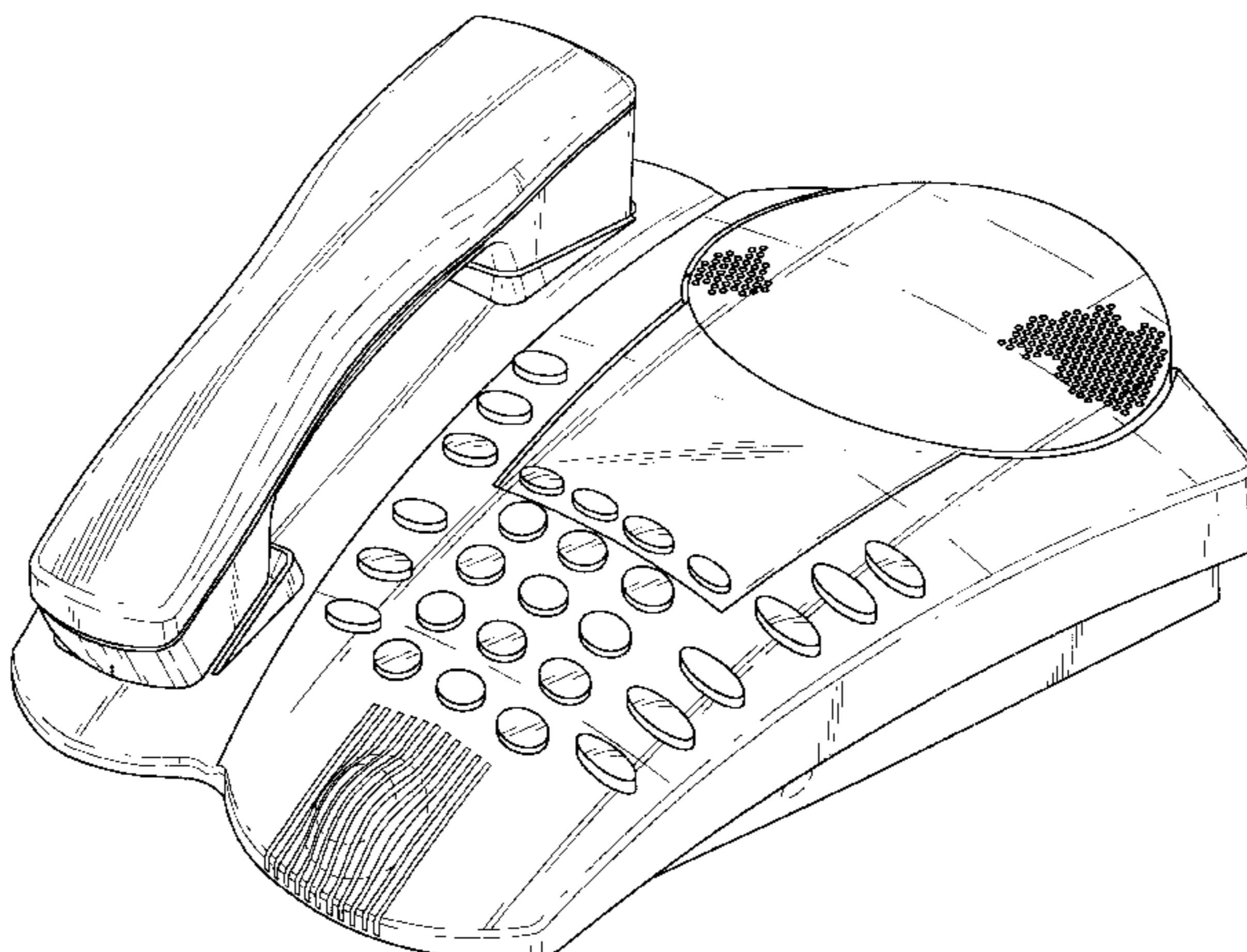
[57] **CLAIM**

The ornamental design for a speakerphone with handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the top, front and right side of a speakerphone;  
FIG. 2 is a top plan view of the speakerphone of FIG. 1;  
FIG. 3 is a front elevational view of the speakerphone of FIG. 1;  
FIG. 4 is a right side elevational view of the speakerphone of FIG. 1;  
FIG. 5 is a left side elevational view of the speakerphone of FIG. 1;  
FIG. 6 is a rear elevational view of the speakerphone of FIG. 1; and,  
FIG. 7 is a bottom plan view of the speakerphone of FIG. 1. The broken line showings throughout the views are for illustrative purposes only and form no part of the claimed design.

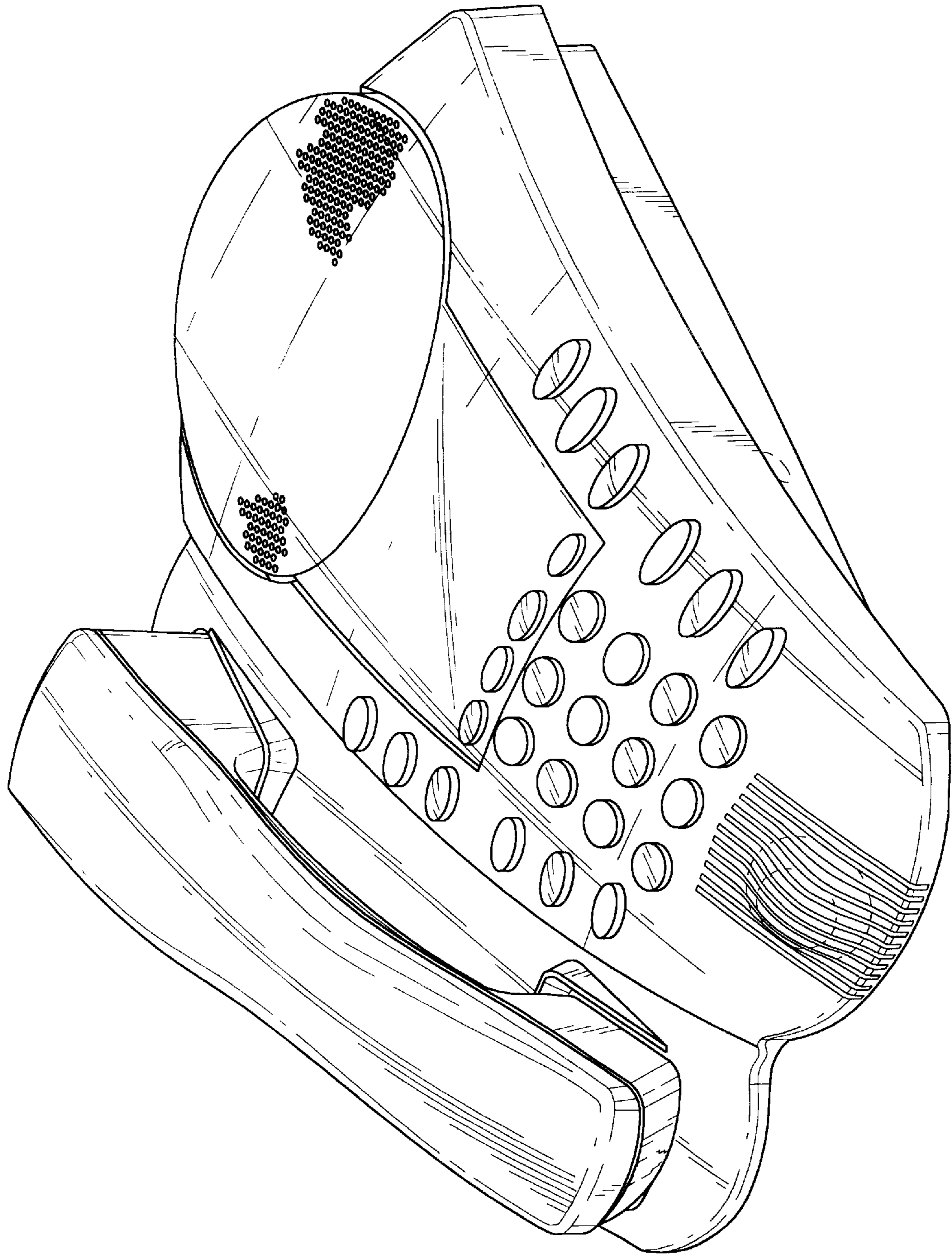

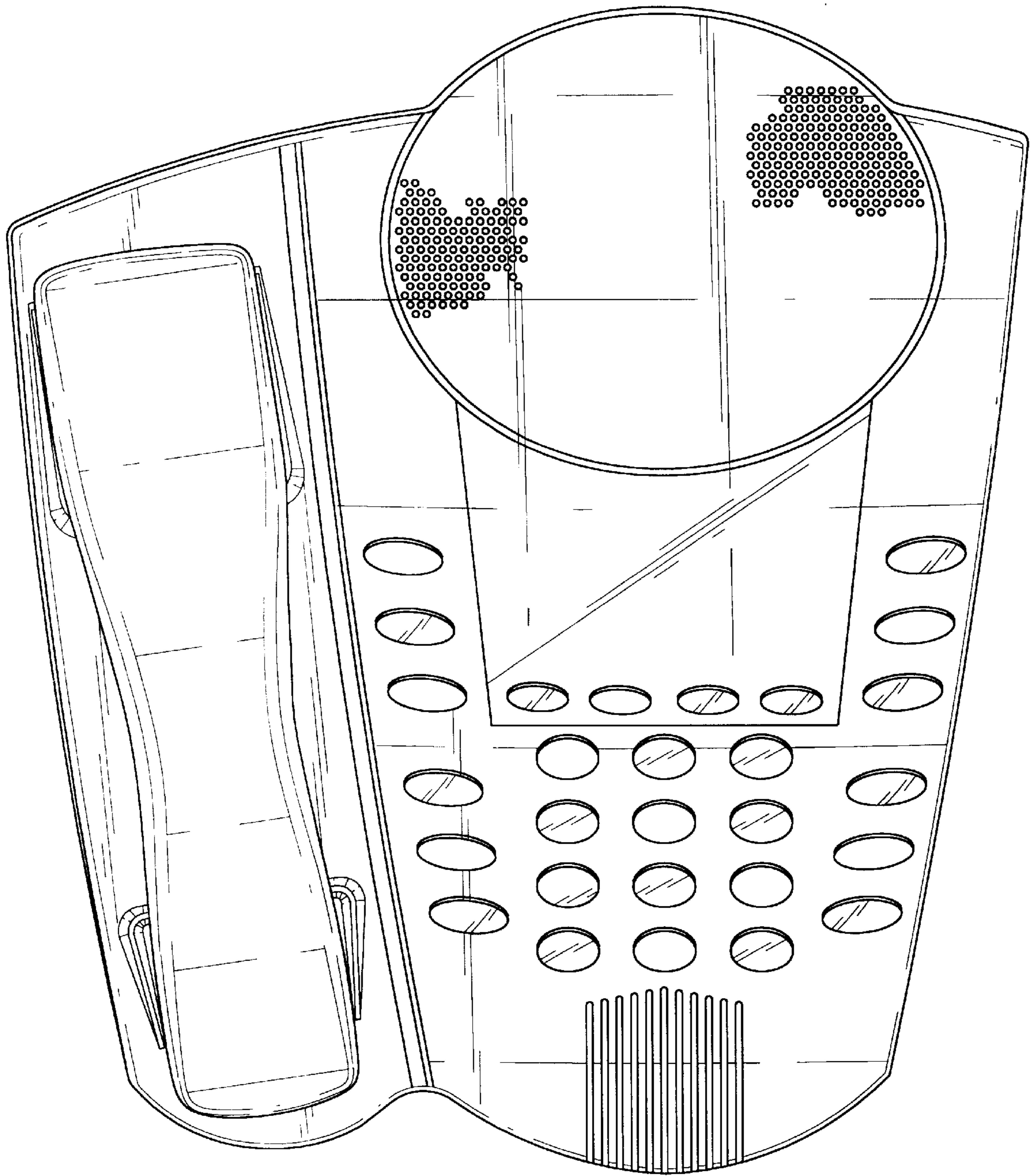

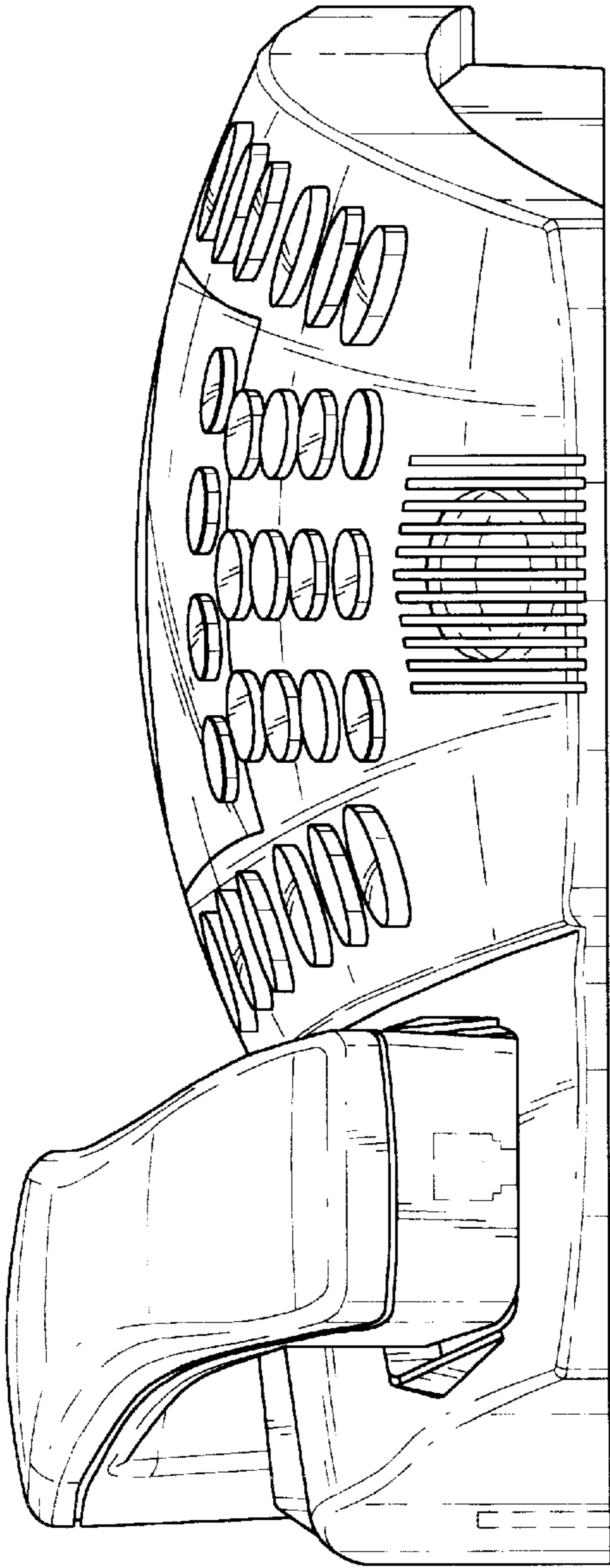

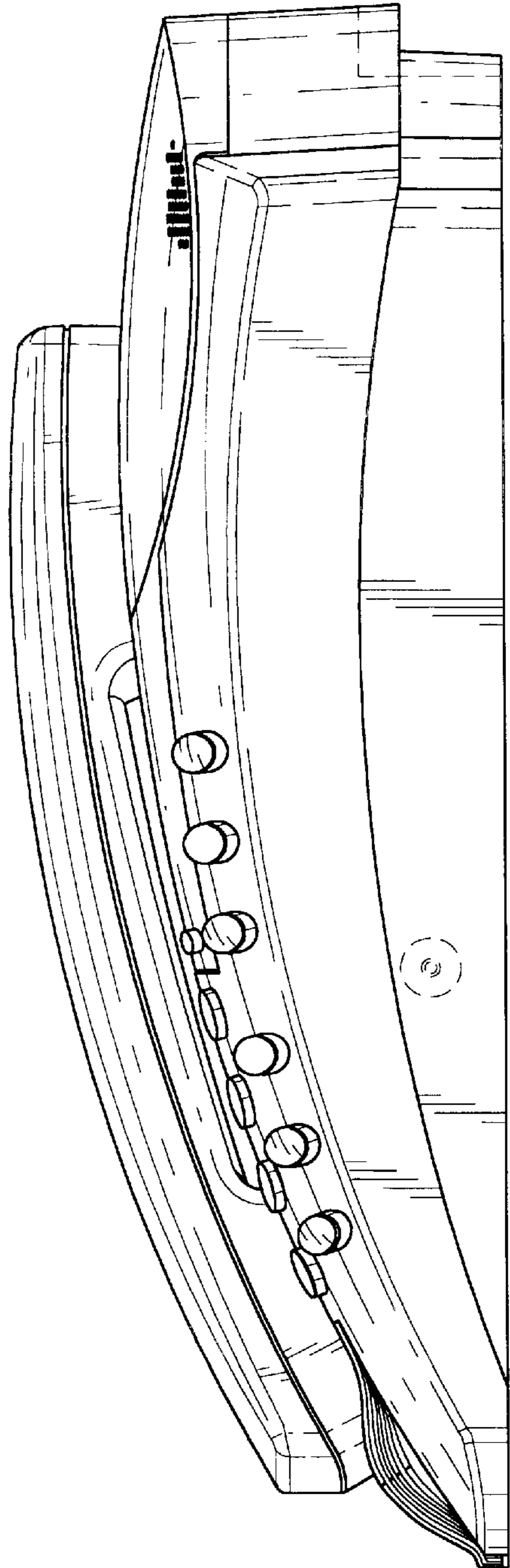

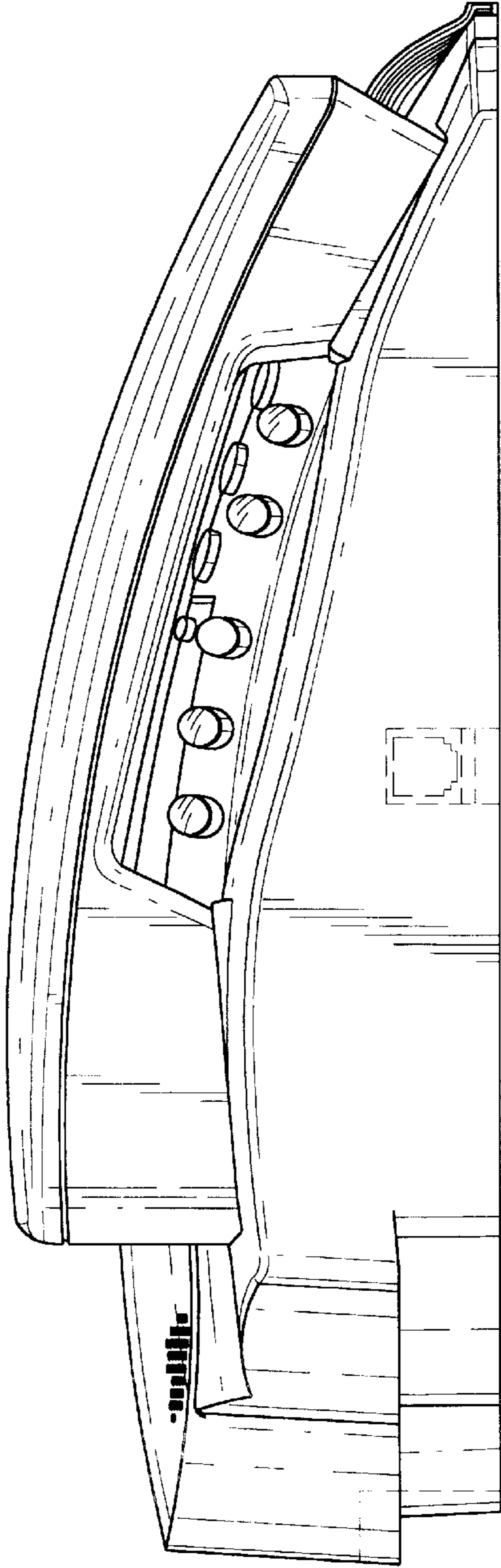

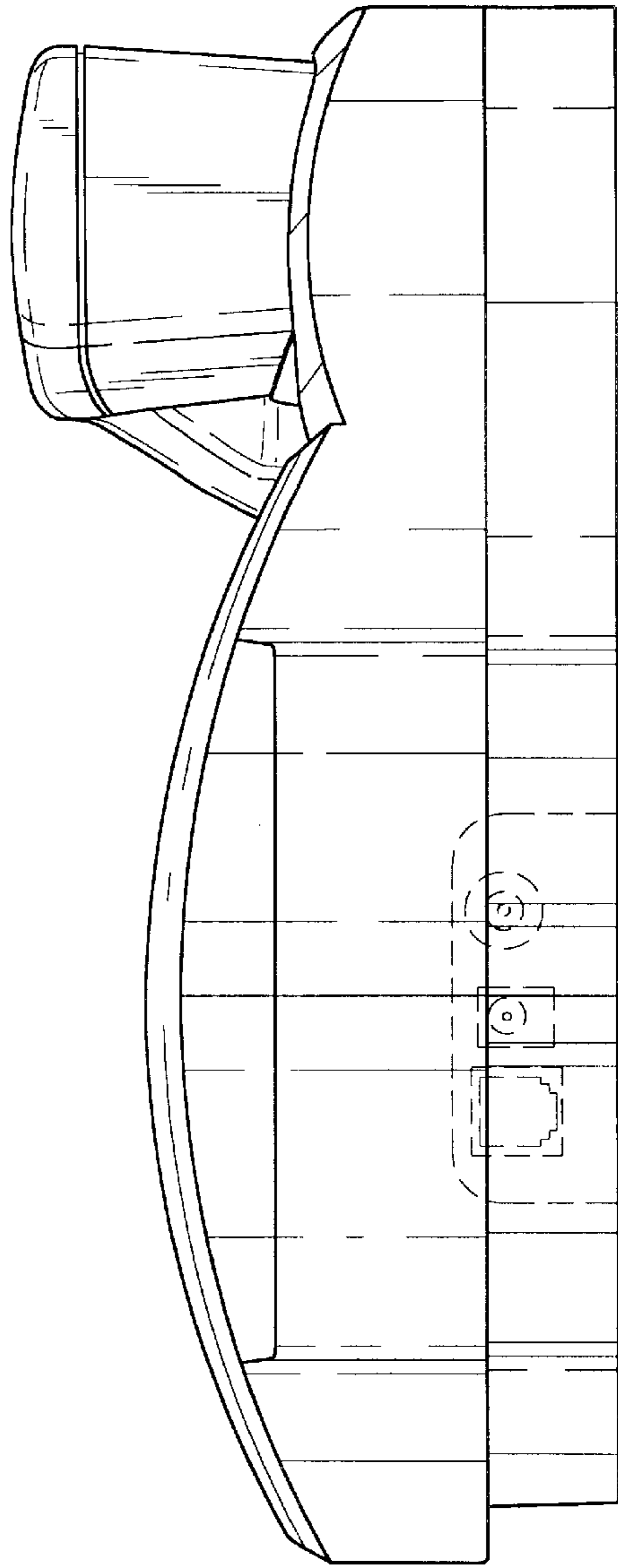
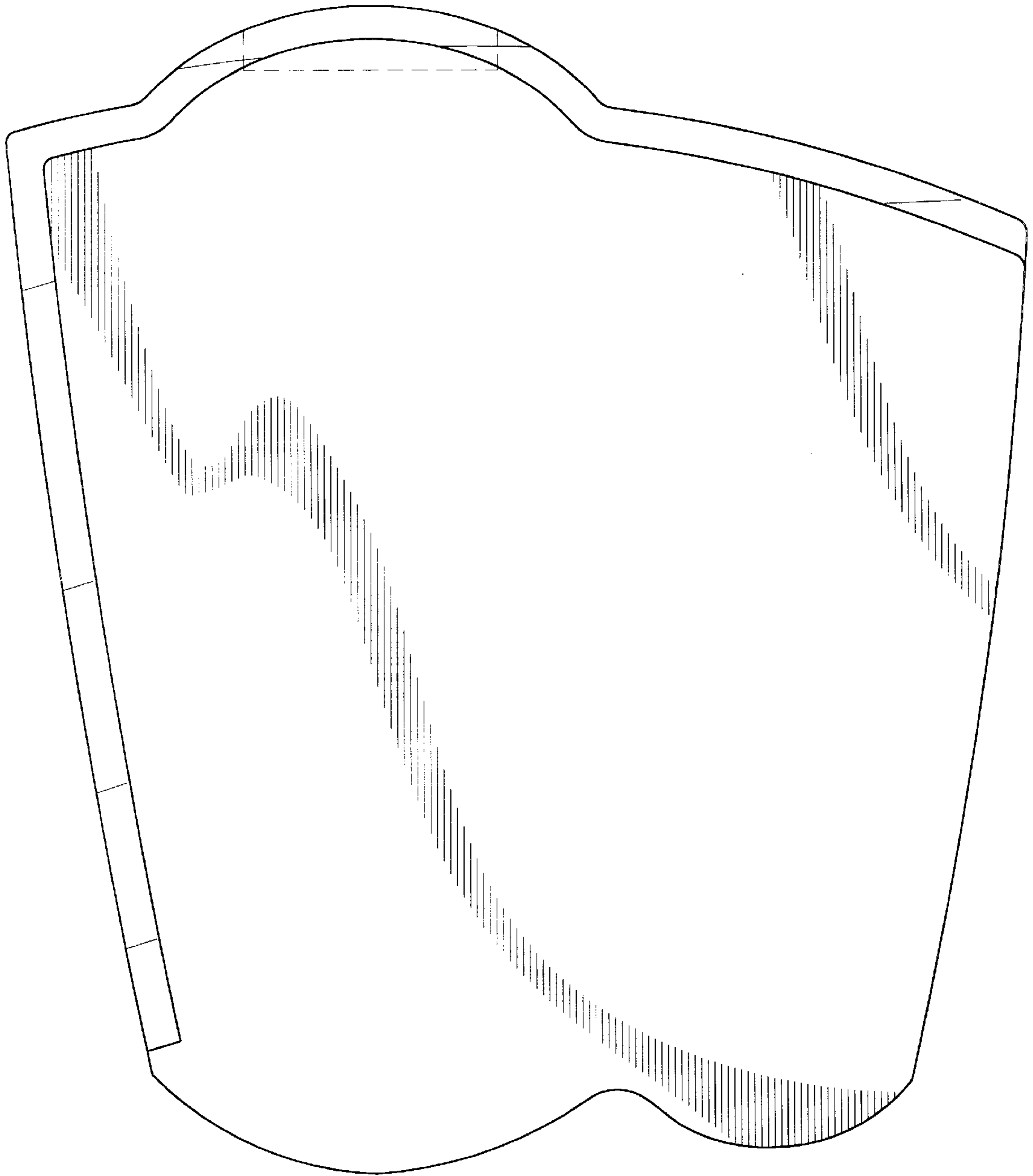
