**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view showing one embodiment of my new design for a video game machine;

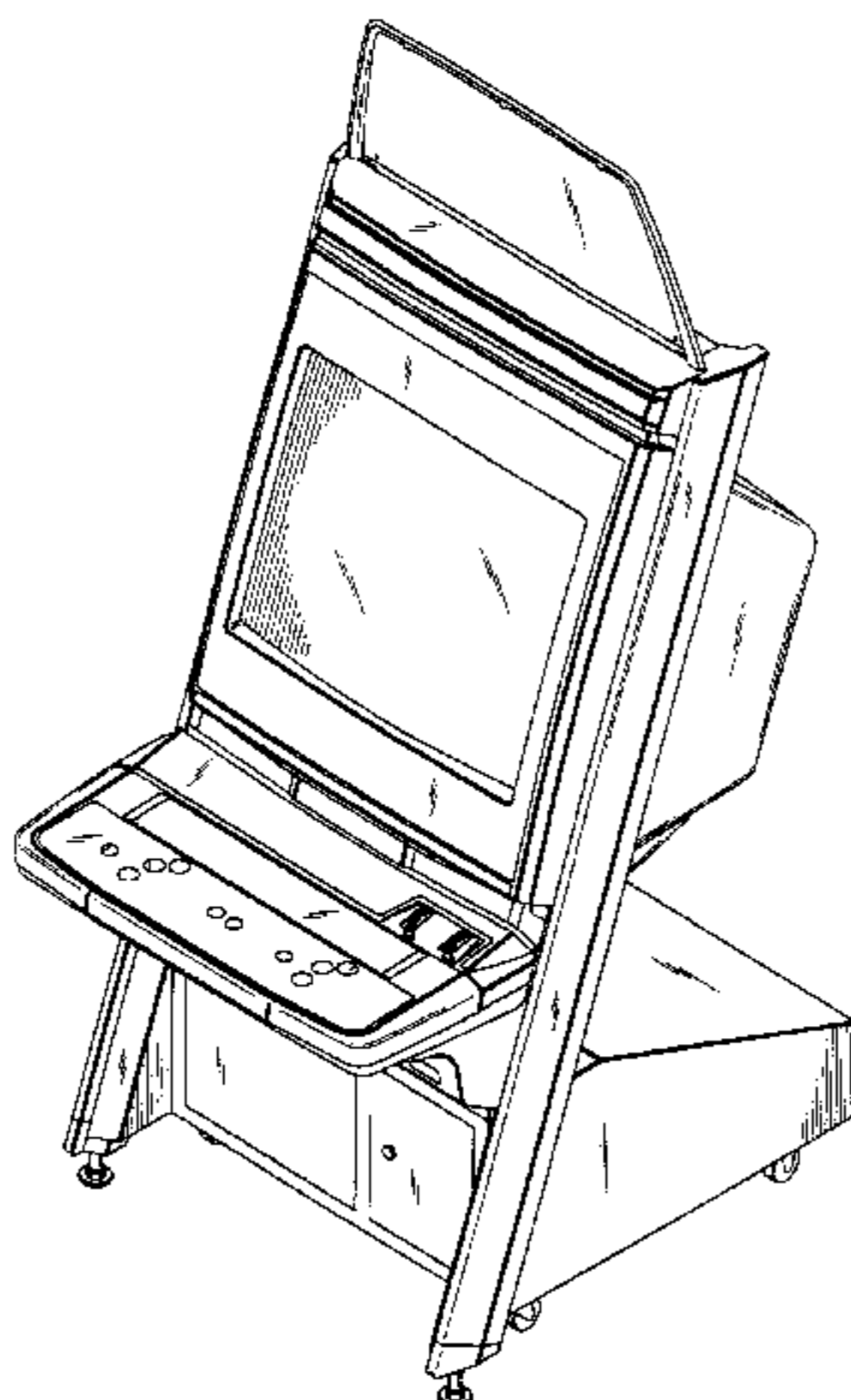

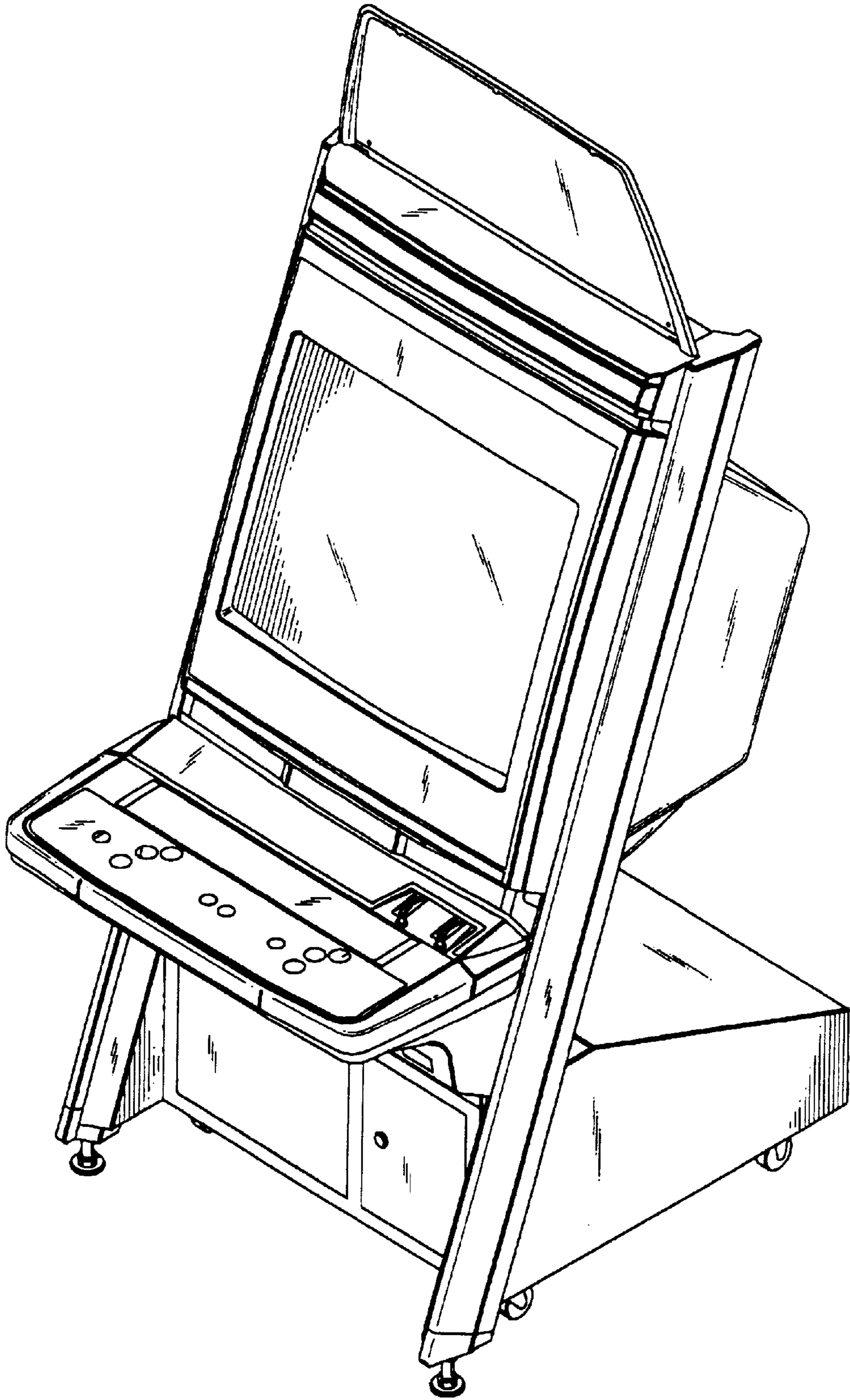

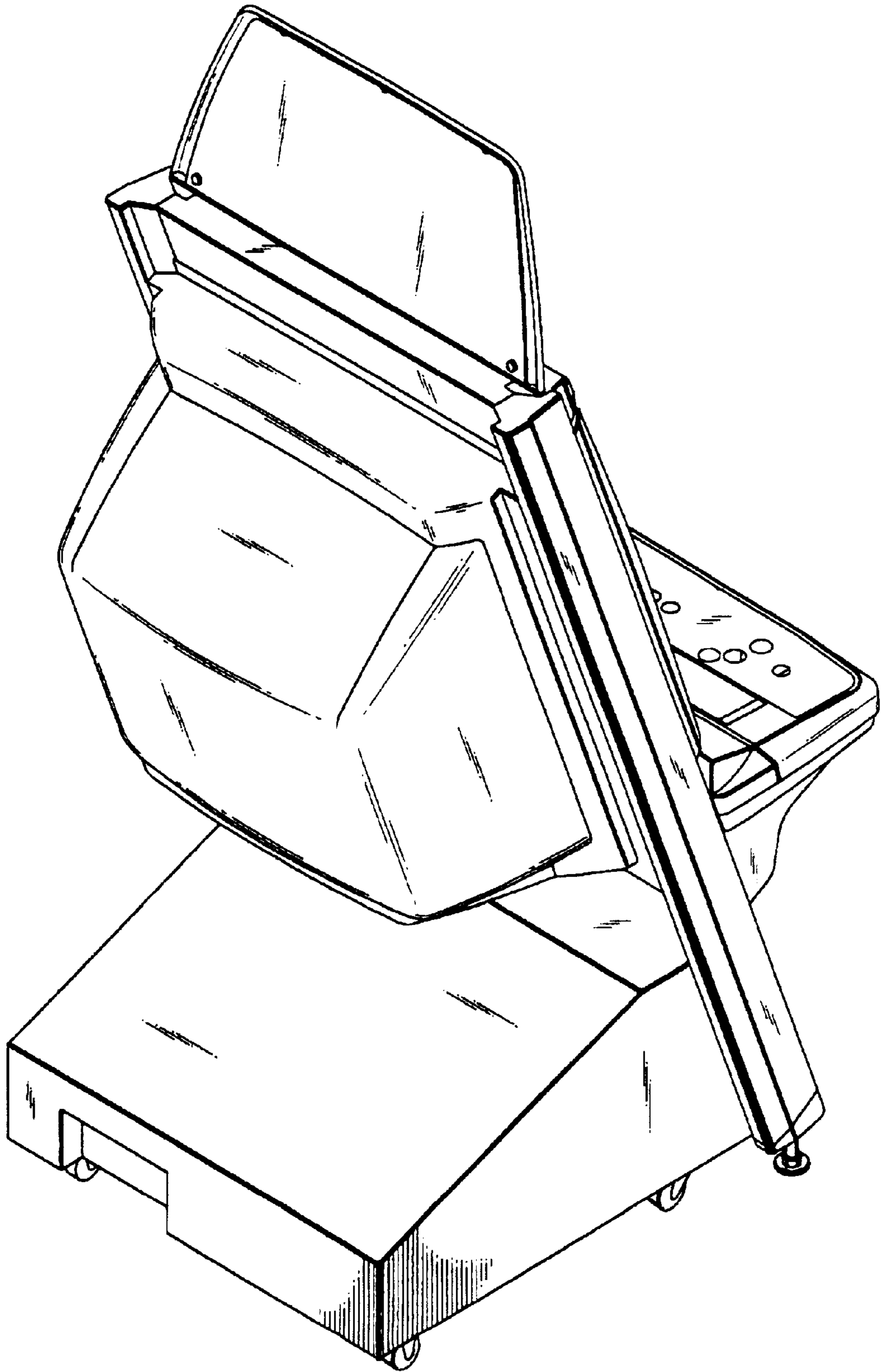

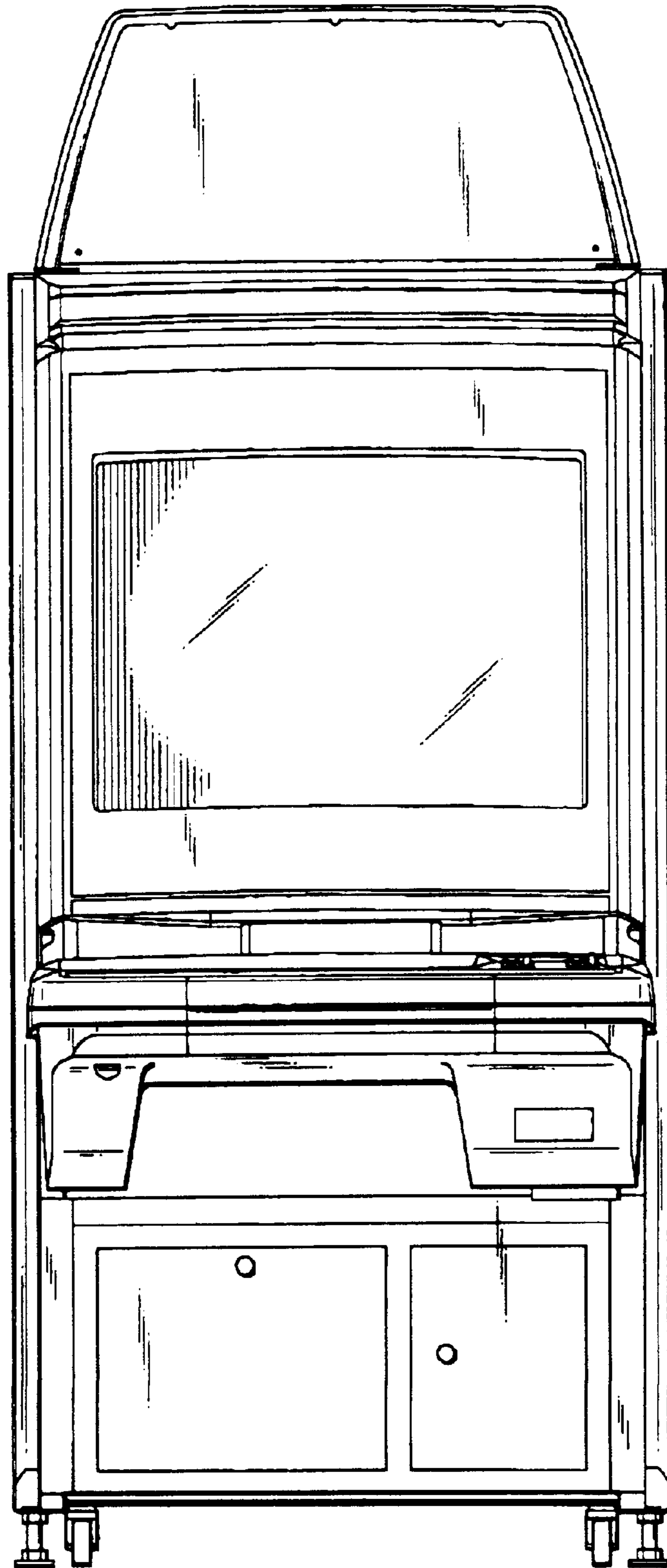

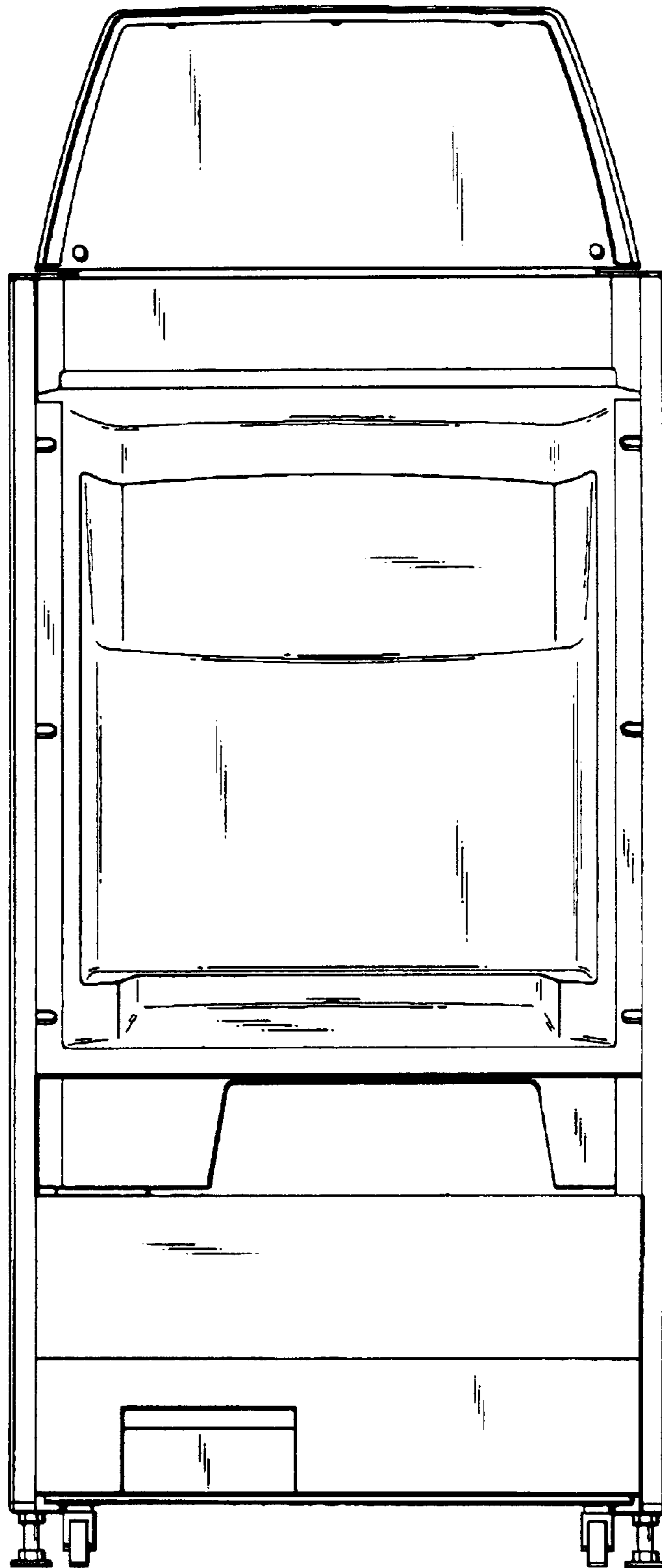

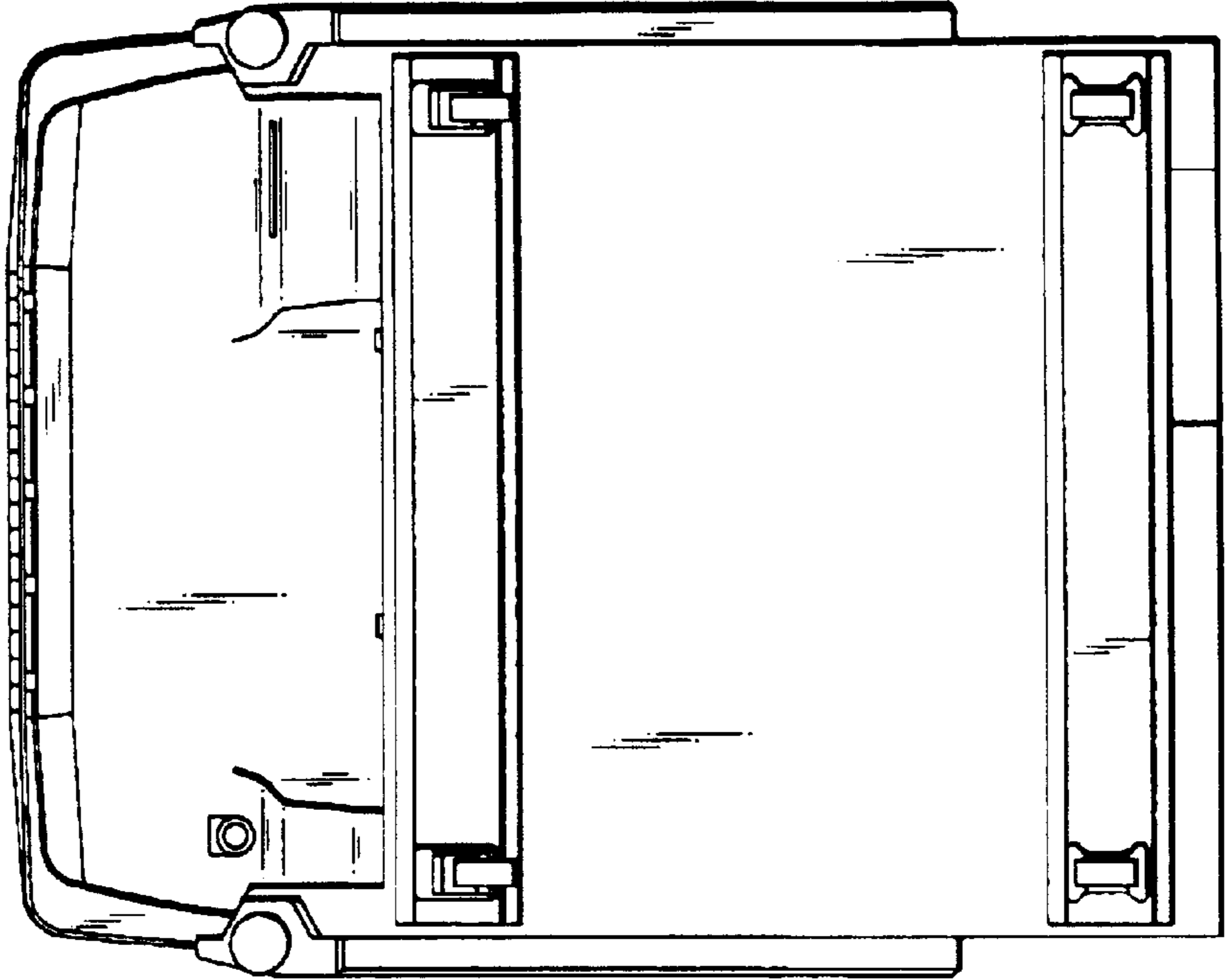

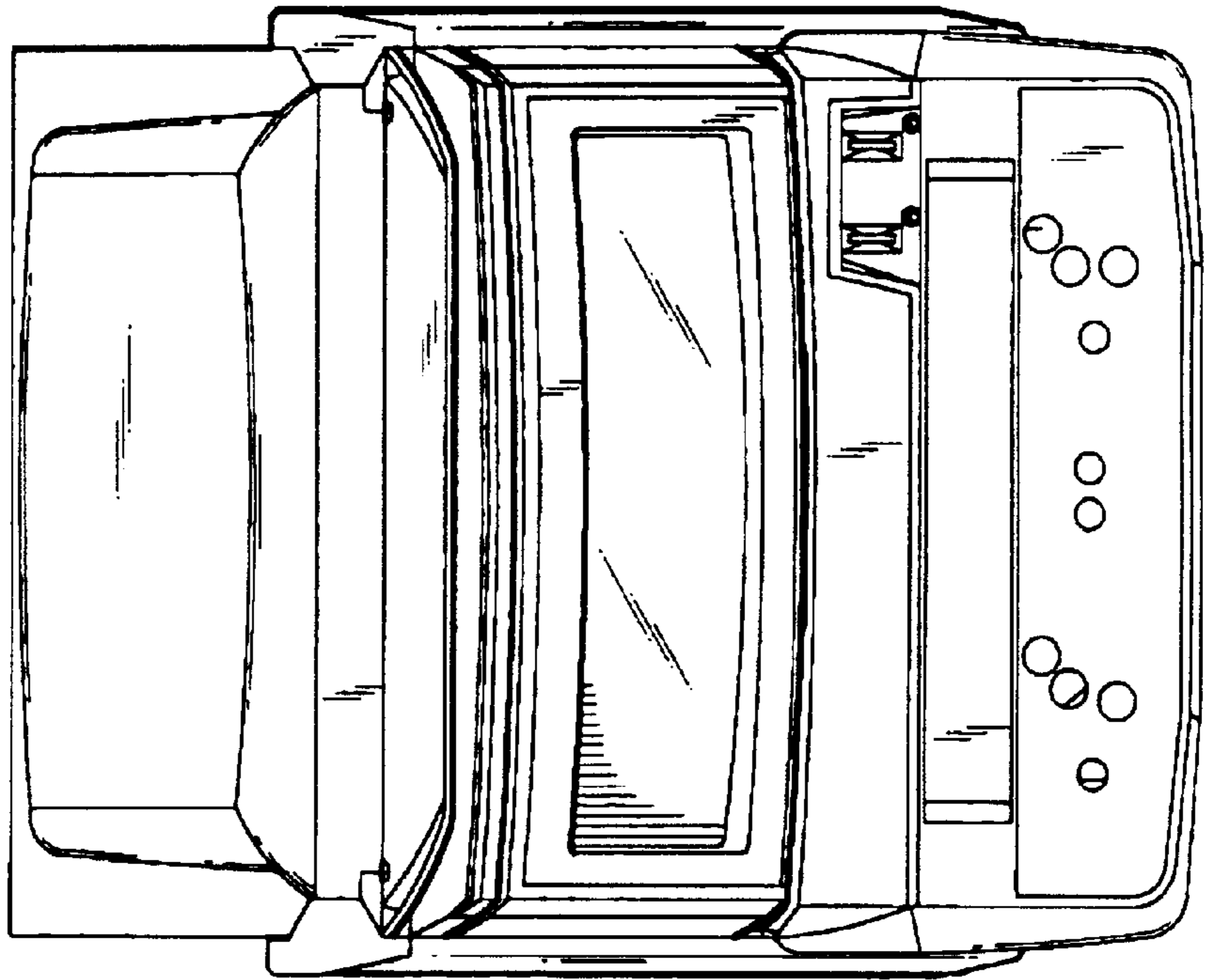

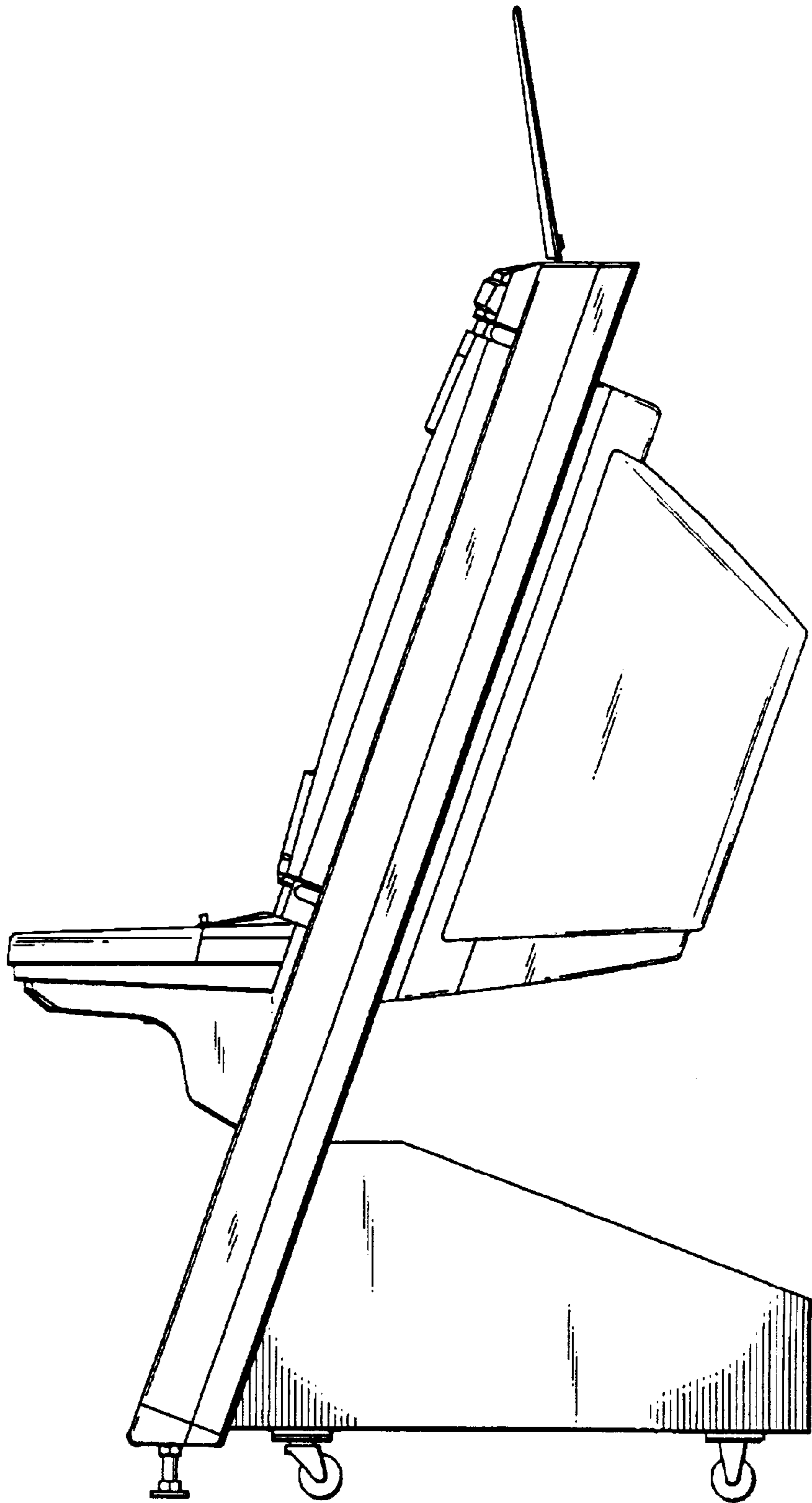

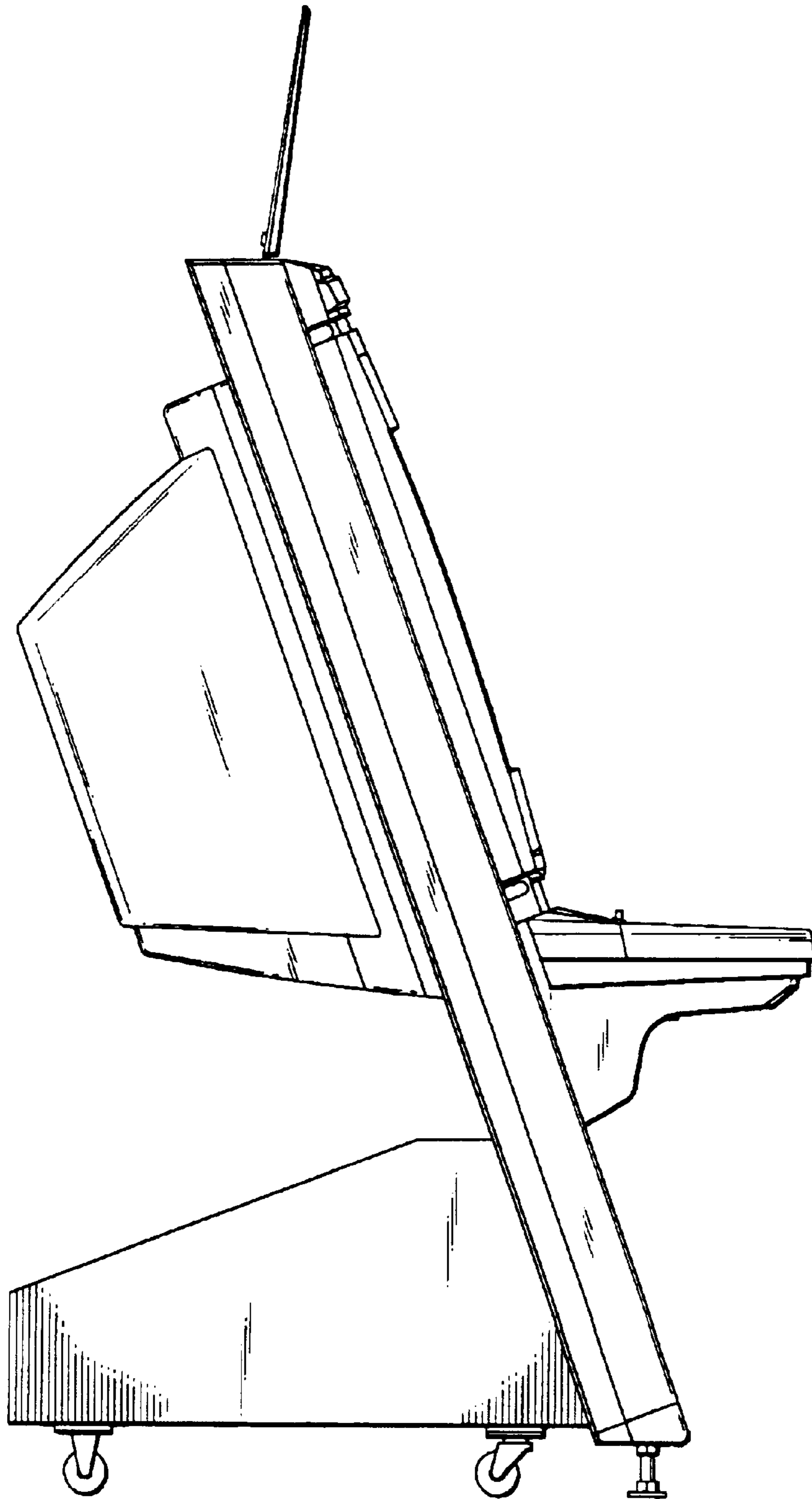

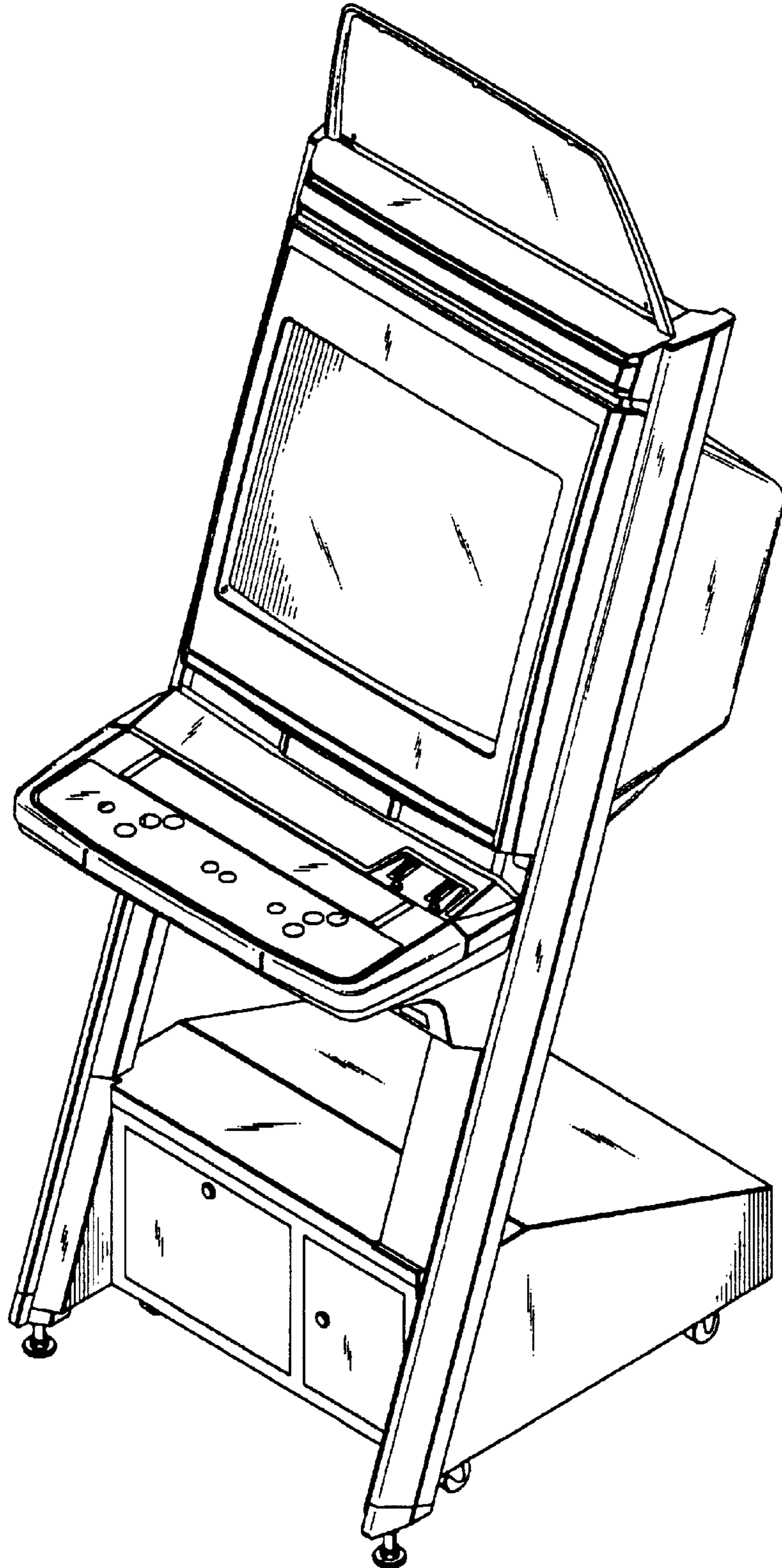

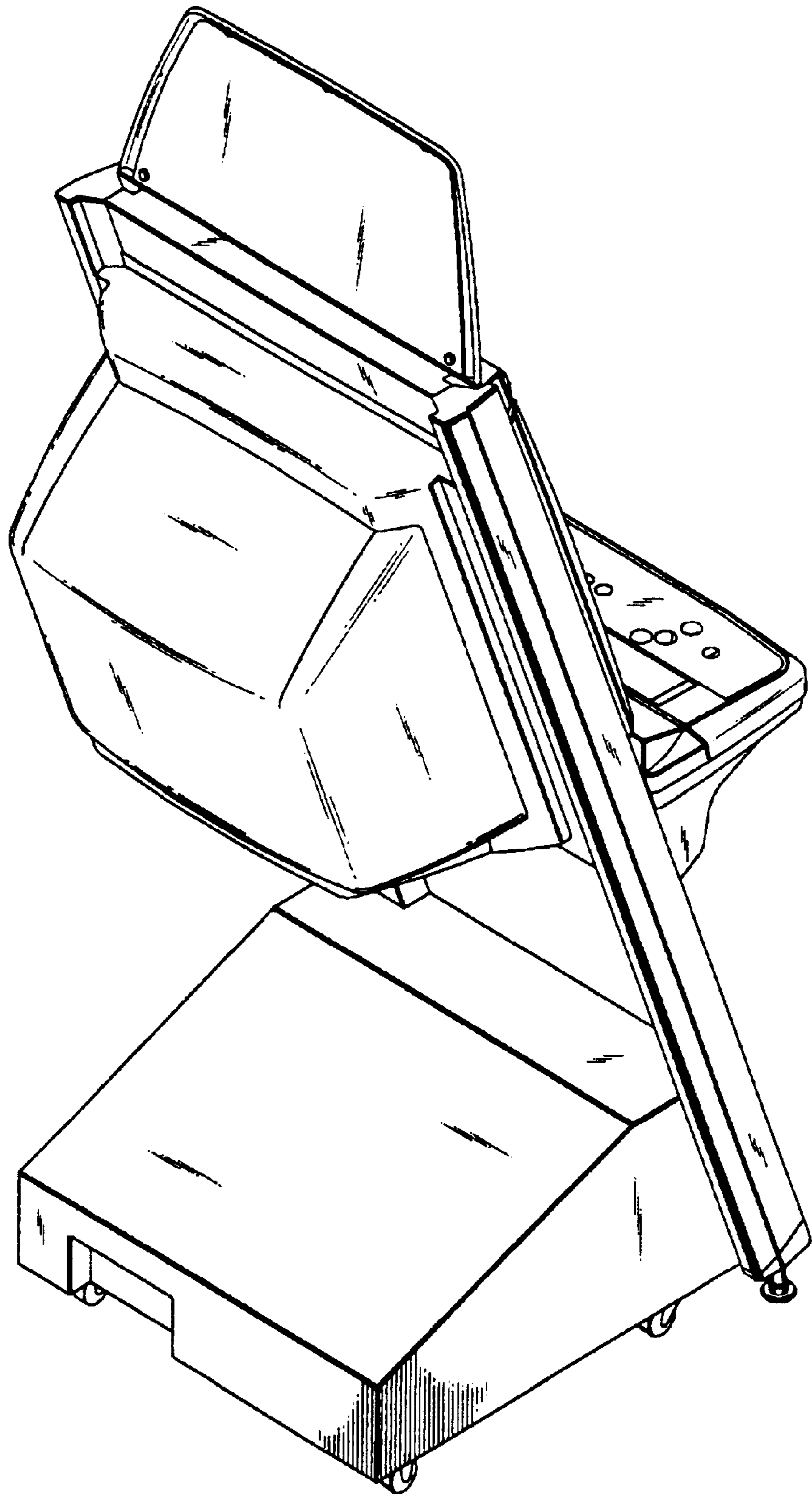

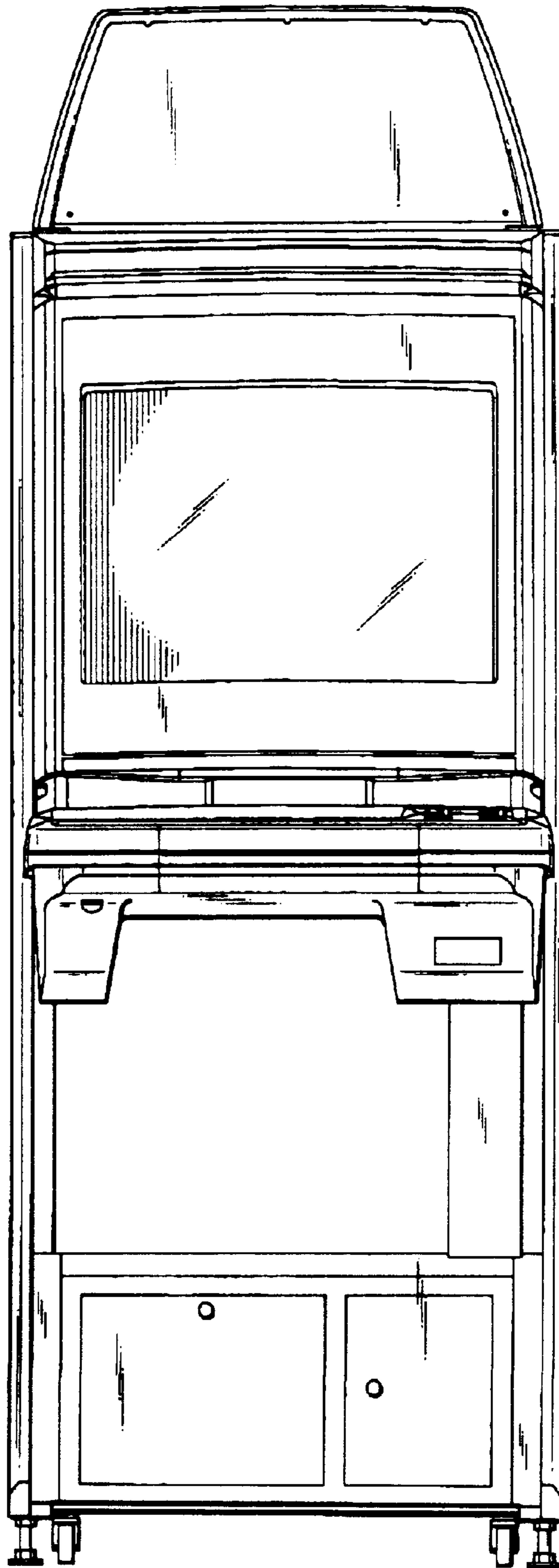

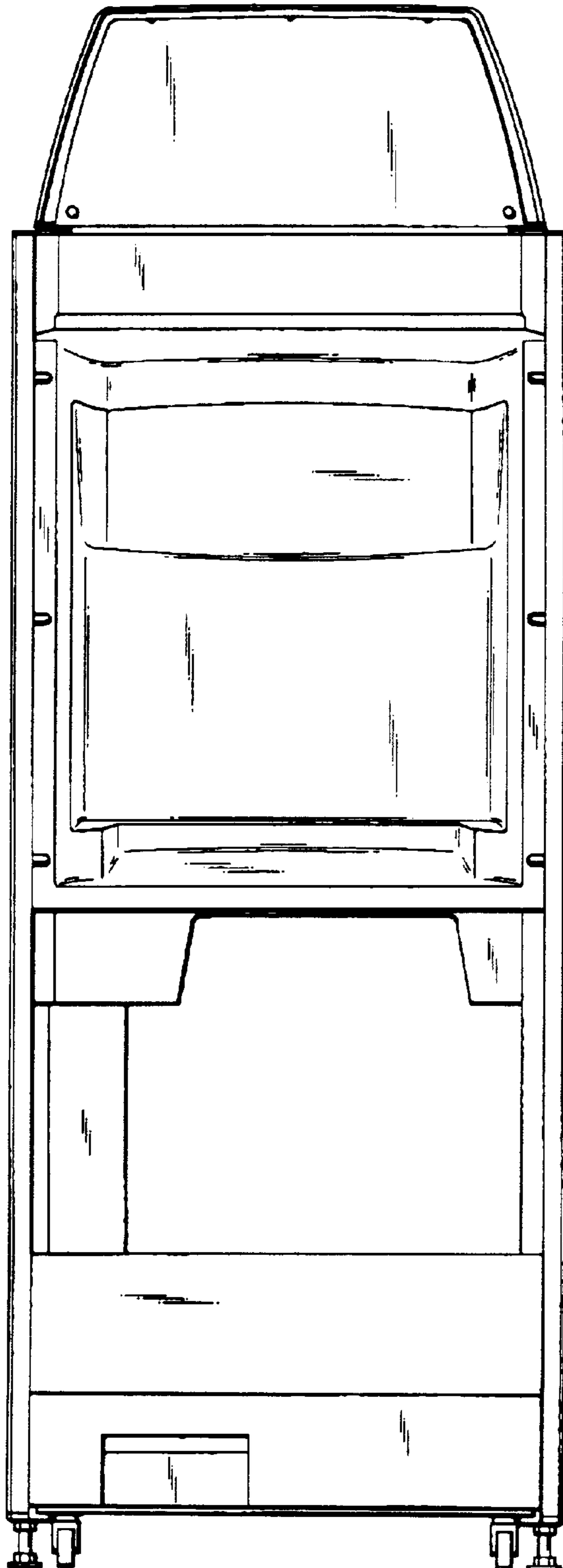

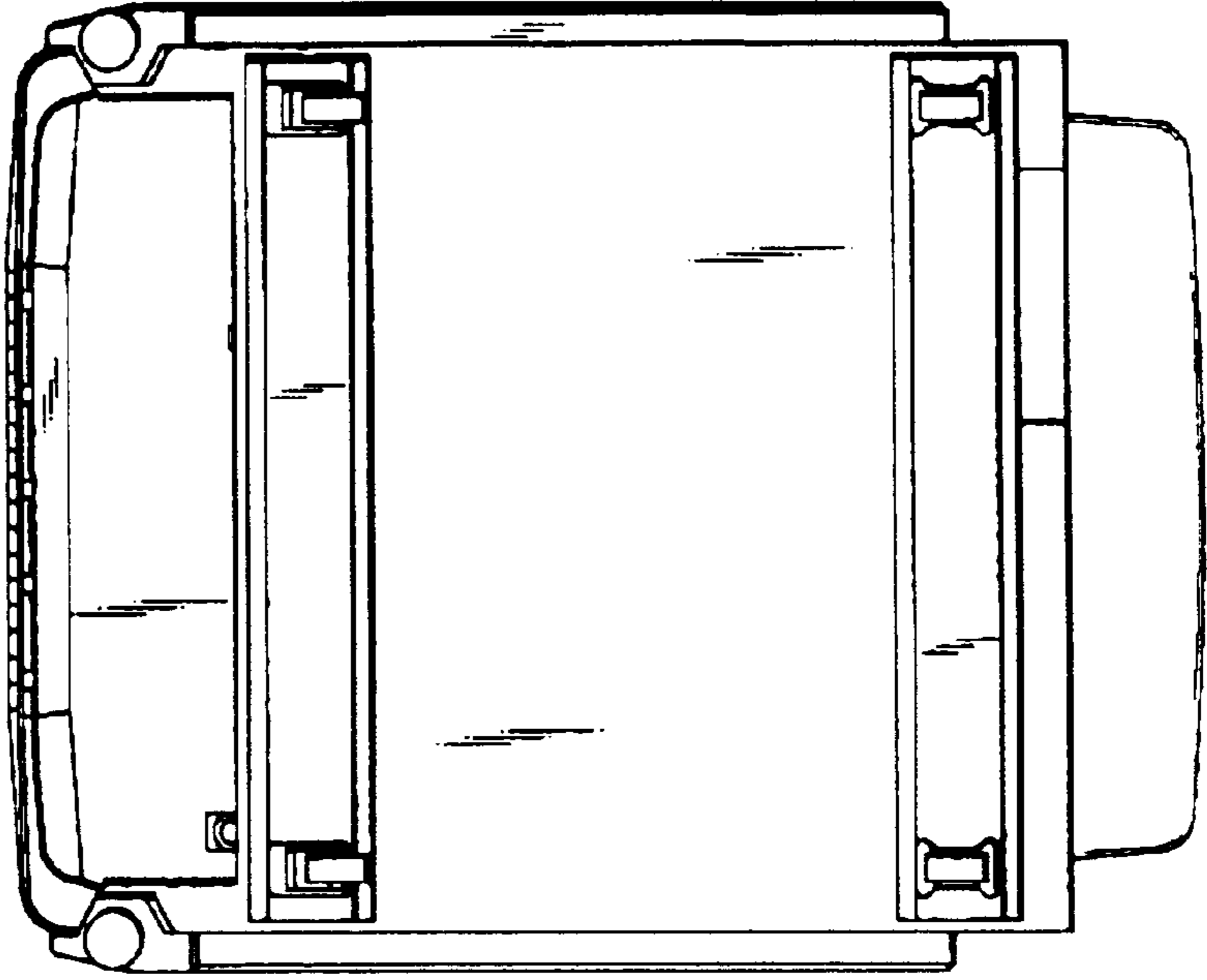

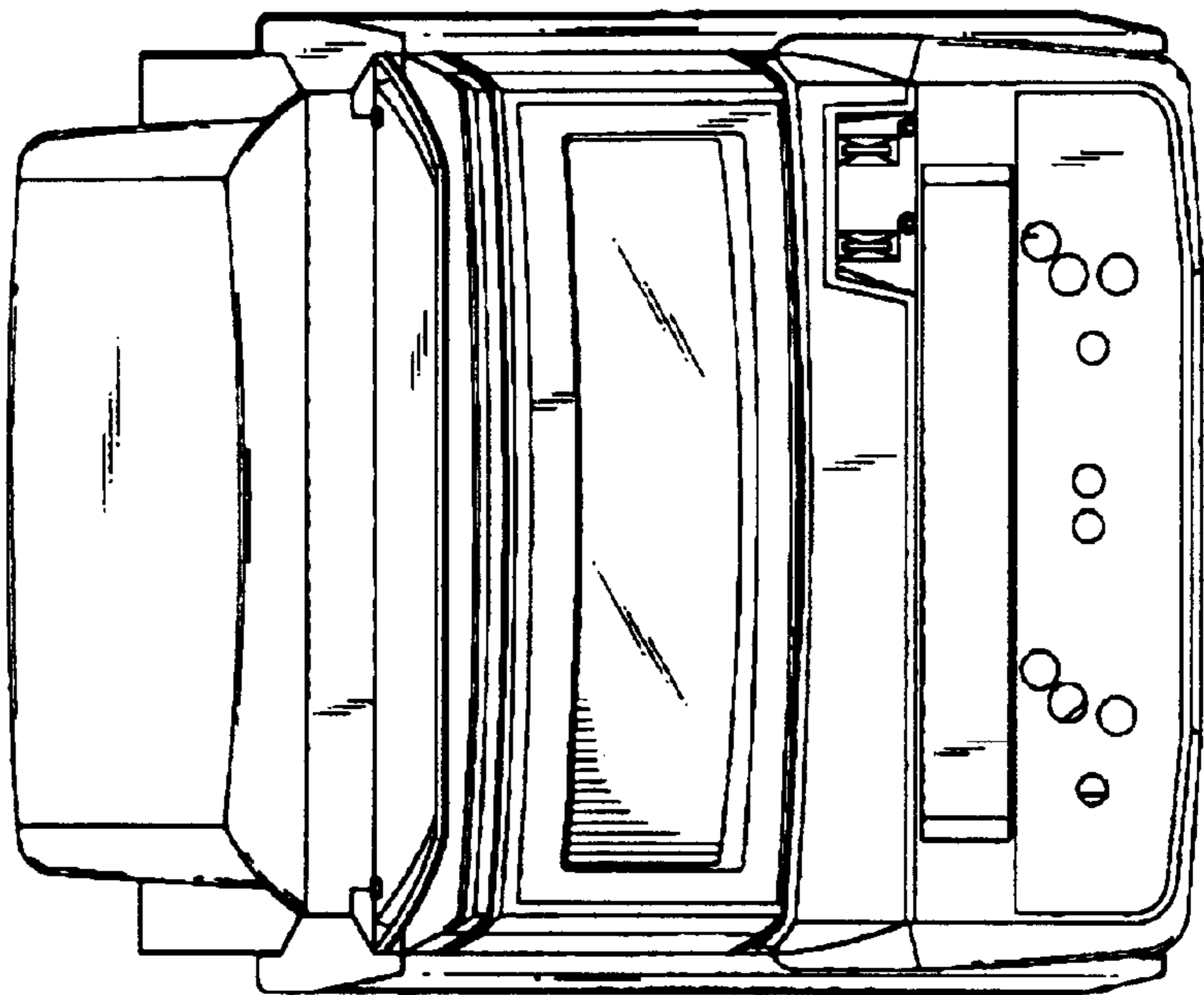

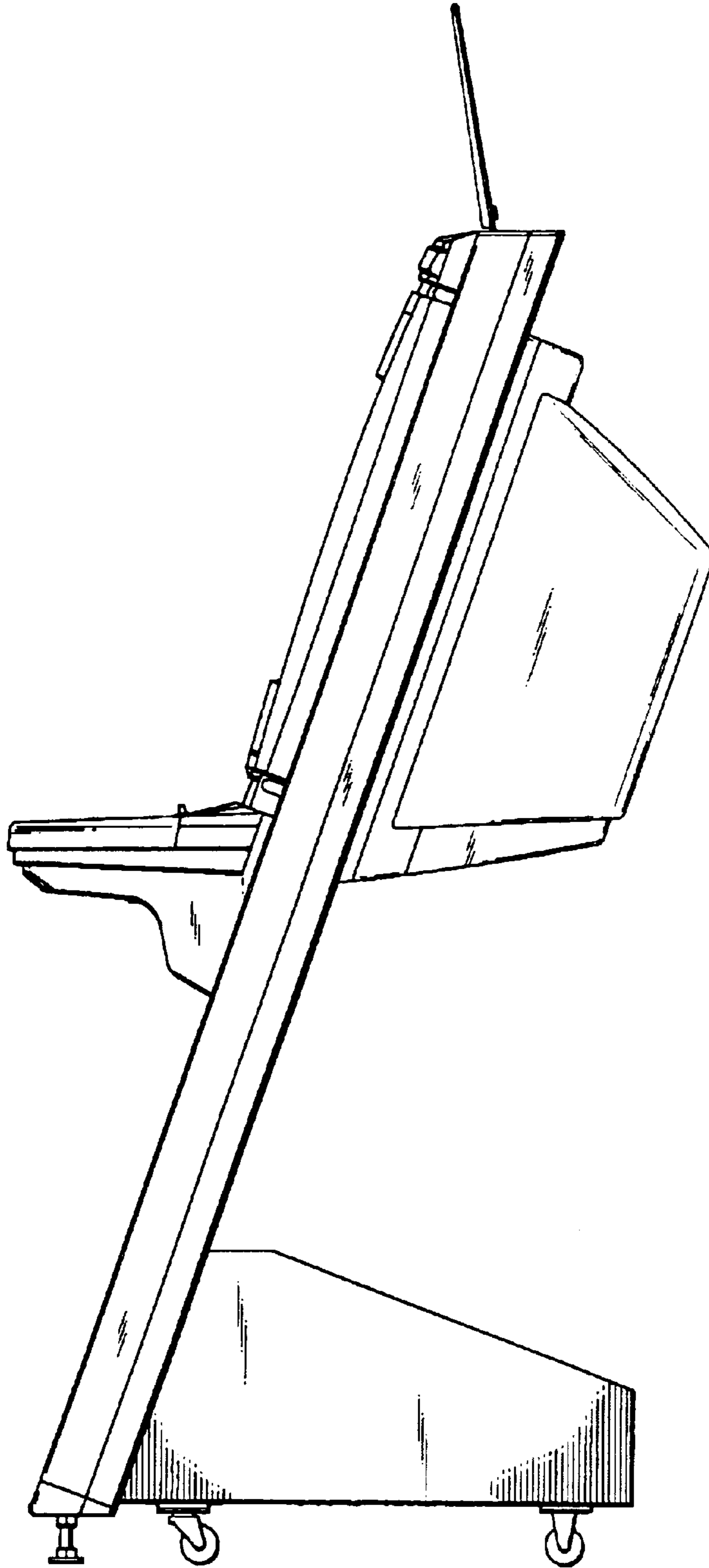
