FIG. 2 is a right side view, the left side being a mirror image thereof;

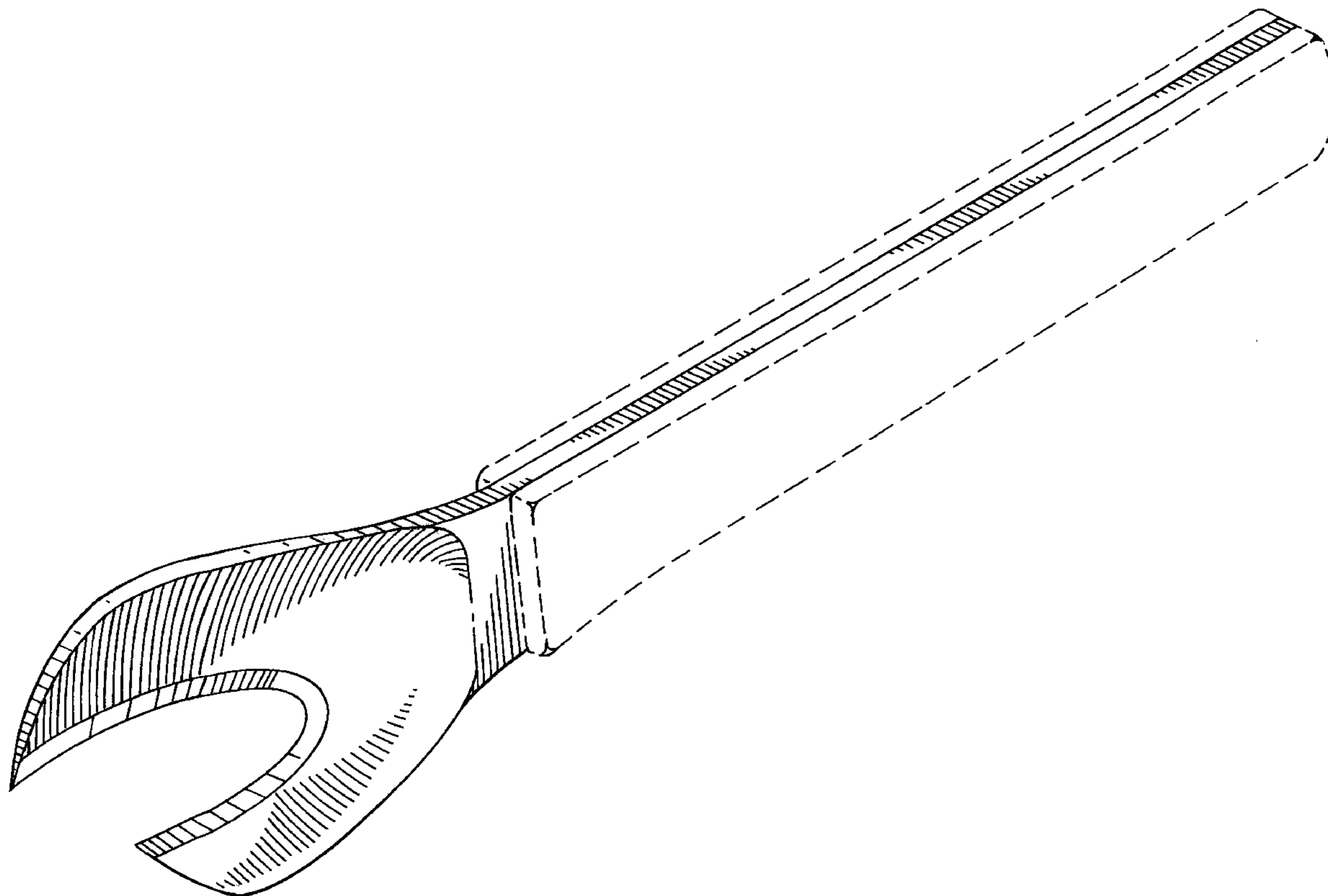
FIG. 3 is a top view thereof;

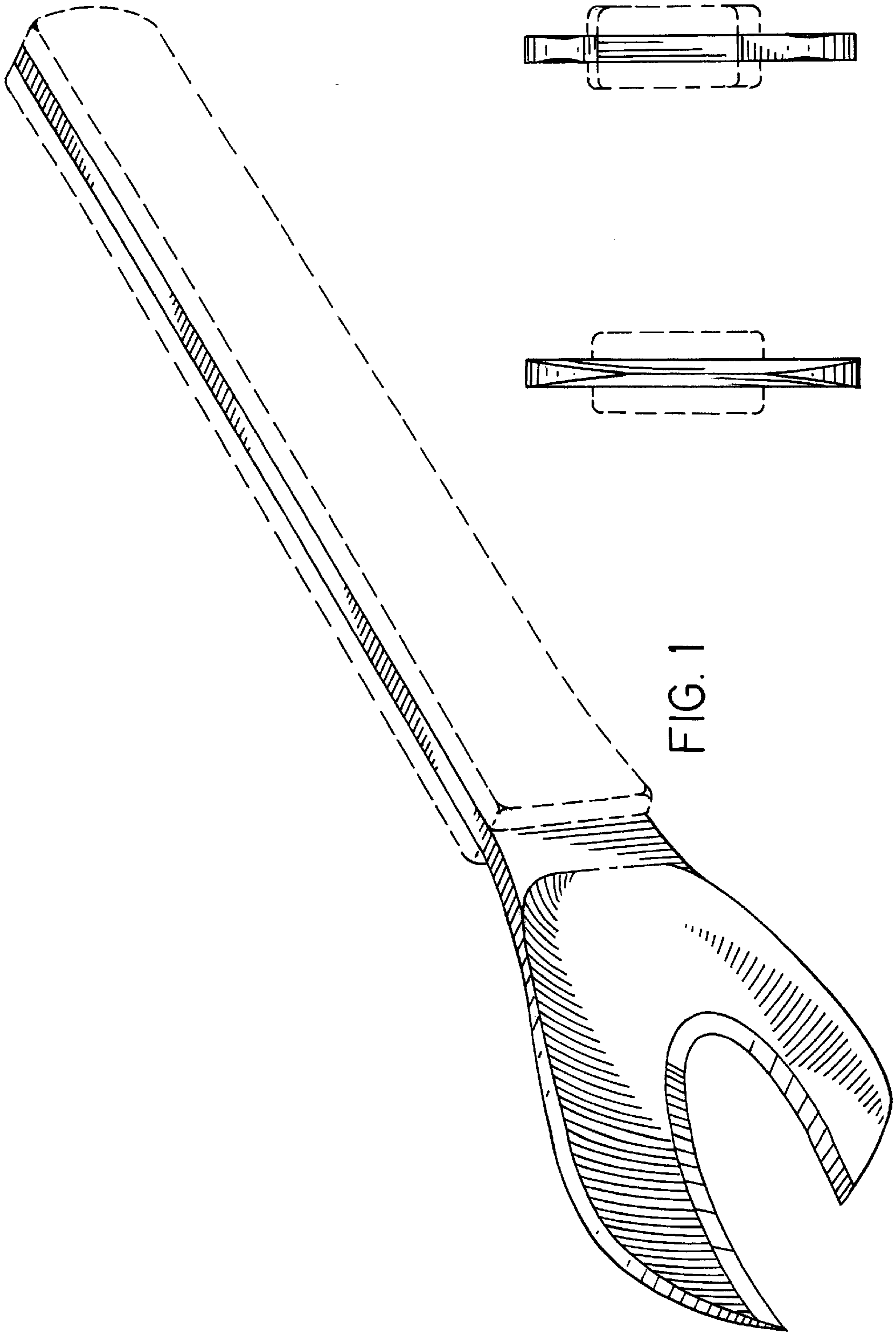

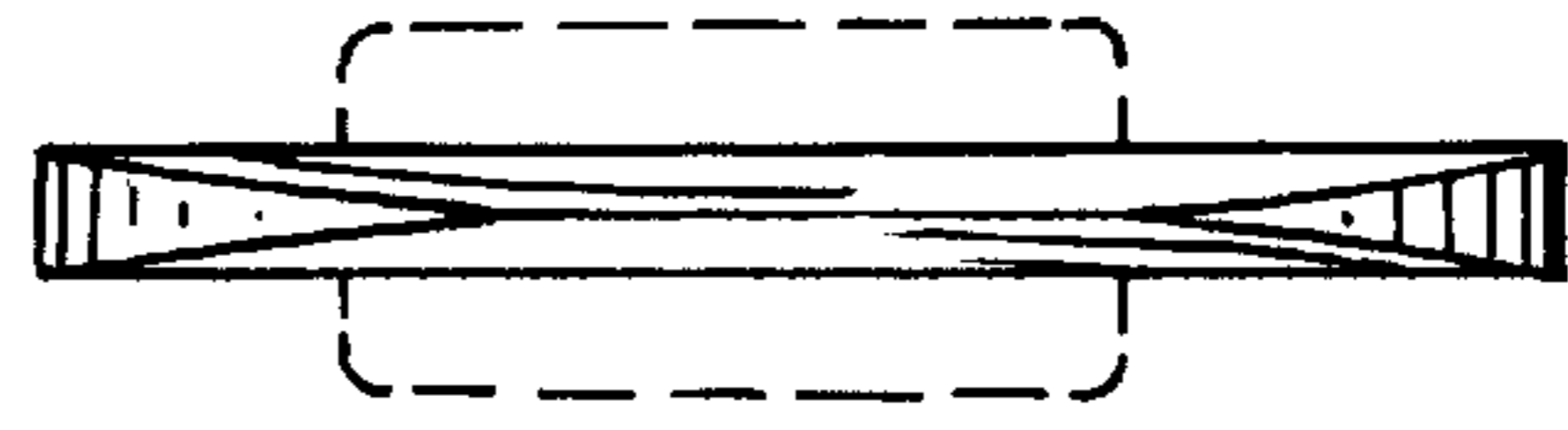

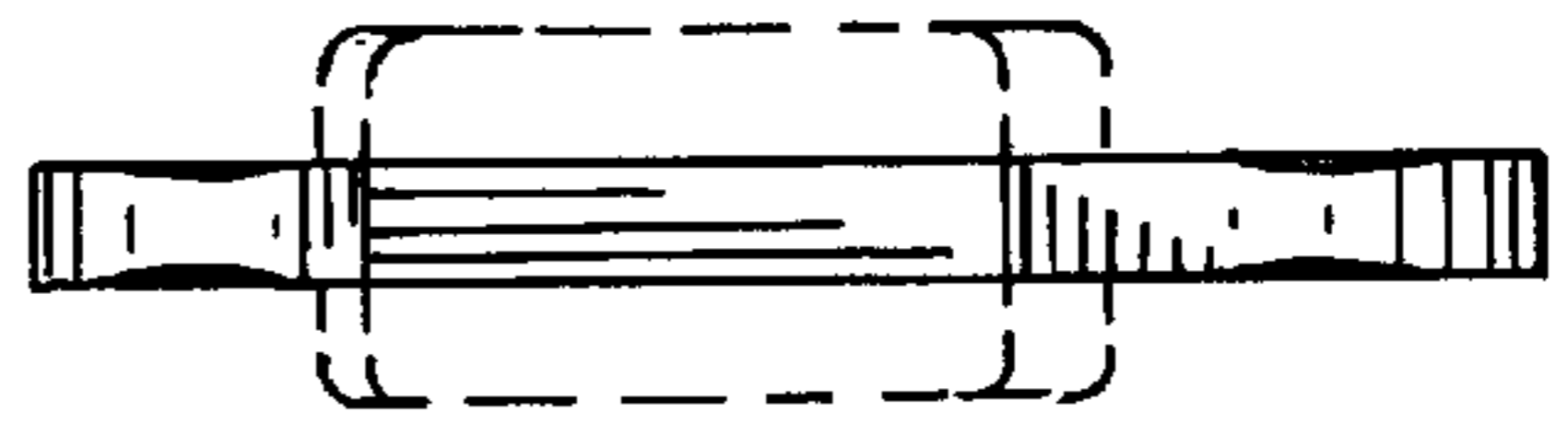

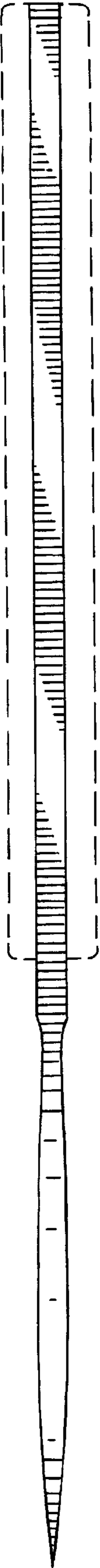

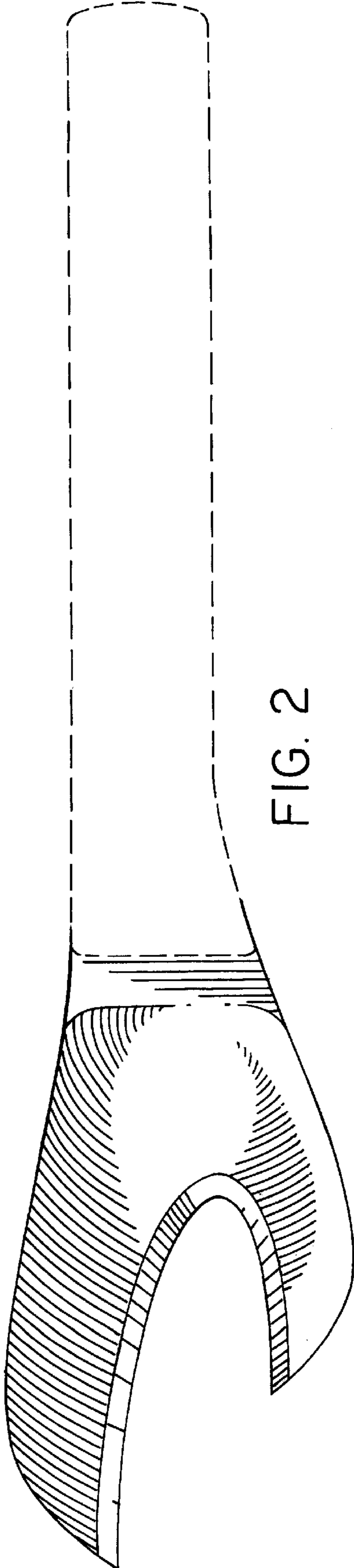
