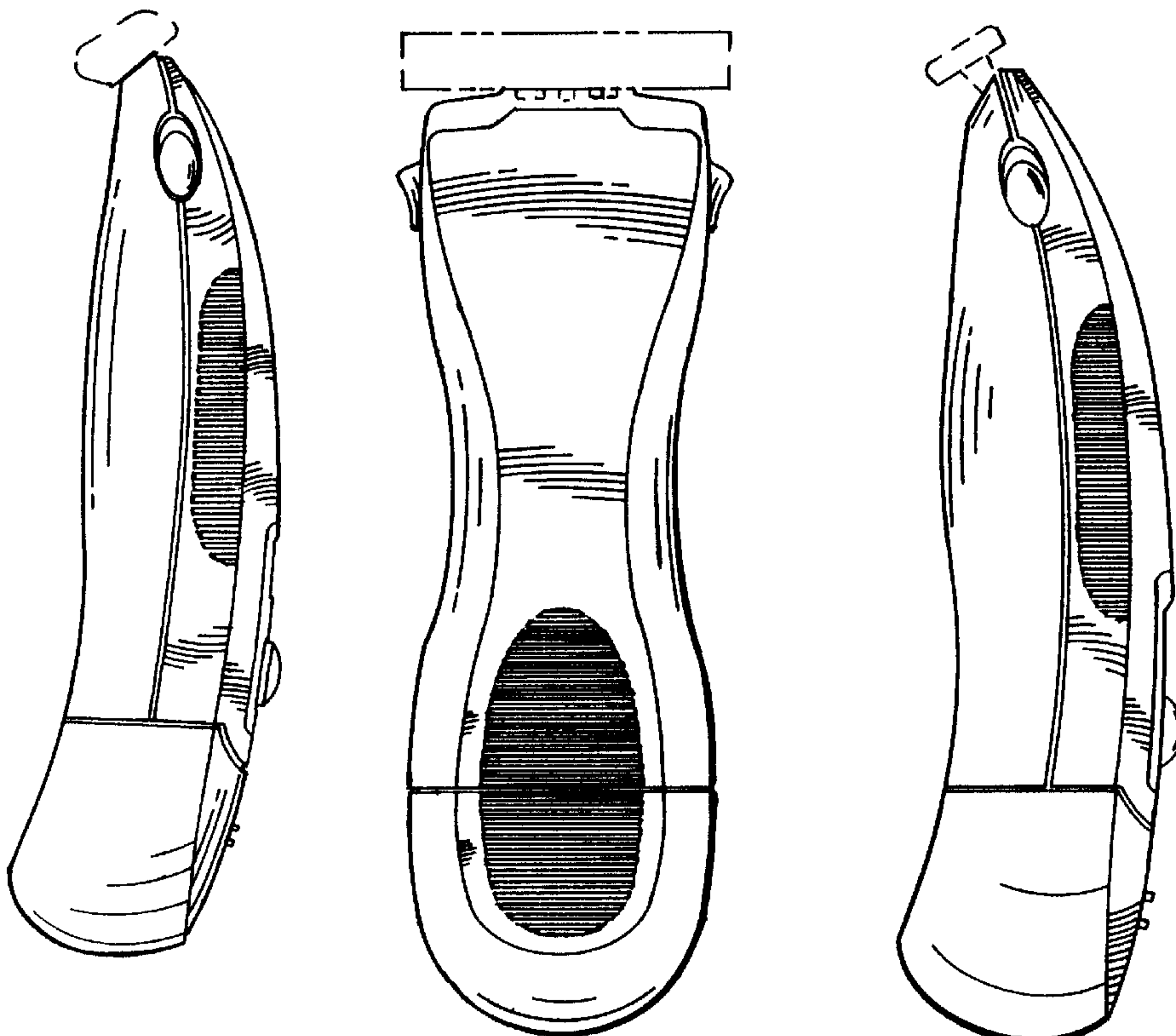
FIG. 7 is a rear elevational view thereof; and,

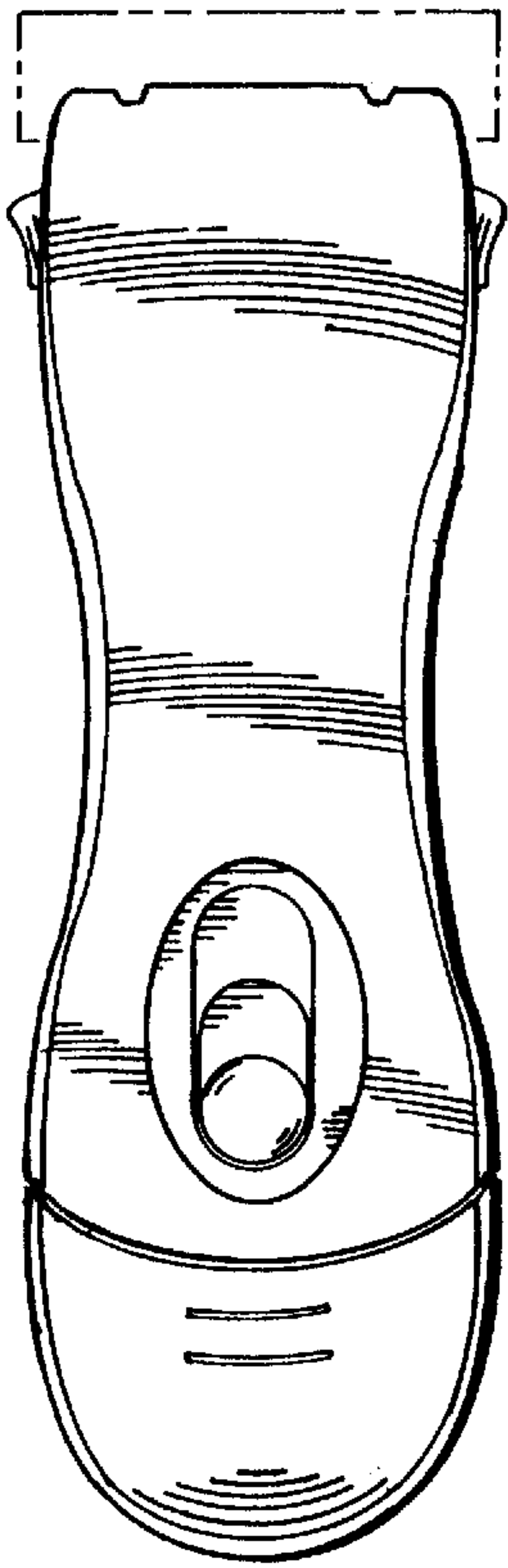

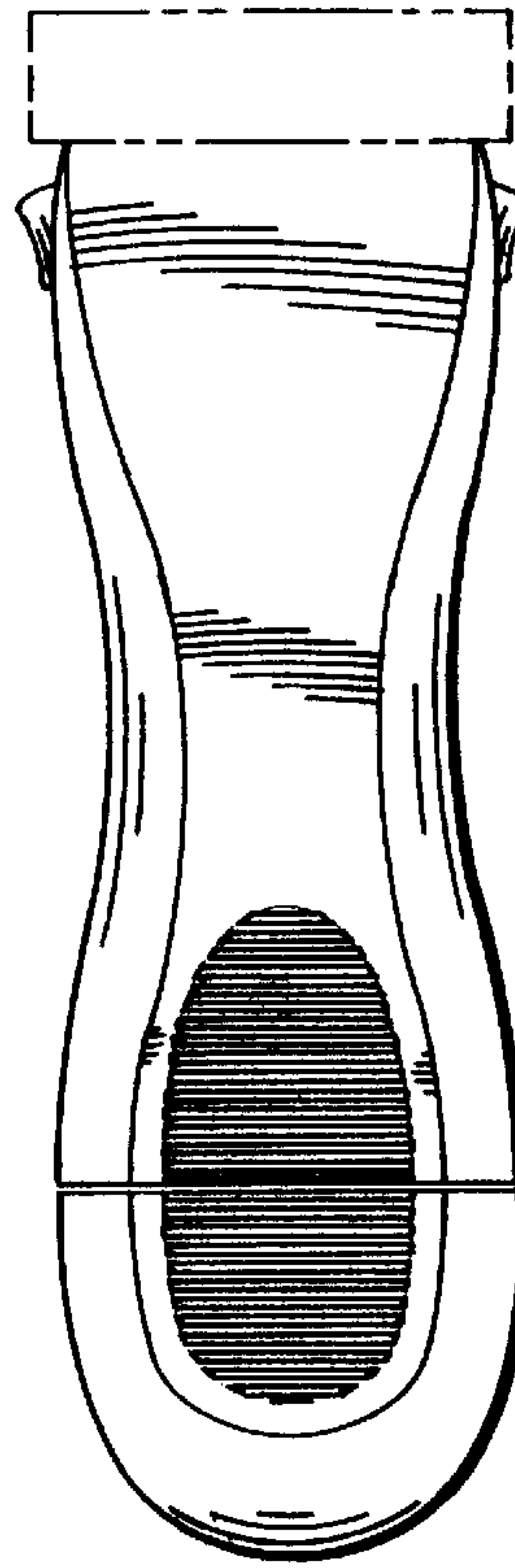

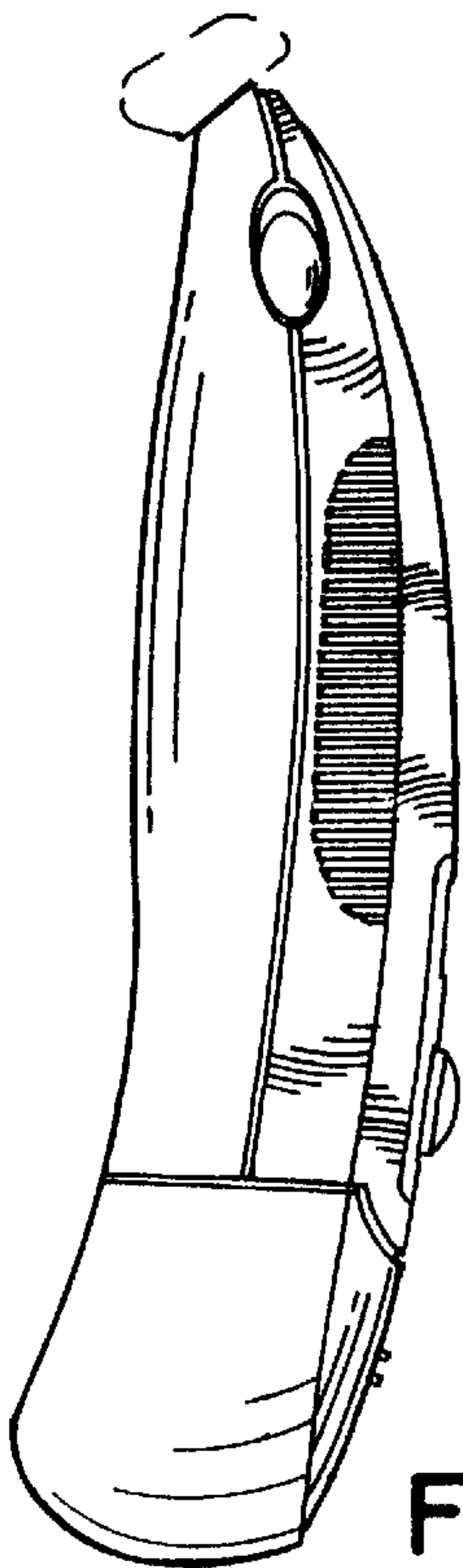

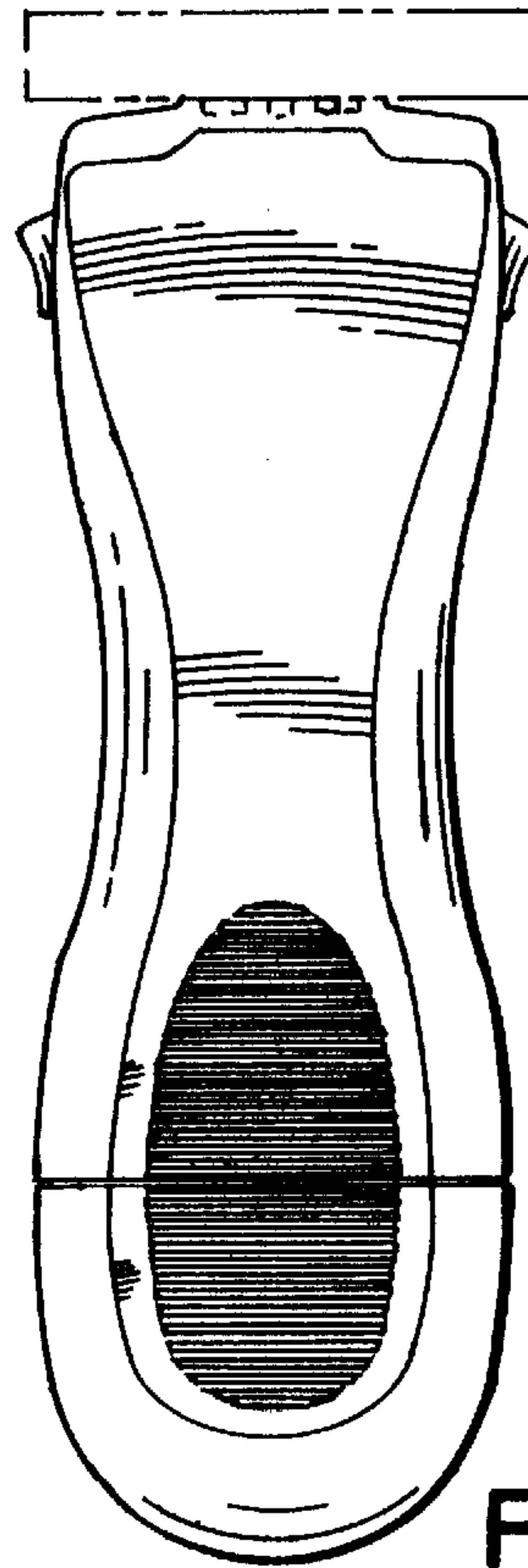

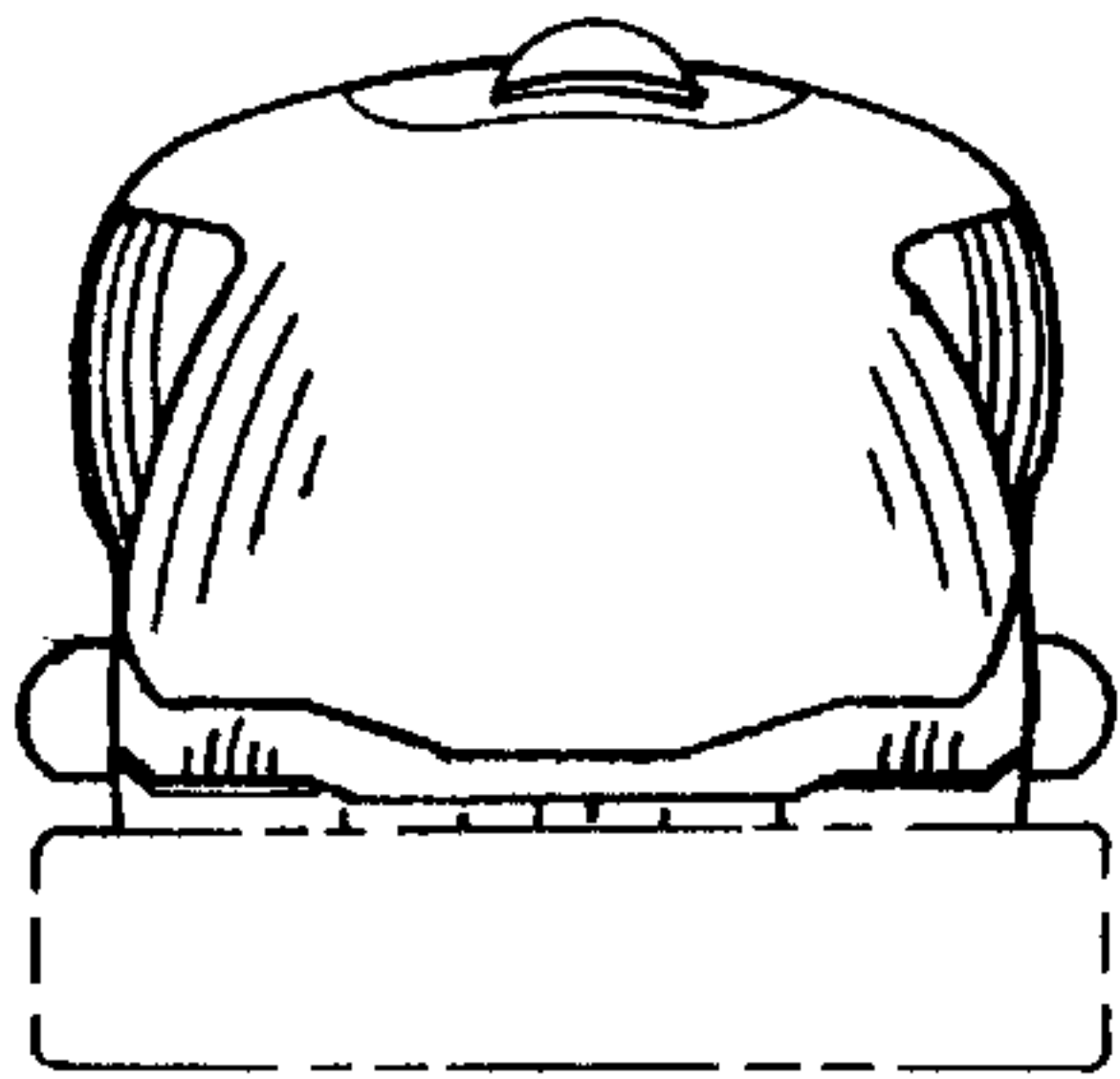

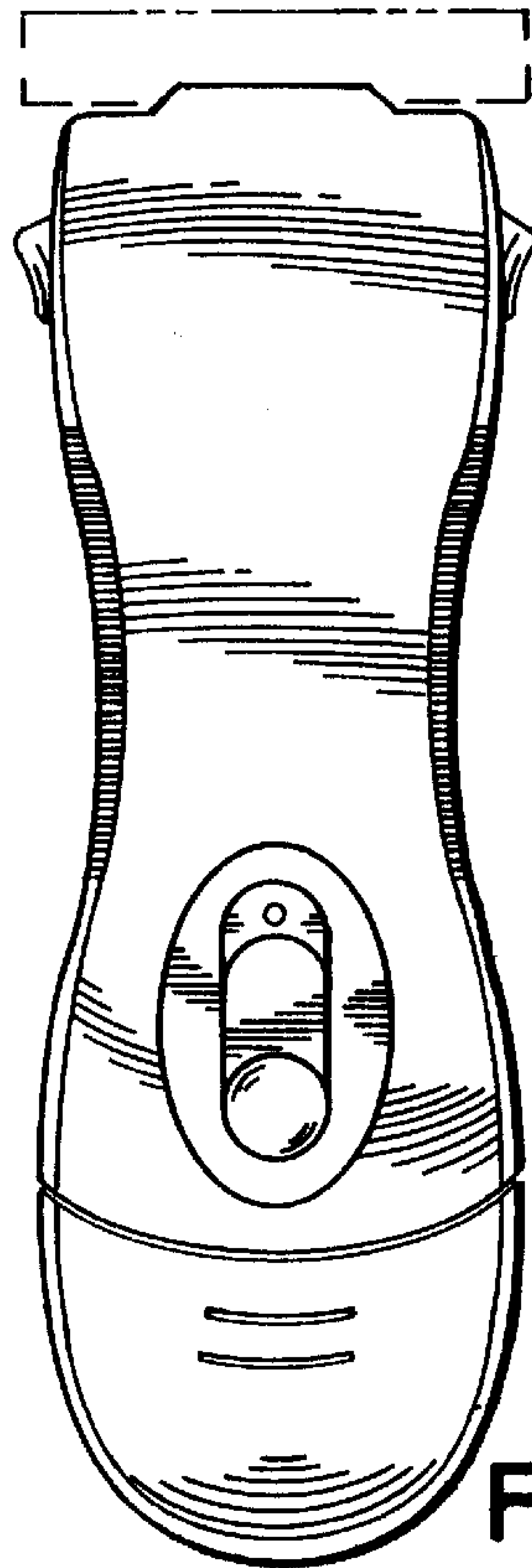

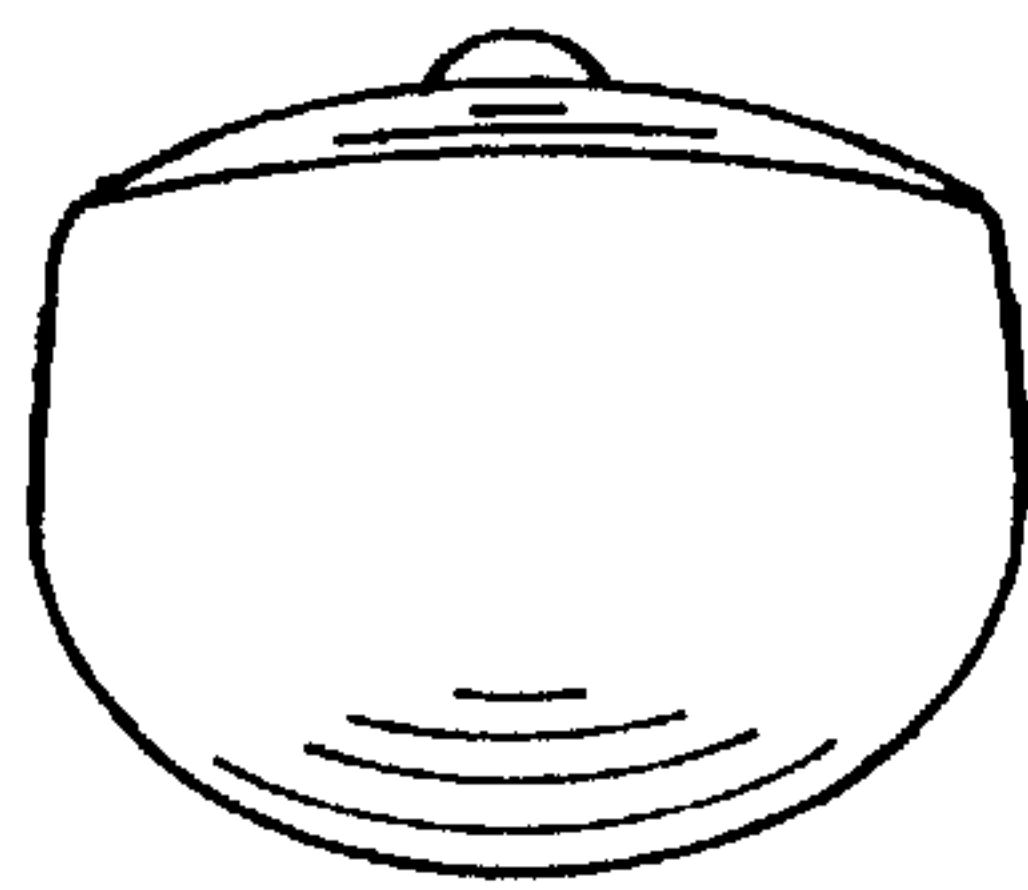

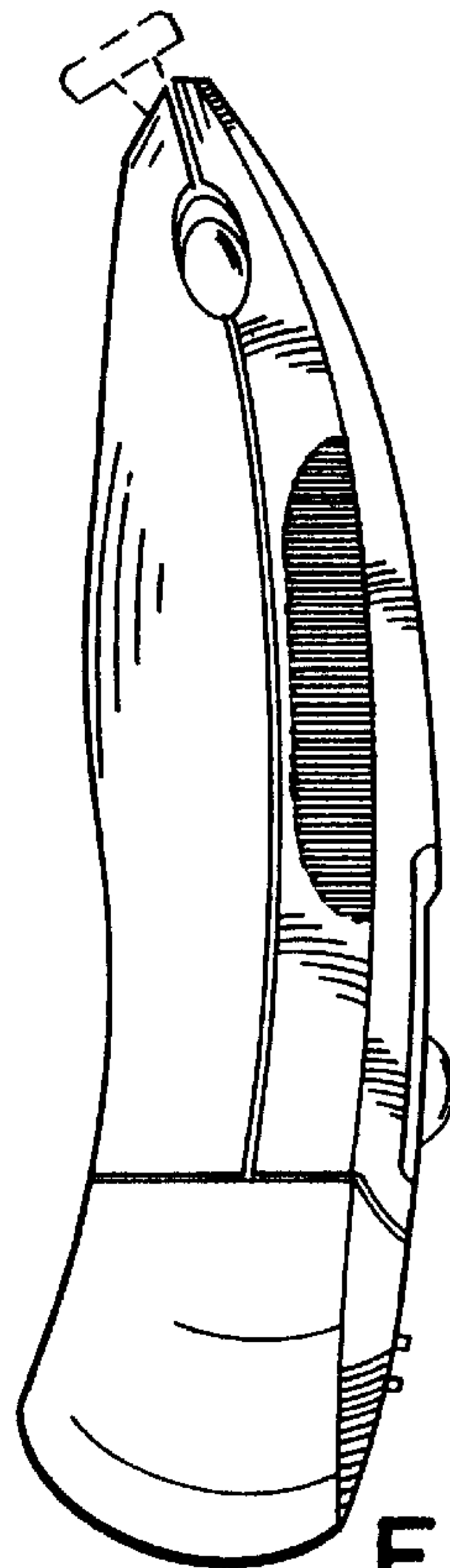
