FIG. 7 is a top plan view of the tower chair of FIG. 6;

FIG. 8 is a front elevational view of the tower chair of FIG. 6, with the back, right and left elevational views being identical;

FIG. 9 is a bottom plan view of the tower chair of FIG. 6; FIG. 10 is a perspective view of the tower chair of FIG. 1, illustrating an exemplar head piece attached to the top of the tower chair;

FIG. 11 is a perspective view of a tower chair of a third embodiment of the present invention;

FIG. 12 is a top plan view of the tower chair of FIG. 11;

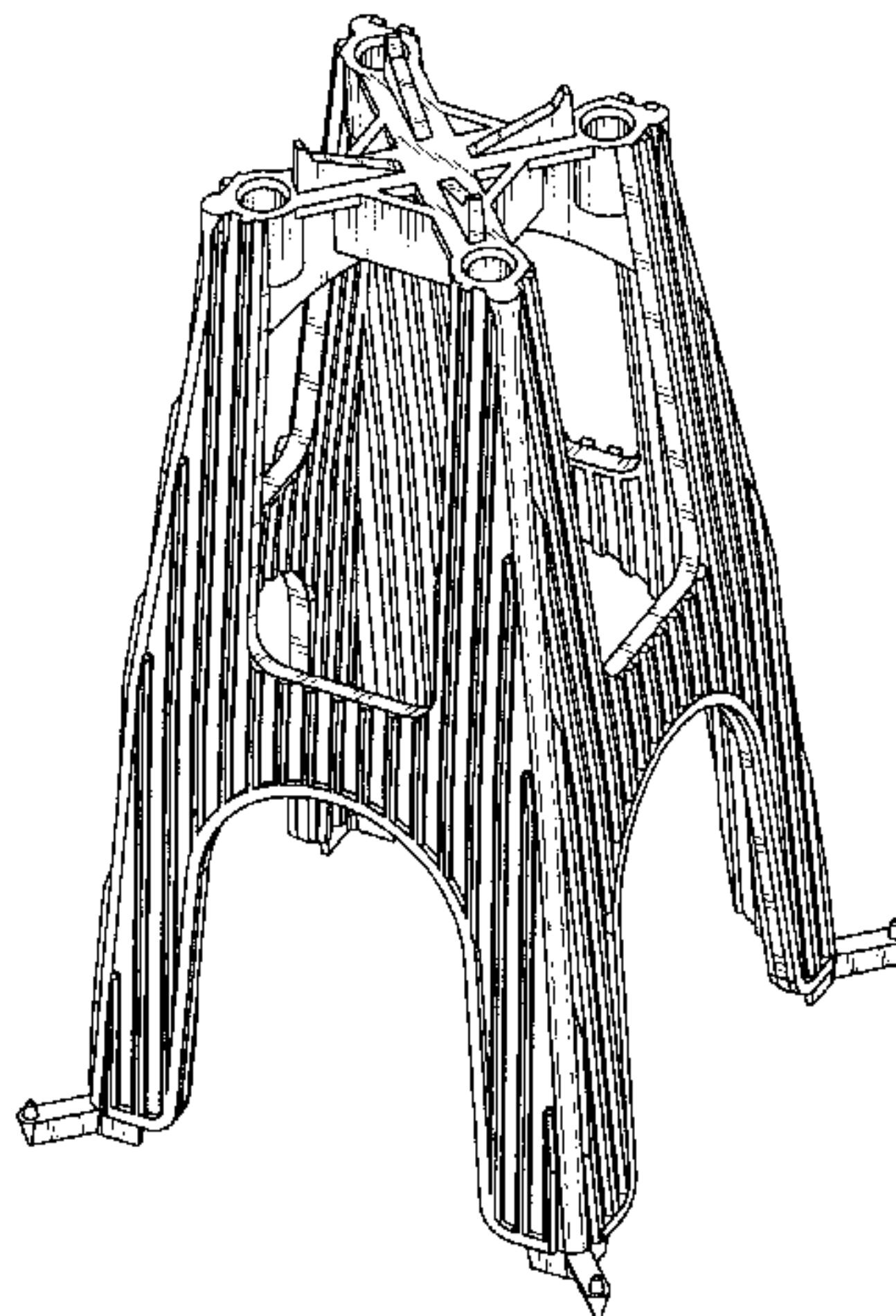


FIG. 13 is a front elevational view of the tower chair of FIG. 11, with the back, right and left elevational views being identical;

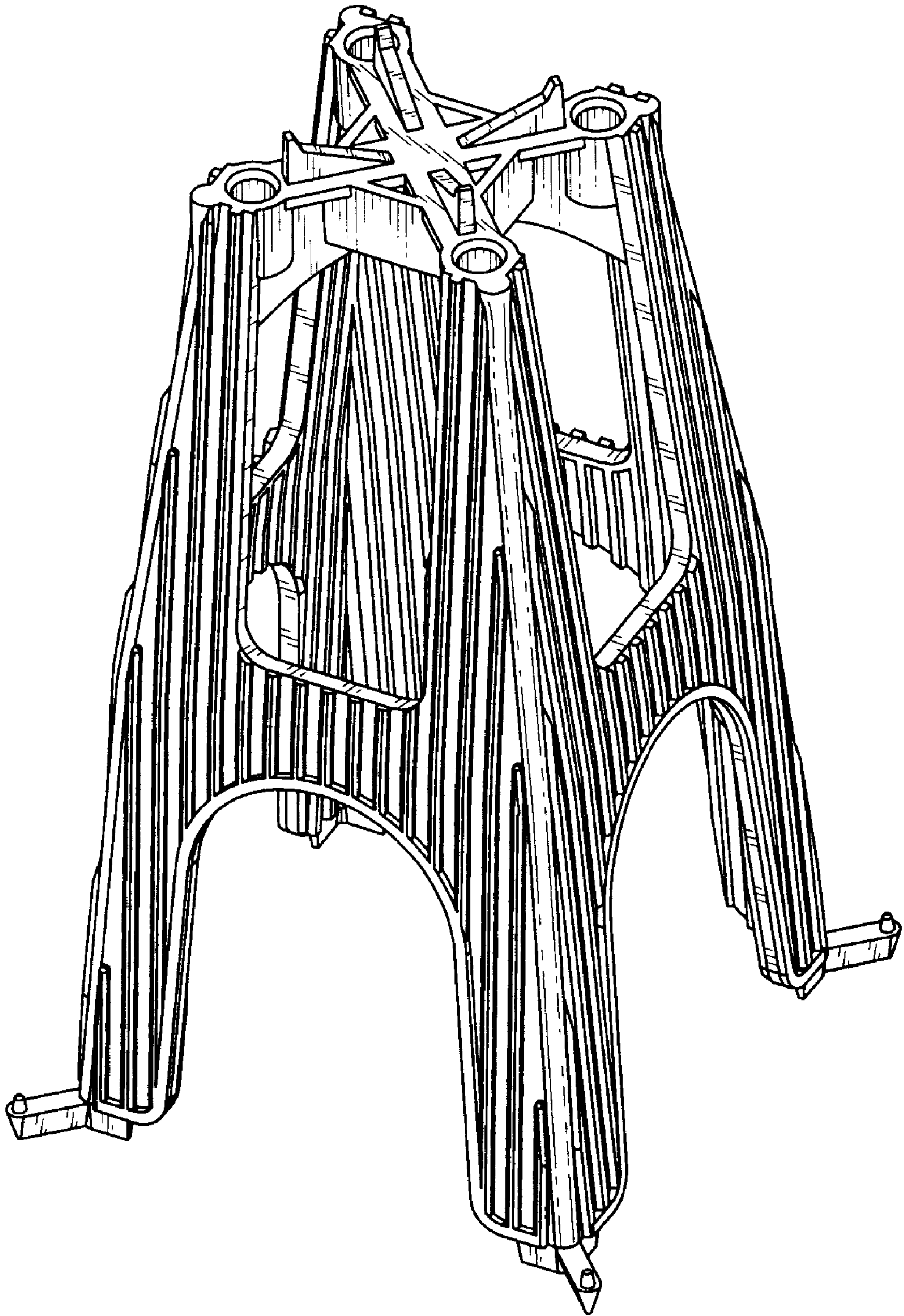

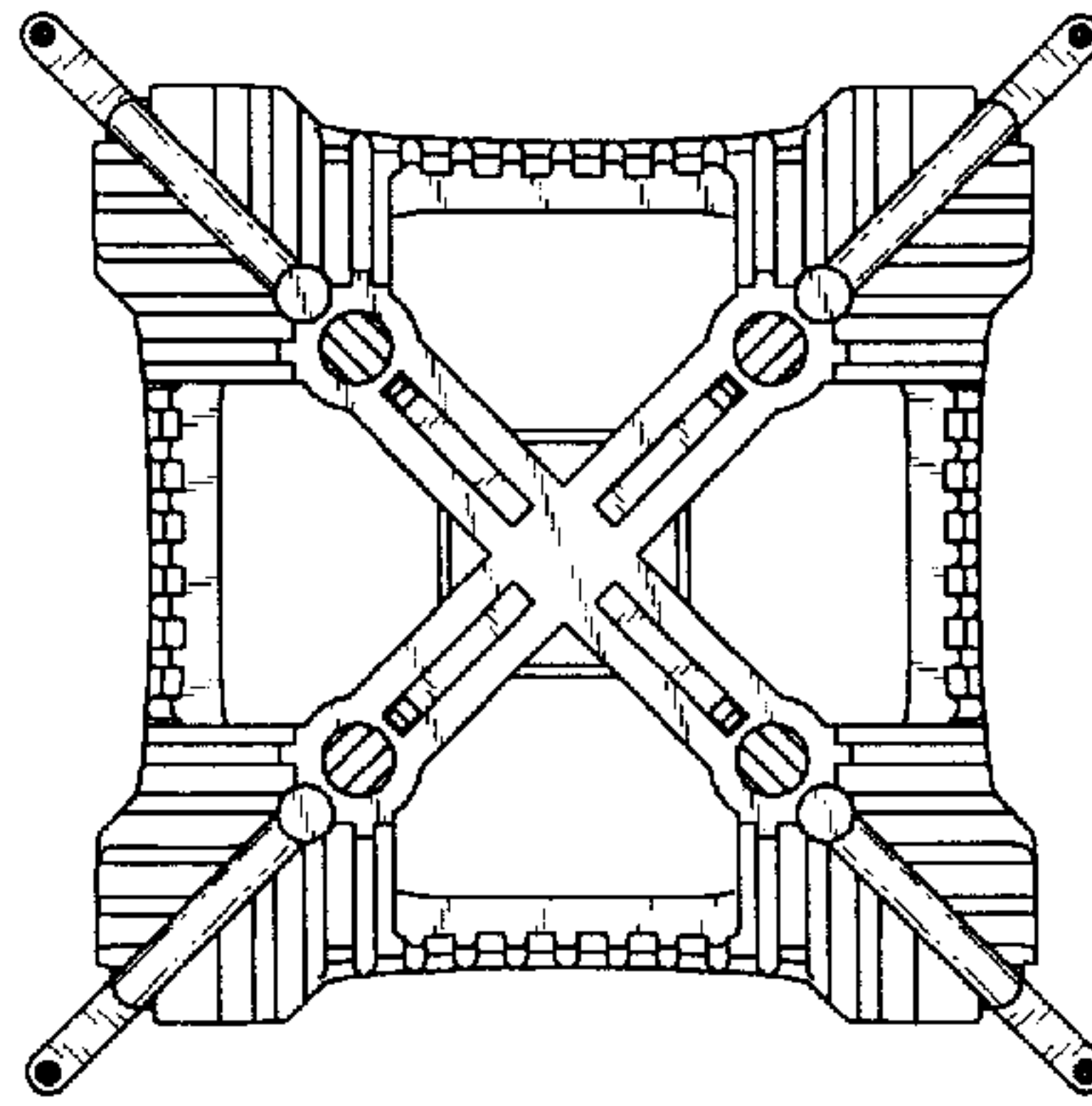

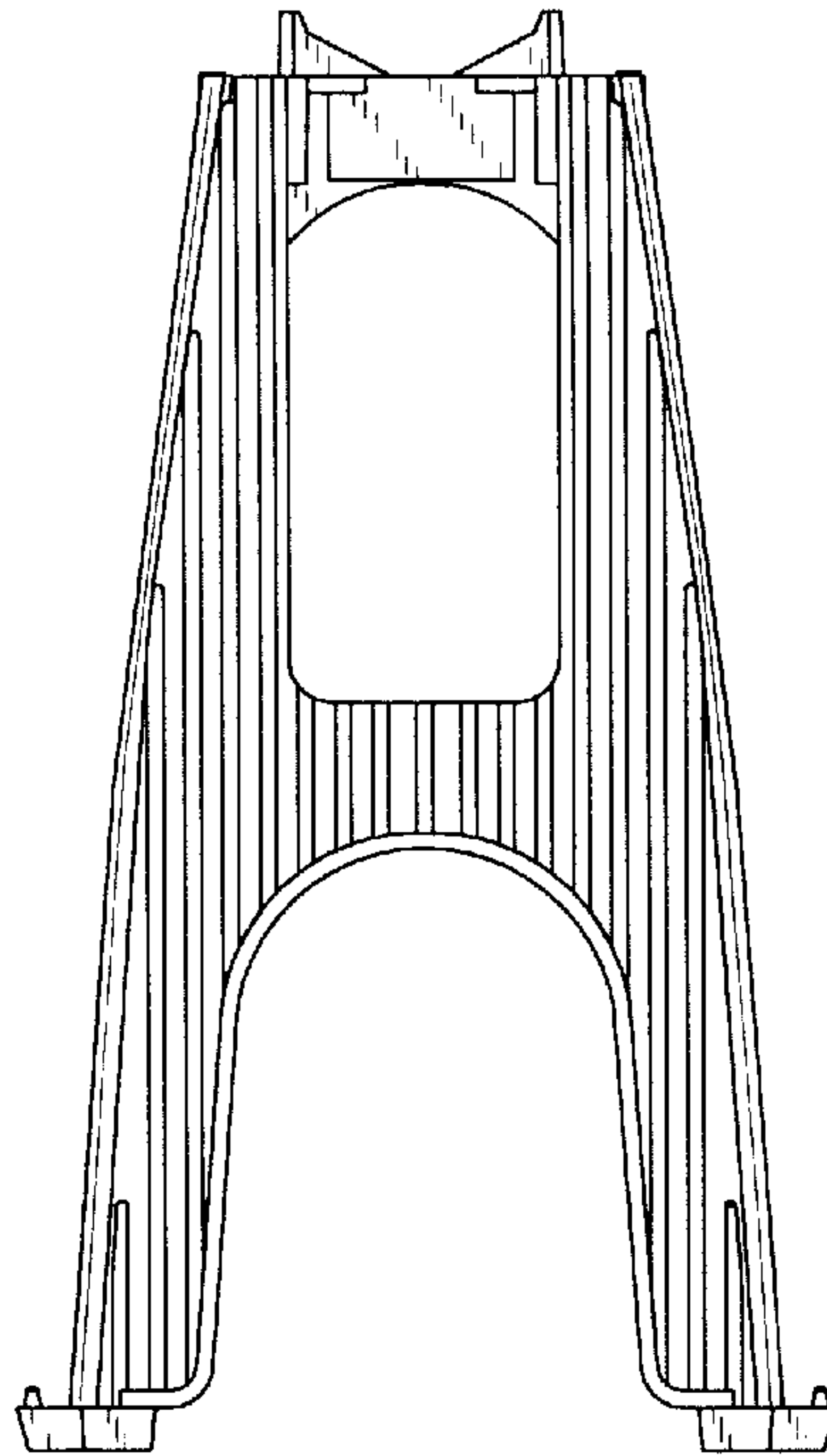
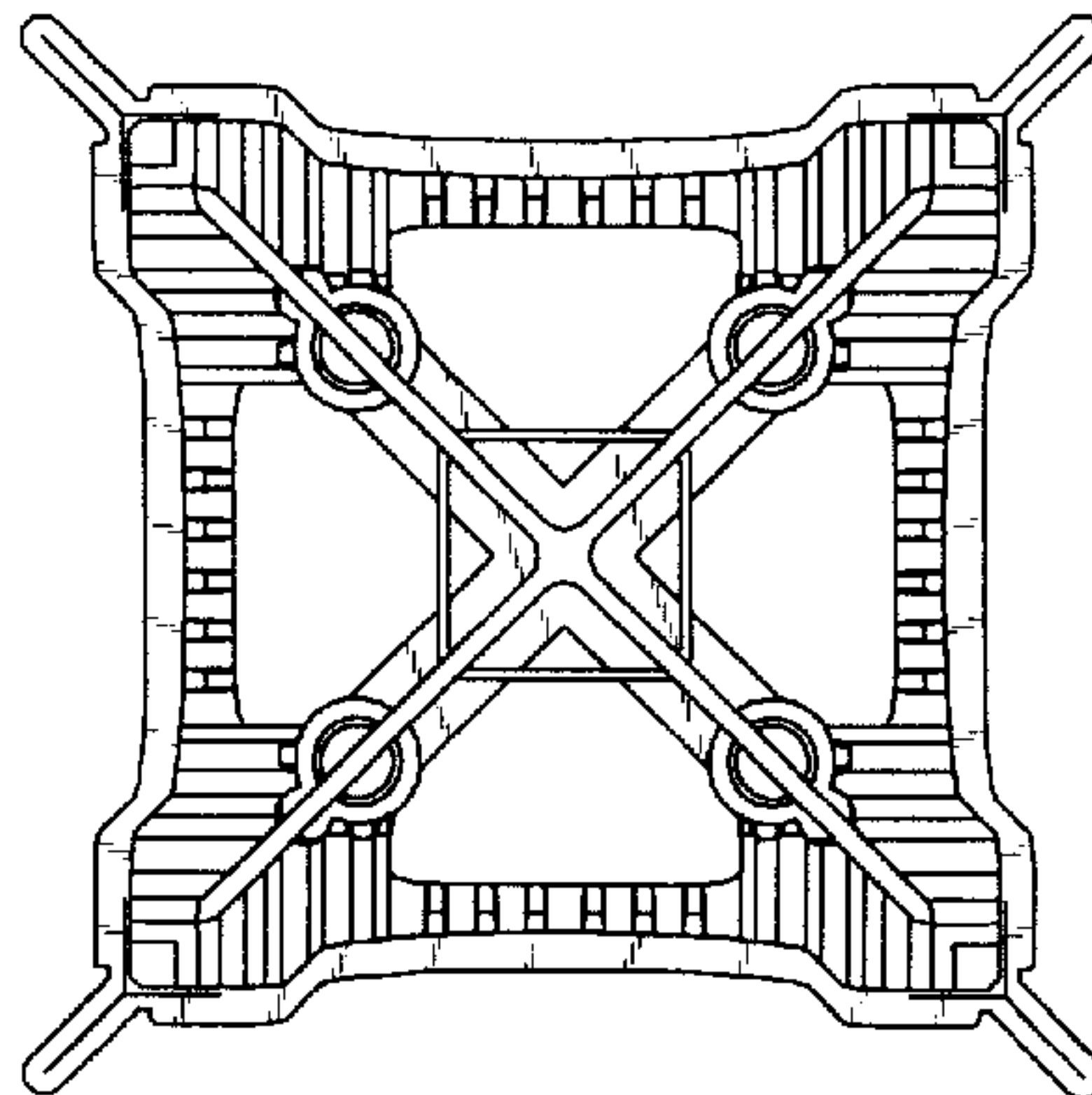

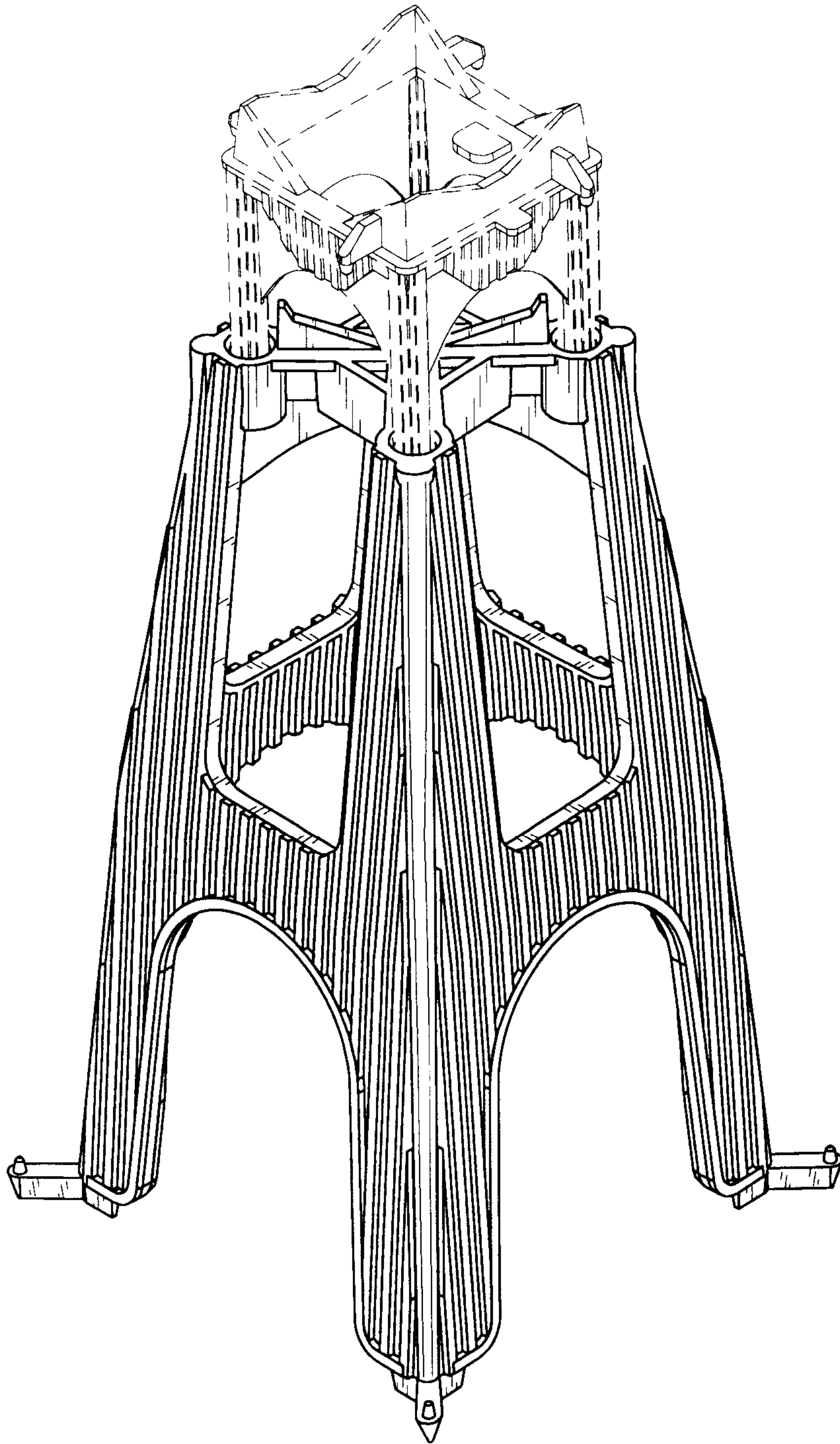

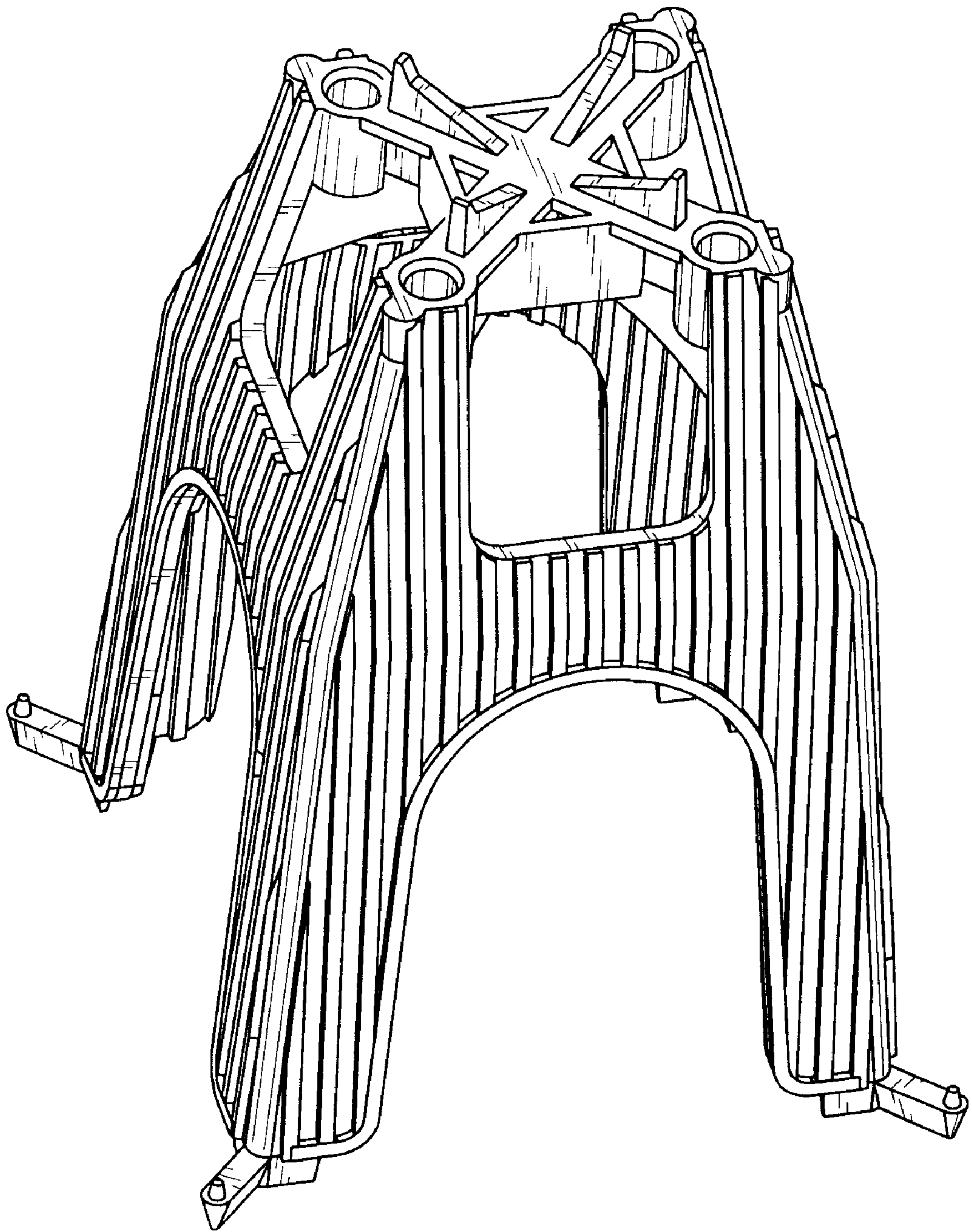

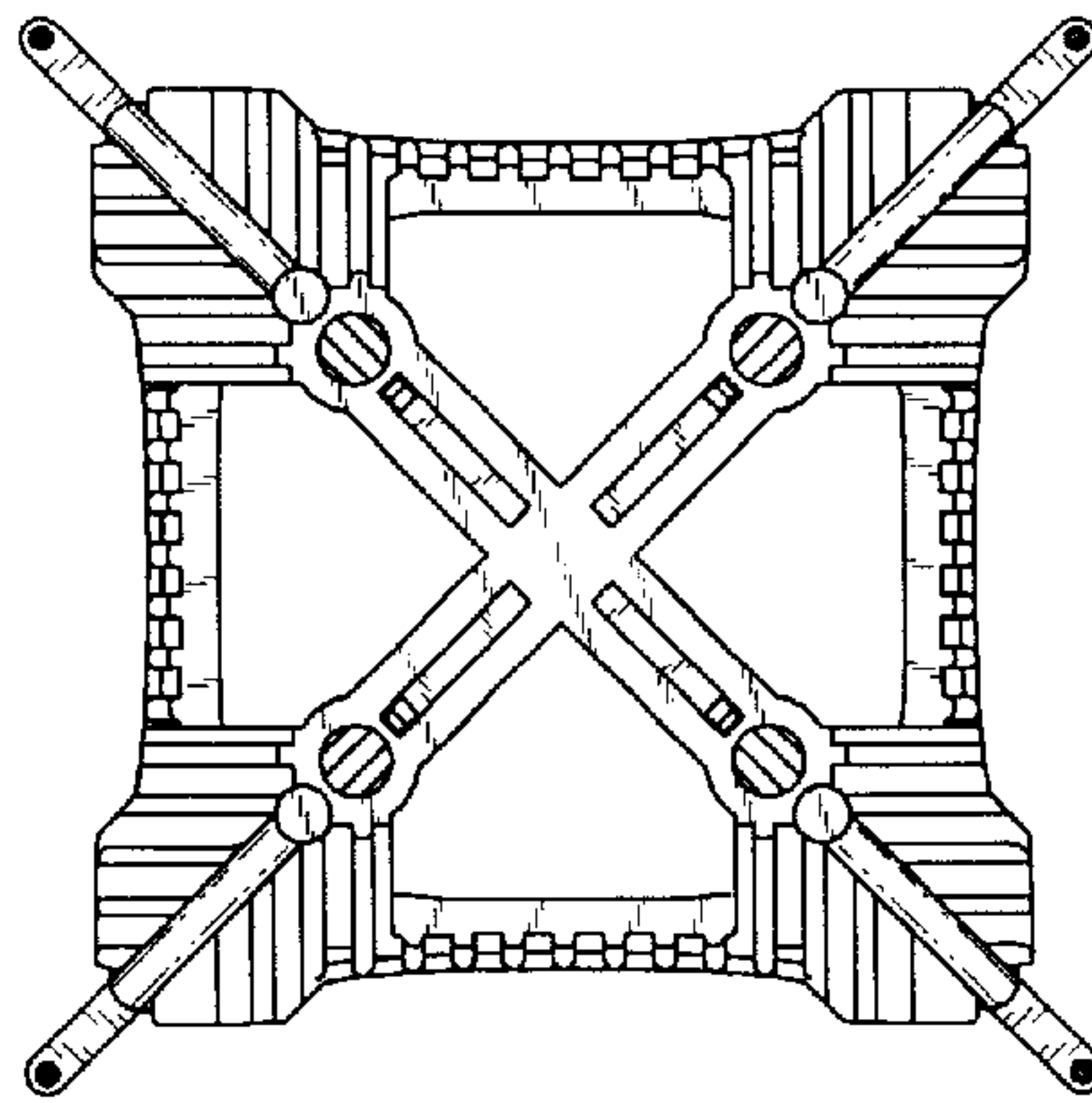

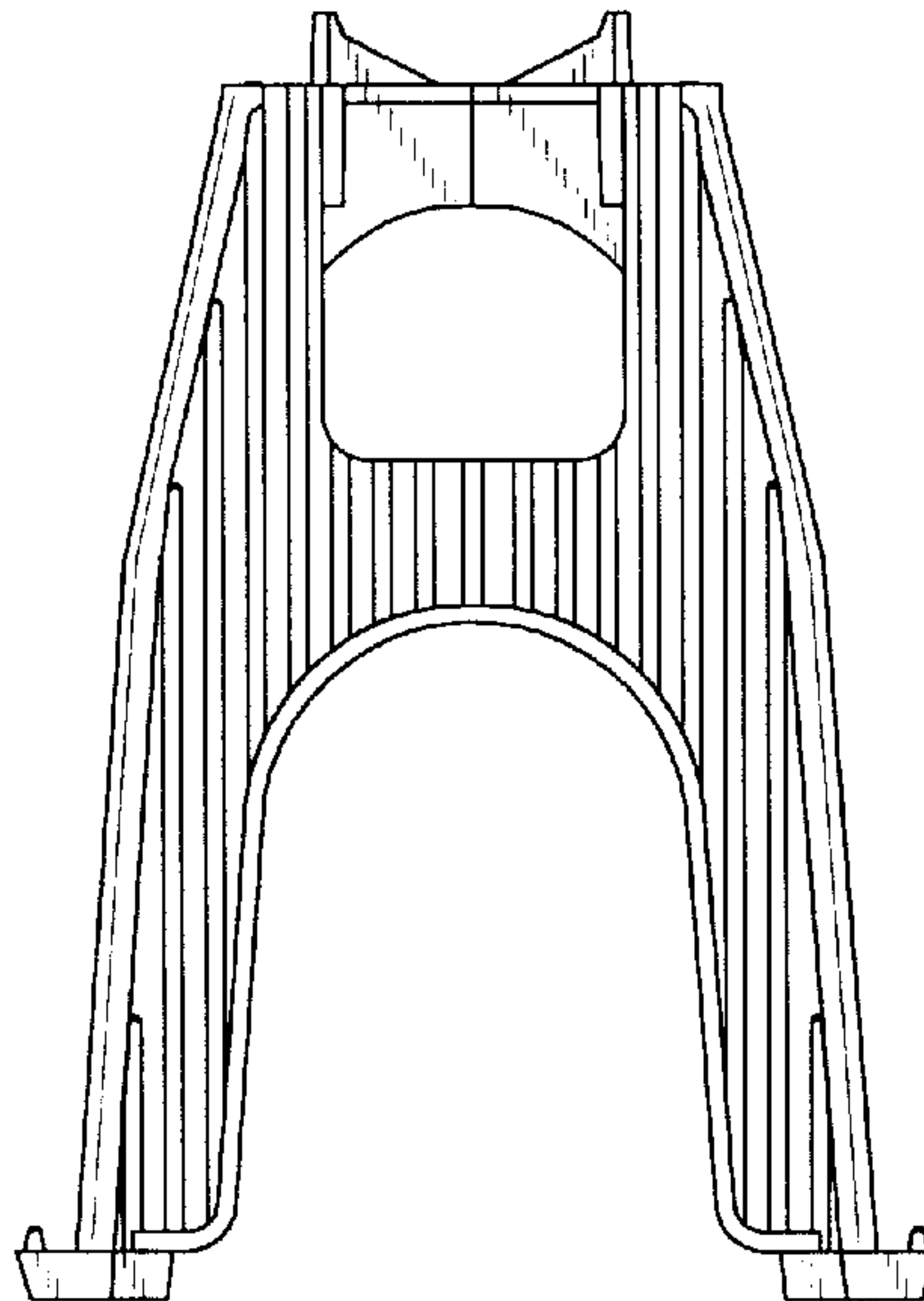
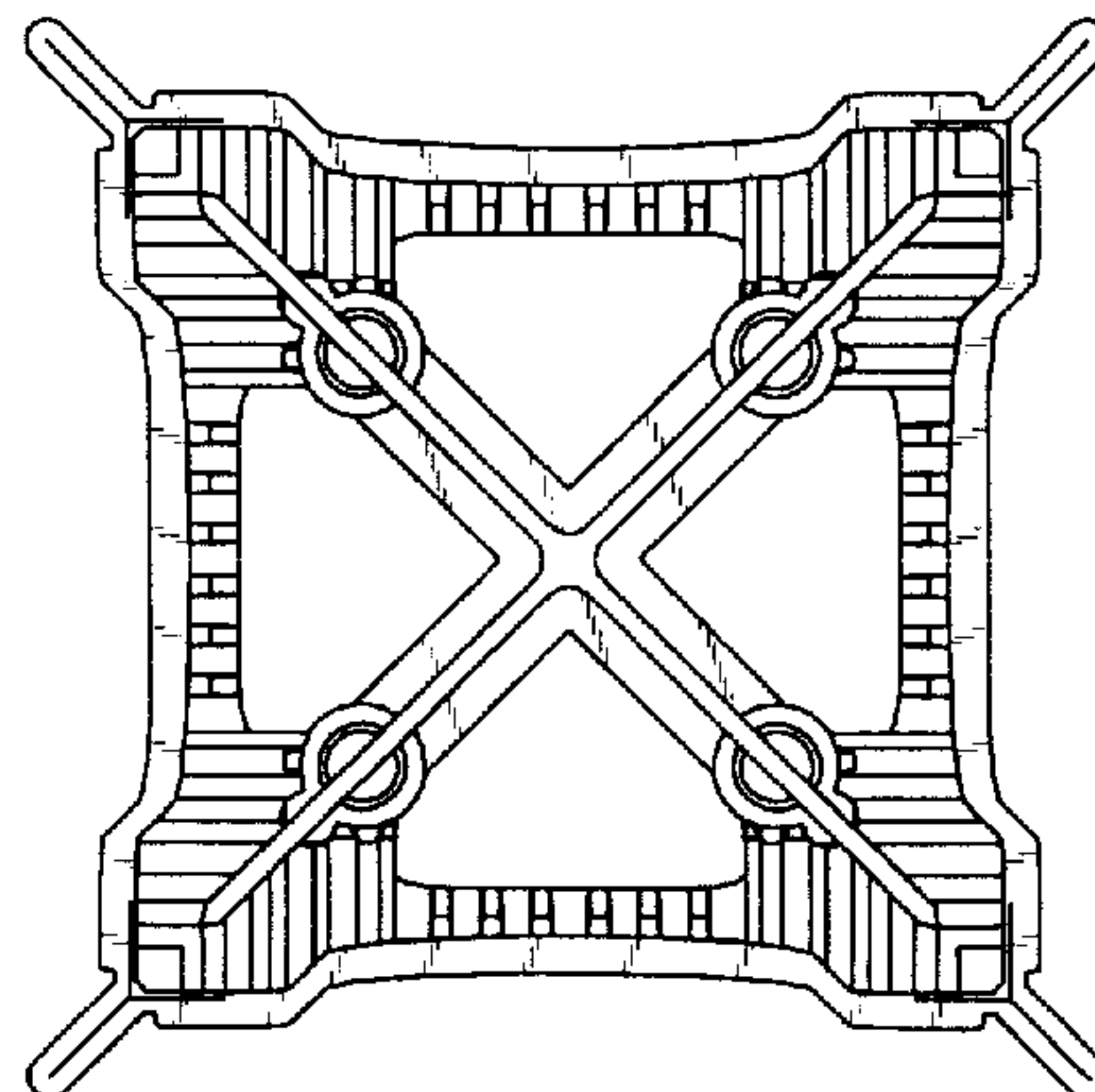

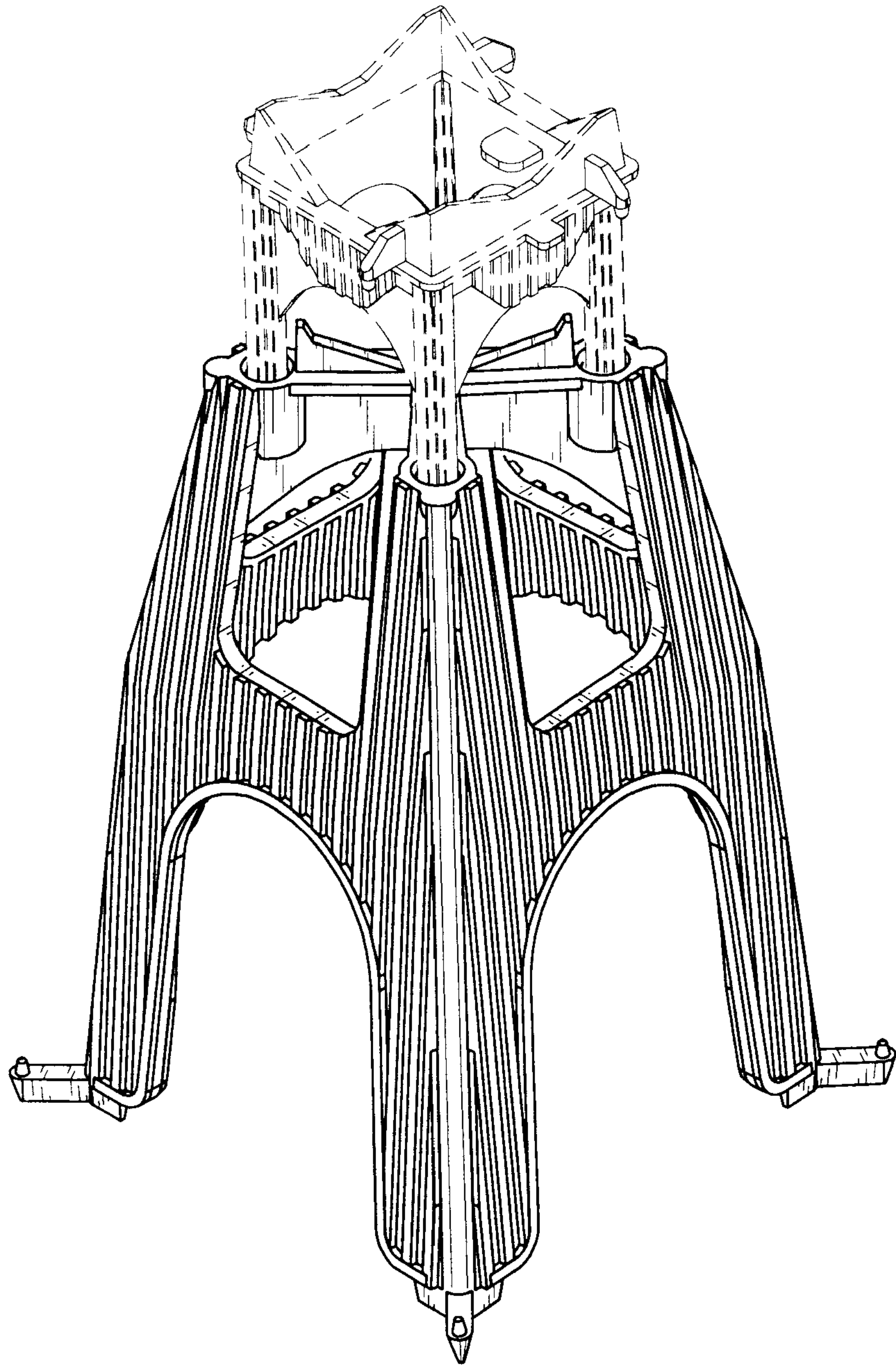

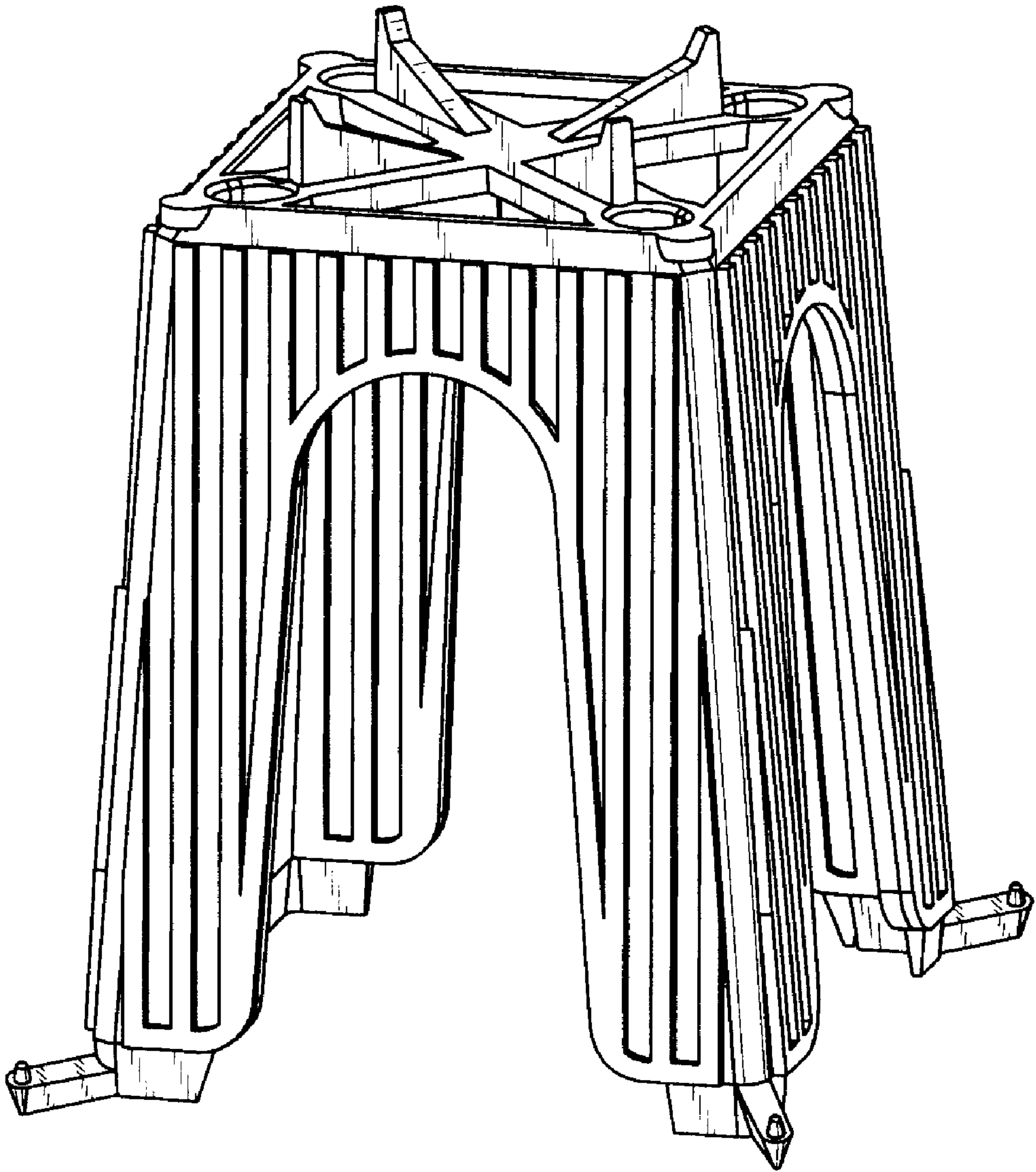

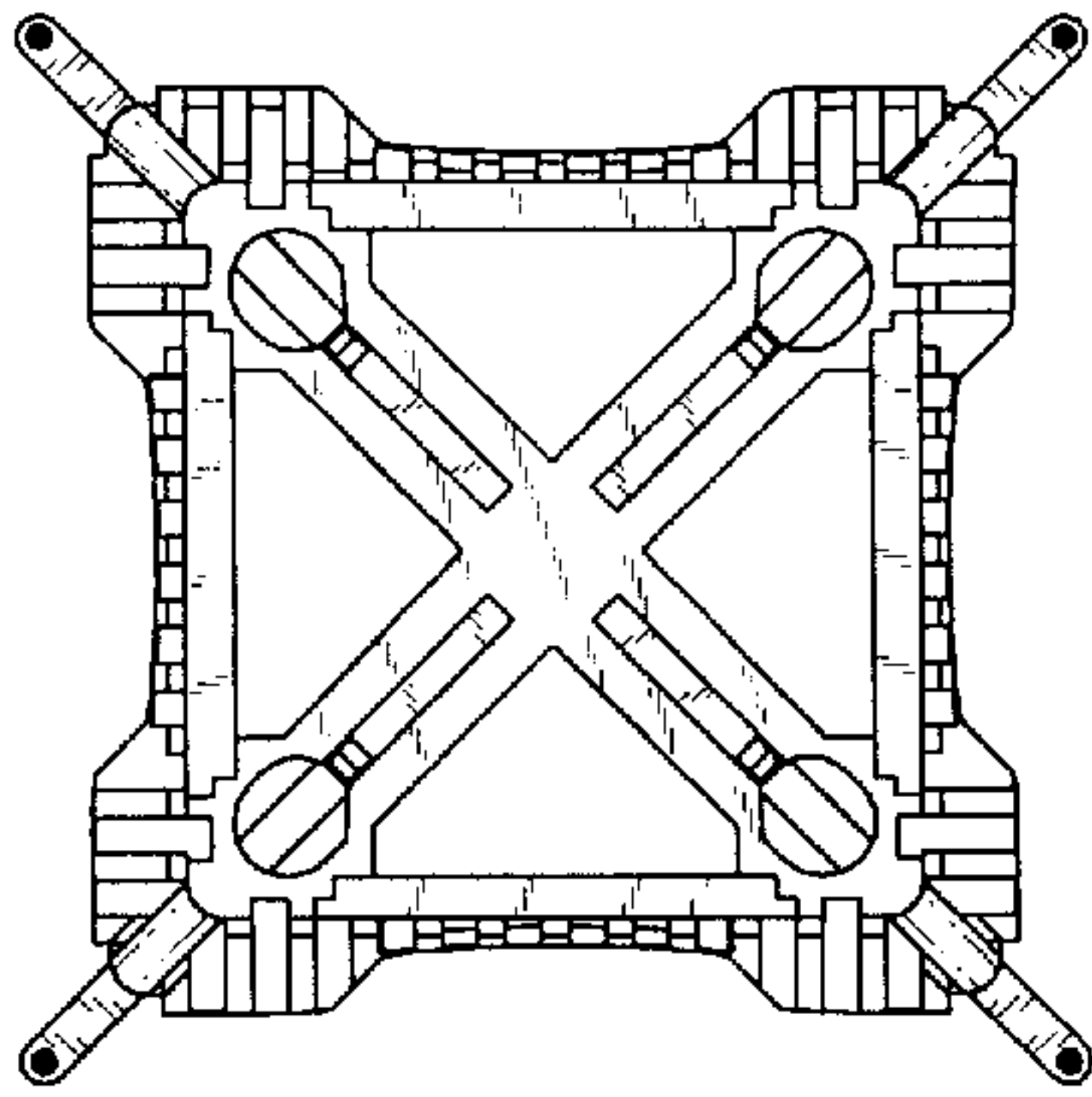

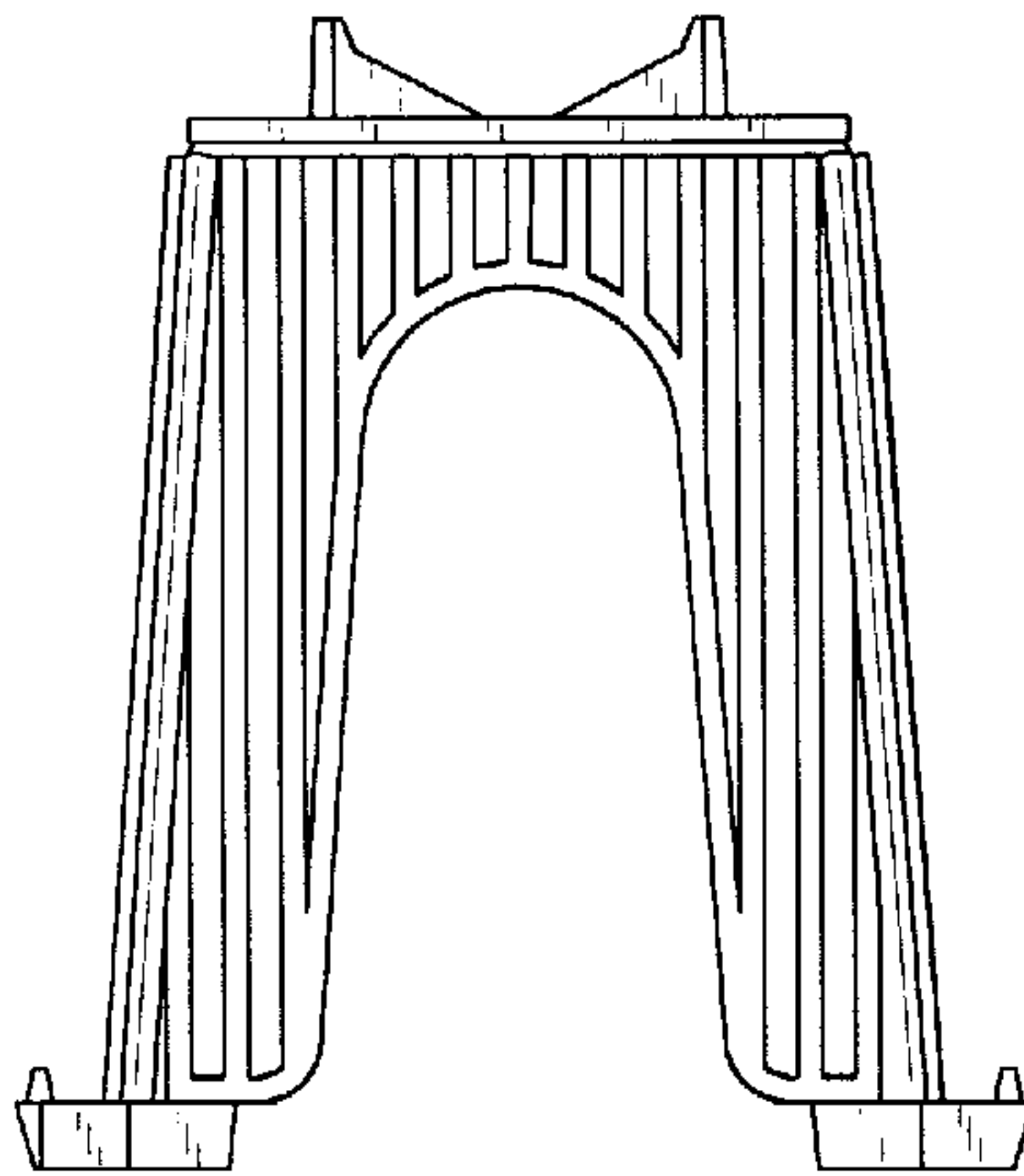

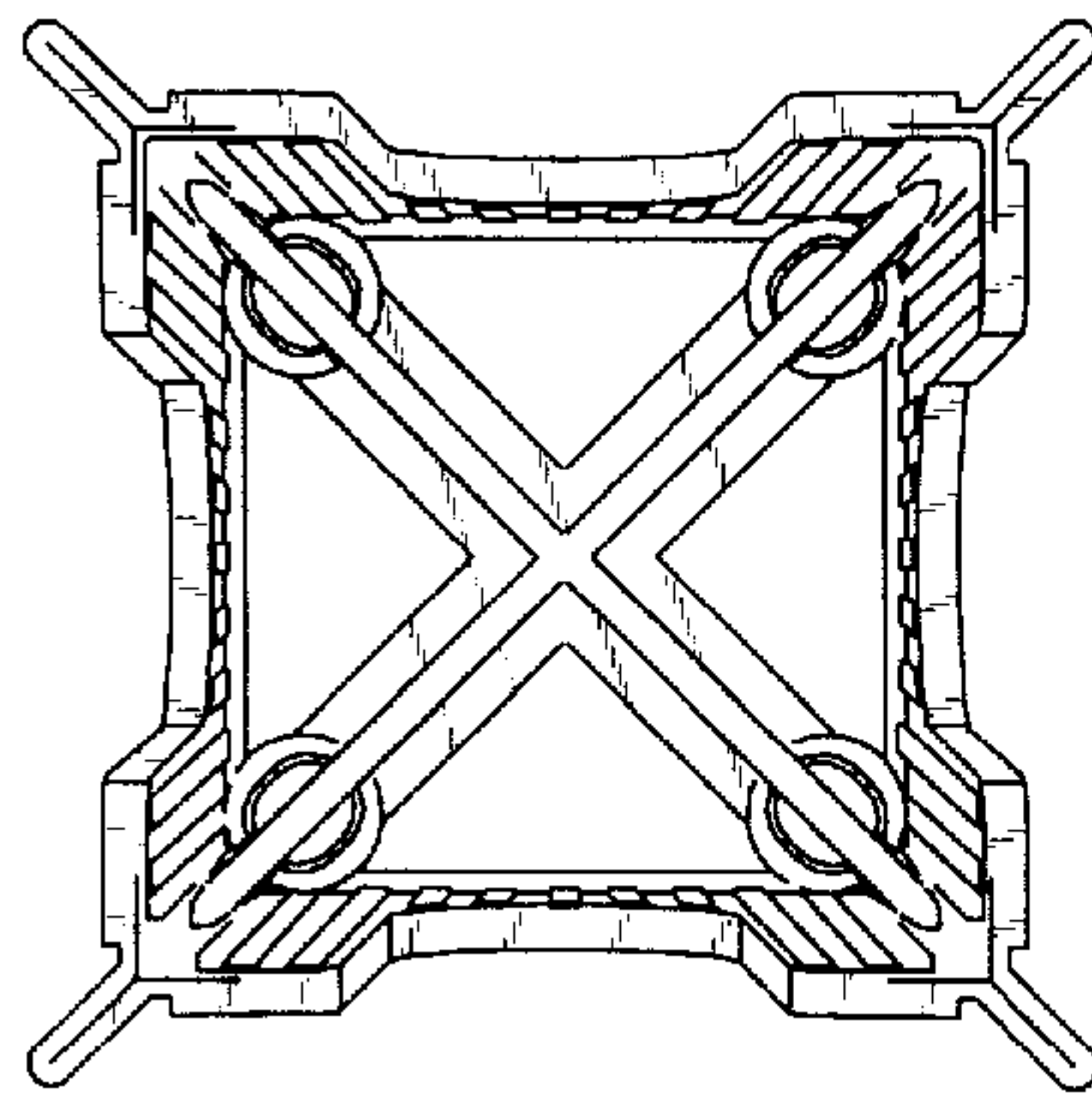

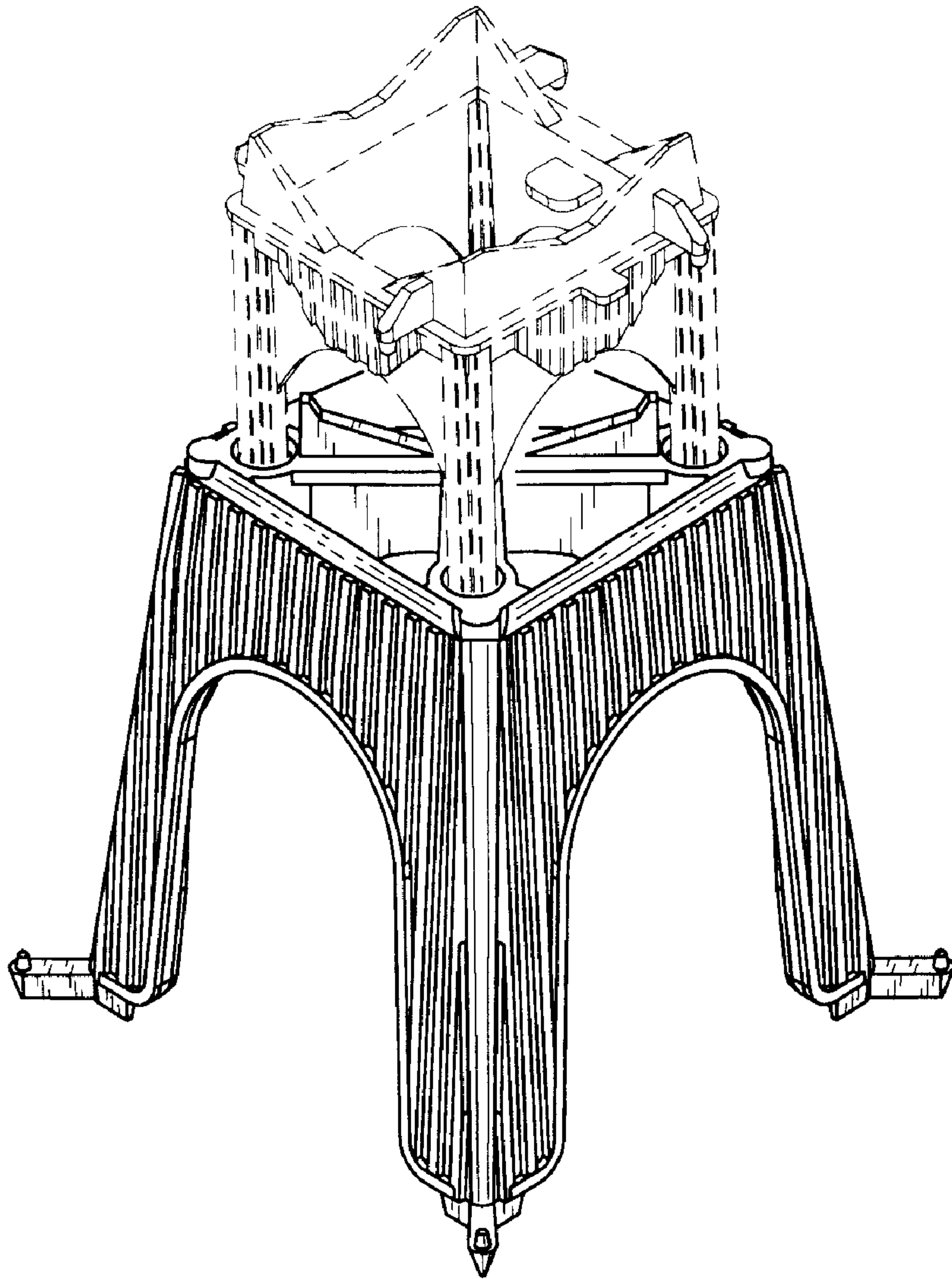
