[57] CLAIM

The ornamental design for a battery clamp, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a battery clamp showing our new design.

FIG. 2 is a top plan view of the battery clamp of FIG. 1, with the front of the clamp on the right of the figure and the rear of the clamp on the left of the figure.

FIG. 3 is a left side elevational view of the battery clamp of FIG. 1.

FIG. 4 is a rear elevational view of the battery clamp of FIG. 1.

FIG. 5 is a right side elevational view of the battery clamp of FIG. 1.

FIG. 6 is a front elevational view of the battery clamp of FIG. 1.

FIG. 7 is a bottom plan view of the battery clamp of FIG. 1.

FIG. 8 is a top perspective view of a second embodiment of a battery clamp showing our new design.

FIG. 9 is a top plan view of the battery clamp of FIG. 8, with the front of the clamp on the right of the figure and the rear of the clamp on the left of the figure.

FIG. 10 is a left side elevational view of the battery clamp of FIG. 8.

FIG. 11 is a rear elevational view of the battery clamp of FIG. 8.

FIG. 12 is a right side elevational view of the battery clamp of FIG. 8.

FIG. 13 is a front elevational view of the battery clamp of FIG. 8; and,

FIG. 14 is a bottom plan view of the battery clamp of FIG. 8.

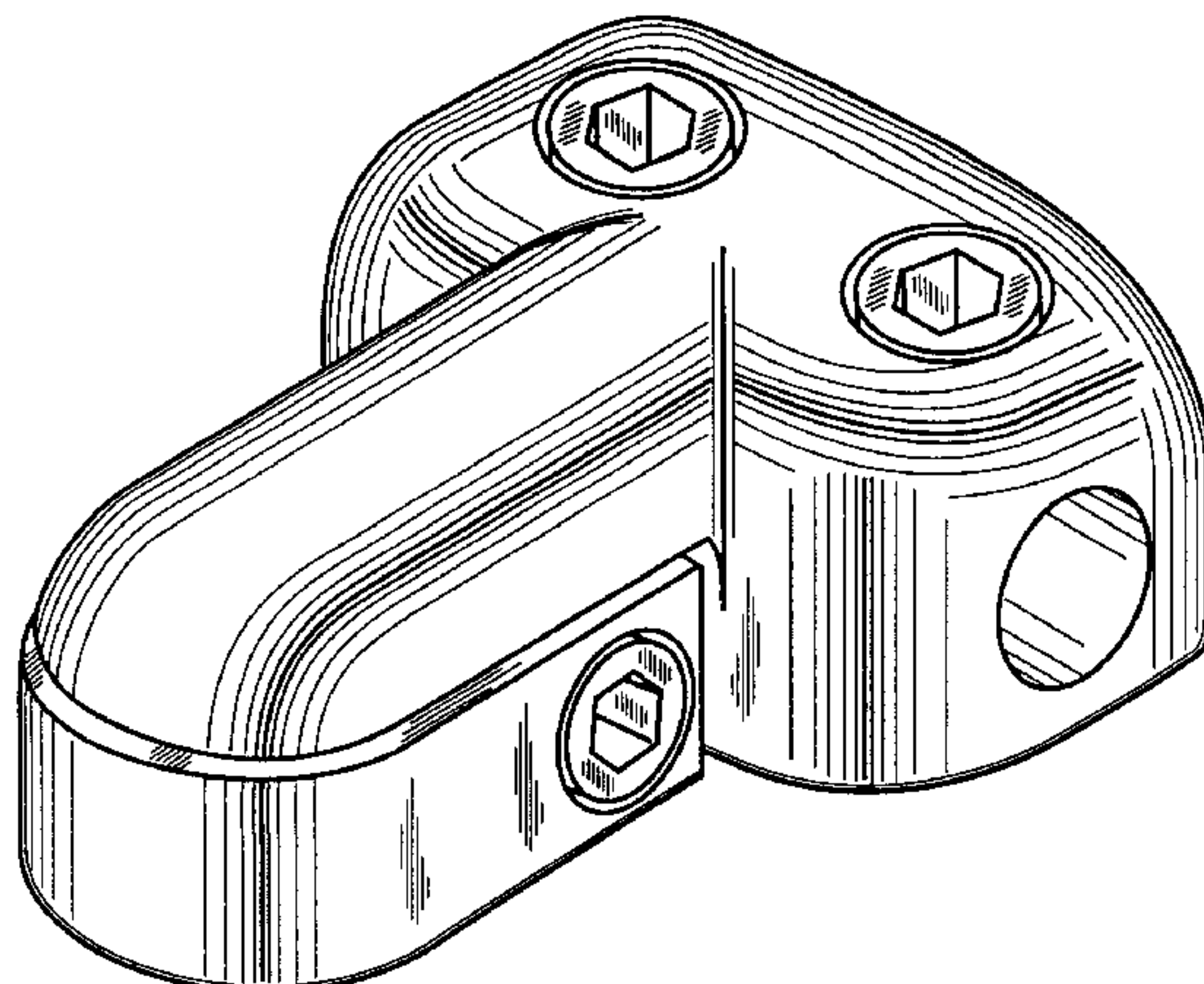

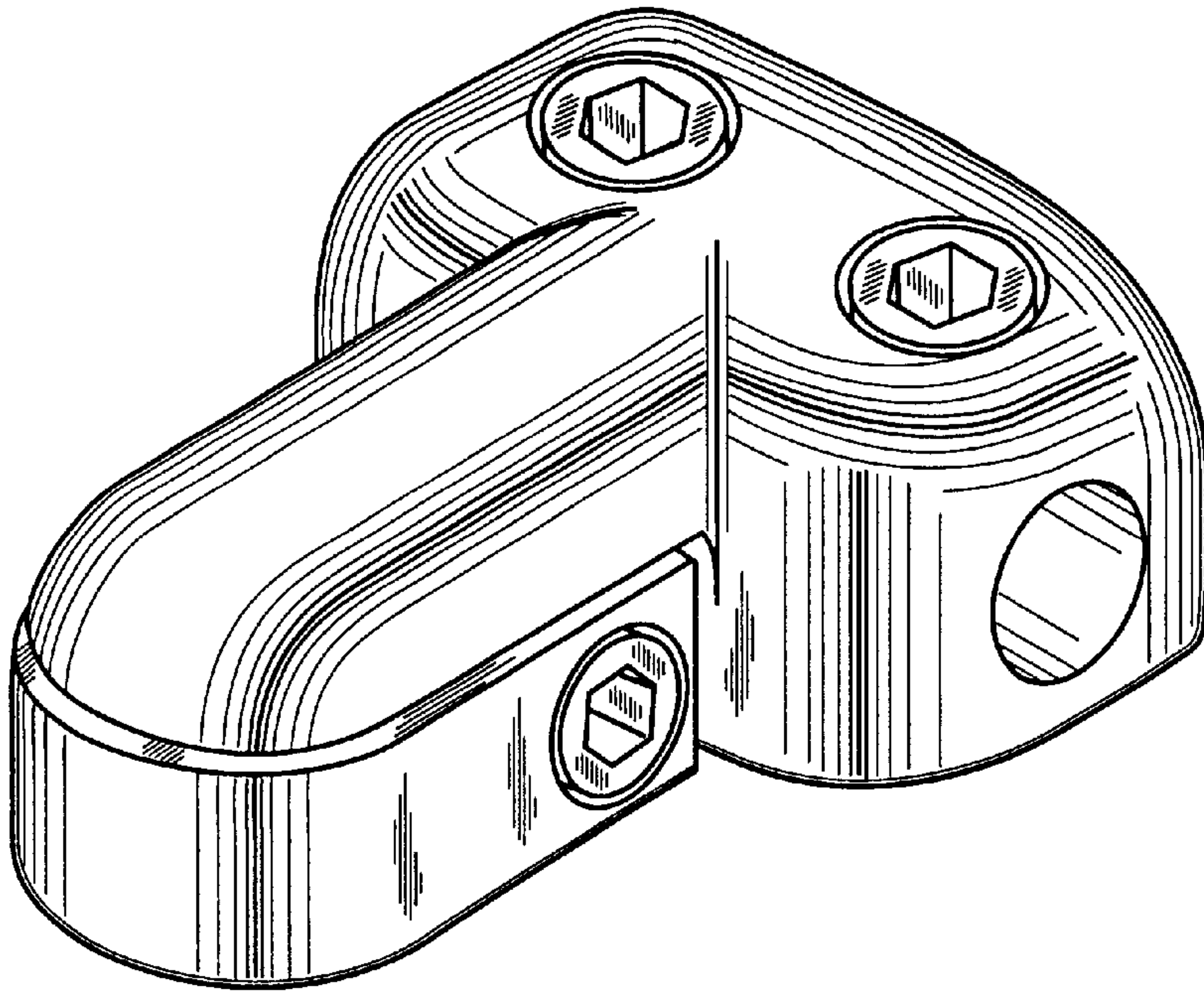

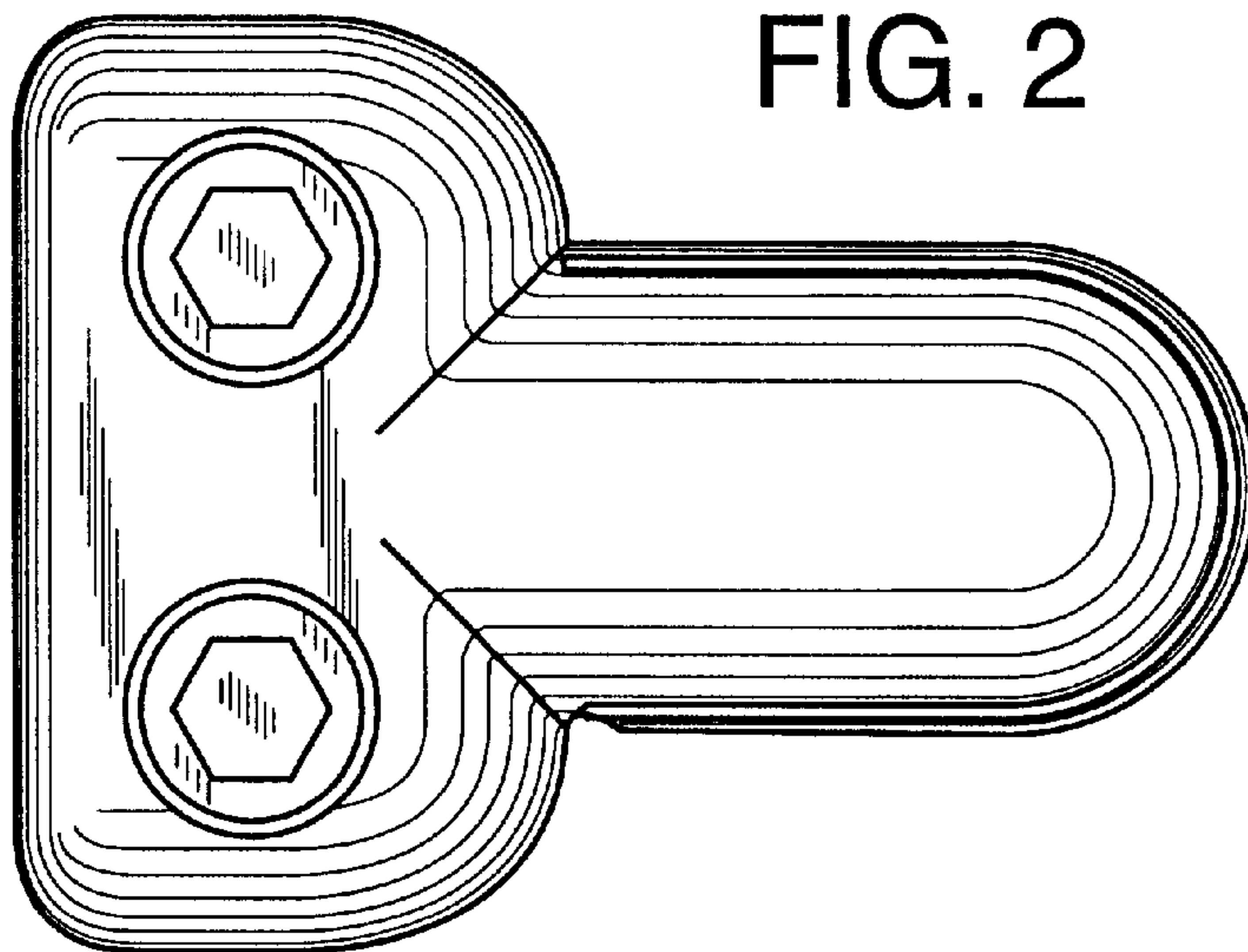

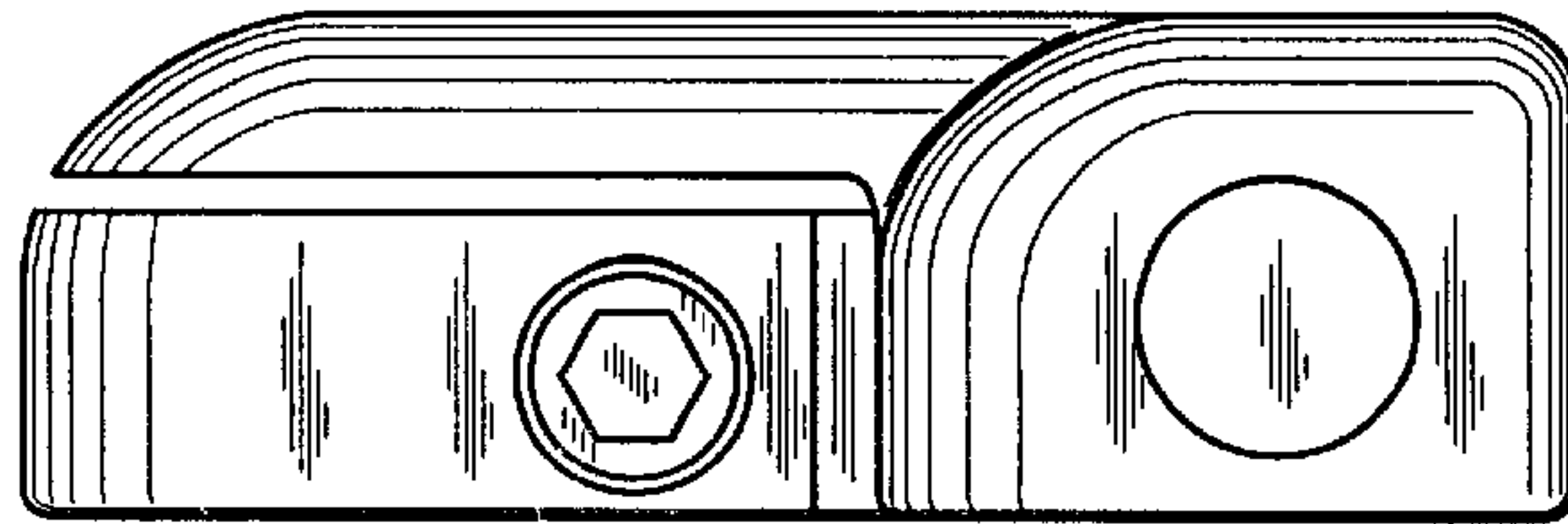

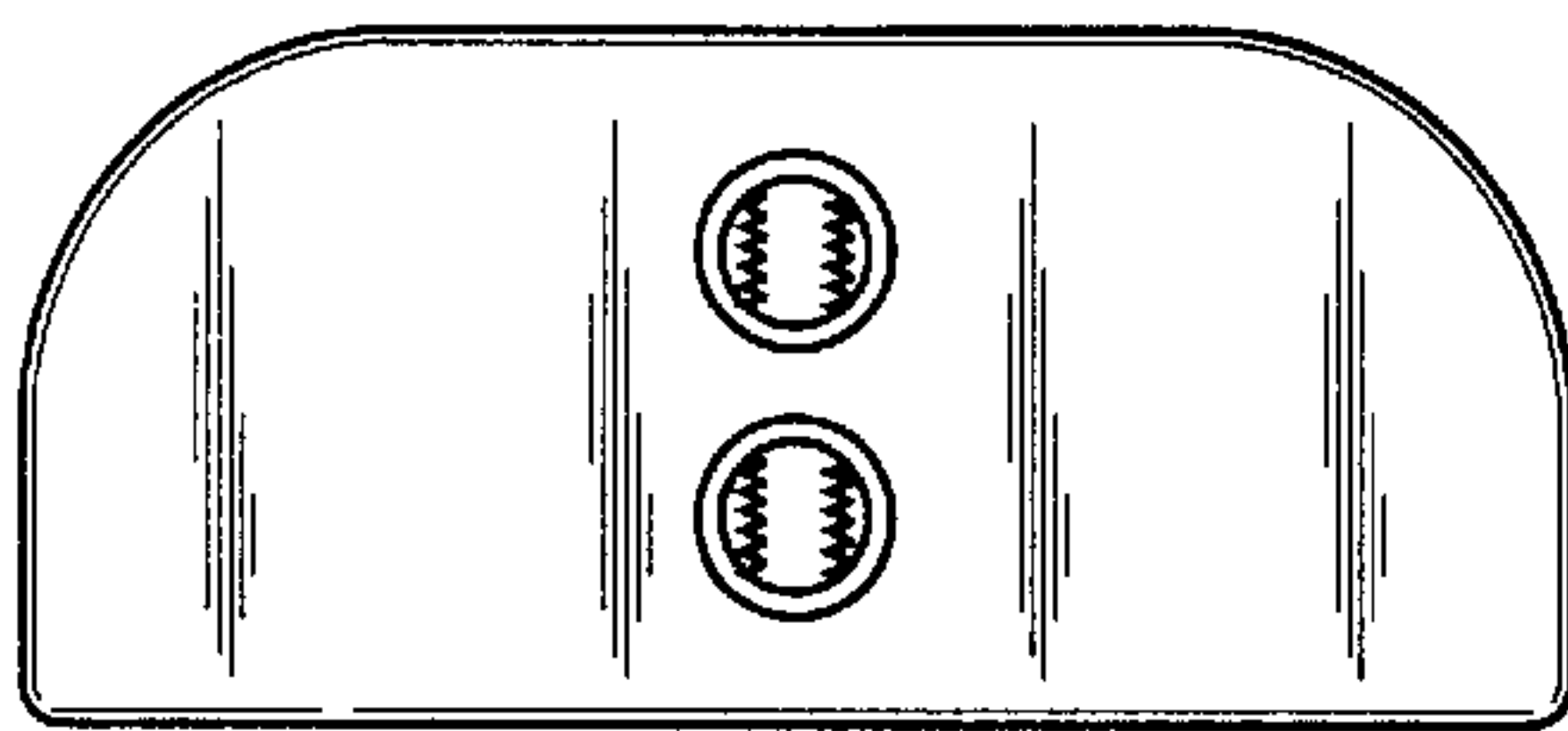

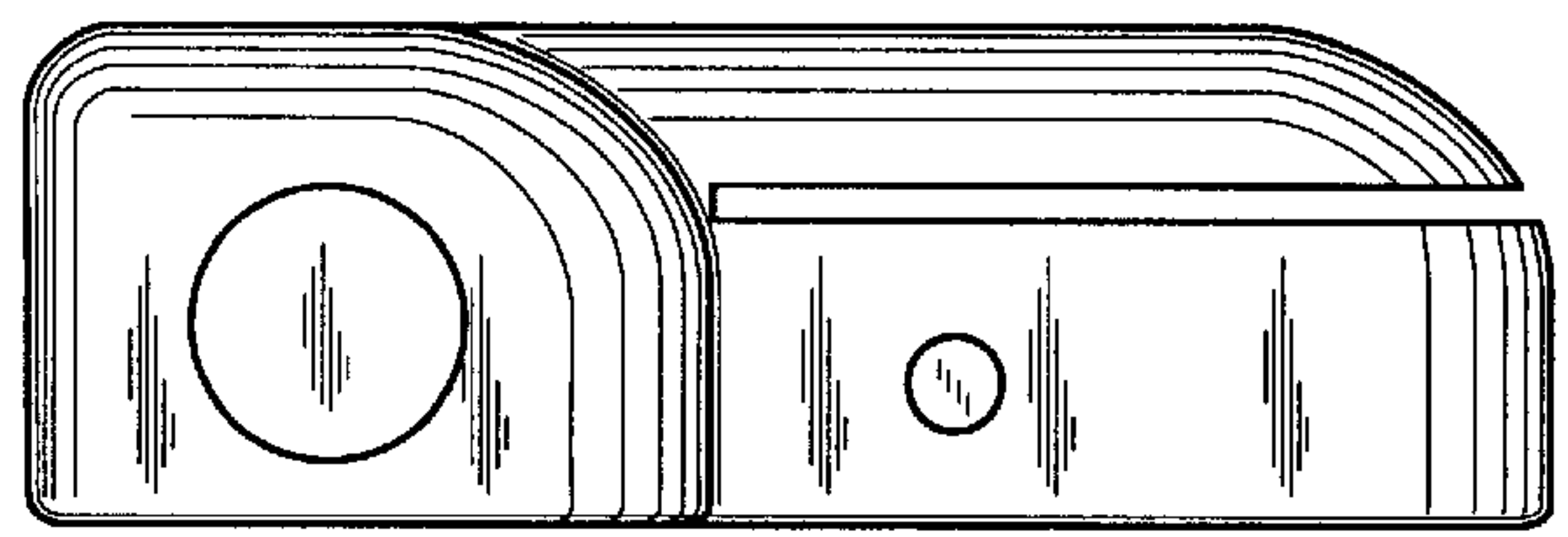

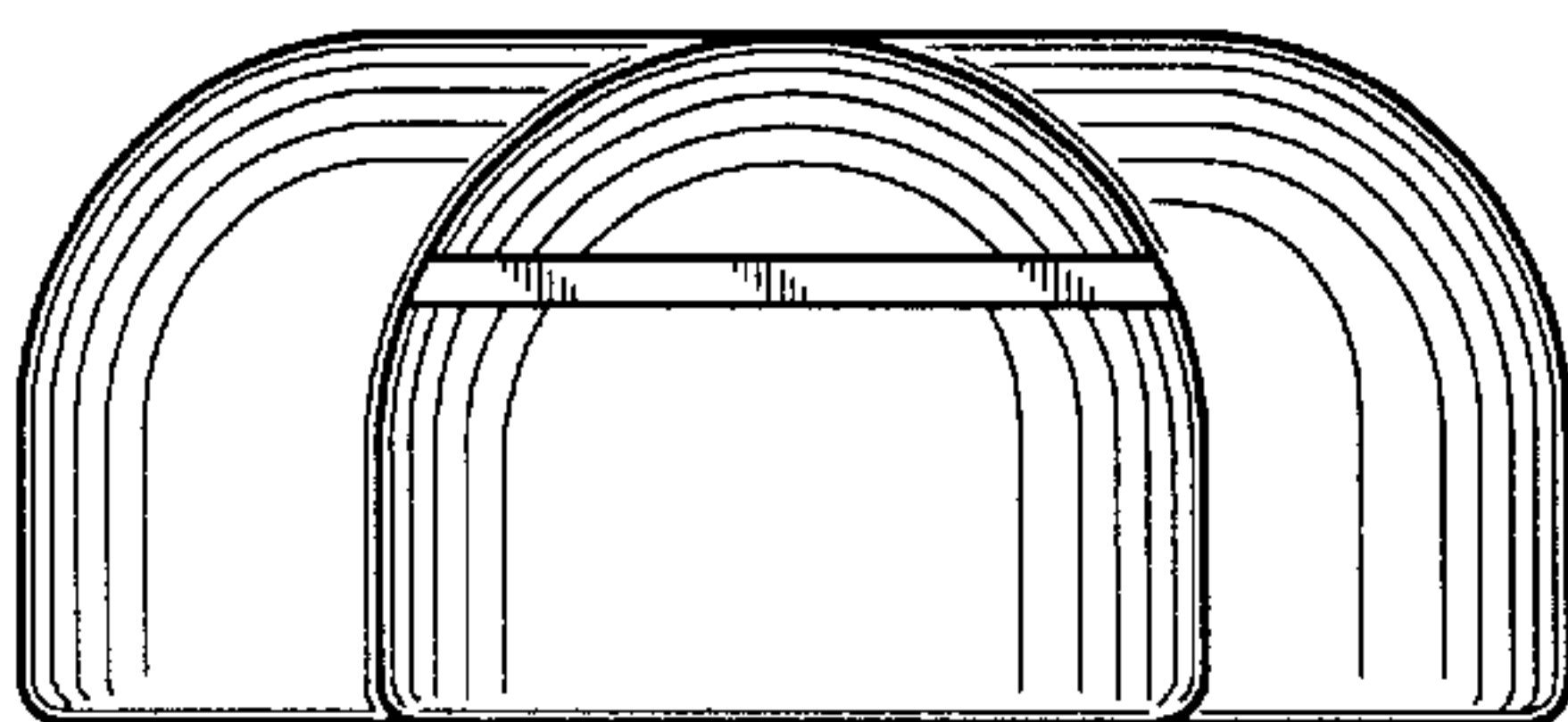

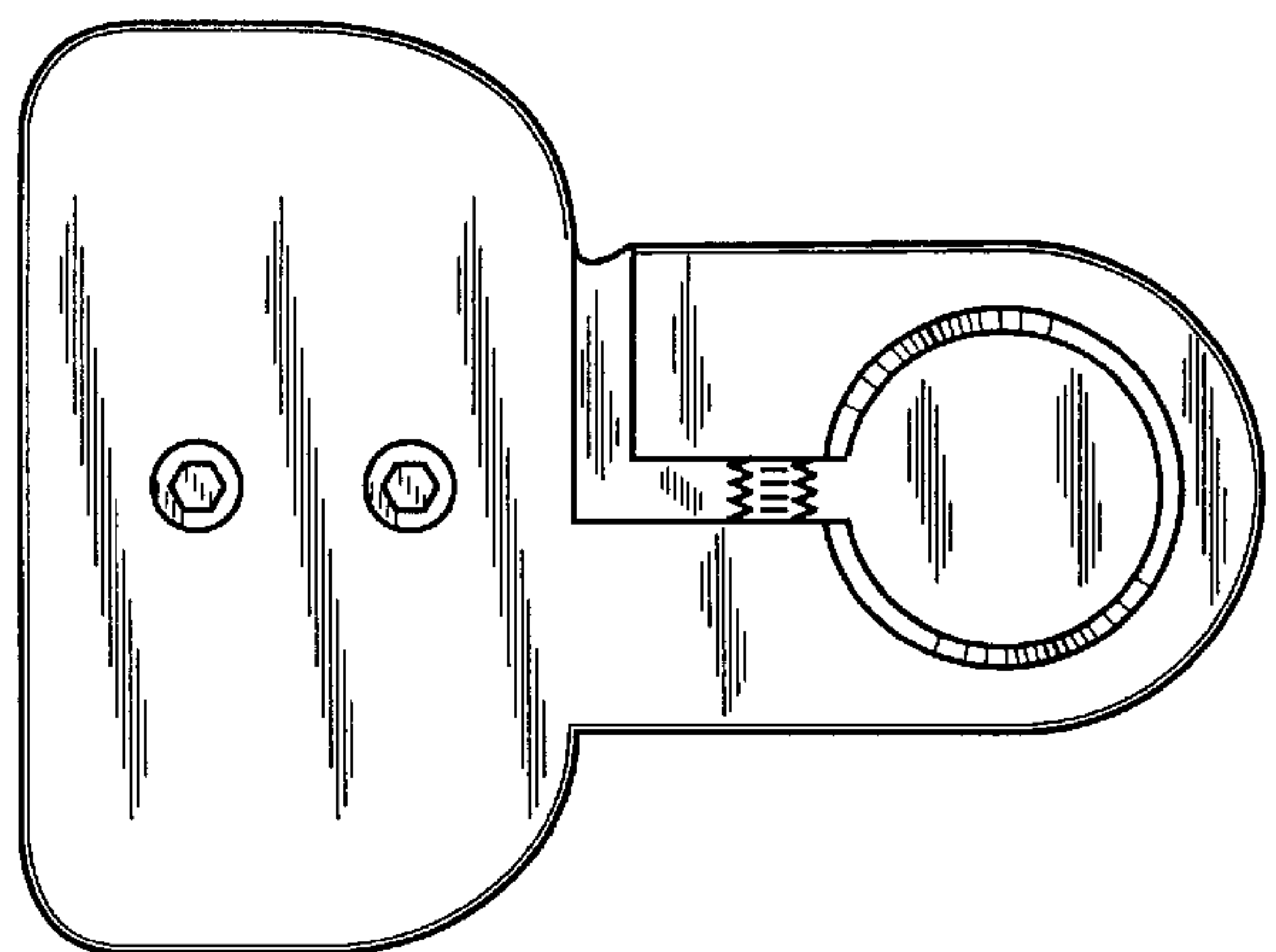

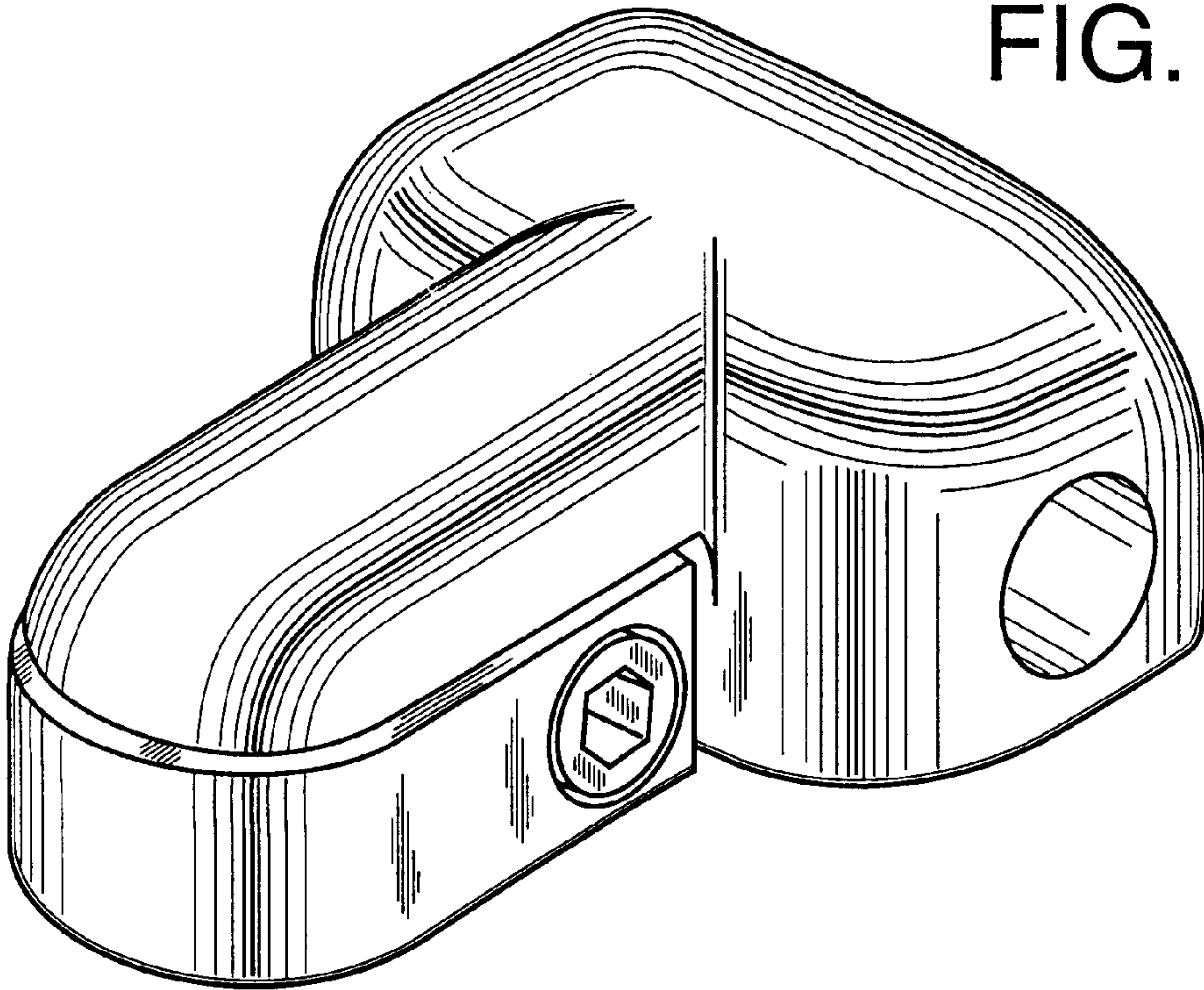

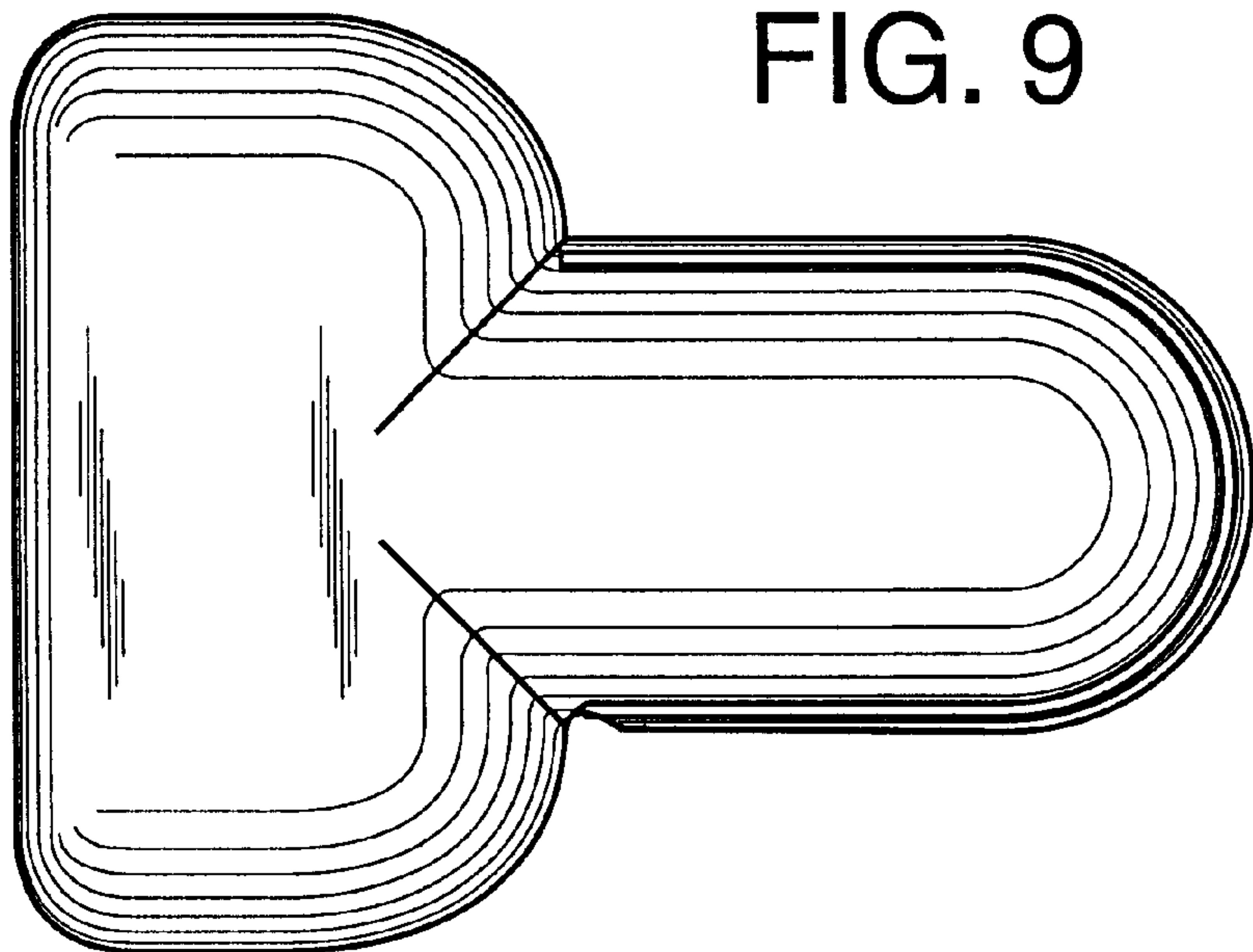

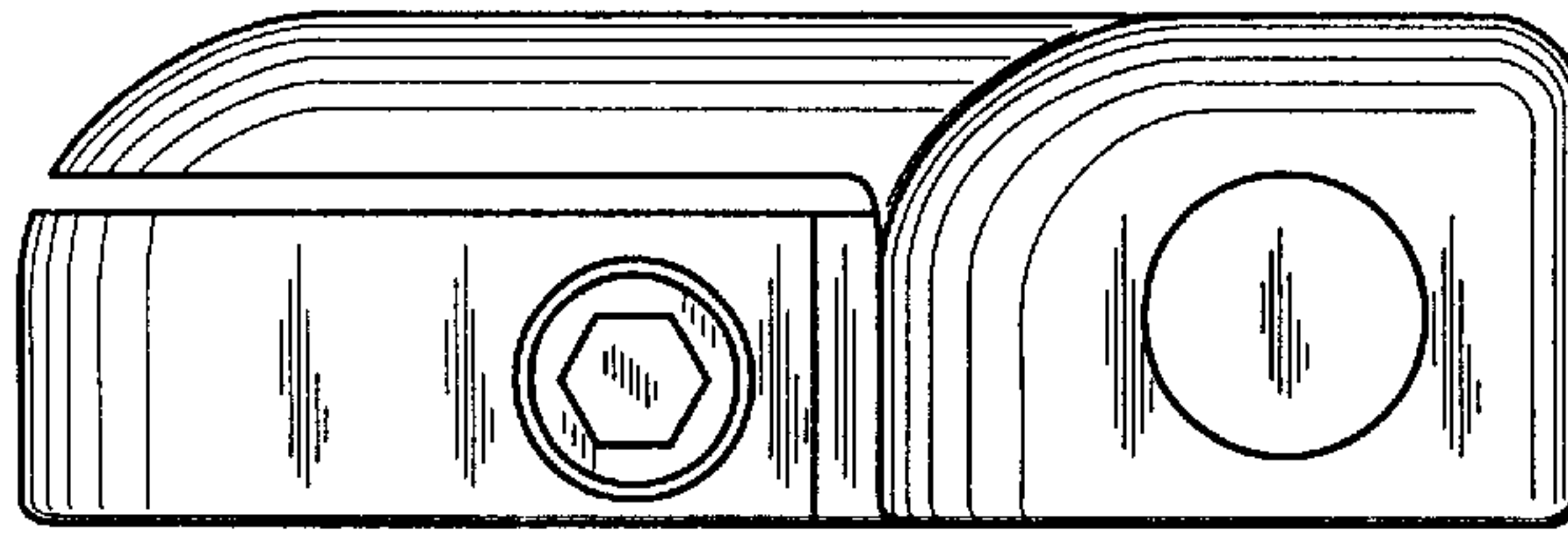

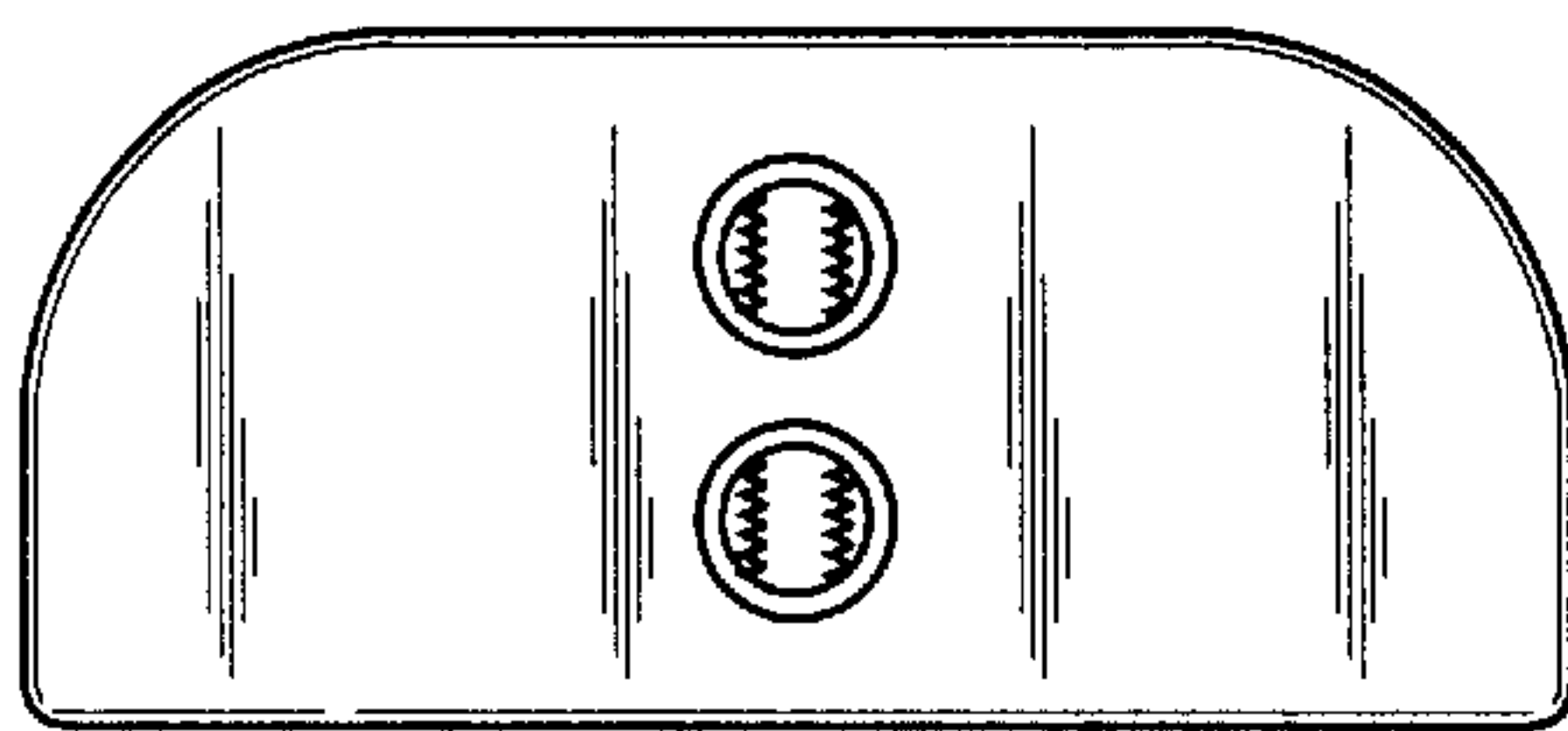

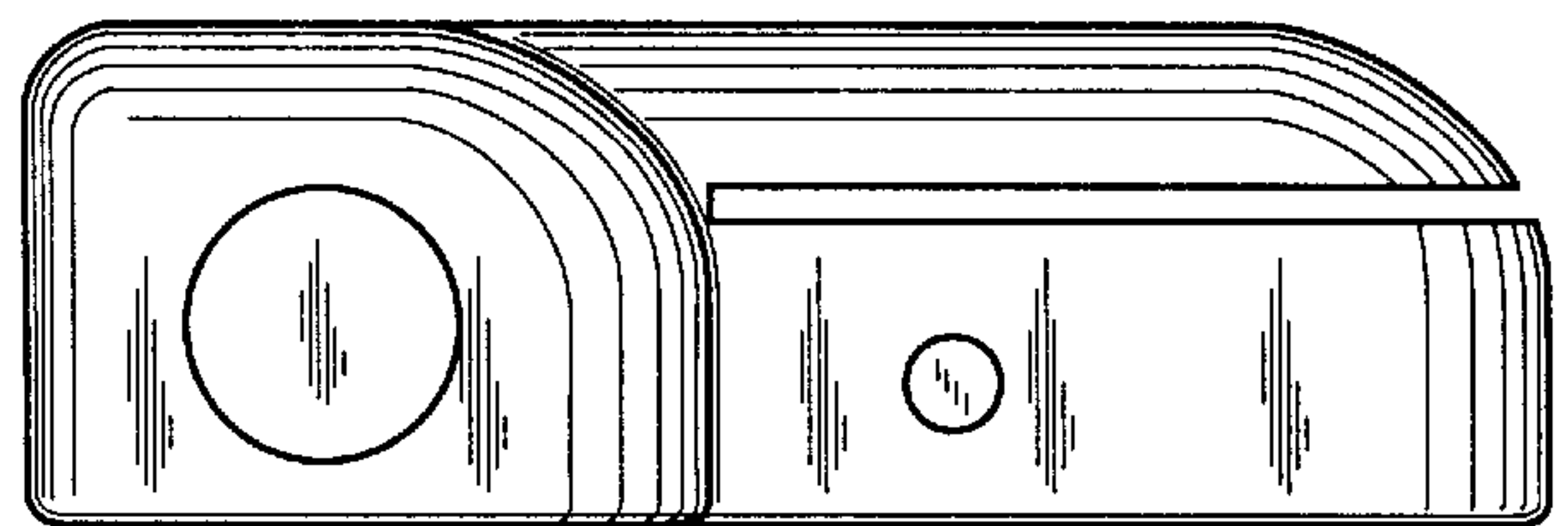

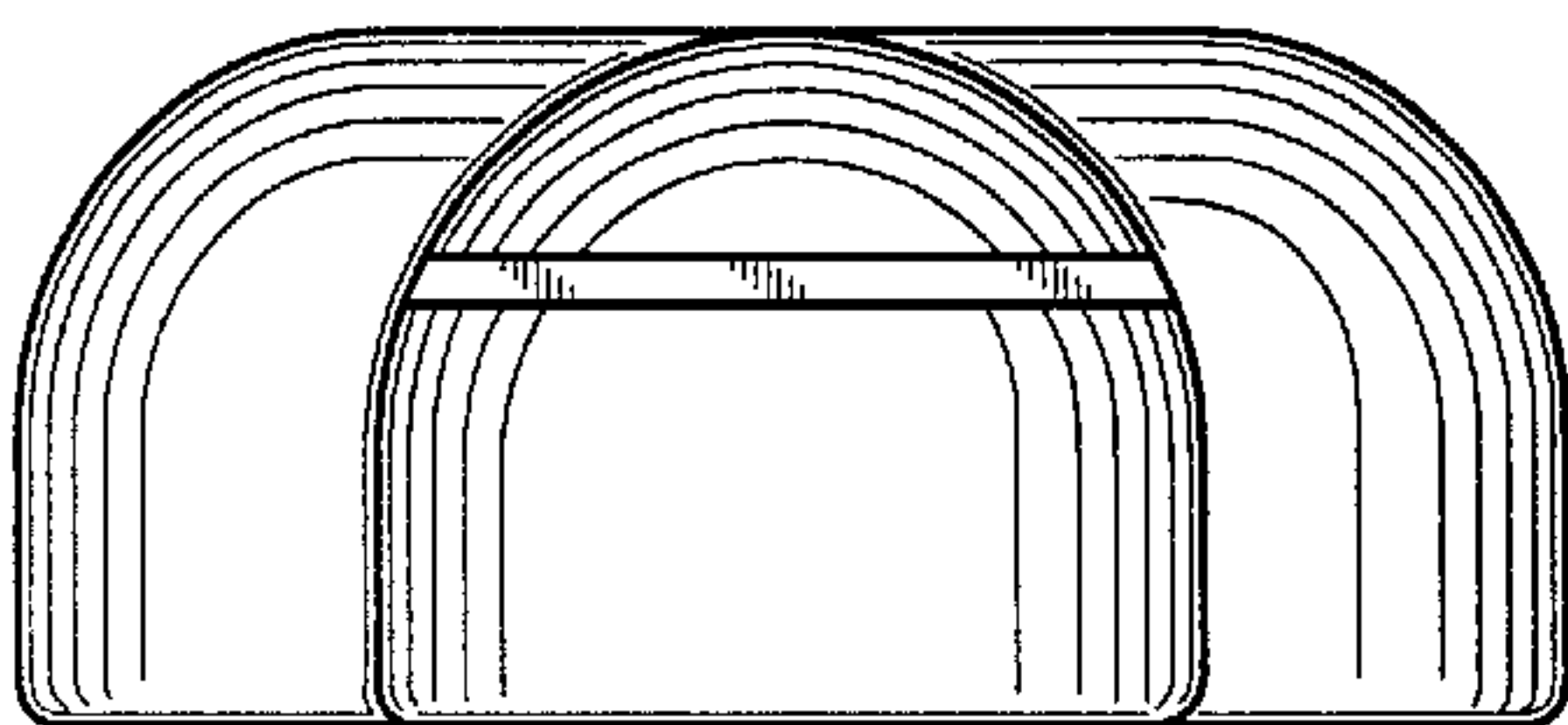
