The ornamental design for a golf club shaft, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf club shaft showing the first embodiment of my new design;  
FIG. 2 is a left side elevational view thereof.

FIG. 4 is a top plan view thereof;

FIG. 18 is a bottom plan view thereof;  
FIG. 19 is a right side elevational view thereof;  
FIG. 20 is a front elevational view thereof; and  
FIG. 21 is a rear elevational view thereof; and  
FIG. 22 is a perspective view of a golf club shaft showing the fourth embodiment of my new design;  
FIG. 23 is a left side elevational view thereof.  
FIG. 24 is a top plan view thereof.  
FIG. 25 is a bottom plan view thereof;  
FIG. 26 is a right side elevational view thereof;  
FIG. 27 is a front elevational view thereof; and,  
FIG. 28 is a rear elevational view thereof.  
The broken line showing the golf club head and grip is for illustrative purposes only and forms no part of the claimed design.

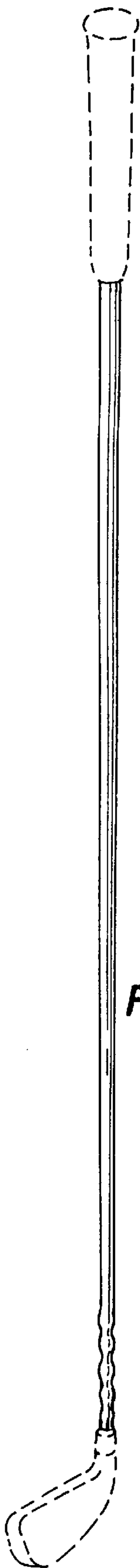

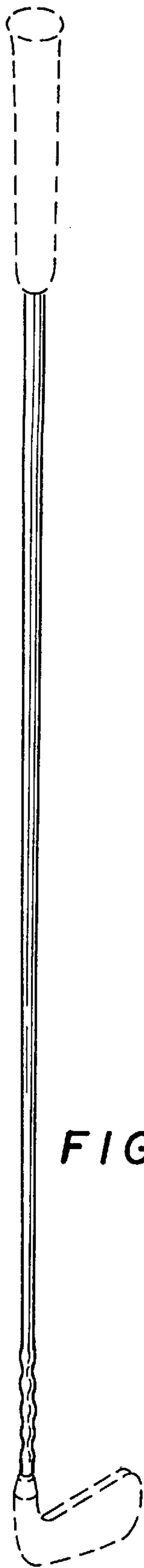

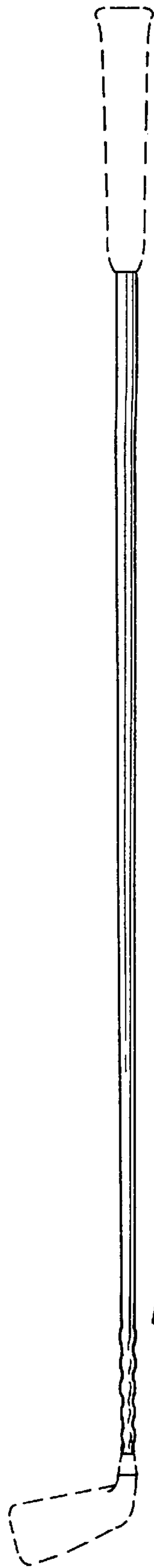

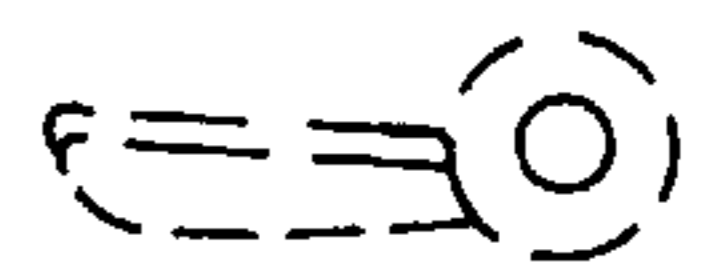

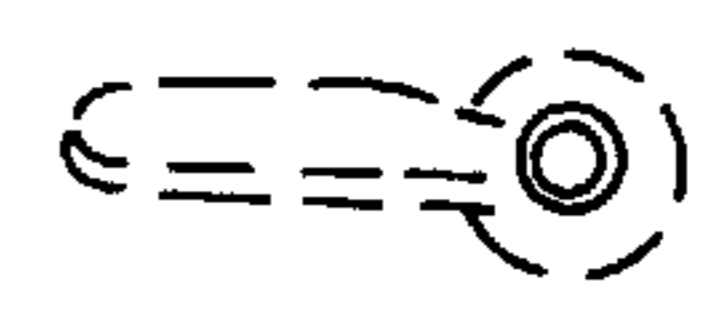

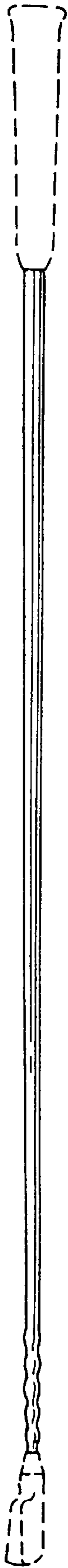

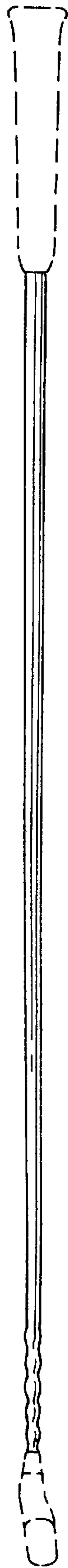

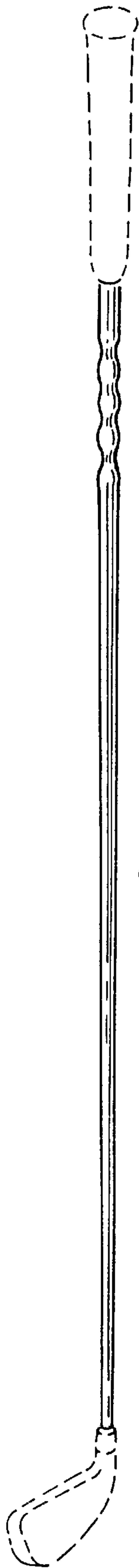

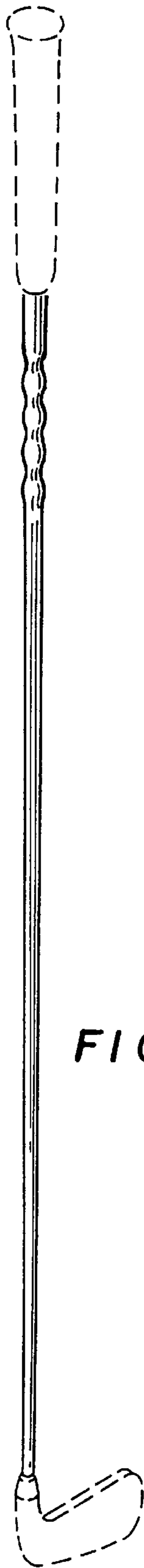

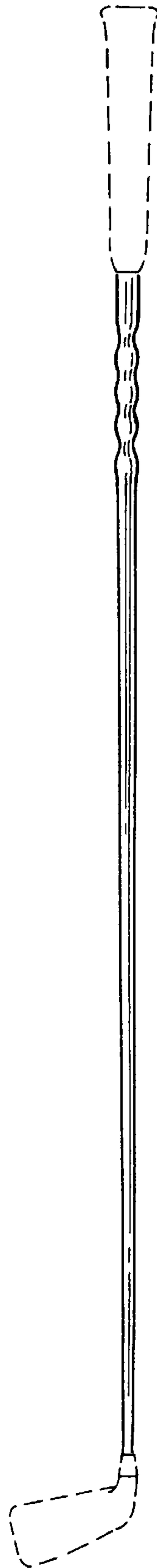

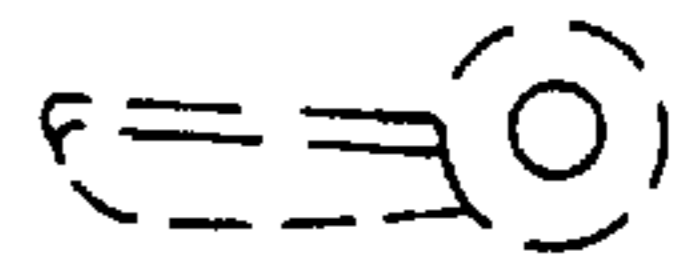

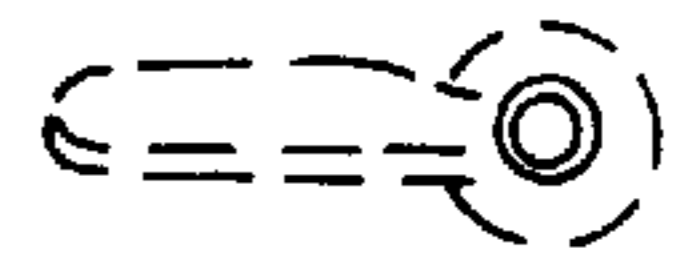

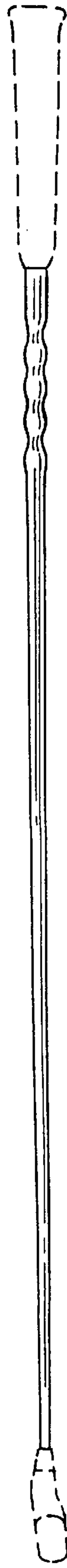

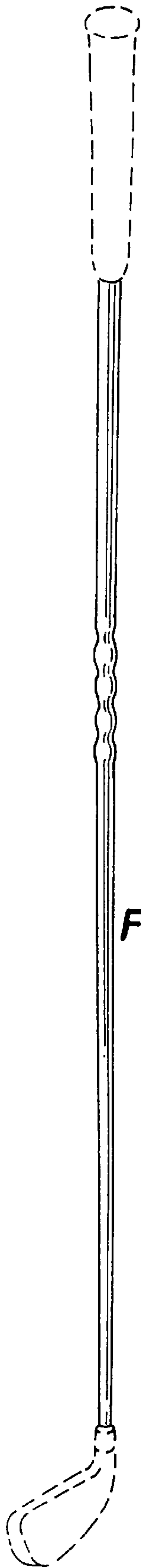

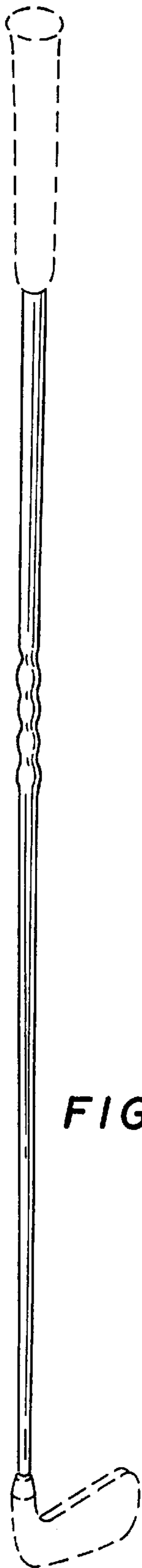

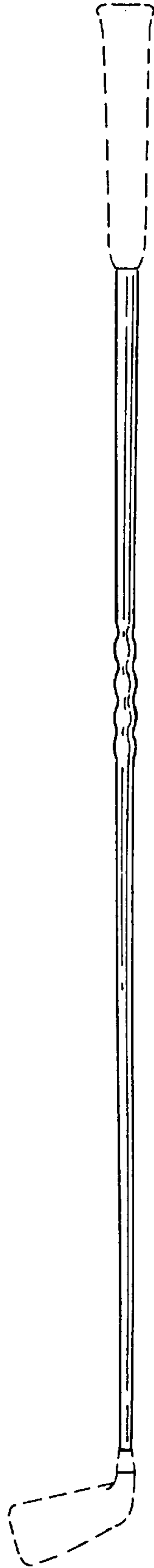

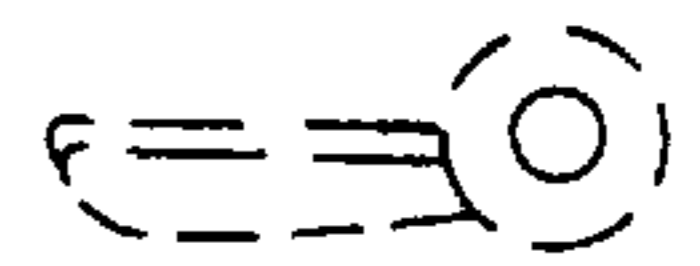

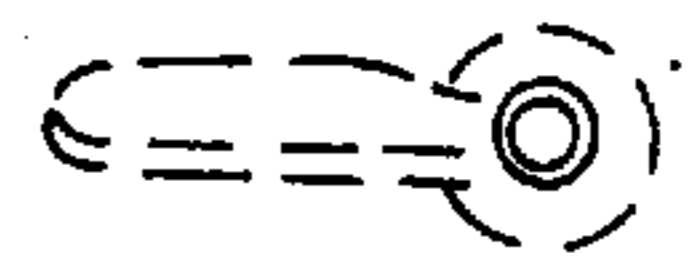

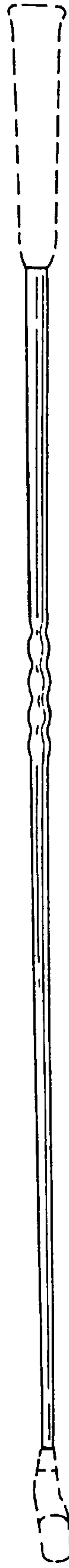

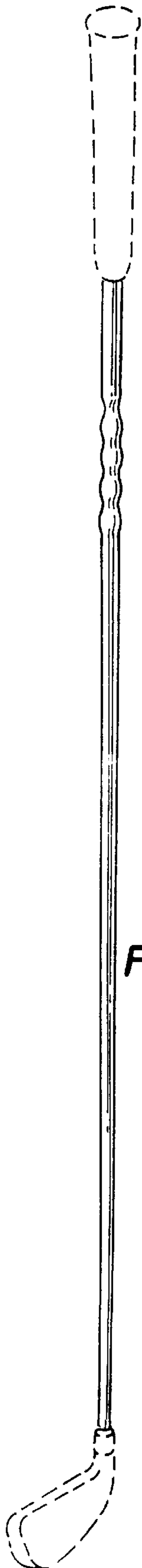

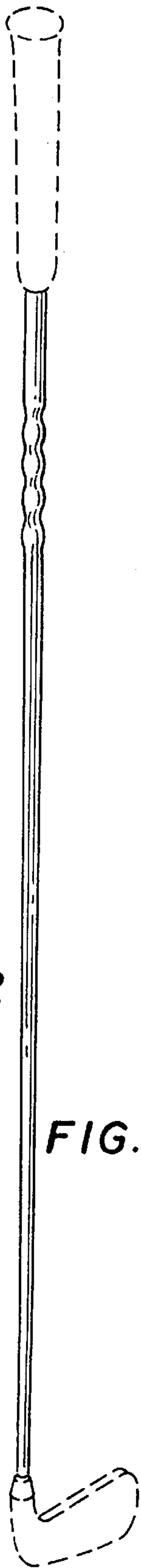

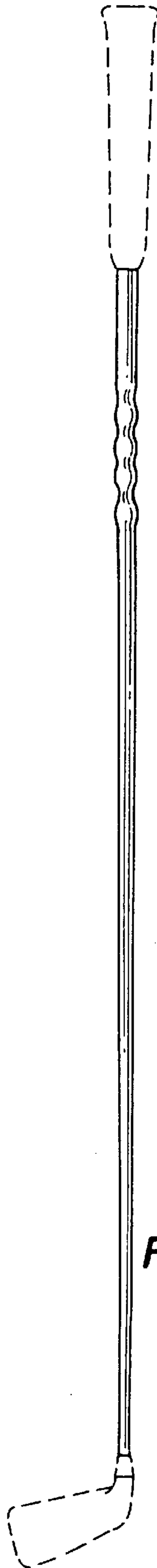

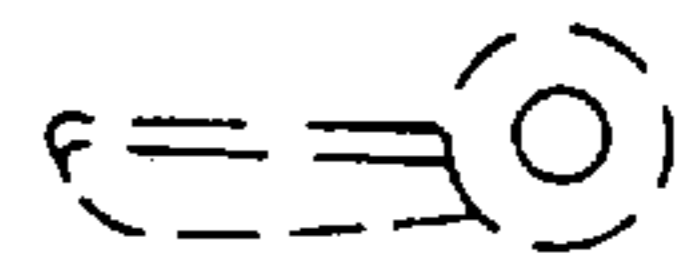

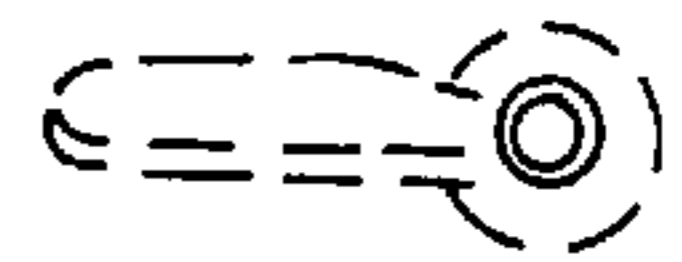

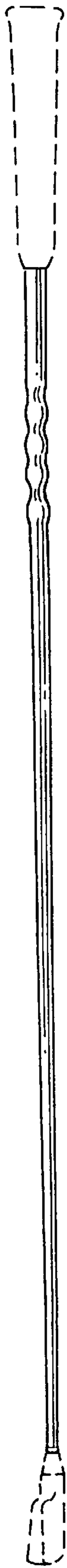

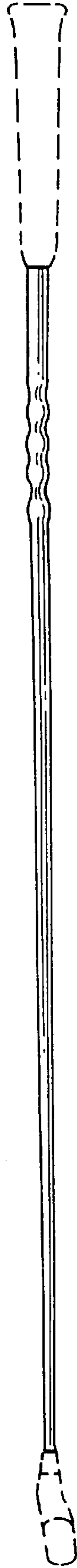
