DESCRIPTION

FIG. 1 is a perspective view of the front, top and side of our new design;

FIG. 2 is a left side elevation view of our new design;

FIG. 3 is a right side elevation view of our new design;

FIG. 4 is a bottom plan view of our new design;

FIG. 5 is a top plan view of our new design;

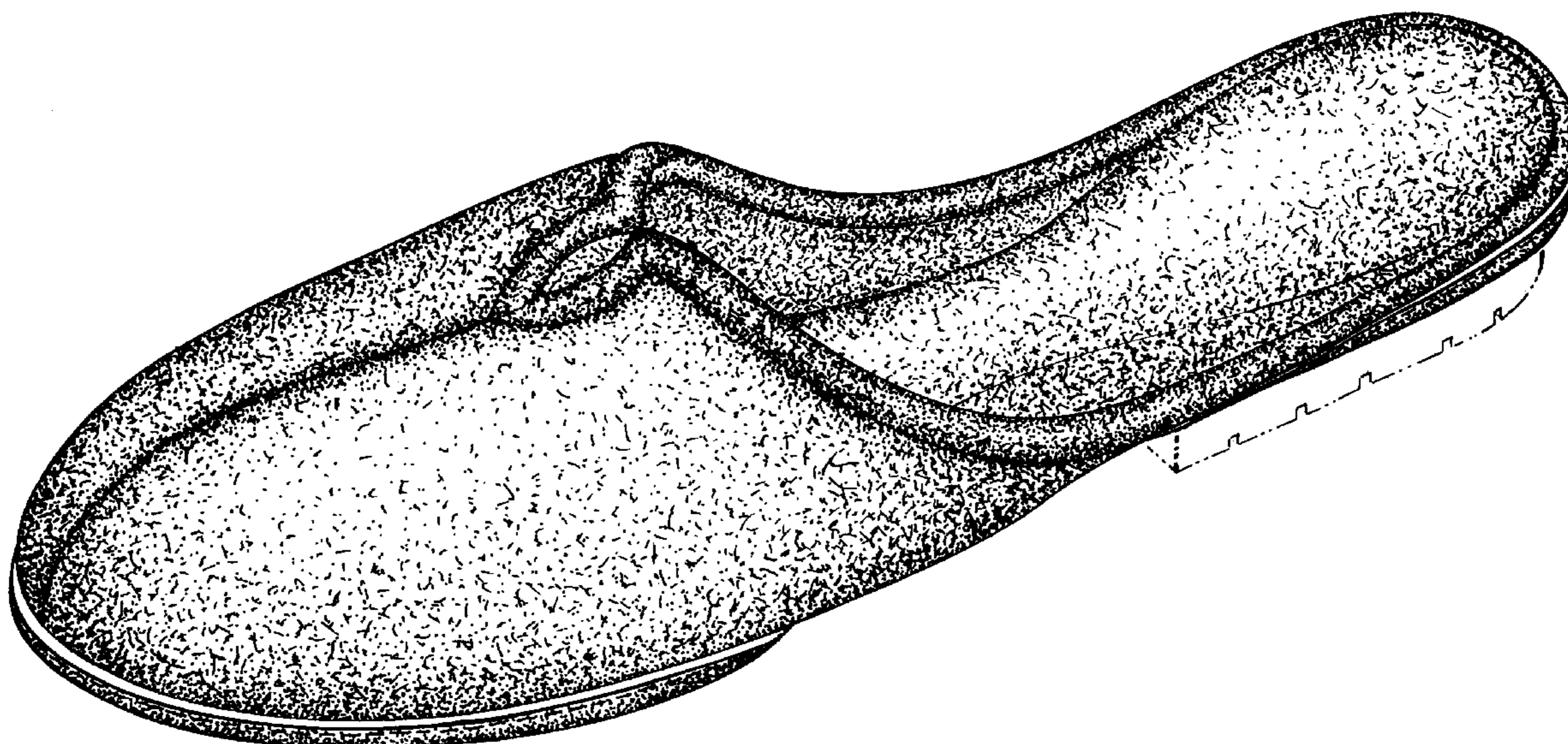
FIG. 6 is a front elevation view of our new design; and,

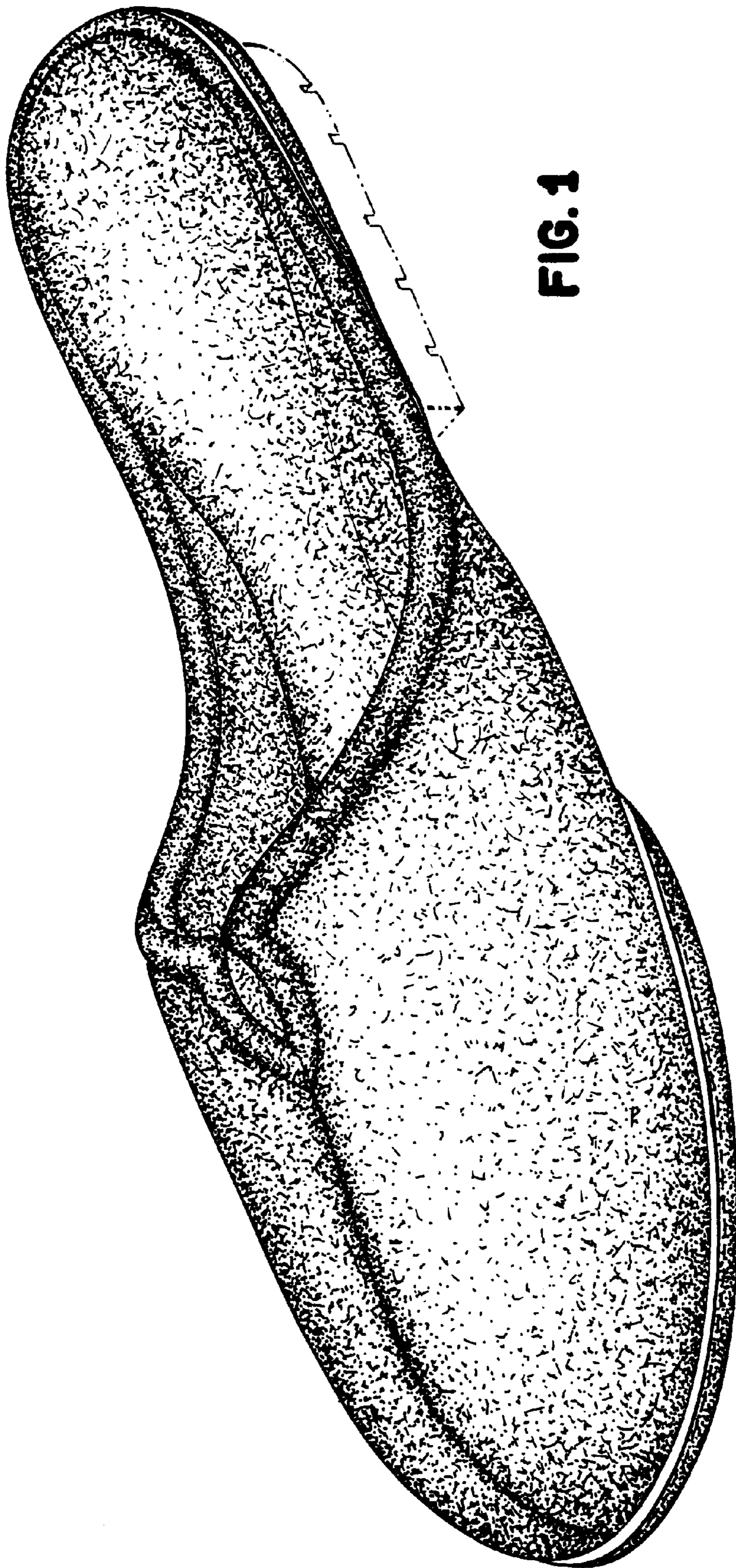

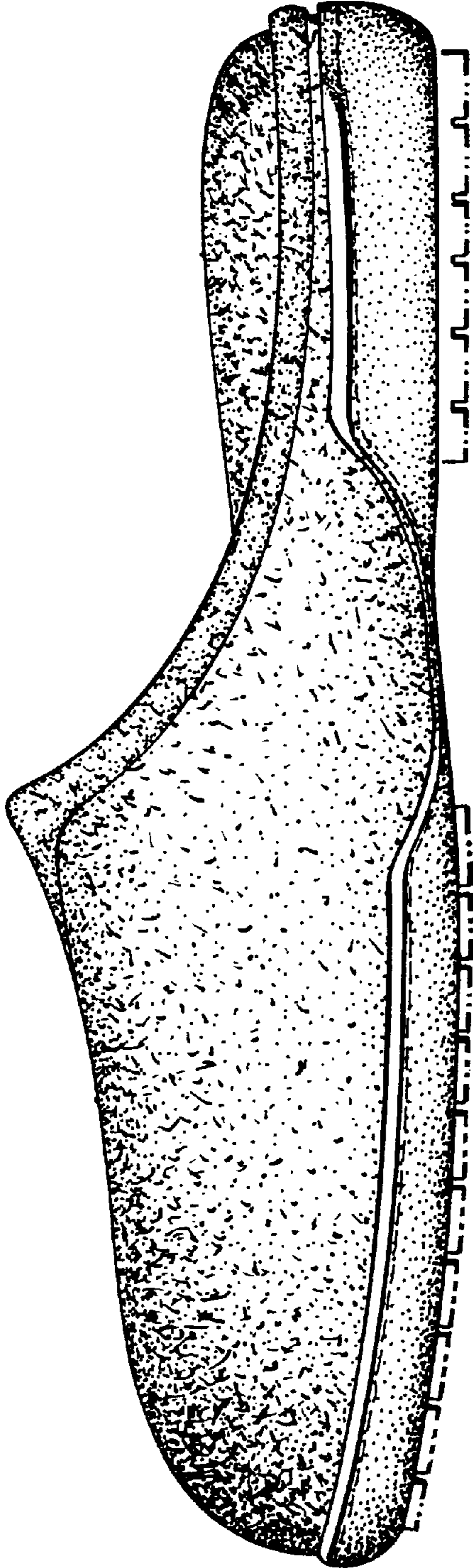

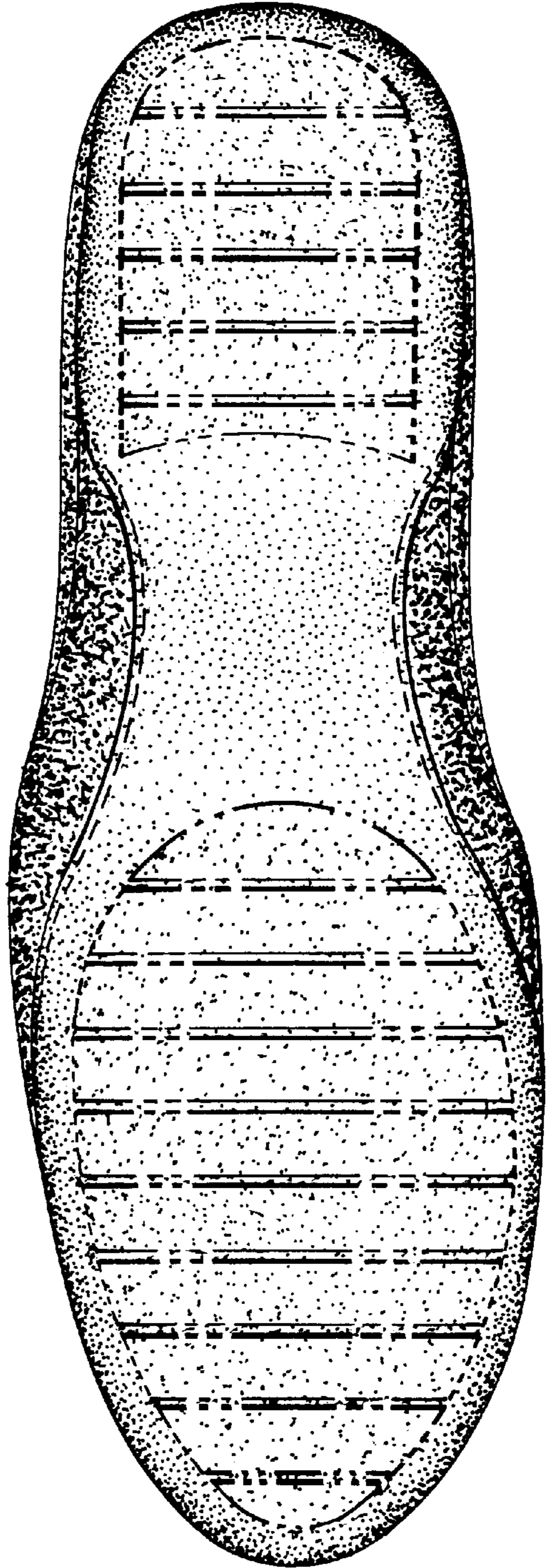

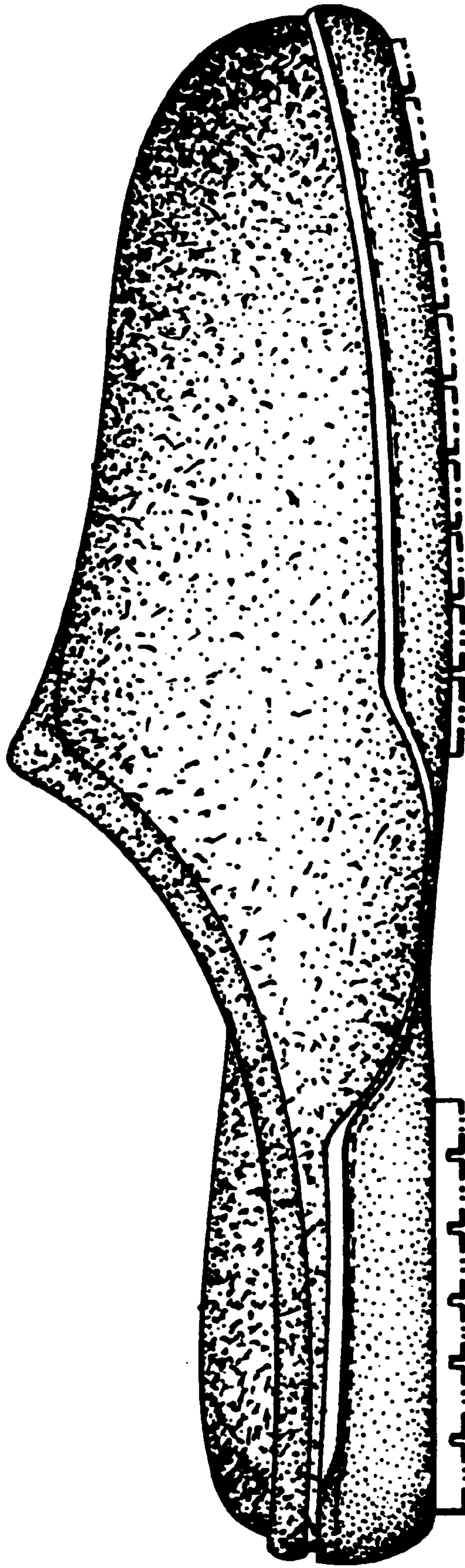

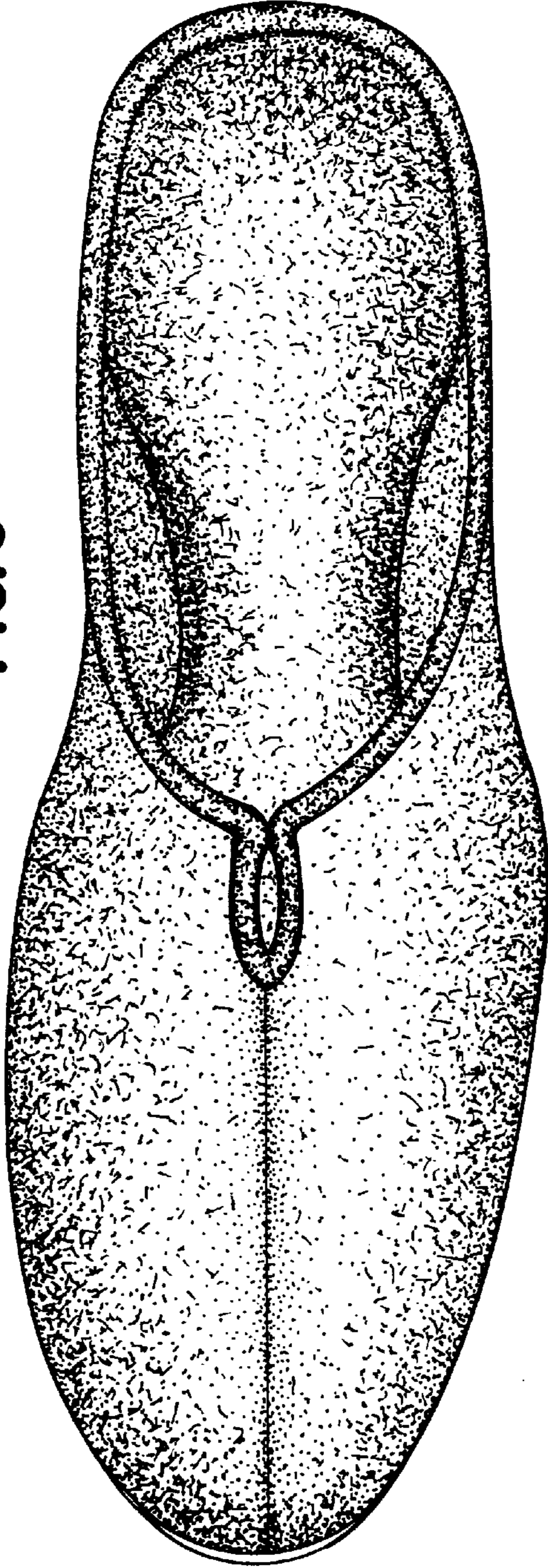

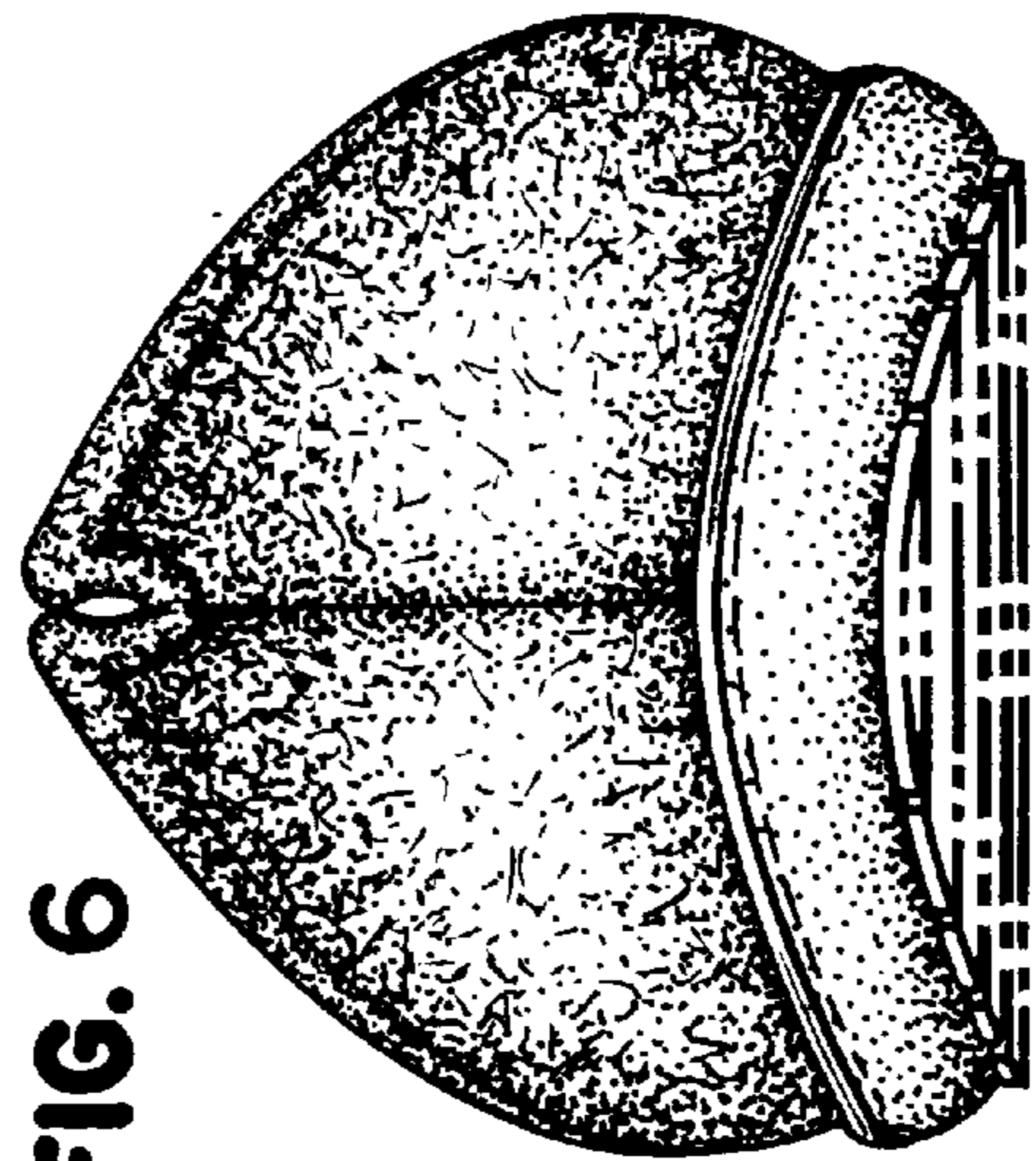
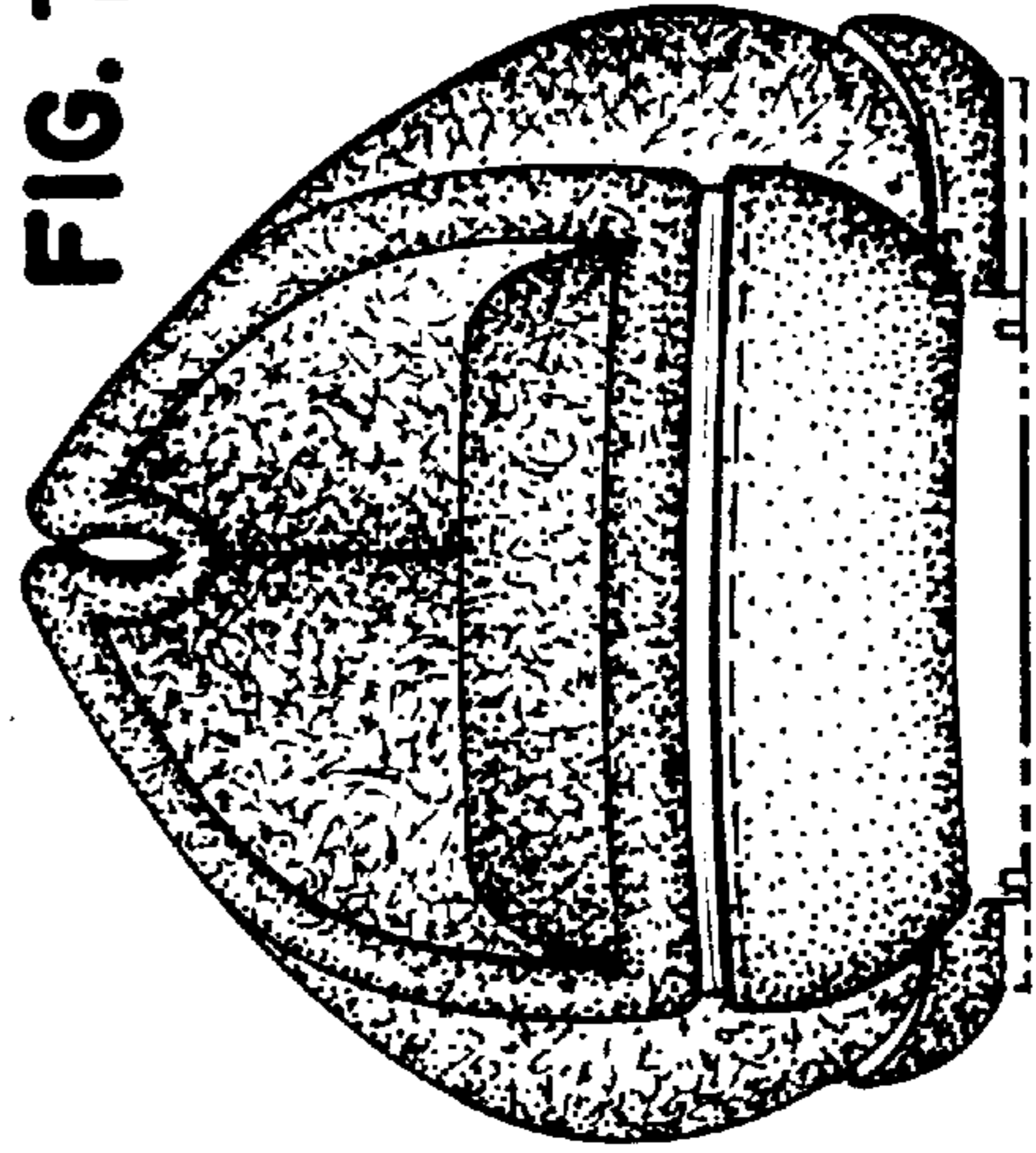
