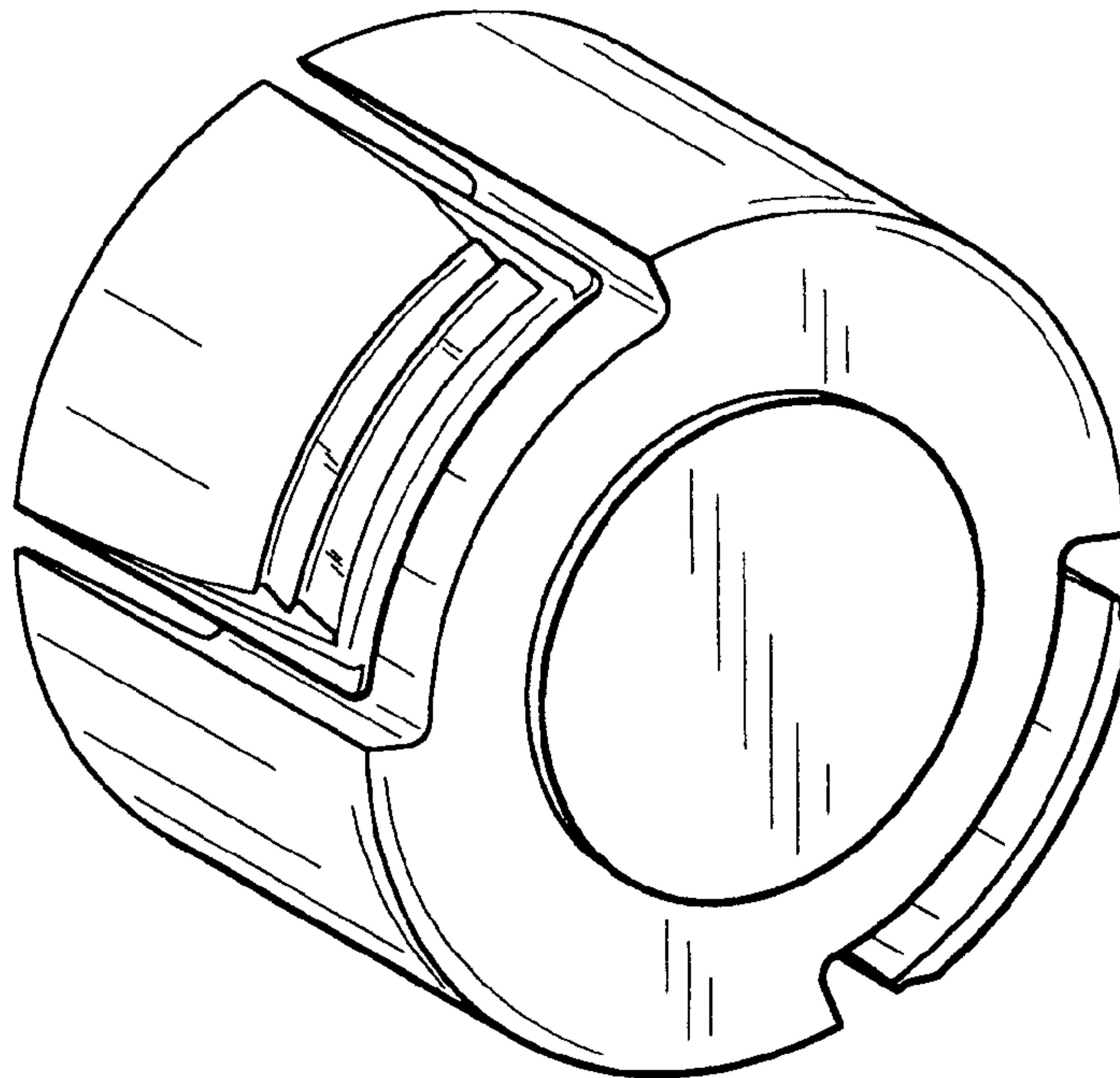
[57] **CLAIM**

The ornamental design for a child-resistant screw-on cap, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a child-resistant screw-on cap showing my new design;

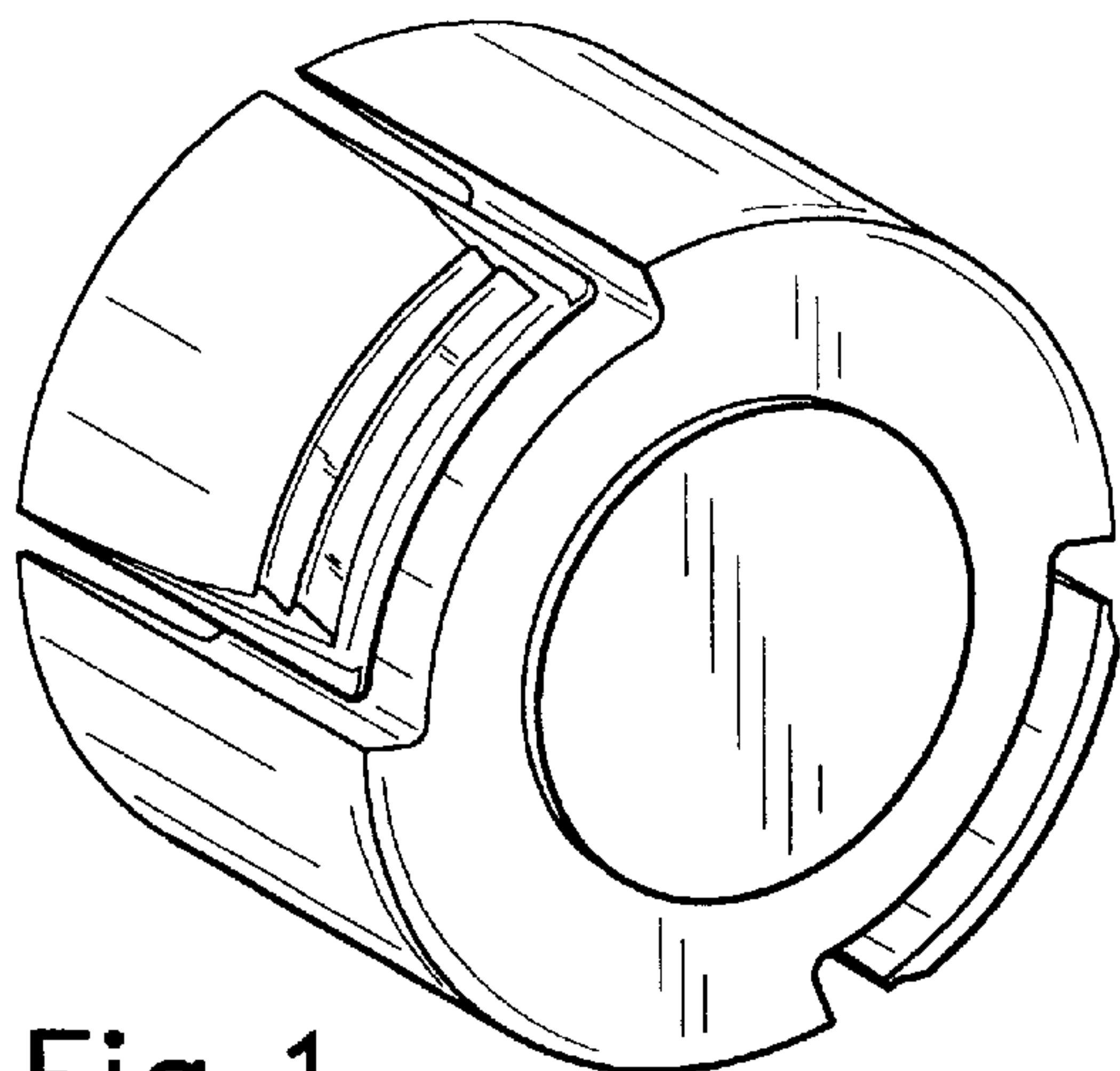

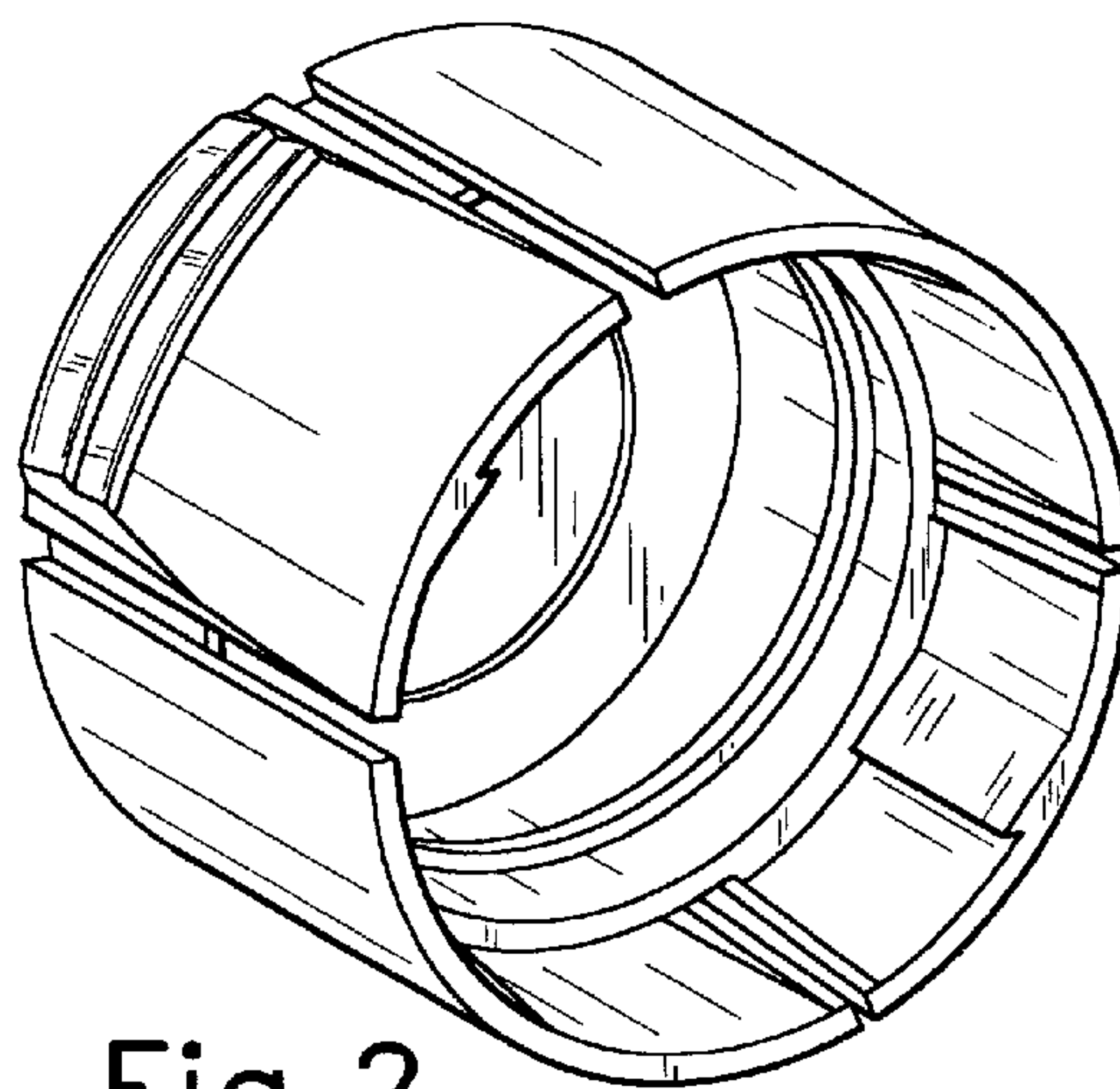

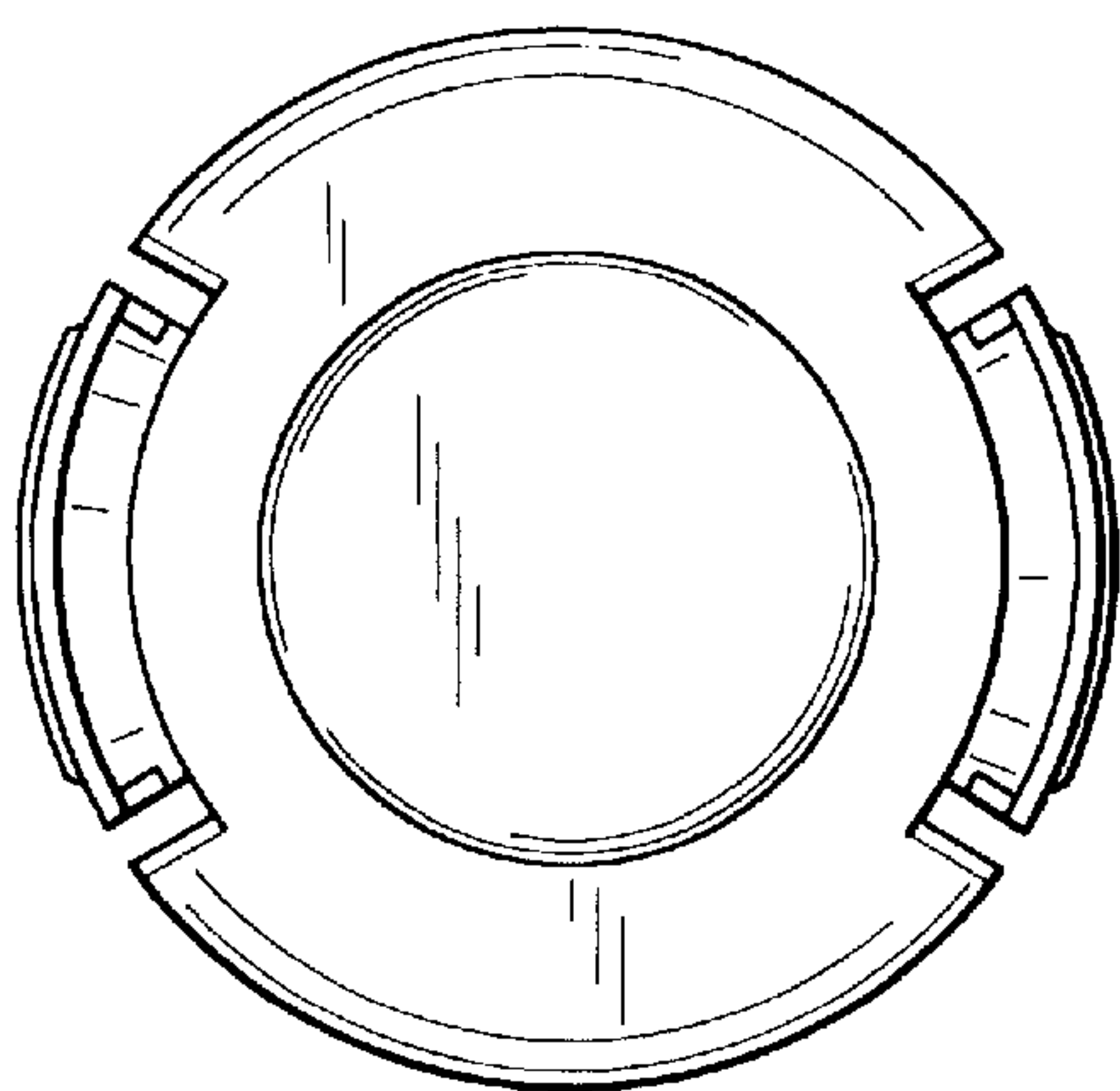

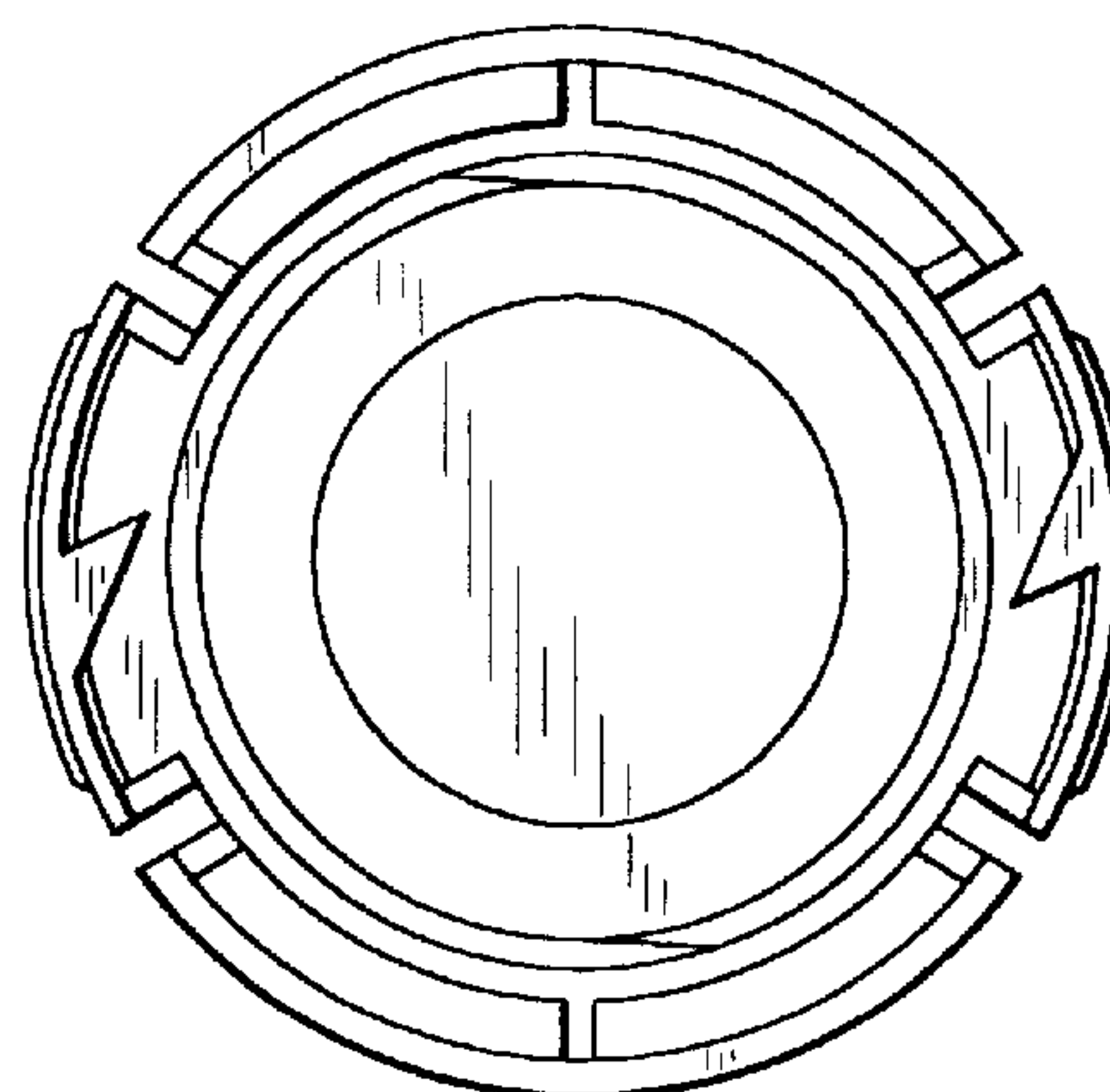

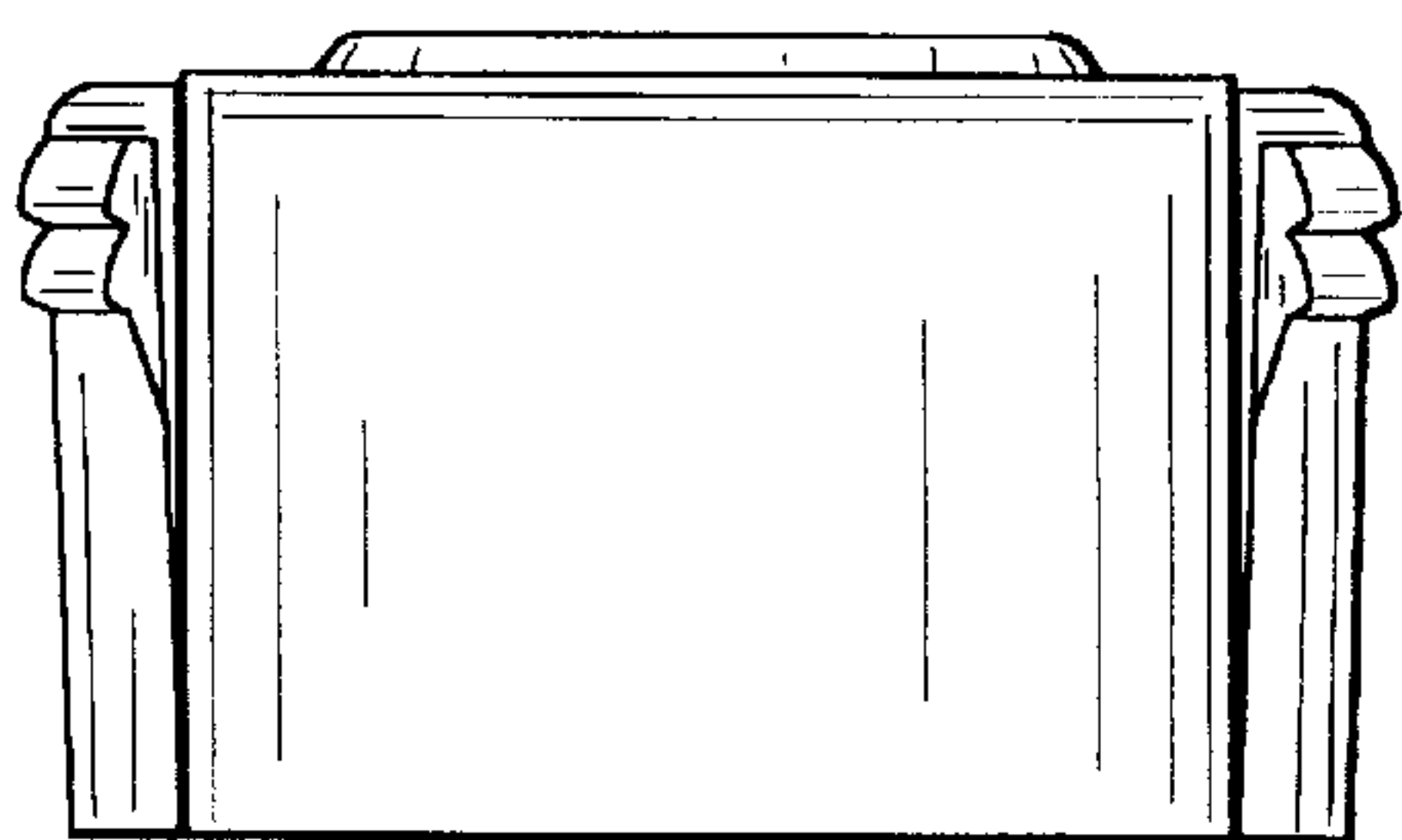

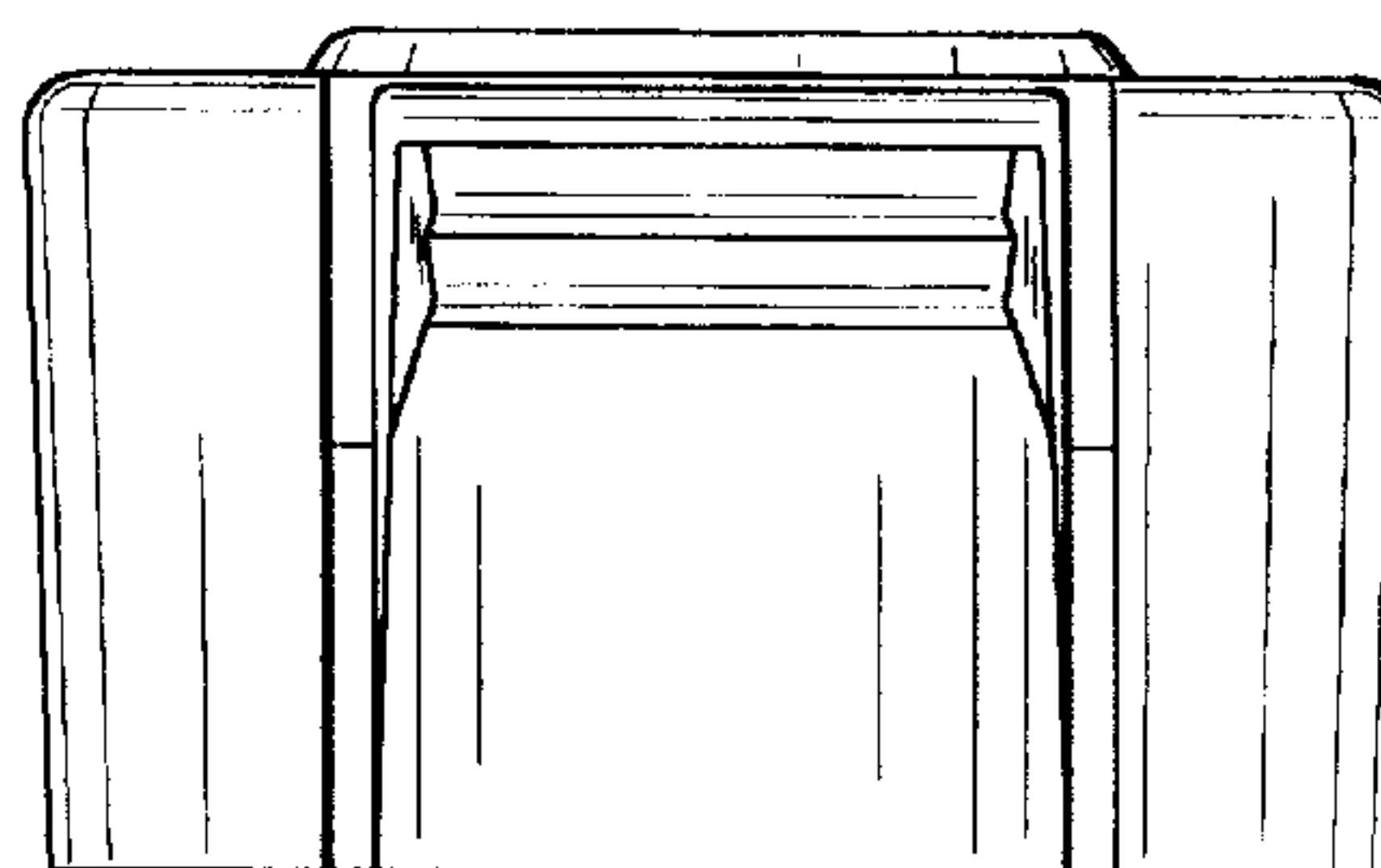
