DESCRIPTION

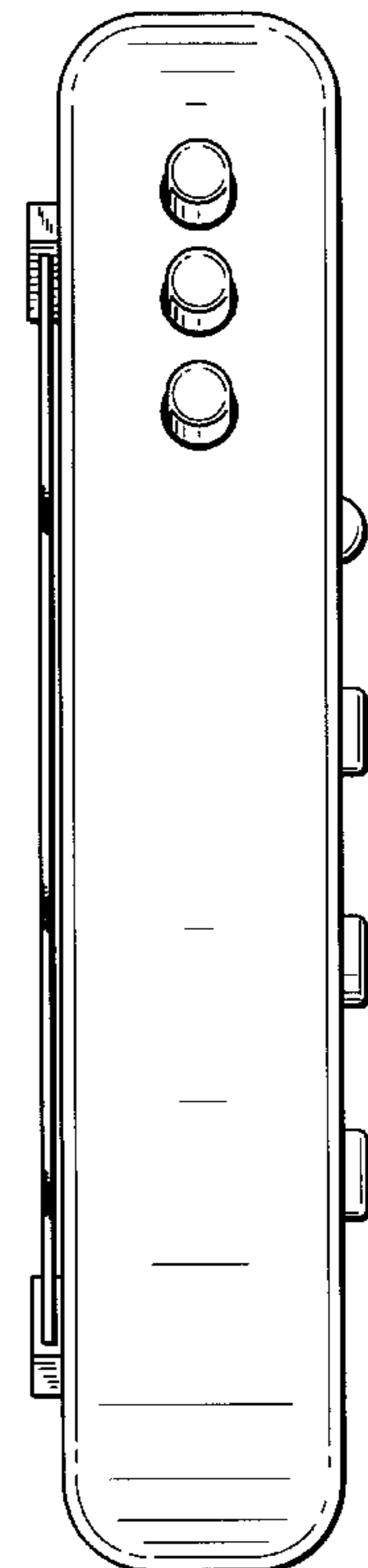
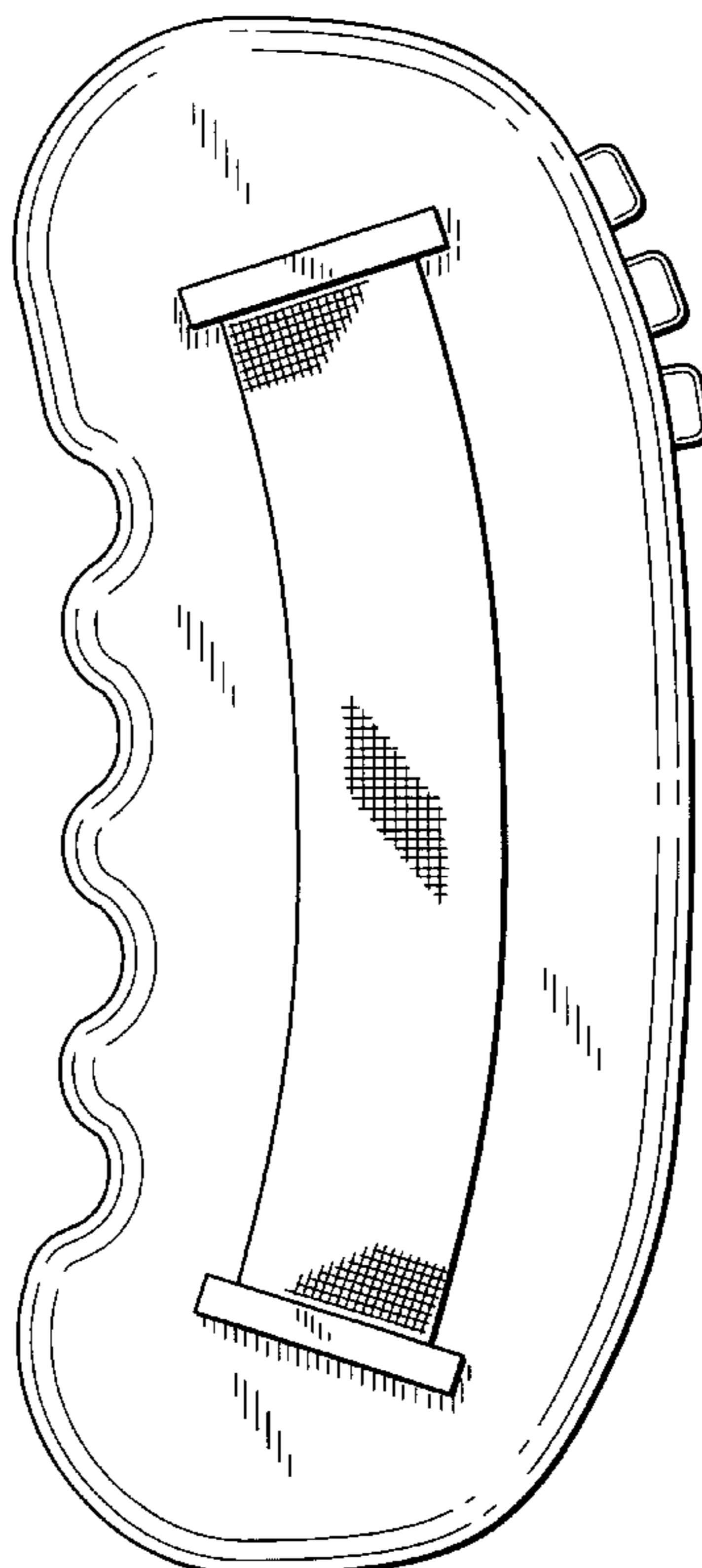
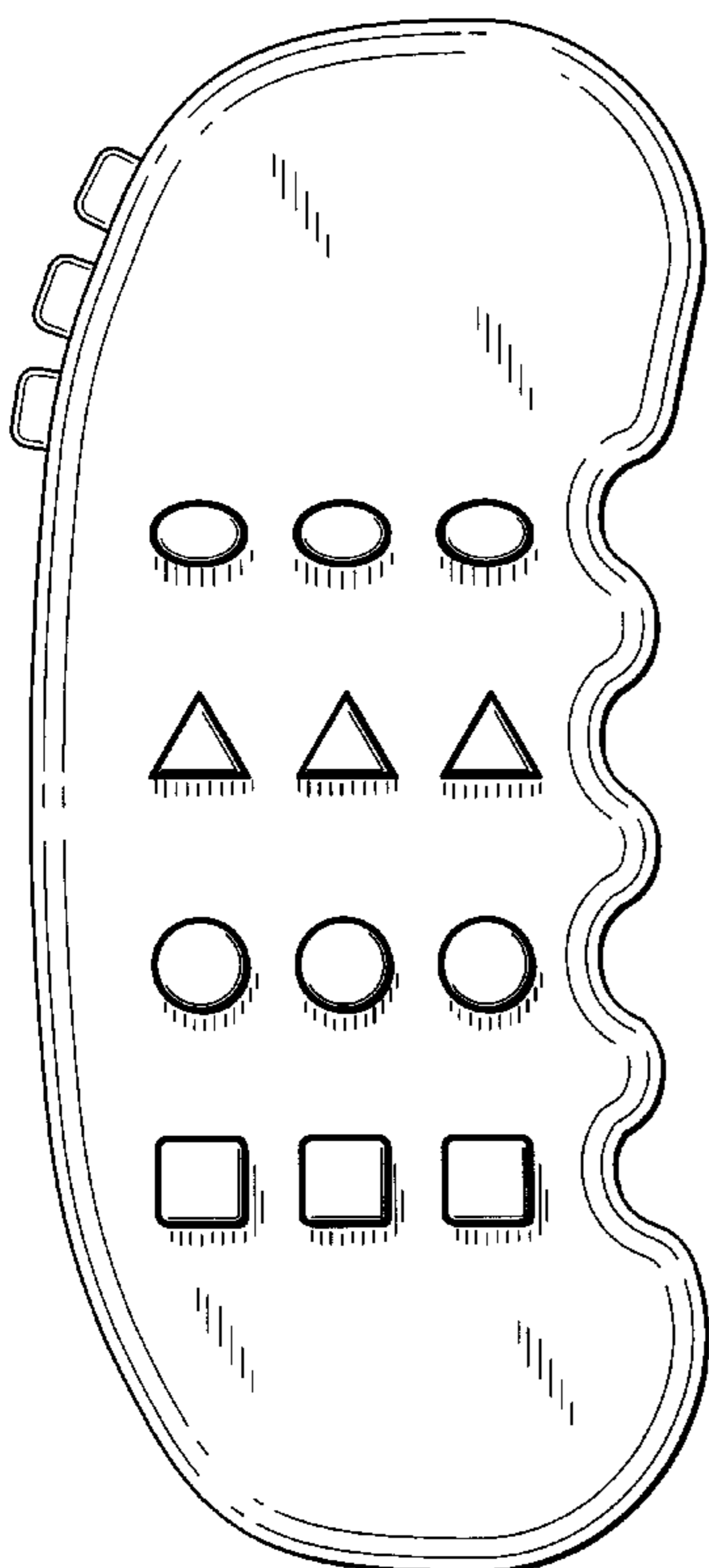

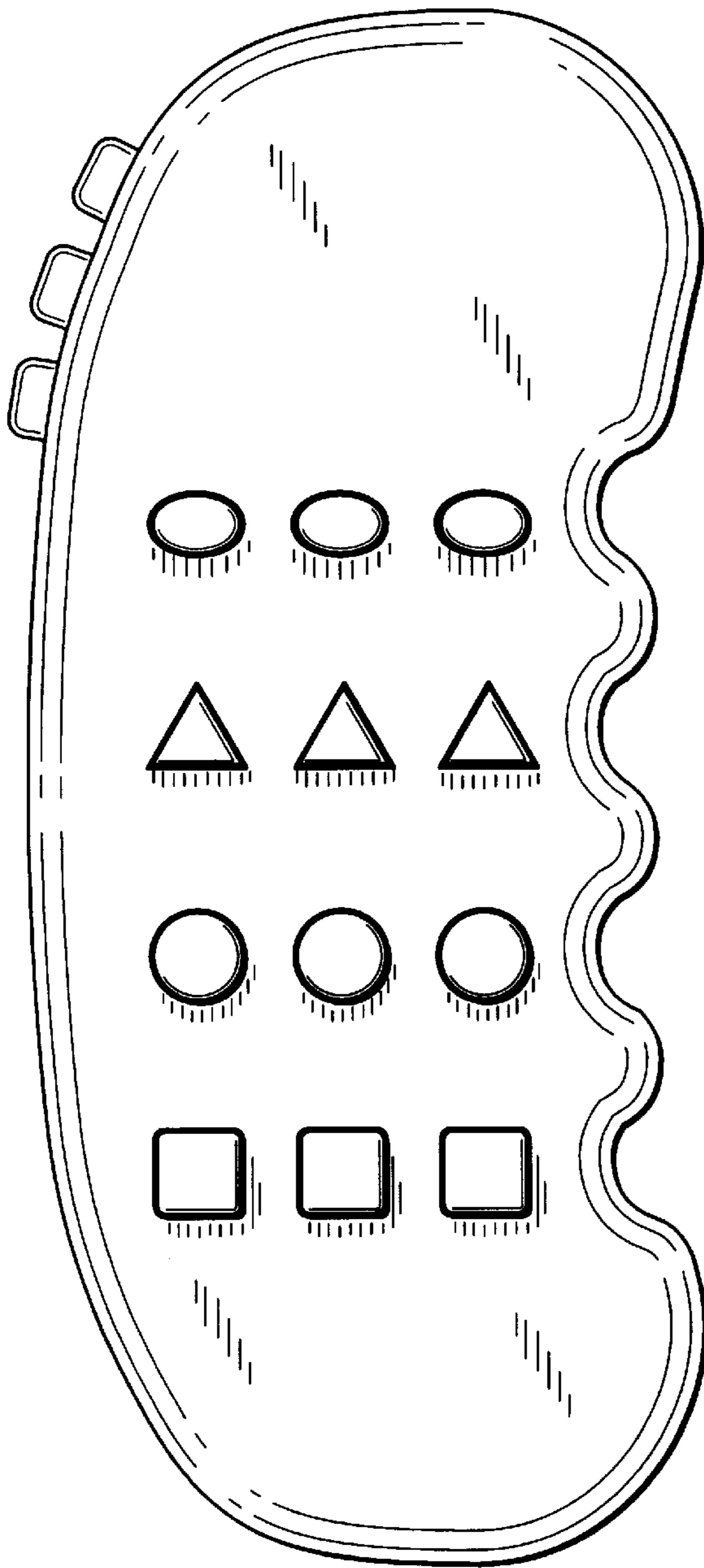

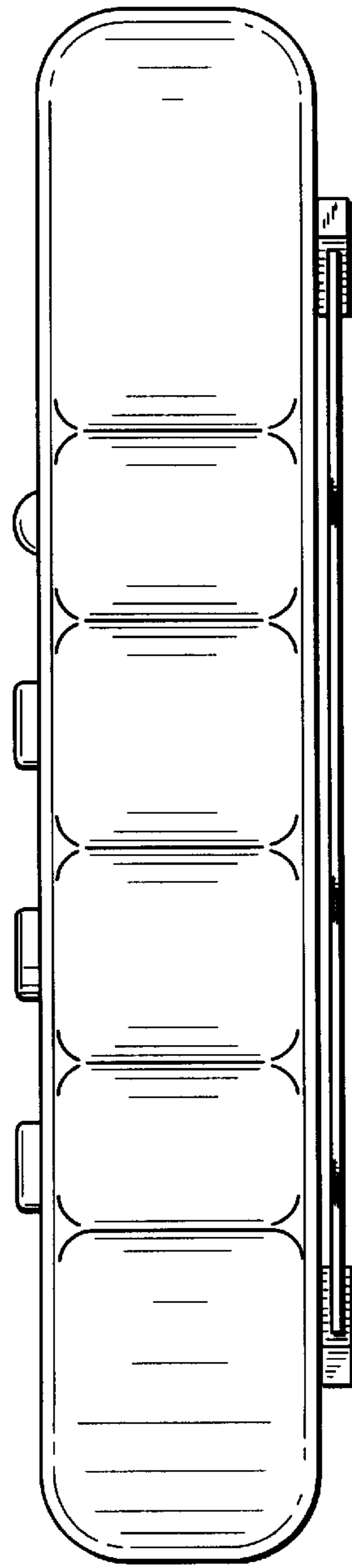

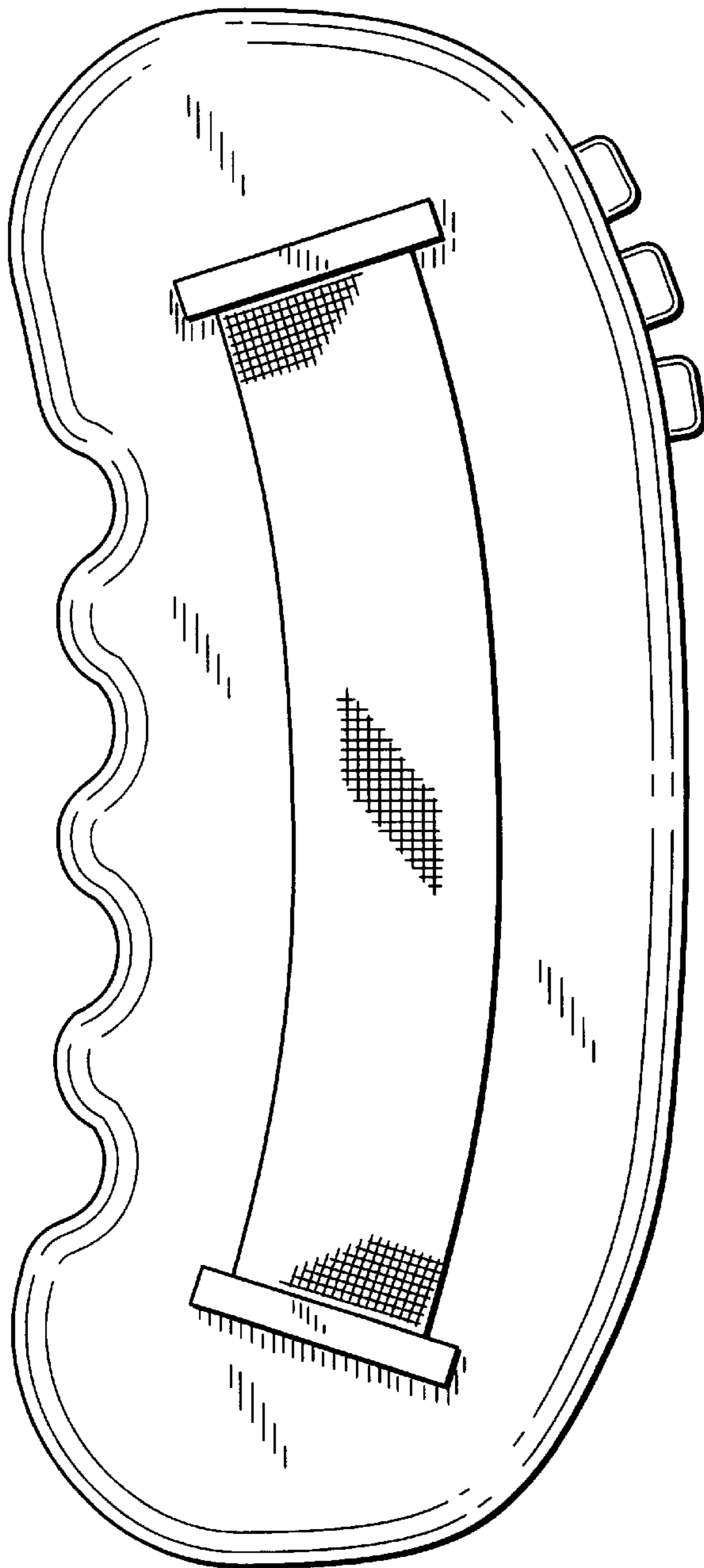

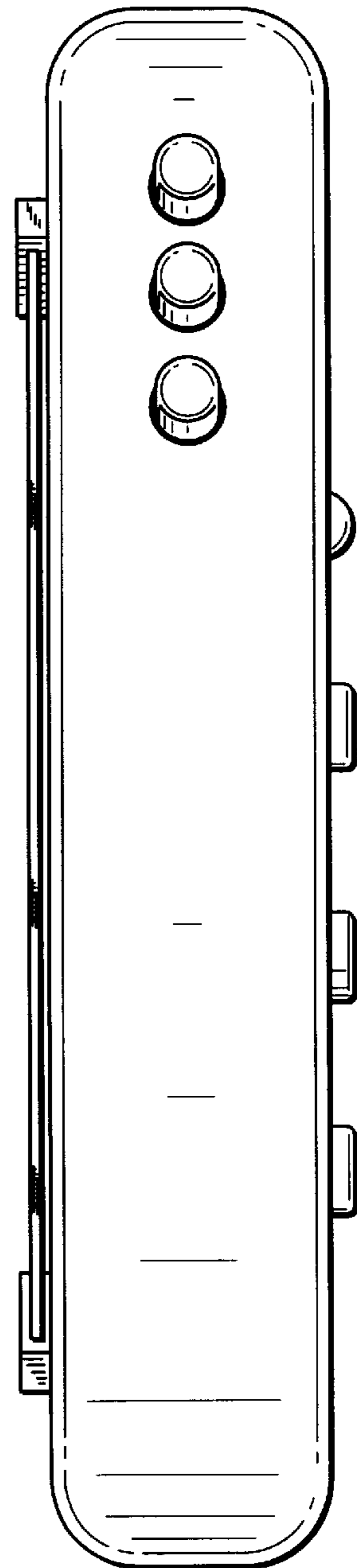

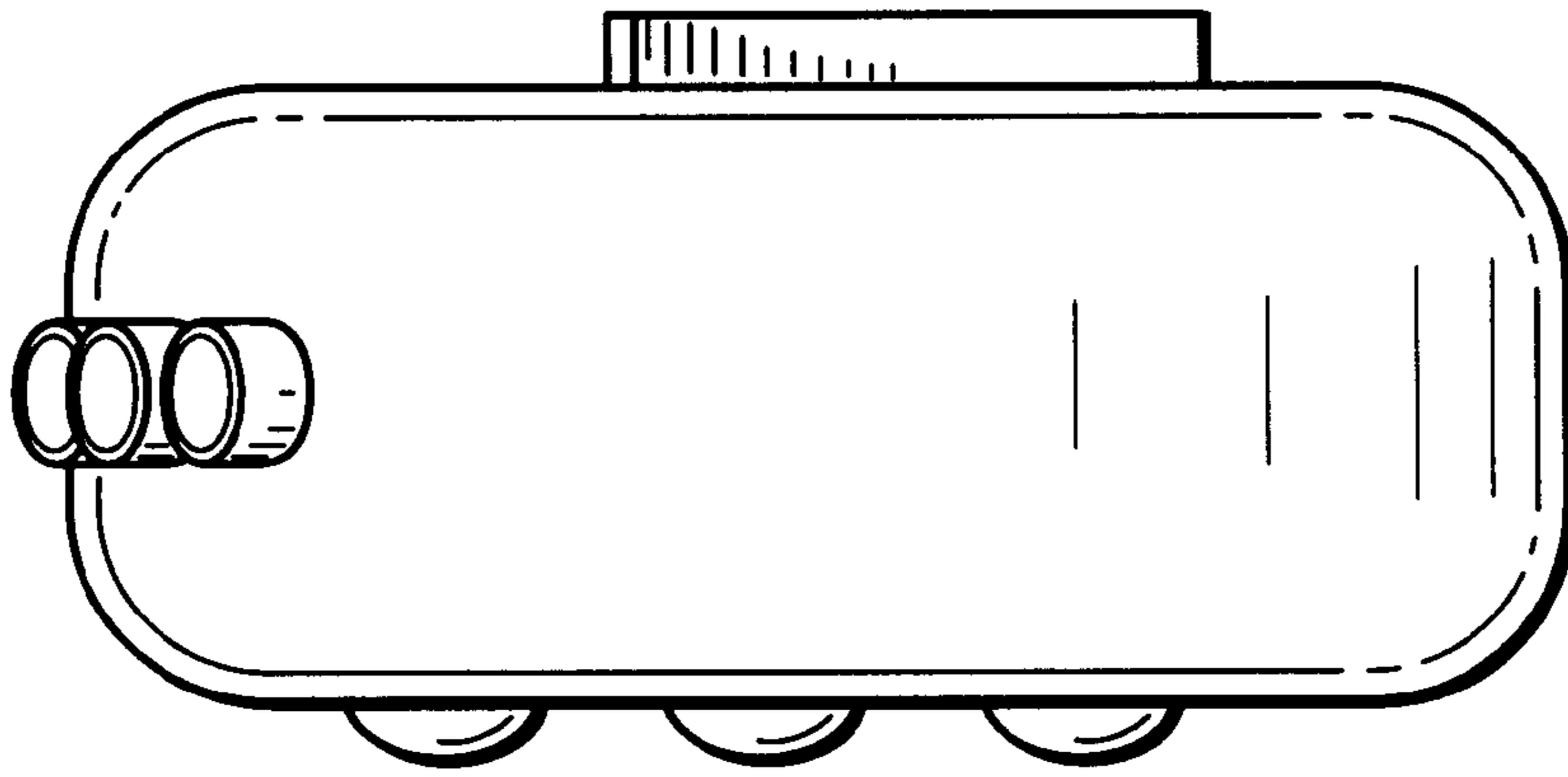

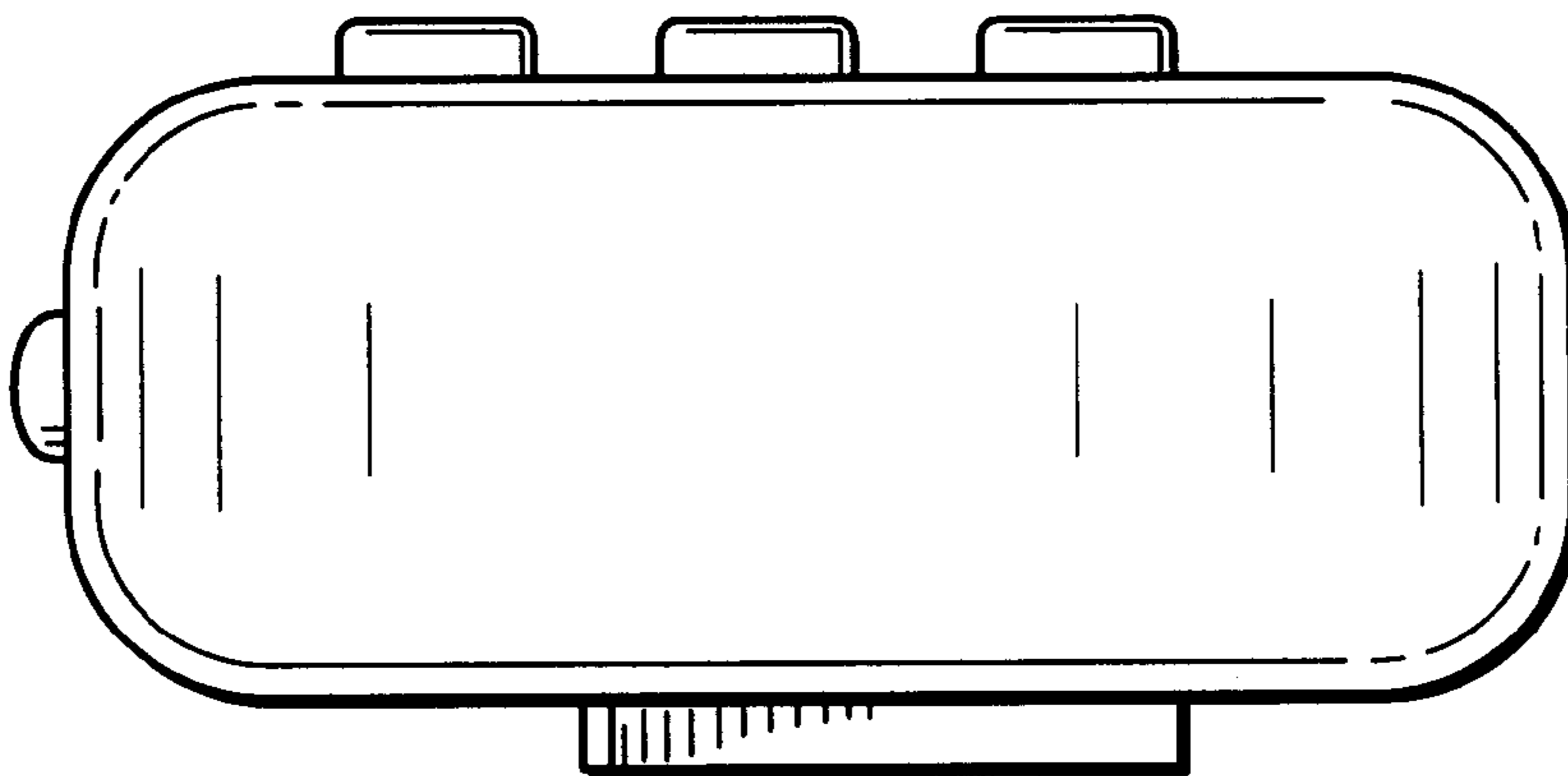

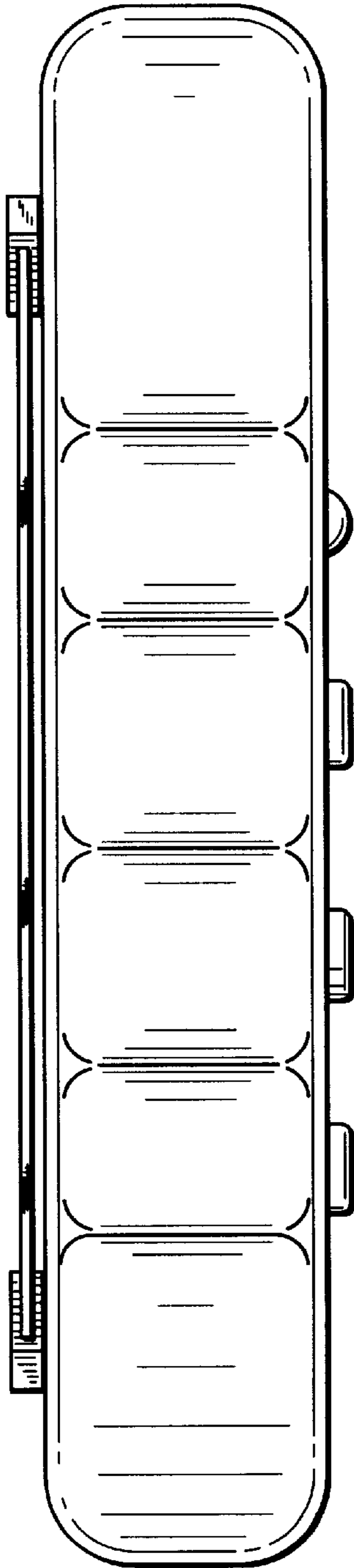

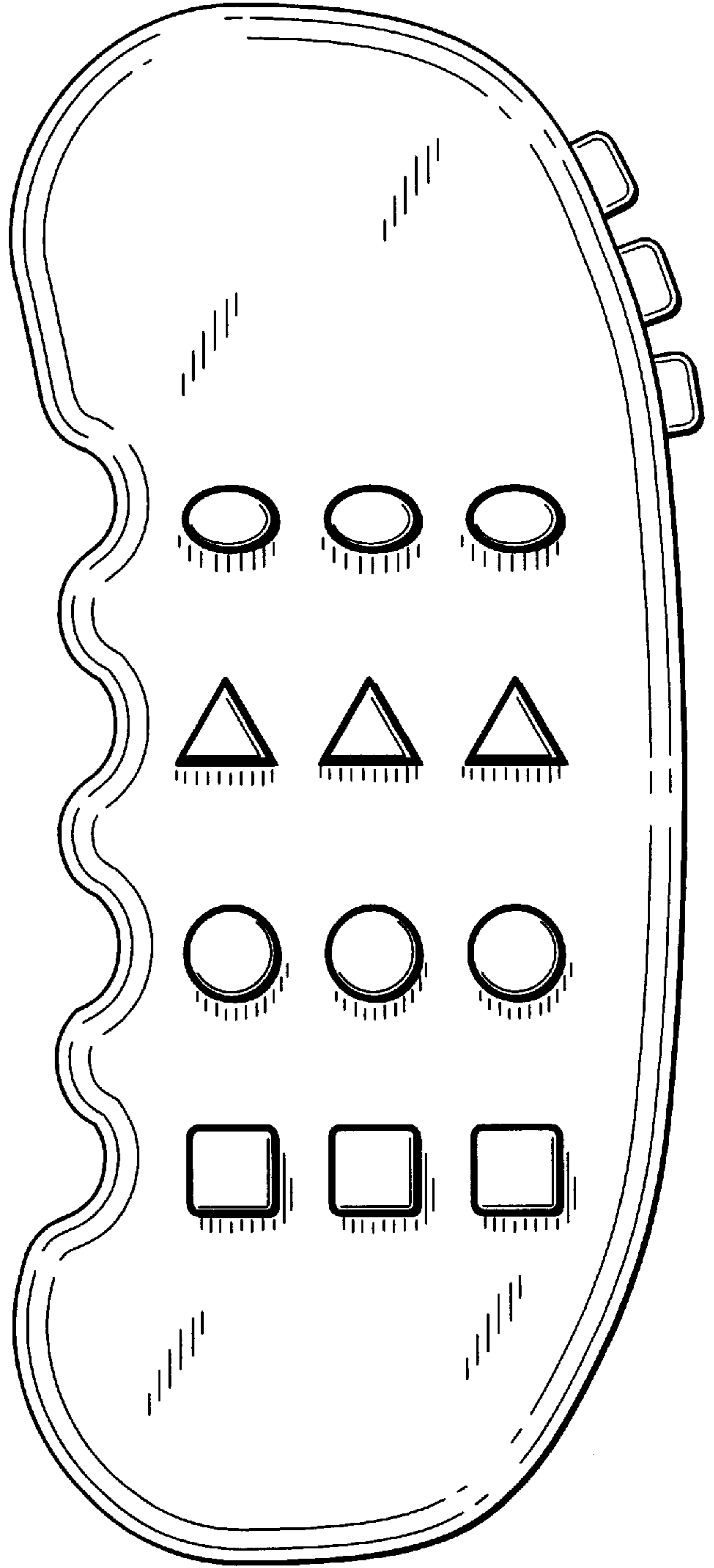

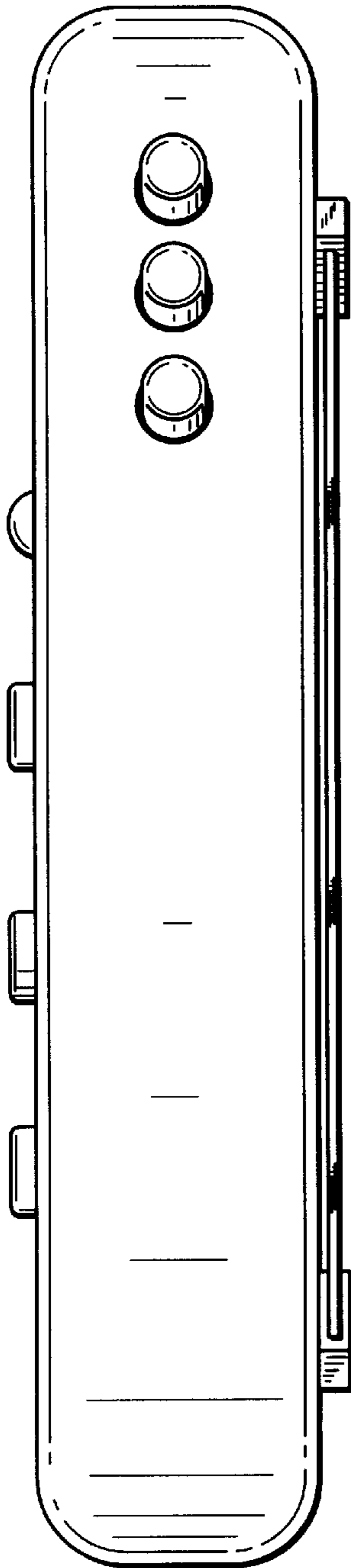

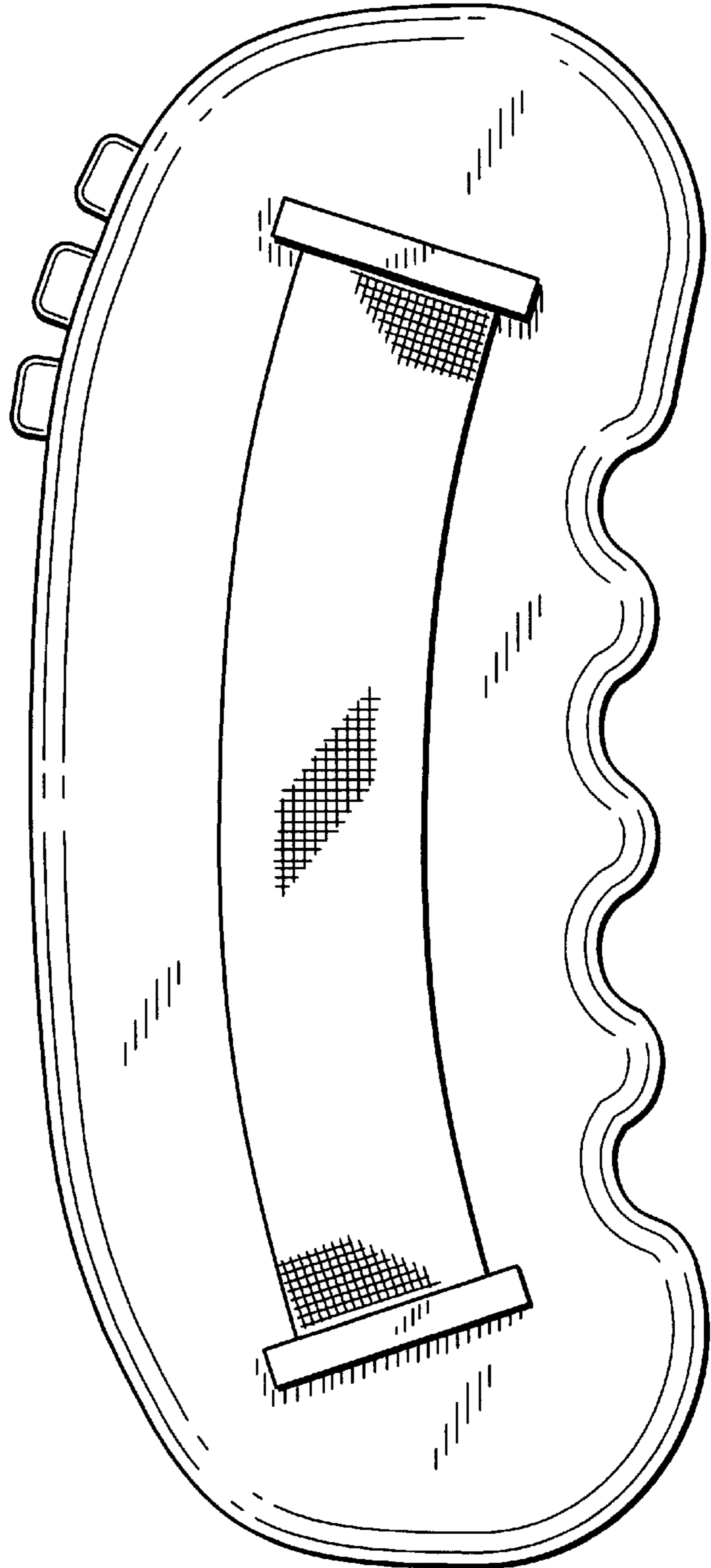

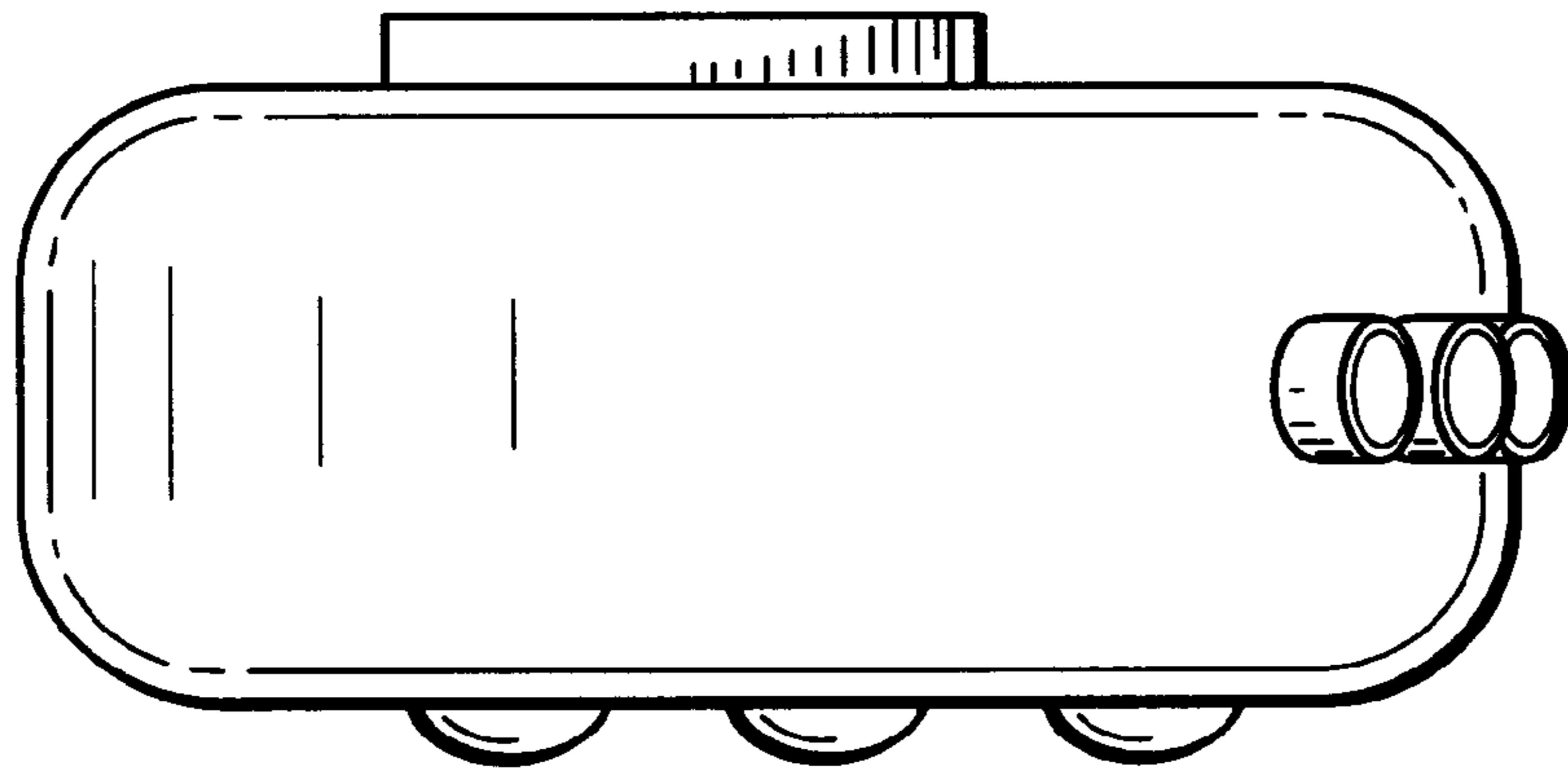
