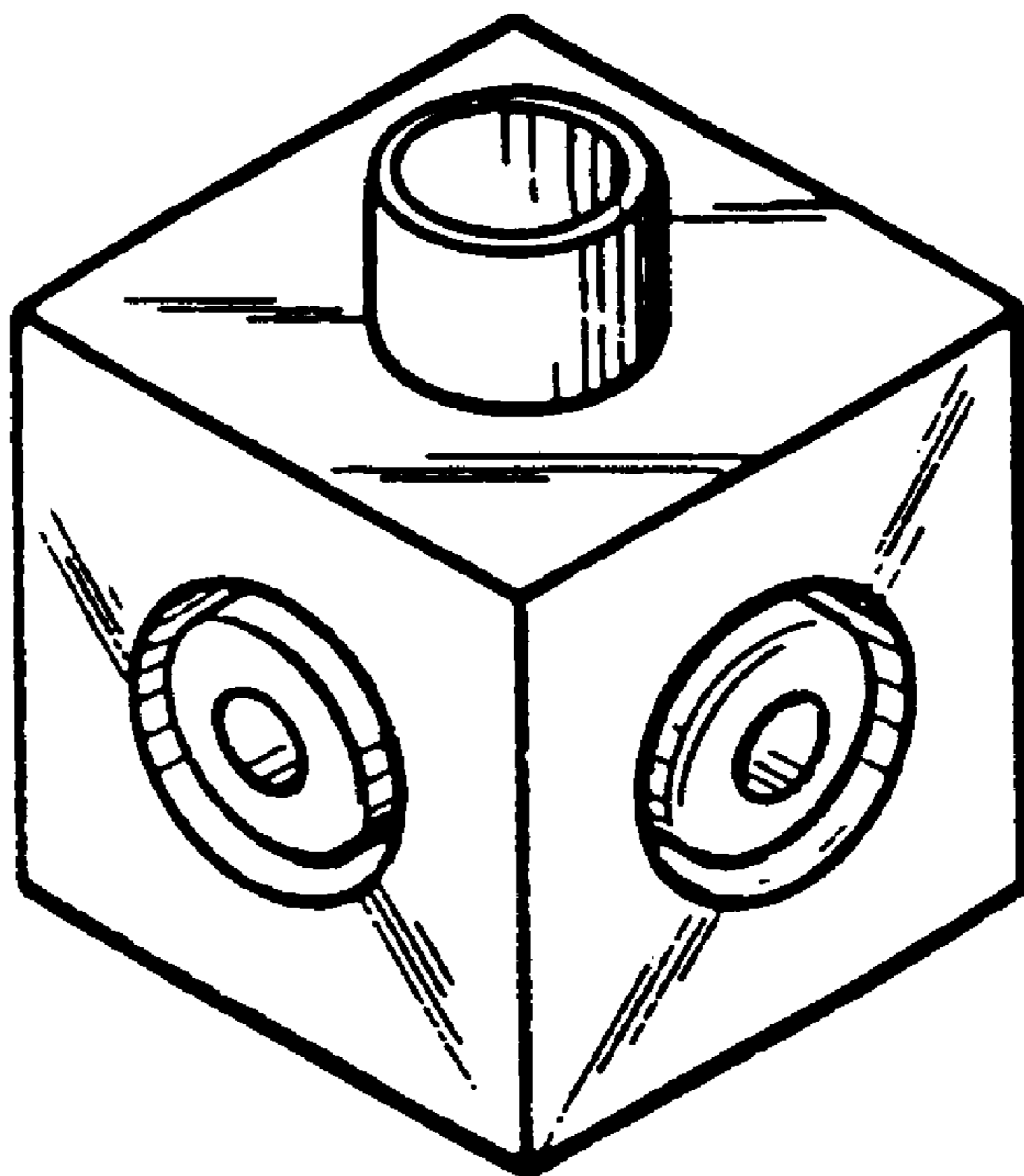
[57] CLAIM

The ornamental design for toy block, as shown.

DESCRIPTION

FIG. 1 is a perspective elevational view of the toy block of my new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a side view thereof with the block shown in the inverted position;
 FIG. 6 is a bottom view thereof; and,
 FIG. 7 is a side view thereof similar to that of FIG. 5 with the toy block of my new design shown resting on one side.

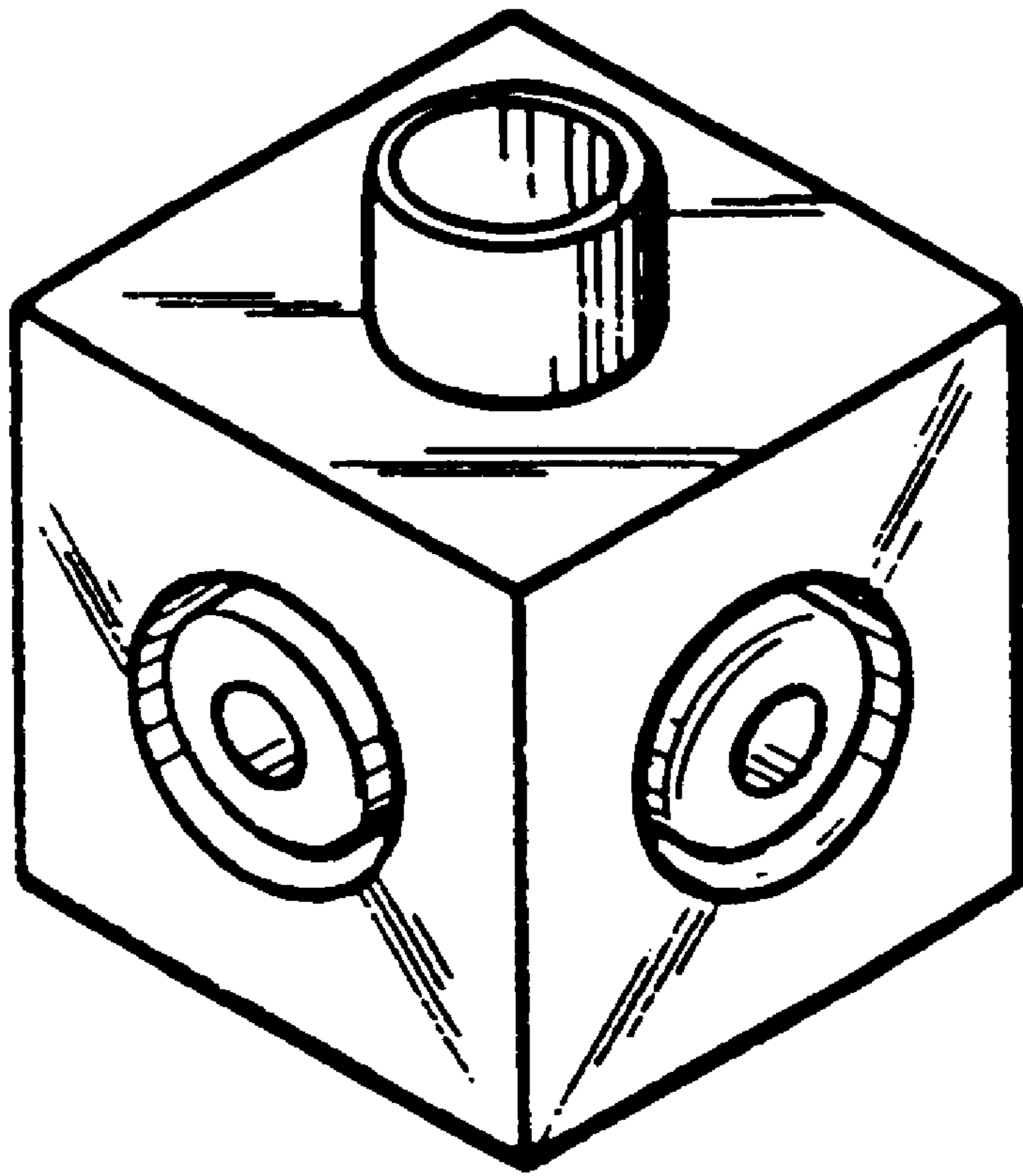

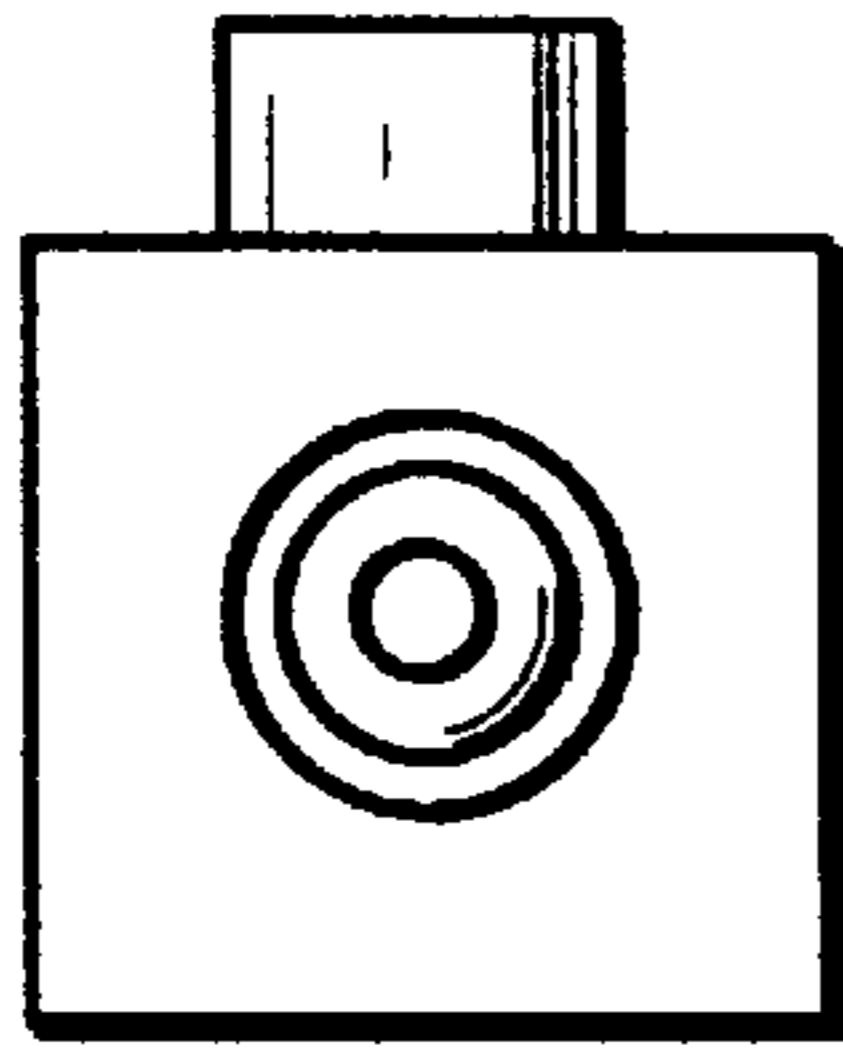

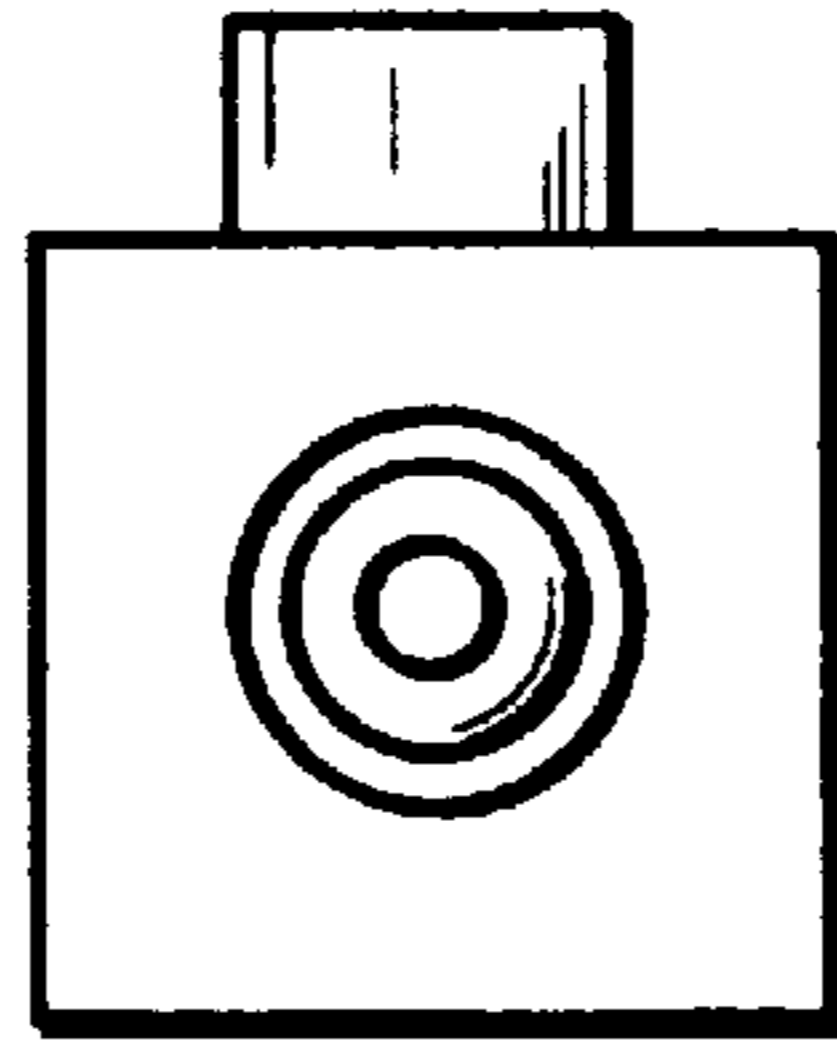

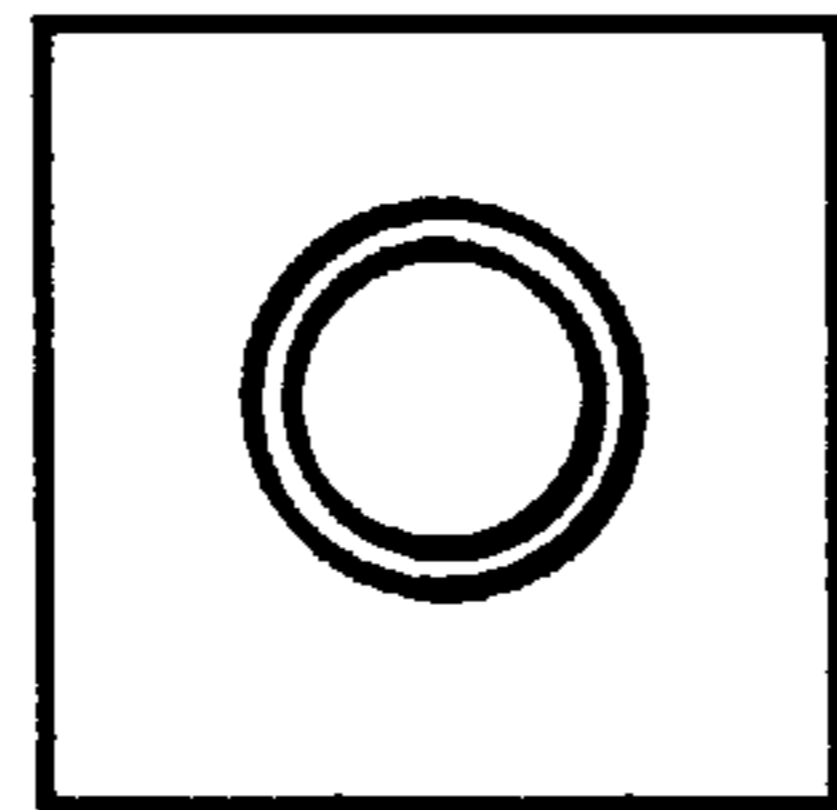

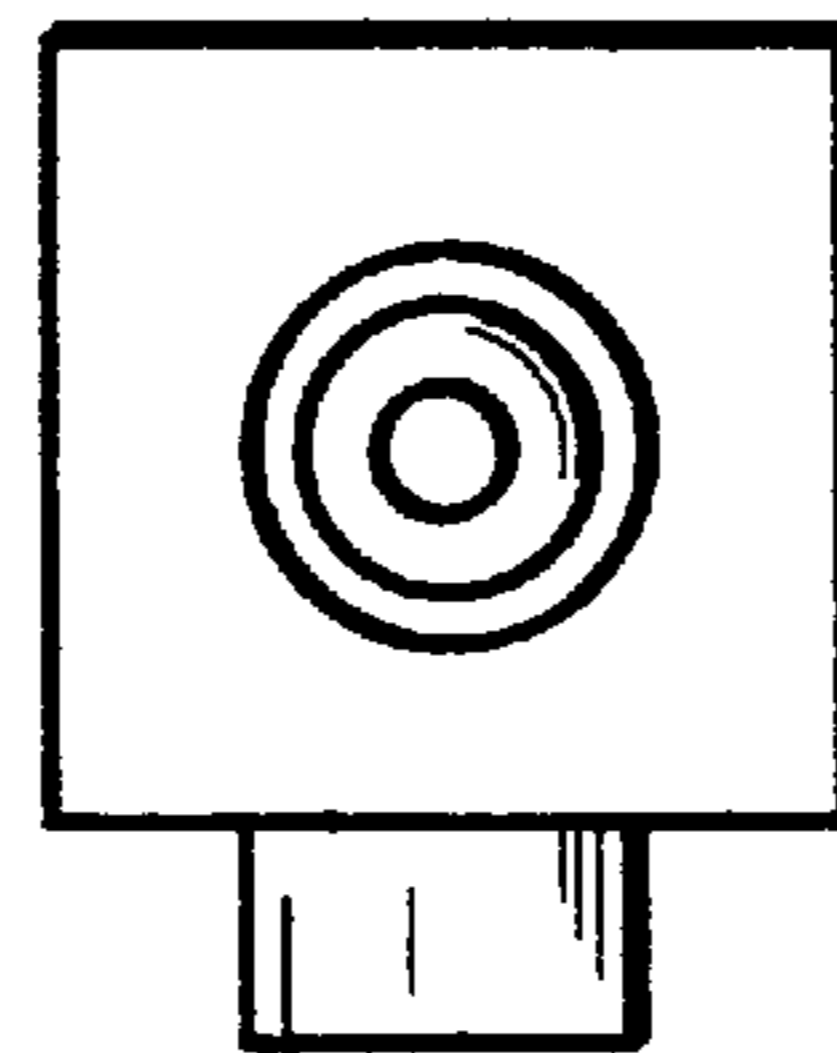

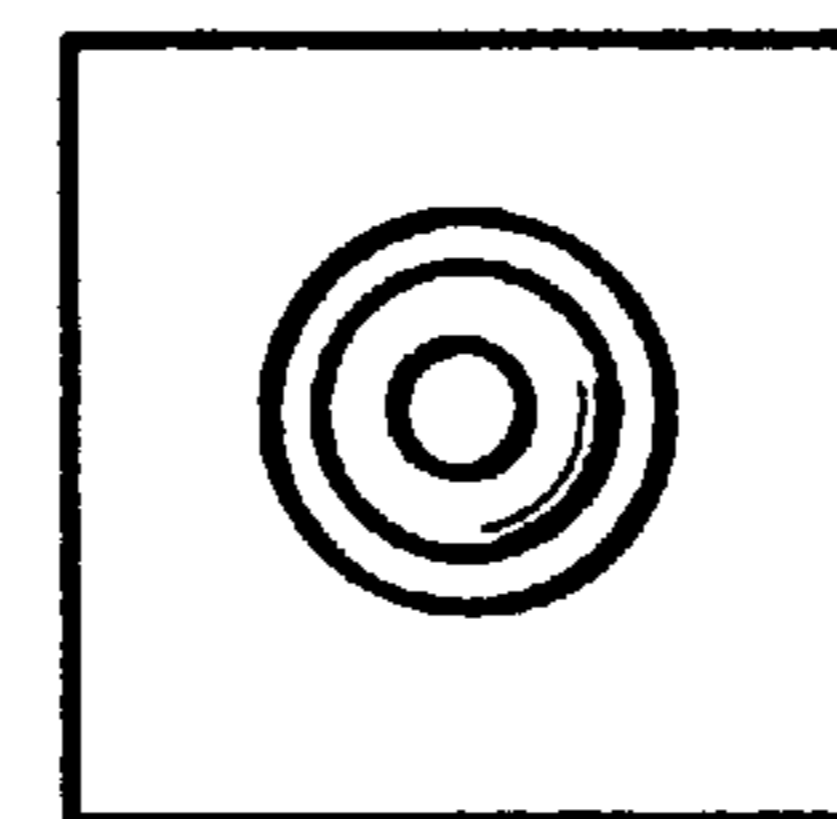

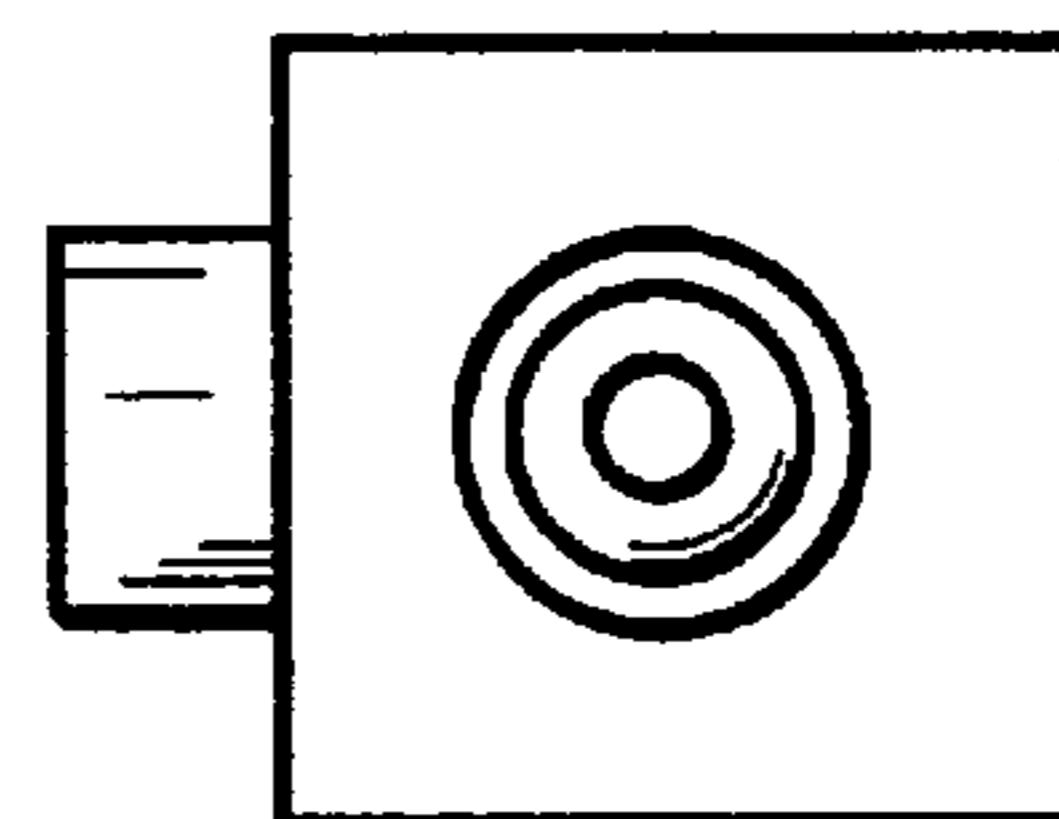
