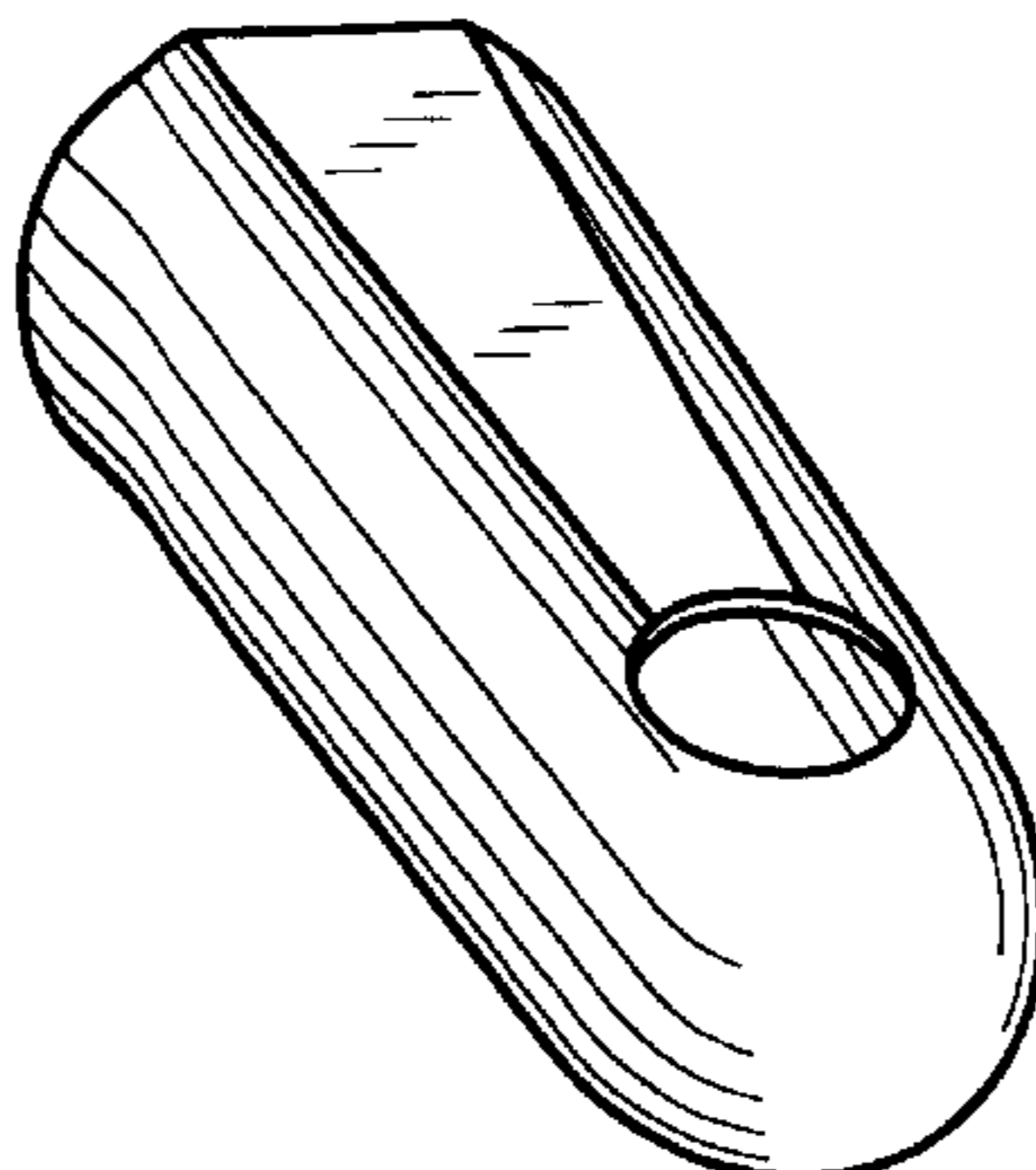
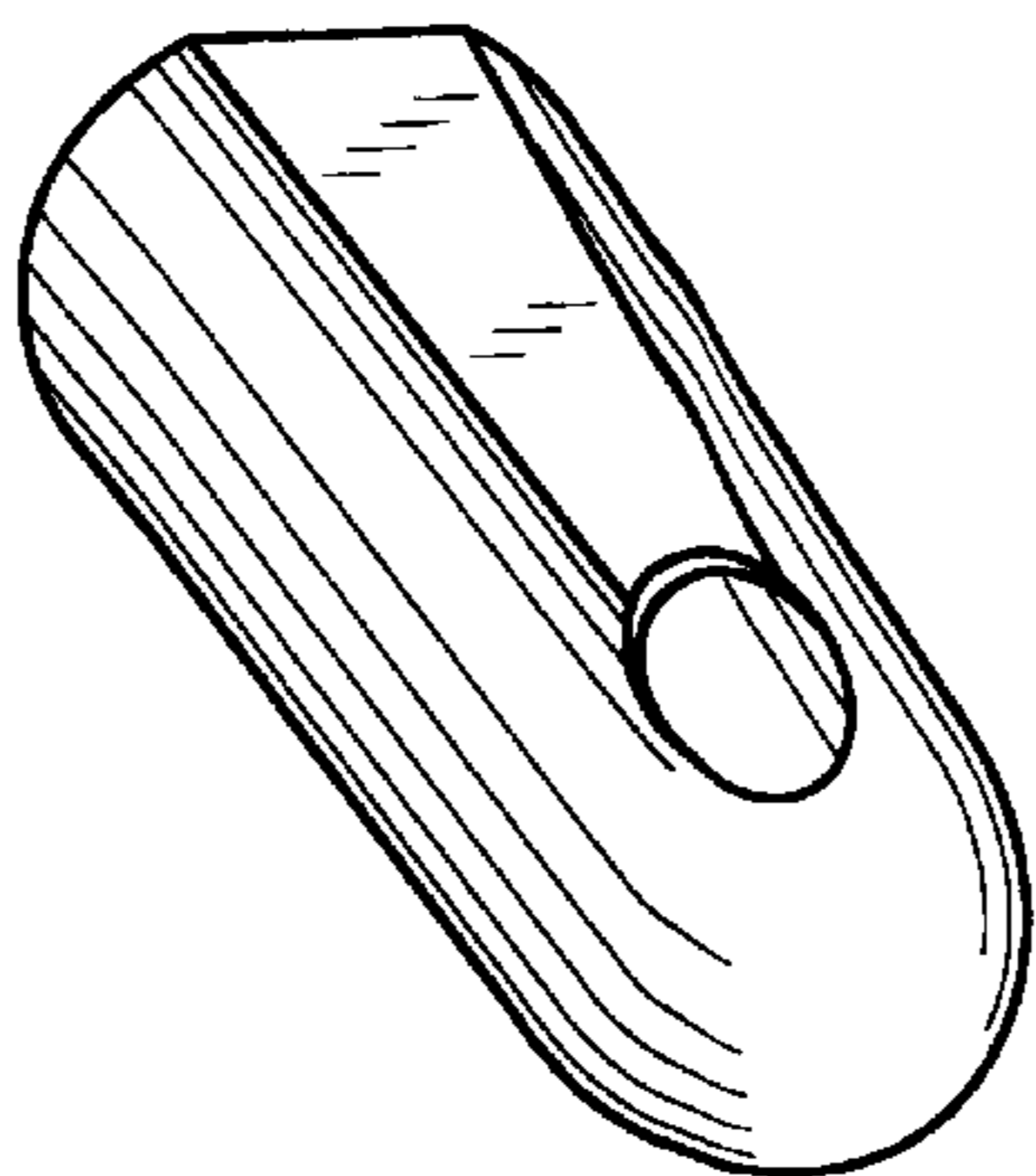

FIG. 4 is a left side elevational view of the finger protector of FIG. 1, the right side being a mirror image thereof.
FIG. 5 is a perspective view of the bottom, front and right side of a second embodiment of the finger protector embodying my design;
FIG. 6 is a top plan view of the finger protector of FIG. 5;
FIG. 7 is a left side elevational view of the finger protector of FIG. 5, the right side being a mirror image thereof; and,
FIG. 8 is a rear elevational view of the finger protector of FIG. 5.

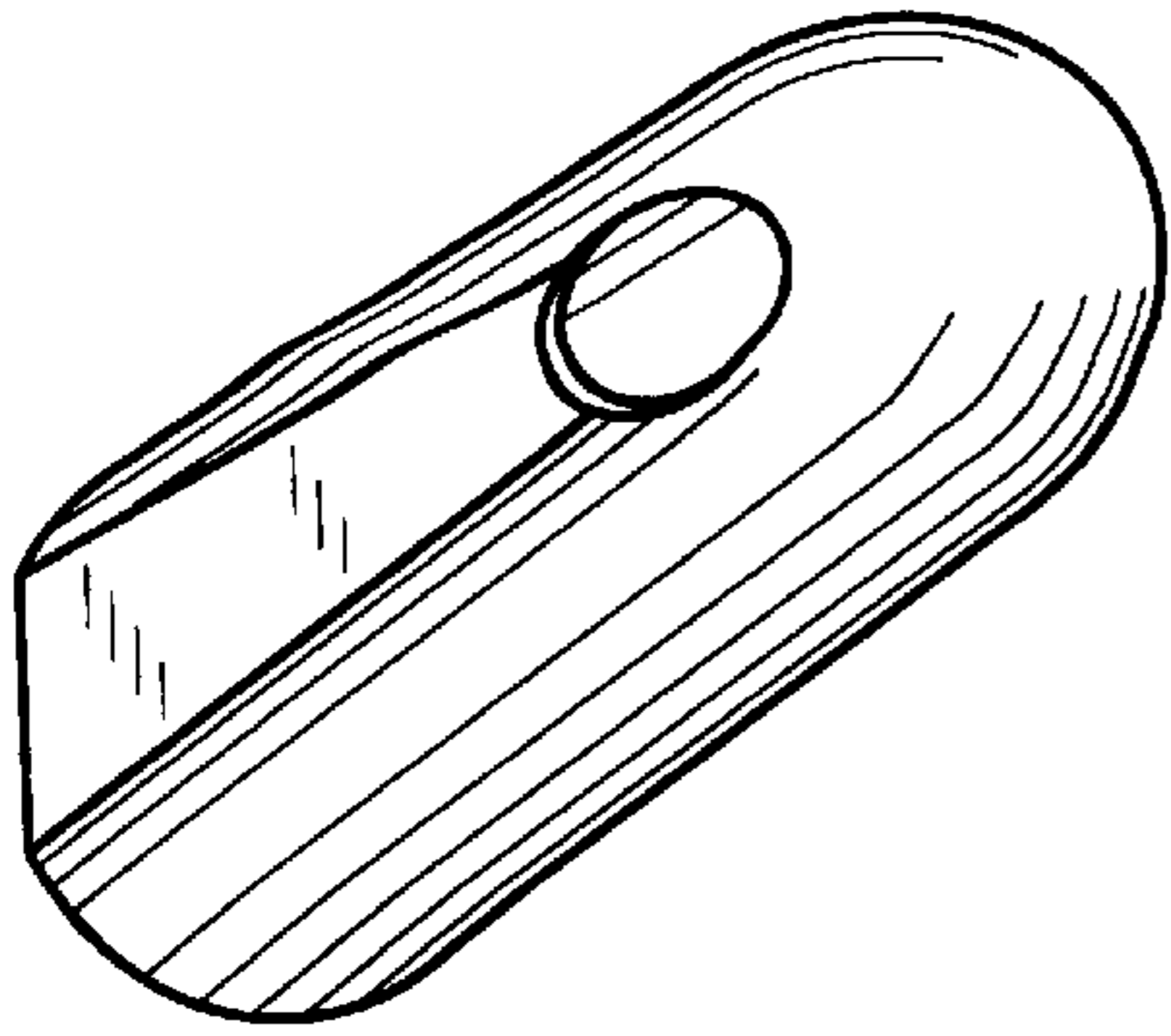

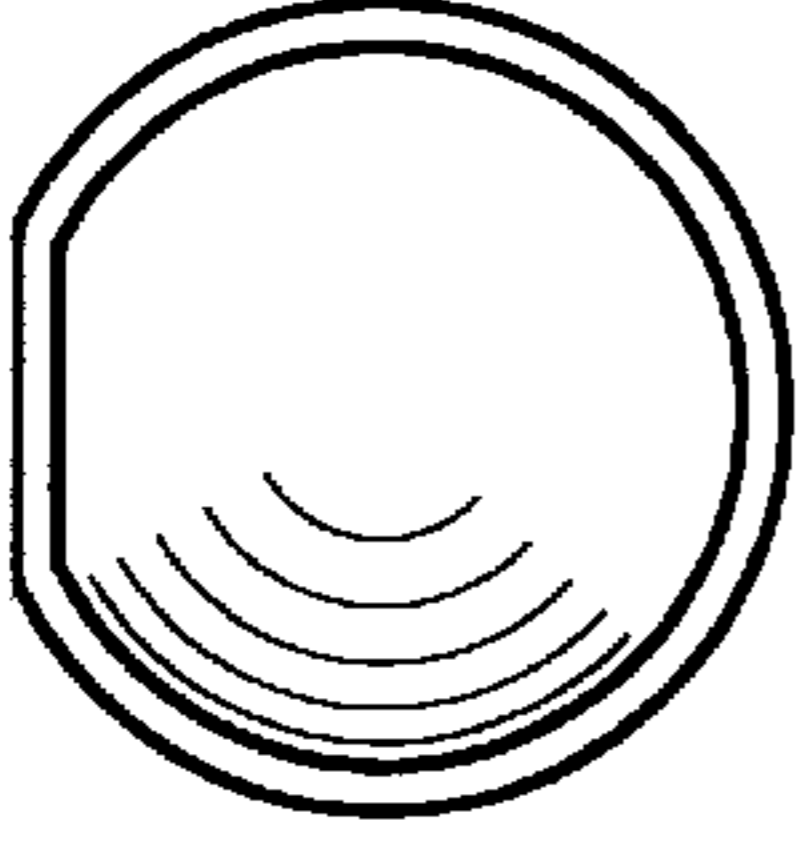

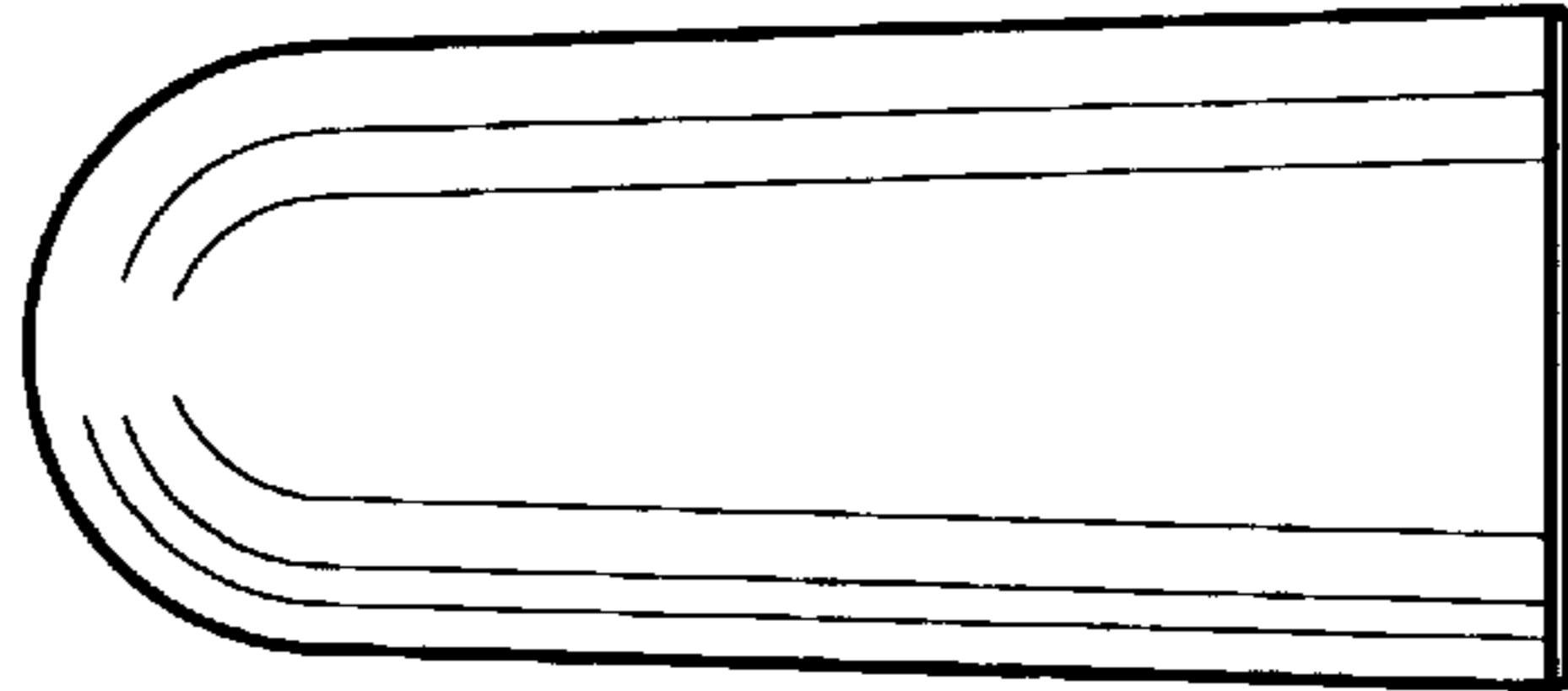

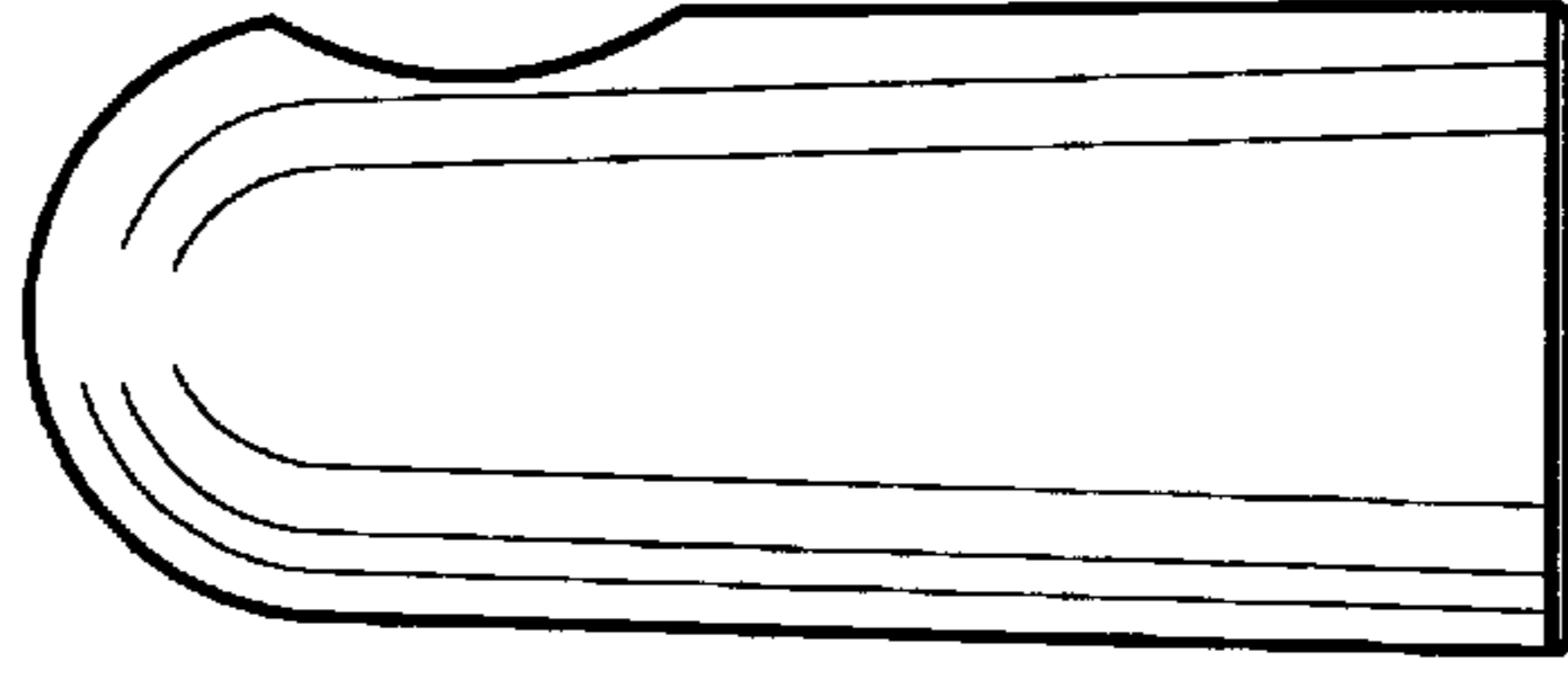

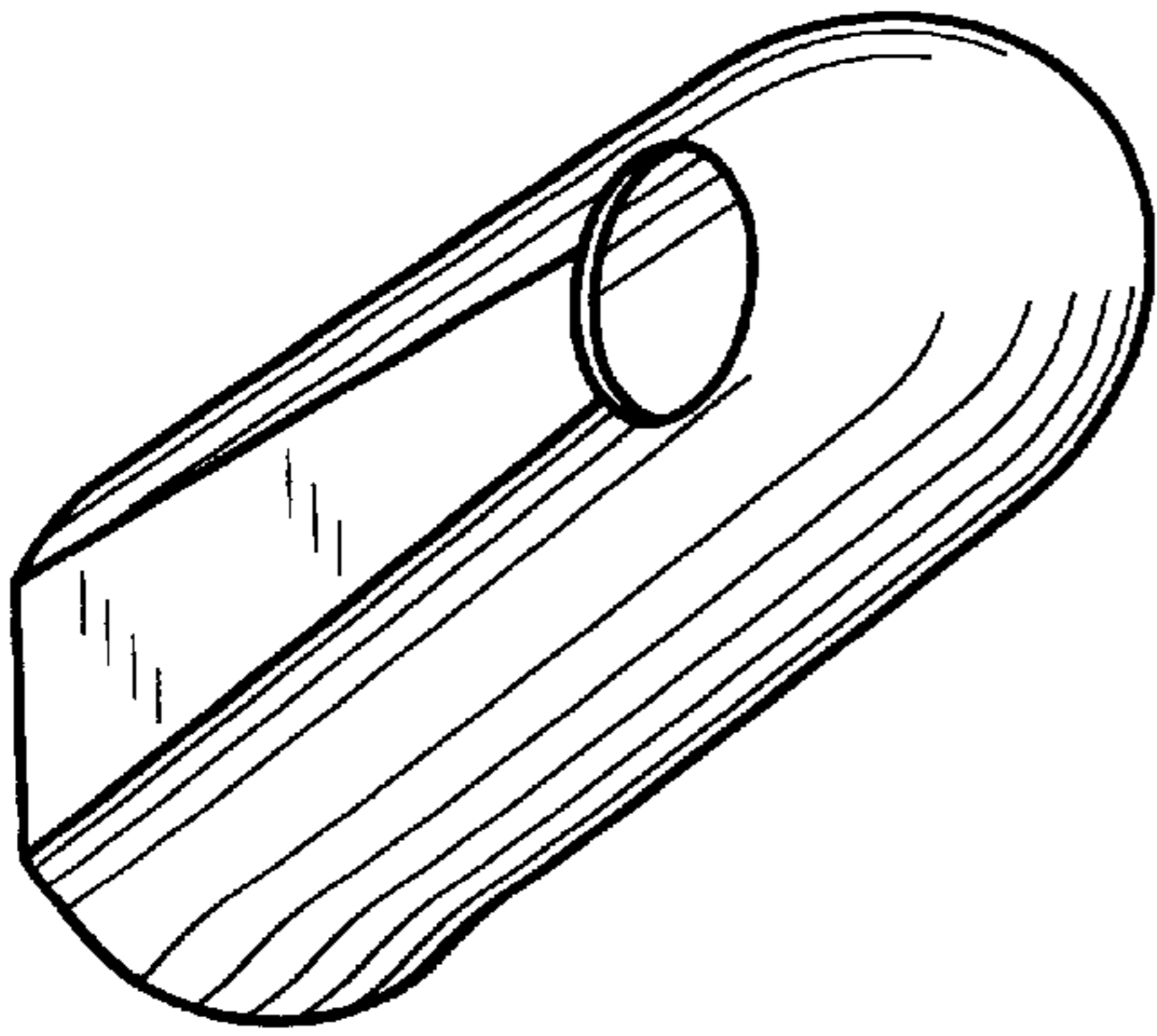

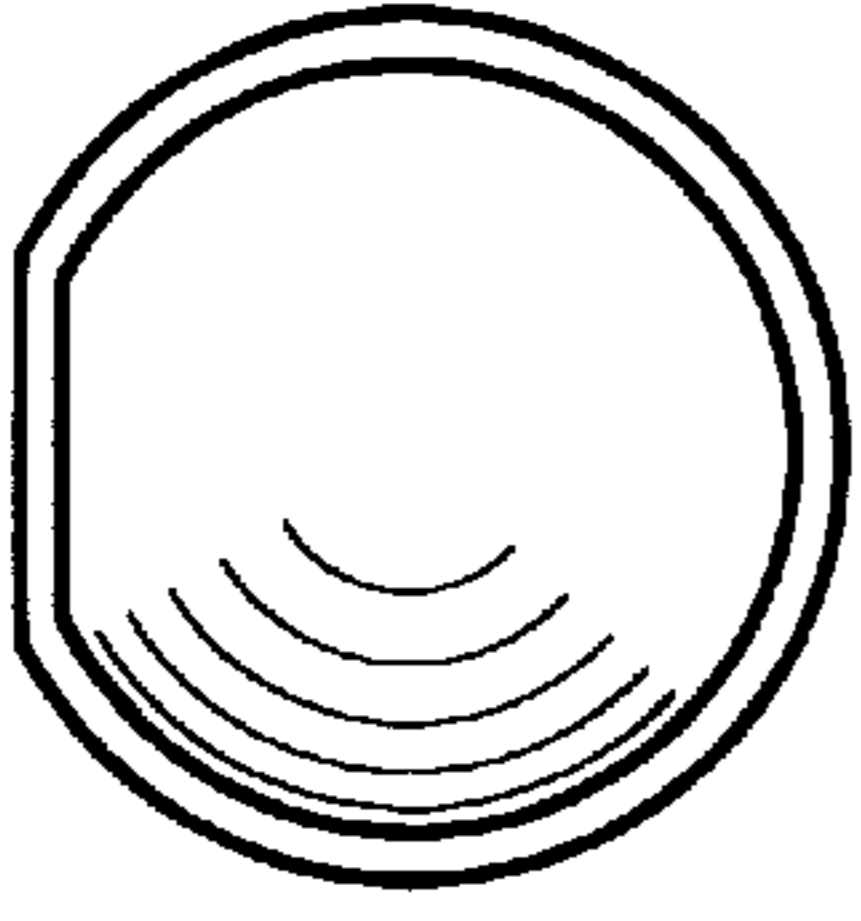

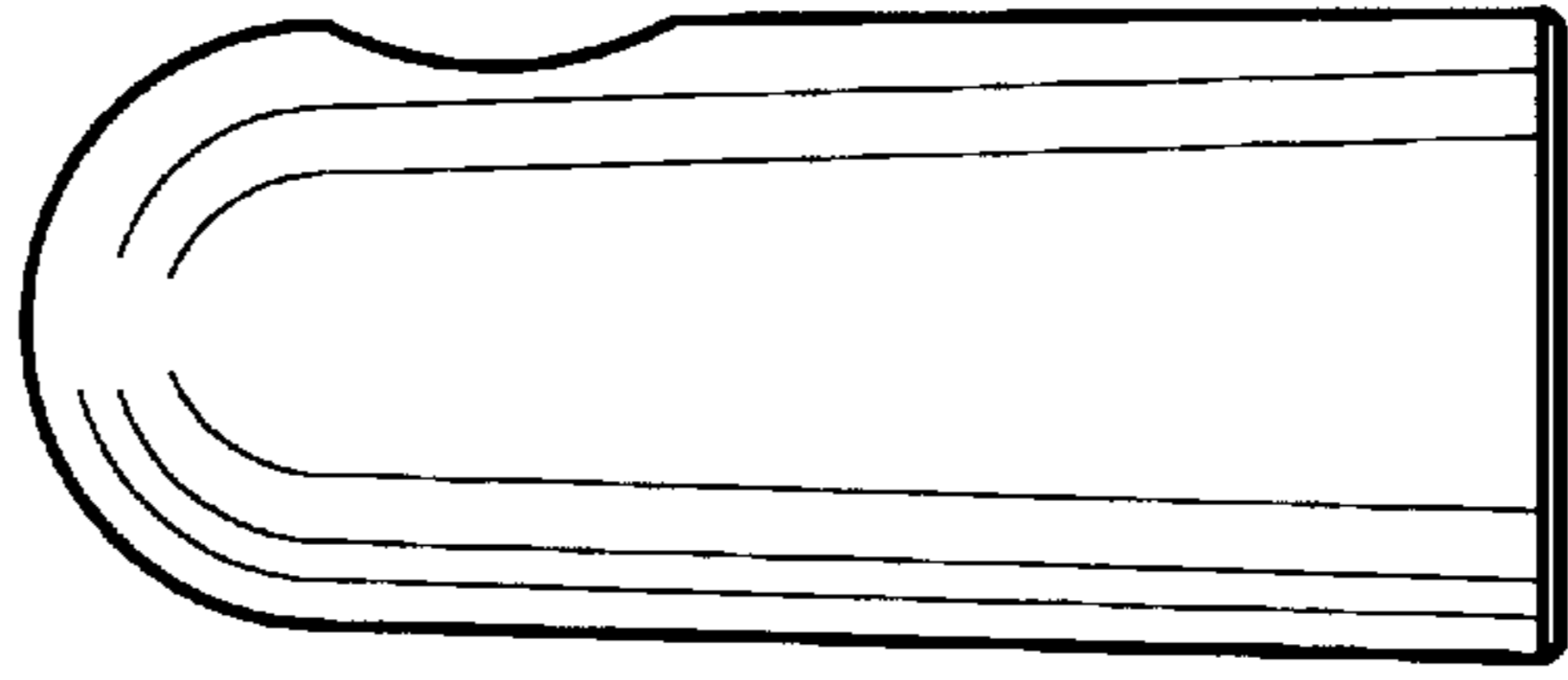
