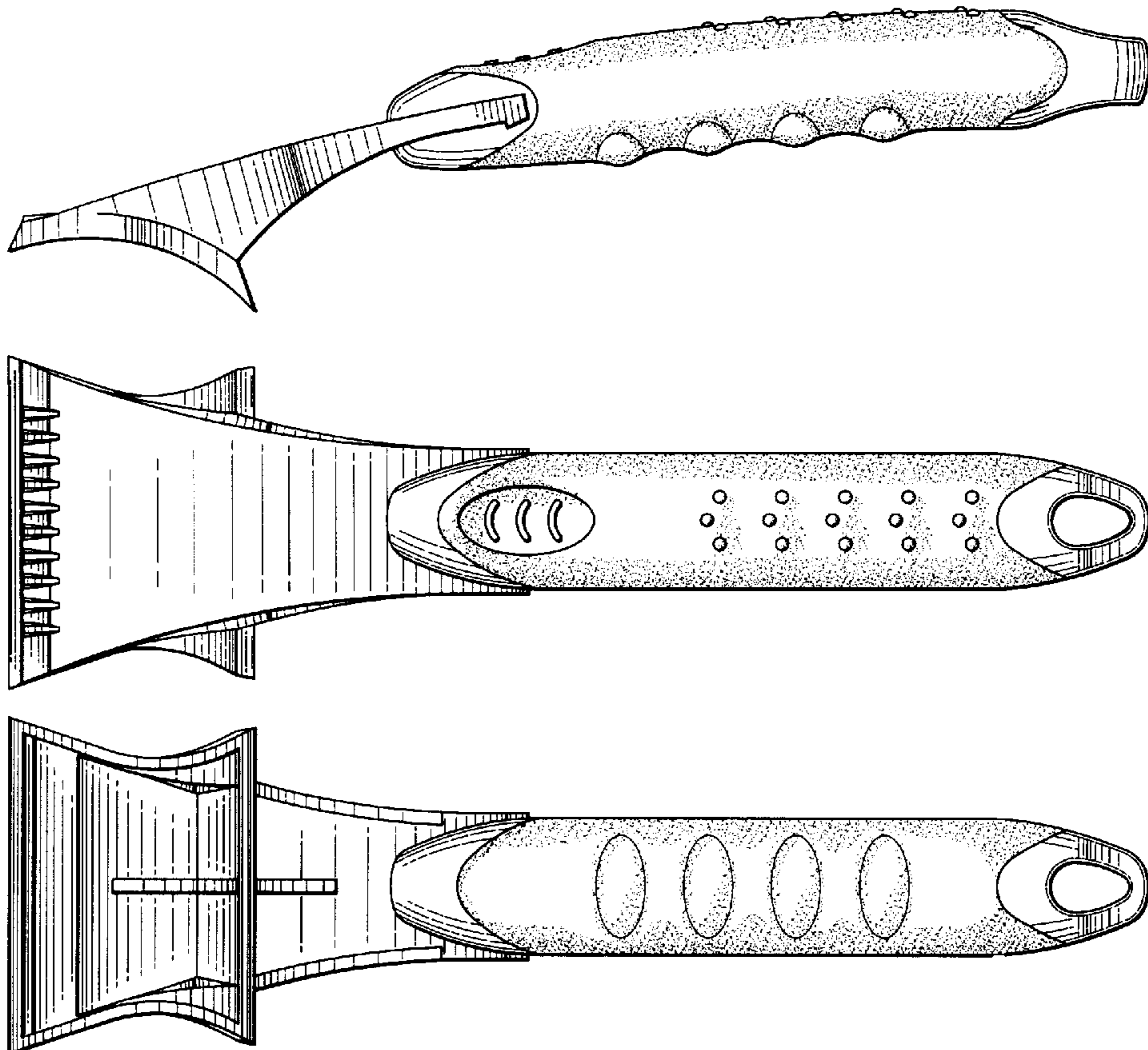

DESCRIPTION

FIG. 1 is a left side elevational view of a snow and ice
scraper embodying our design, with the right side eleva-
tional view of the scraper being a mirror image thereof;
FIG. 2 is a top plan view of the snow and ice scraper;
FIG. 3 is a bottom plan view of the snow and ice scraper;
FIG. 4 is a front elevational view of the snow and ice
scraper; and,
FIG. 5 is a rear elevational view of the snow and ice scraper.

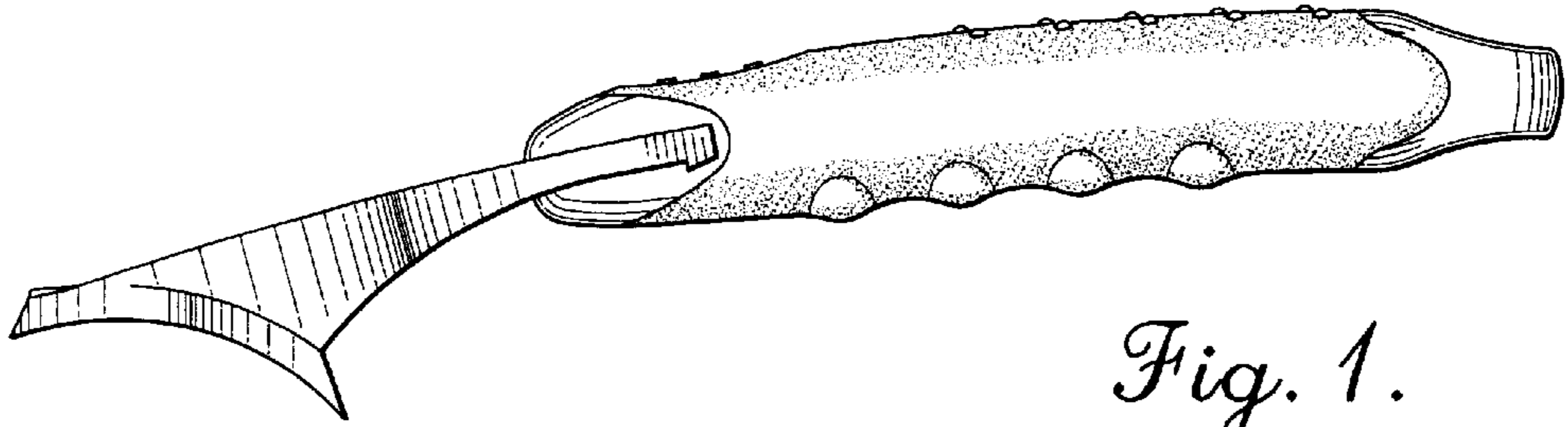

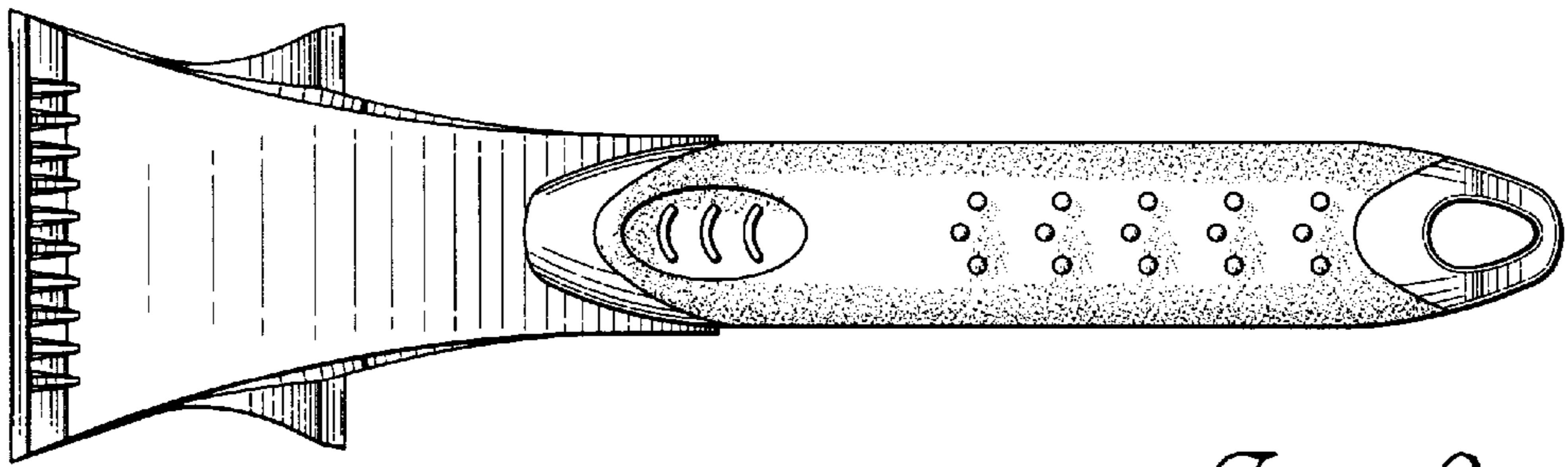

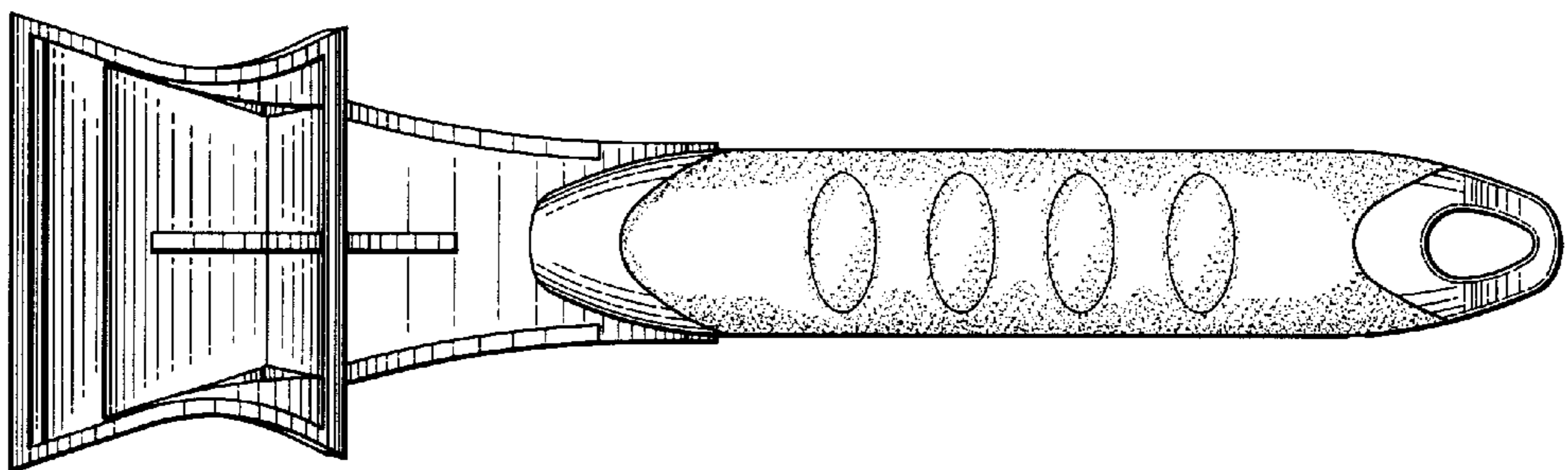

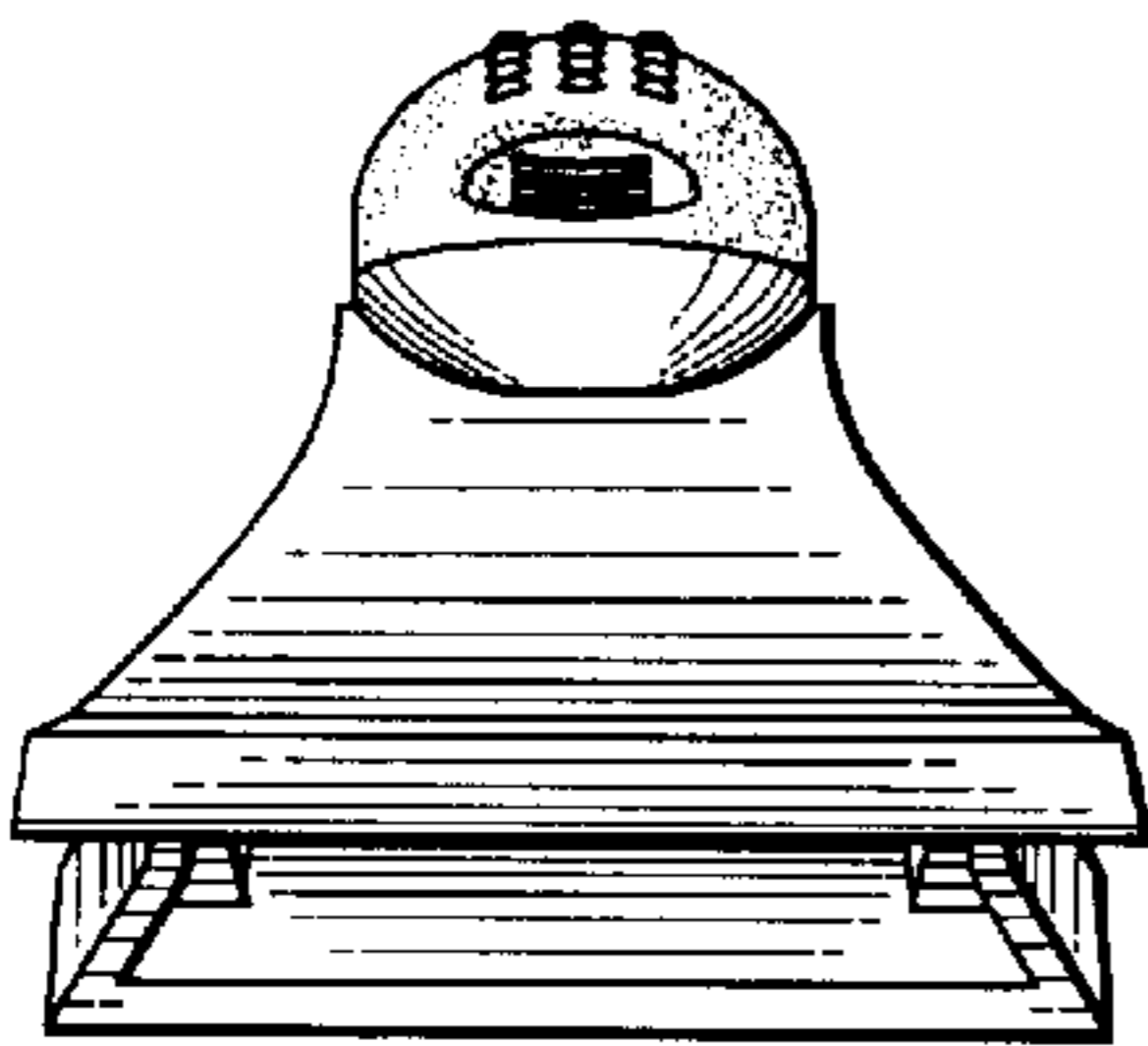

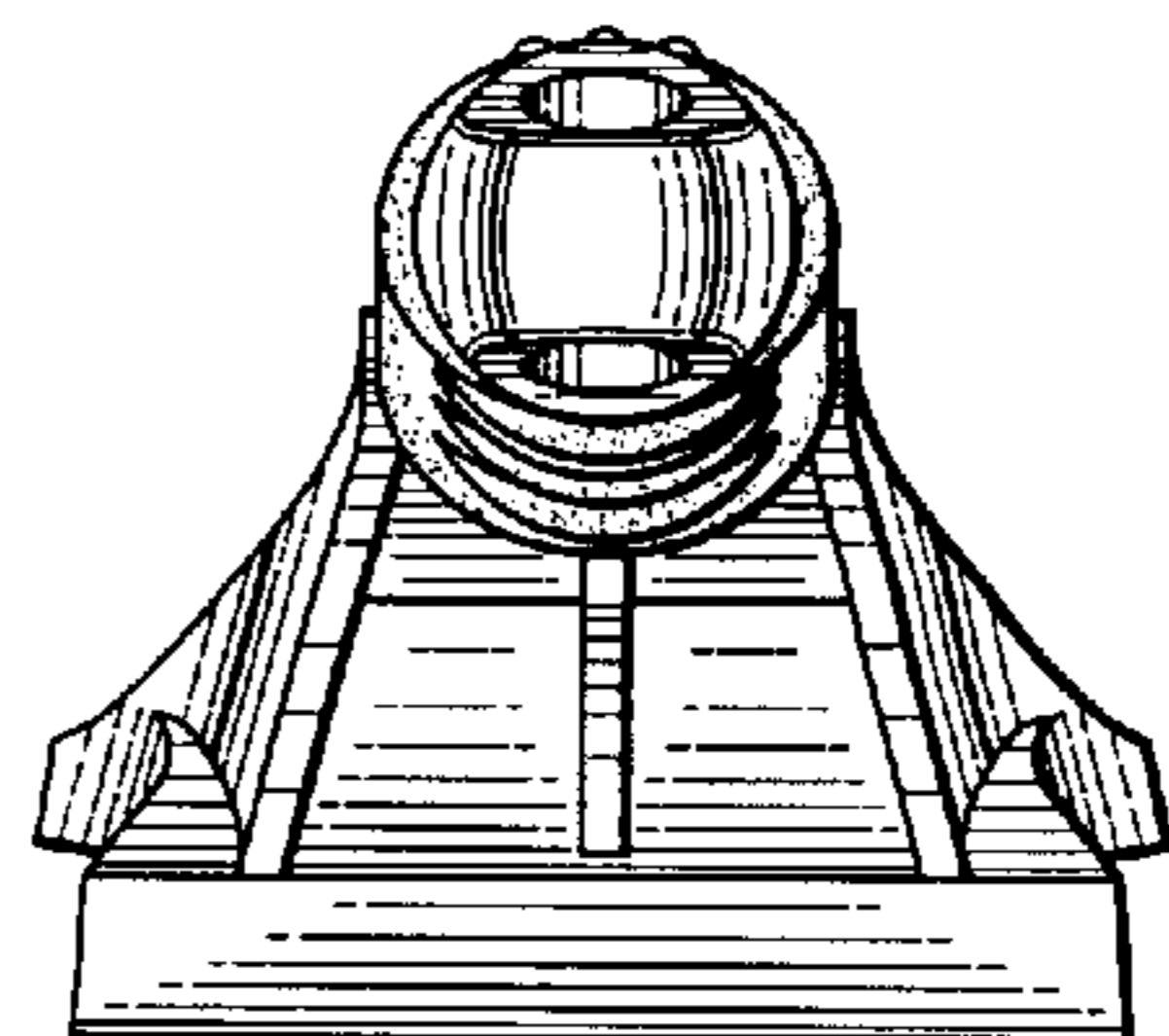
