[57] **CLAIM**

The ornamental design for a side element of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the side element of a shoe showing my new design;

FIG. 2 is a side elevational view of the side element of a shoe shown in FIG. 1;

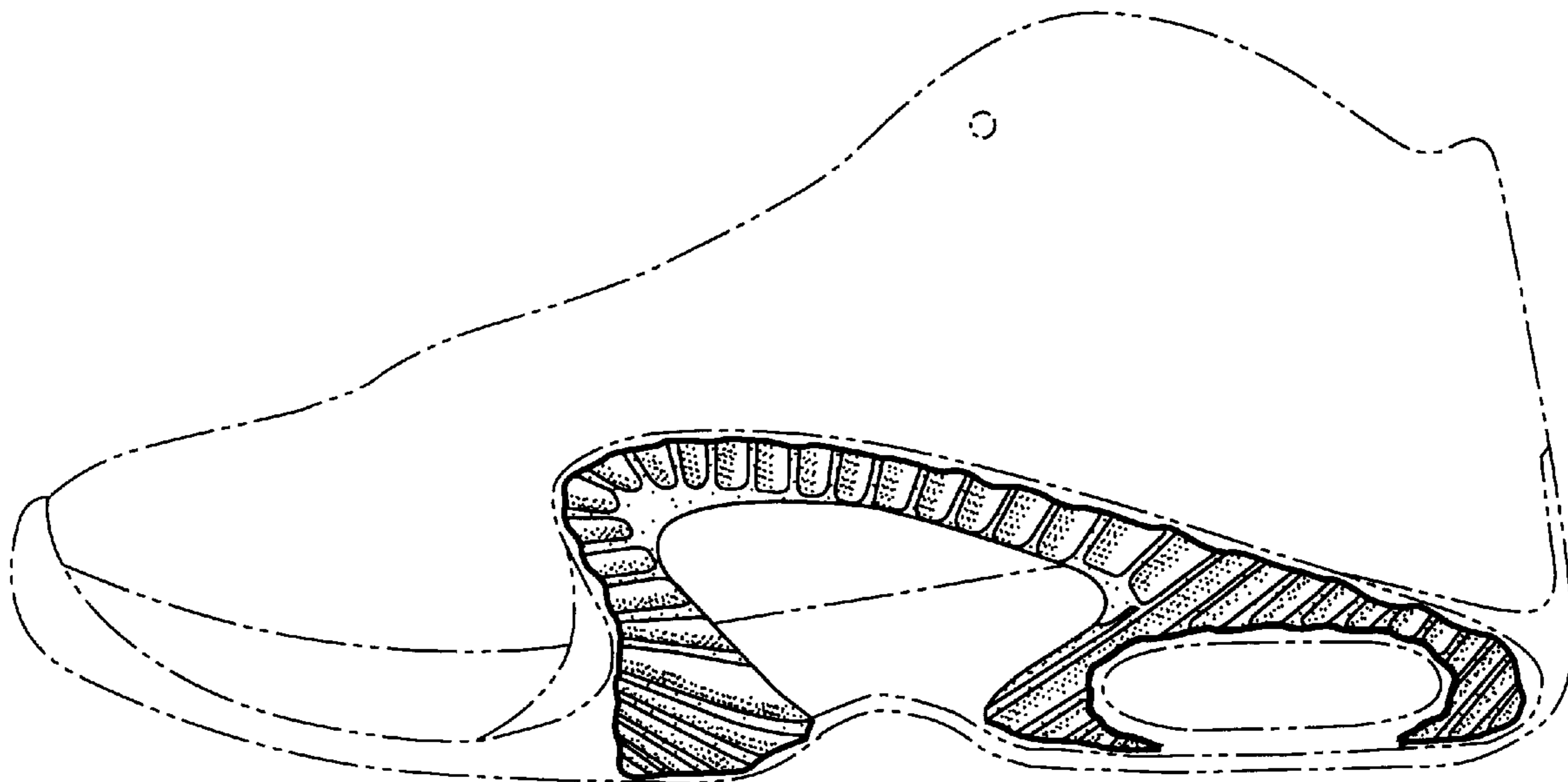
FIG. 3 is a front elevational view of the side element of a shoe shown in FIG. 1;

FIG. 4 is a rear elevational view of the side element of a shoe shown in FIG. 1; and,

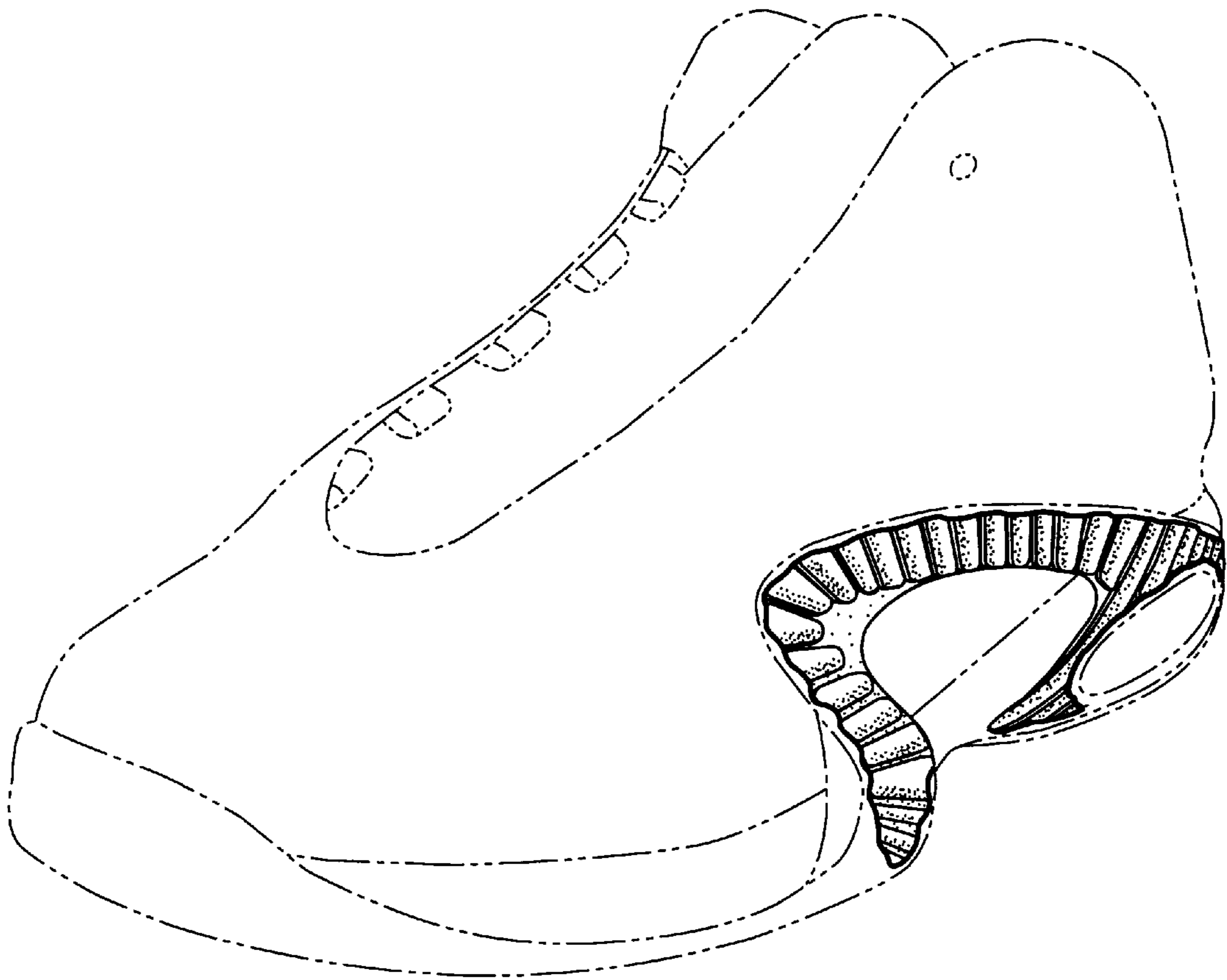

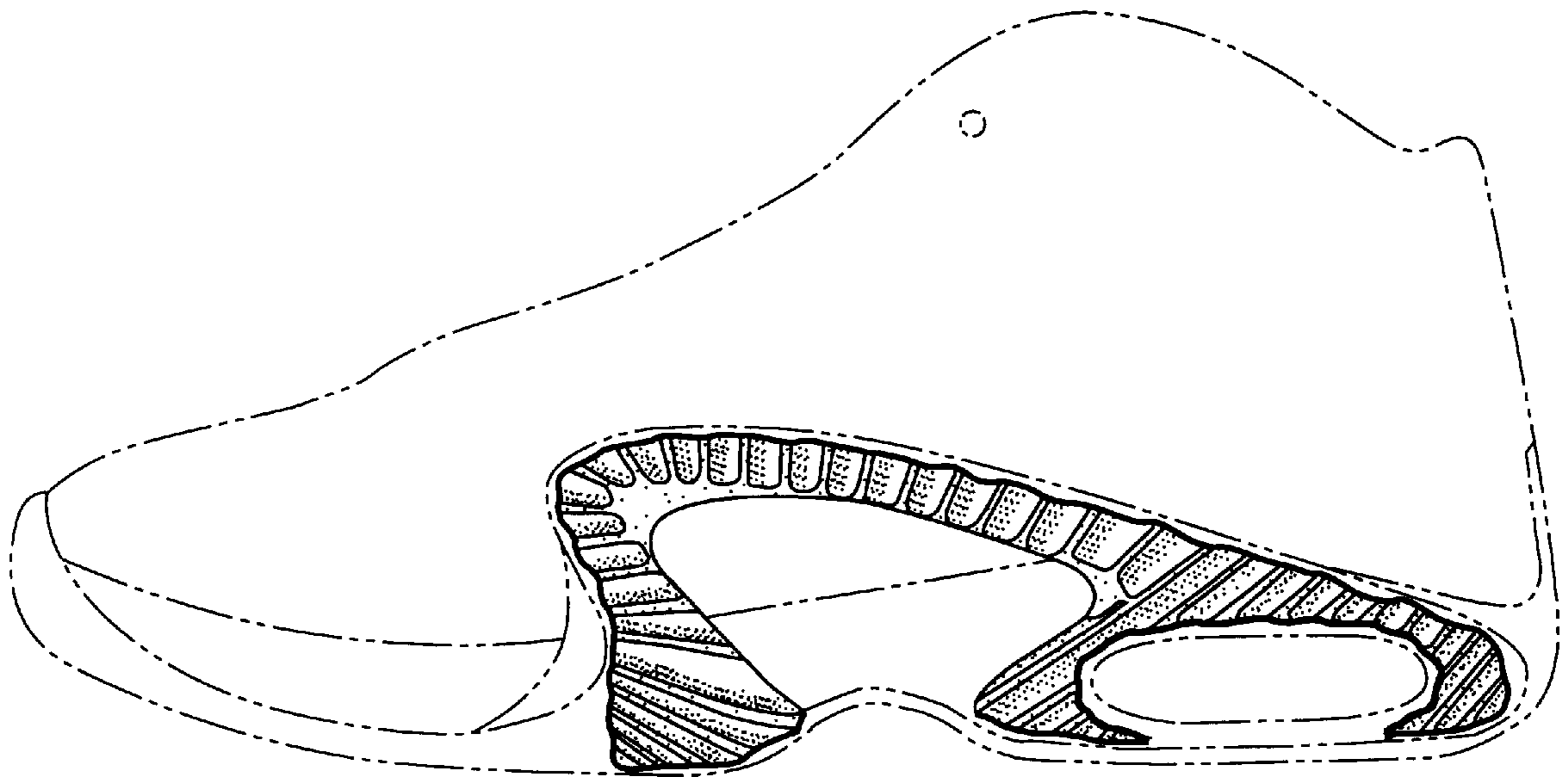

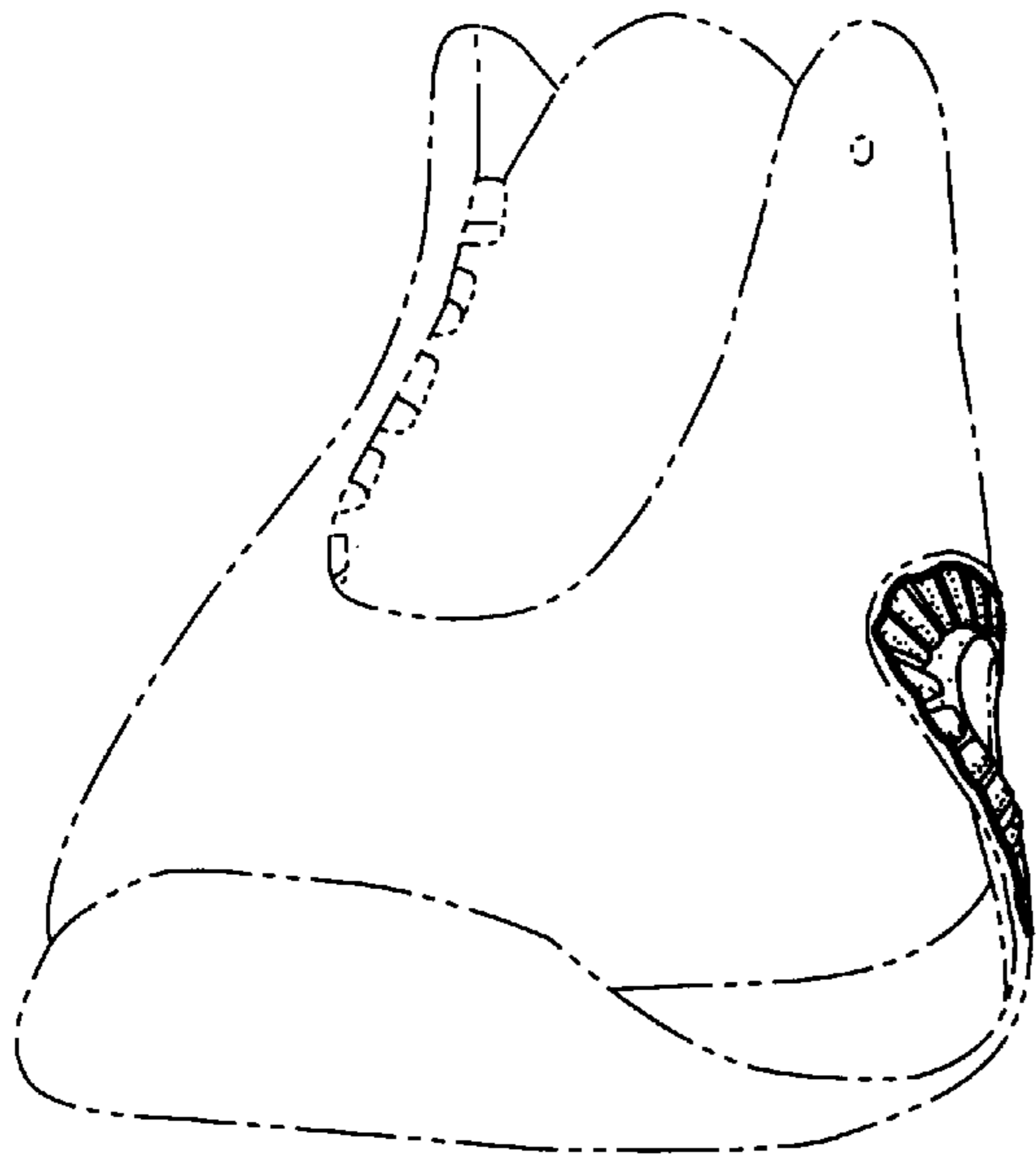

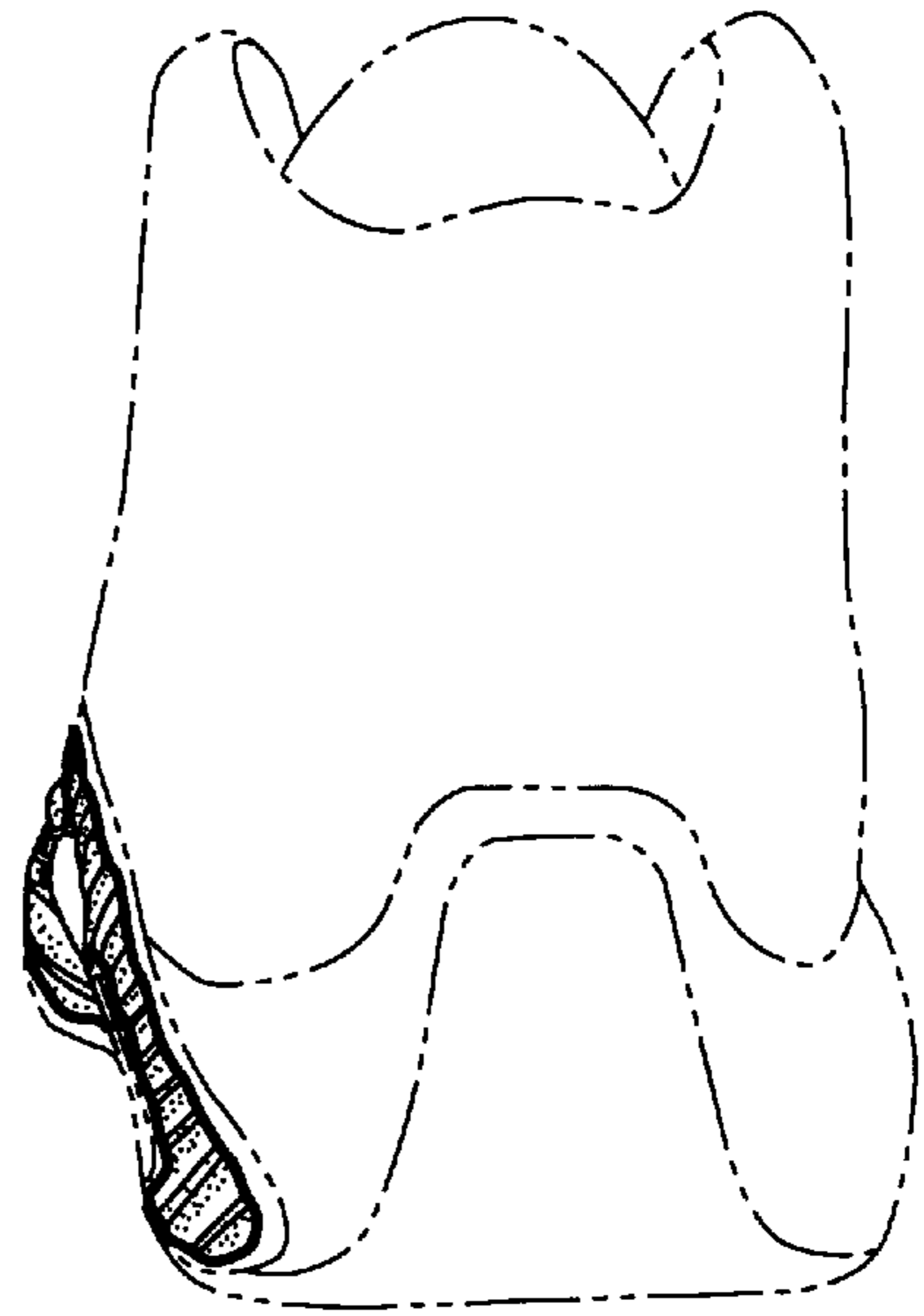

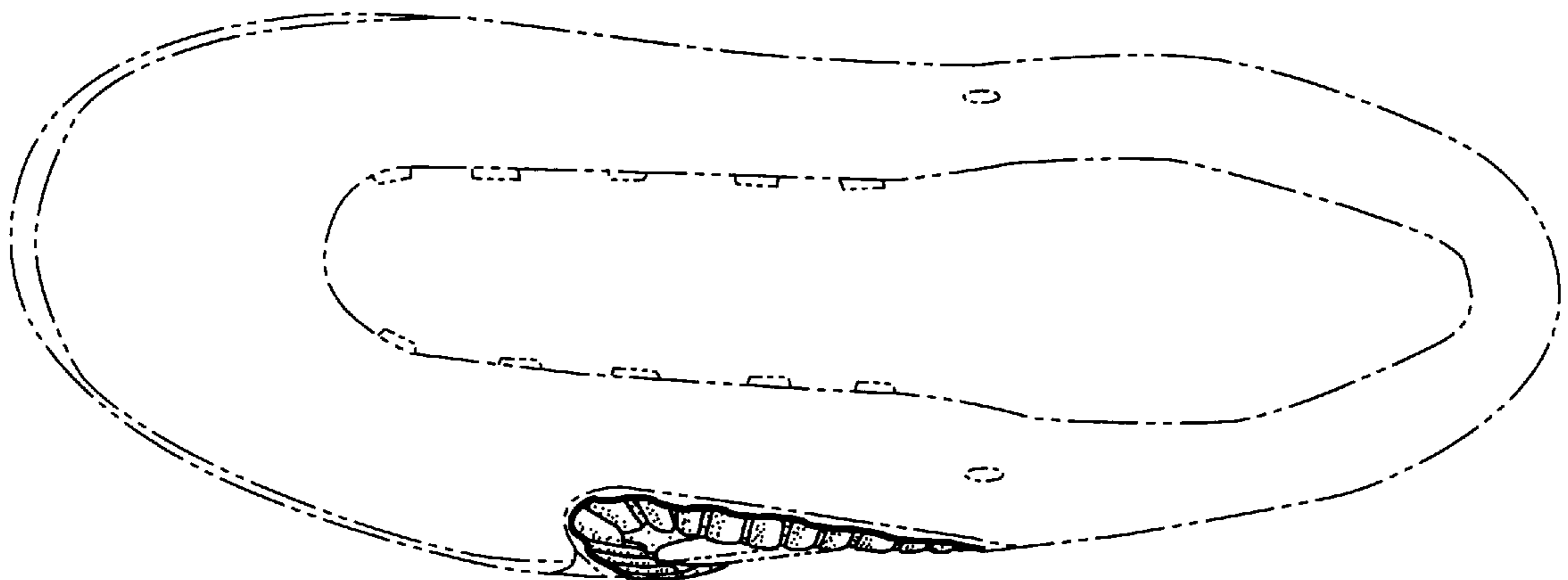
