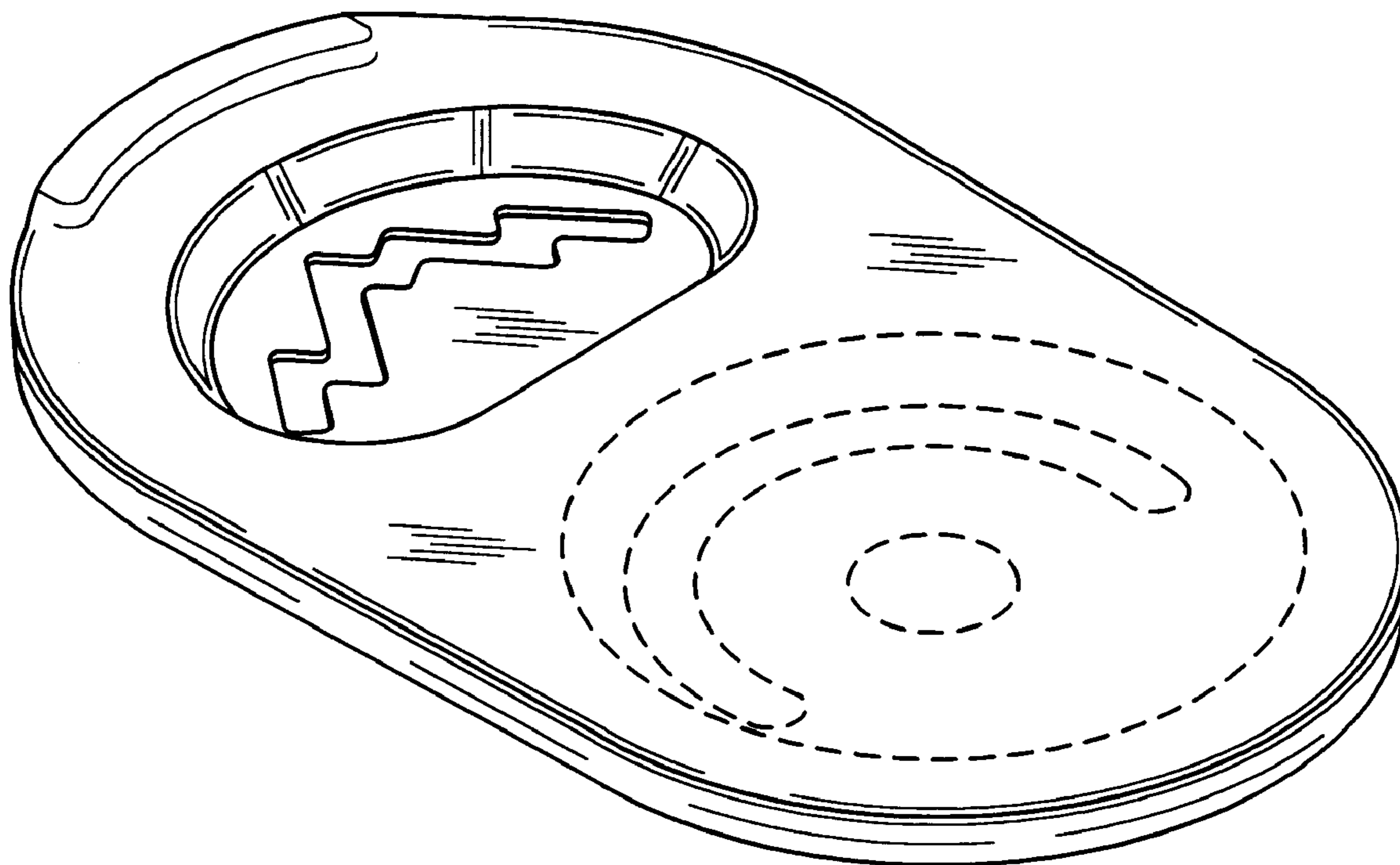
The ornamental design for a can end tab, as shown and described.

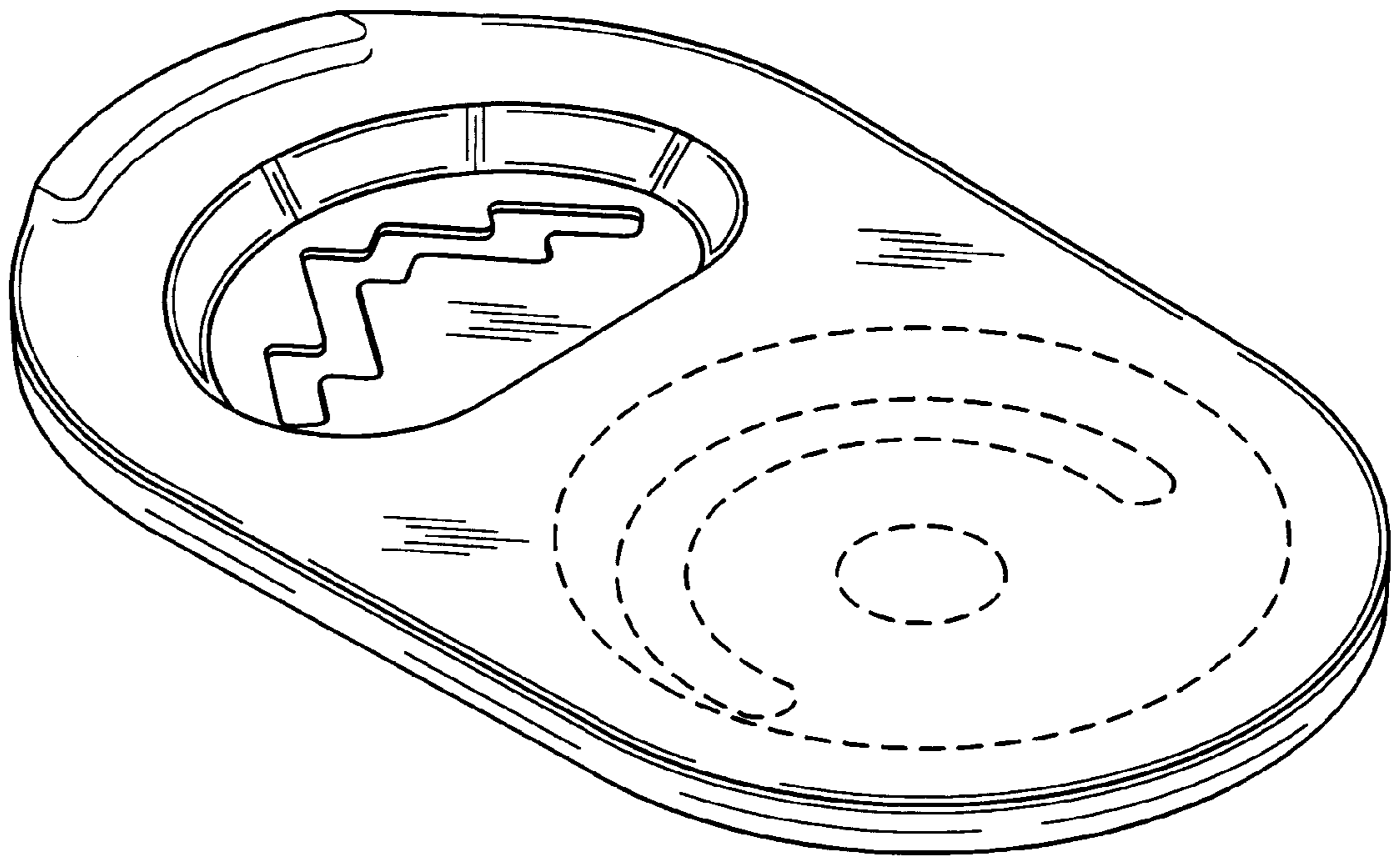
**DESCRIPTION**

FIG. 1 is a top perspective view of a can end tab;  
FIG. 2 is a rear perspective view of the can end tab of FIG. 1;  
FIG. 3 is a top plan view of the can end tab of FIG. 1;  
FIG. 4 is a bottom plan view of the can end tab of FIG. 1;  
FIG. 5 is a left side elevation view of the can end tab of FIG. 1 of which the right side elevation view a mirror image;  
FIG. 6 is a rear elevation view of the can end tab of FIG. 1; and,  
FIG. 7 is a front elevation view of the can end tab of FIG. 1.

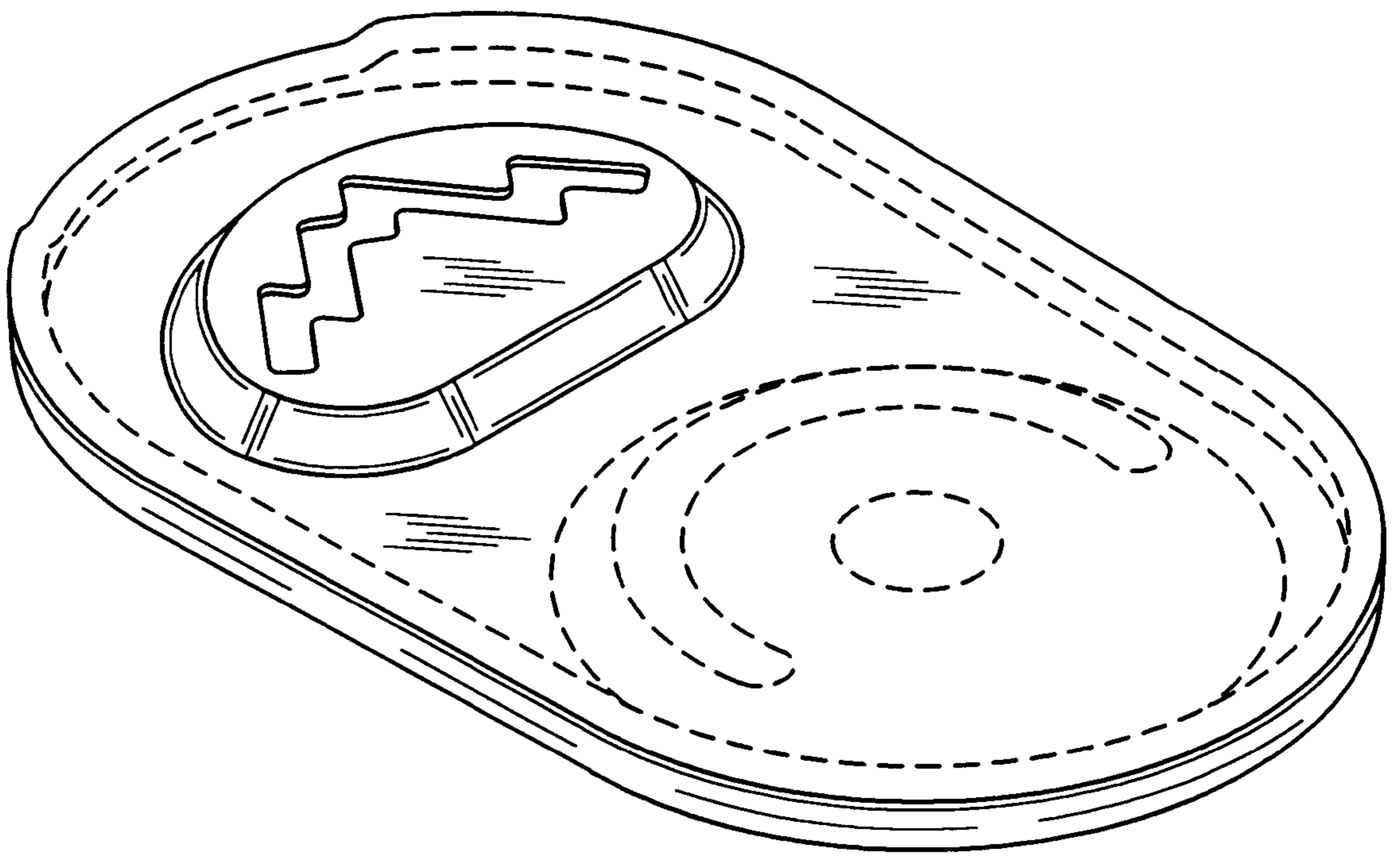

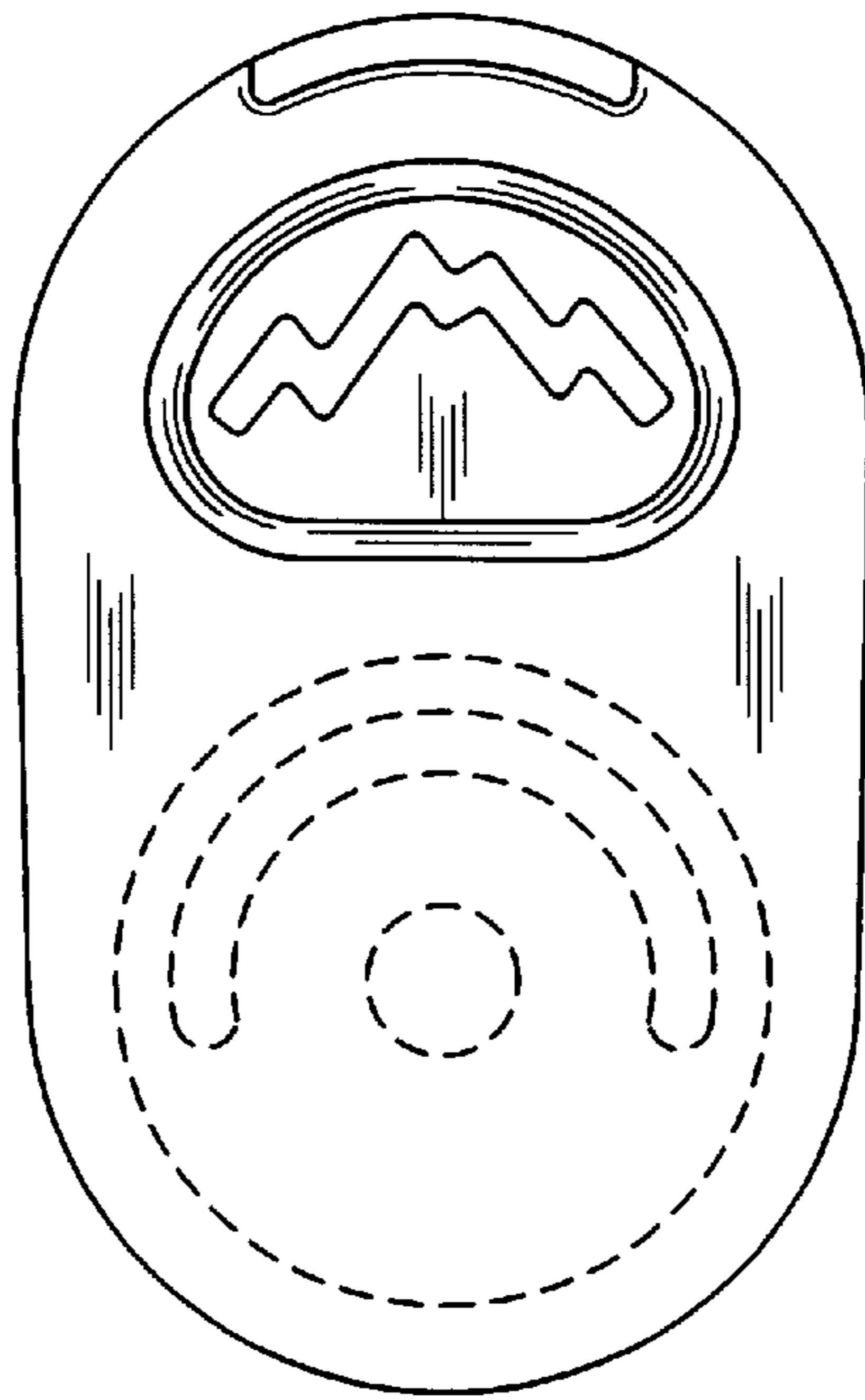




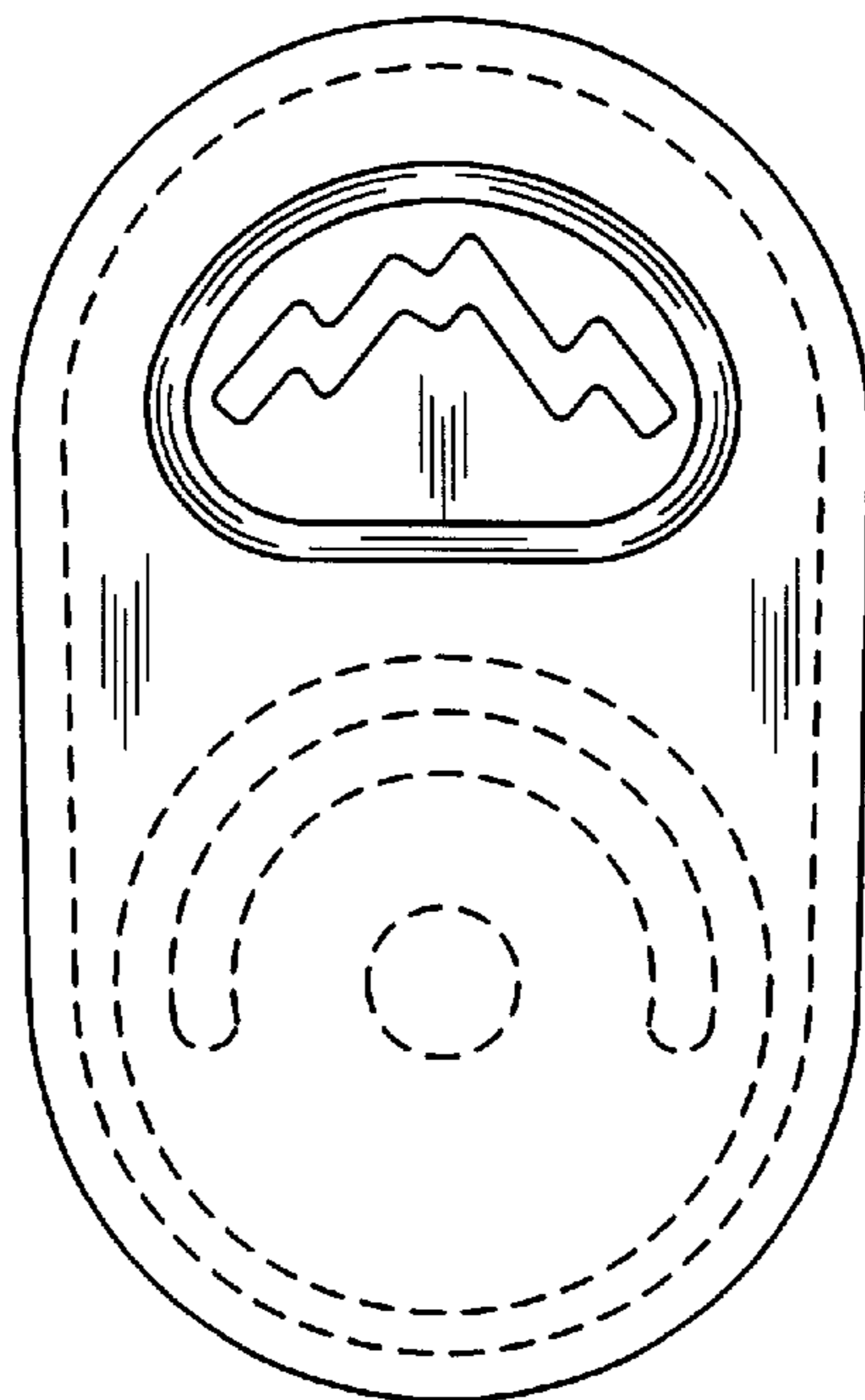

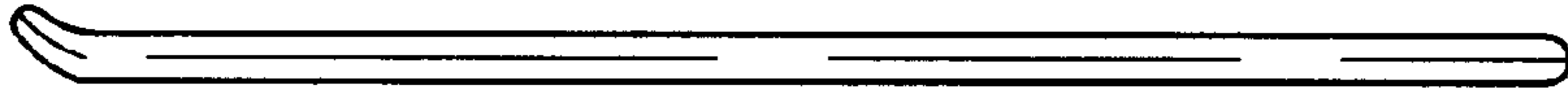

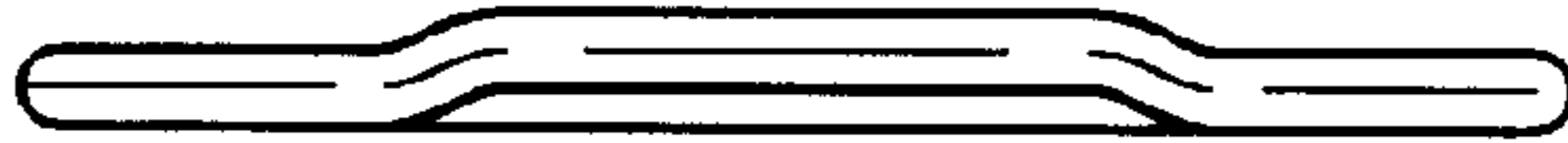

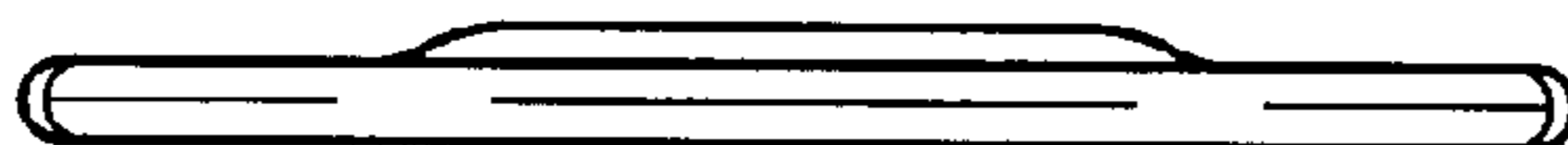
