The ornamental design for a wristwatch, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the front, inside rear and one side of a wristwatch showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a perspective view of the front, the opposite side and inside rear thereof;
FIG. 4 is an end elevational view of one side thereof;
FIG. 5 is a side elevational view of the opposite side thereof;
FIG. 6 is an end elevational view of the opposite side thereof; and,
FIG. 7 is a side elevational view of said one side thereof.

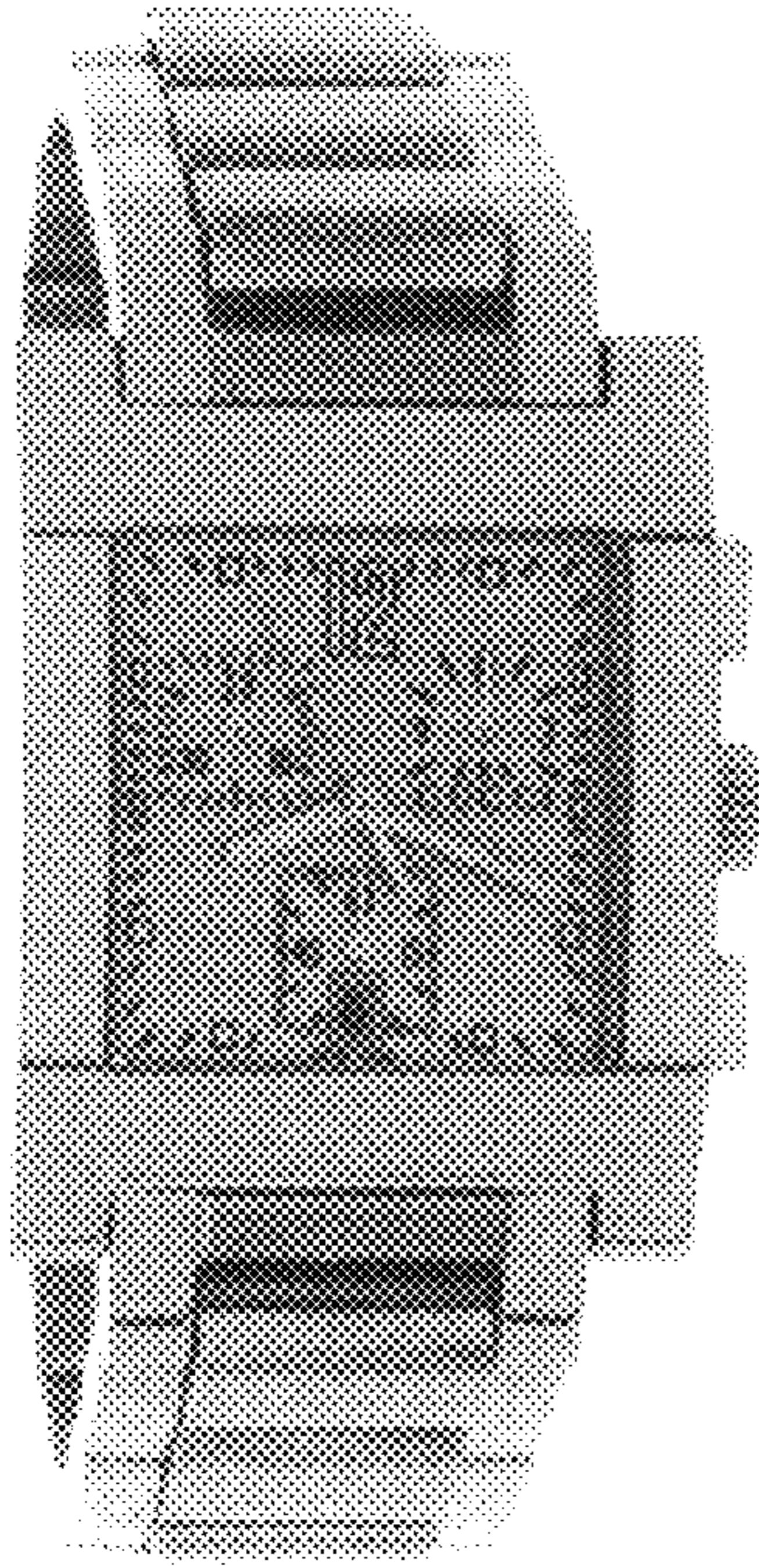

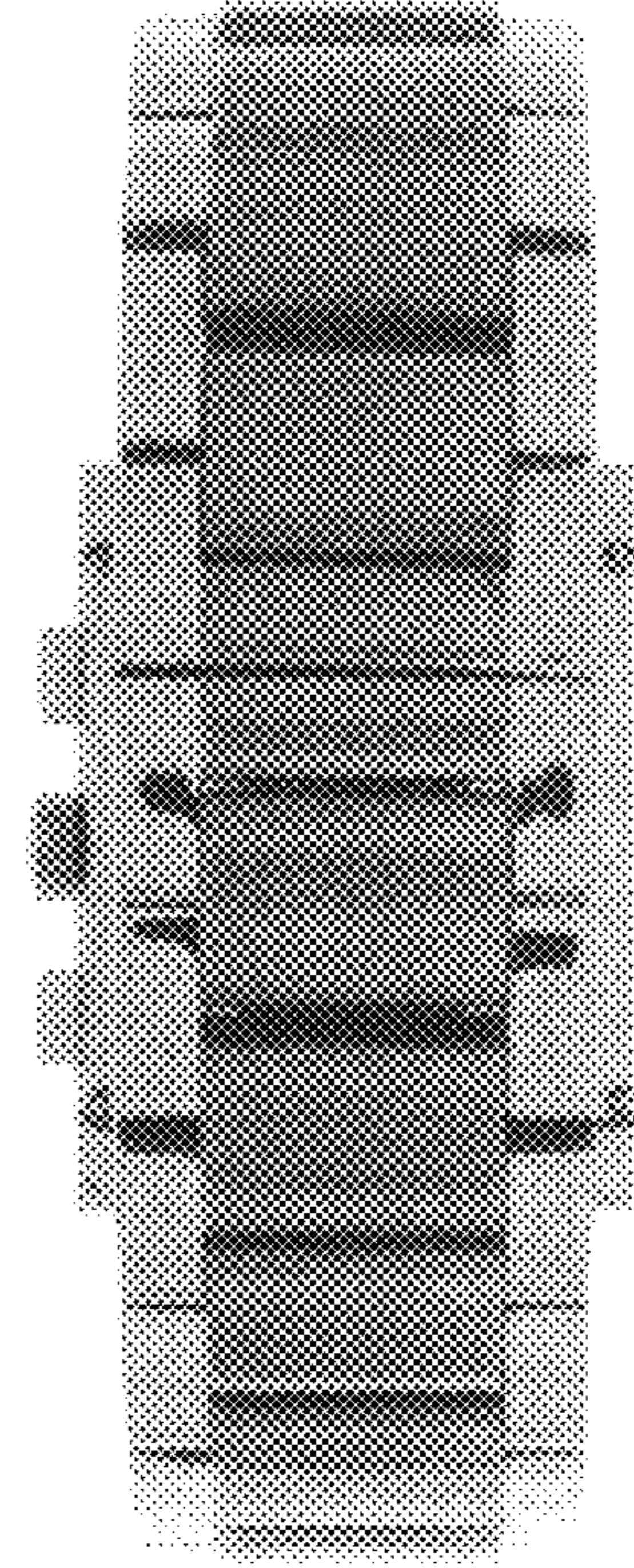

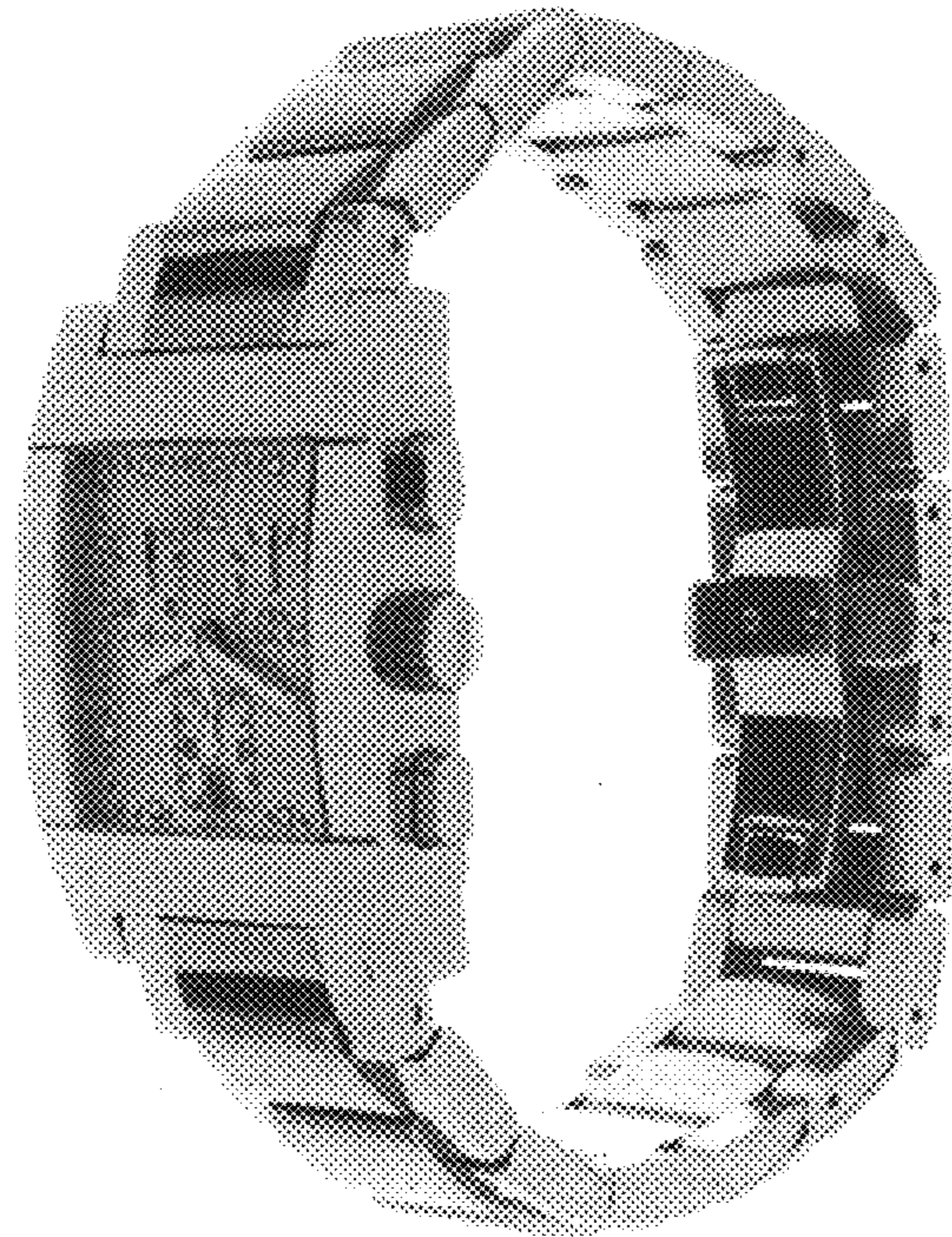

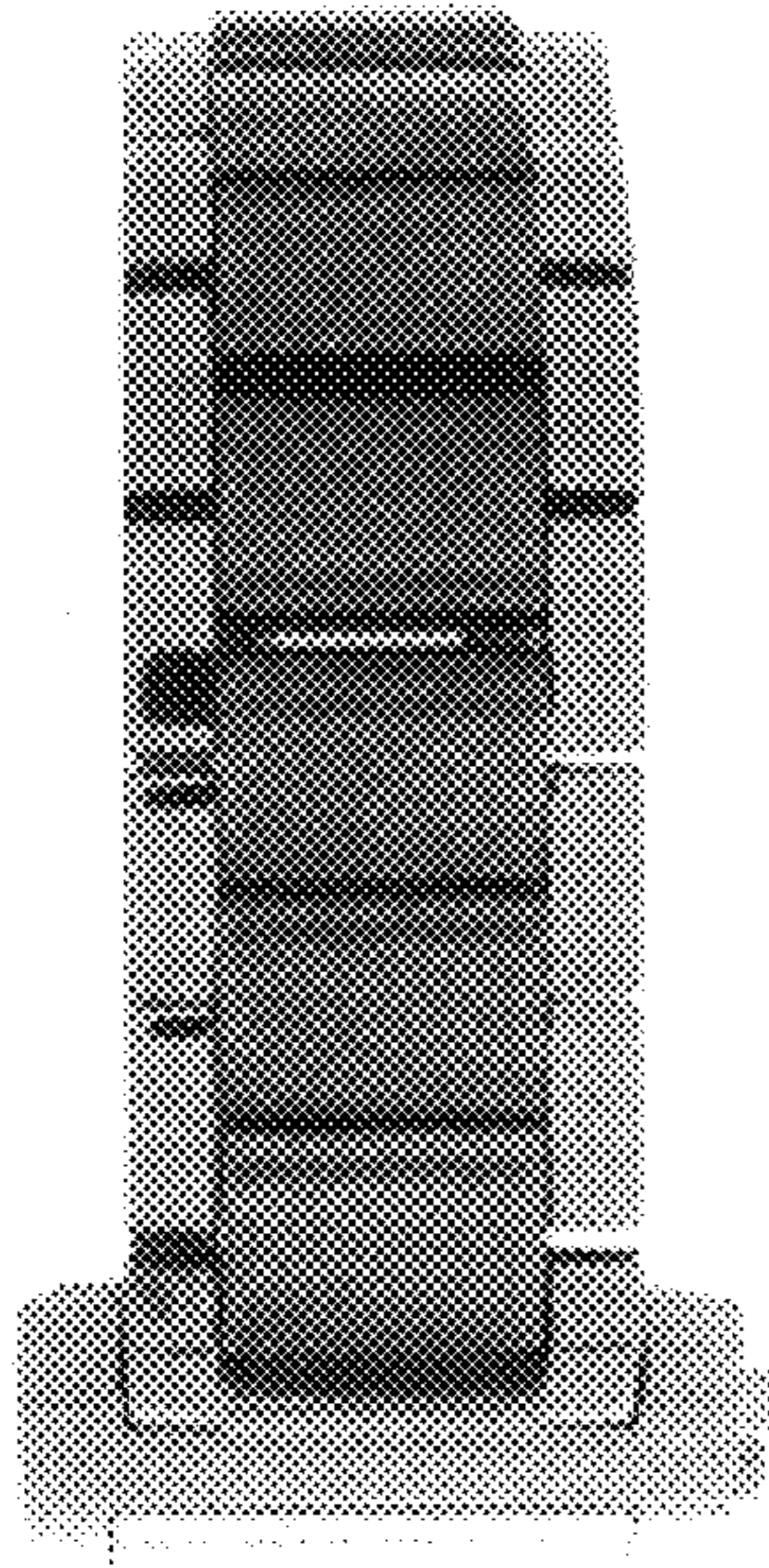

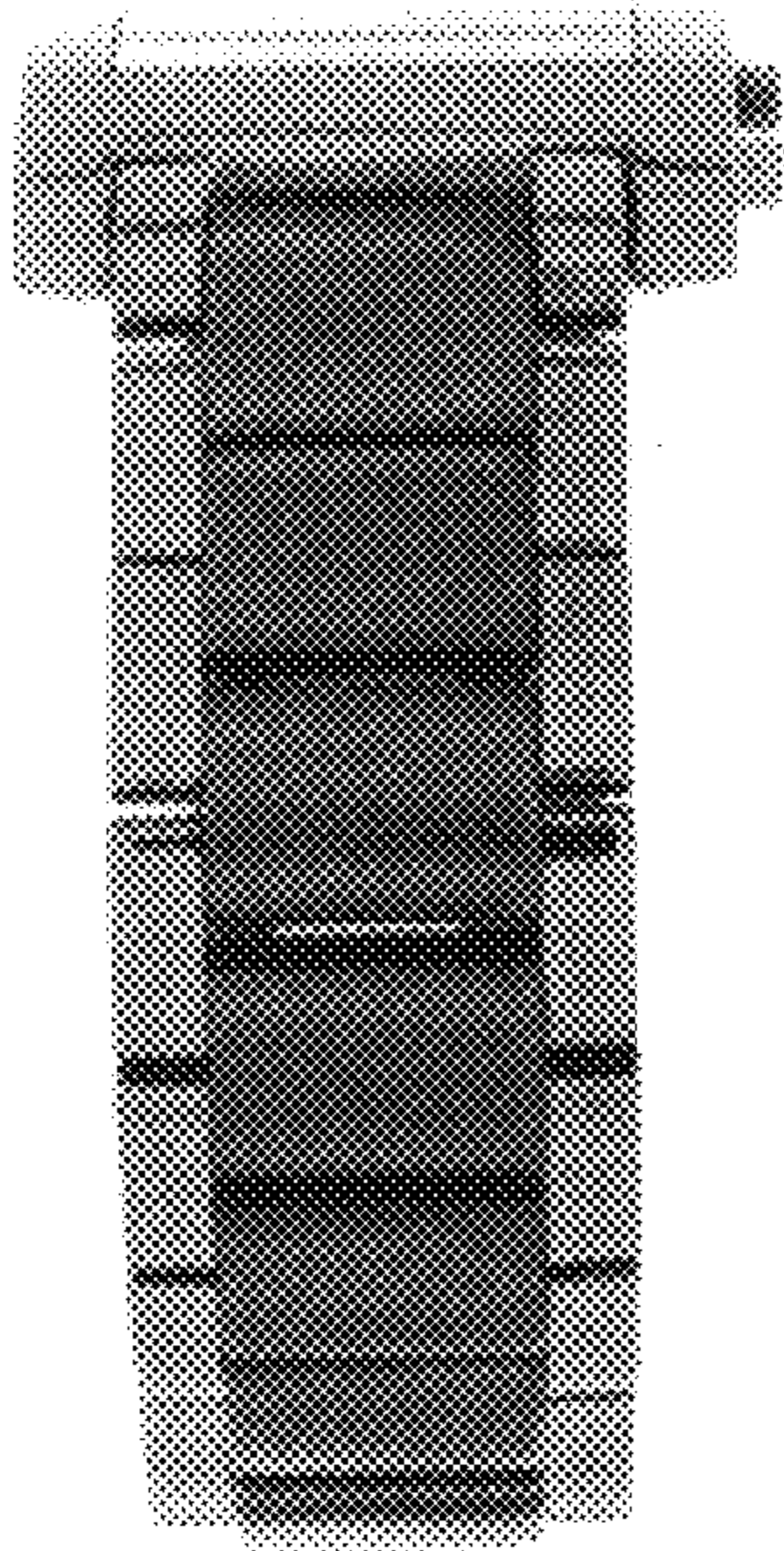

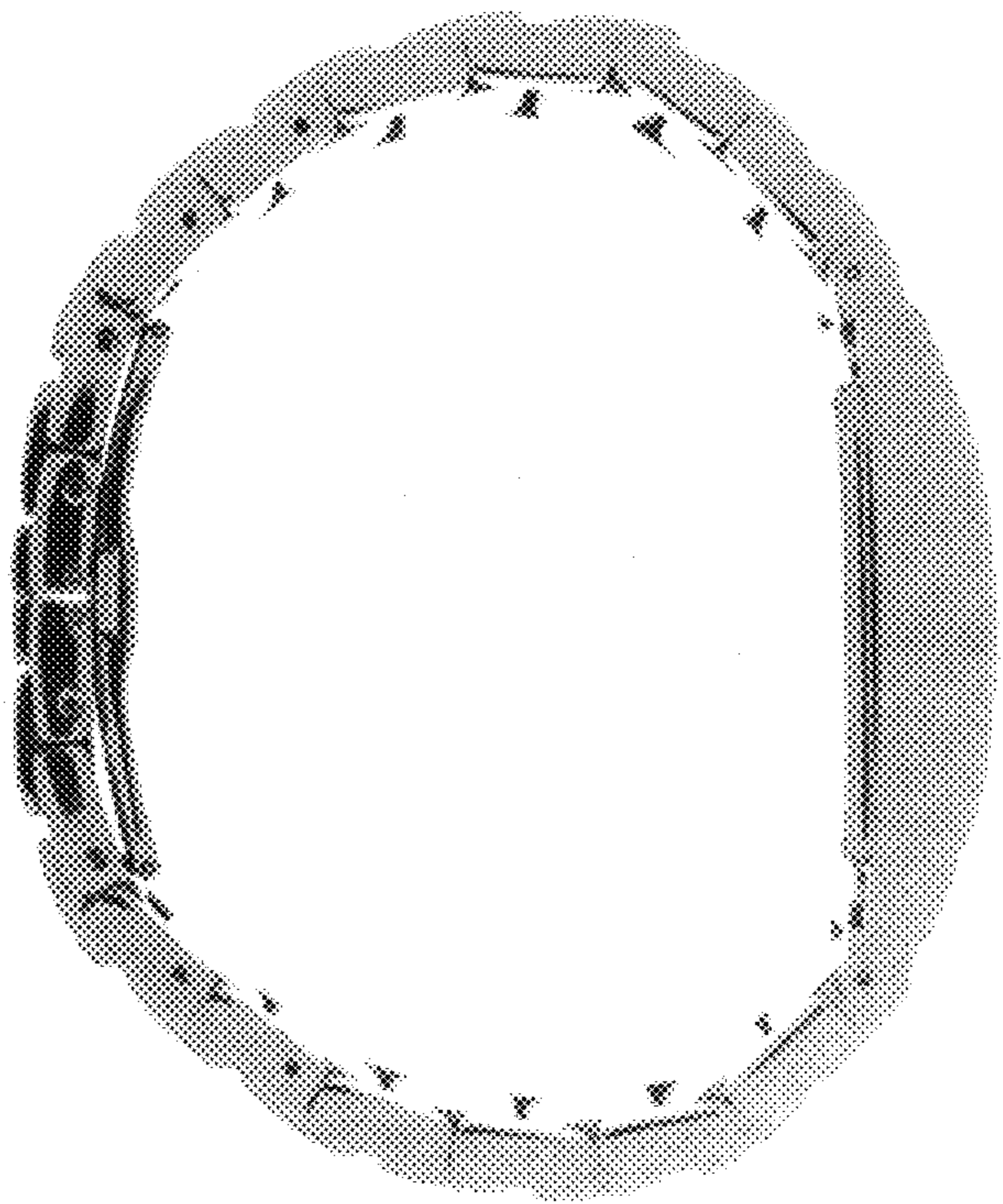
