[57] **CLAIM**

The ornamental design for a telephone answering machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a telephone answering machine showing our new design; FIG. 2 is a front elevation view of the telephone answering machine of FIG. 1; FIG. 3 is a top plan view of the telephone answering machine of FIG. 1; FIG. 4 is a rear elevation view of the telephone answering machine of FIG. 1; FIG. 5 is a bottom plan view of the telephone answering machine of FIG. 1; FIG. 6 is a right side elevation view of the telephone answering machine of FIG. 1; and, FIG. 7 is a left side elevation view of the telephone answering machine of FIG. 1.

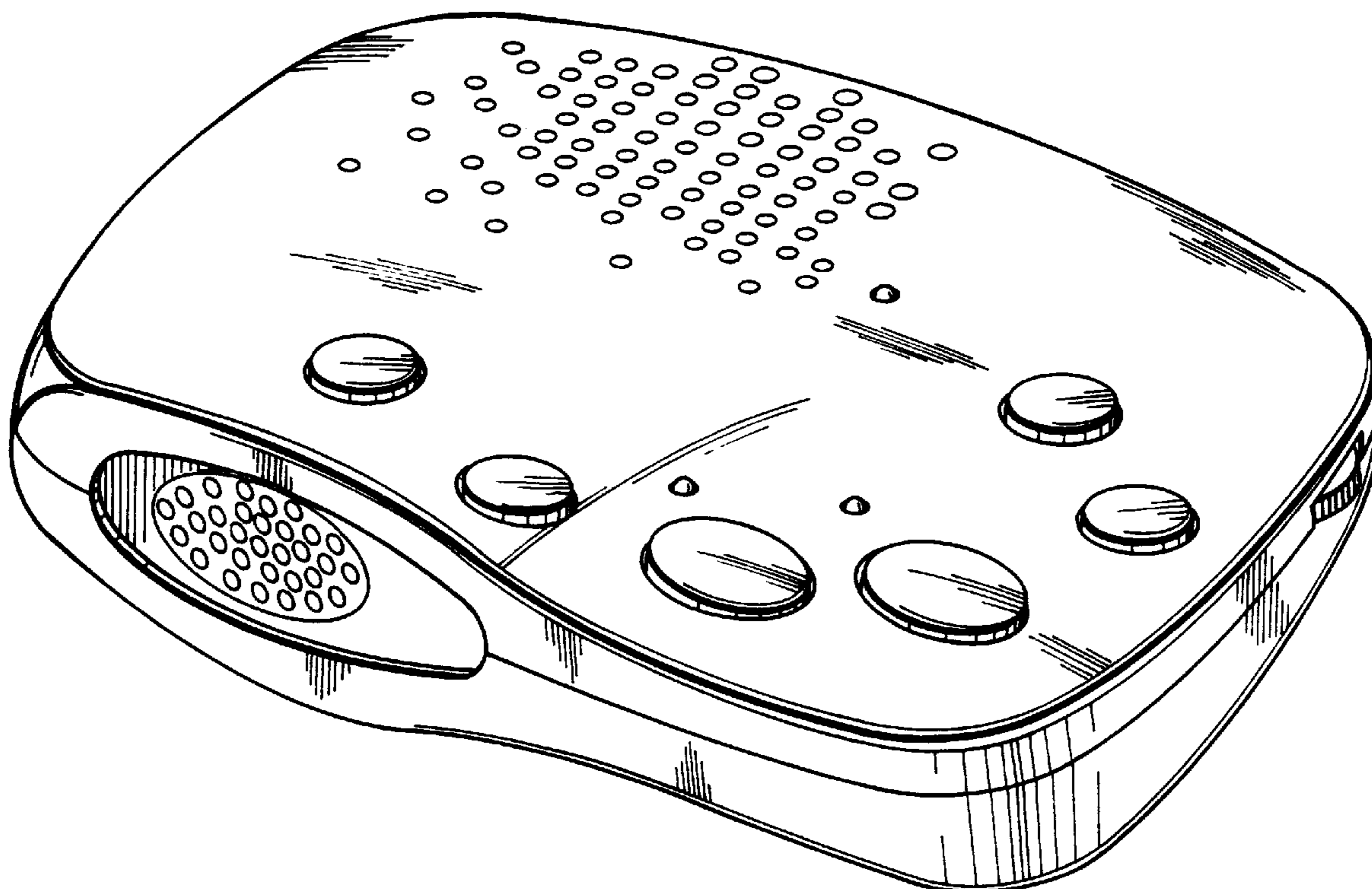

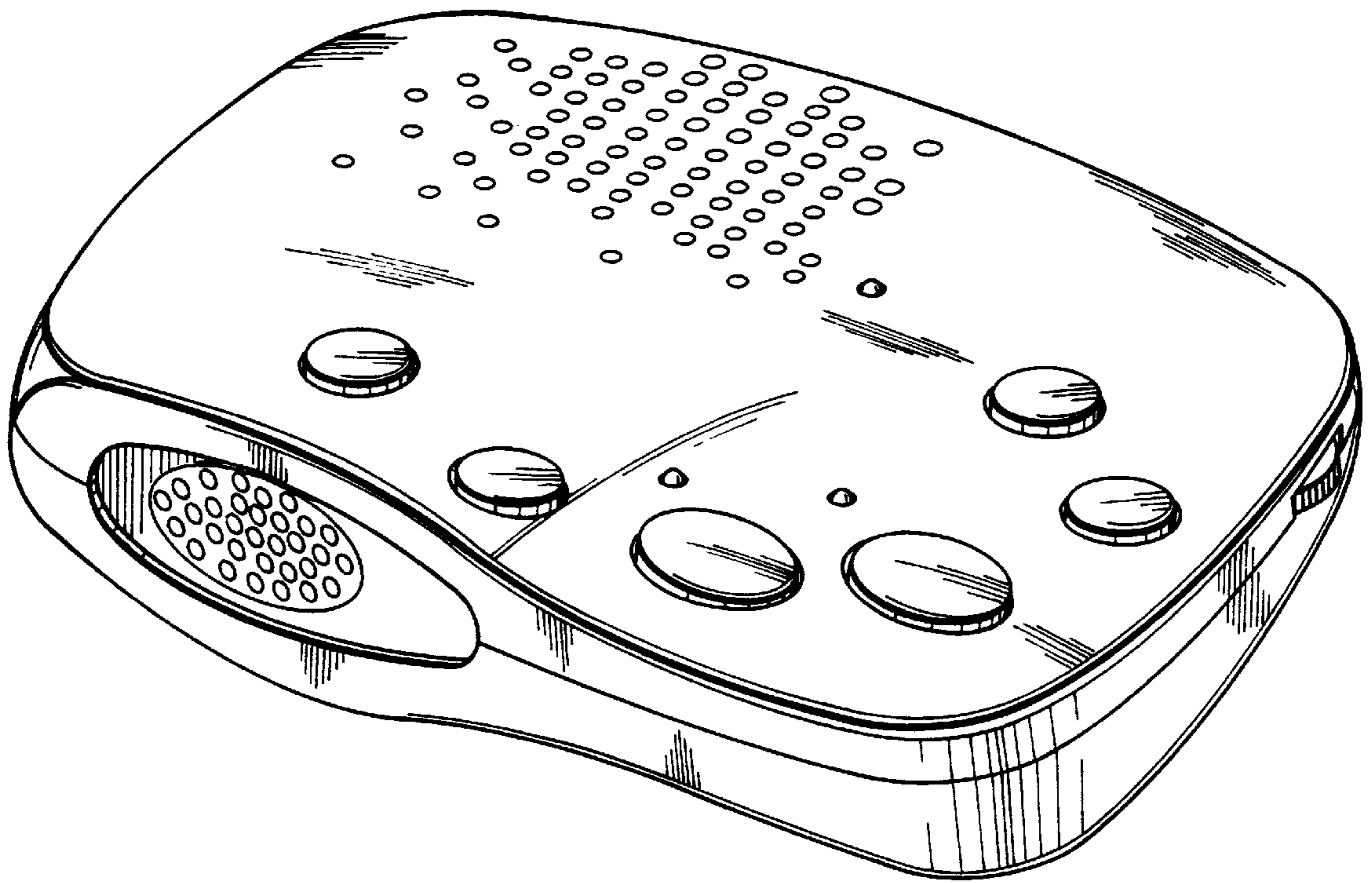

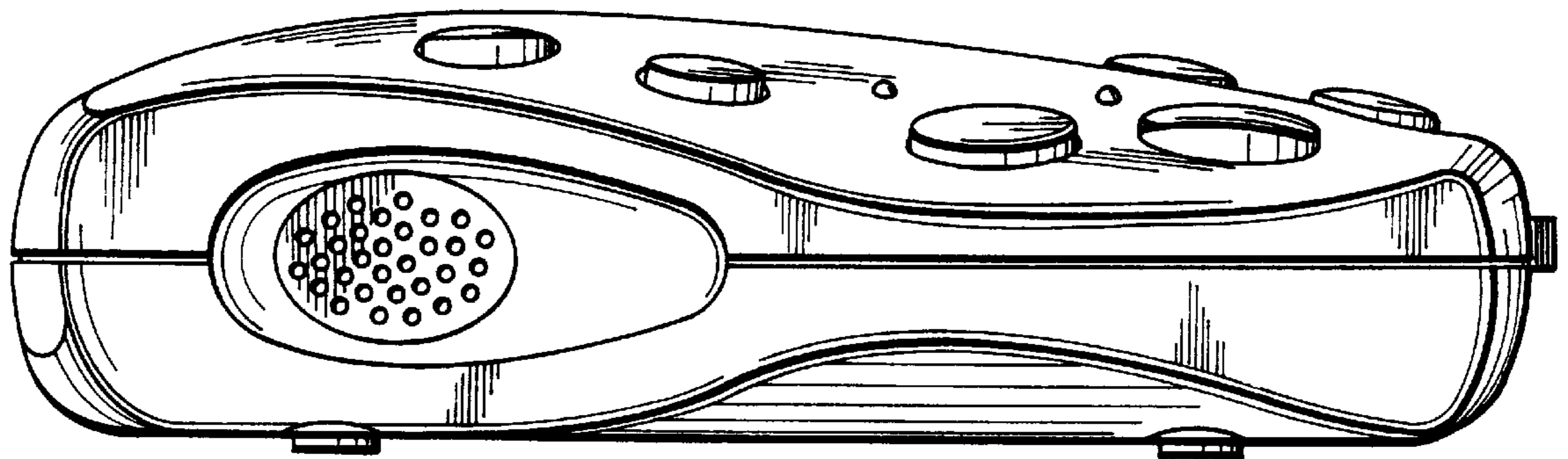

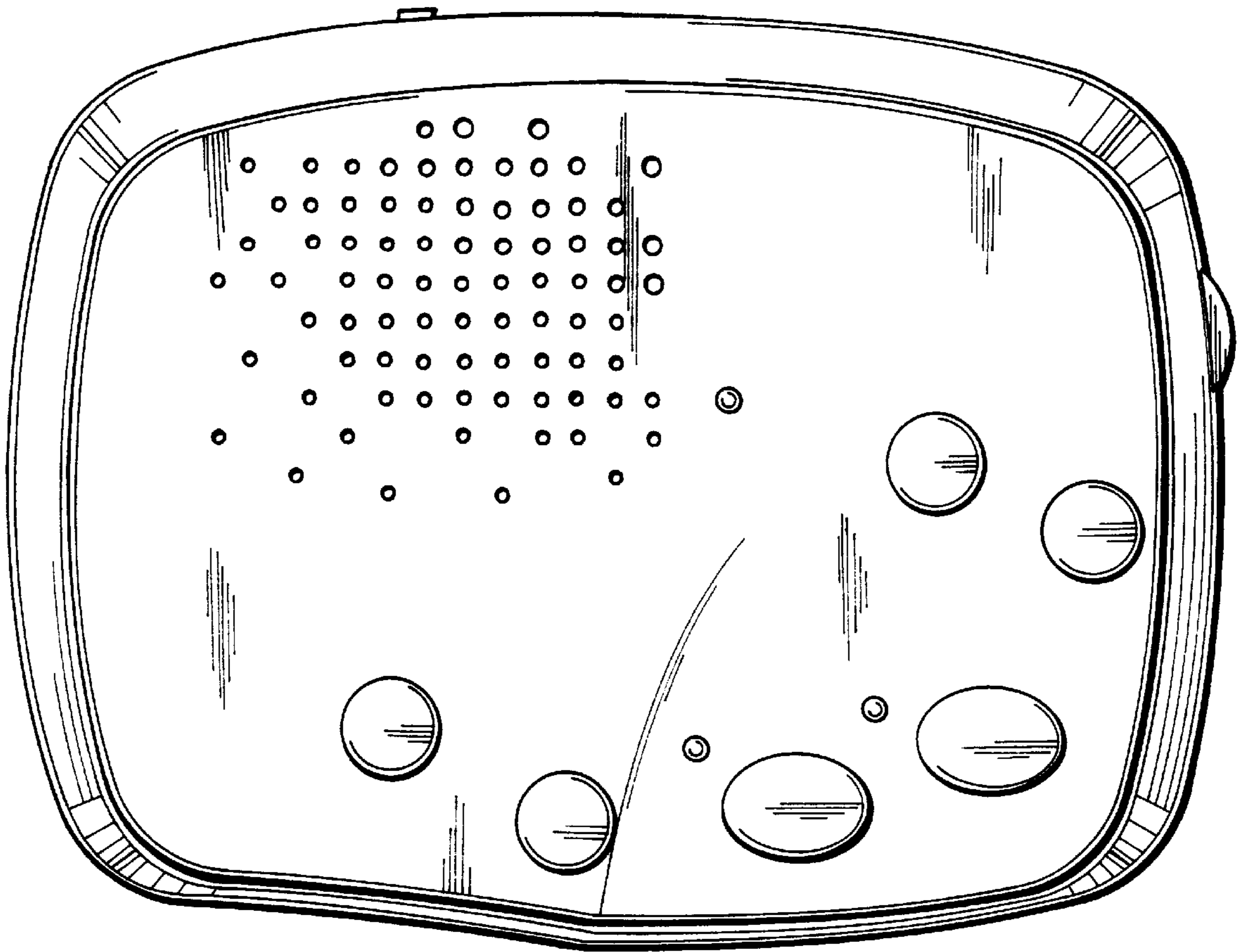

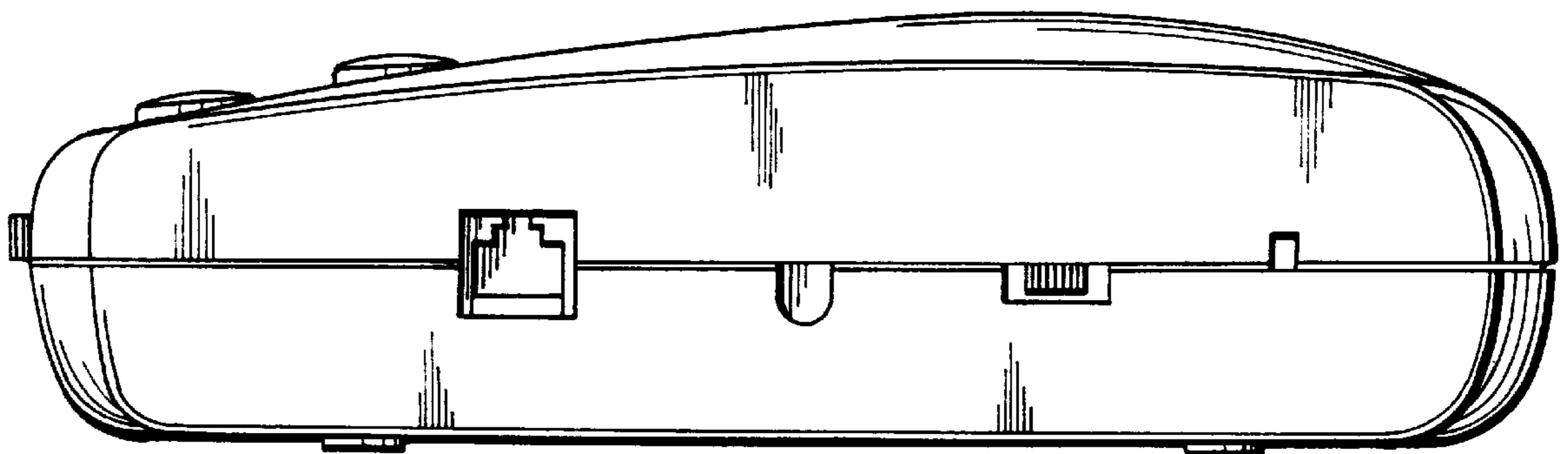

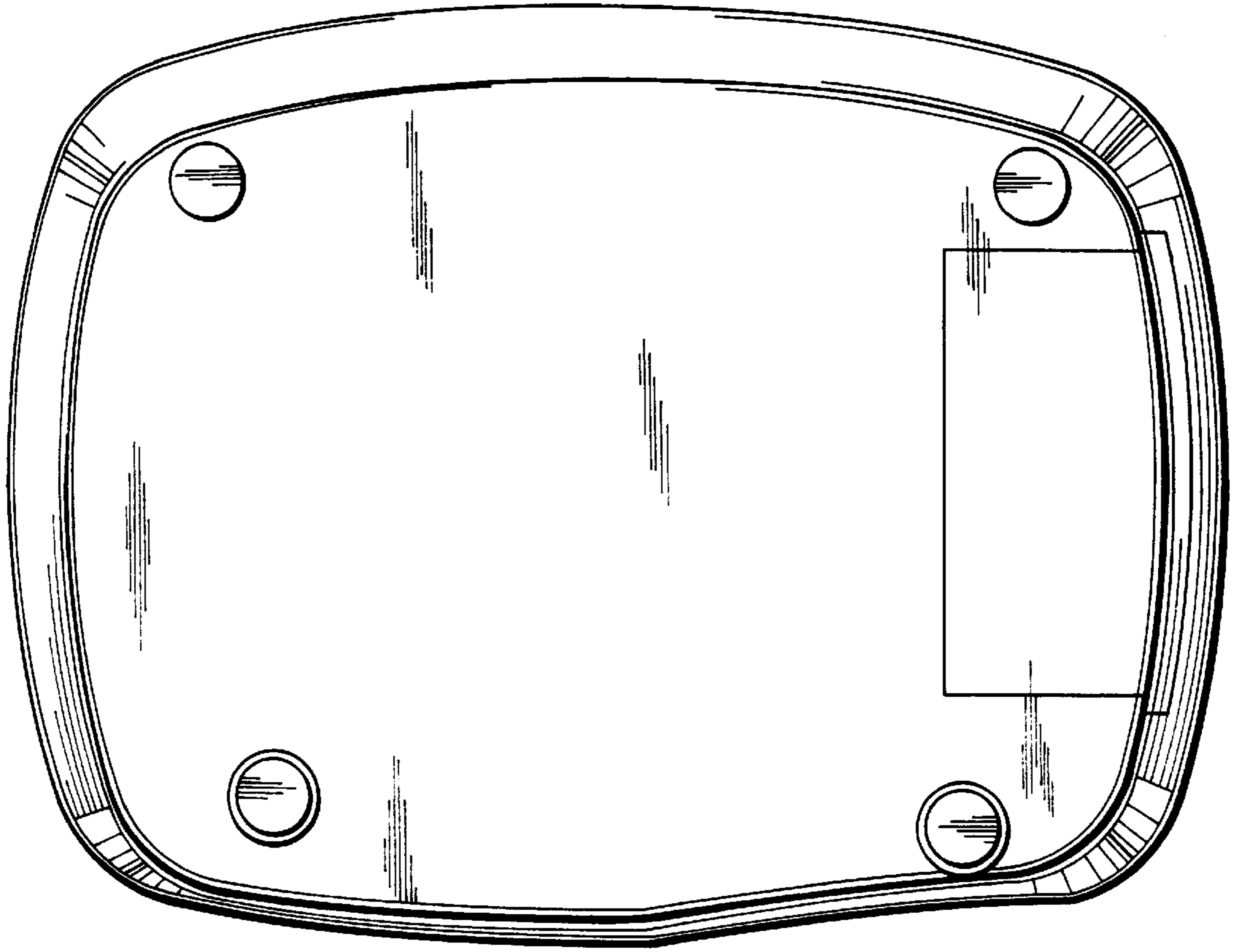

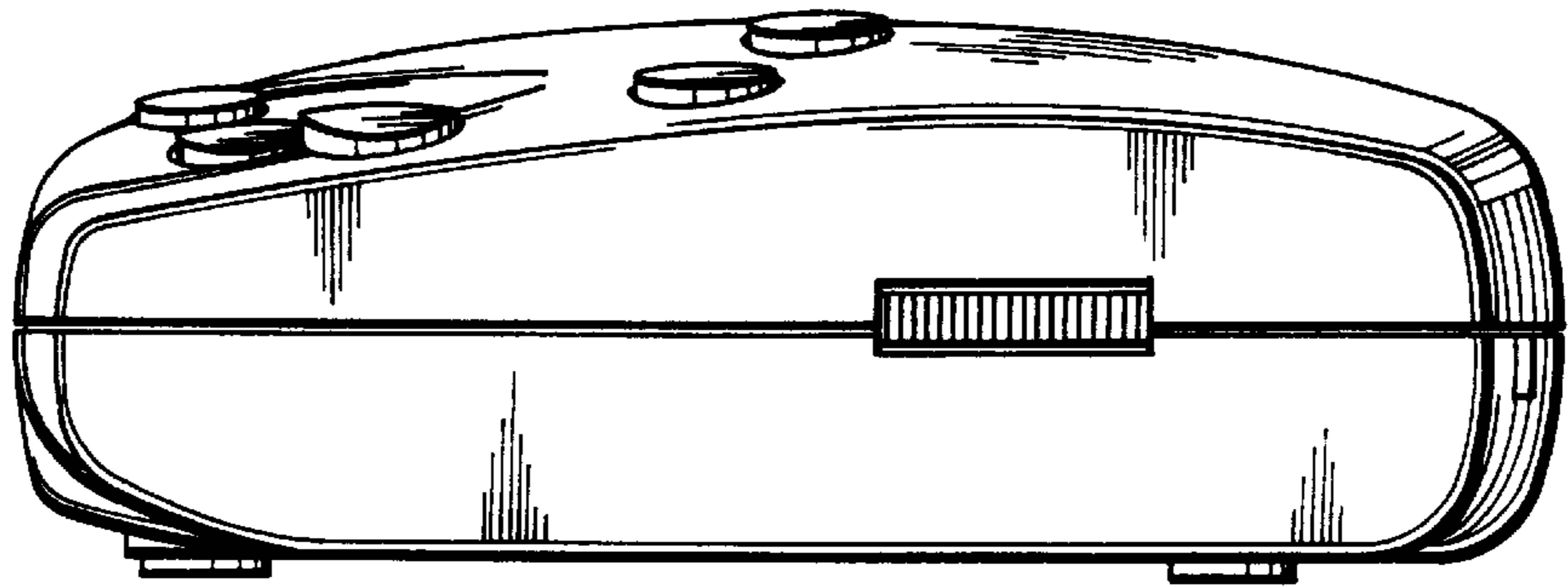
