[57] CLAIM

The ornamental design for a therapeutic post-operative arm elevator/sling, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation of the therapeutic post-operative arm elevator/sling, with the elongated strap shown in FIG. 8 omitted for ease of illustration;

FIG. 2 is a top plan thereof;

FIG. 3 is a bottom plan thereof;

FIG. 4 is a front elevation thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is an isometric view thereof;

FIG. 7 is a right side elevation of the therapeutic post-operative arm elevator/sling, with the short straps shown in FIG. 8 omitted for ease of illustration; and,

FIG. 8 is a right side elevation of the therapeutic post-operative arm elevator/sling, showing my new design. The left side of the therapeutic post-operative arm elevator/sling has substantially the appearance of the right side illustrated in FIG. 1.

The broken lines in the figures is for illustrative purposes only and forms no part of the claimed design.

The broken away showing of the straps in FIGS. 6 and 8 is for ease of illustration.

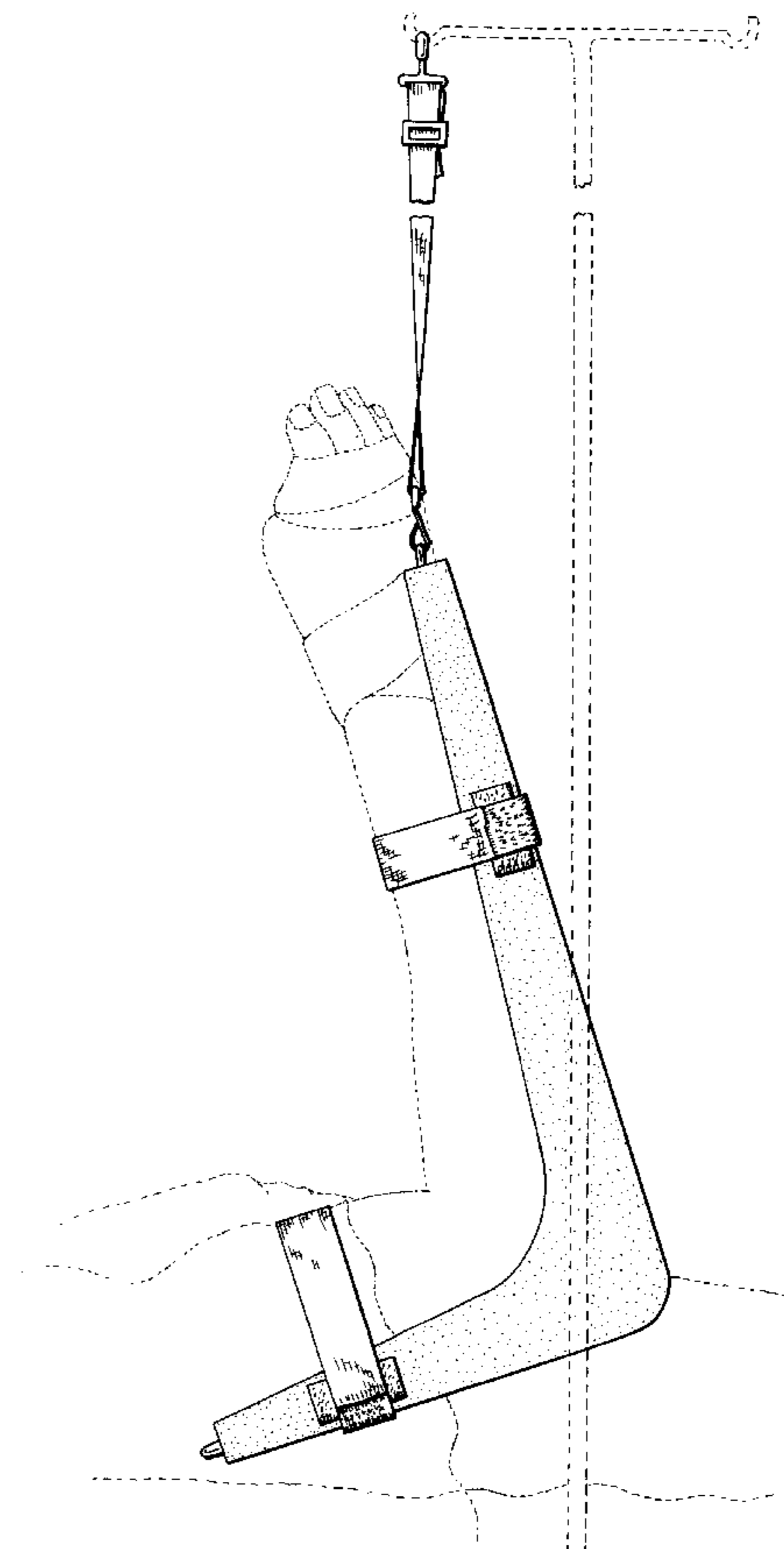
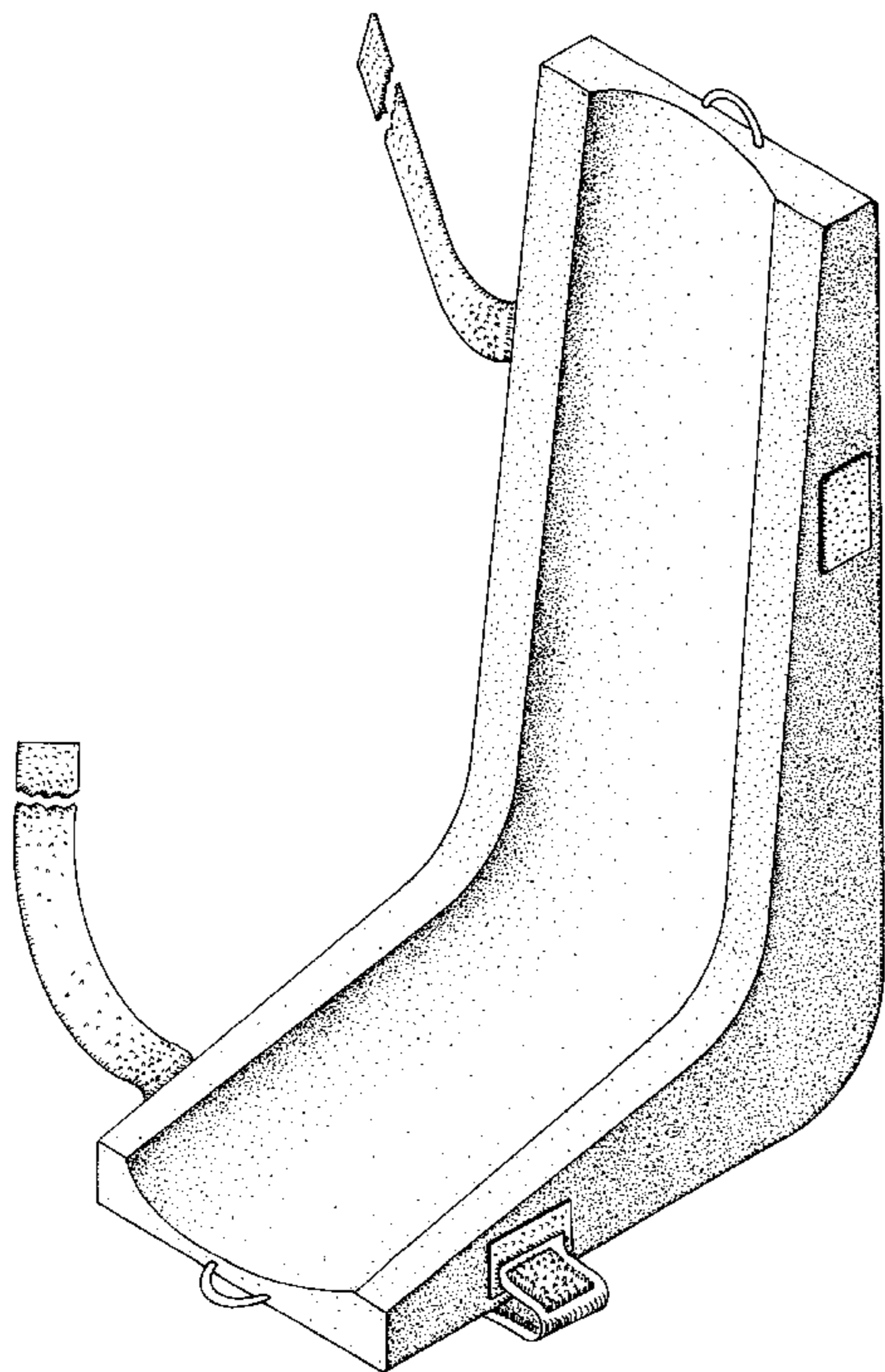

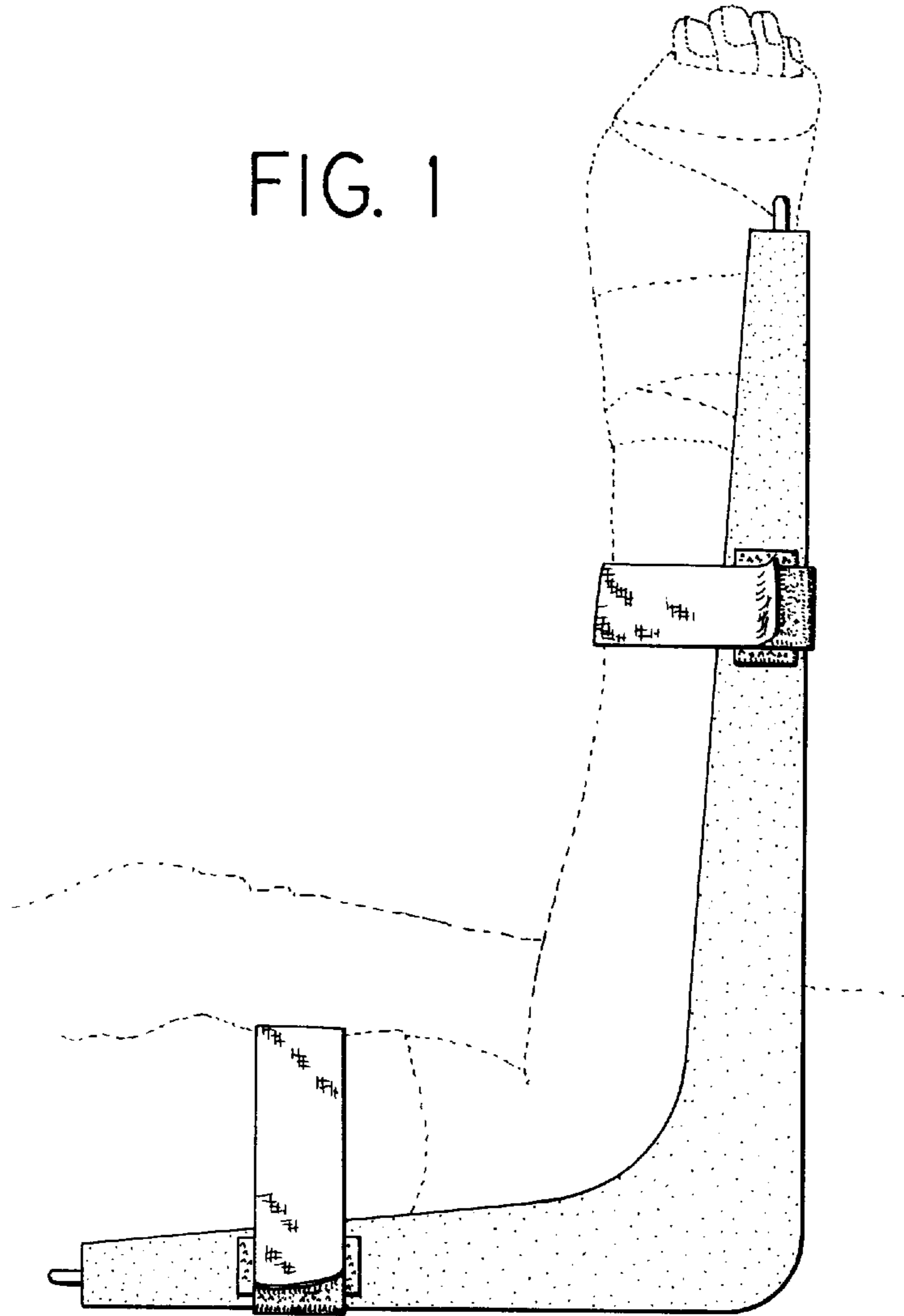

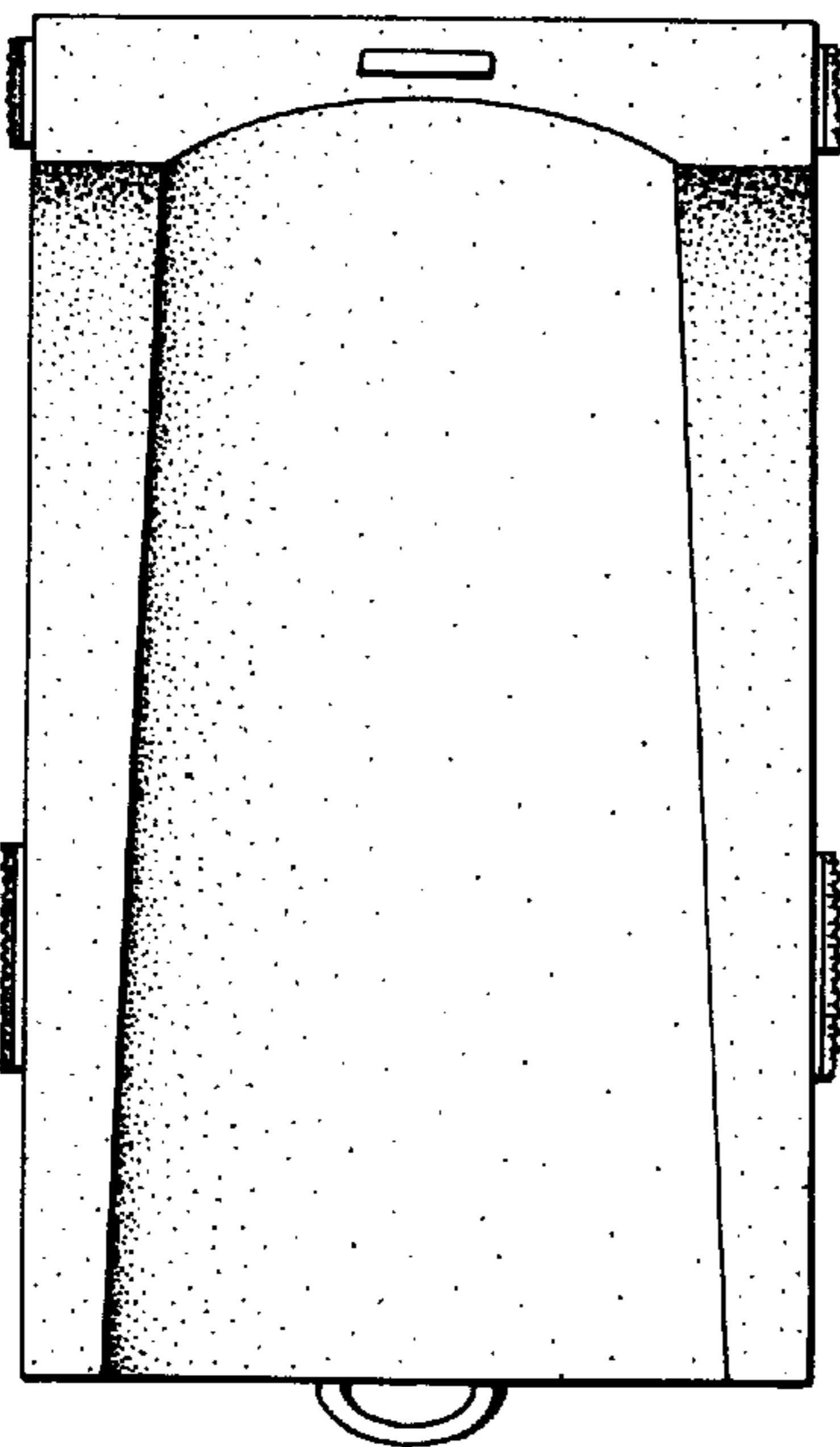
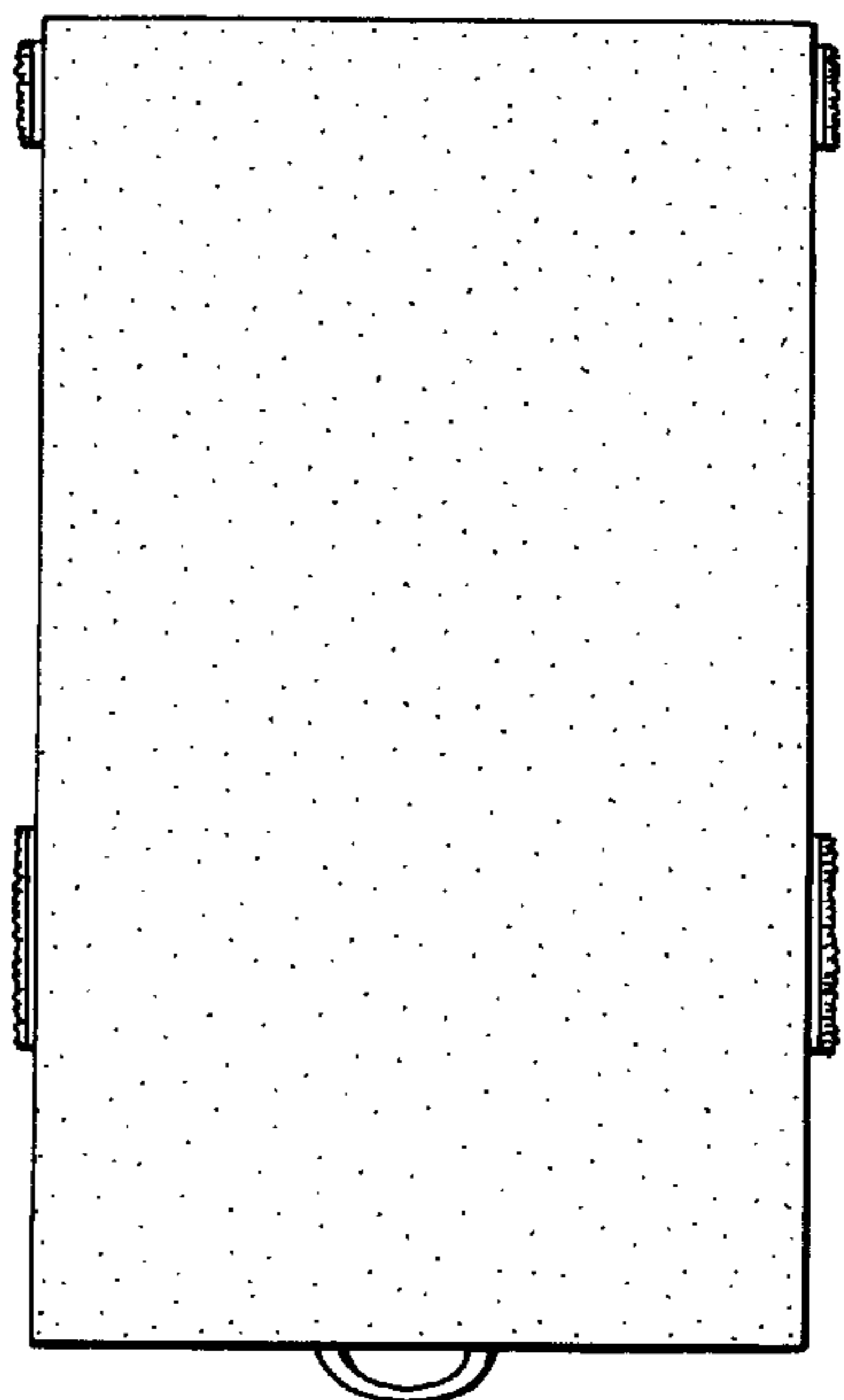

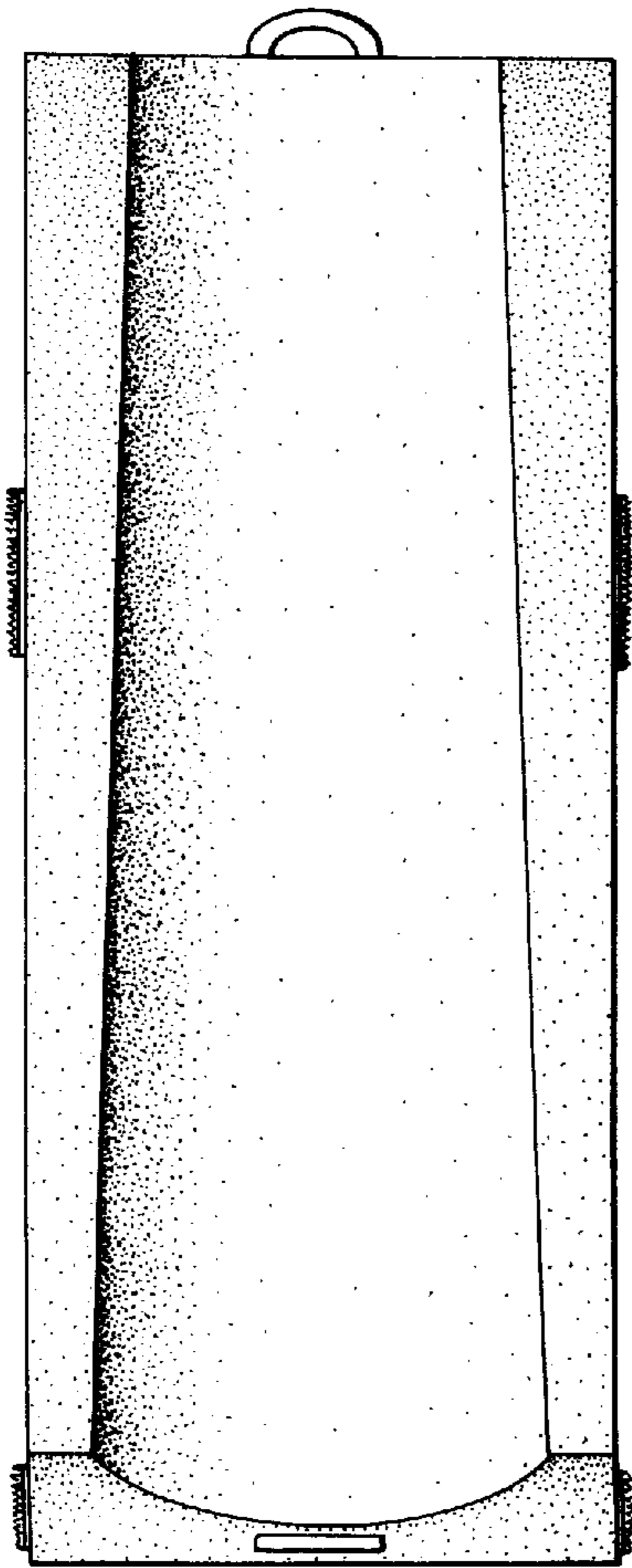

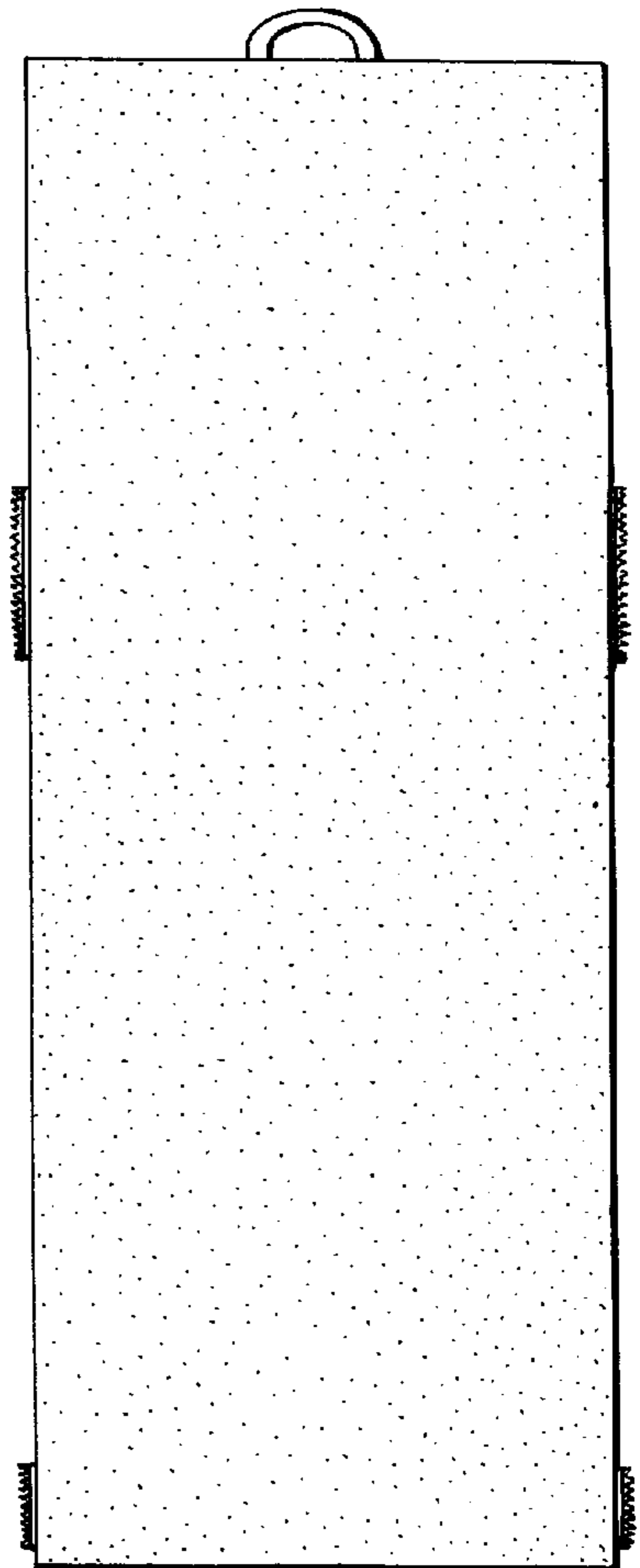
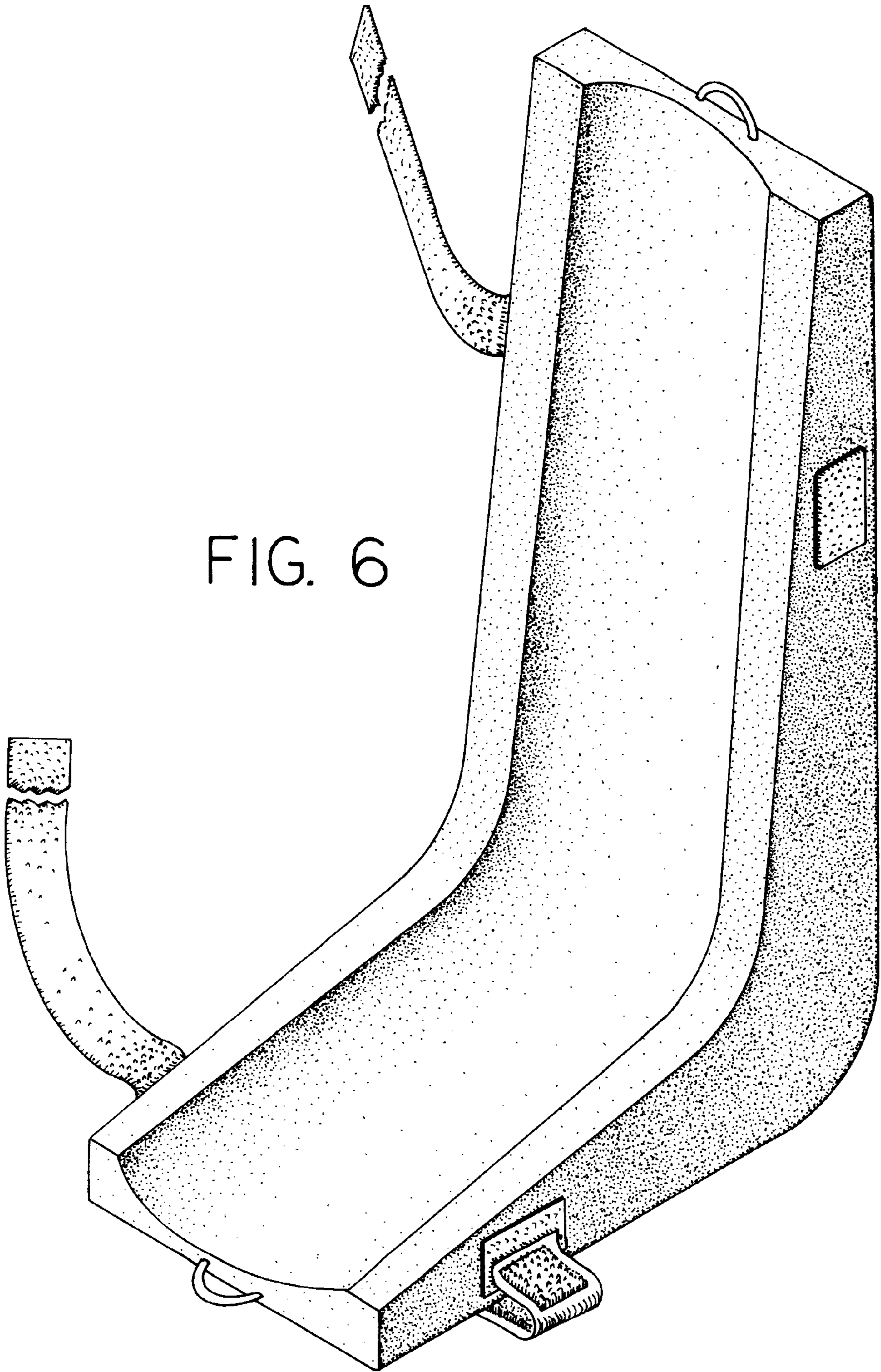

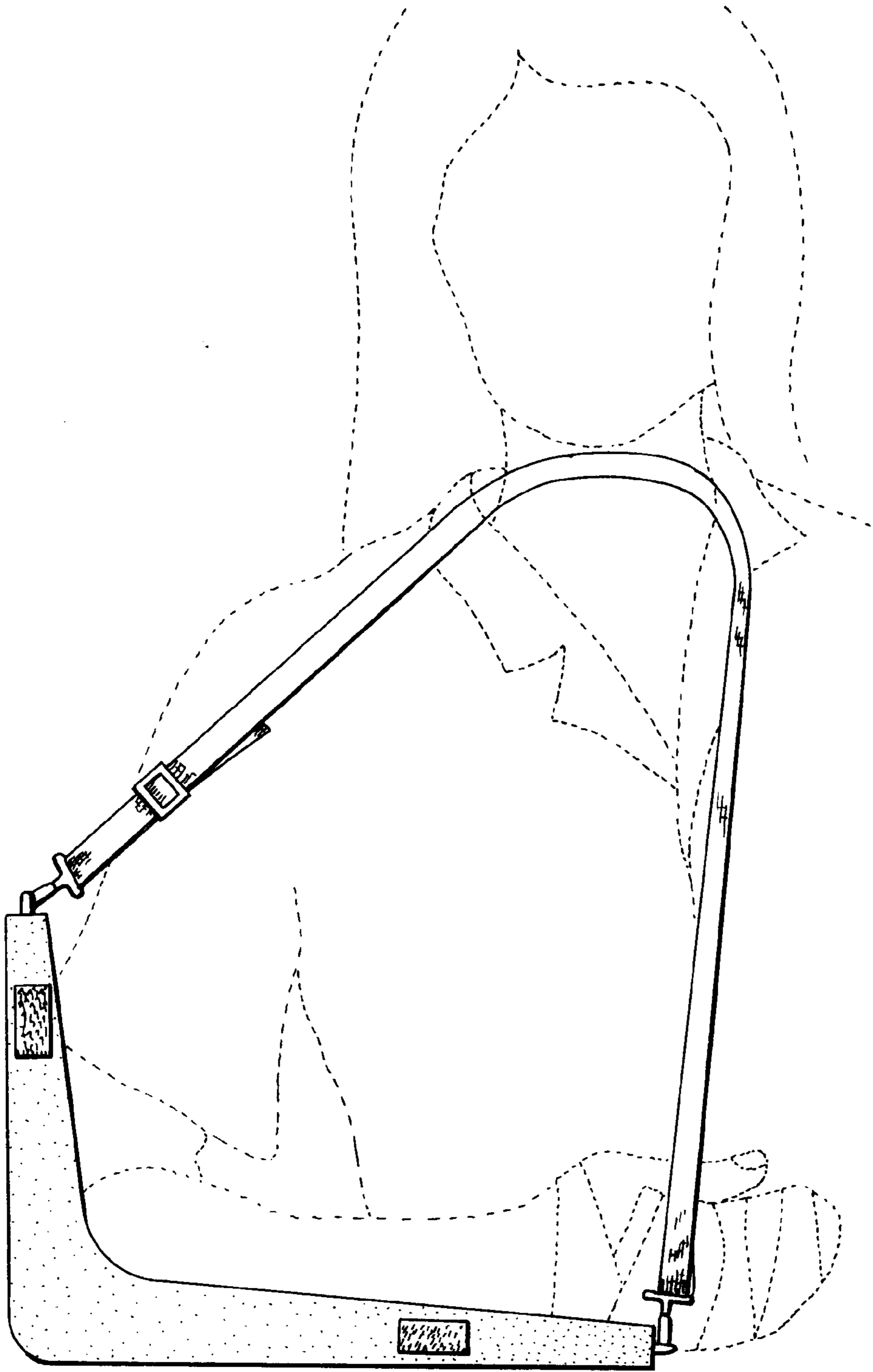

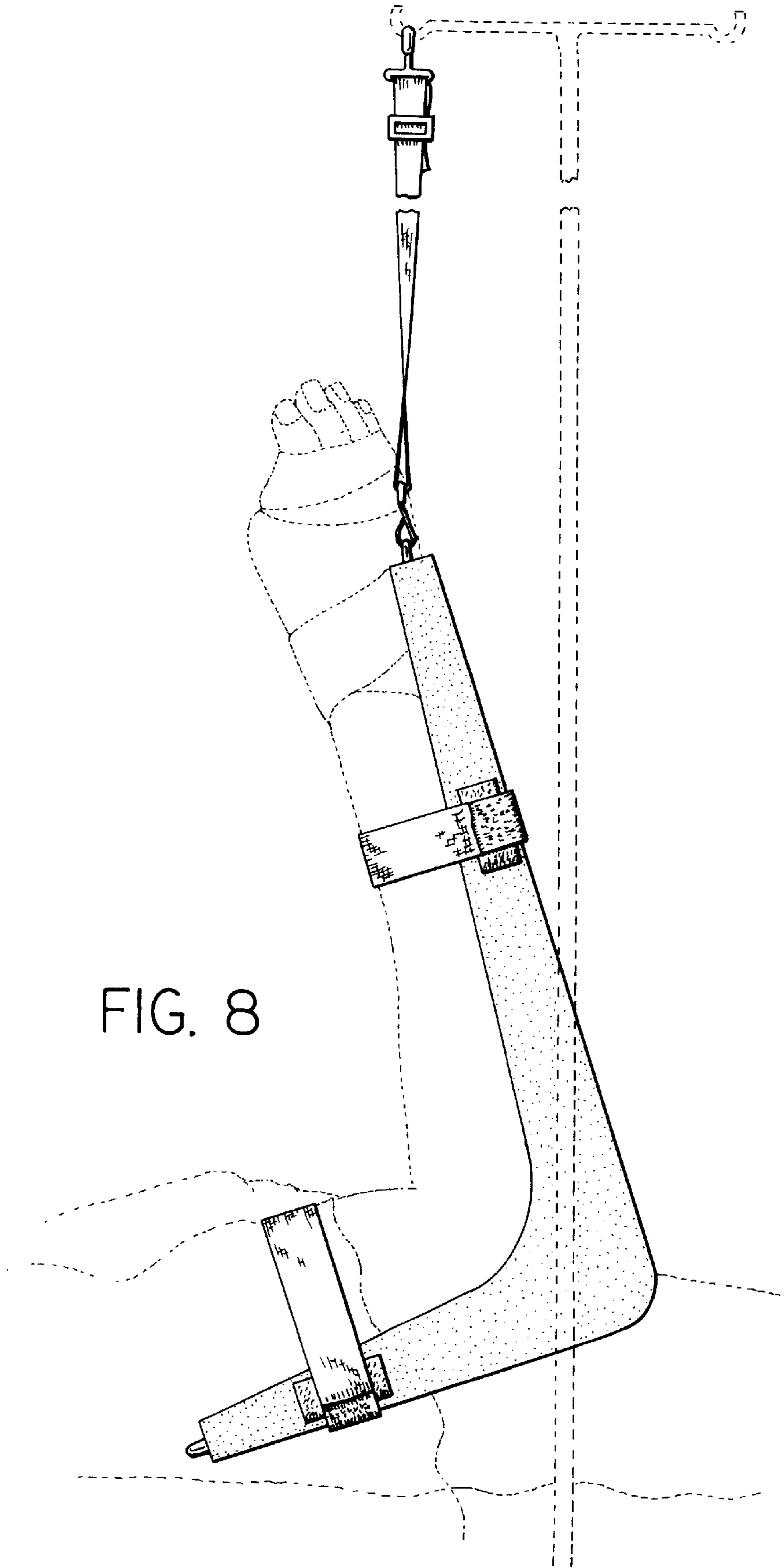
