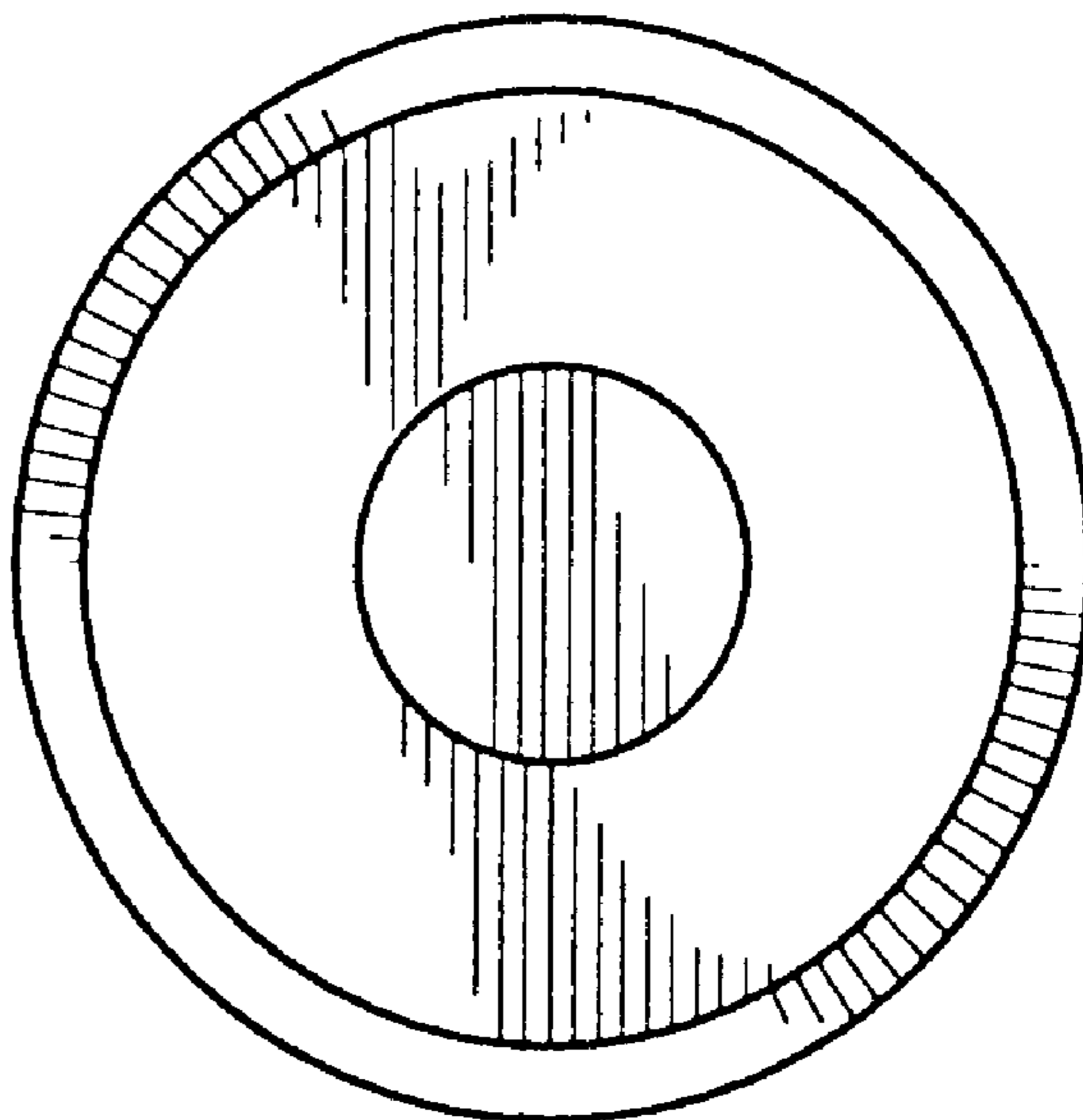
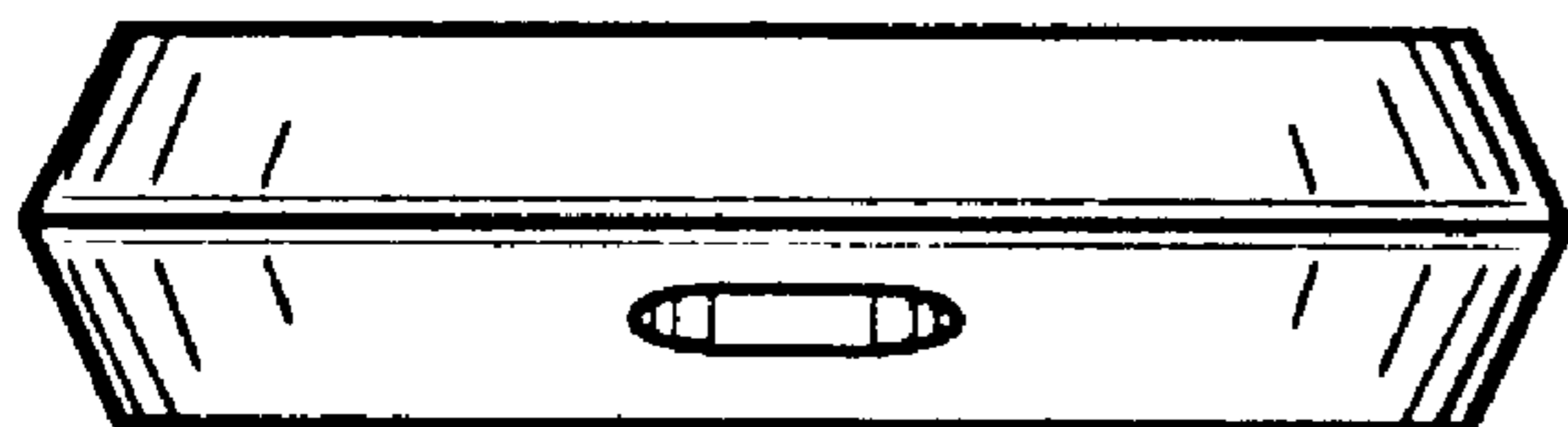
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of the design for a compact;

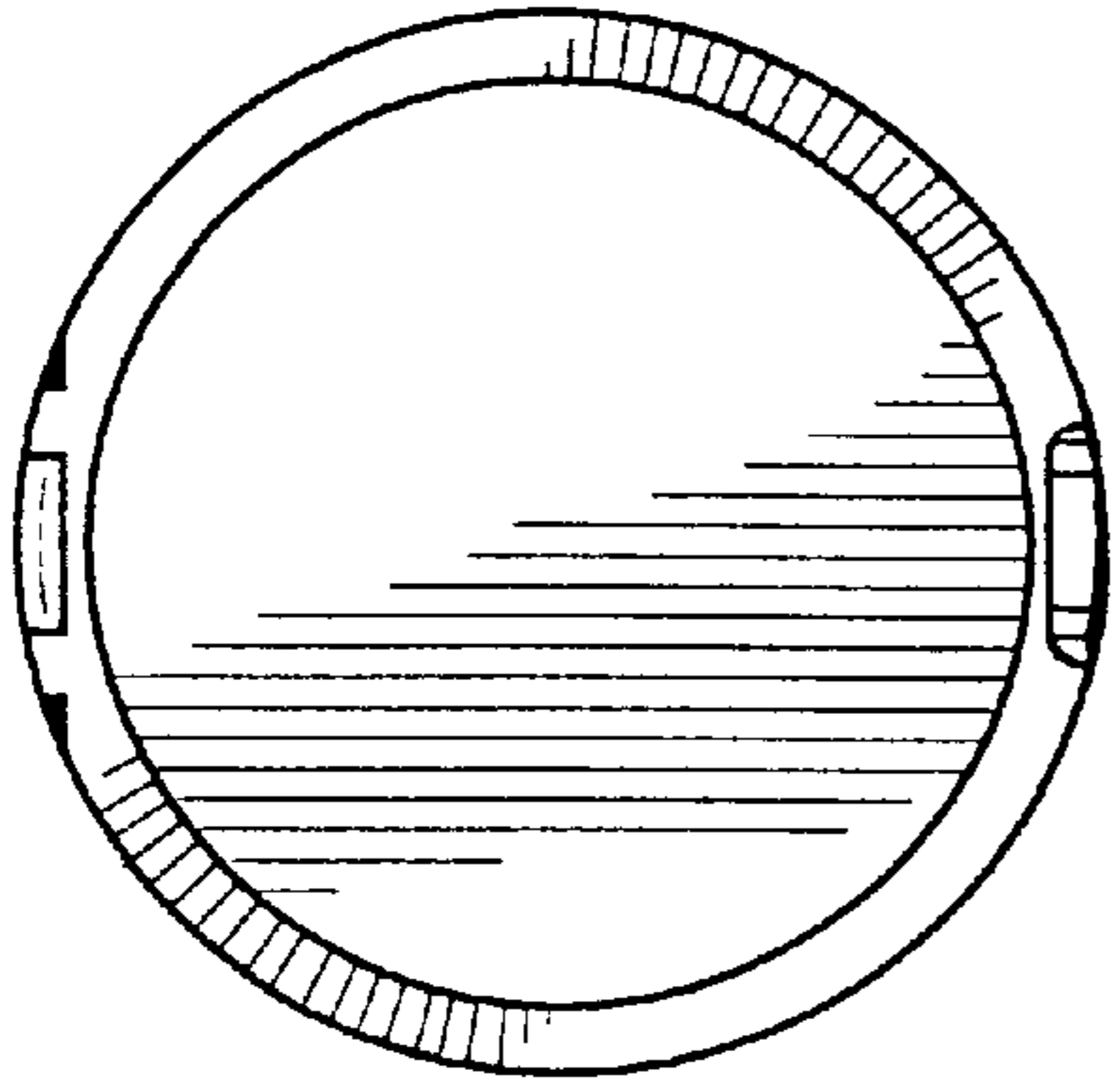

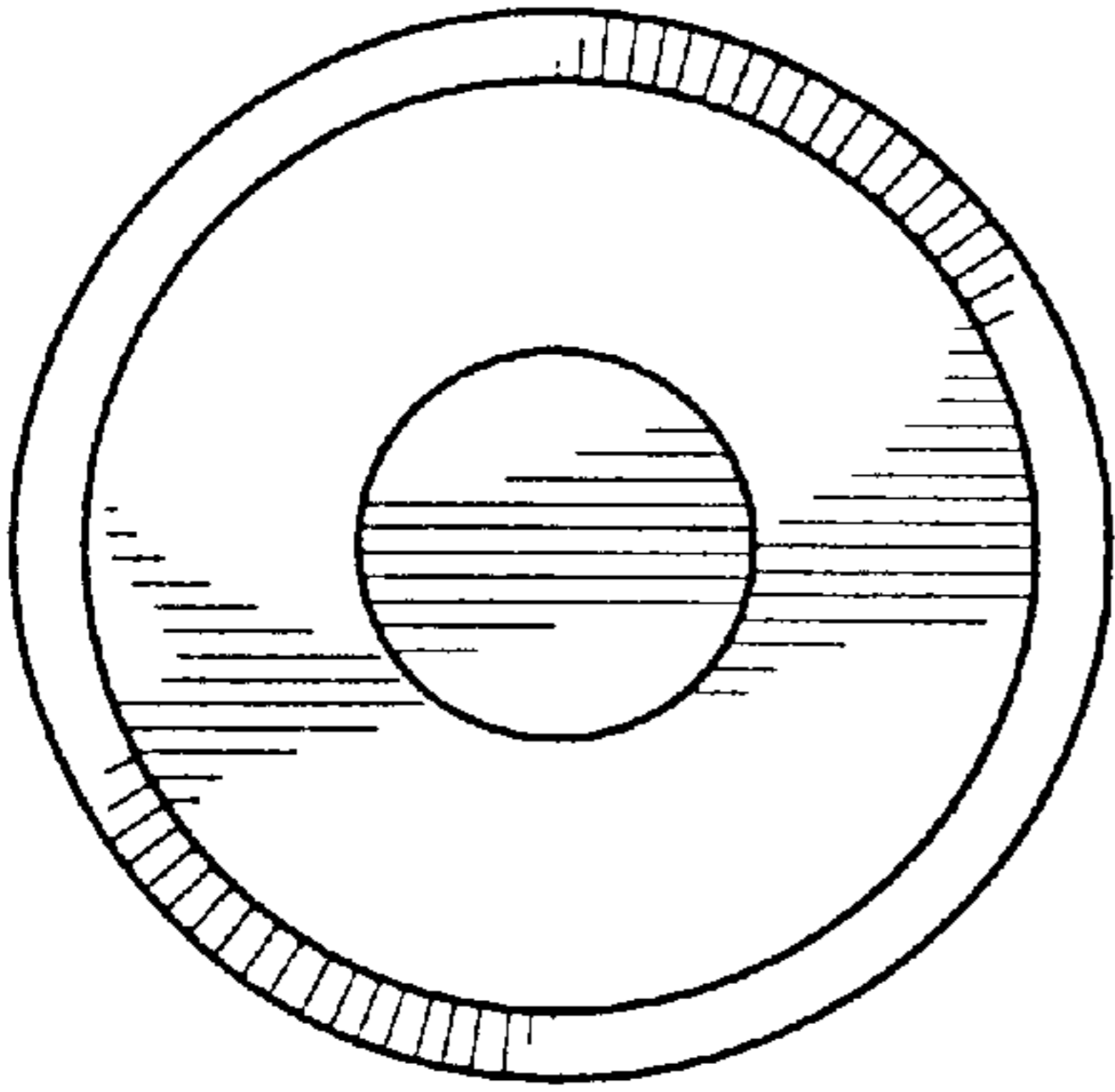

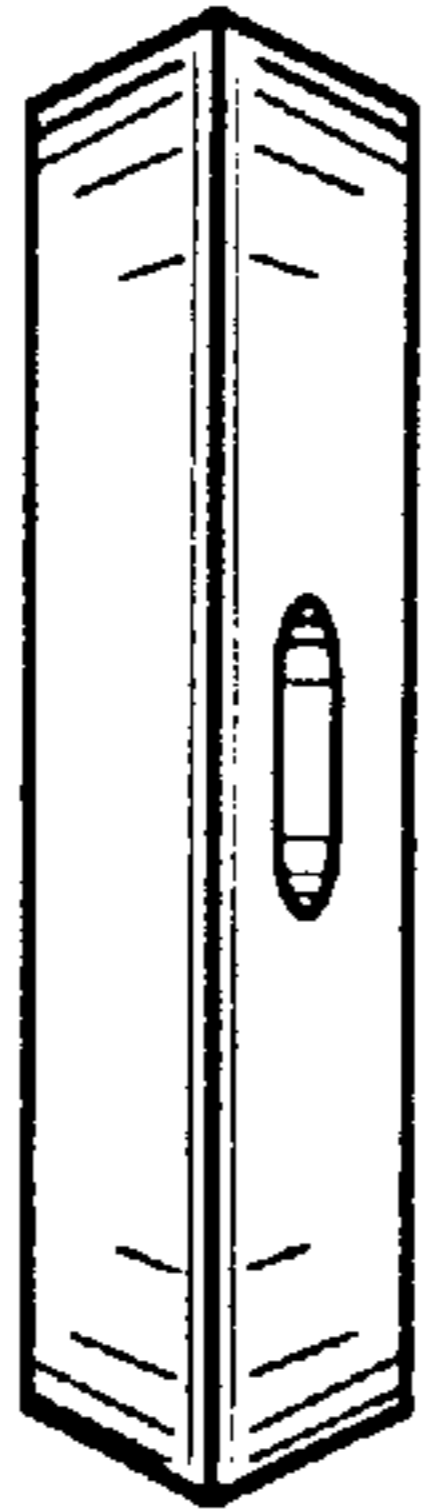

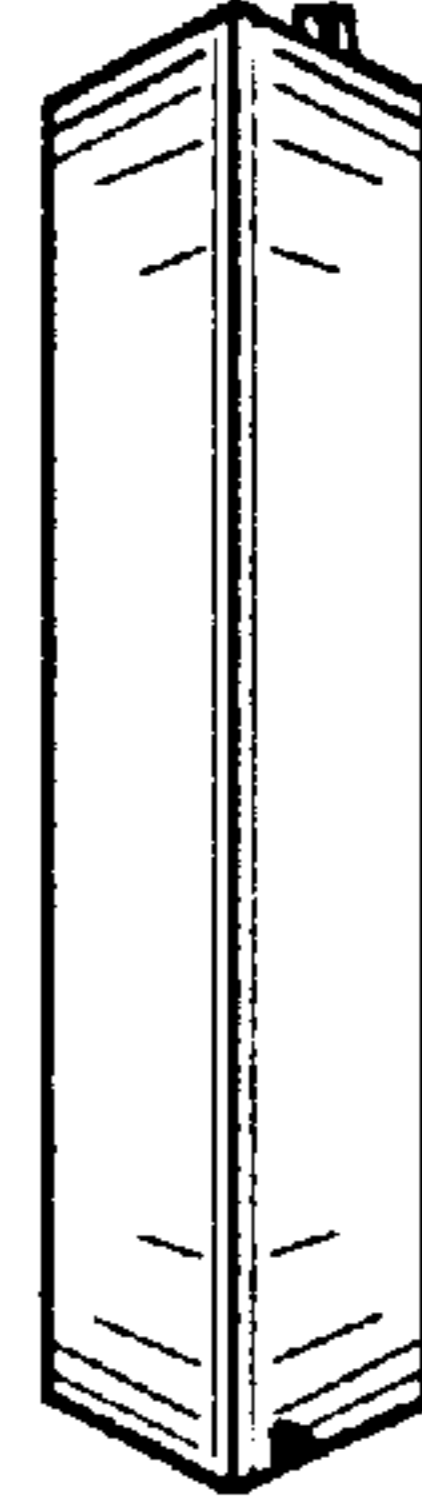

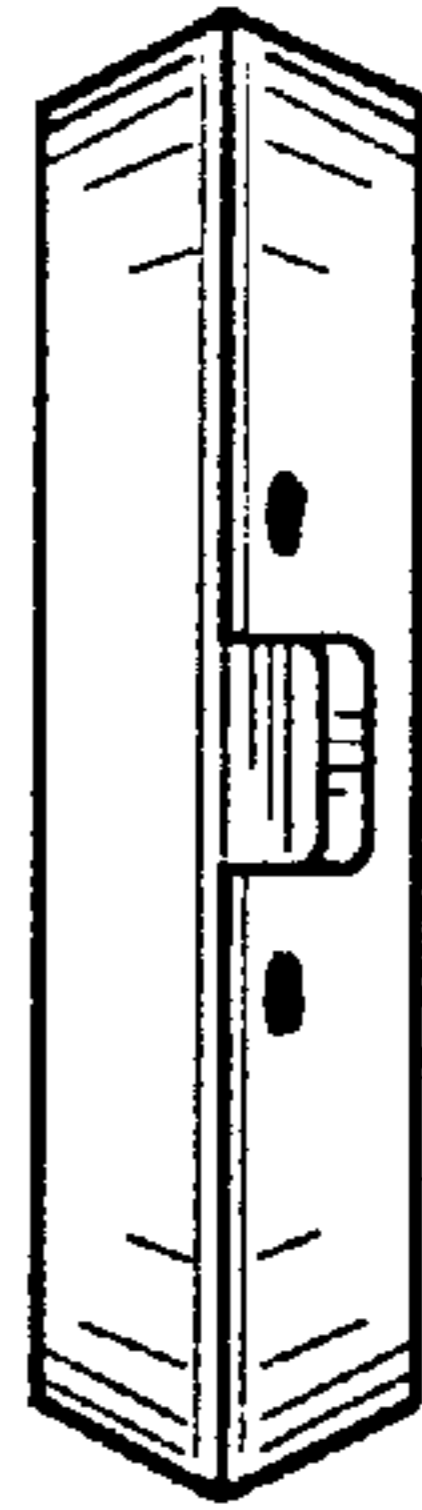
