[57] **CLAIM**

I claim the ornamental design for a handle, as shown and described.

DESCRIPTION

FIG. 1 is a upper perspective view taken from the back of a new design for a handle according to the present invention; FIG. 2 is a lower perspective view taken from the front of a new design for a handle according to the present invention; FIG. 3 is a side view, an opposite side view being a mirror image thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is an end view thereof; and, FIG. 7 is an enlarged view of the new design for the handle. The broken lines shown in FIGS. 1–6 are for illustrative purposes only and form no part of the claimed design.

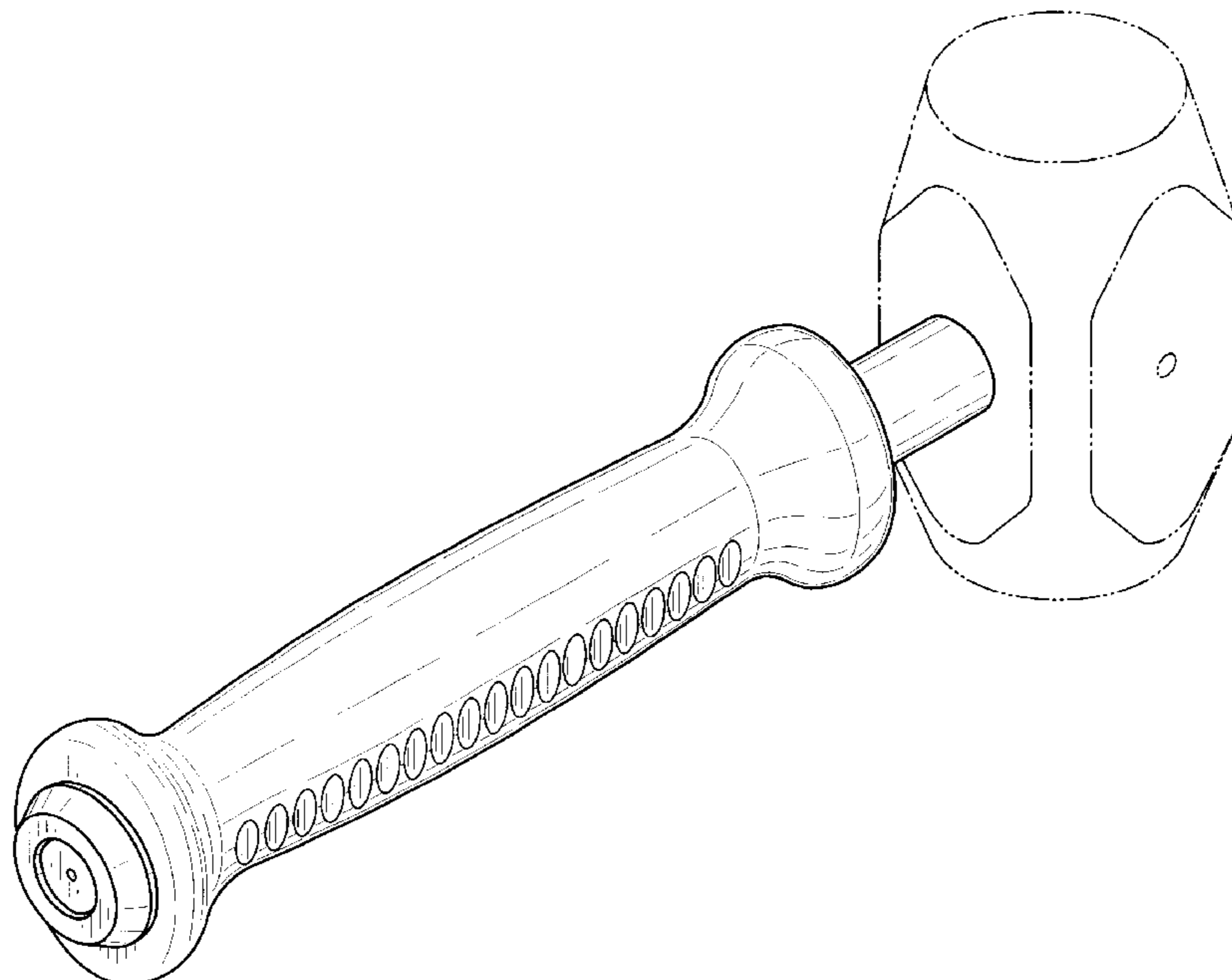

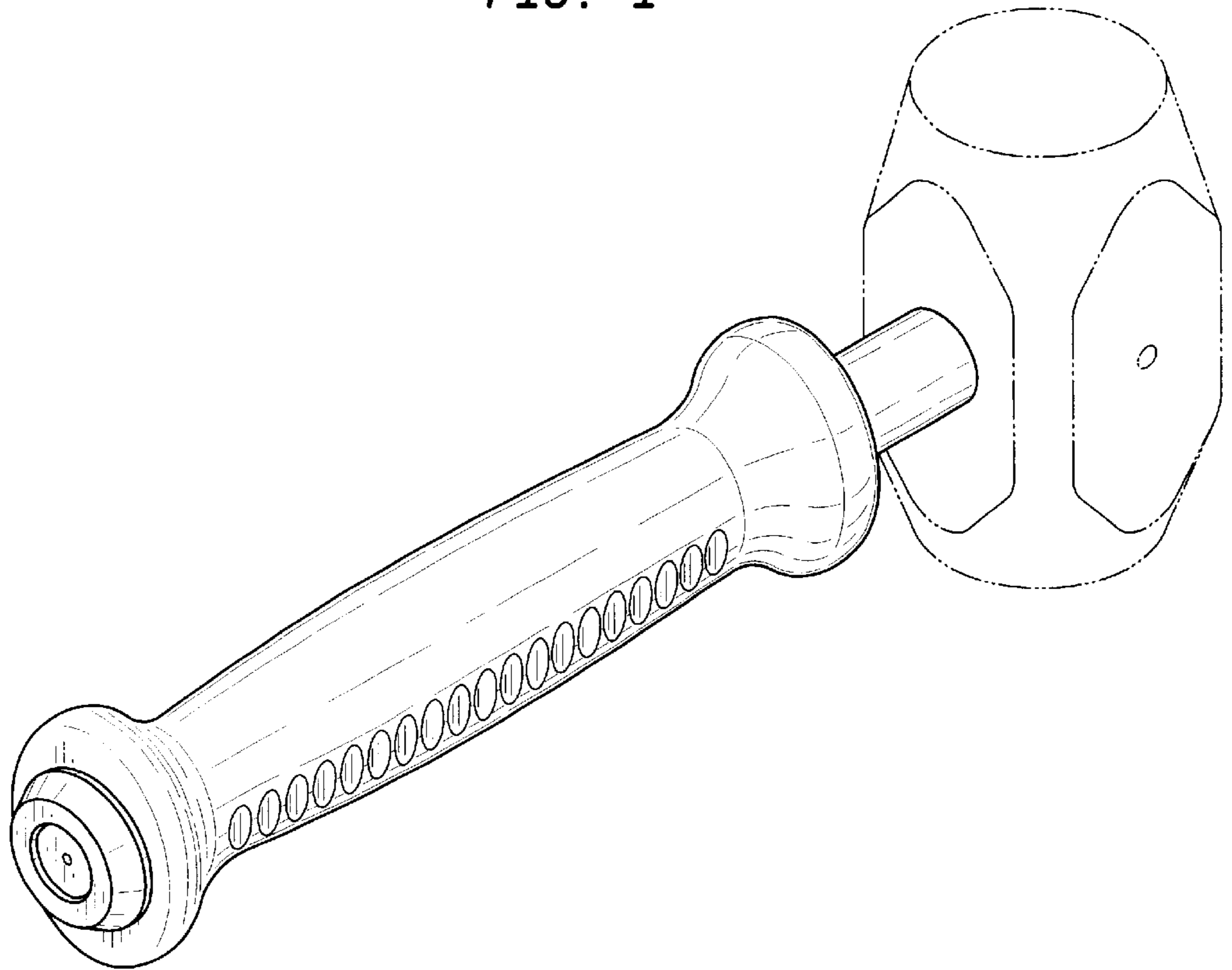

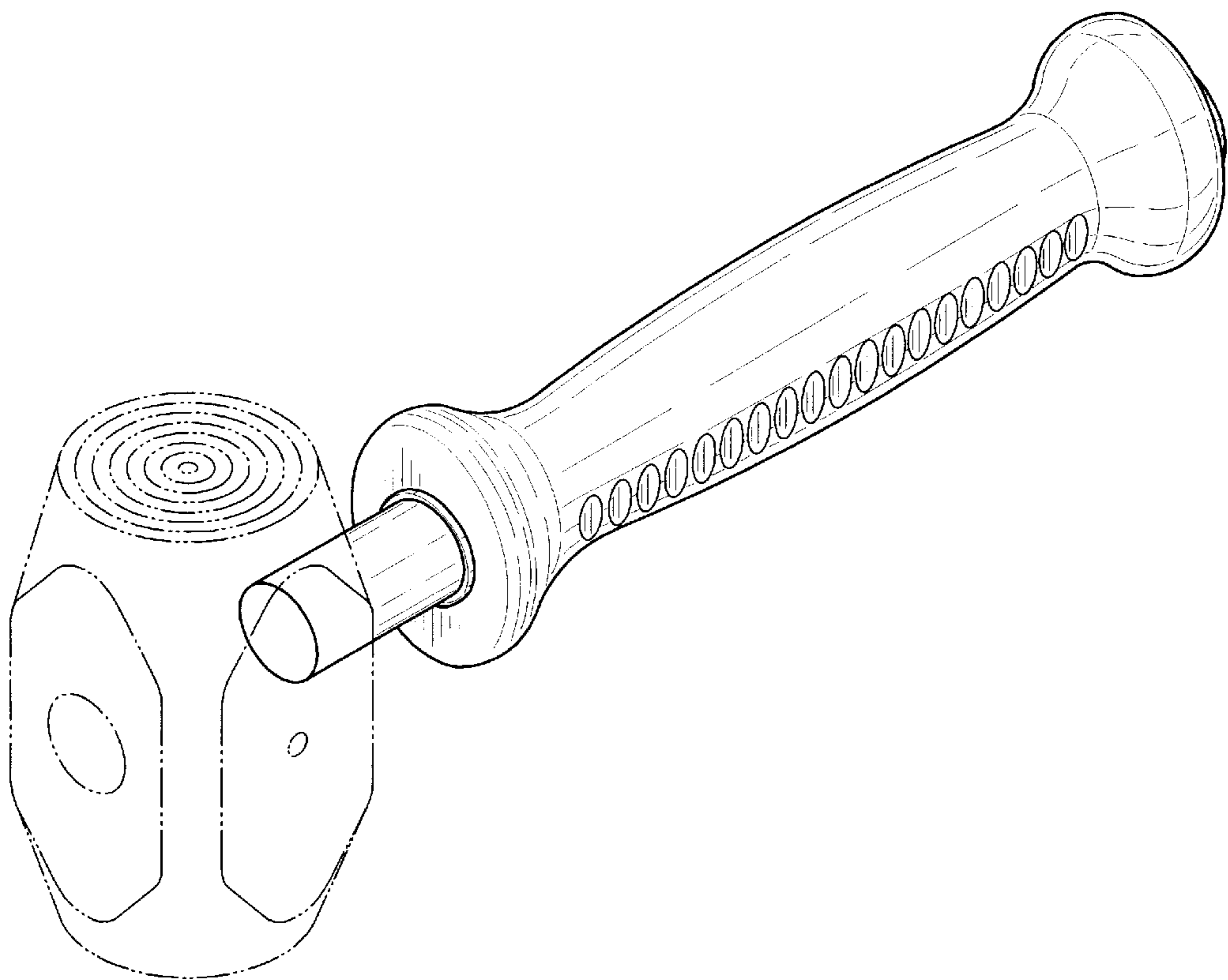

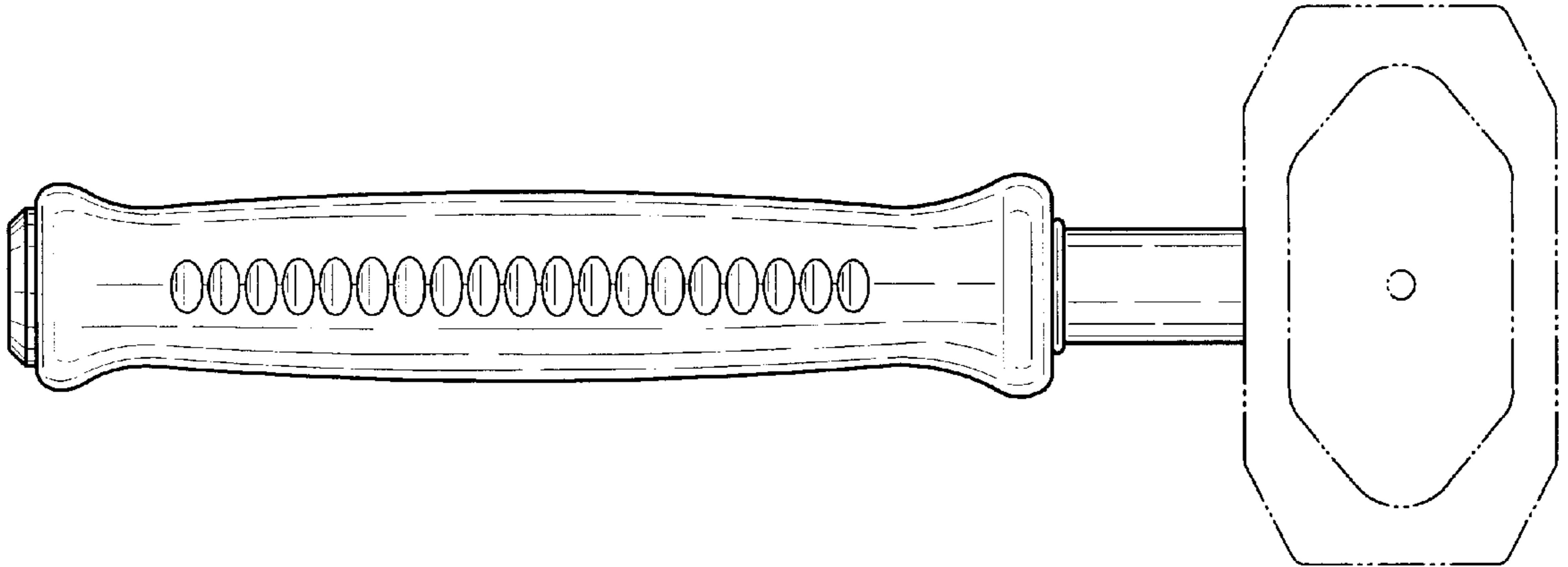

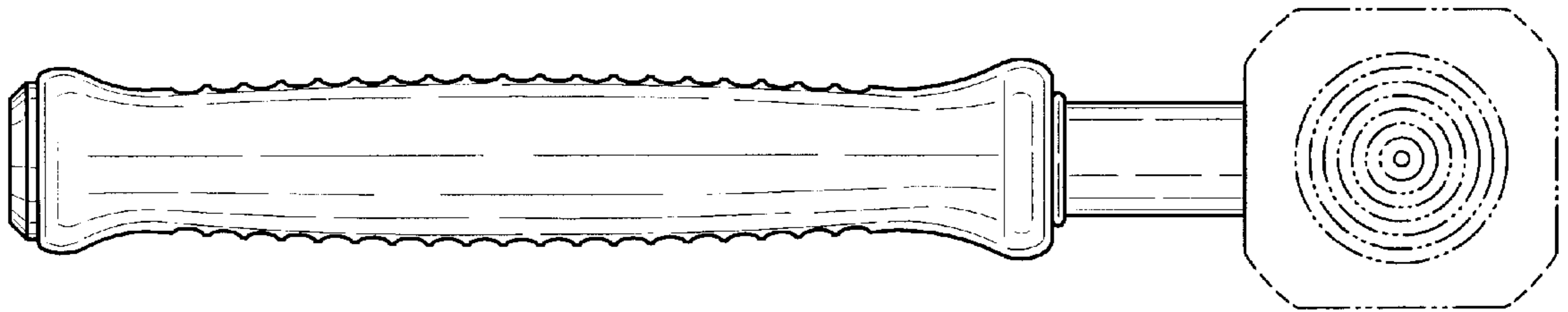

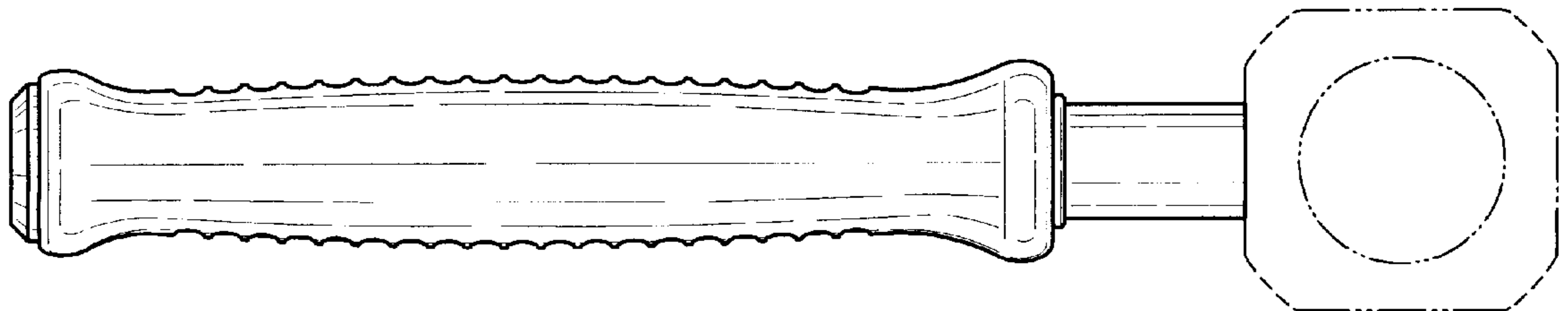

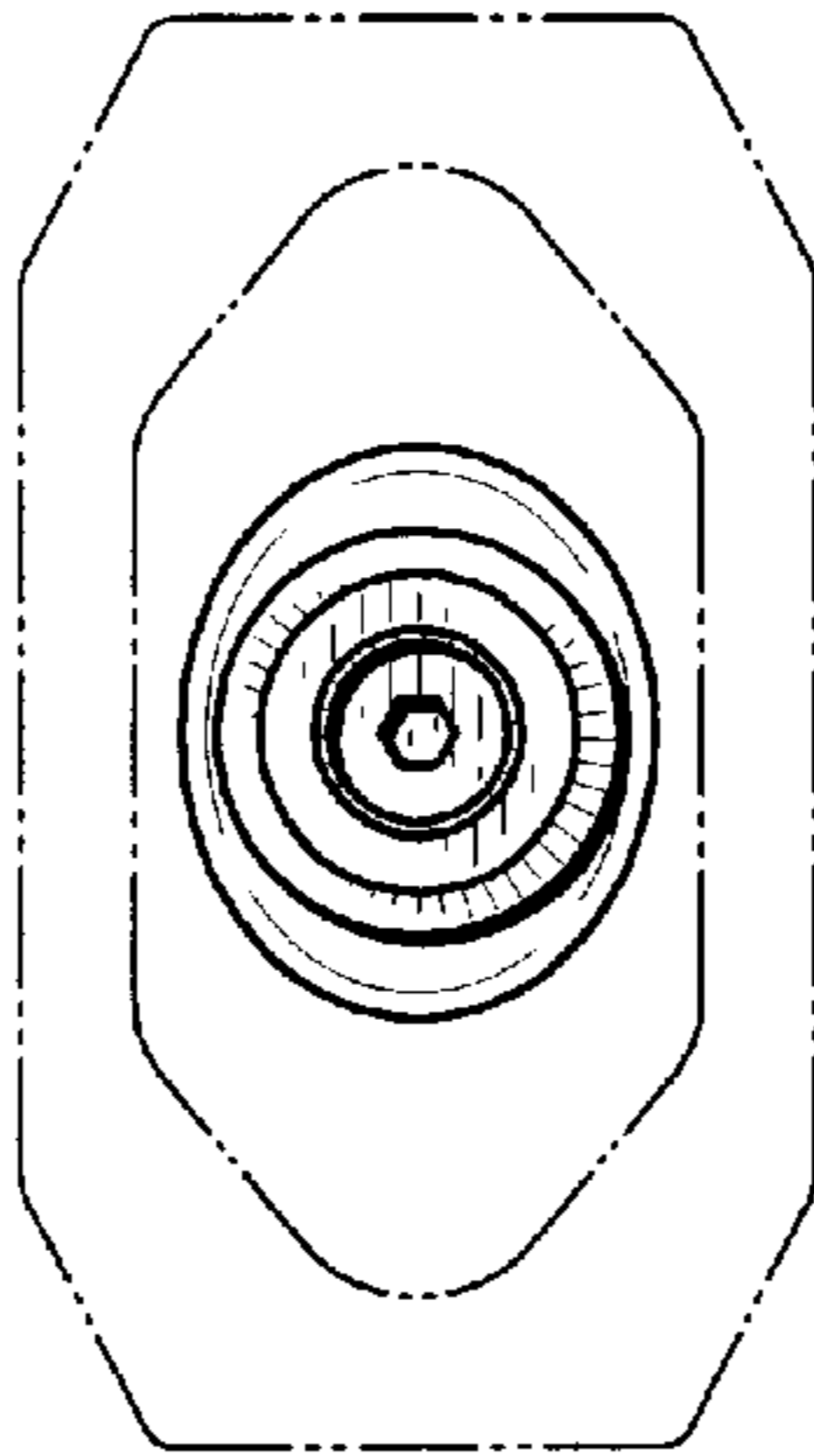
