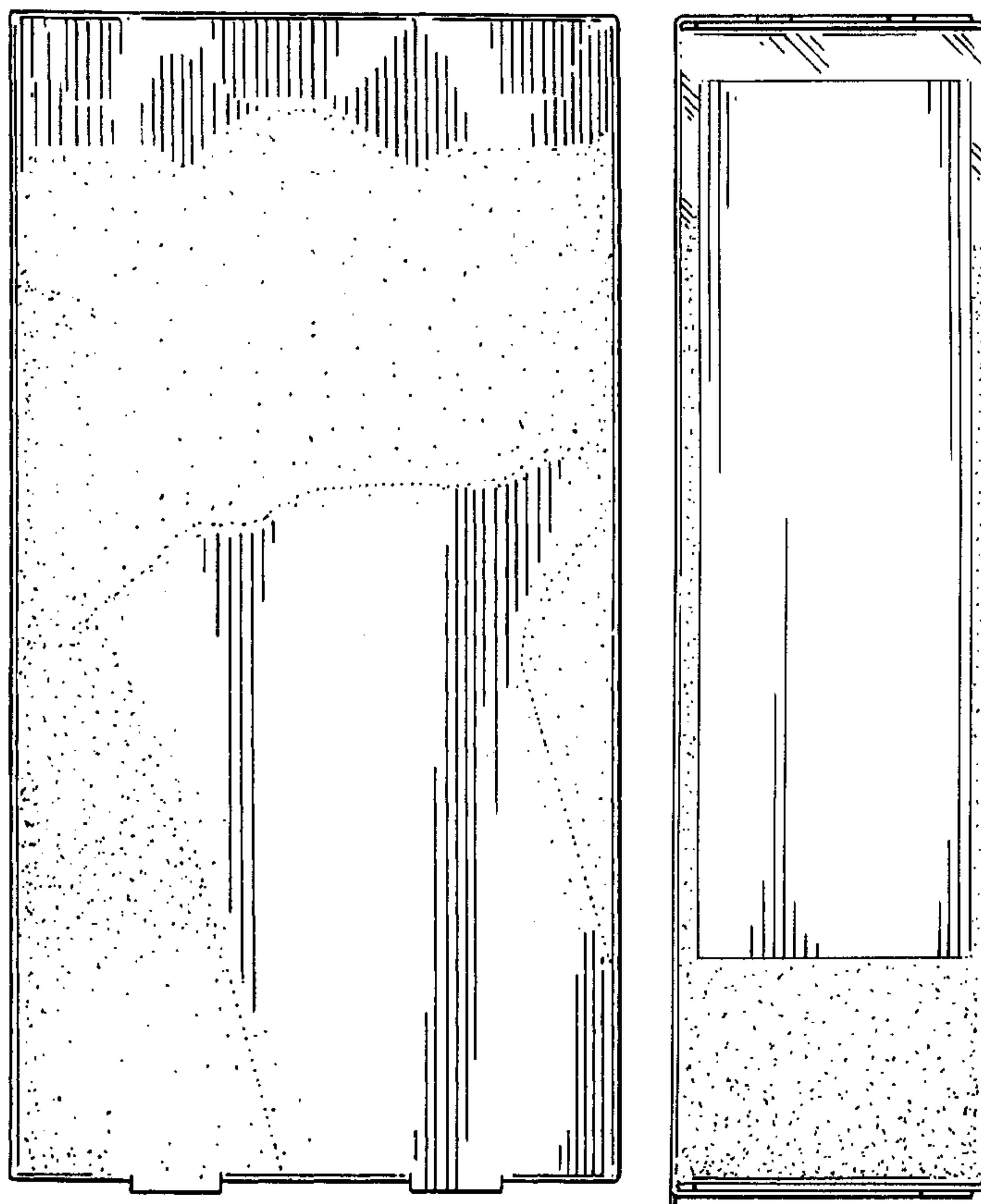
[57] CLAIM

The ornamental design for a package, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a package, showing my new design.
FIG. 2 is a rear elevational view thereof.
FIG. 3 is a right side elevational view thereof.
FIG. 4 is a left side elevational view thereof.
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The straight line shading shown on the design in the drawing represents opaque surfaces, the oblique shading represents transparent surfaces, and the stipple shading represents translucent shading.

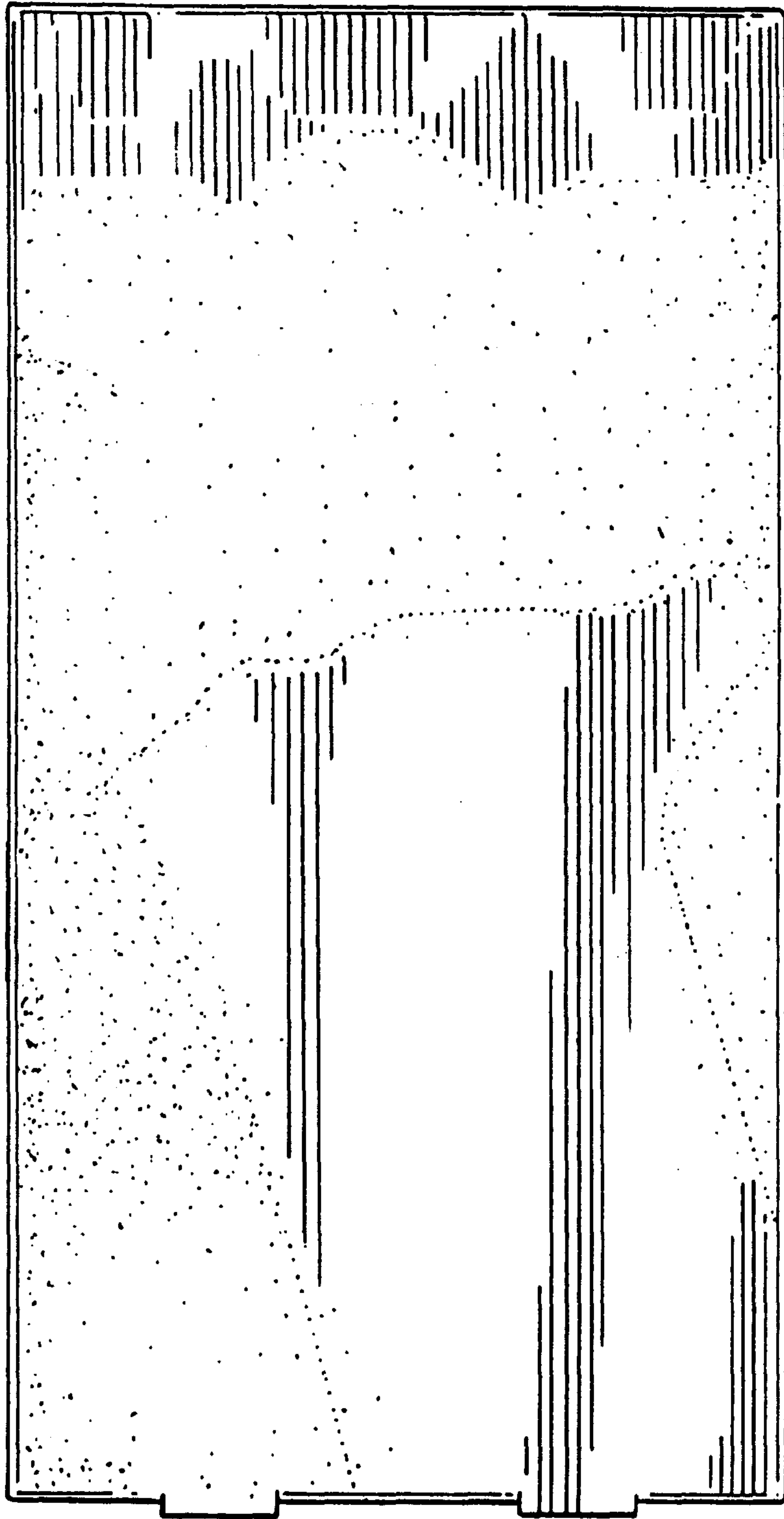

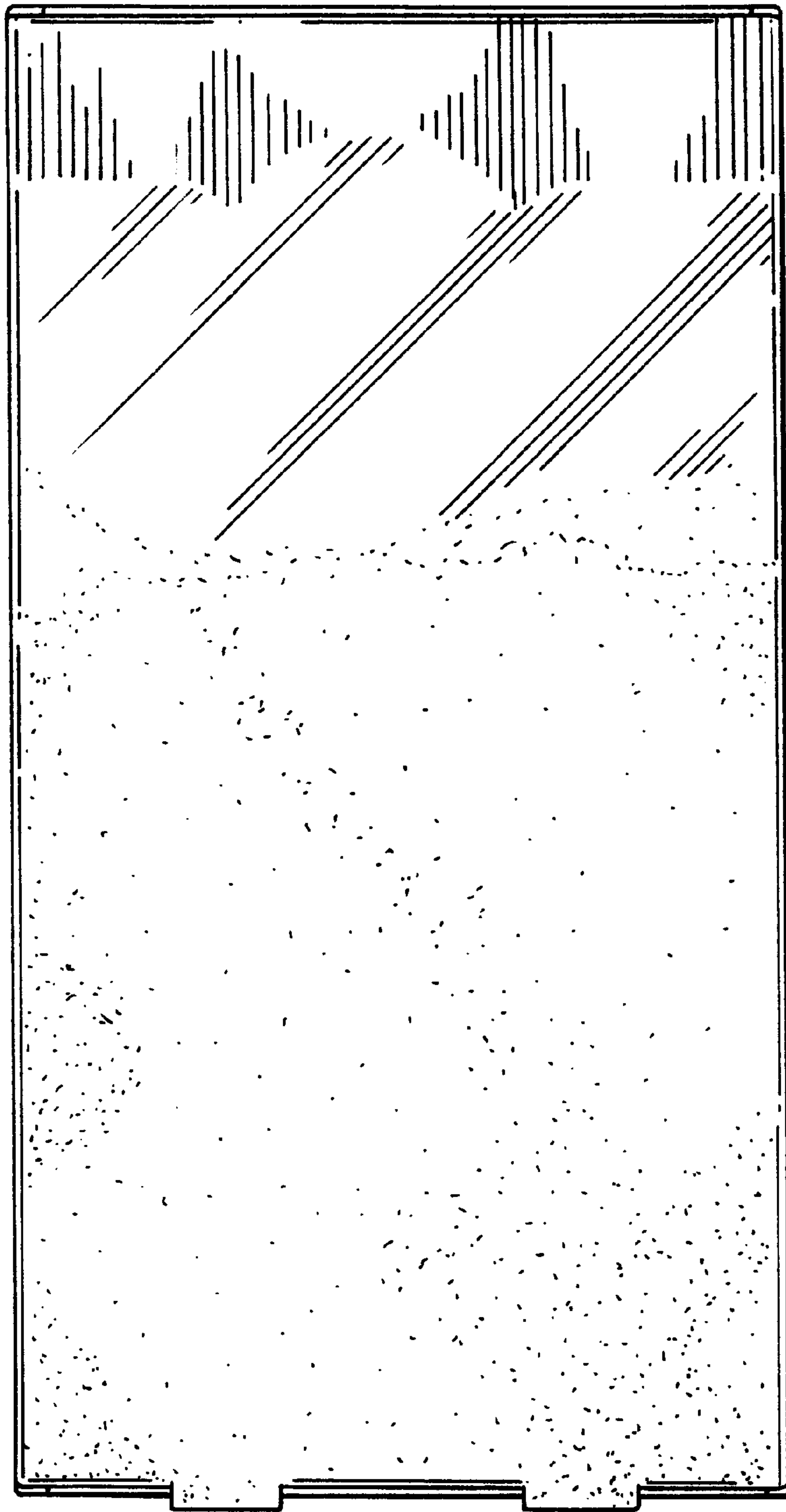

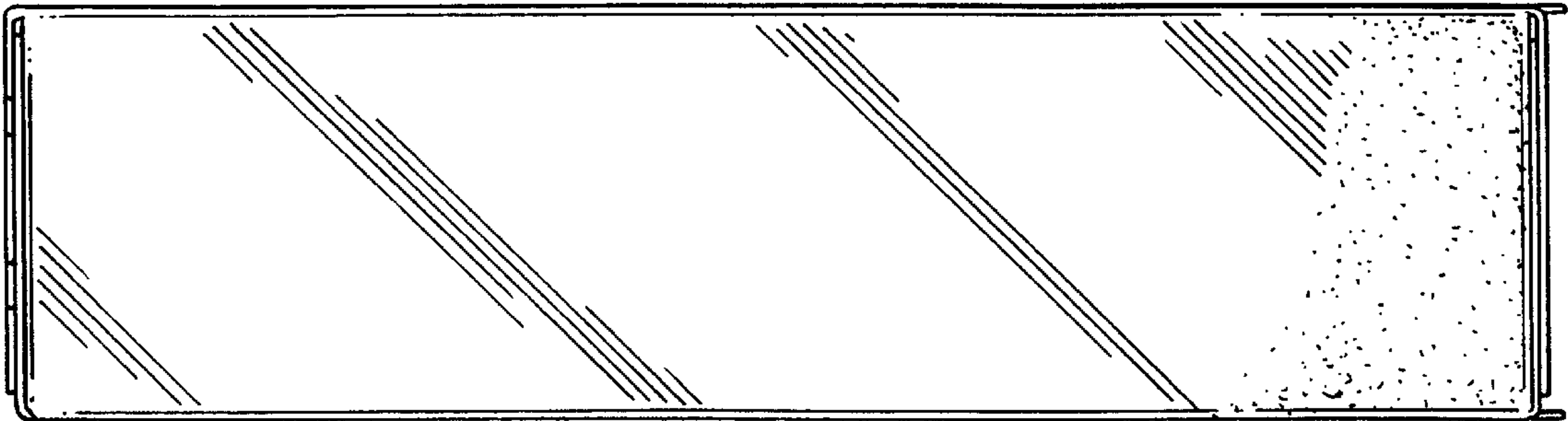
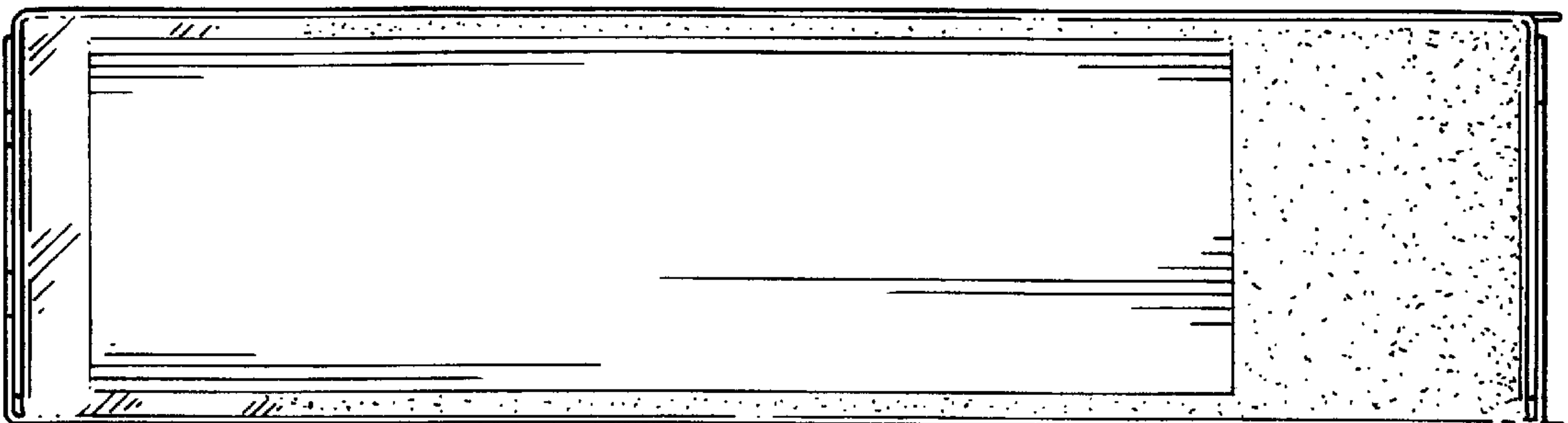

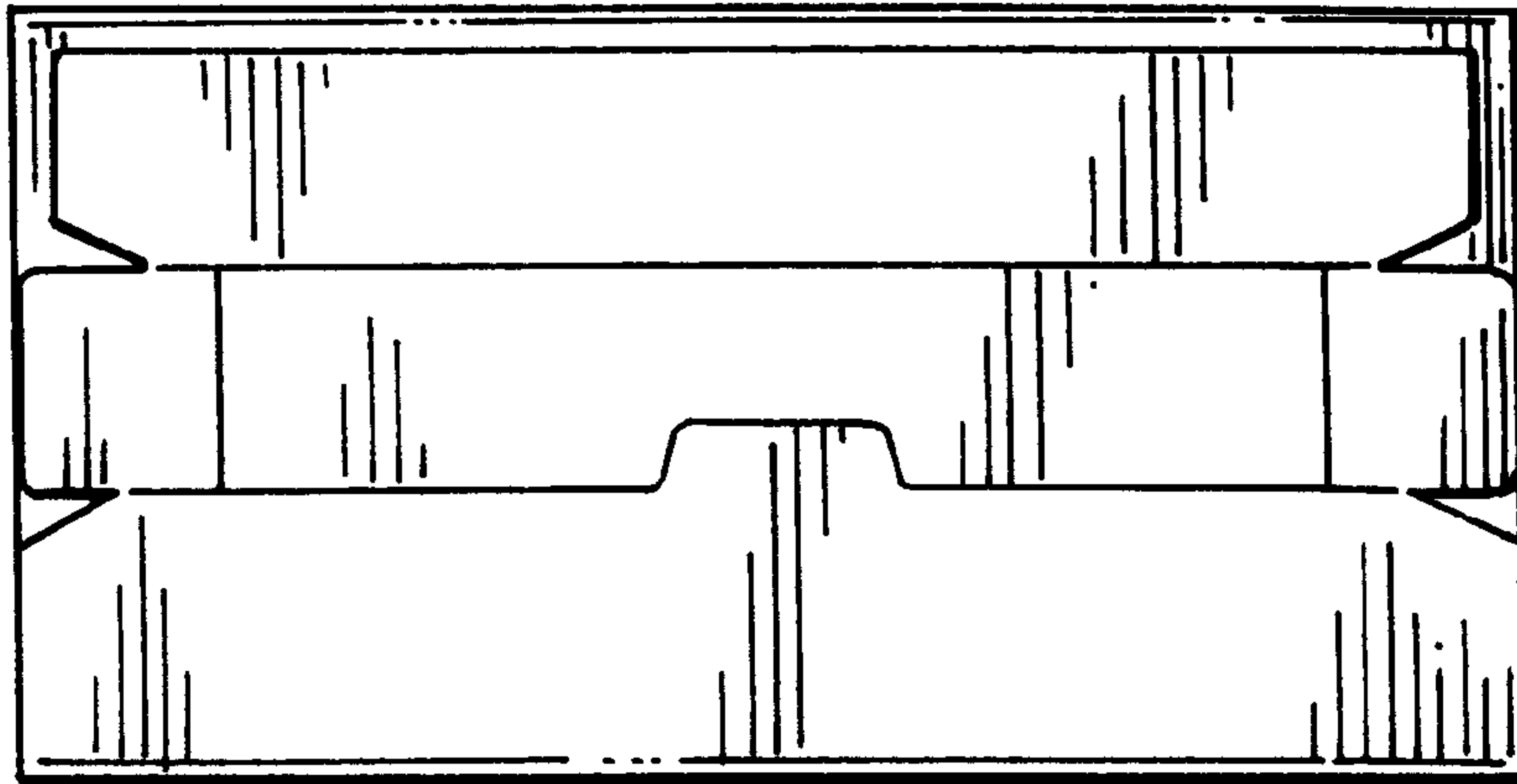

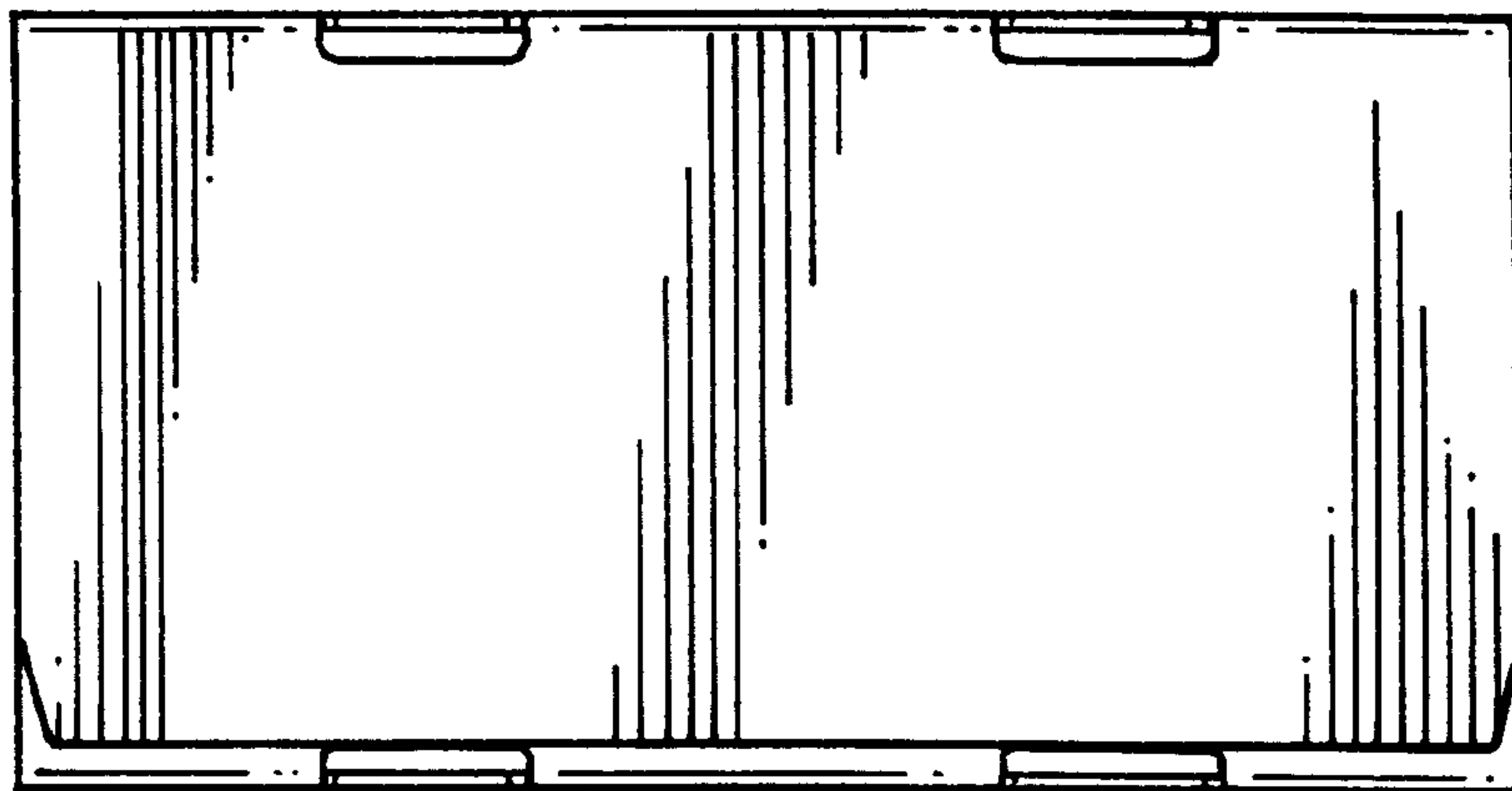
