[57] CLAIM

The ornamental design for a heart stethoscope tag, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the present invention; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left-side elevational view thereof; FIG. 4 is a right-side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a plan view in open position; and, FIG. 8 is a front elevational view of a second embodiment of the present invention (the rear elevational view being a mirror image thereof, and all other views being the same as those shown in FIGS. 3–6 hereof).

The broken line disclosure of the stethoscope tubing is shown for illustrative purposes only and forms no part of the claimed design.

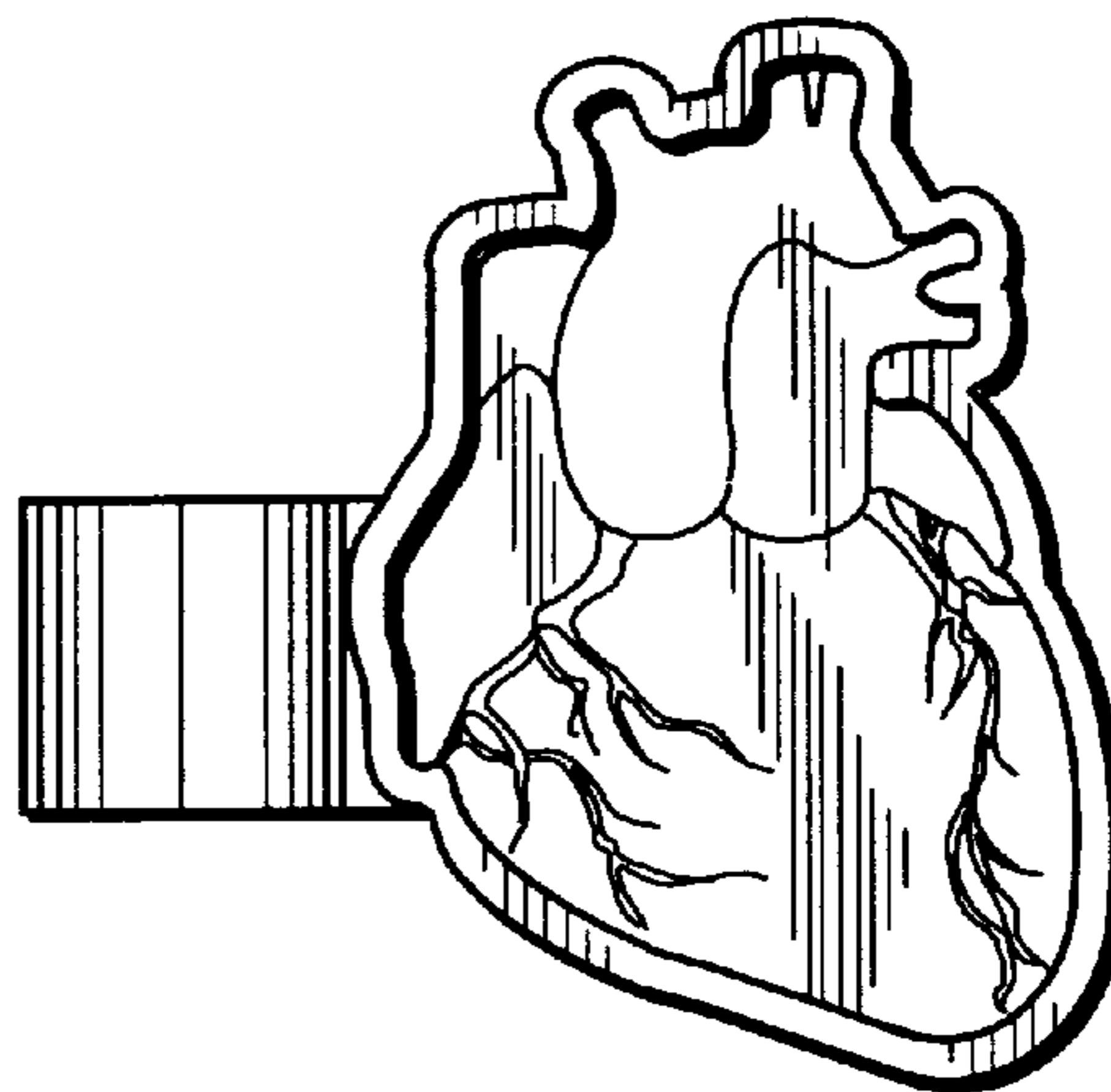
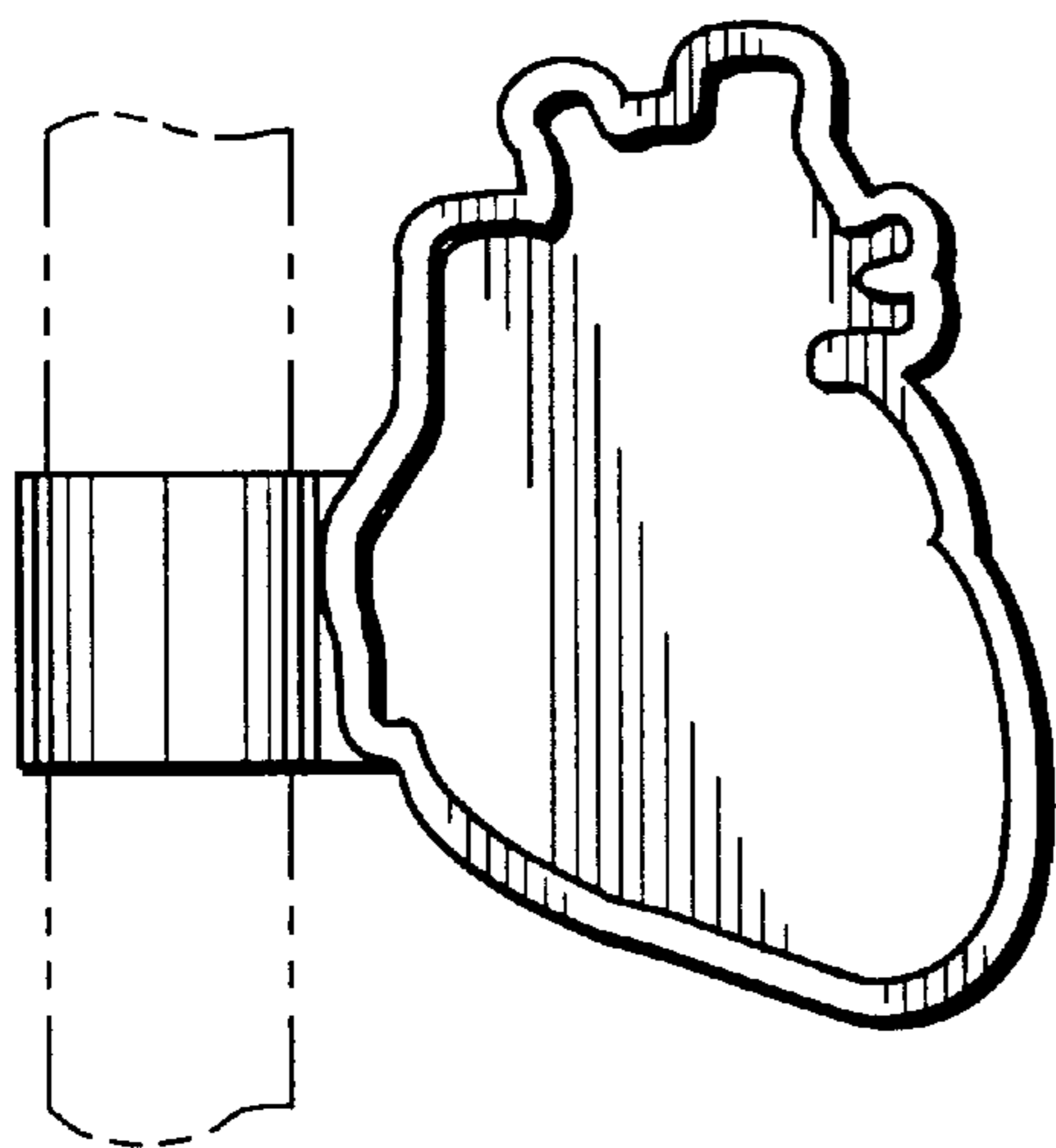
The article in which the design may be embodied is a name identification and advertising medium for a stethoscope or other medical device.

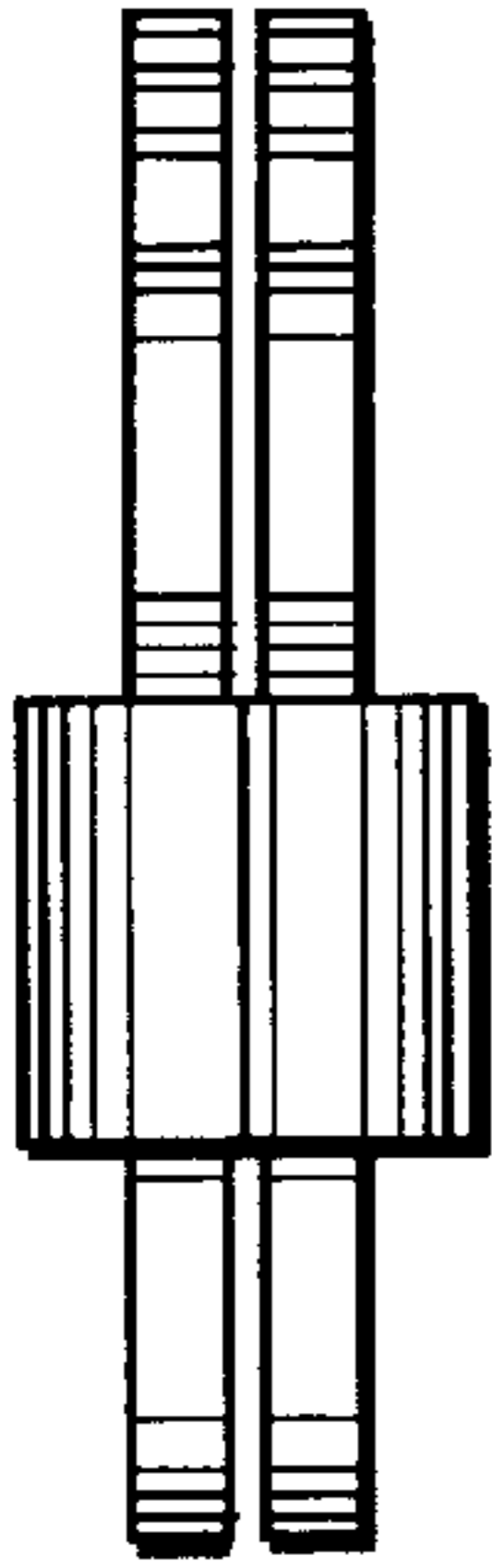

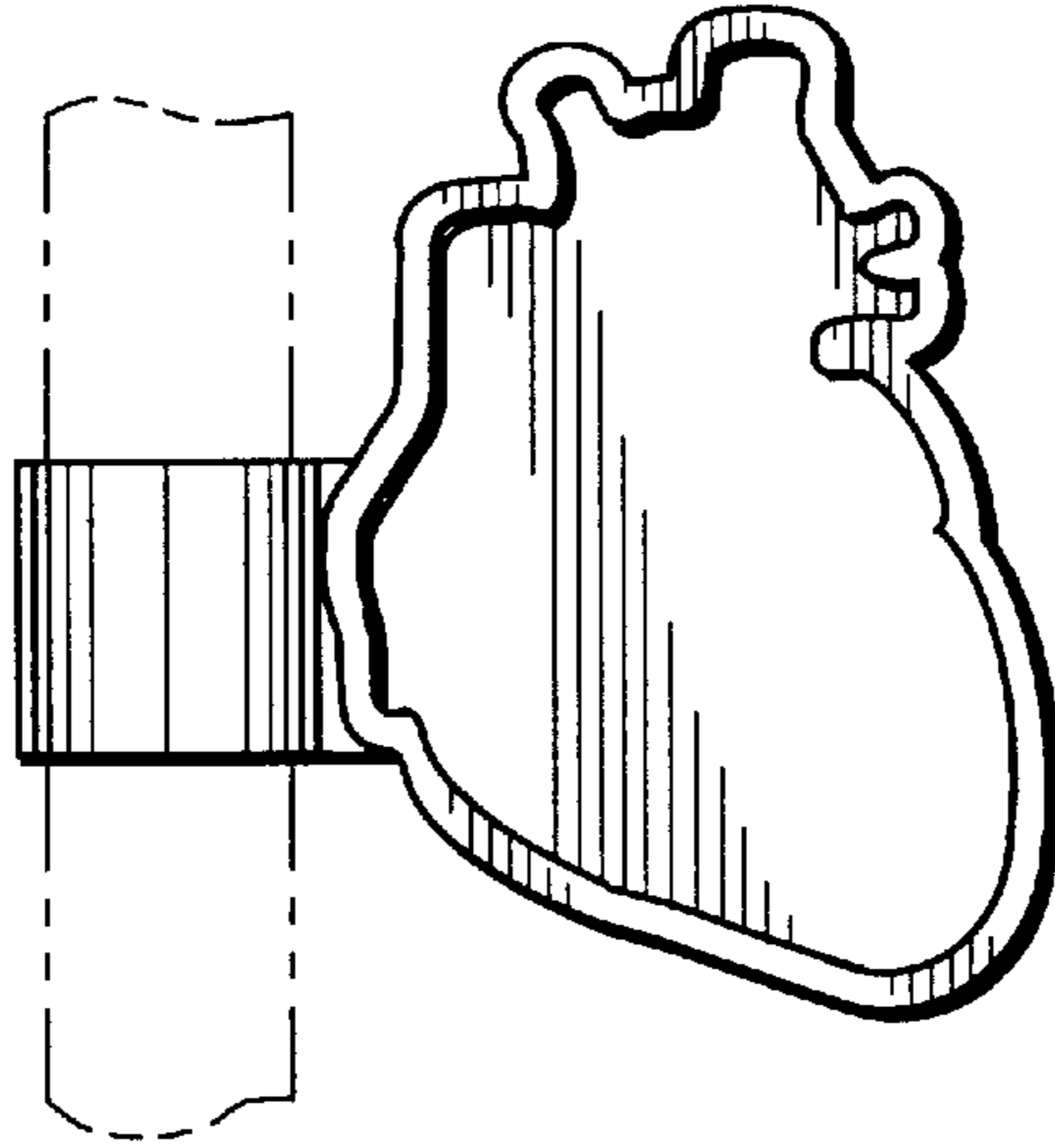

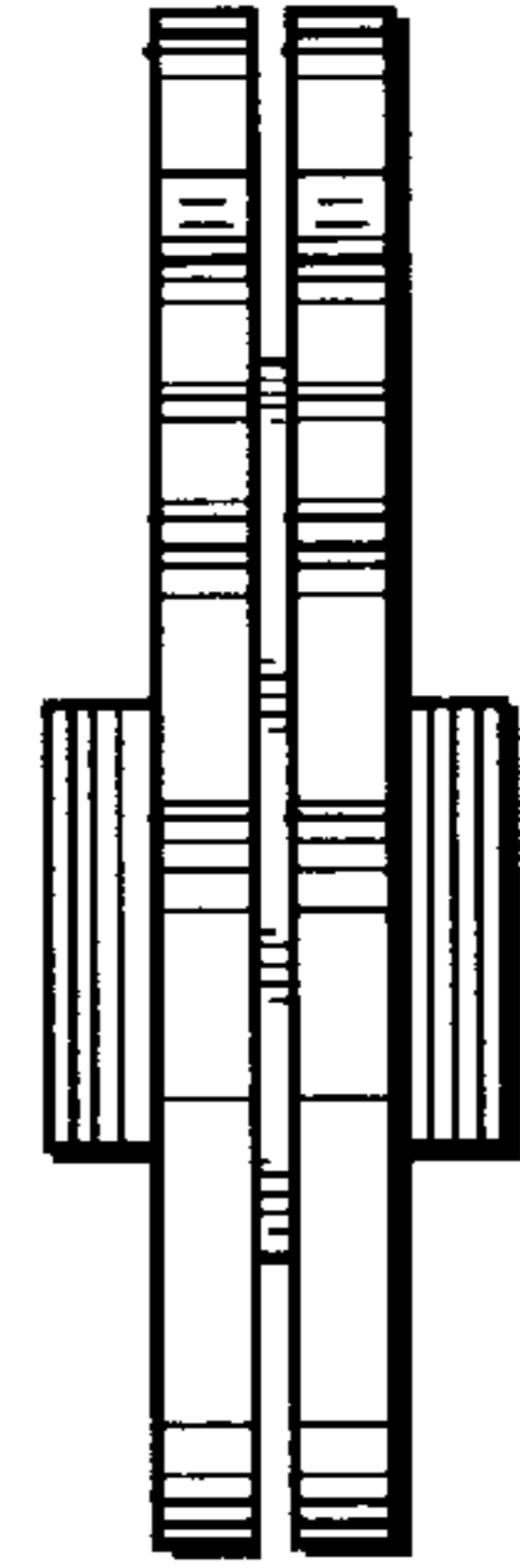

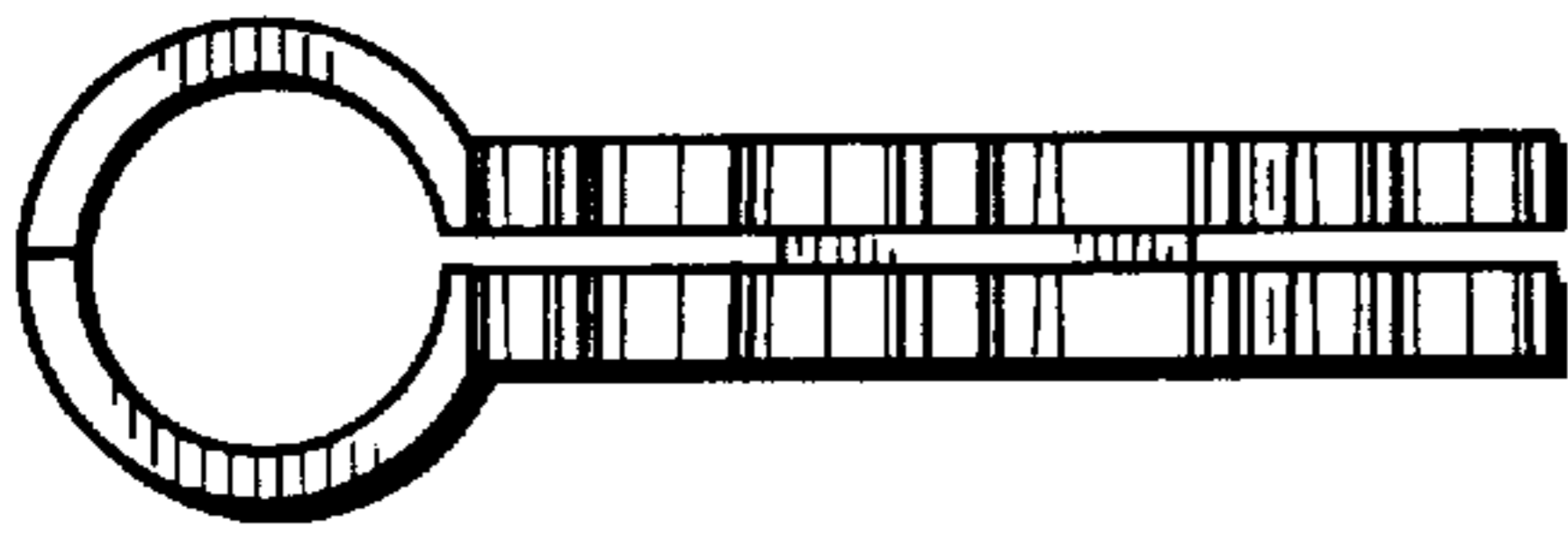

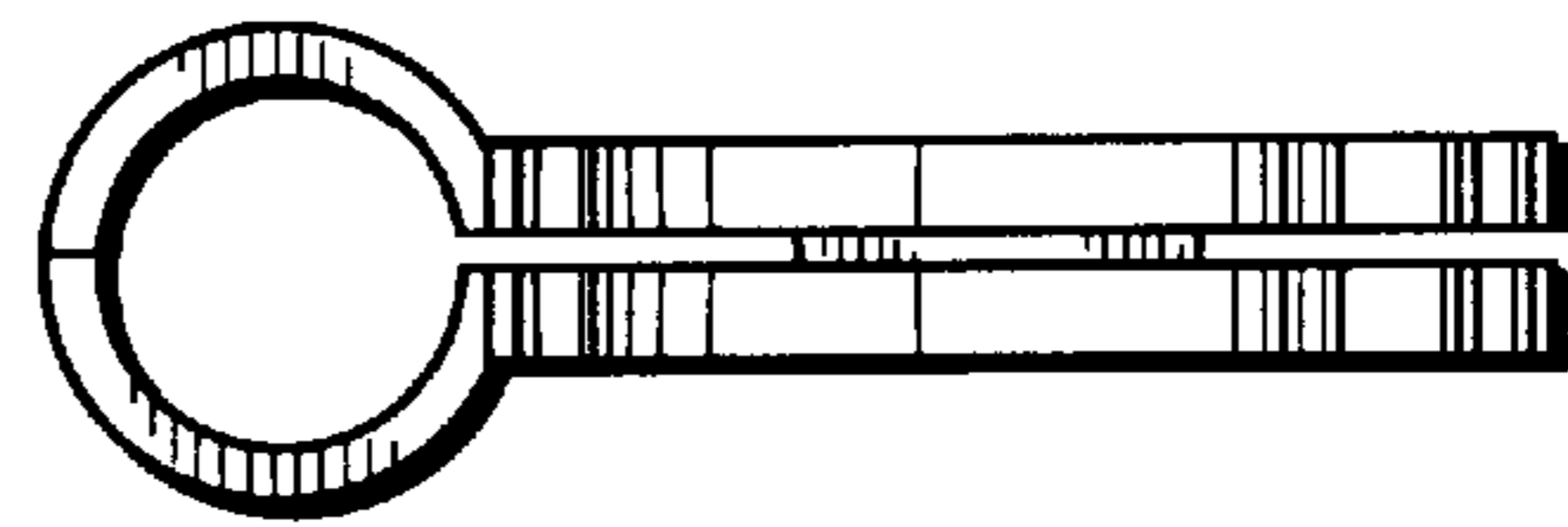

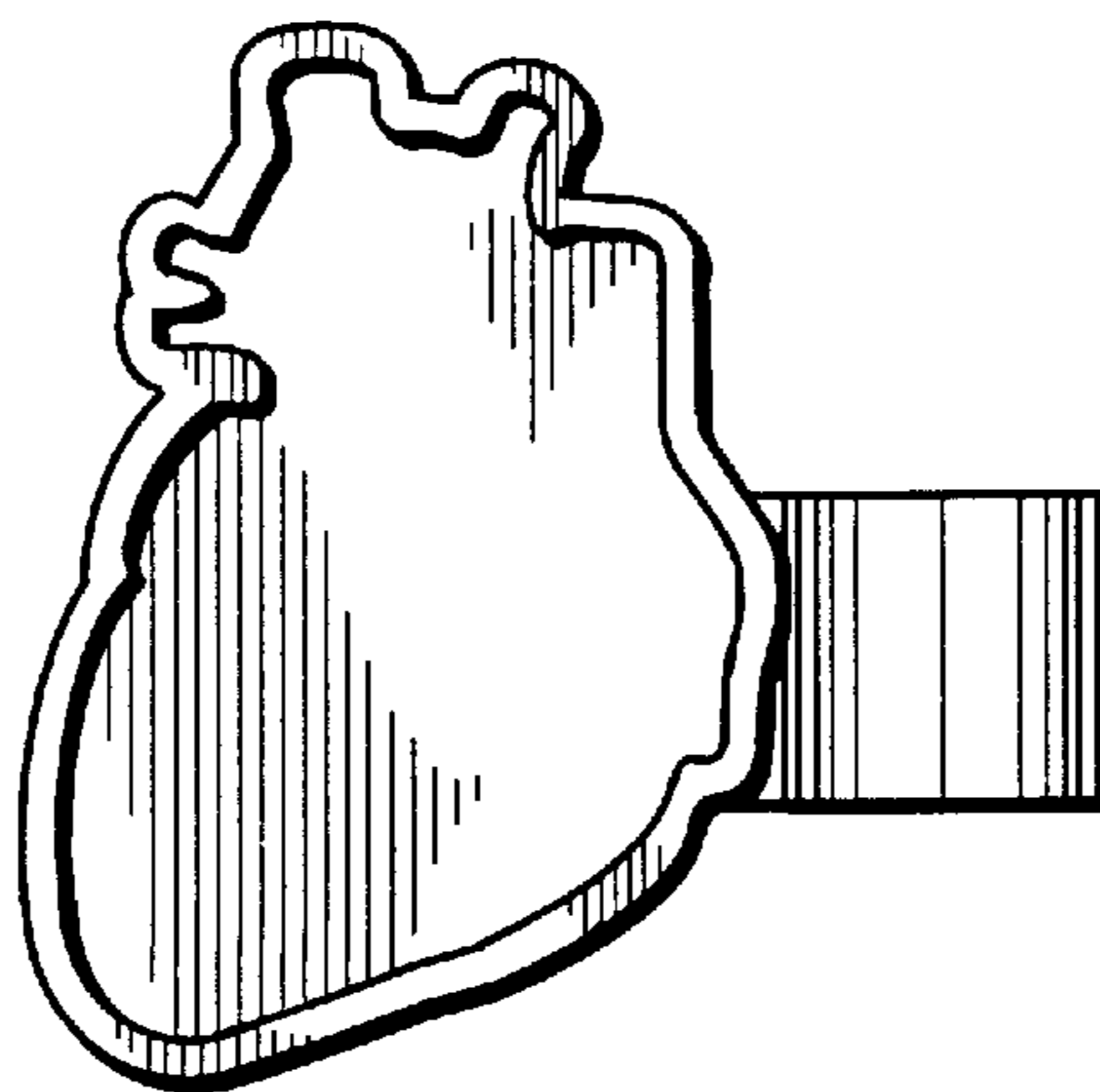

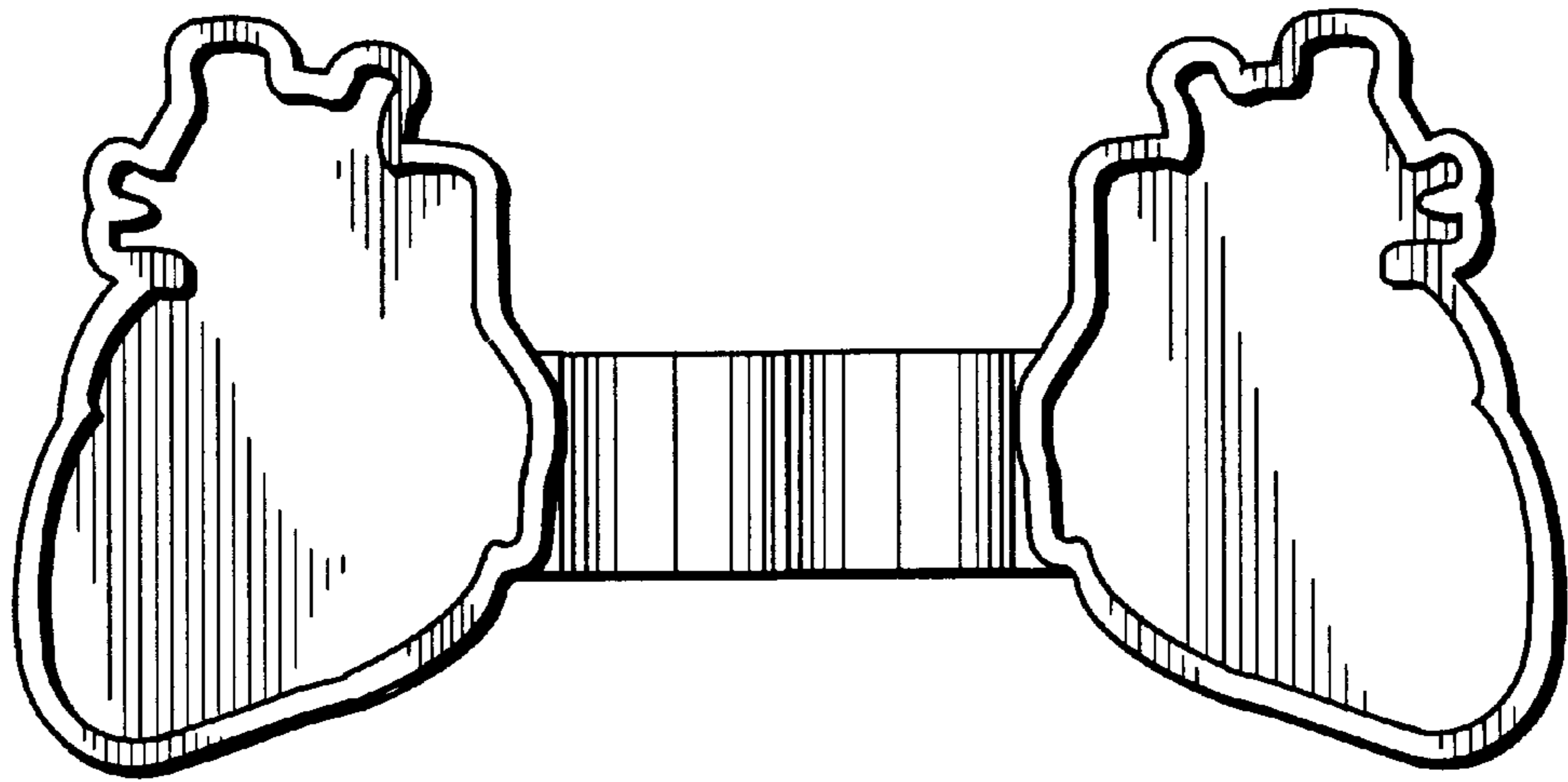

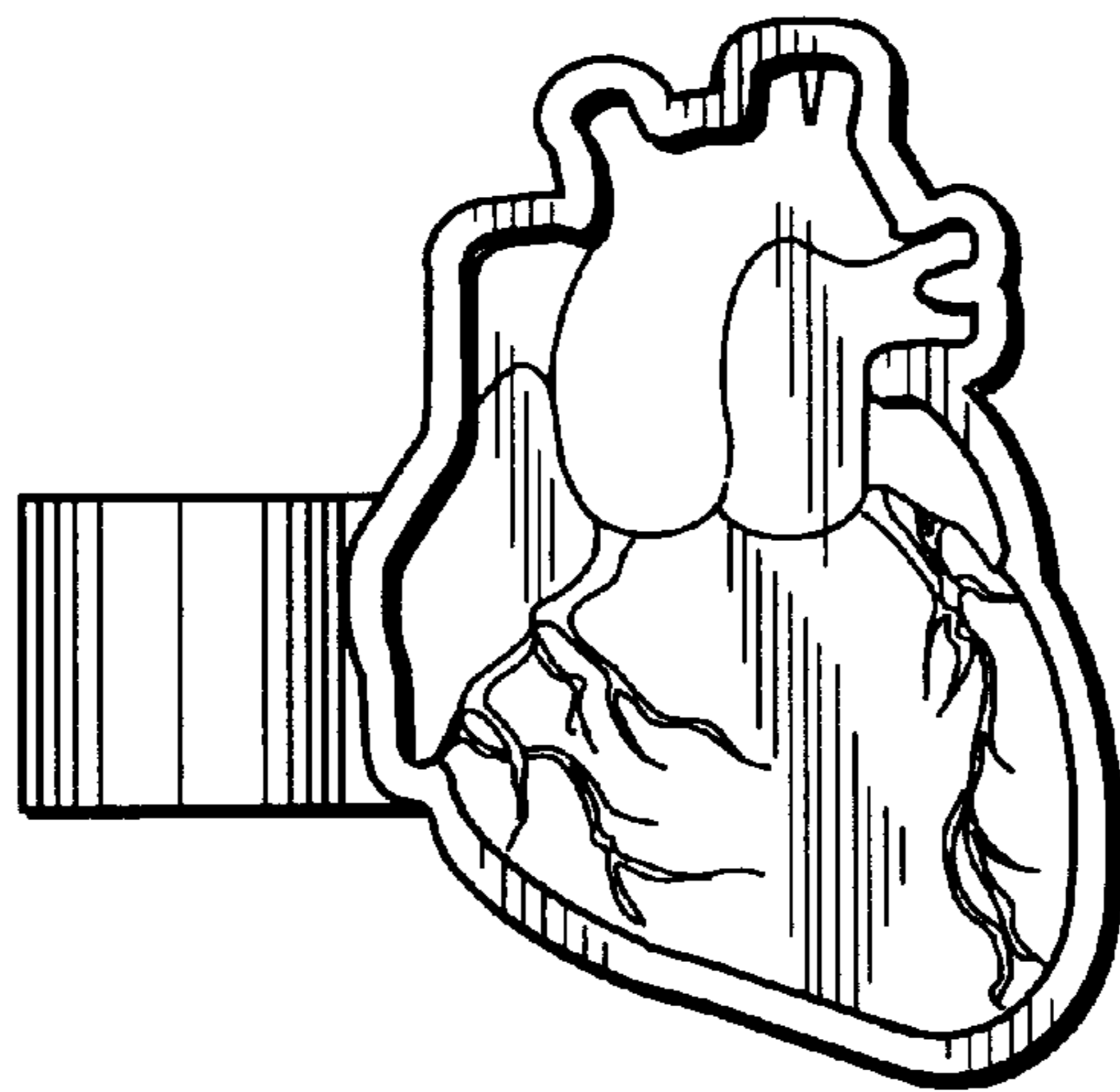
