[57] **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf club head showing a first embodiment of our new design;

FIG. 2 is a front elevational view of this first embodiment of the golf club head;

FIG. 3 is a rear elevational view of this first embodiment of the golf club head;

FIG. 4 is a right side elevational view of this first embodiment of the golf club head;

FIG. 5 is a left side elevational view of this first embodiment of the golf club head;

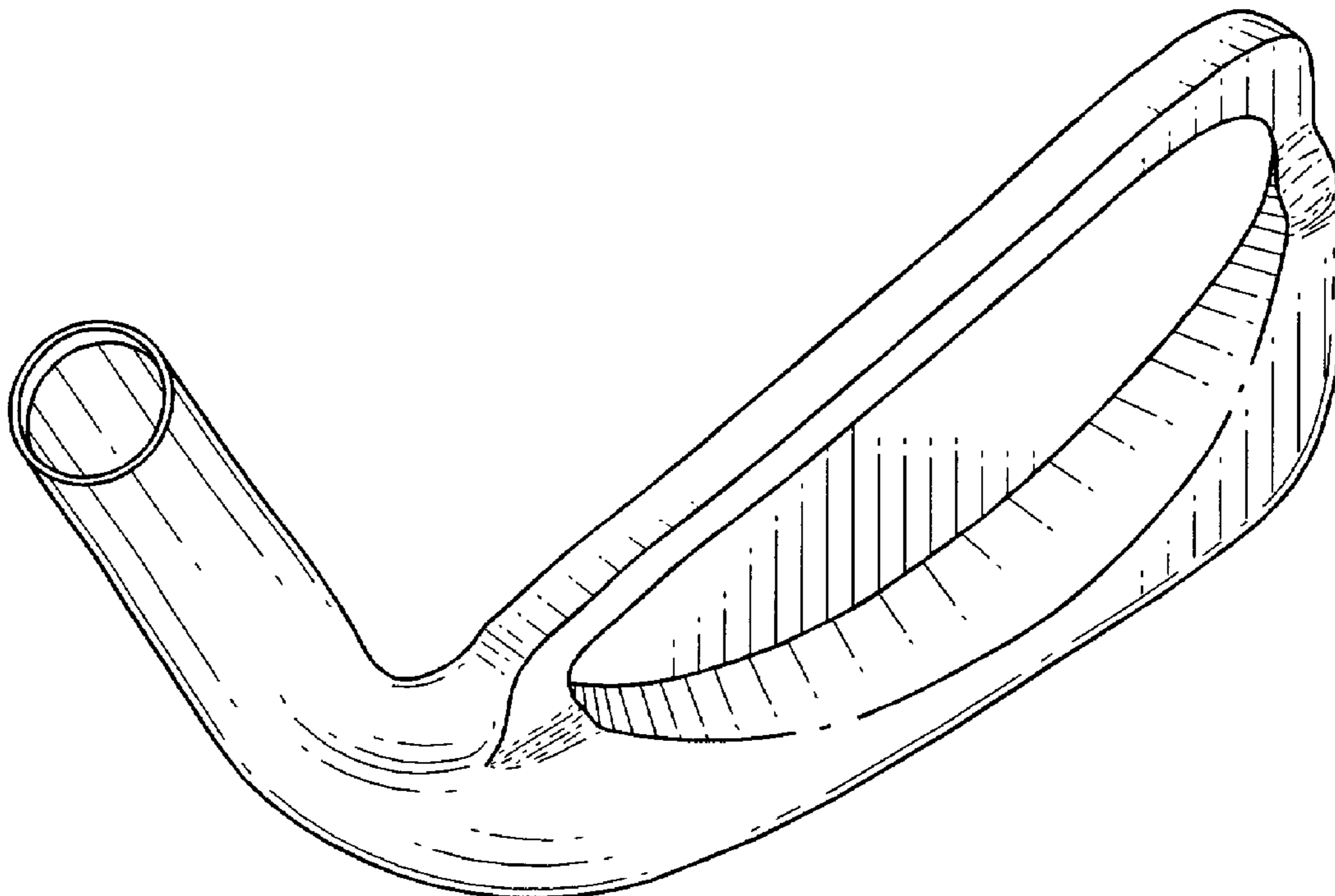
FIG. 6 is a top side plan view of this first embodiment of the golf club head;

FIG. 7 is a bottom plan view of this first embodiment of the golf club head;

FIG. 8 is a rear elevational view of a golf club head showing a second embodiment of our new design;

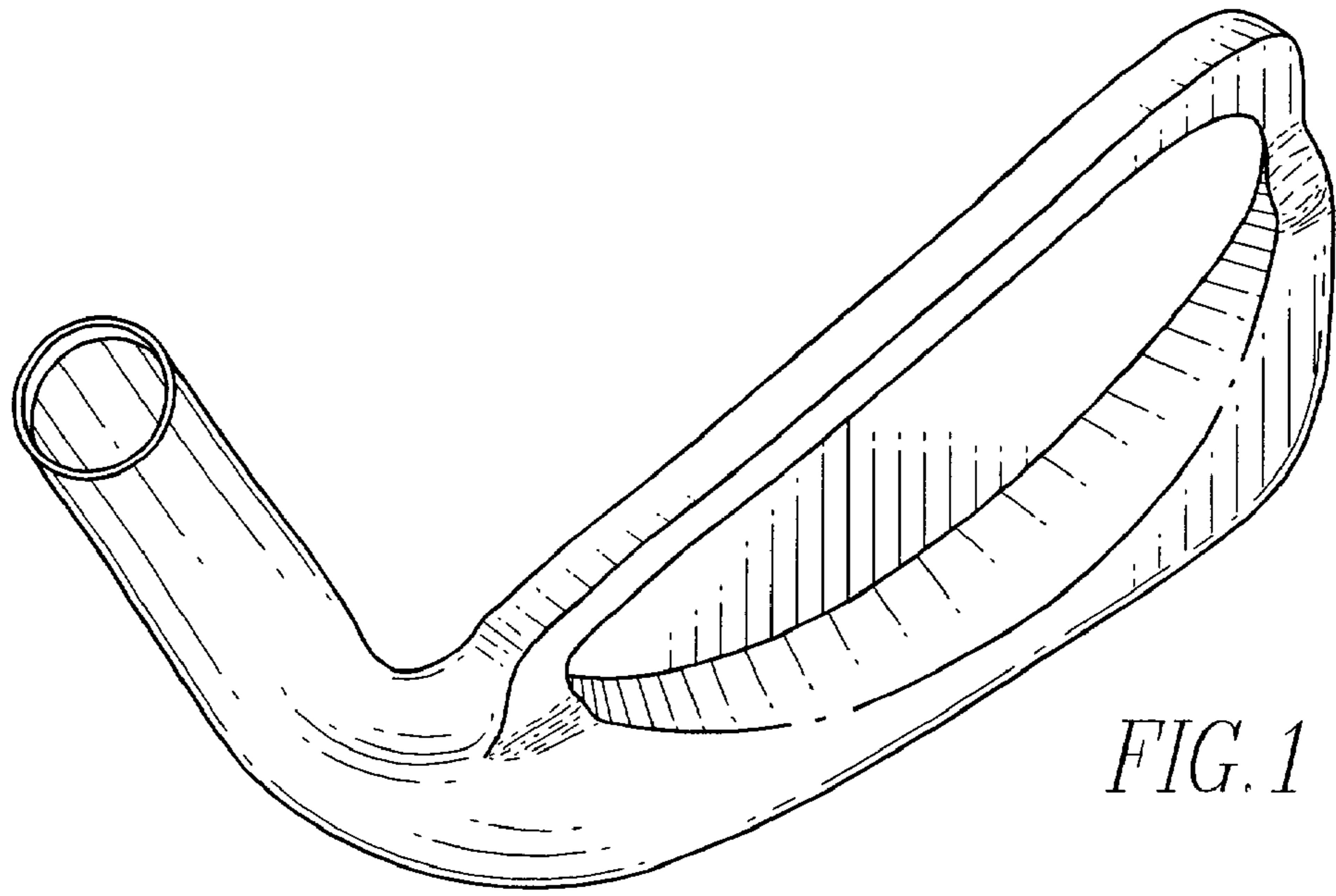

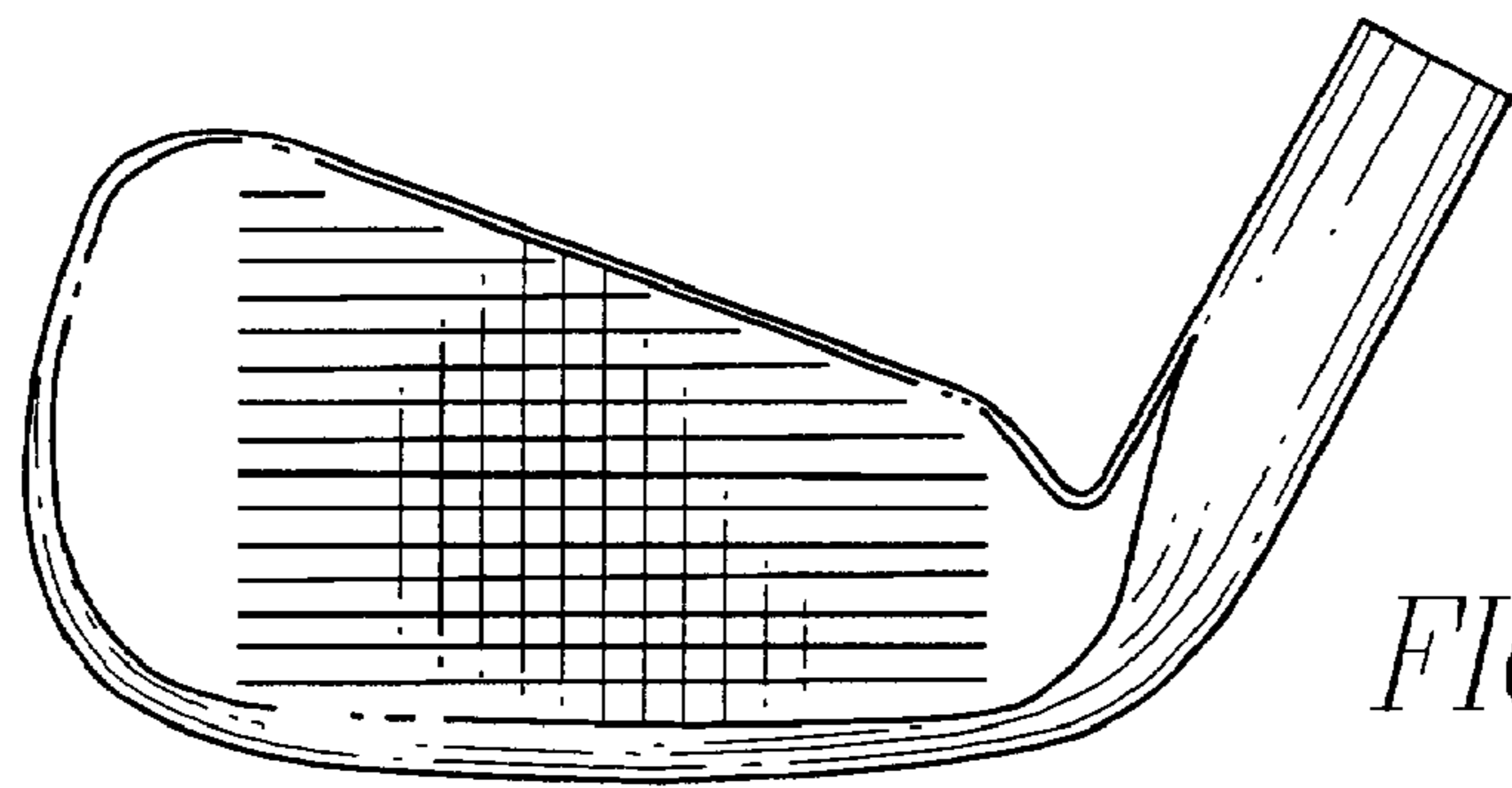

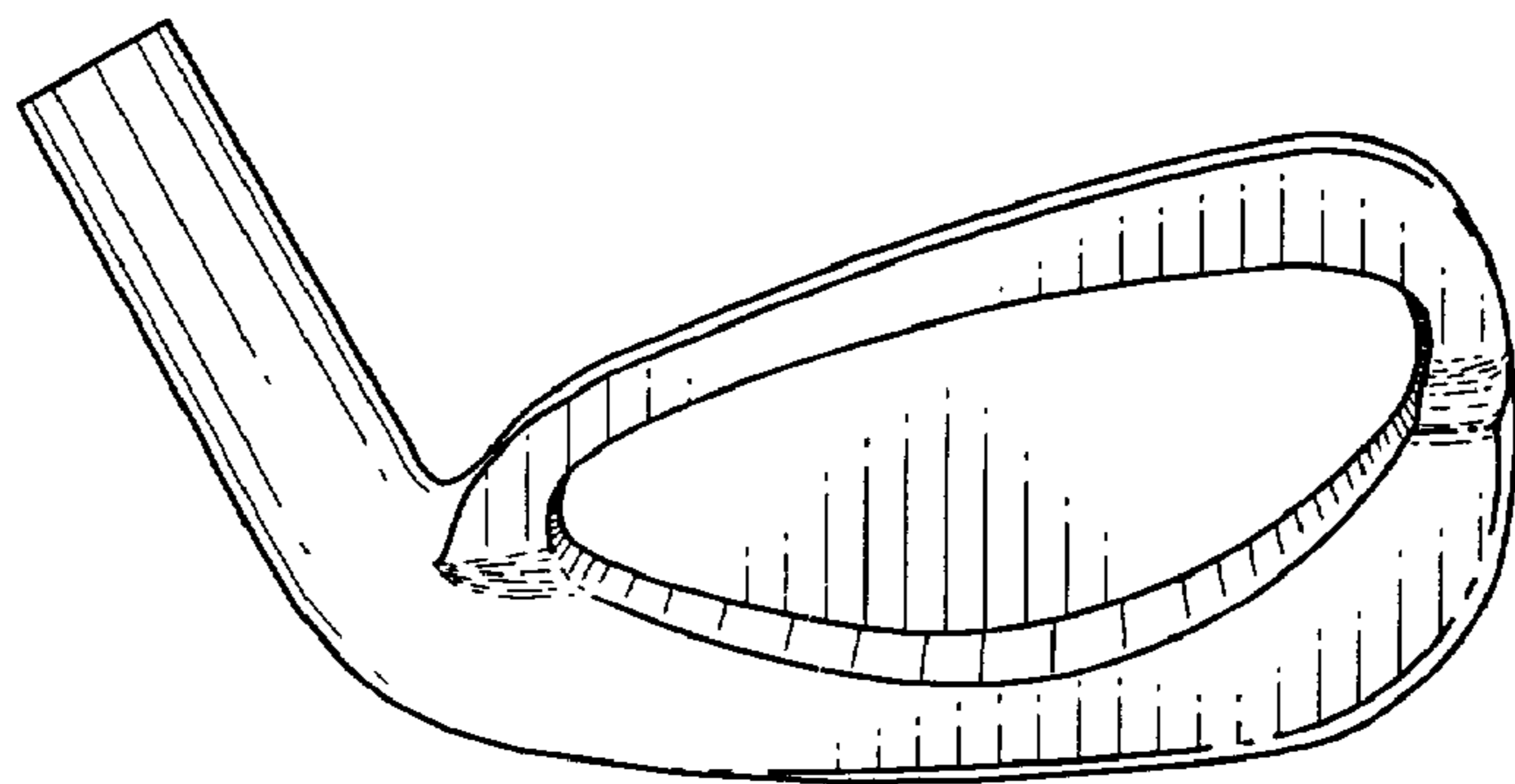

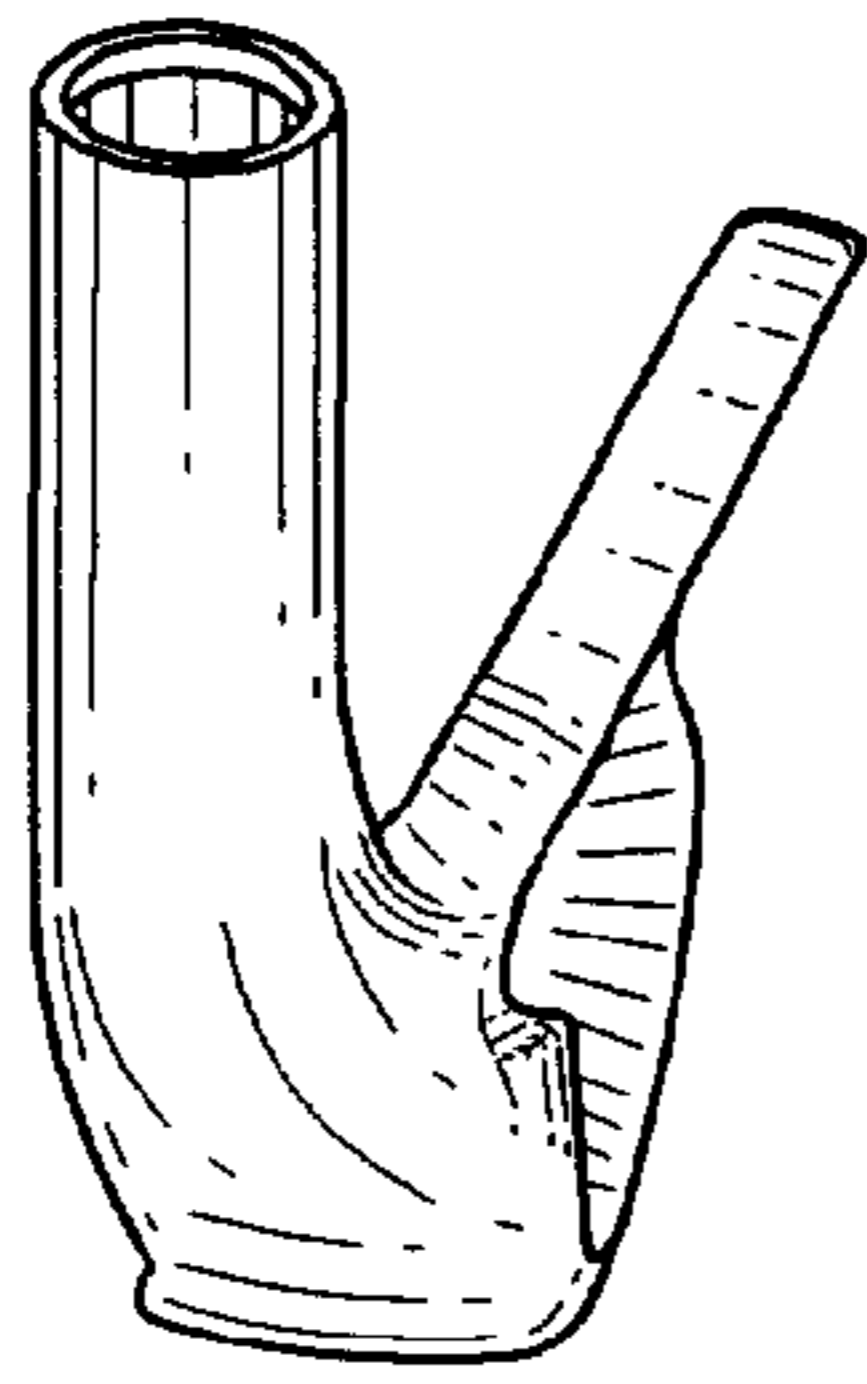

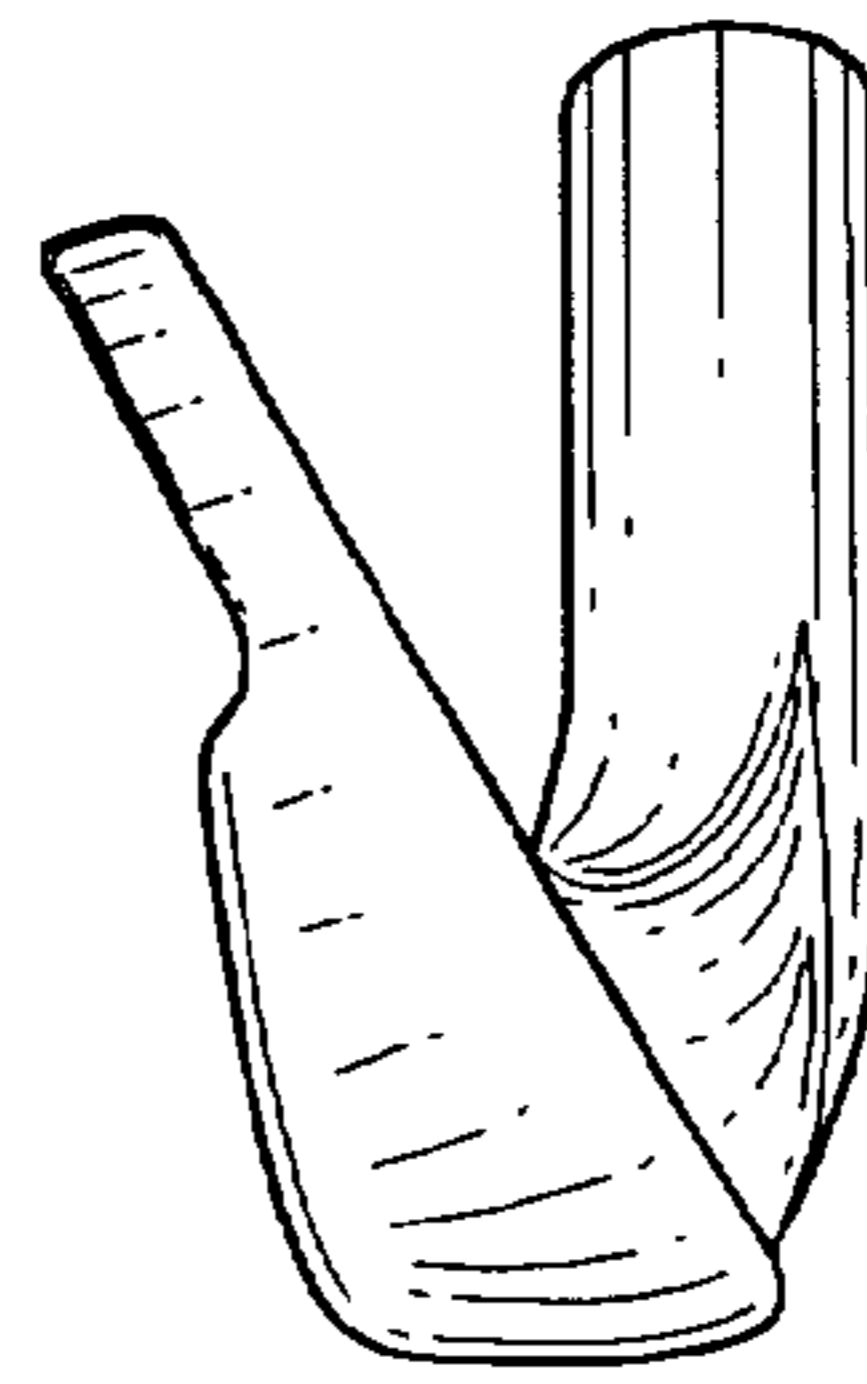

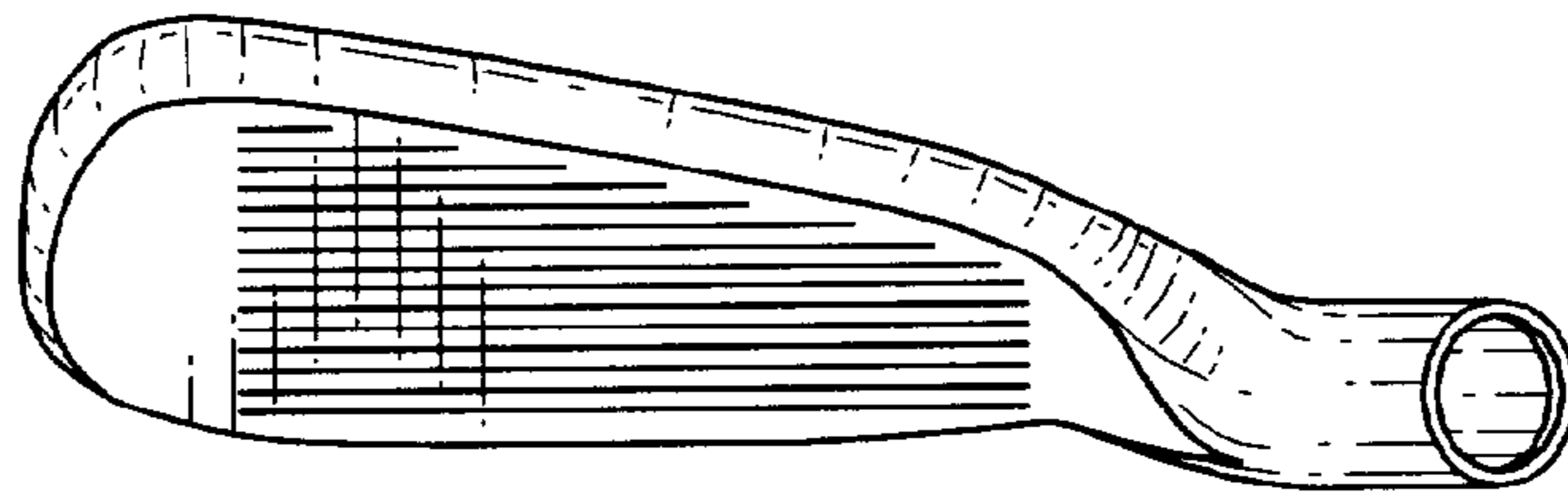

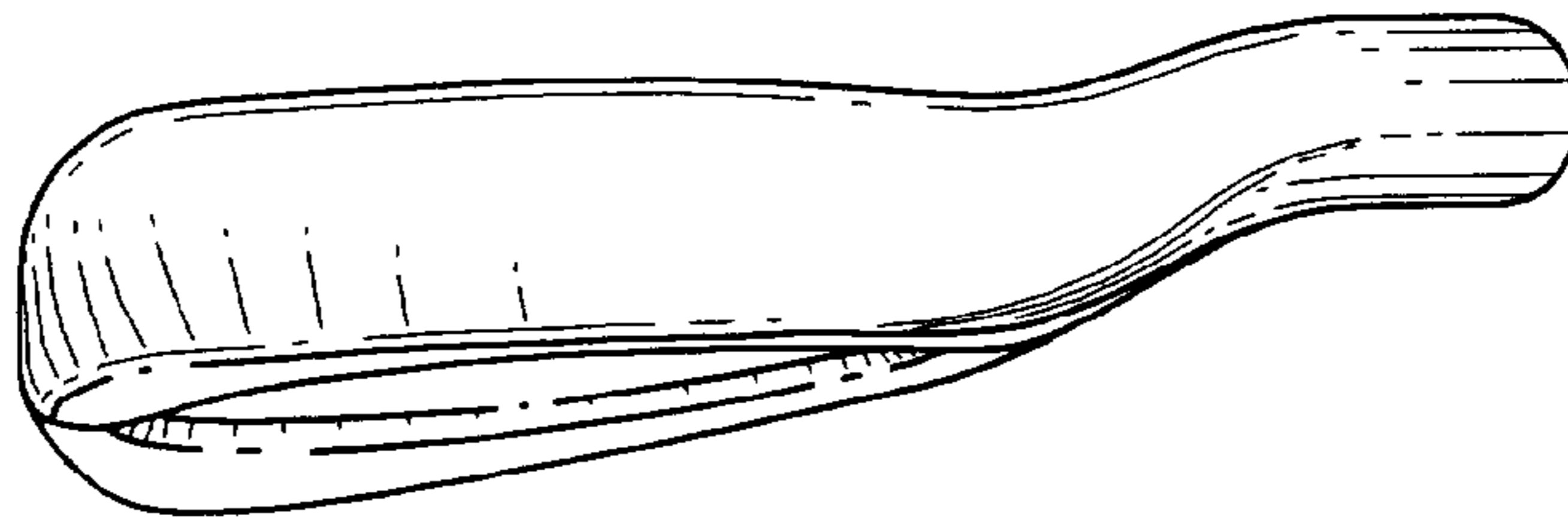

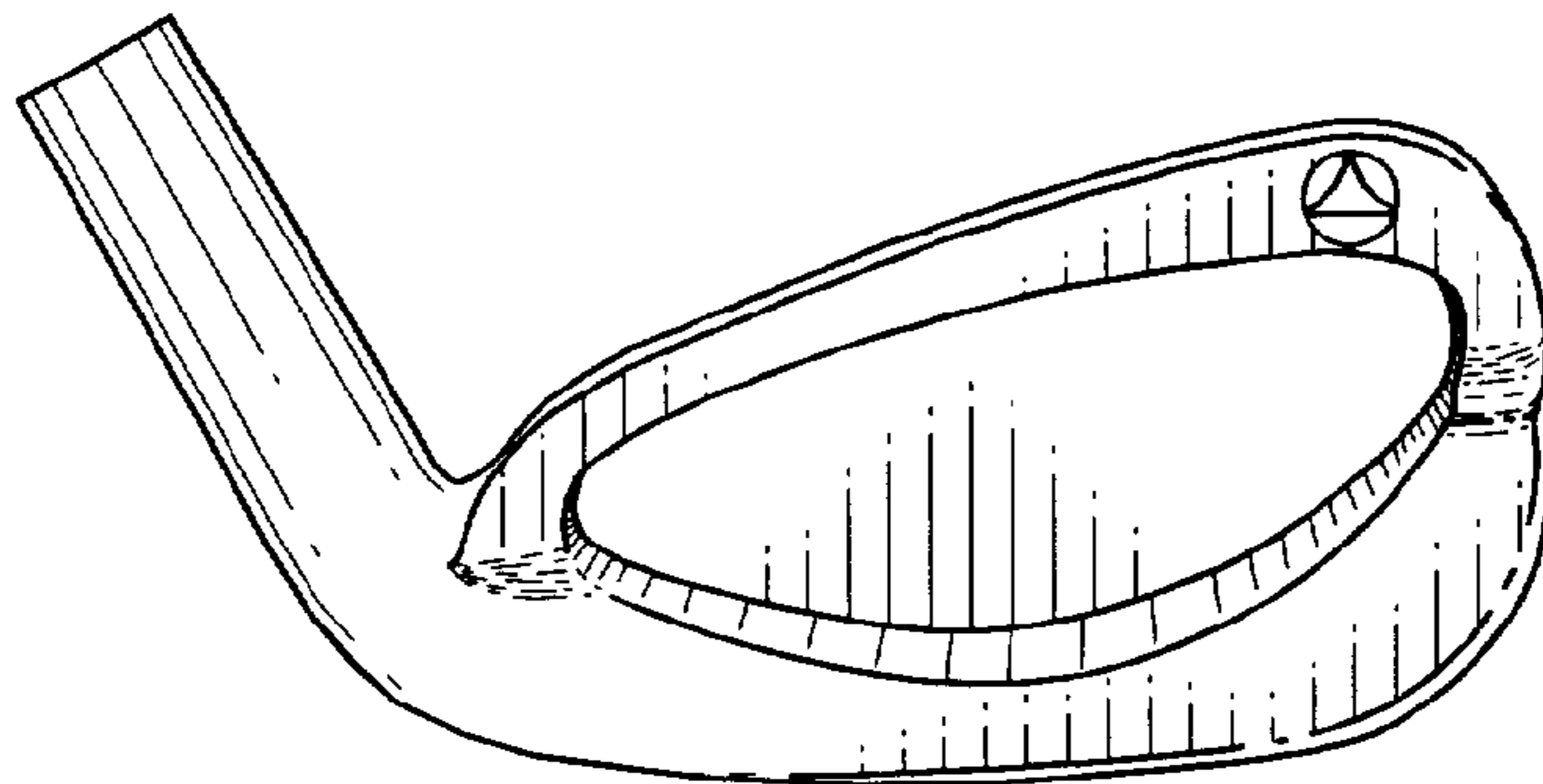
