[57] **CLAIM**

The ornamental design for a dual dispensing container, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a first embodiment, the side opposite being a mirror image of the side shown;
FIG. 2 is a side view of a second embodiment, the side opposite being a mirror image of the side shown;
FIG. 3 is an exploded view of FIG. 1;
FIG. 4 is an end view seen in the direction of arrows 4—4 of FIG. 1; and,
FIG. 5 is an end view along line 5—5 of FIG. 1, wherein each end view of FIG. 2 is the same as shown in FIG. 5.

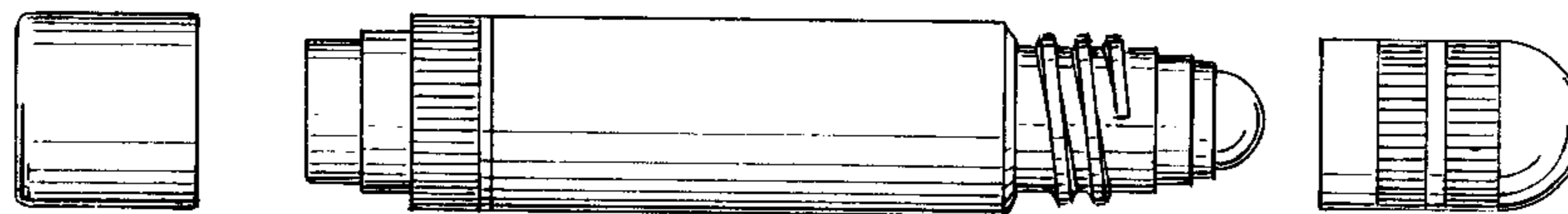
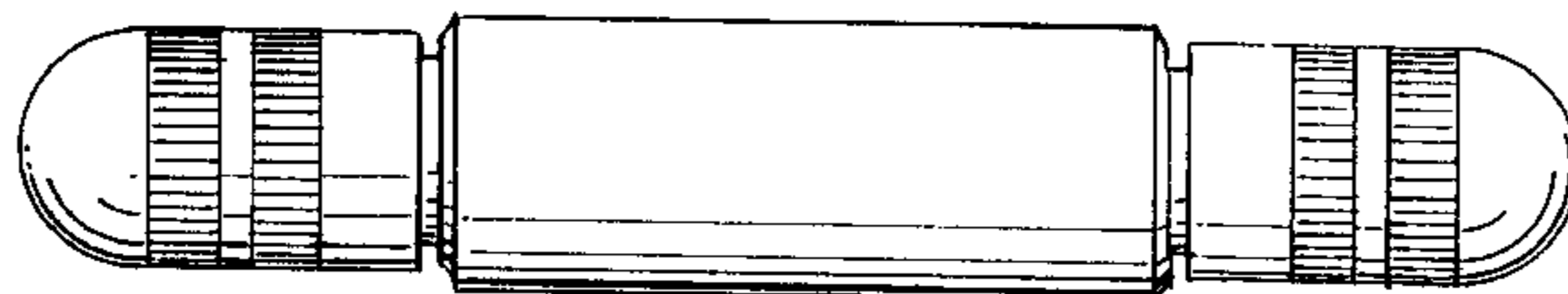

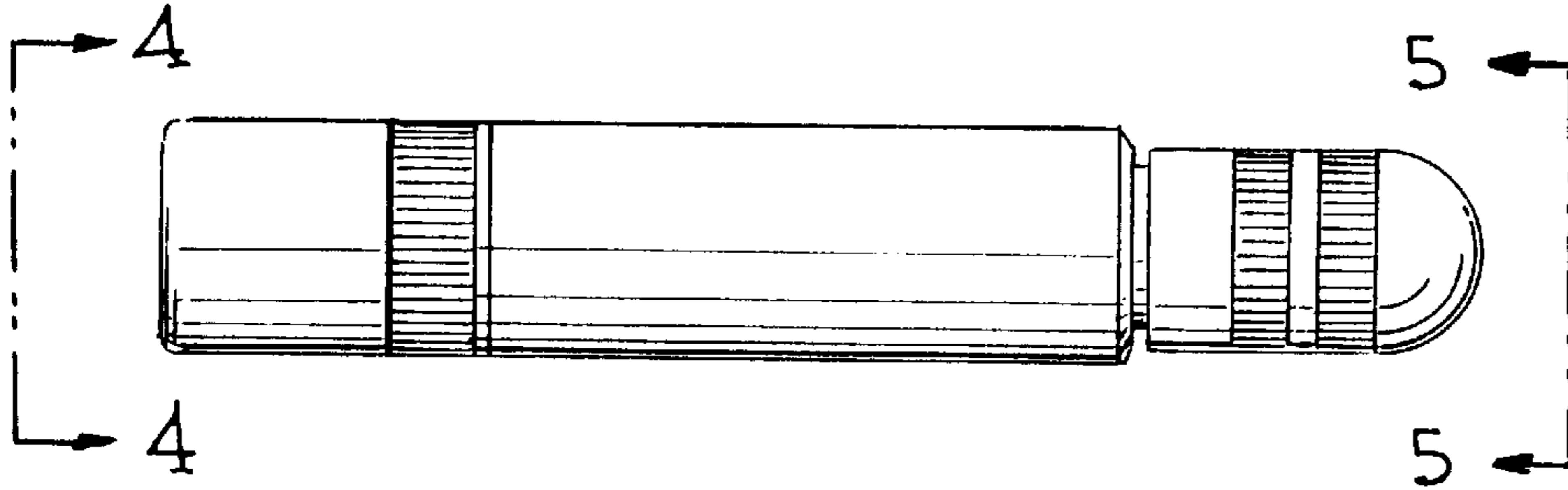

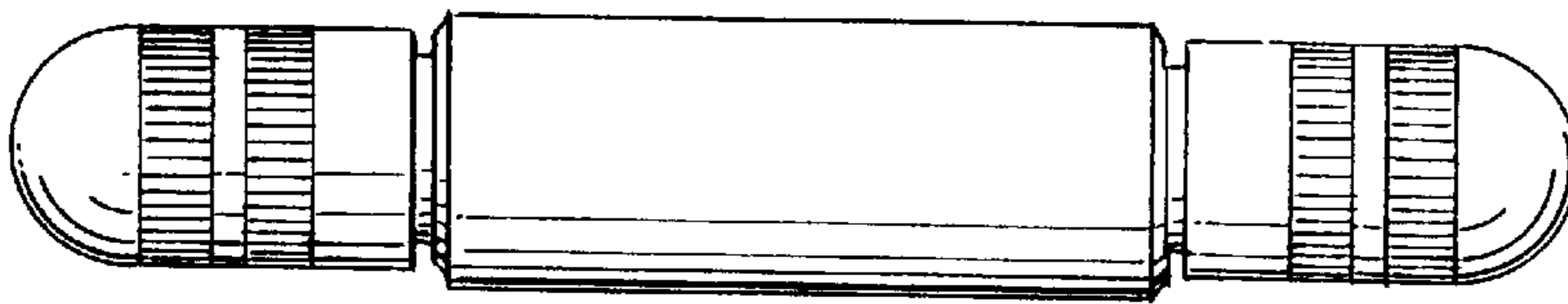

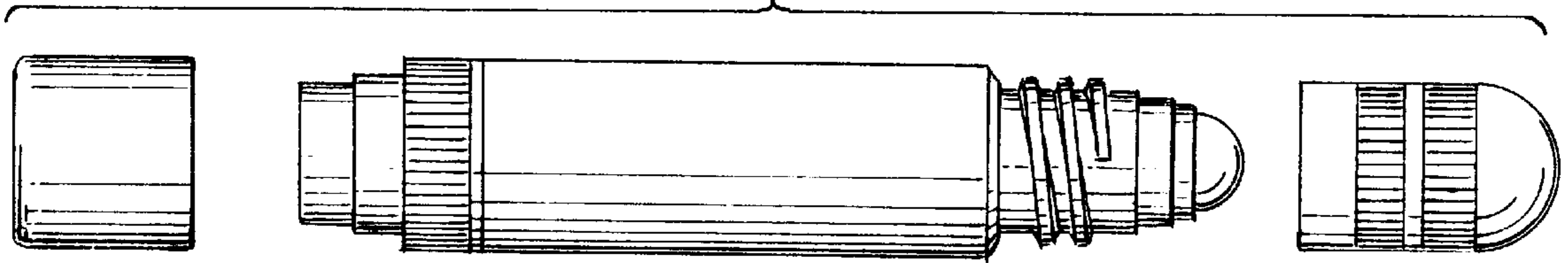

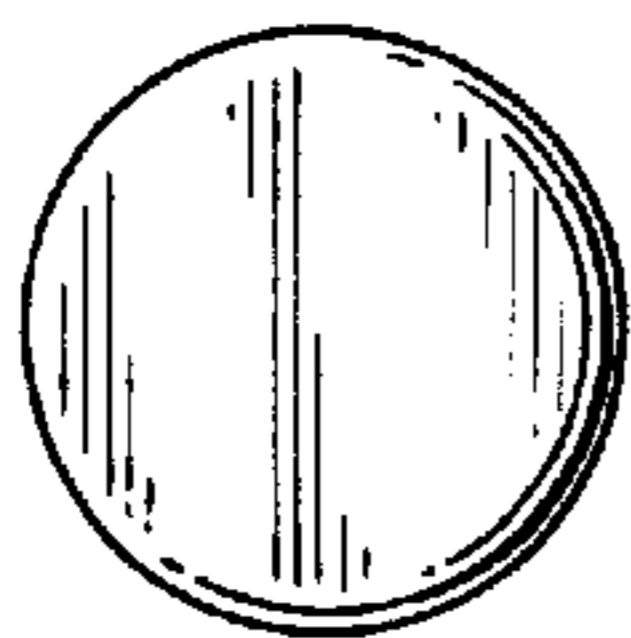
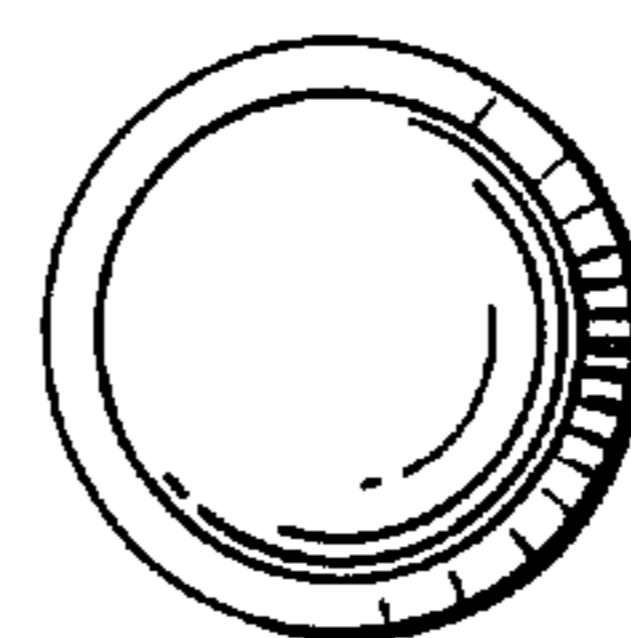


