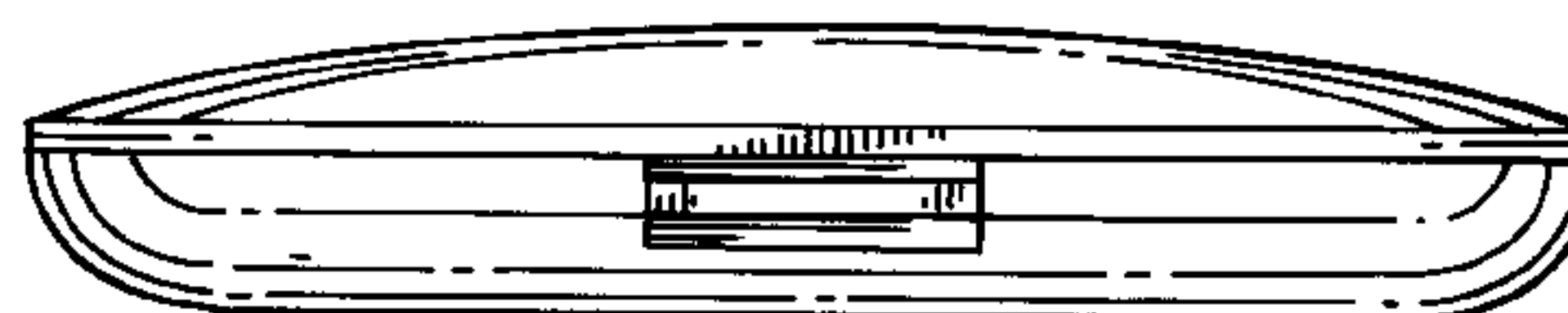
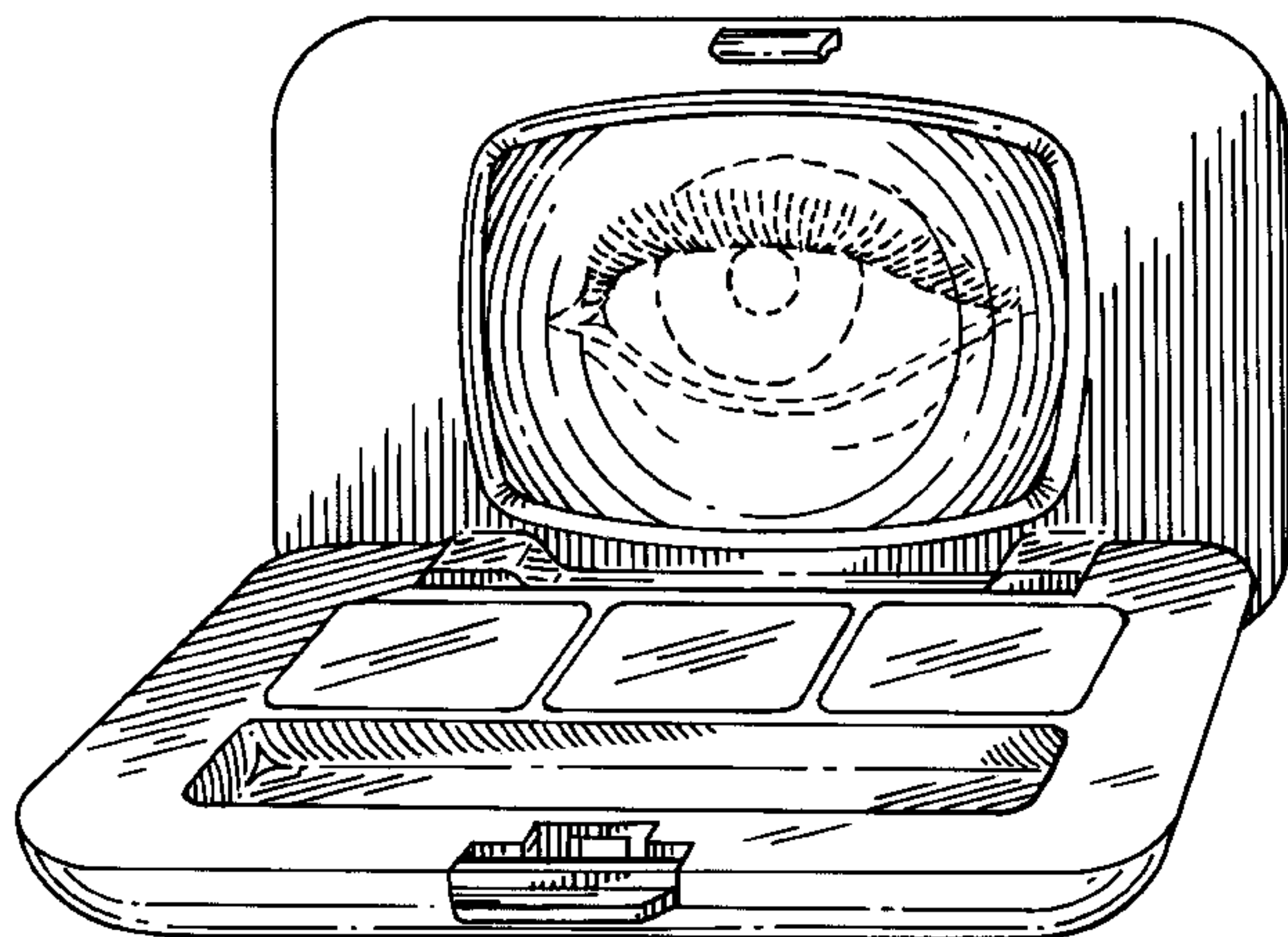
[57] **CLAIM**

The ornamental design for an eye makeup compact with enlarging mirror, as shown and described.

**DESCRIPTION**

FIG. 1 depicts a perspective view of the inside of the eye makeup compact with enlarging mirror;  
FIG. 2 depicts a top plan view of the eye makeup compact with enlarging mirror shown in the closed position, revealing the convex enlarging mirror;  
FIG. 3 depicts a bottom plan view of FIG. 2;  
FIG. 4 depicts a right-side elevation view of FIG. 2;  
FIG. 5 depicts a left side elevation view of FIG. 2 with cover open;  
FIG. 6 depicts a front elevation view of FIG. 2; and,  
FIG. 7 depicts a rear elevation view of FIG. 2.  
The portions of the compact interior that are not visible in FIG. 1. are not being claimed.  
The broken lines showing the human eye are for illustrative purposes only, and form no part of the claimed design.

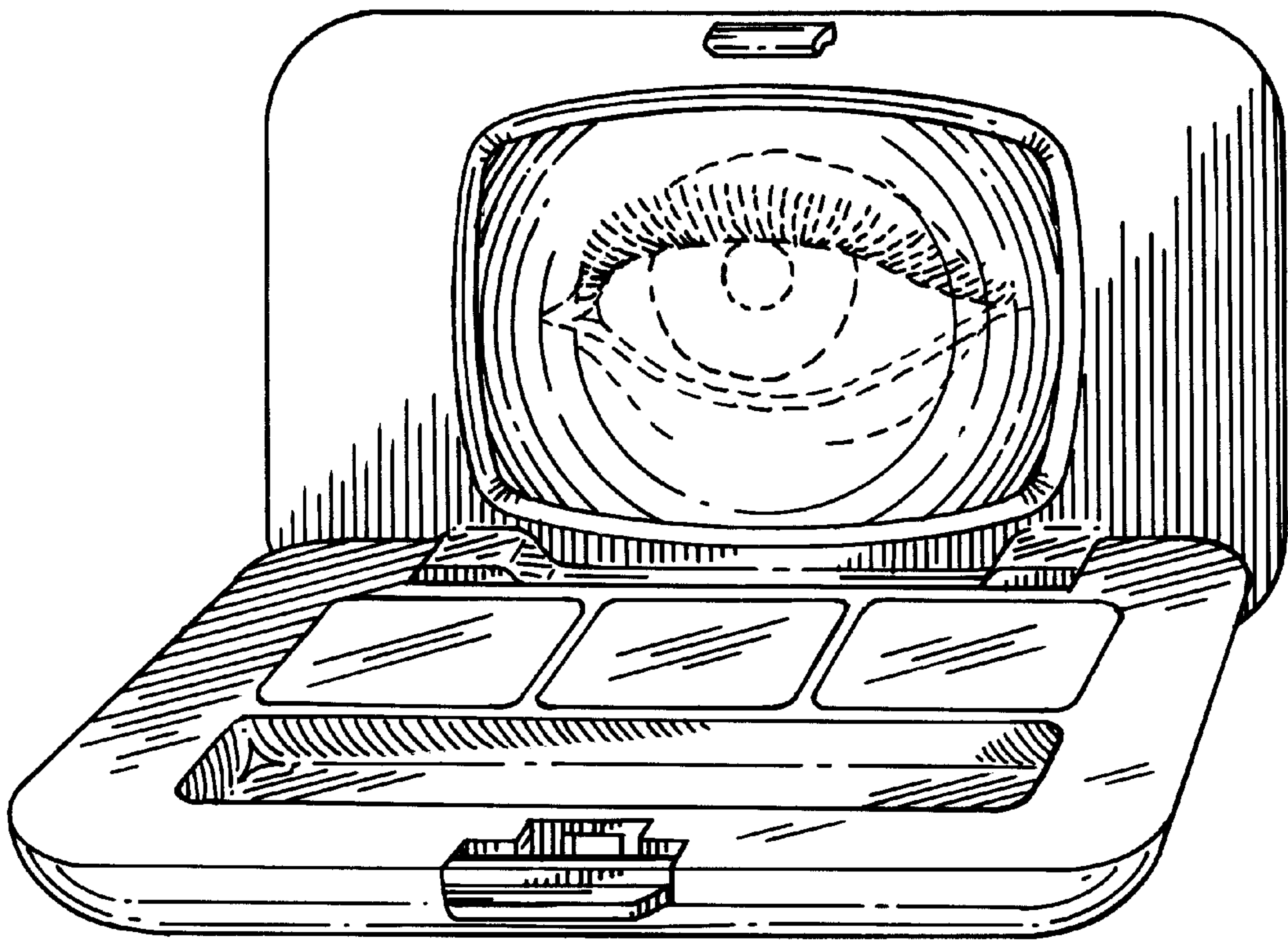

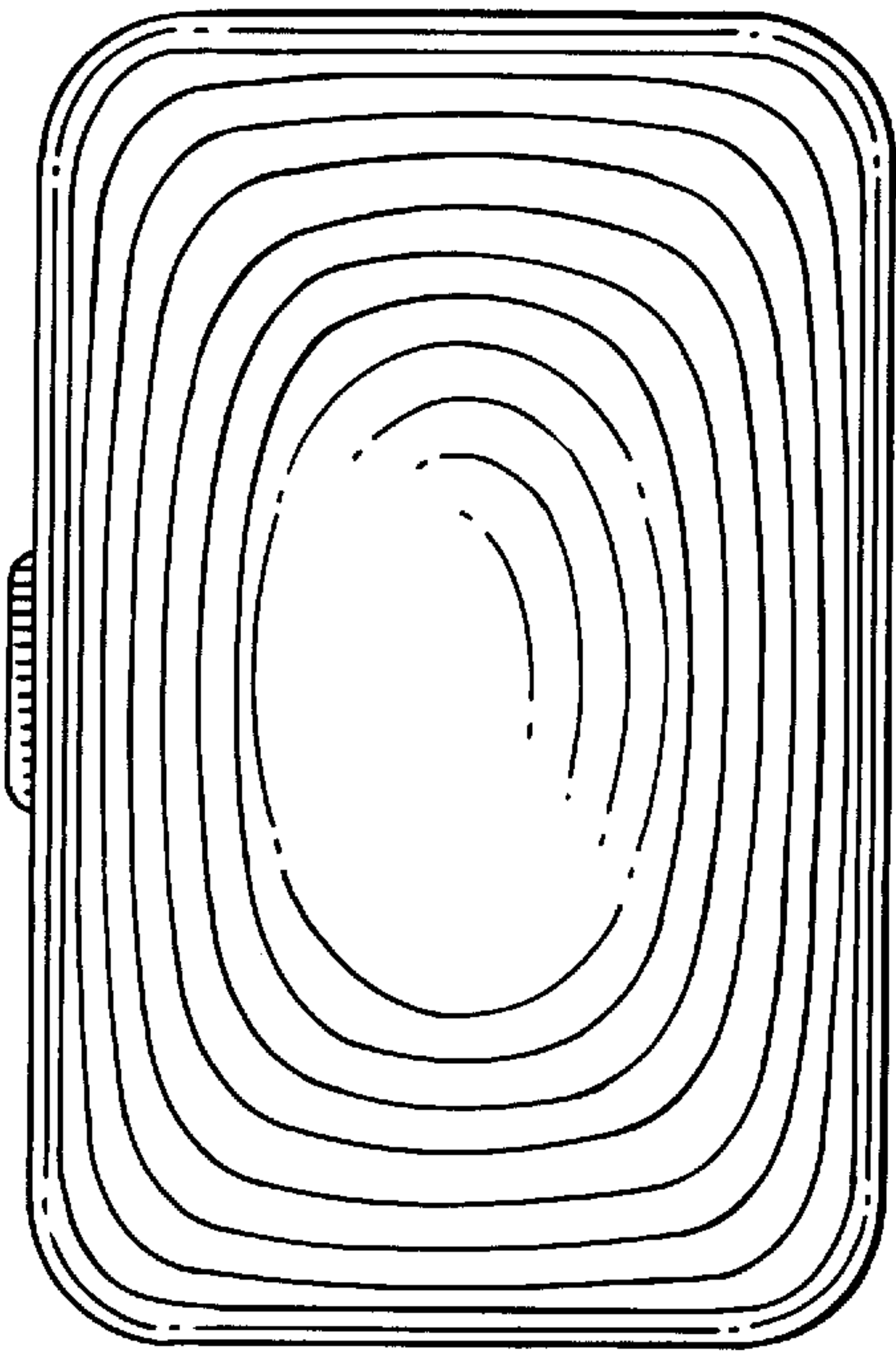

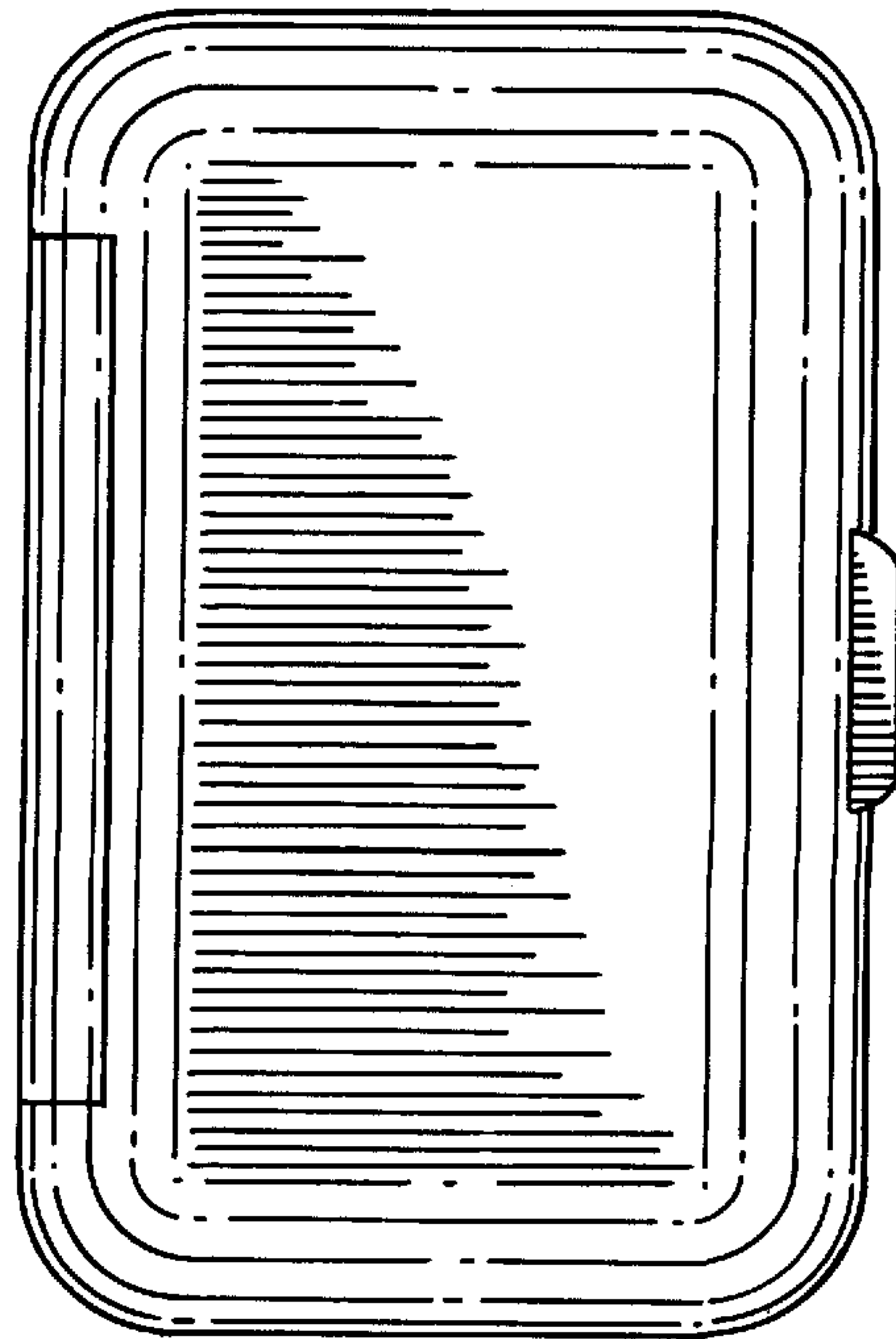

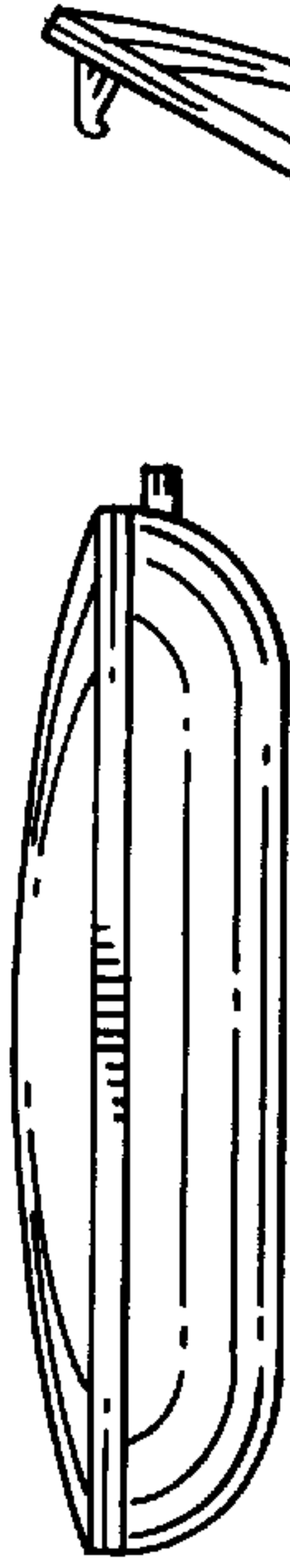

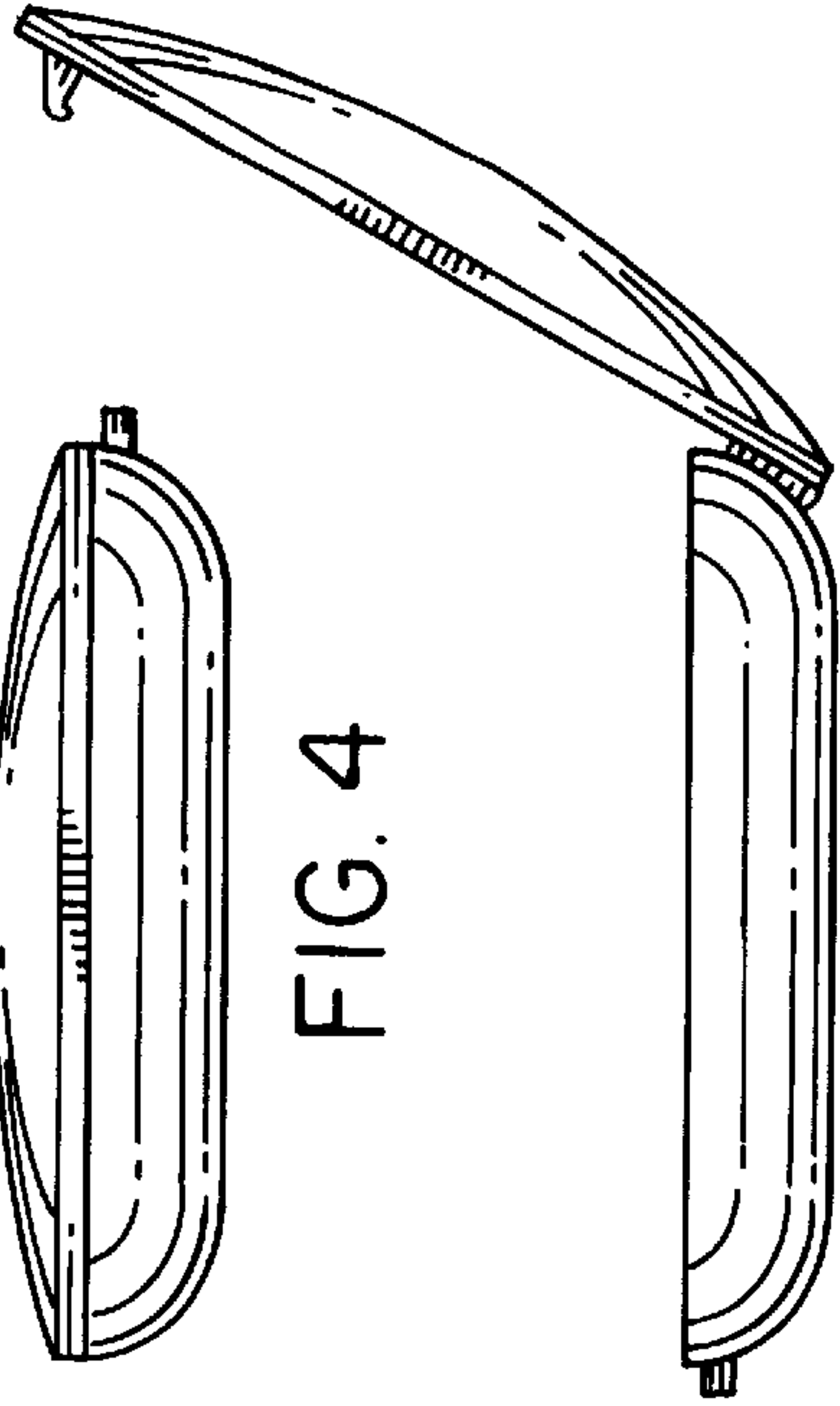

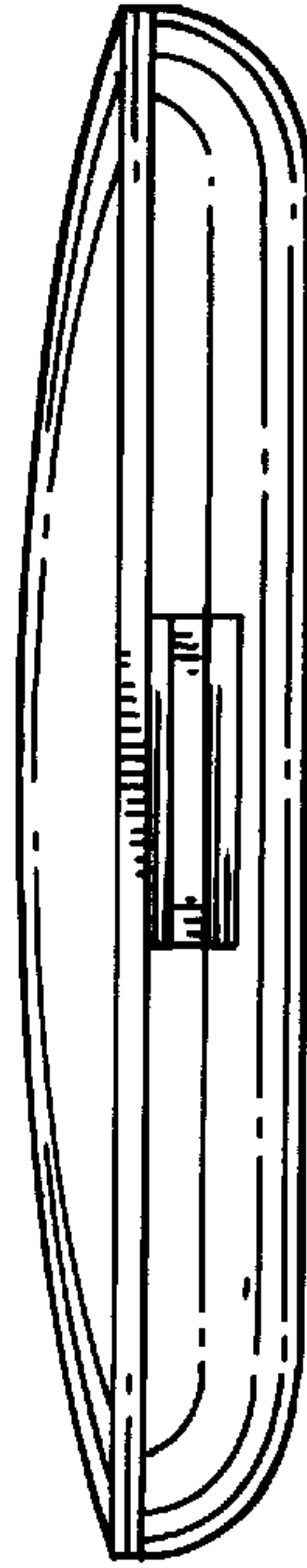

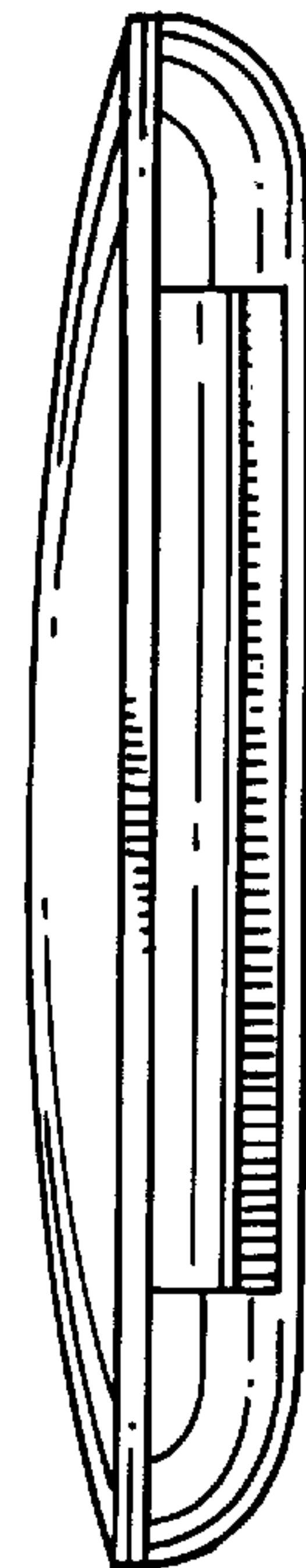
