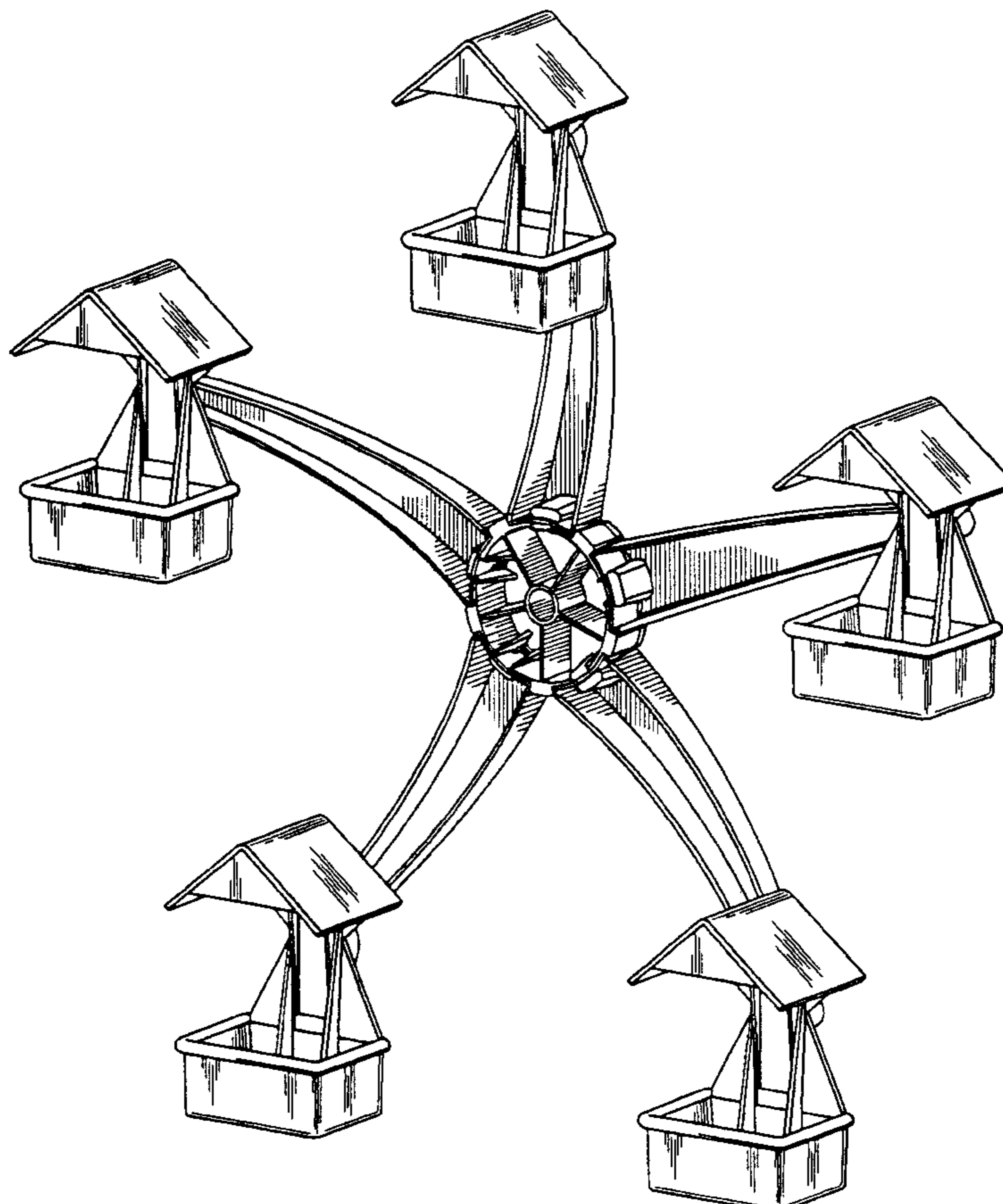
FIG. 1 is a perspective view of a bird feeder showing our new design;

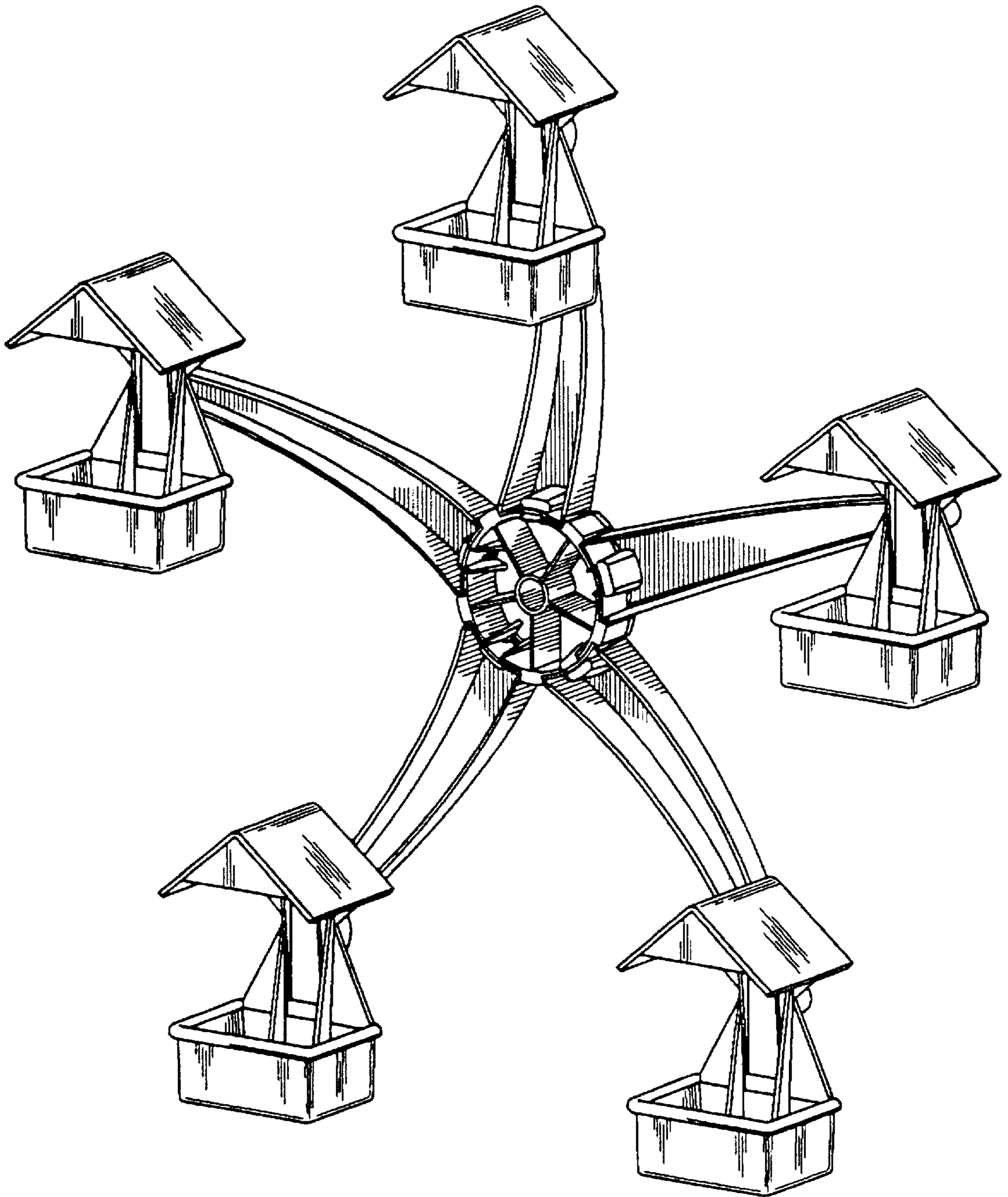

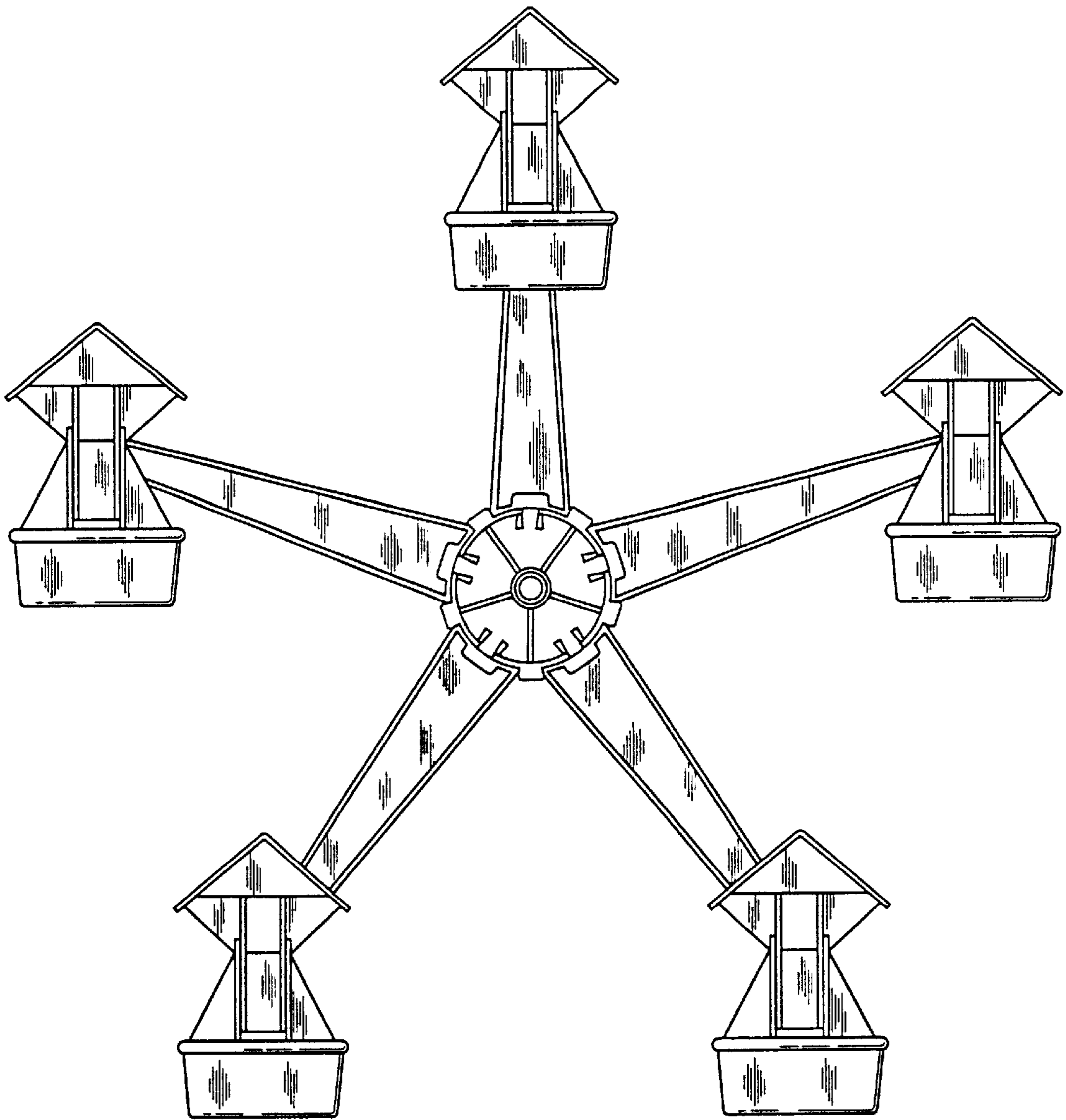

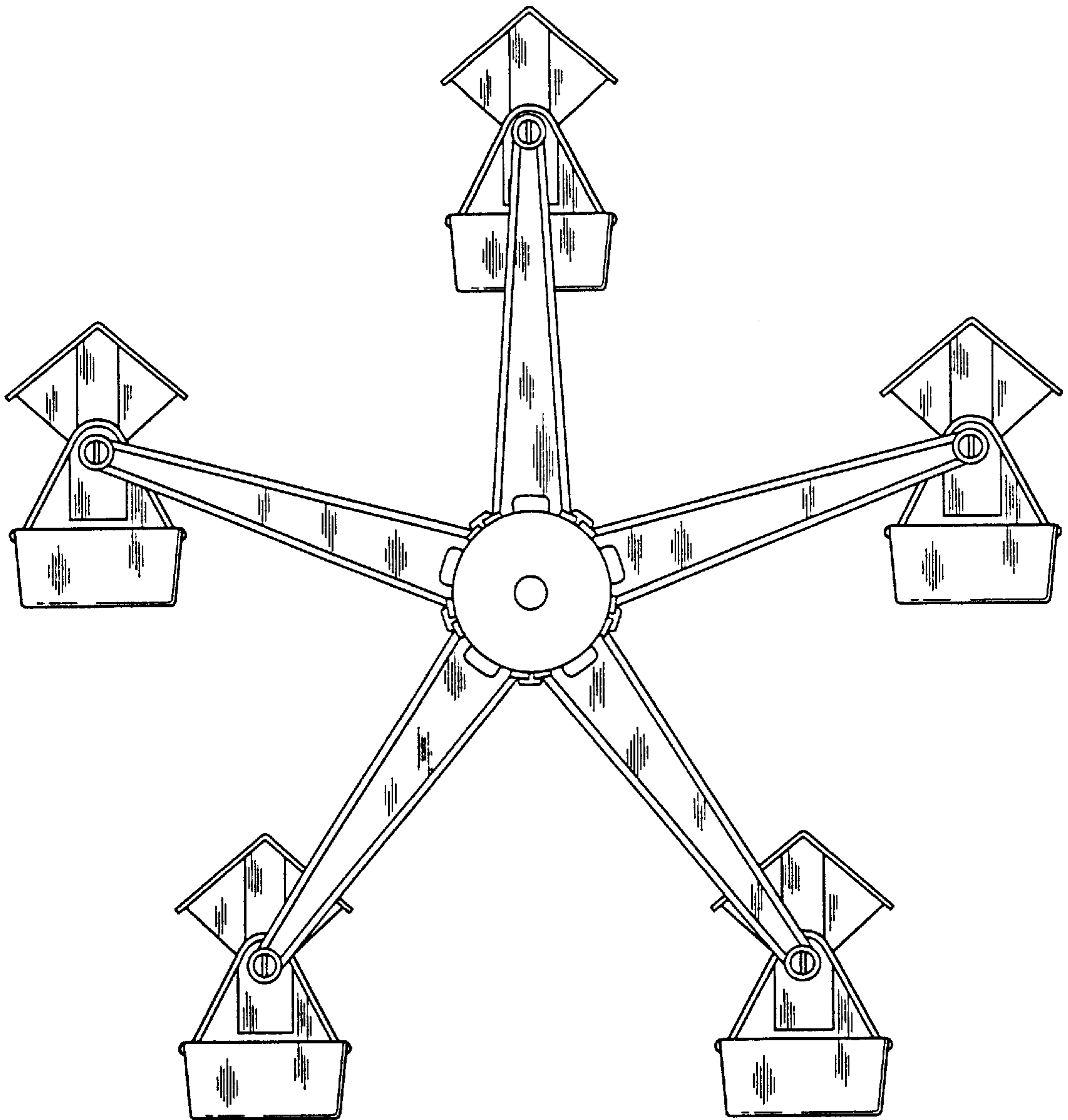

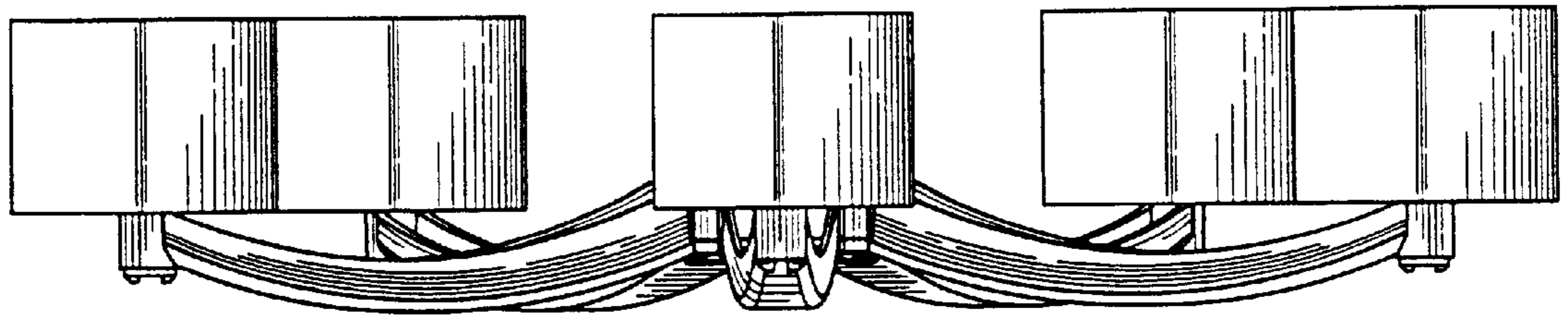

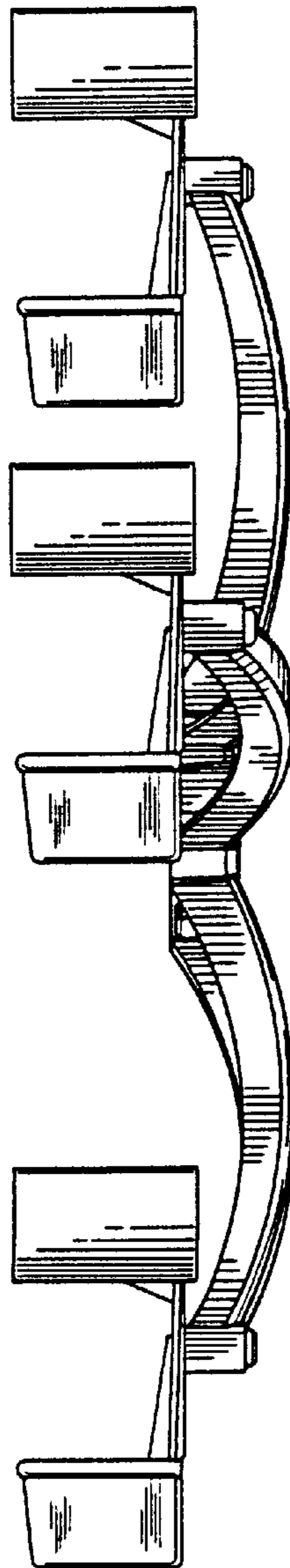

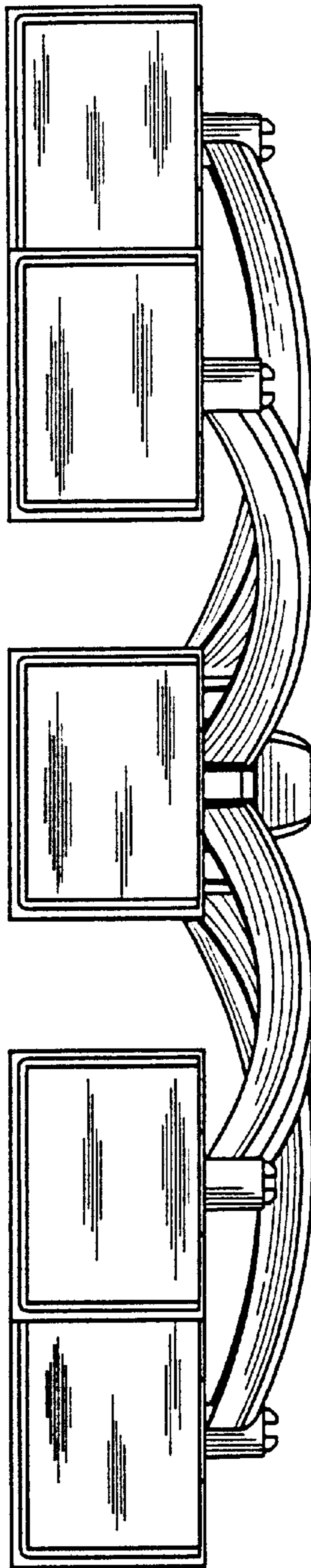

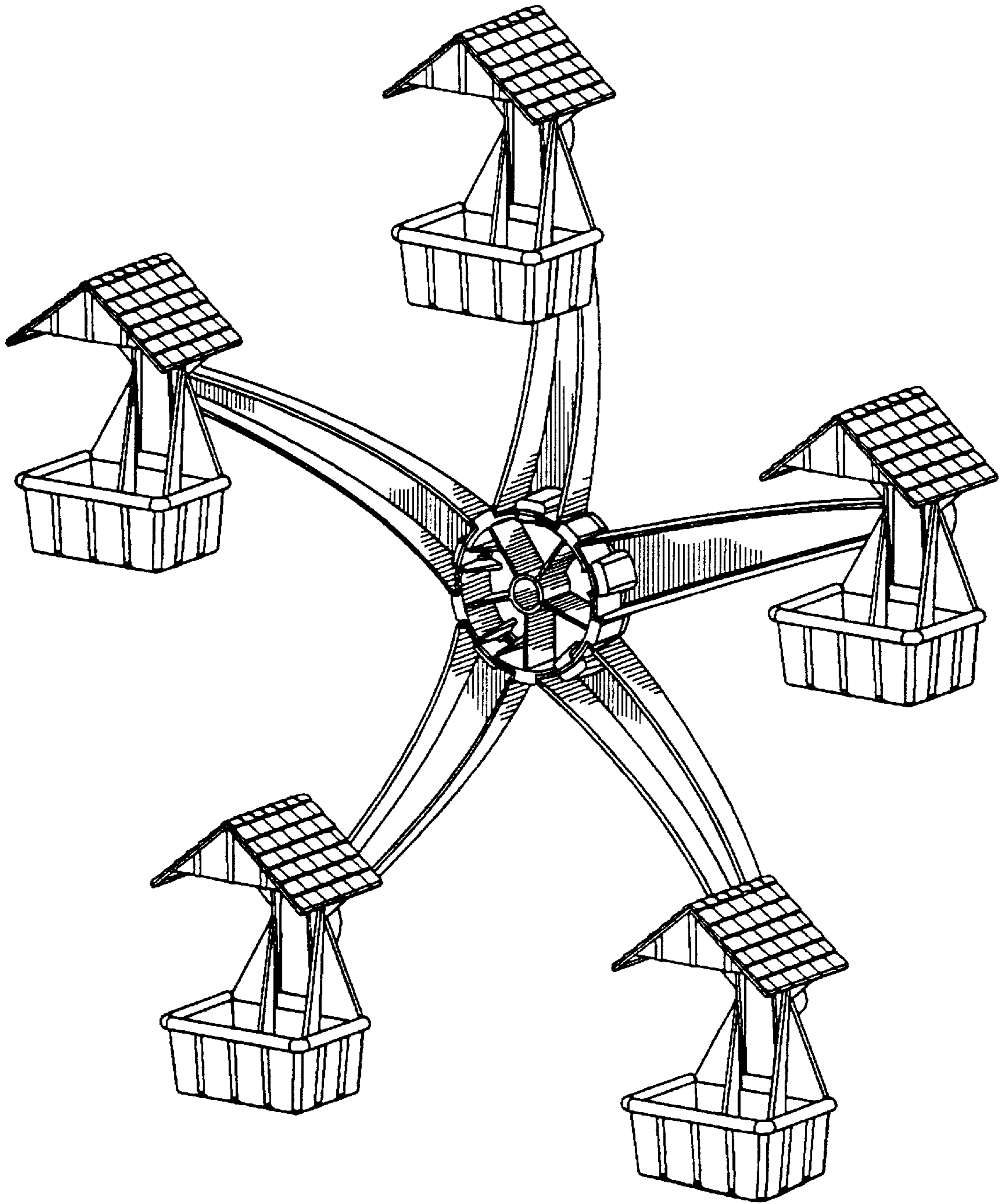

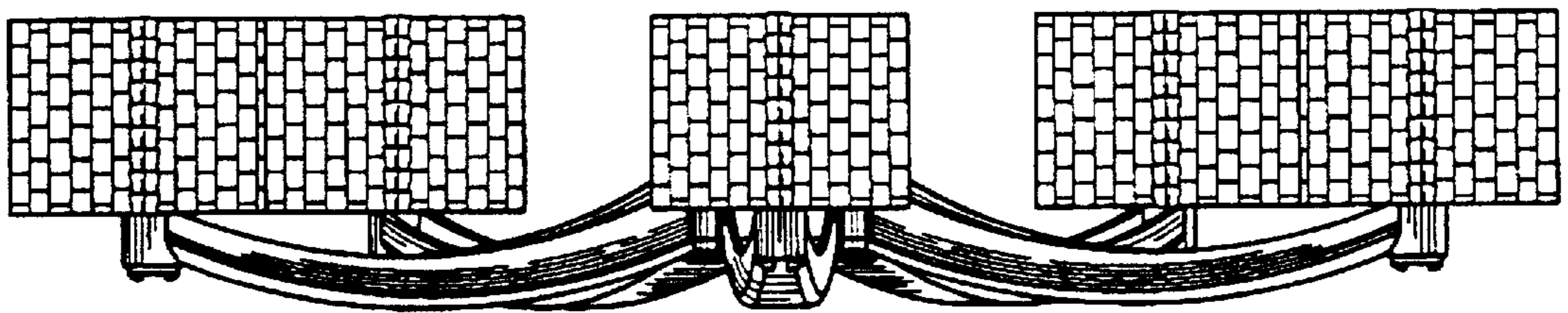
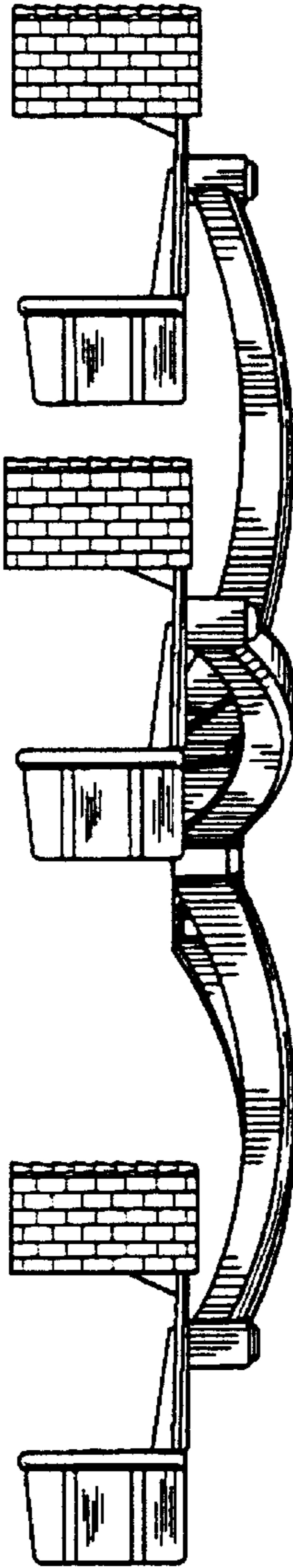

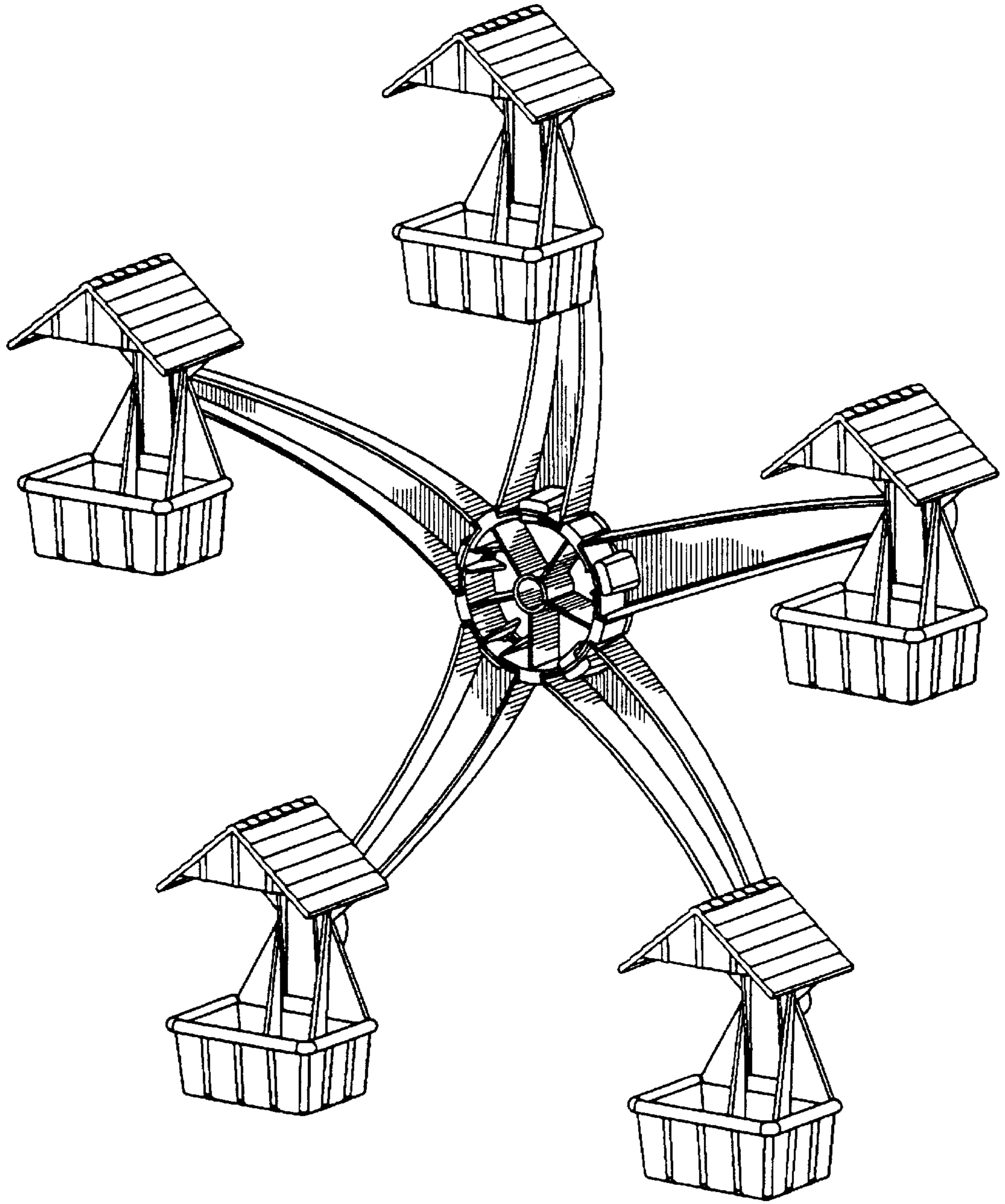

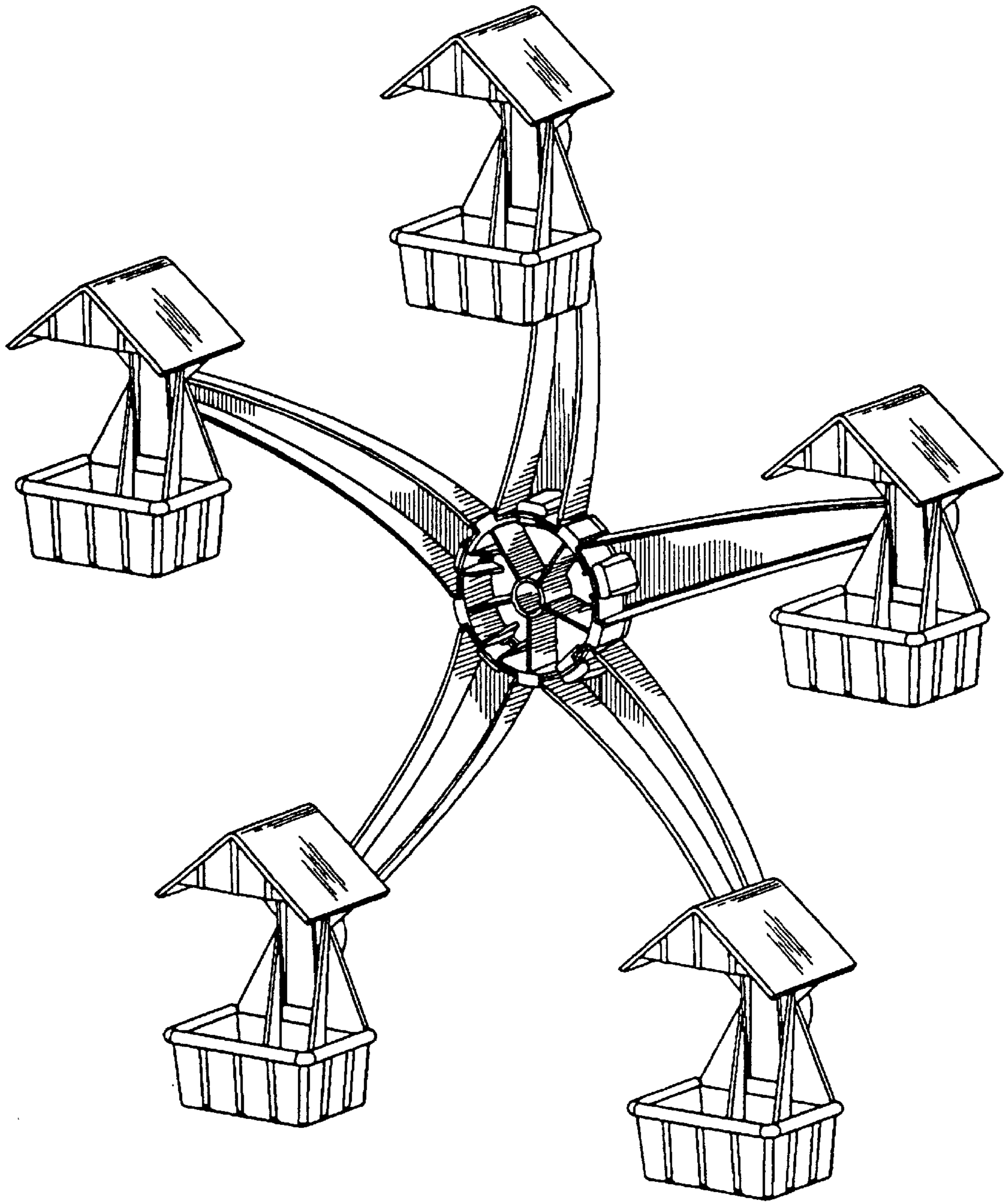
