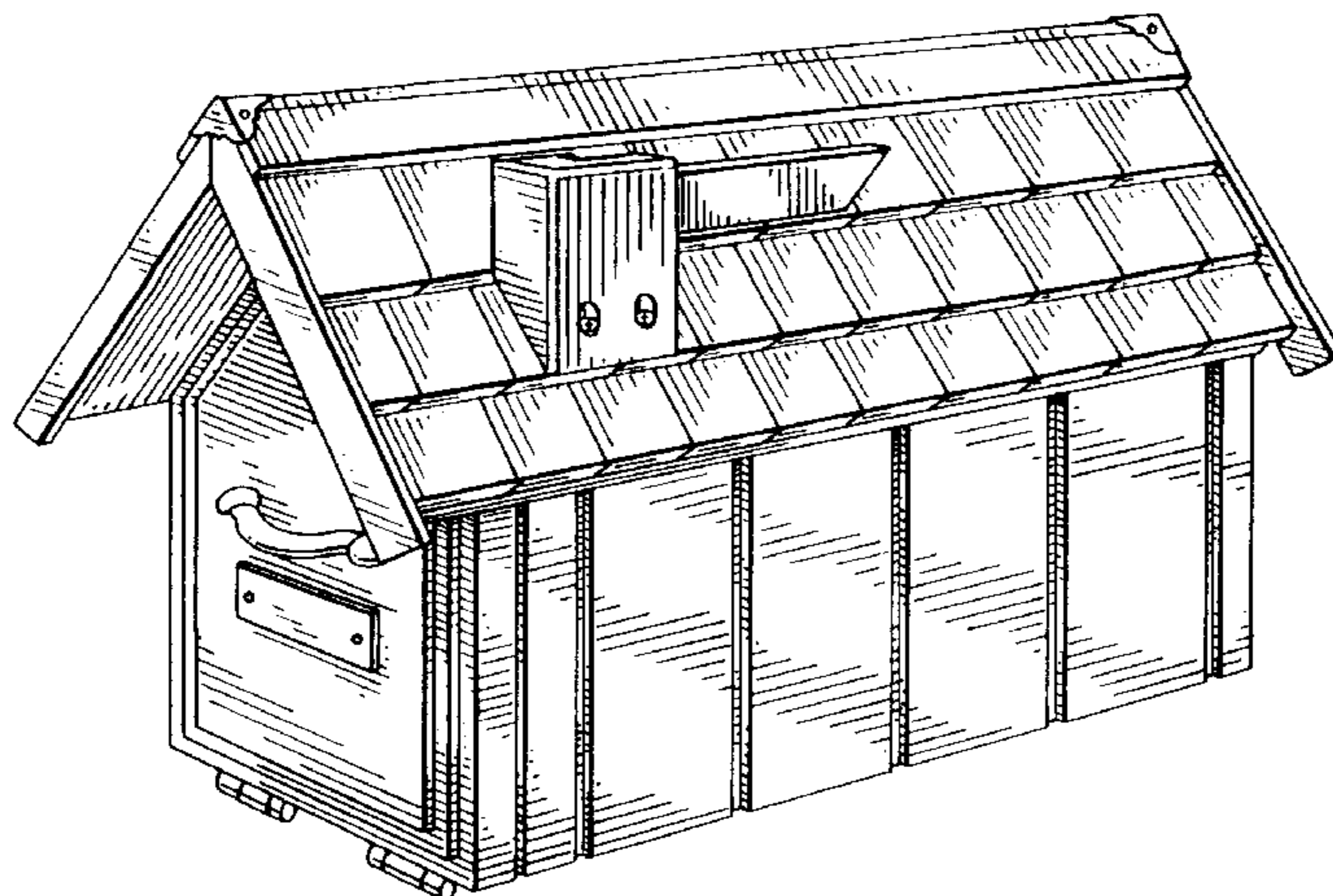
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a mailbox;
FIG. 2 is a top plan view thereof;

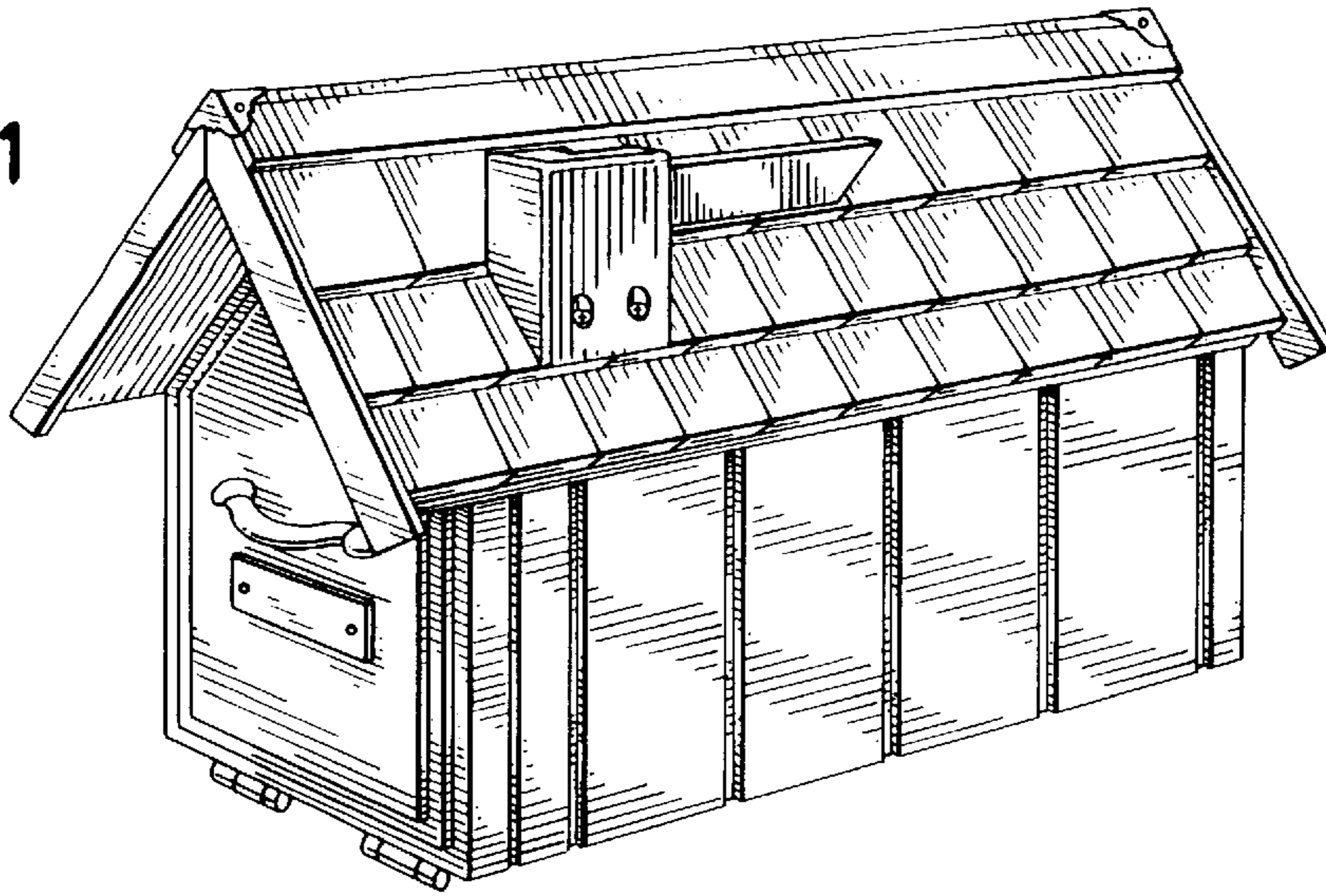

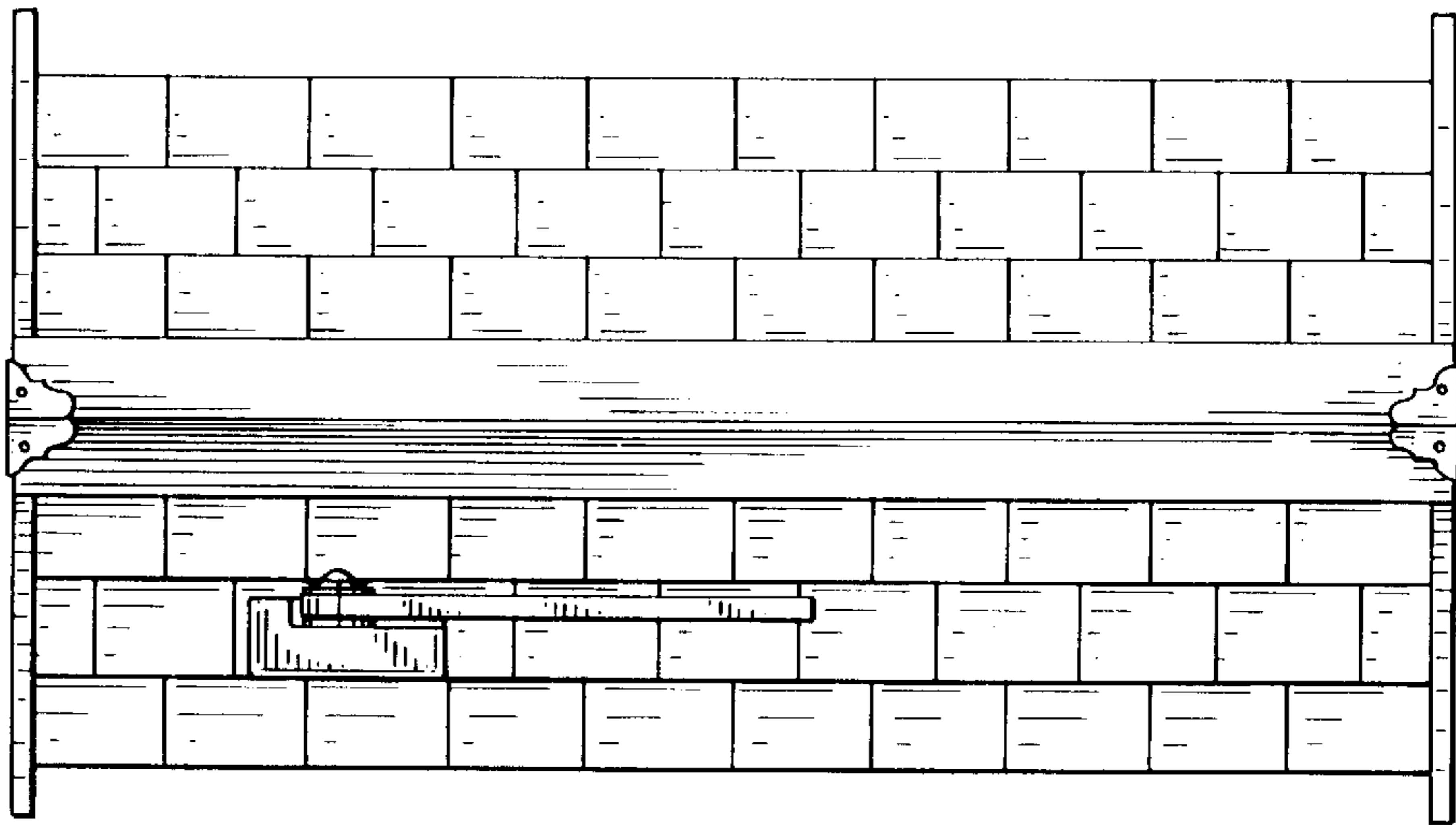

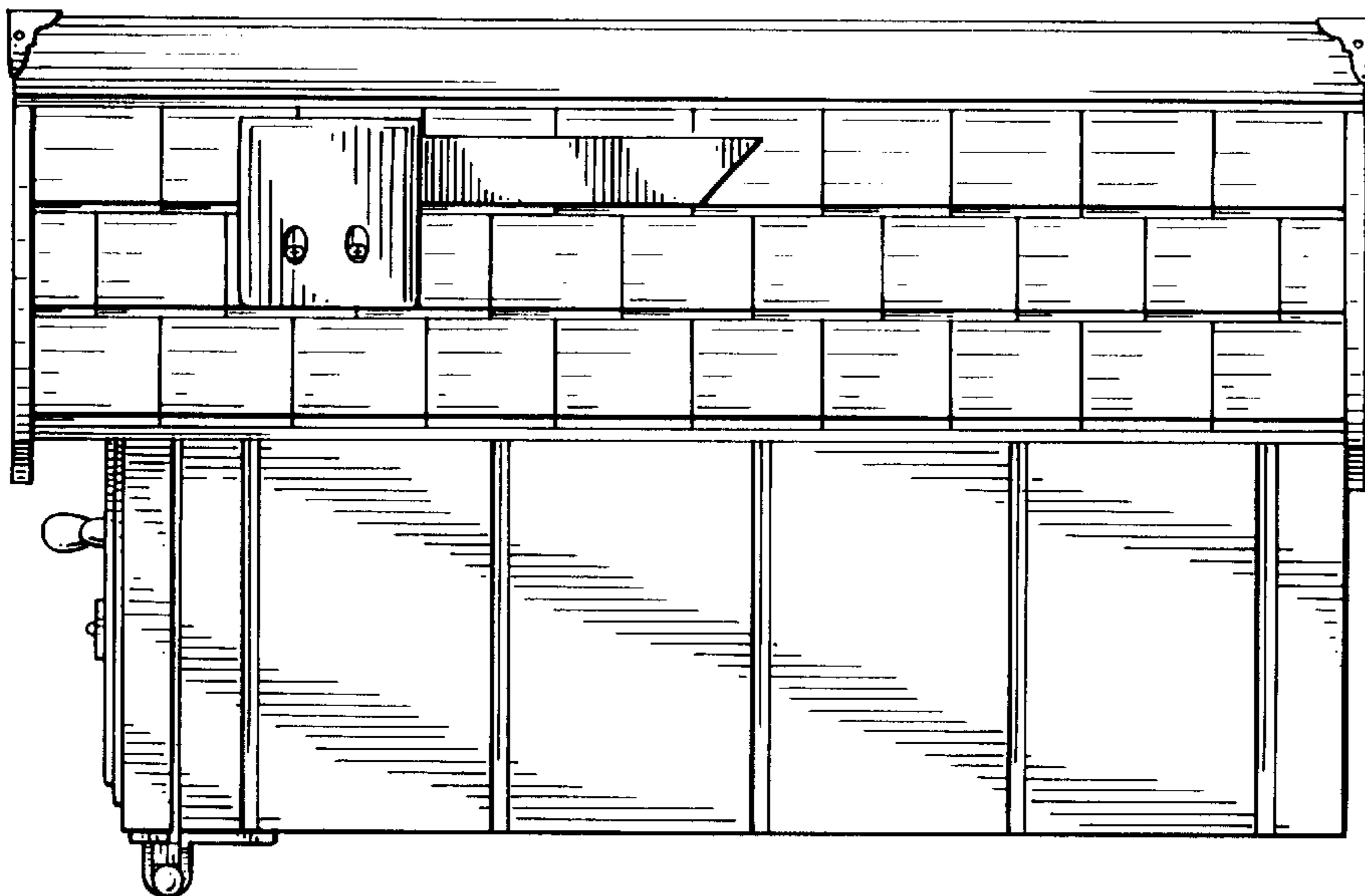

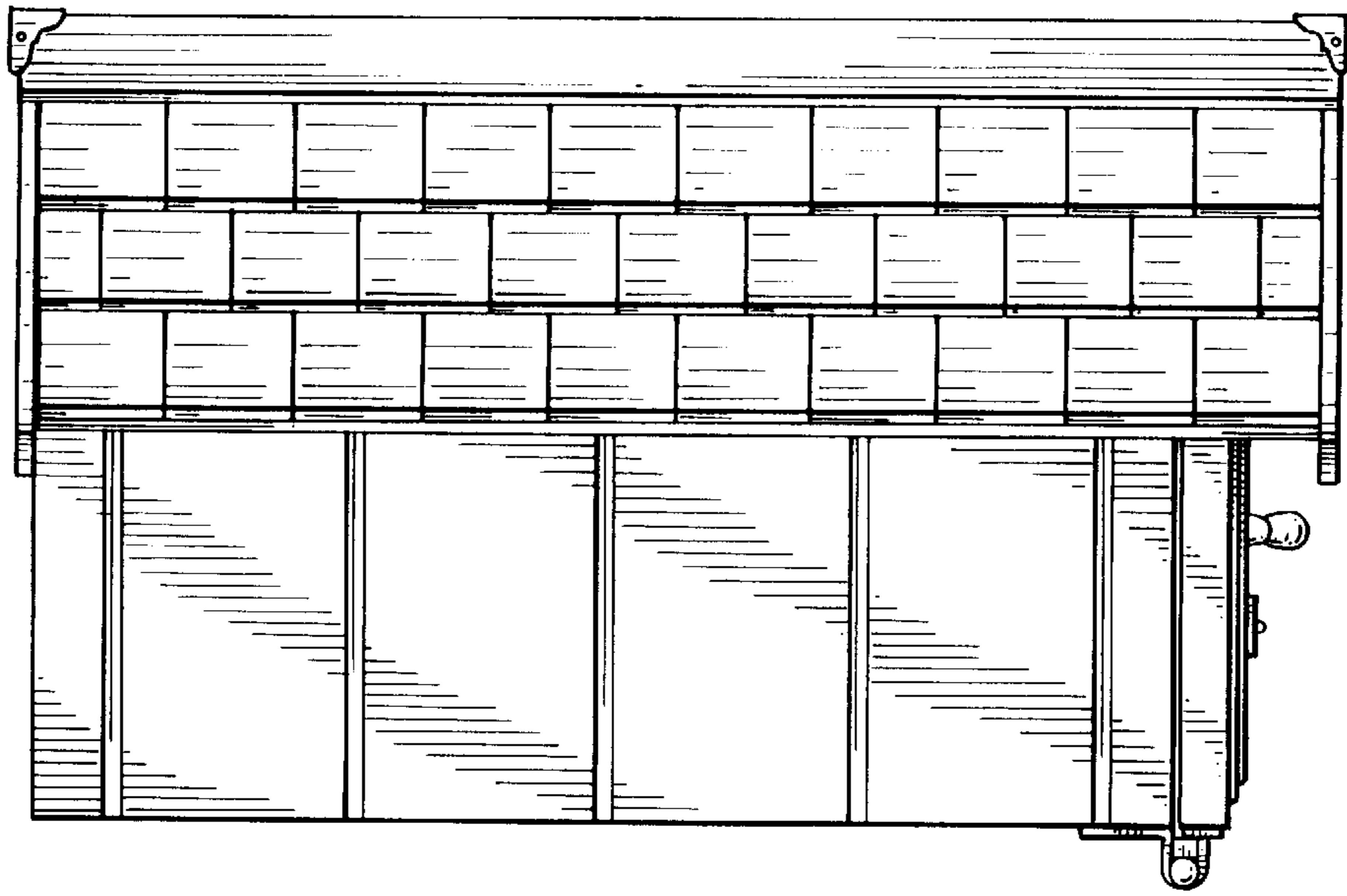

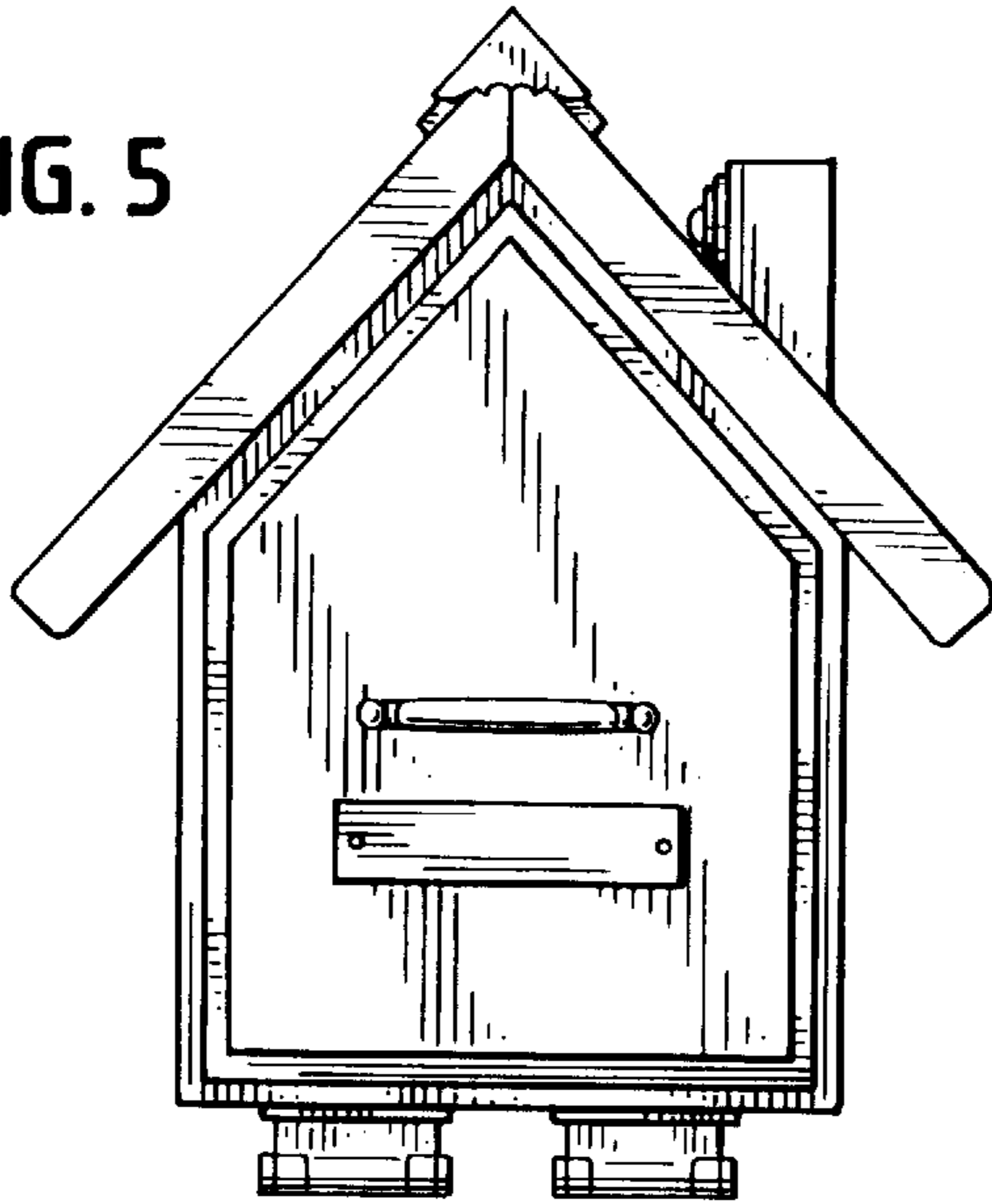

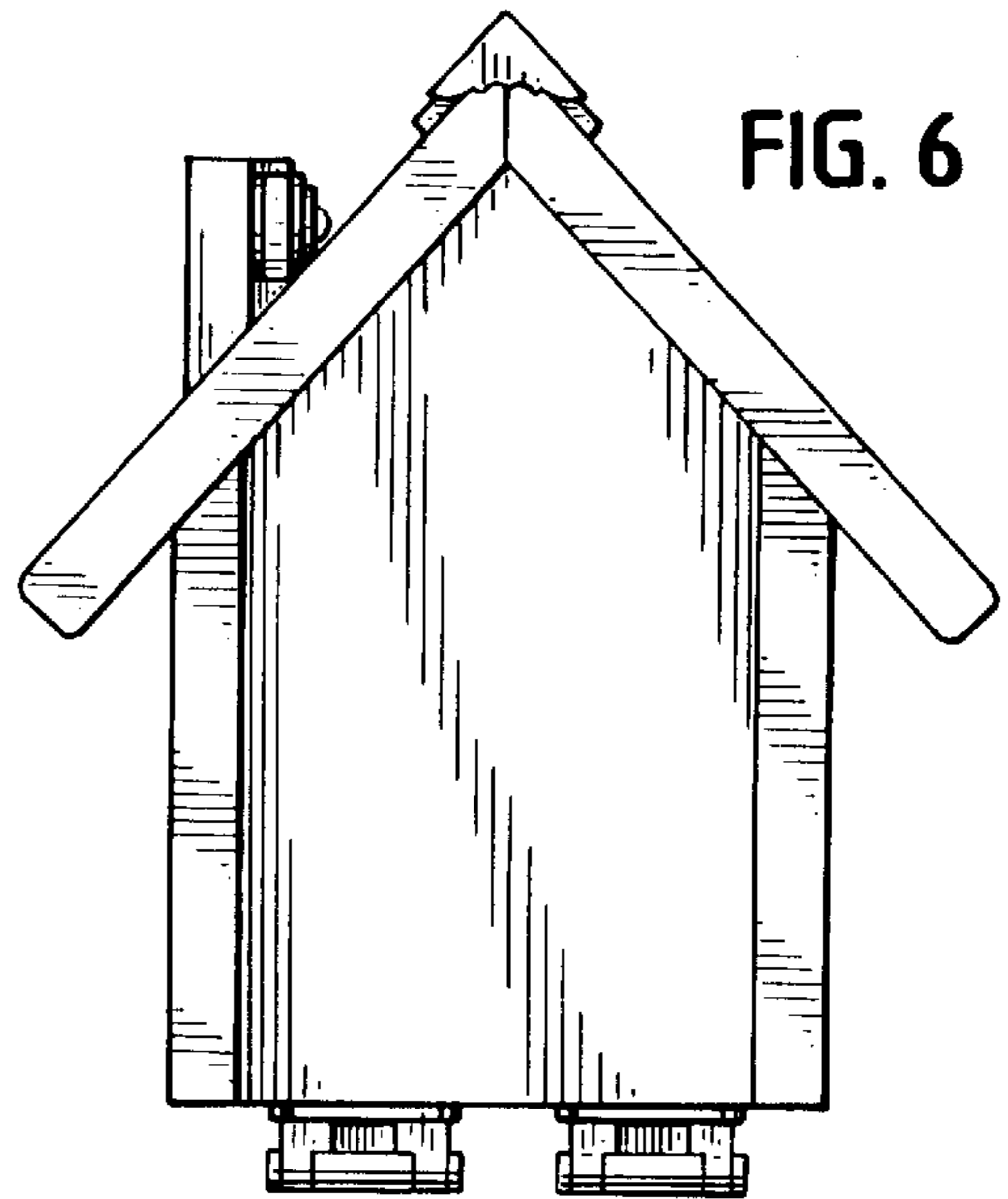
