[57] **CLAIM**

I claim the ornamental design for a headwear with decorative plume or mohawk, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of headwear with decora-

tive plume or mohawk showing my new design;

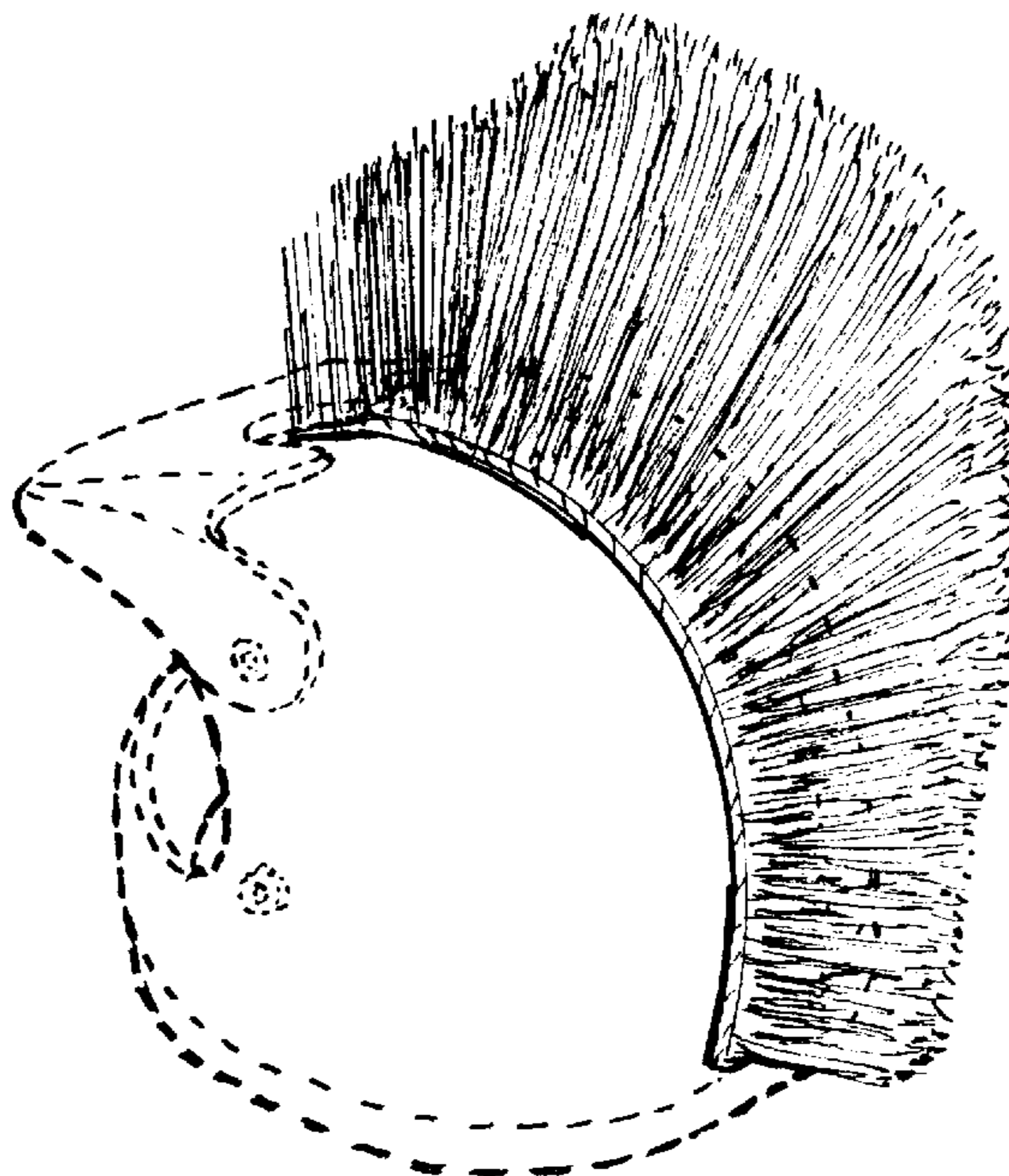

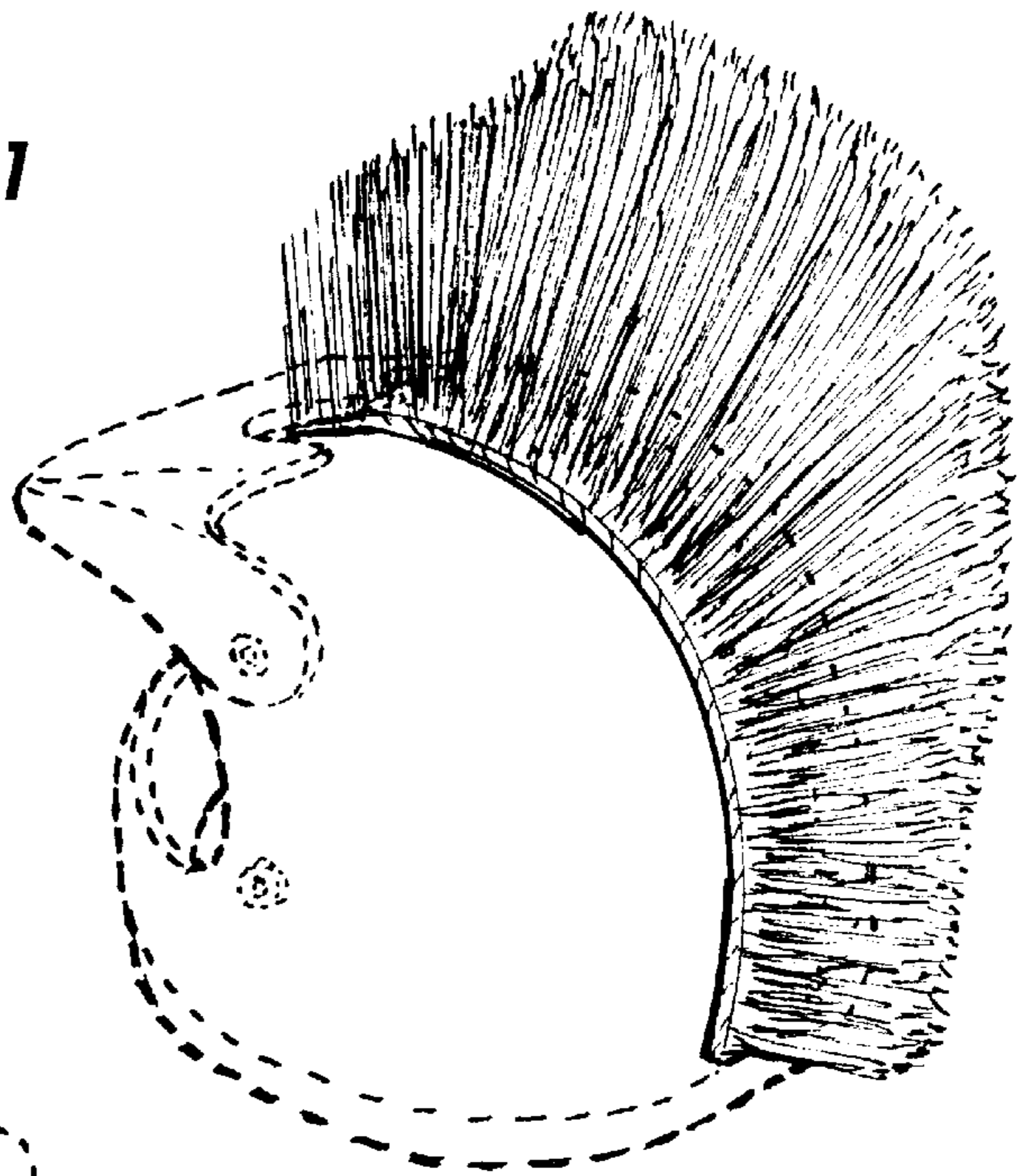

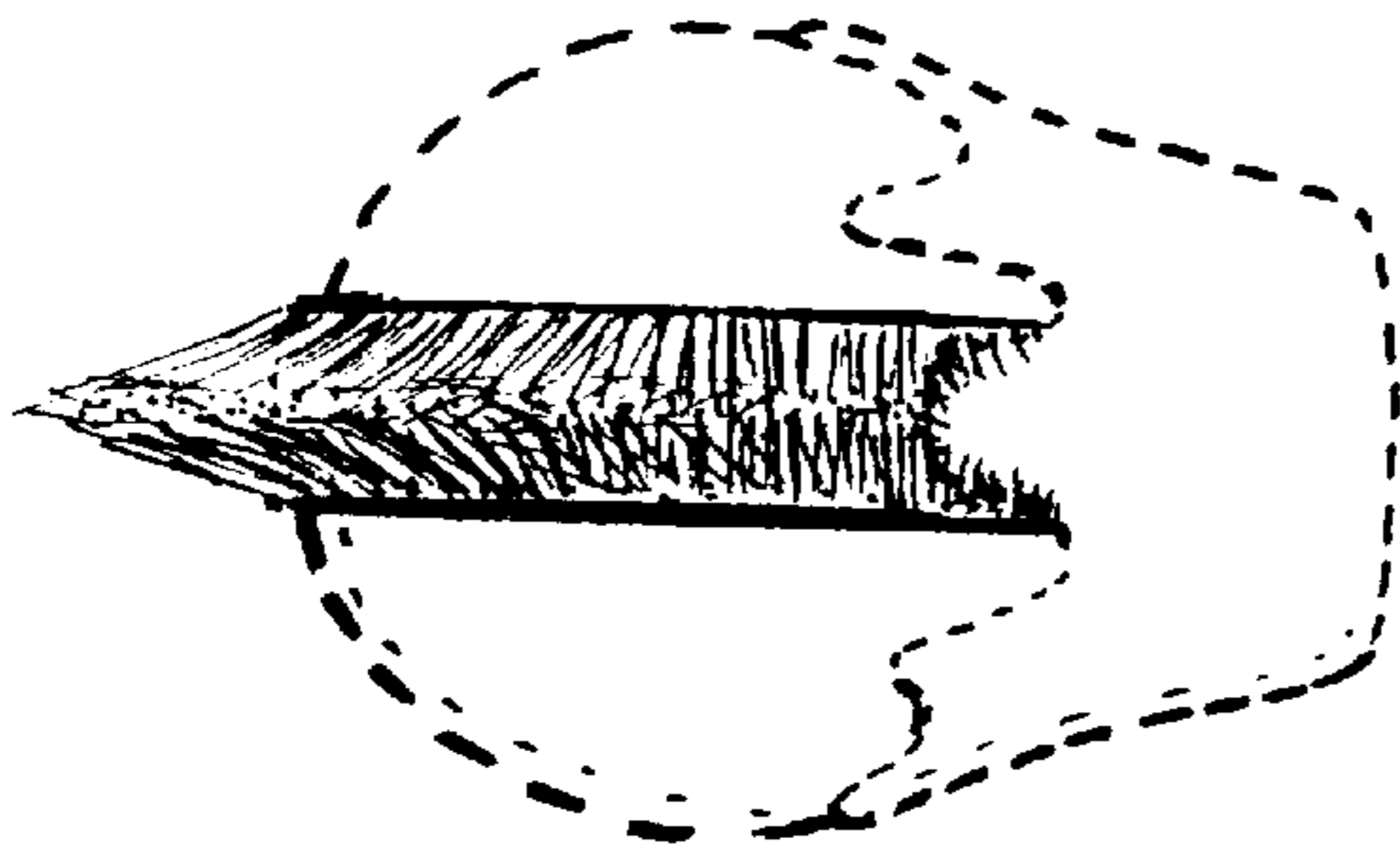

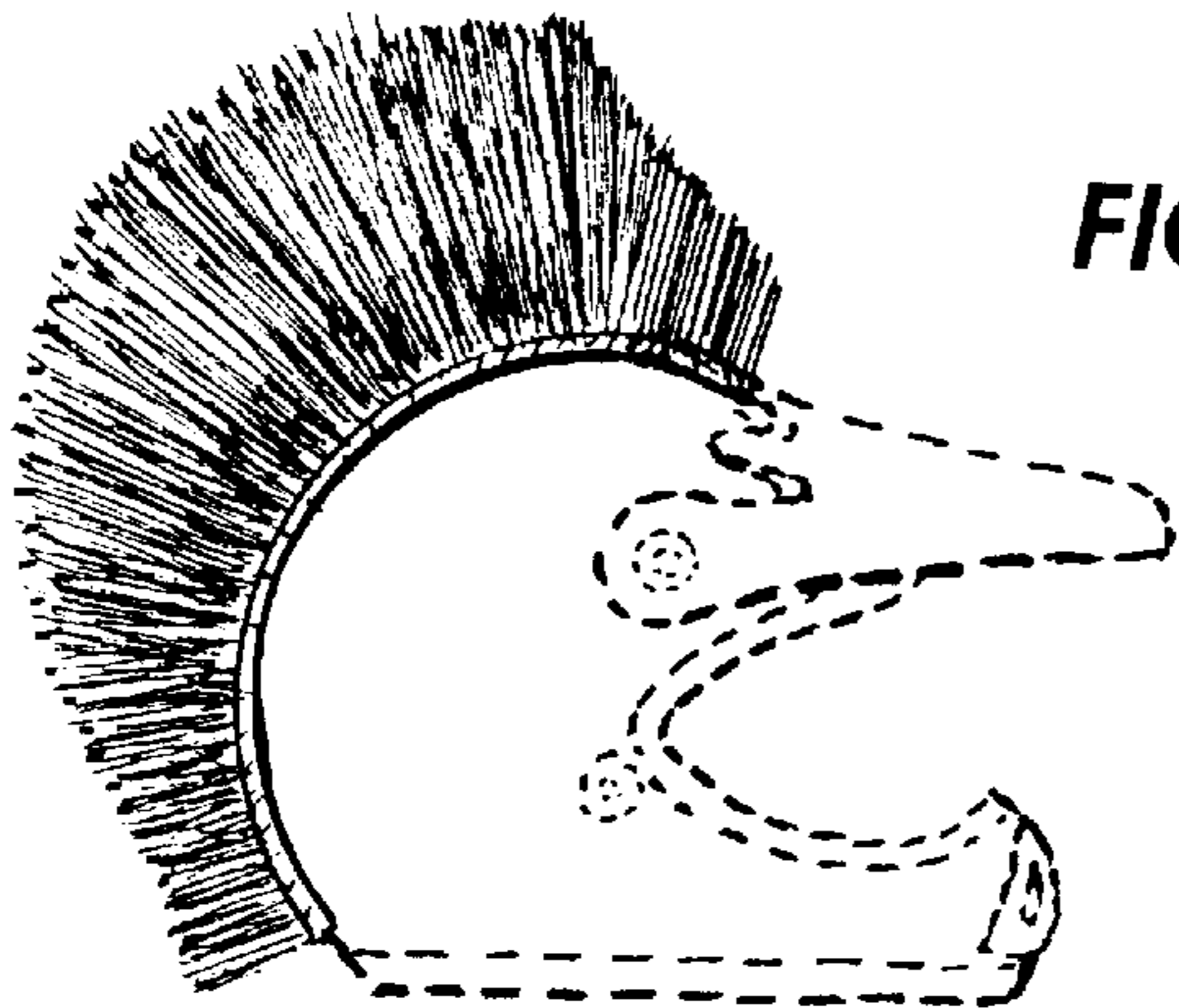

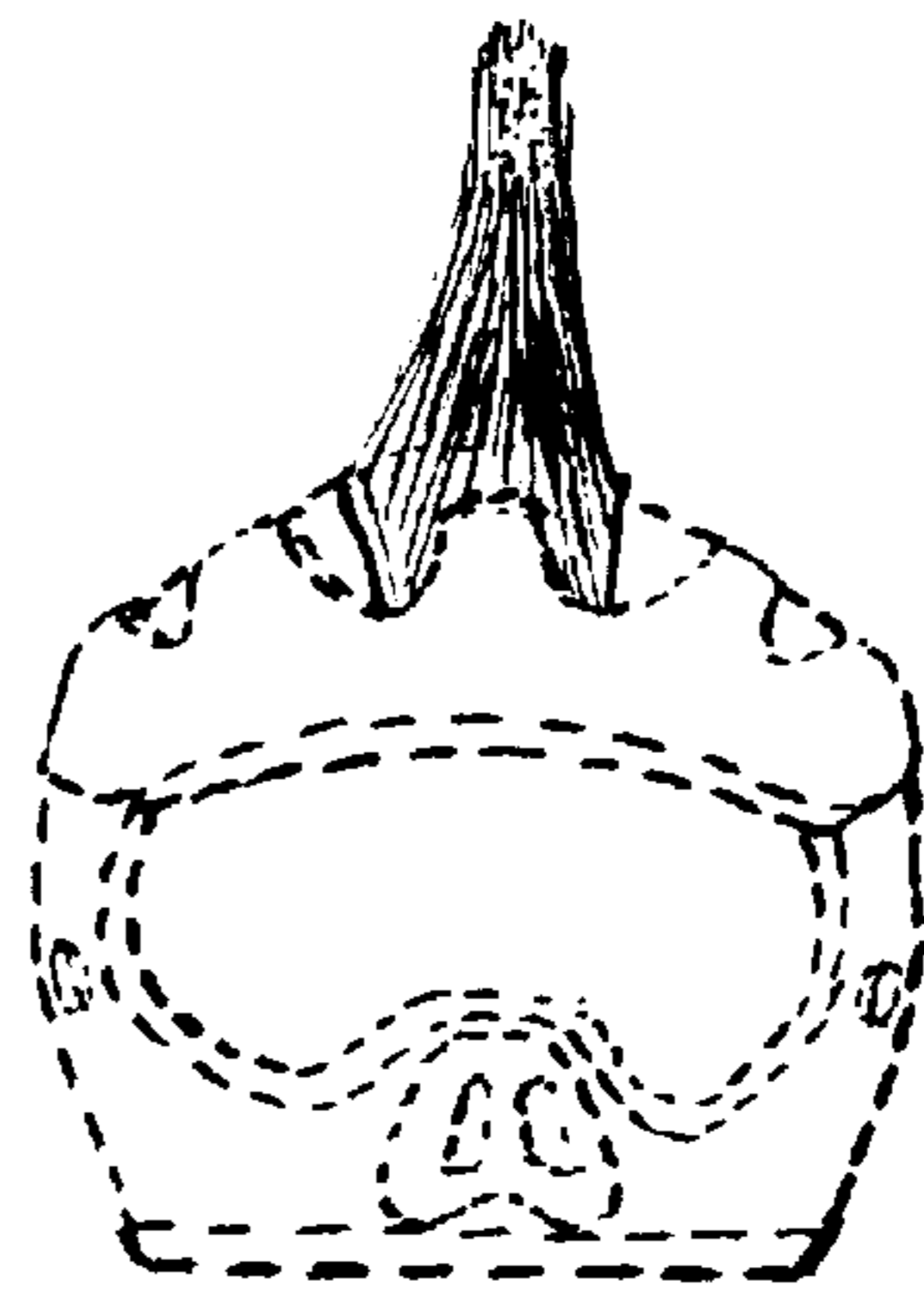

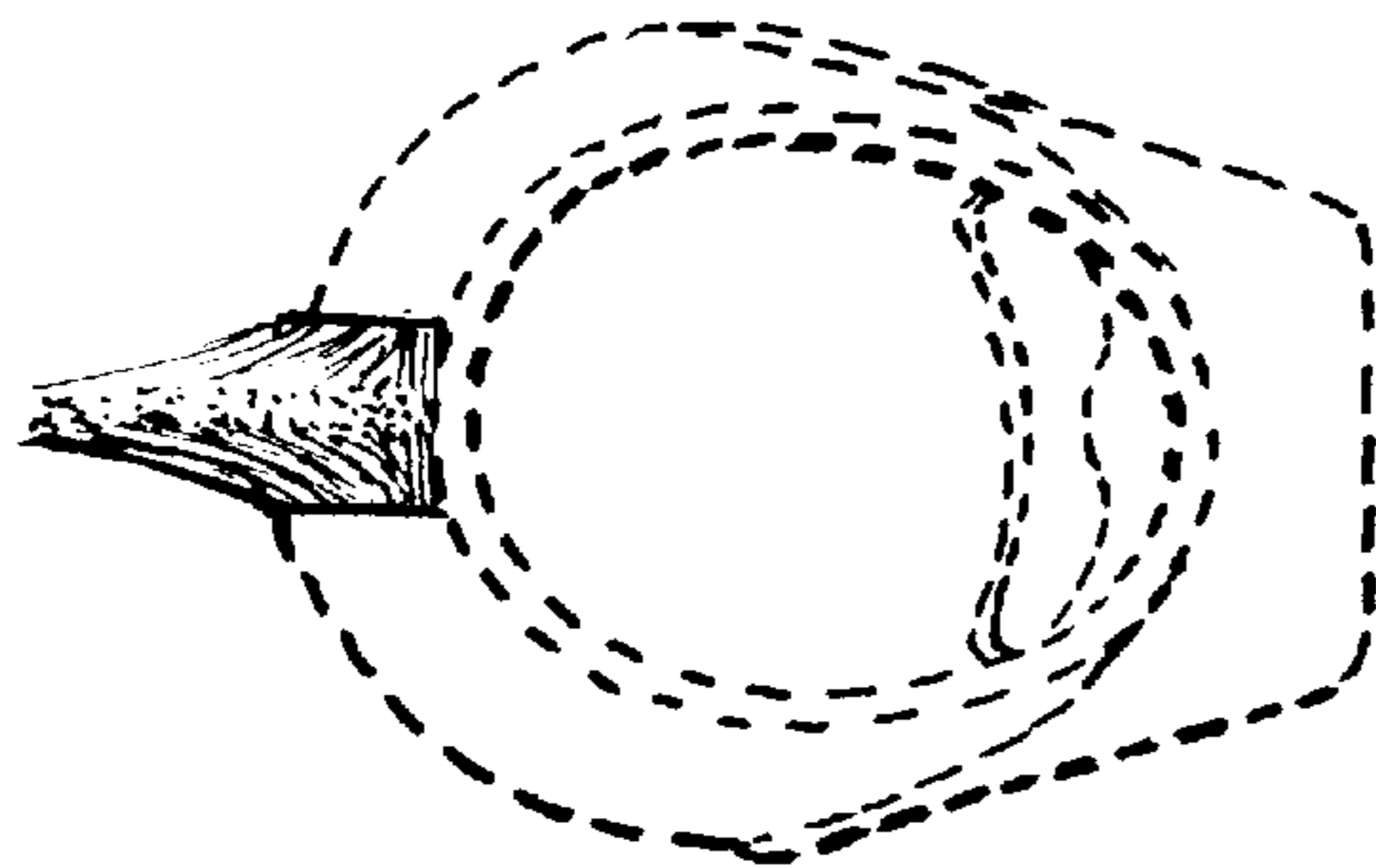

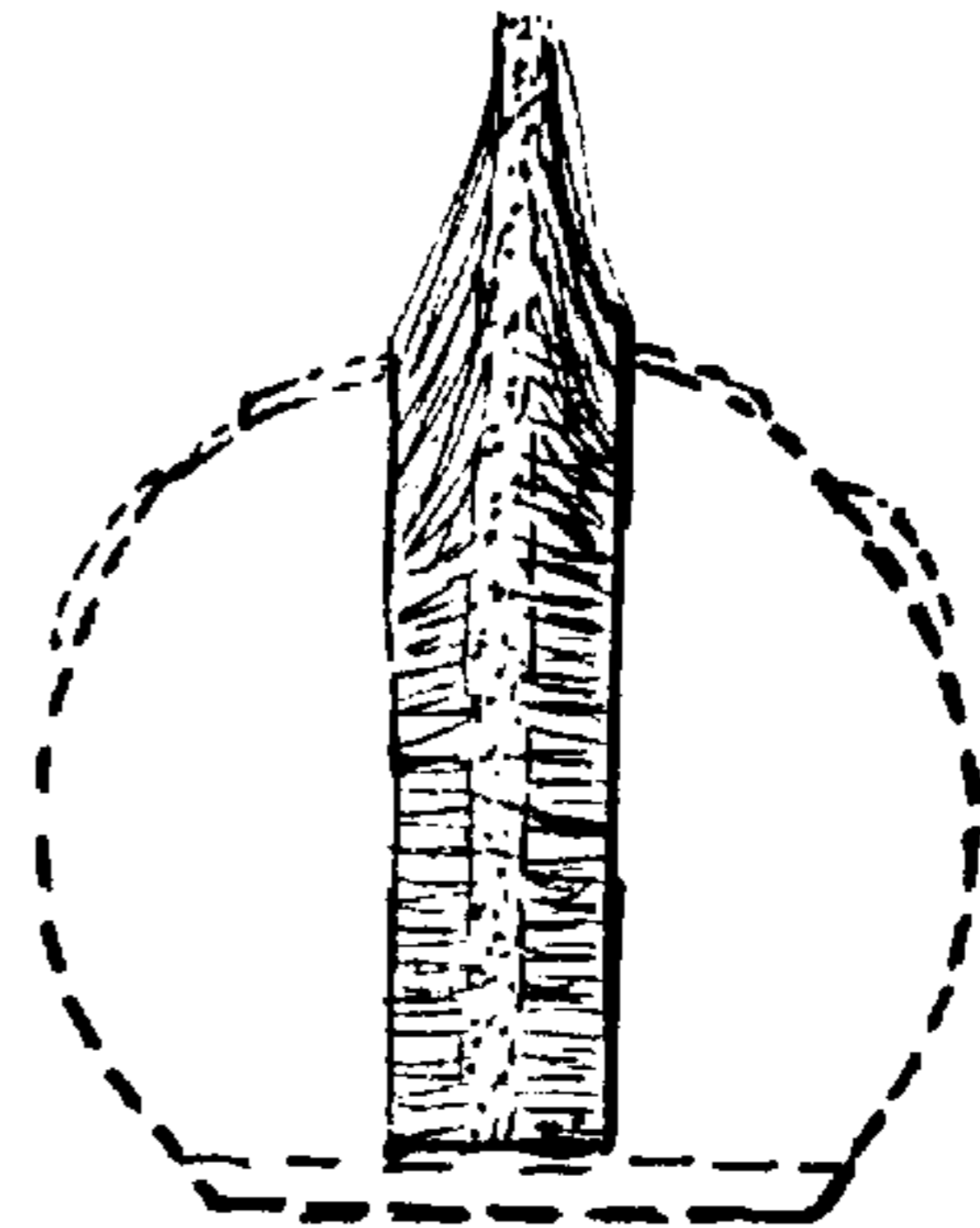

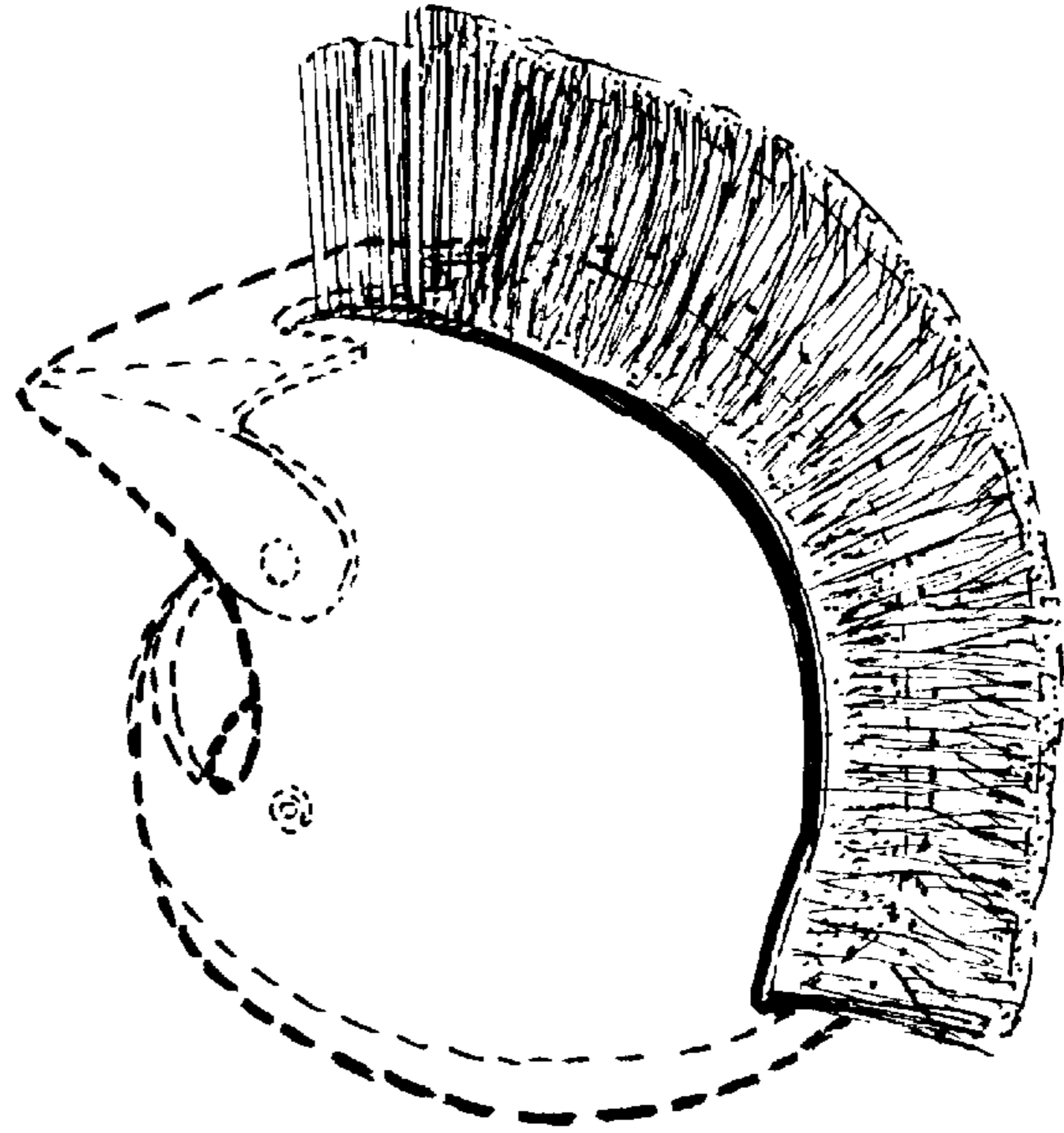

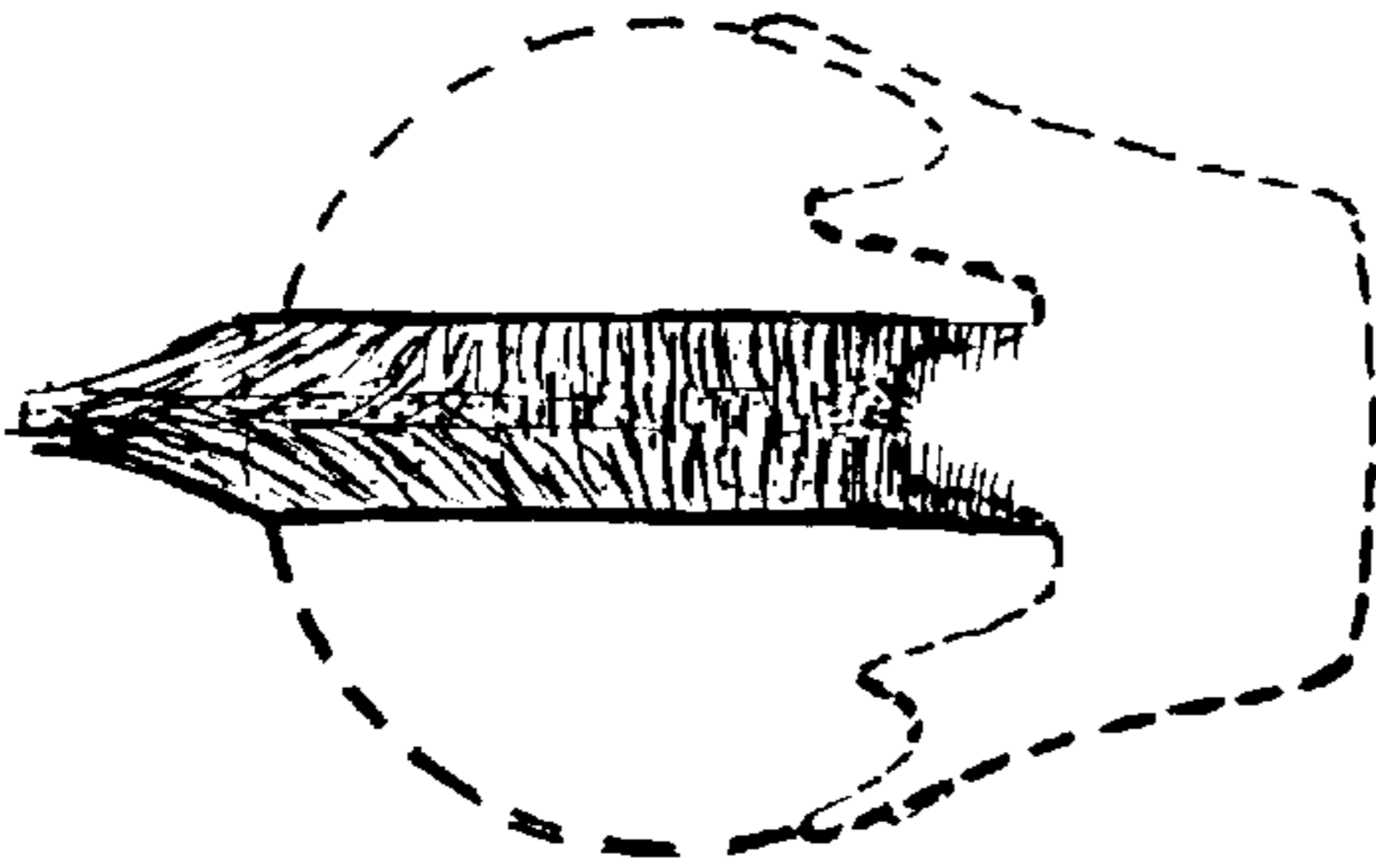

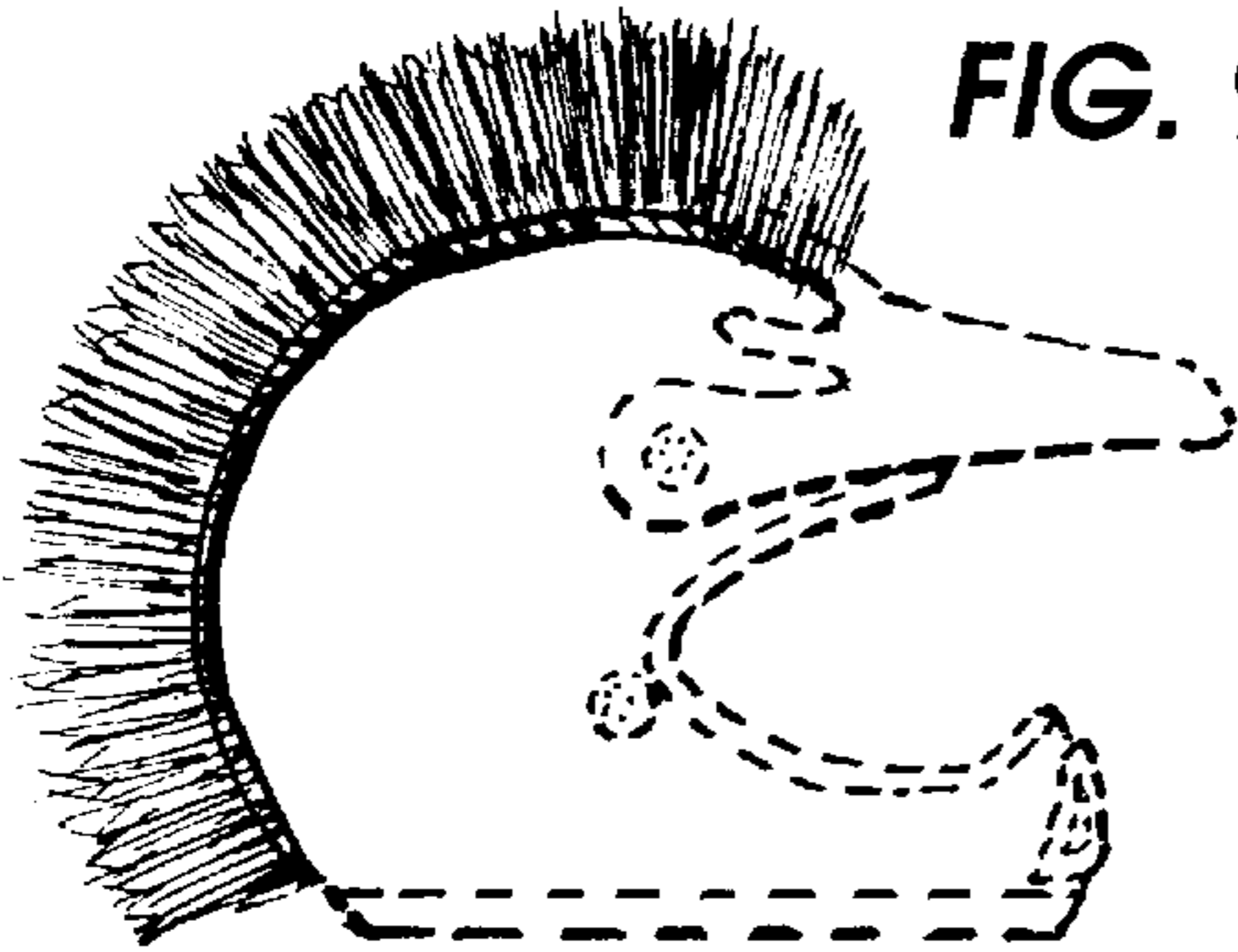

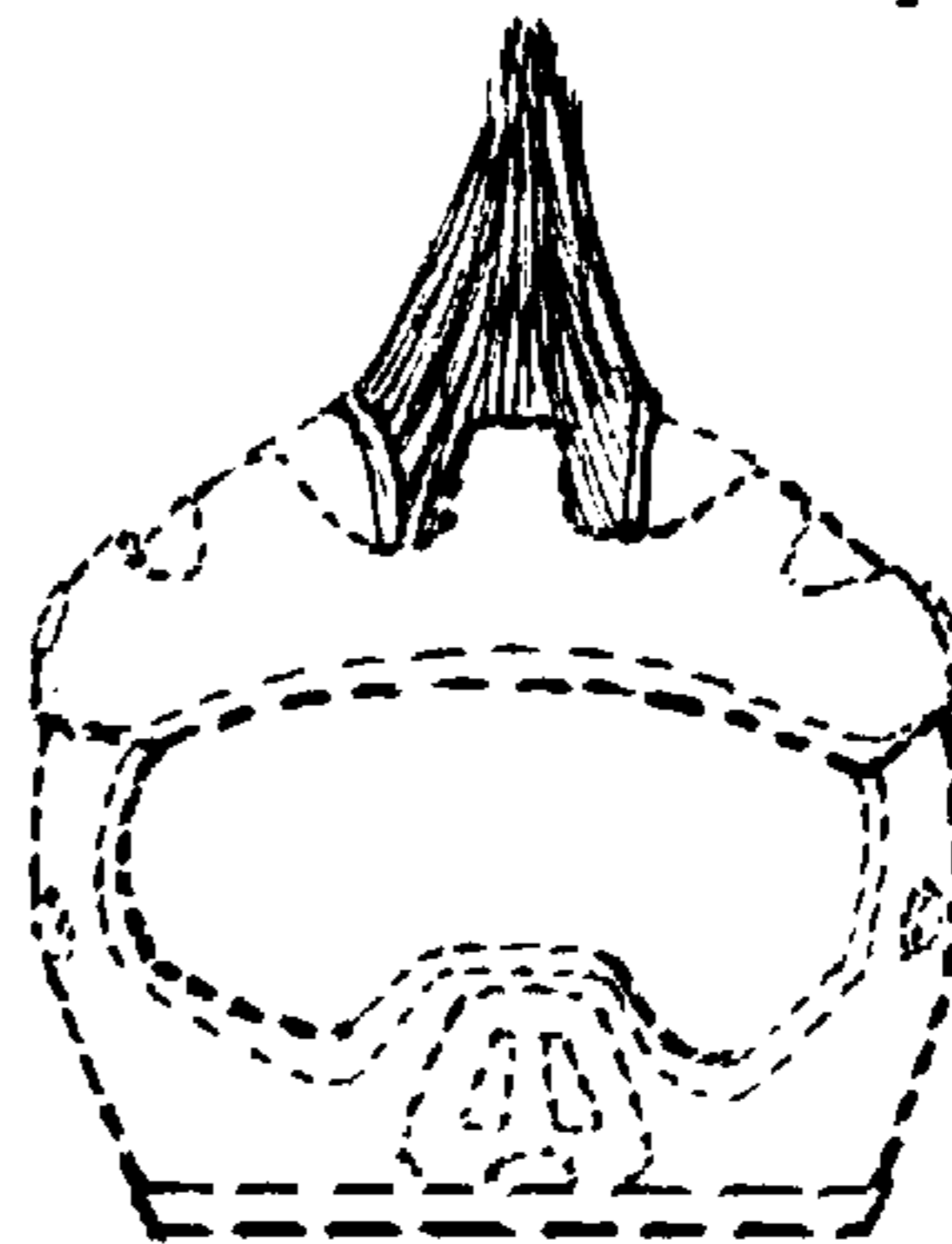

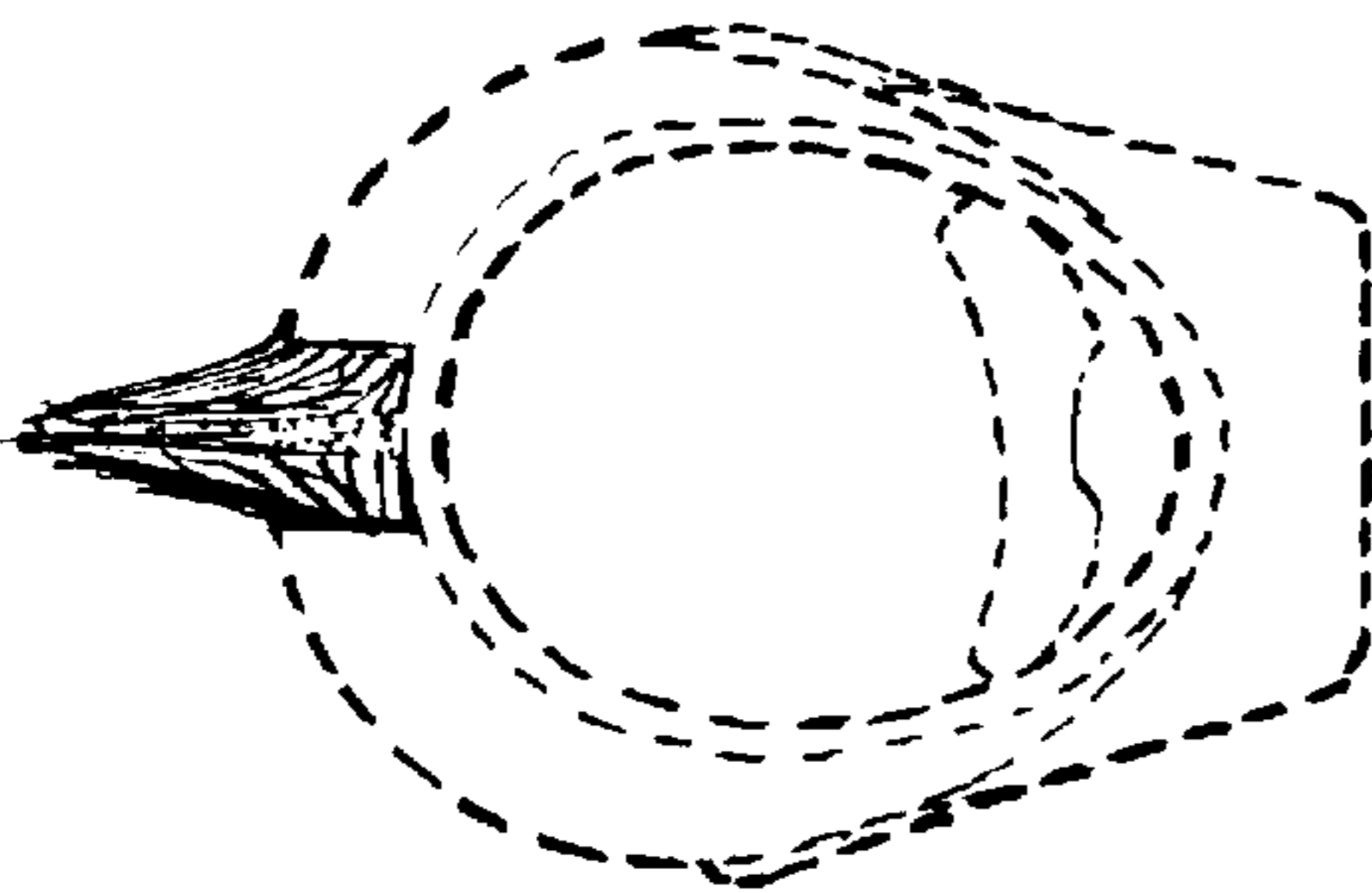

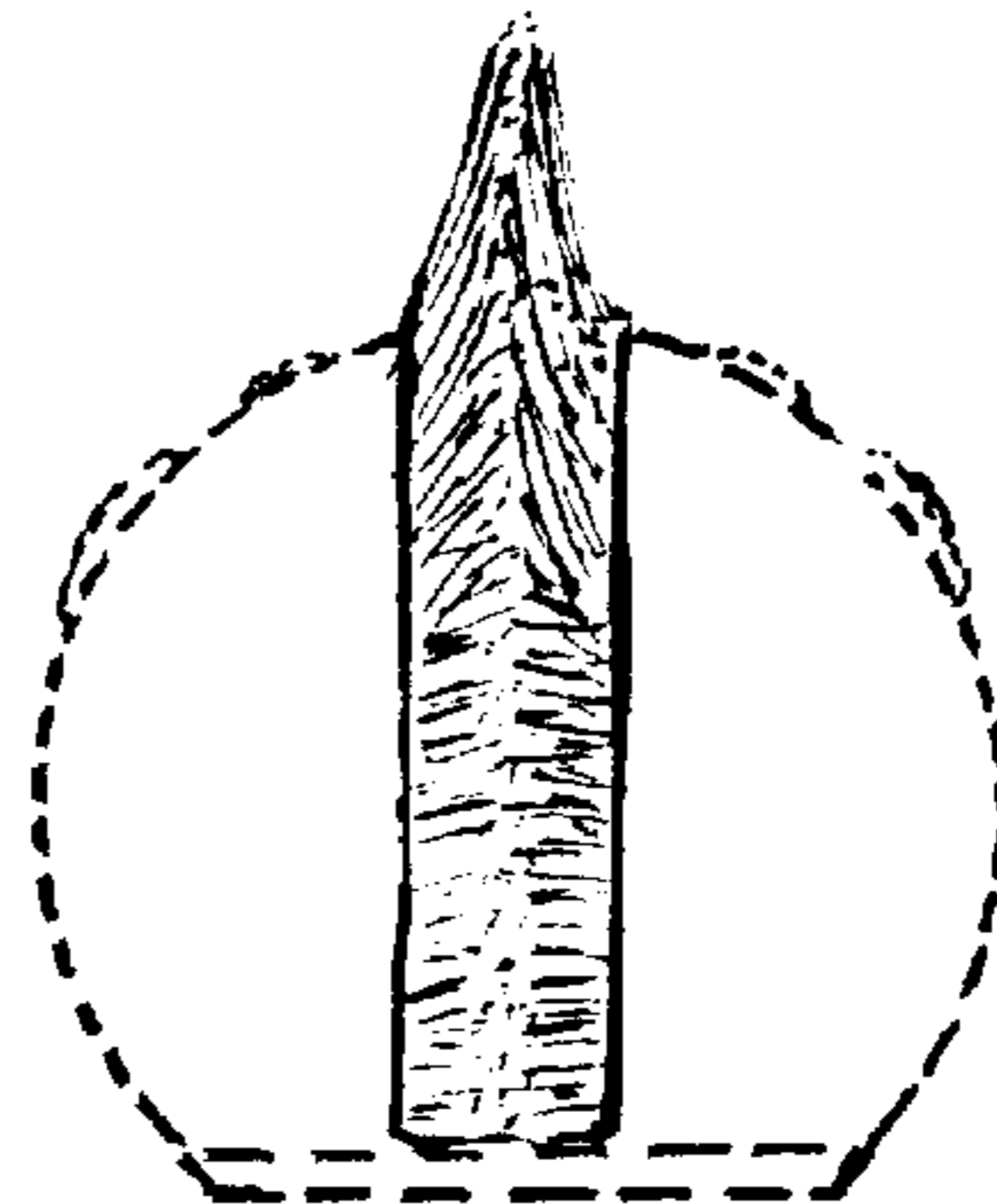

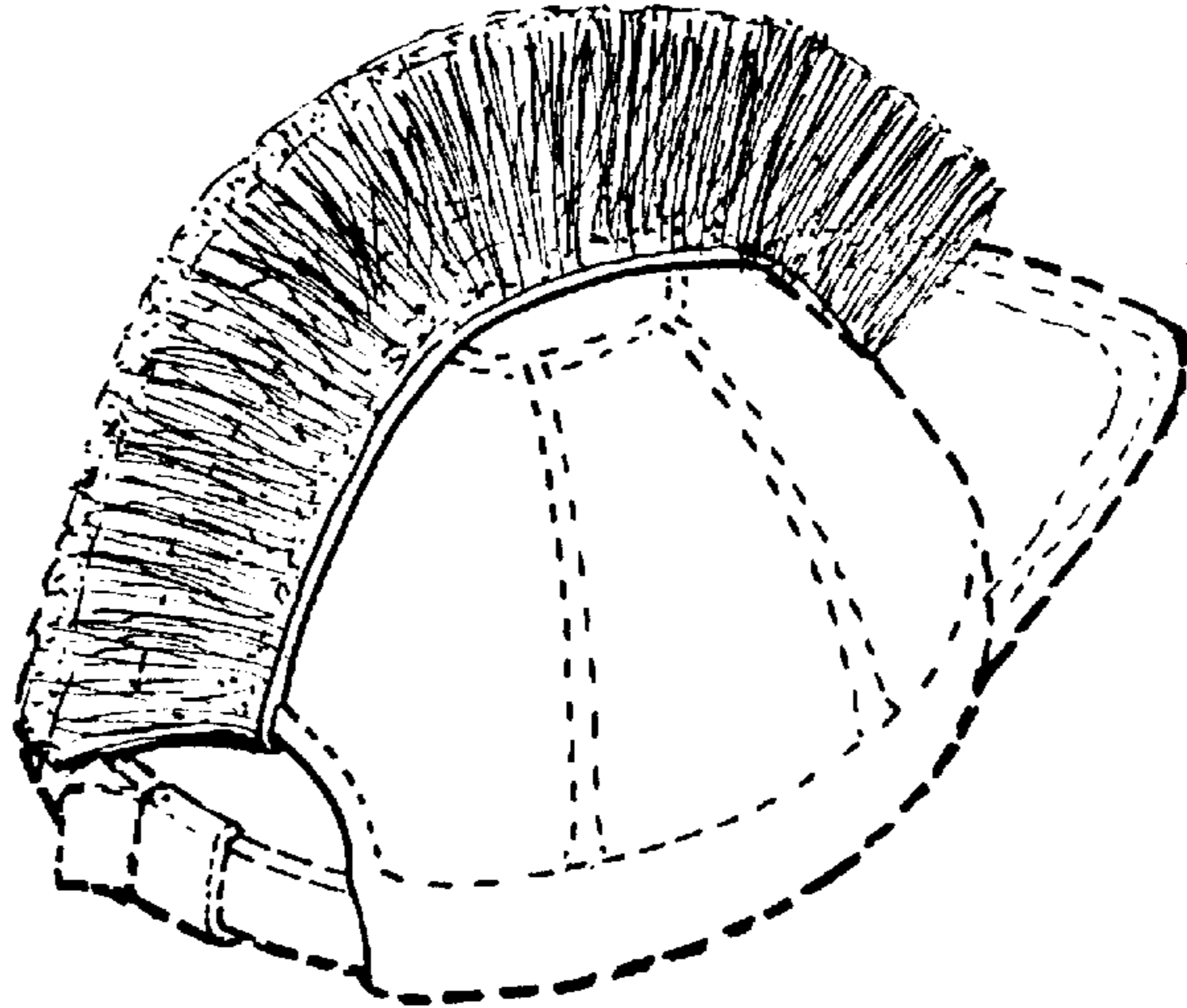

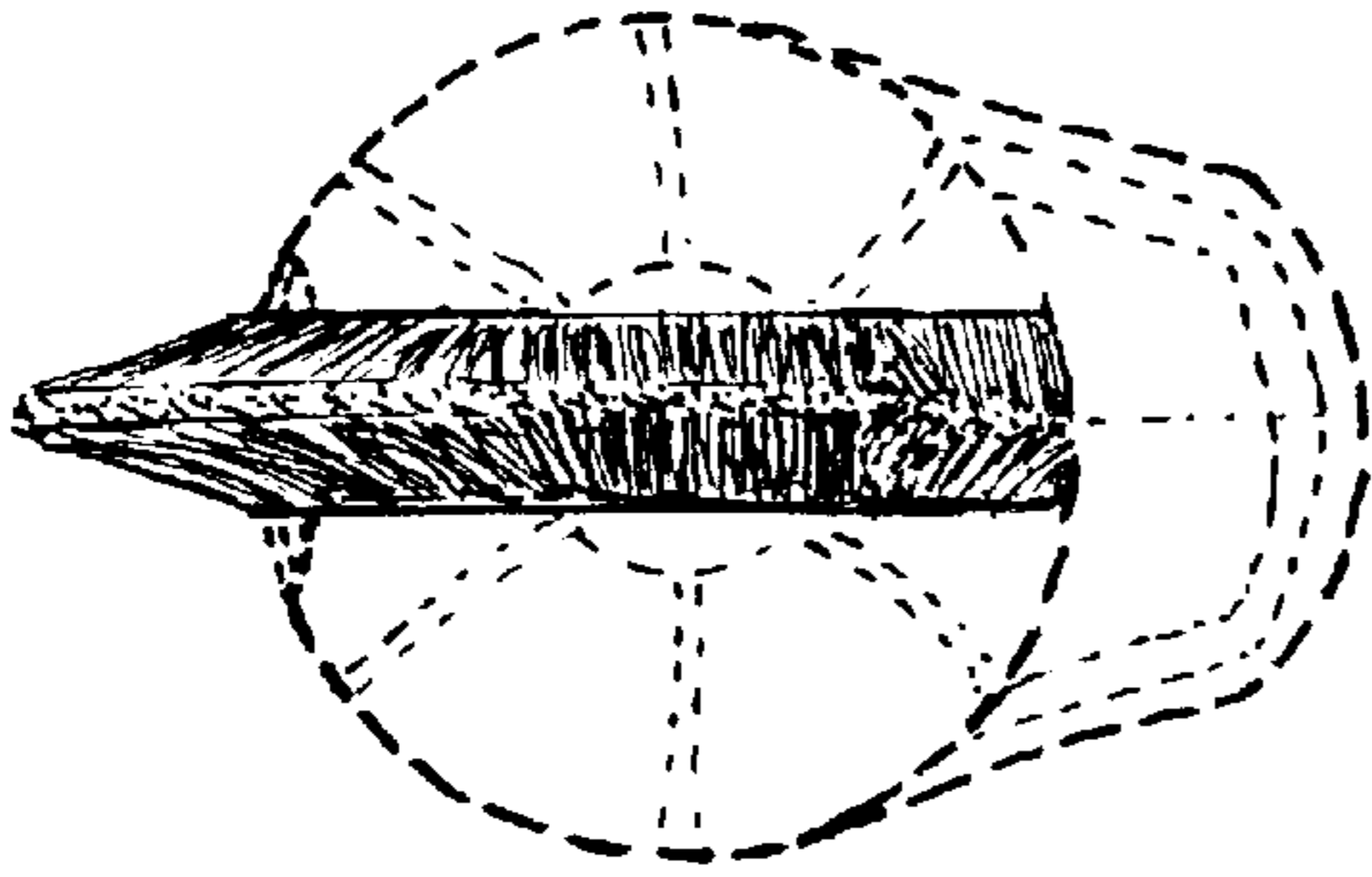

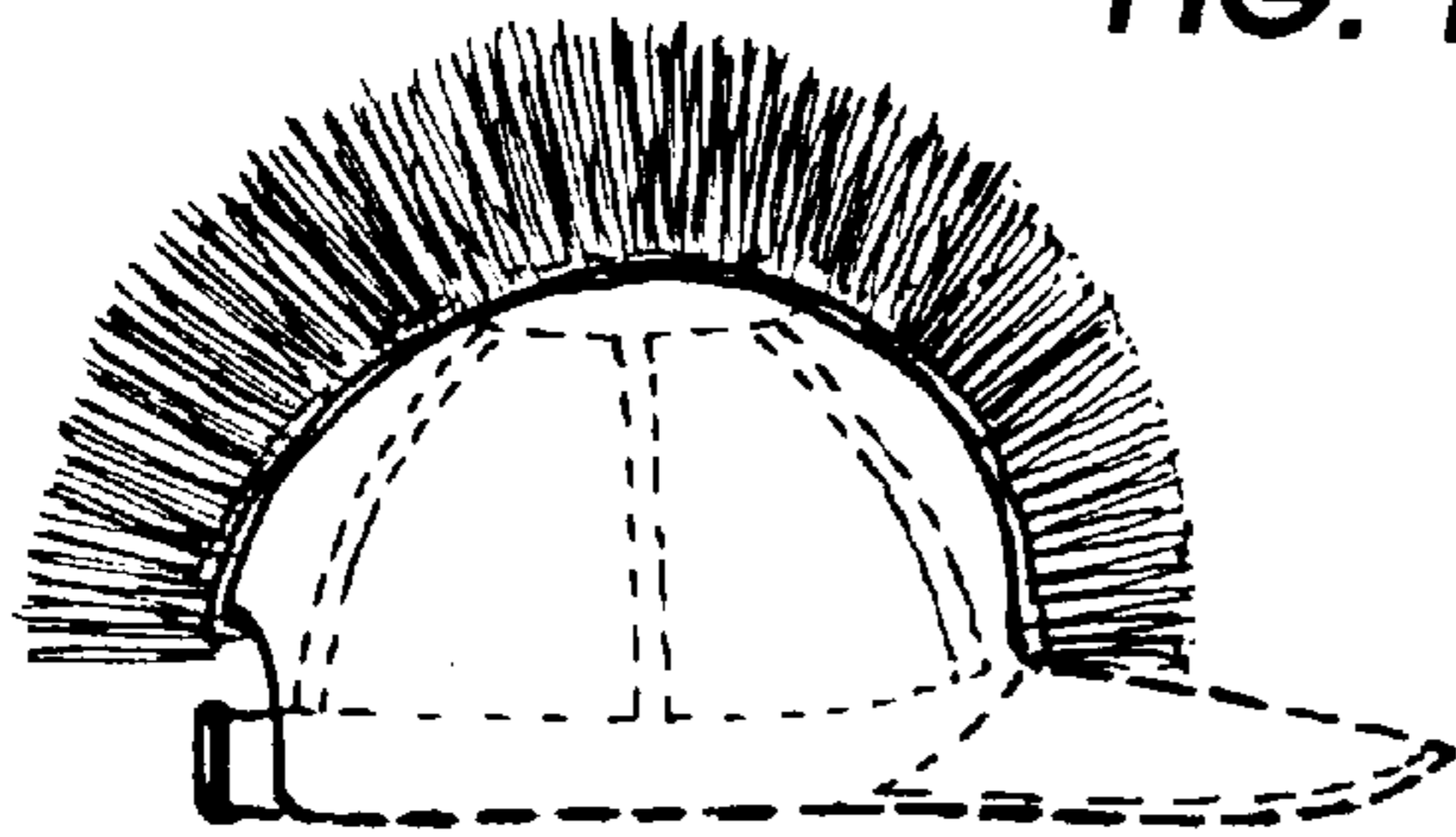

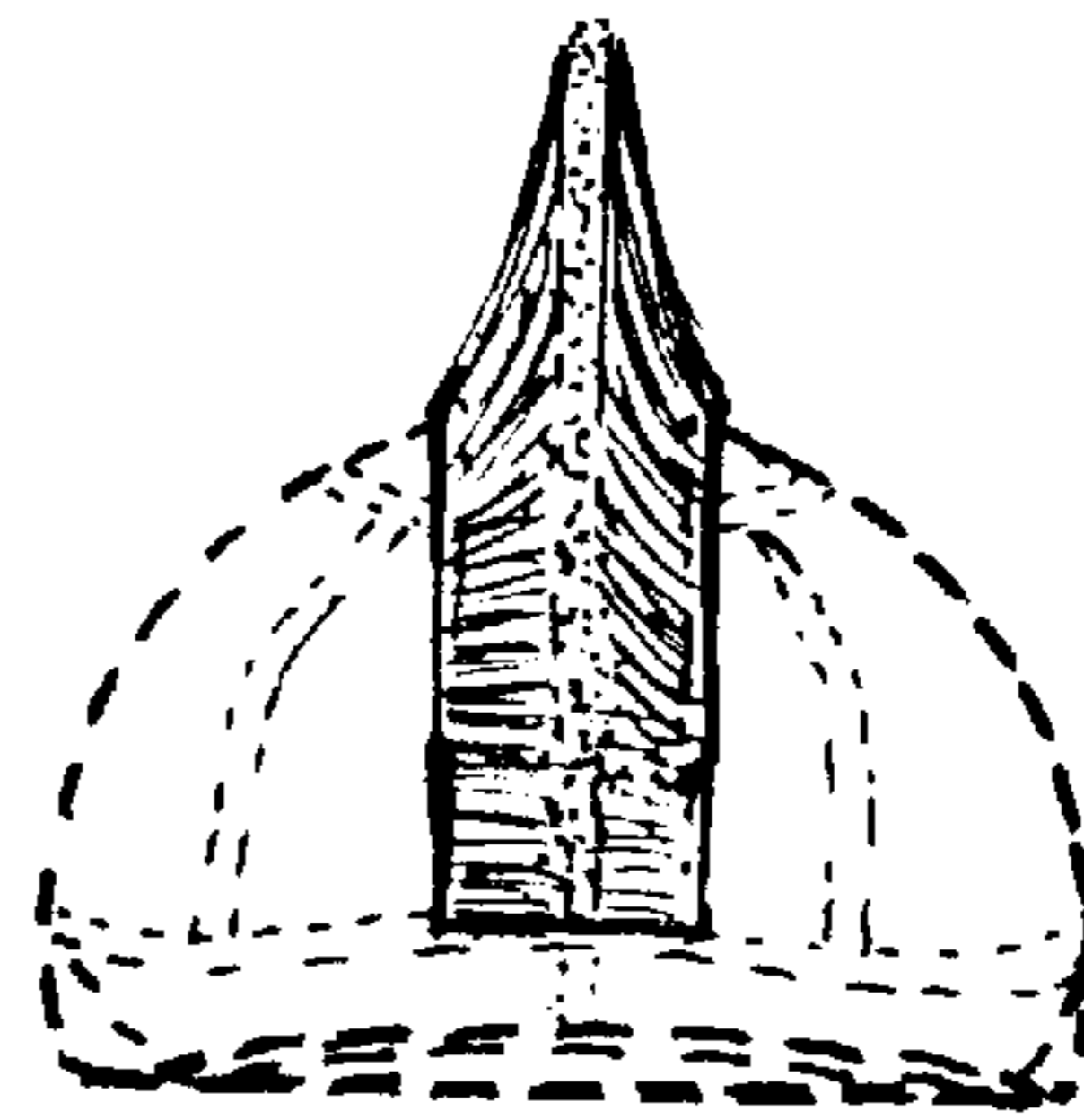

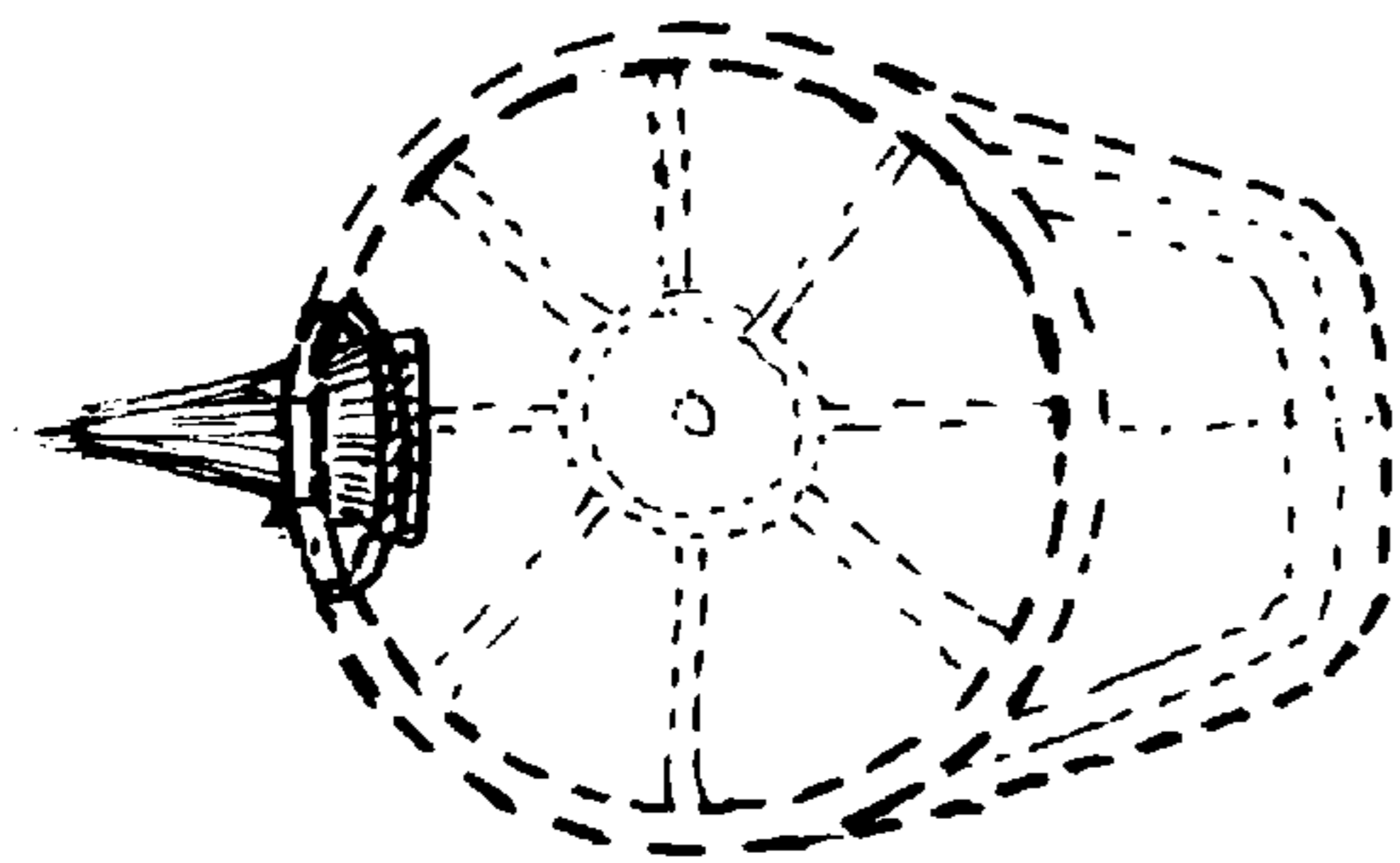
