## [57] **CLAIM**

The ornamental design for a jewelry setting, as shown and described.

FIG. 1 is a front elevational view of a jewelry setting showing my new design, the broken line showing a ring is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a perspective view;

FIG. 3 is a top plan view; and

FIG. 4 is a right side elevational view, the left side being a mirror image thereof;

FIG. 5 is a front elevational view shown in a position for a use in a pendant, the broken line showing two attachment loops is for illustrative purposes only and forms no part of the claimed design;

FIG. 6 is a left side elevational view of FIG. 5;

FIG. 7 is a rear perspective view of FIG. 5;

FIG. 8 is a front perspective view of FIG. 5;

FIG. 9 is a front elevational view shown in a position for a use in an earring, the broken line showing an earring post is for illustrative purposes only and forms no part of the claimed design;

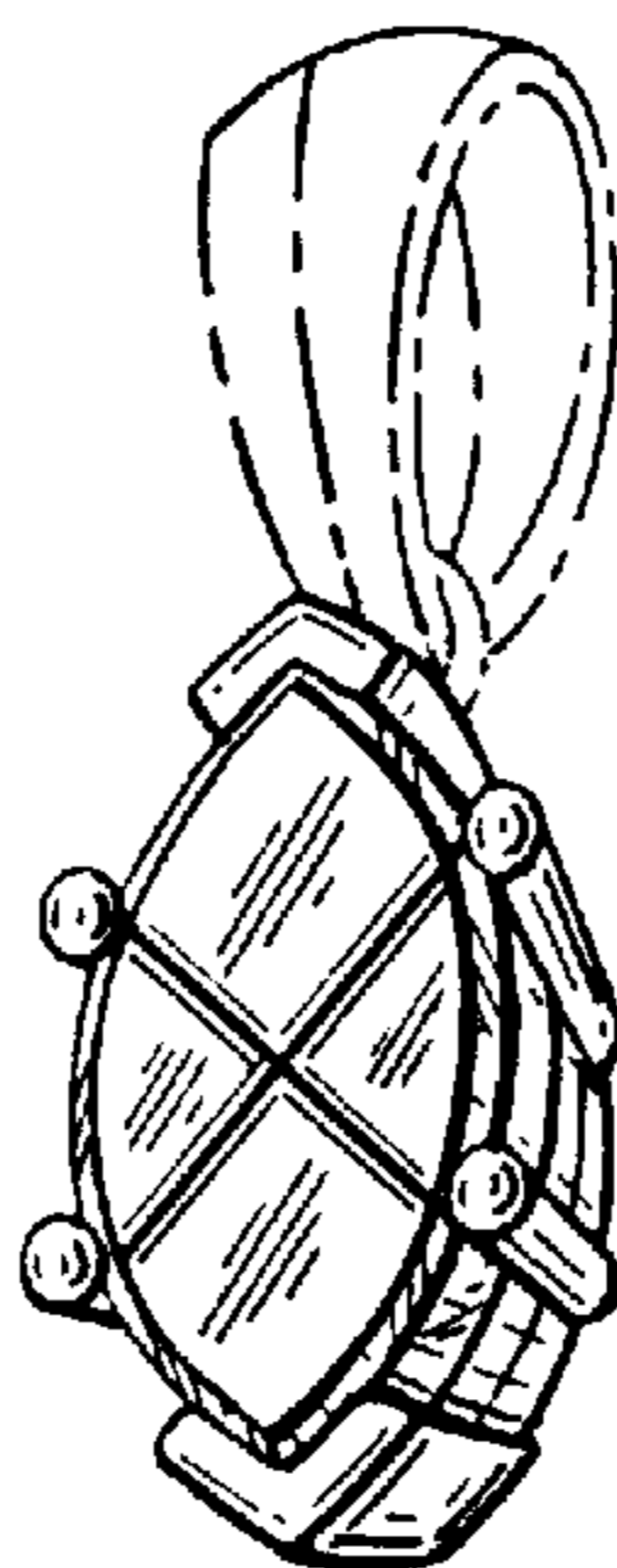
FIG. 10 is a perspective view of FIG. 9;

FIG. 12 is a right side elevational view of FIG. 9, the left side being a mirror image thereof.

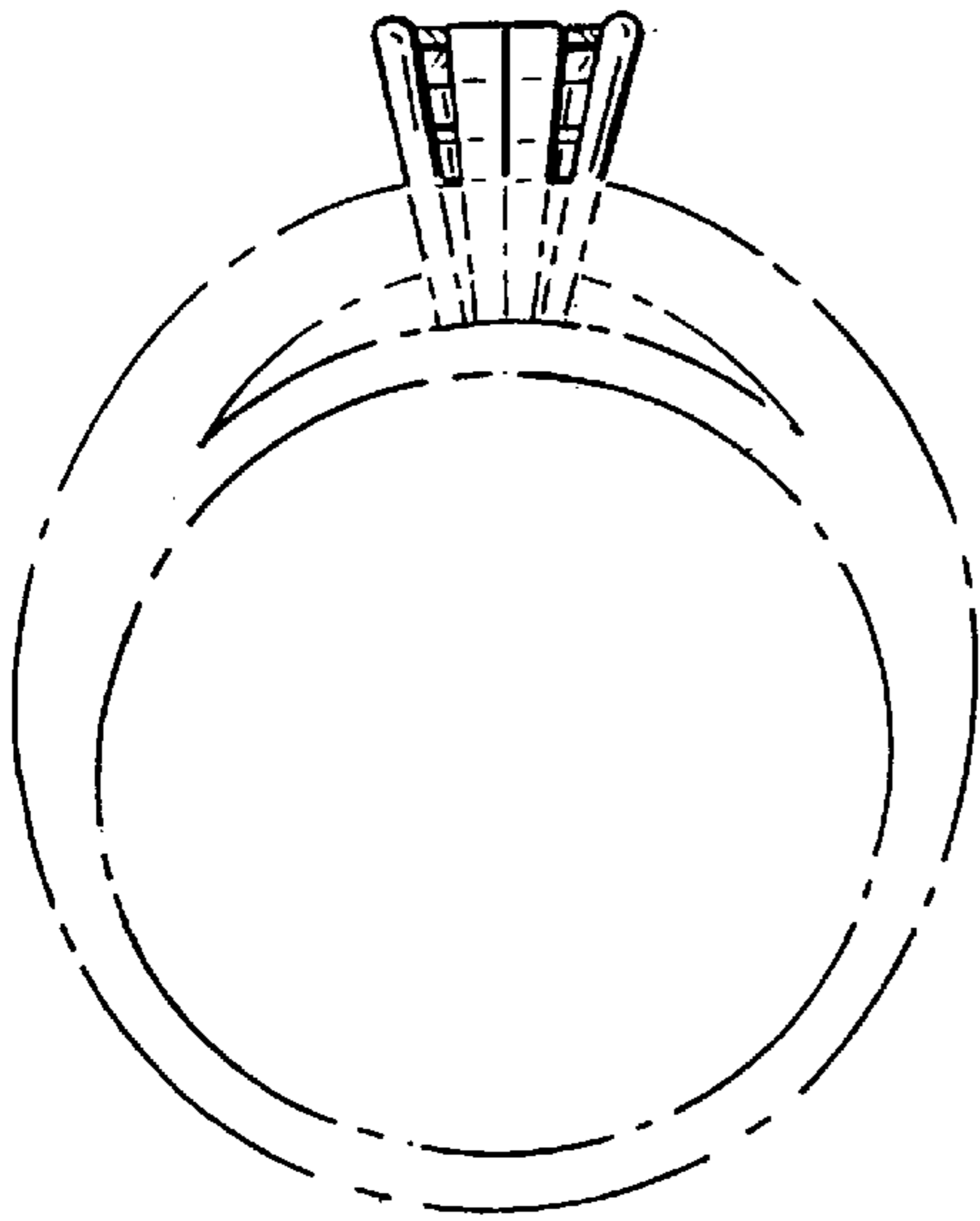

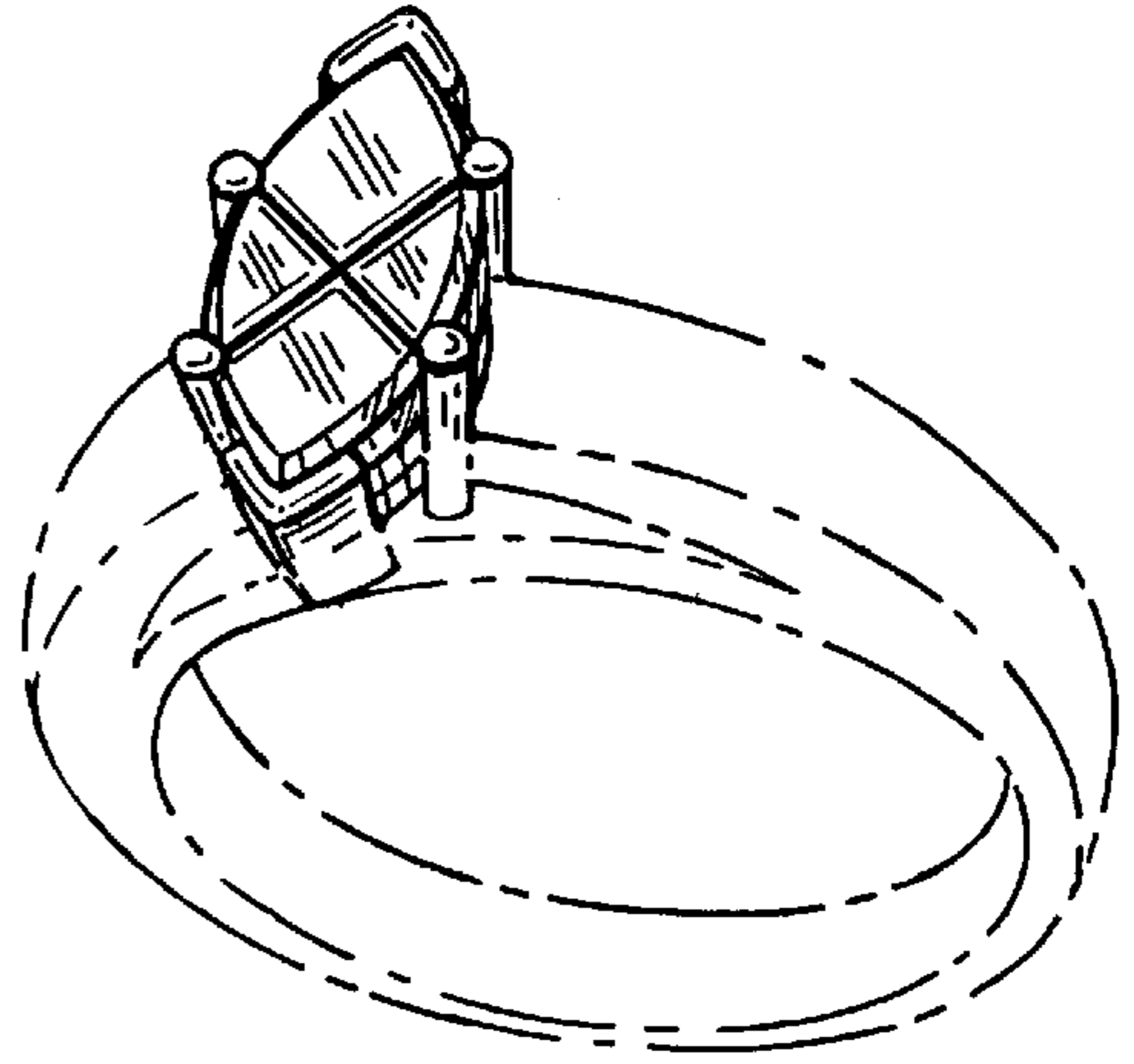

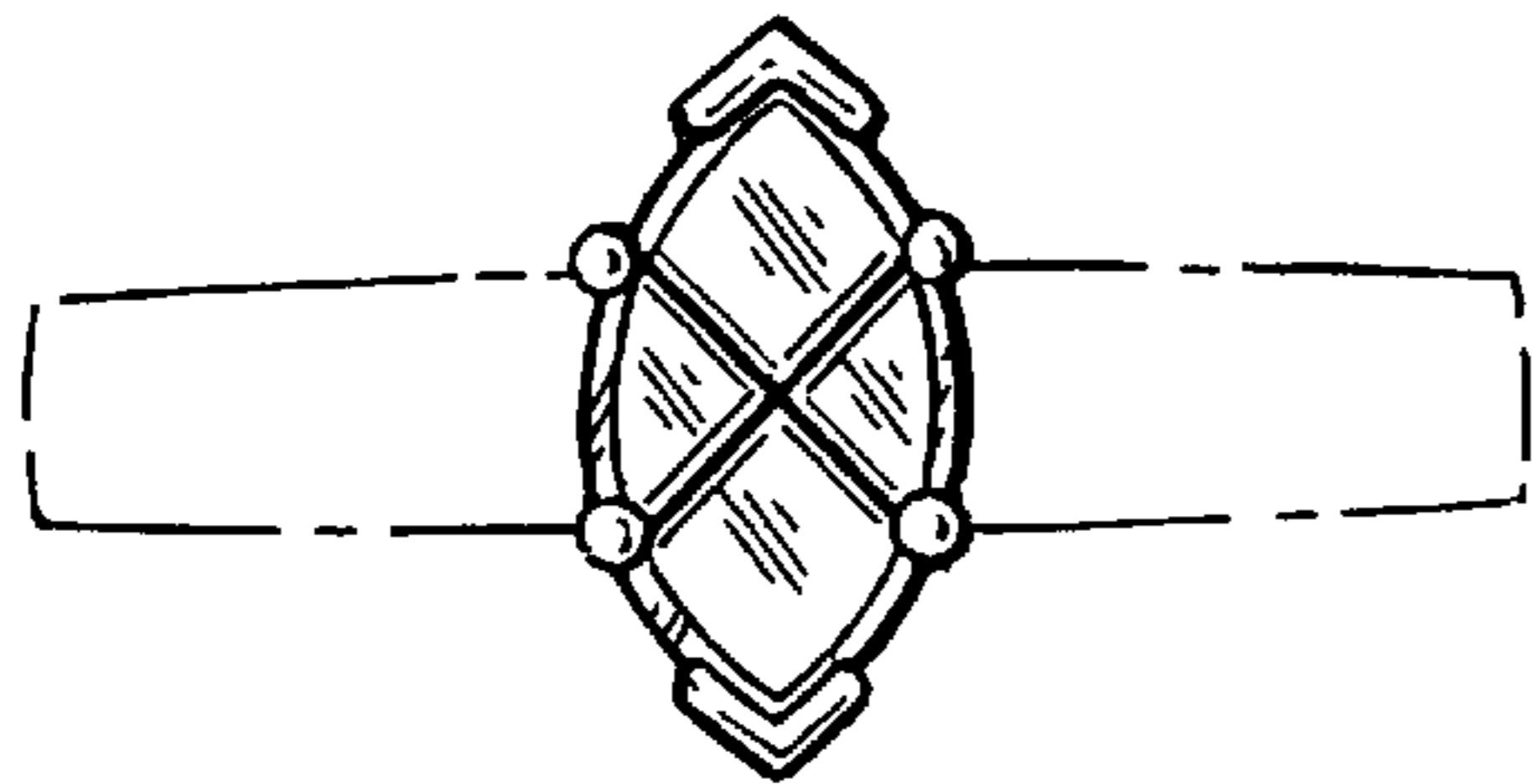

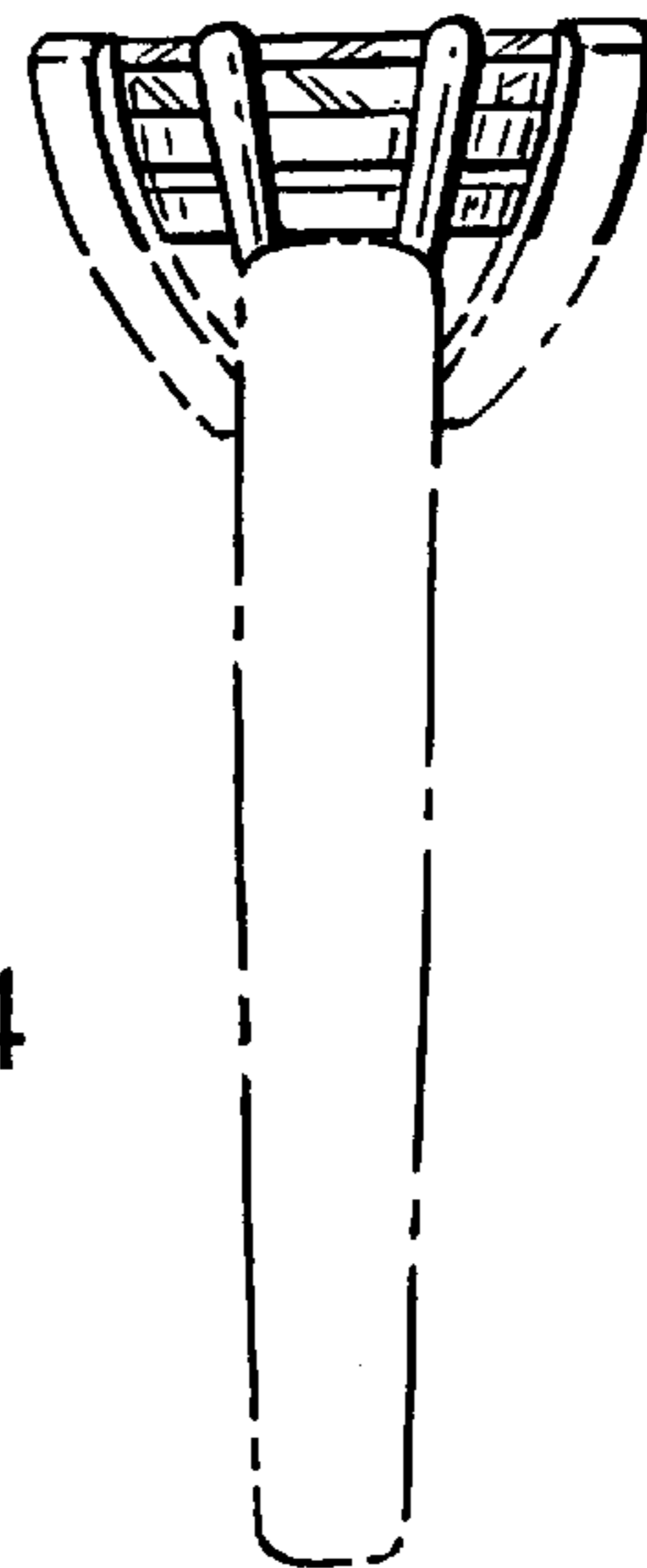

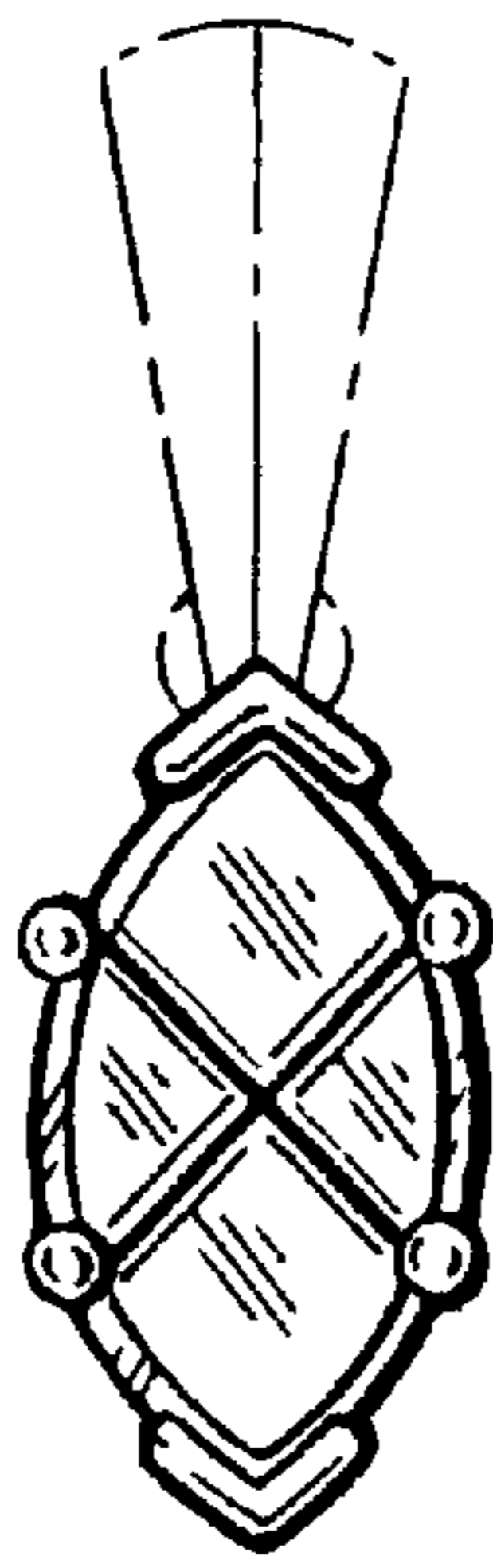

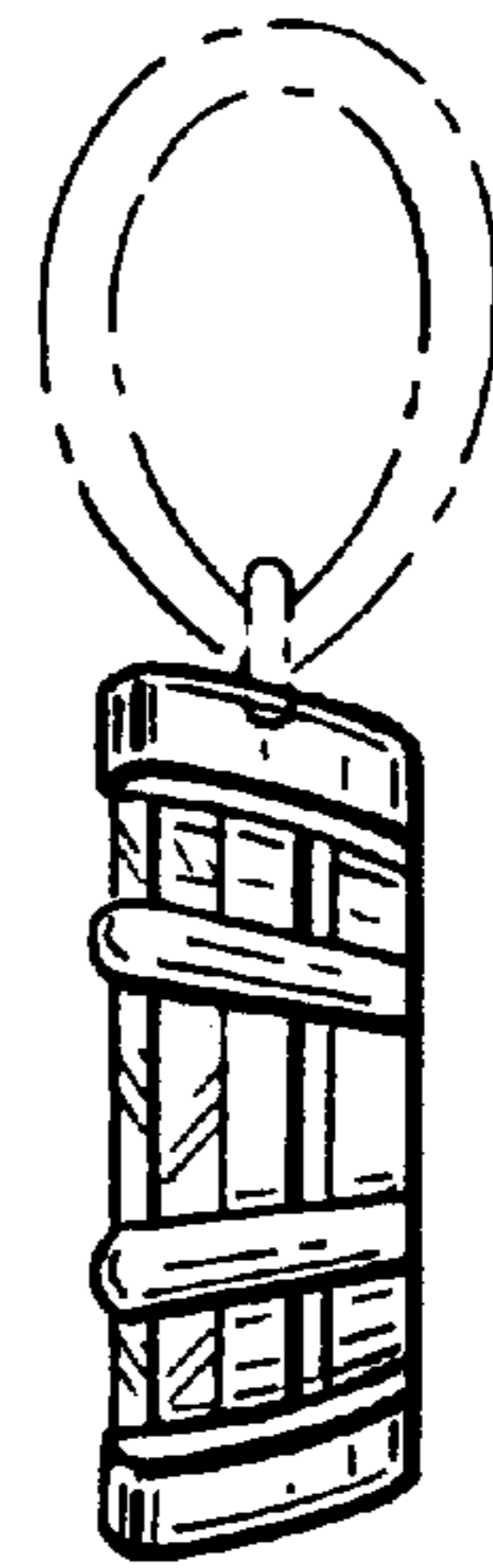

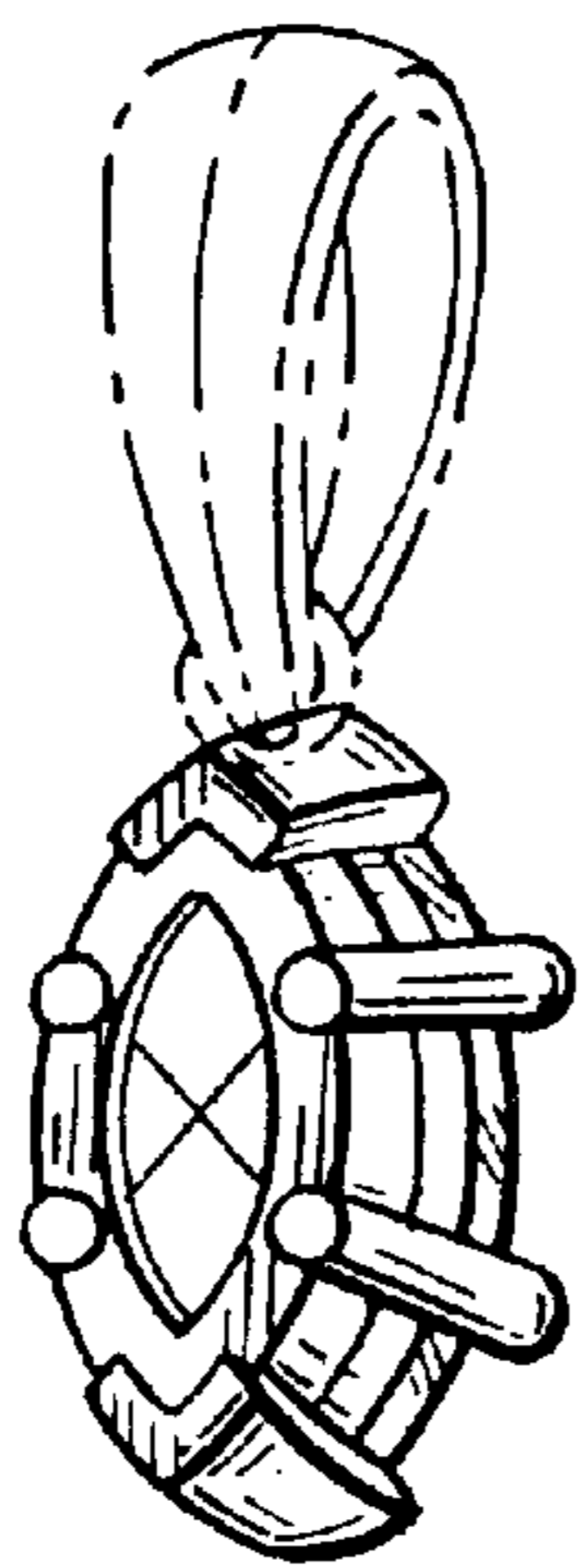

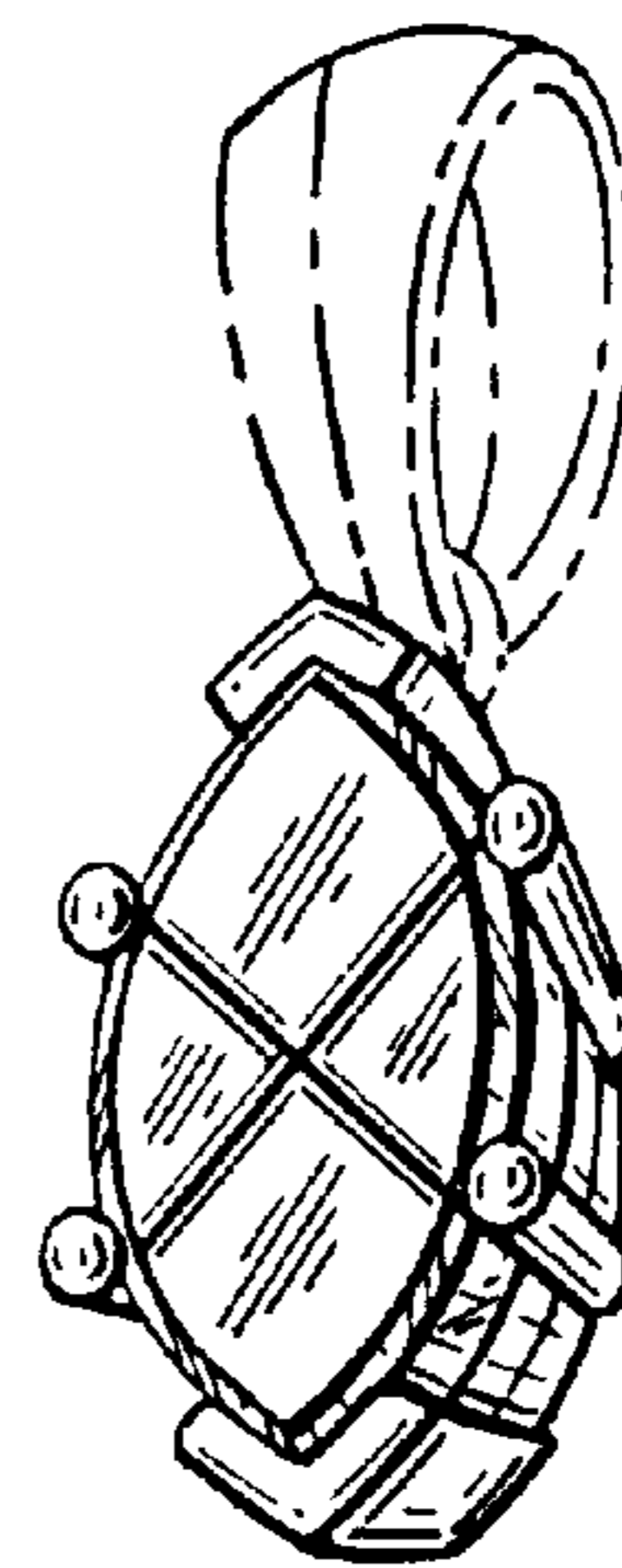

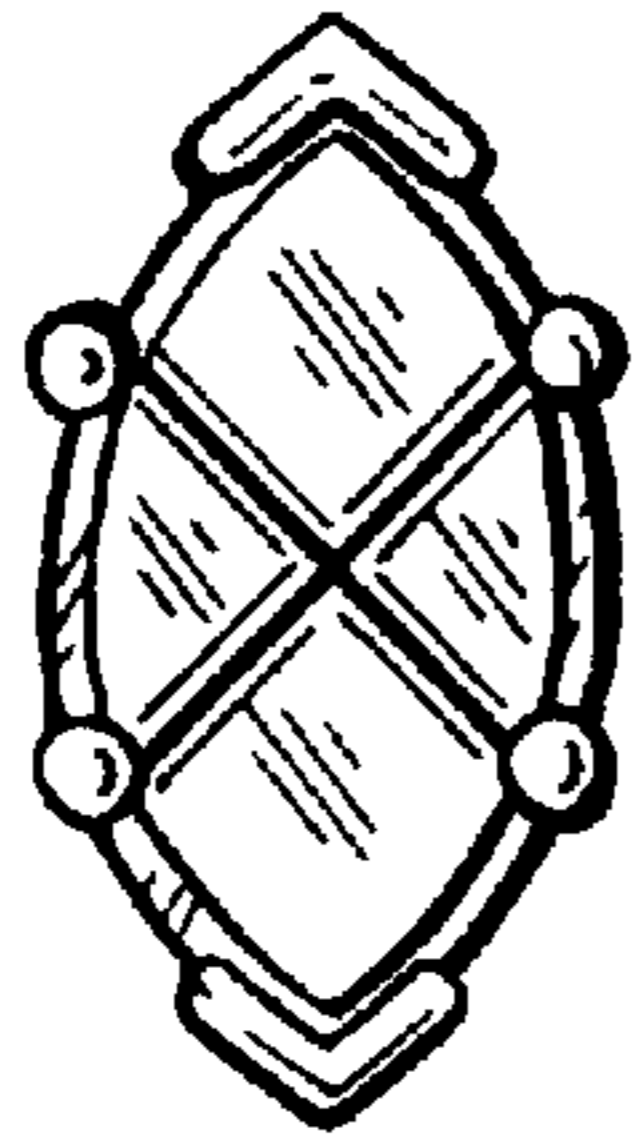

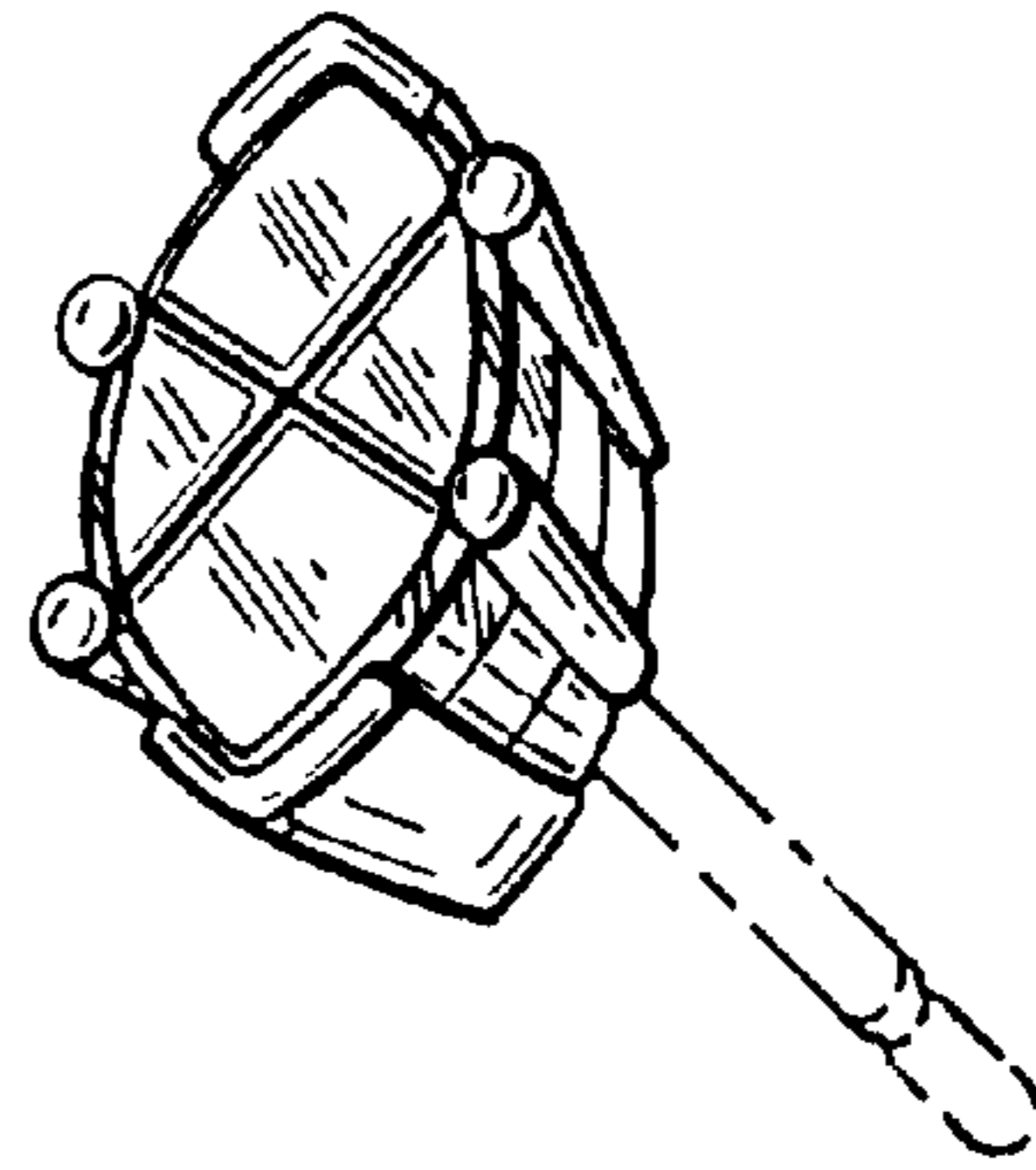

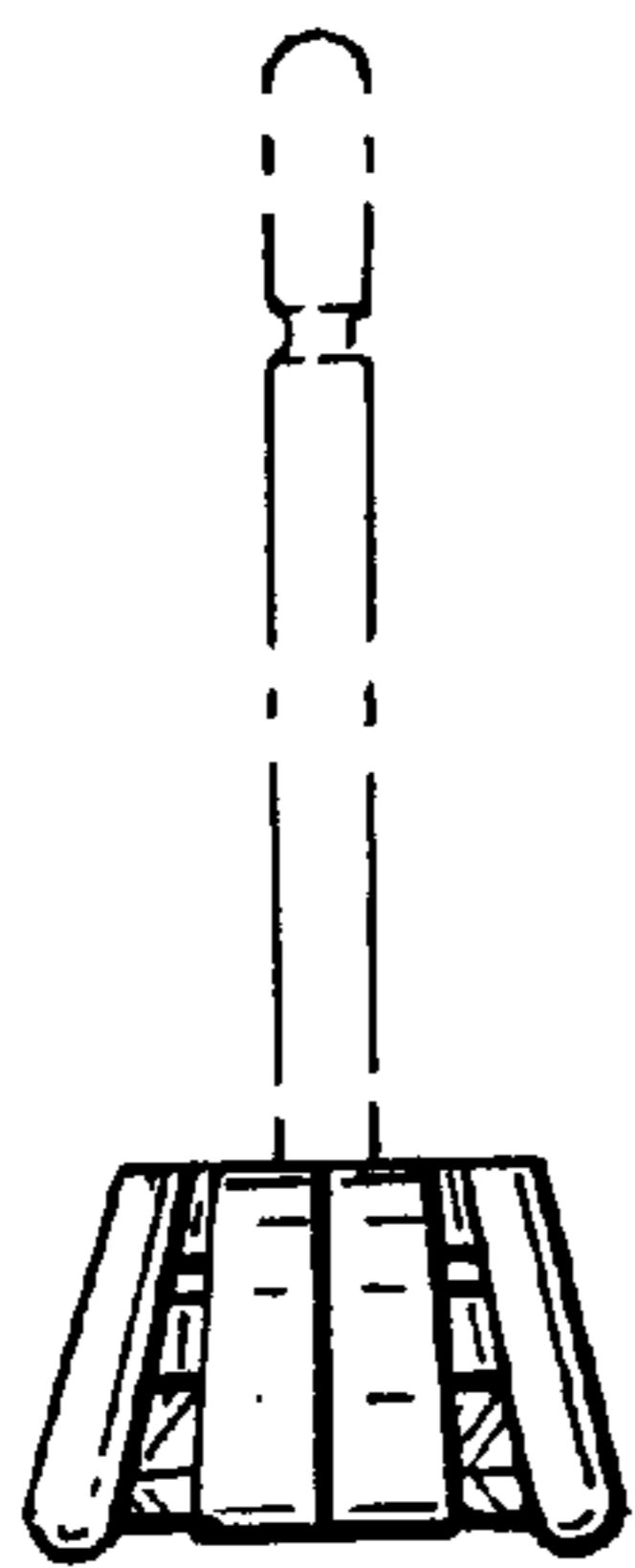

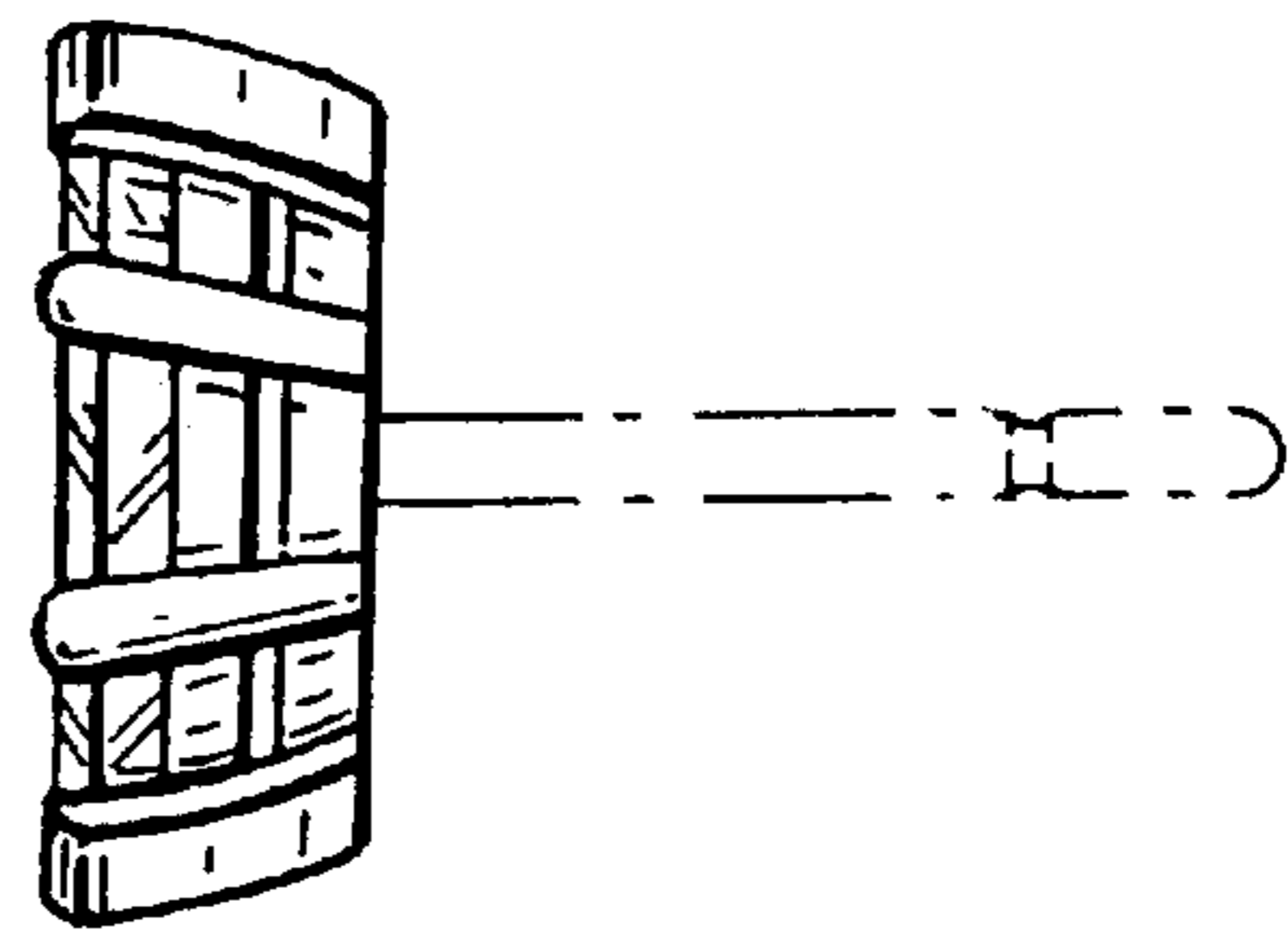
