The ornamental design for a voice pager, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a voice pager according to the present invention.

FIG. 2 is another perspective view of the voice pager of FIG. 1.

FIG. 3 is a front elevation of the voice pager of FIG. 1.

FIG. 4 is a right side elevation of the voice pager of FIG. 1.

FIG. 5 is a rear elevation of the voice pager of FIG. 1.

FIG. 6 is a left side elevation of the voice pager of FIG. 1.

FIG. 7 is a top plan view of the voice pager of FIG. 1; and,

FIG. 8 is a bottom plan view of the voice pager of FIG. 1.

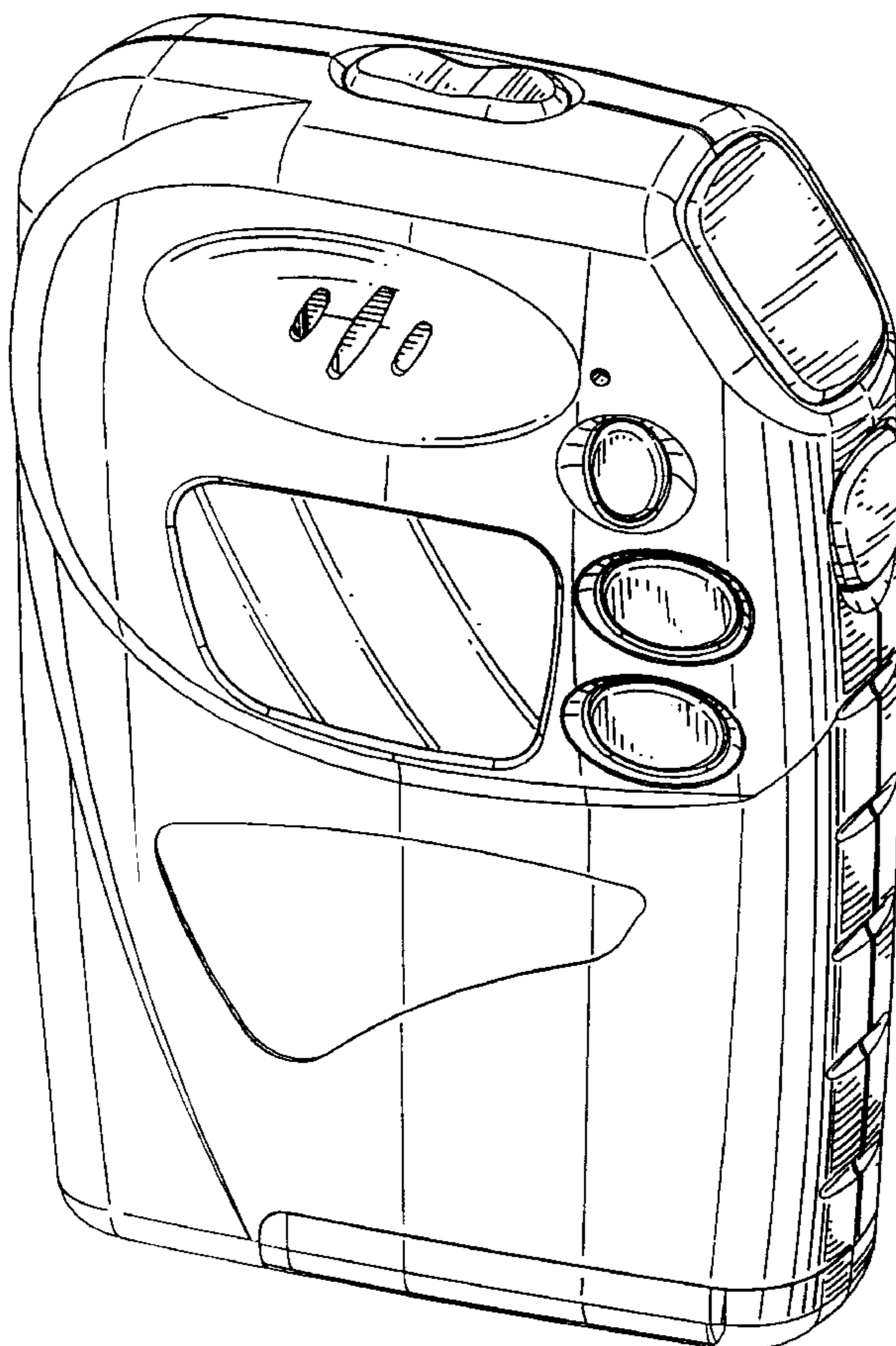

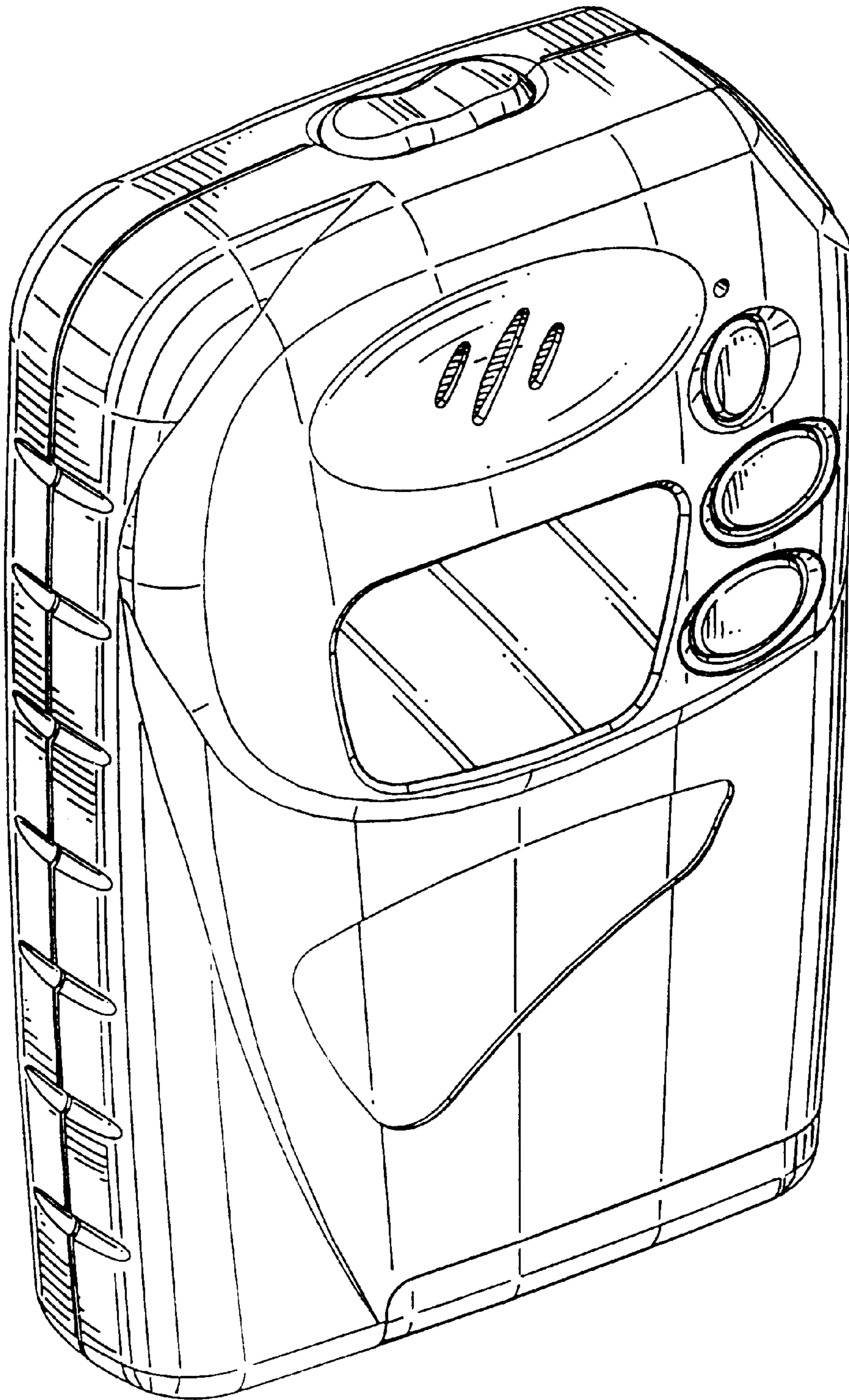

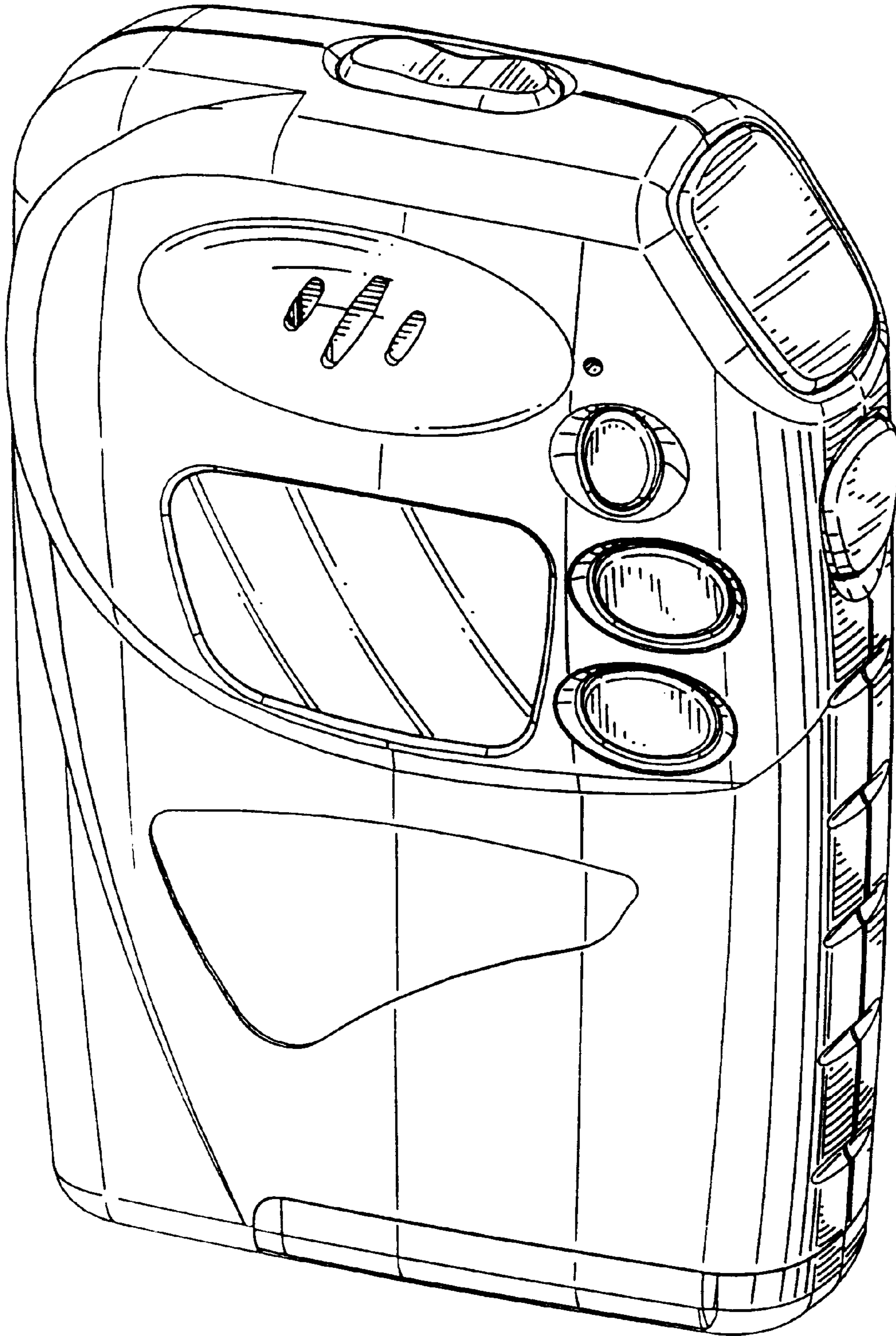

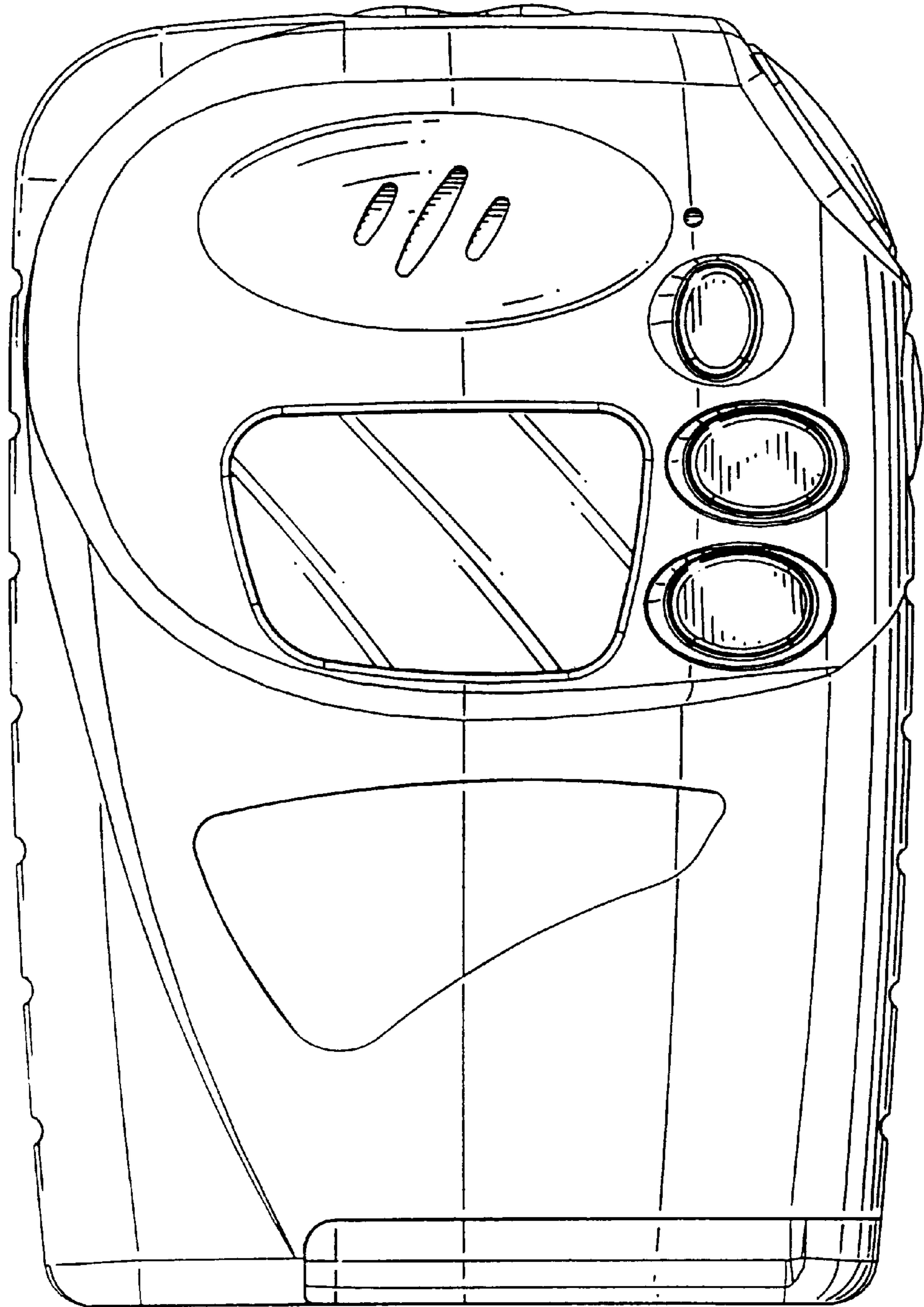

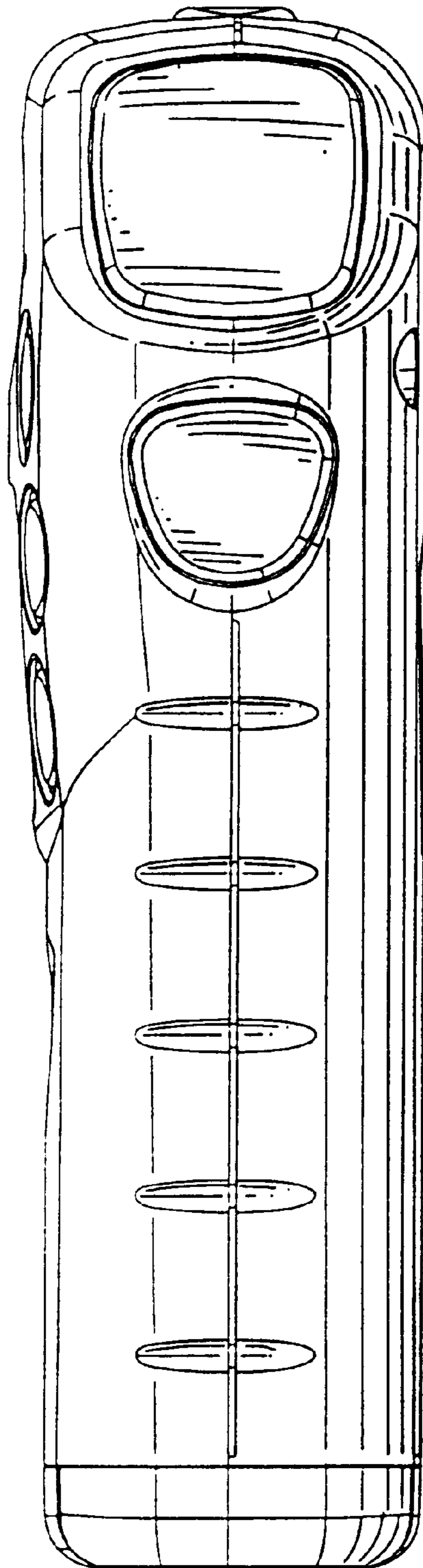

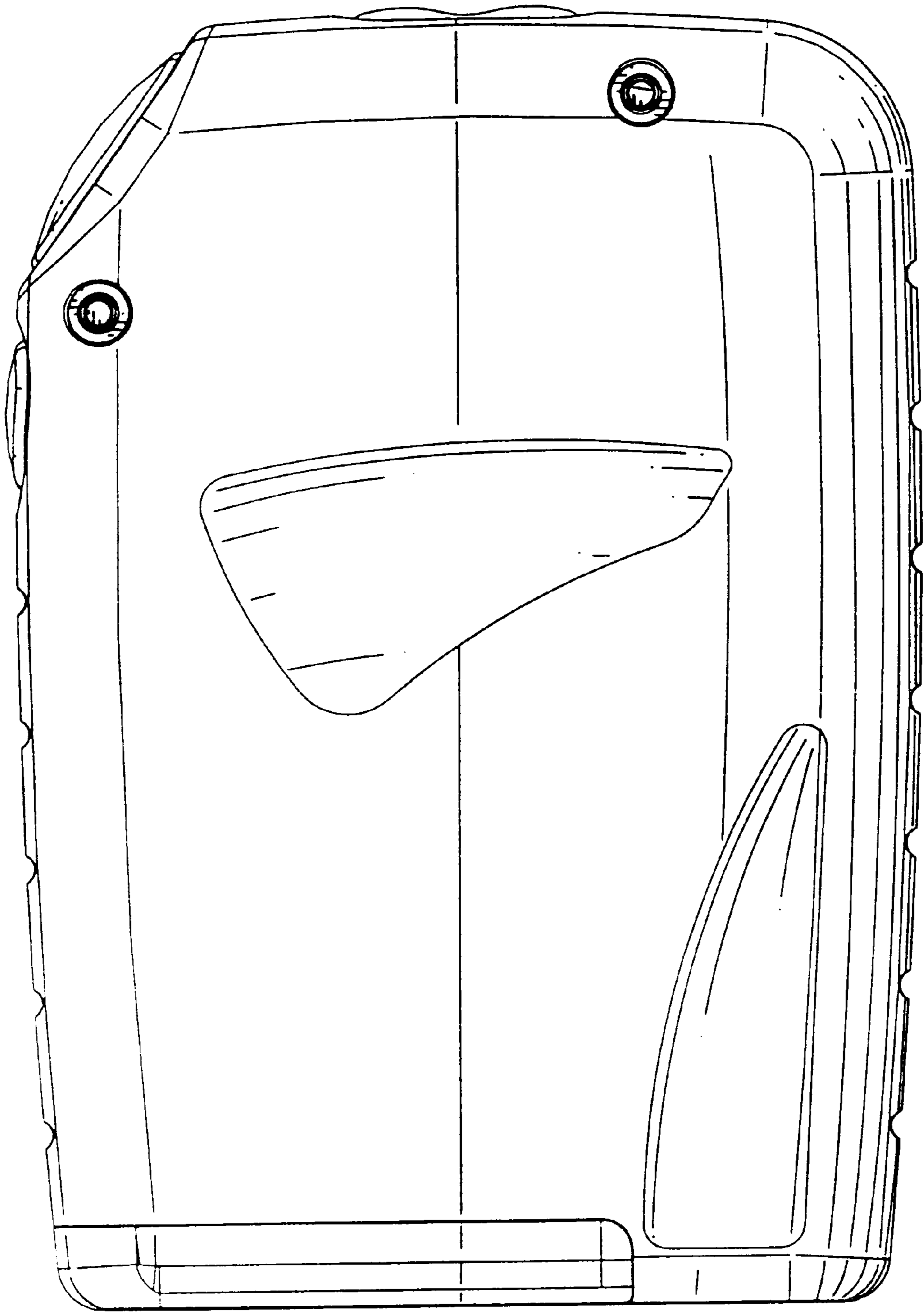

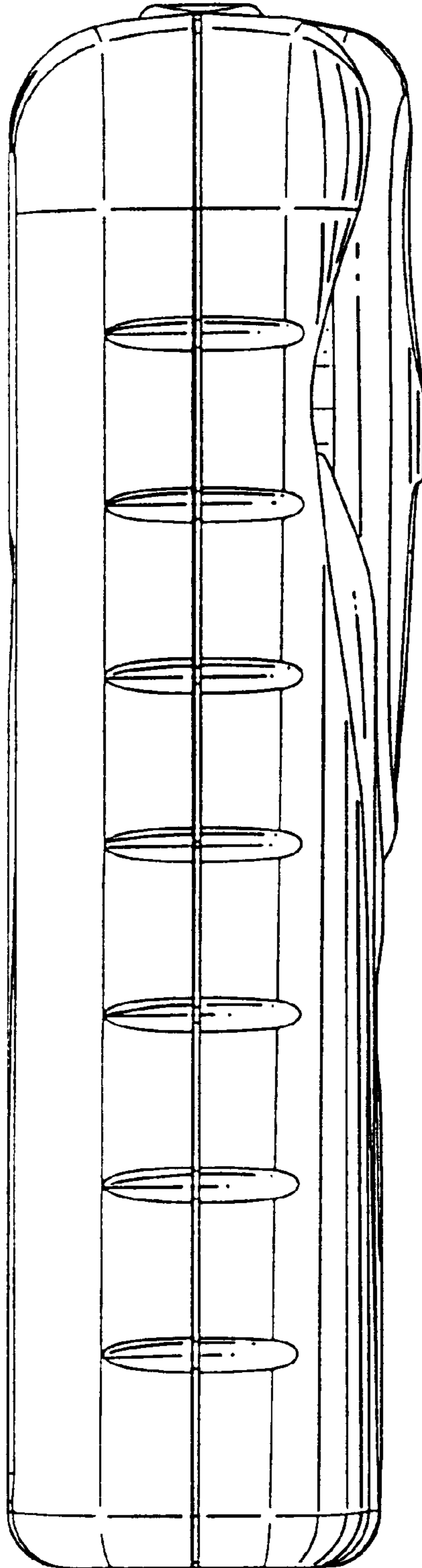

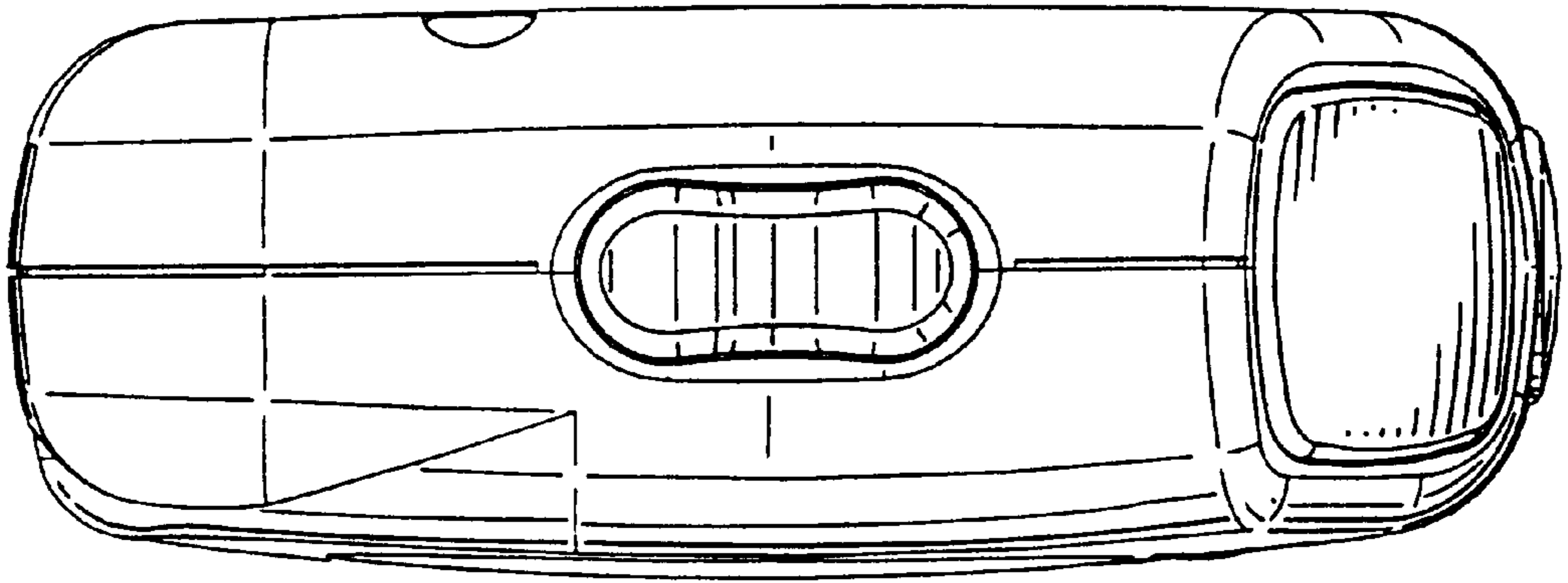
