DESCRIPTION

FIG. 1 is a top plan view of an ink cartridge;
FIG. 2 is a front view of the ink cartridge;
FIG. 3 is a left side view of the ink cartridge;
FIG. 4 is a right side view of the ink cartridge;
FIG. 5 is a bottom plan view of the ink cartridge;

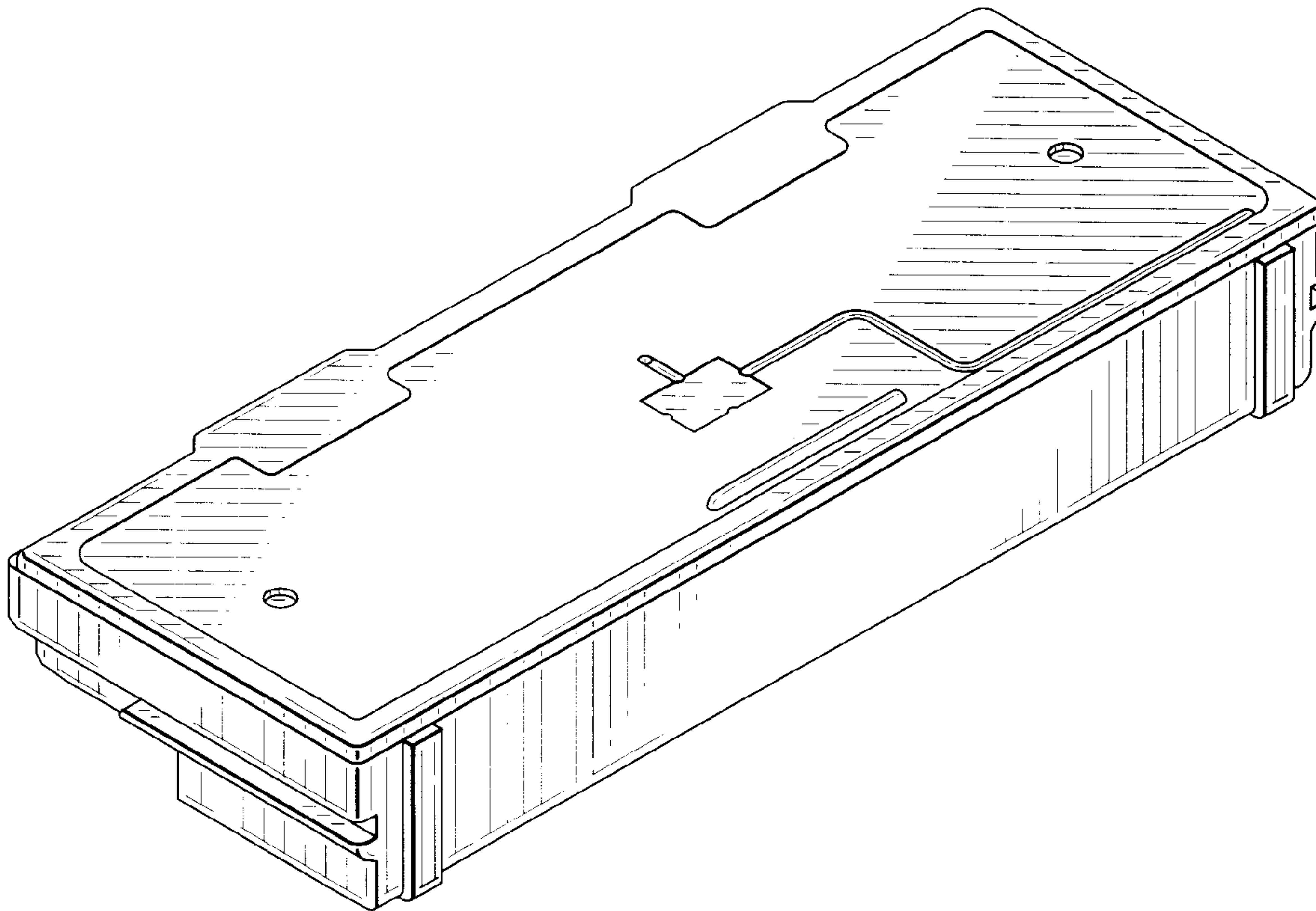

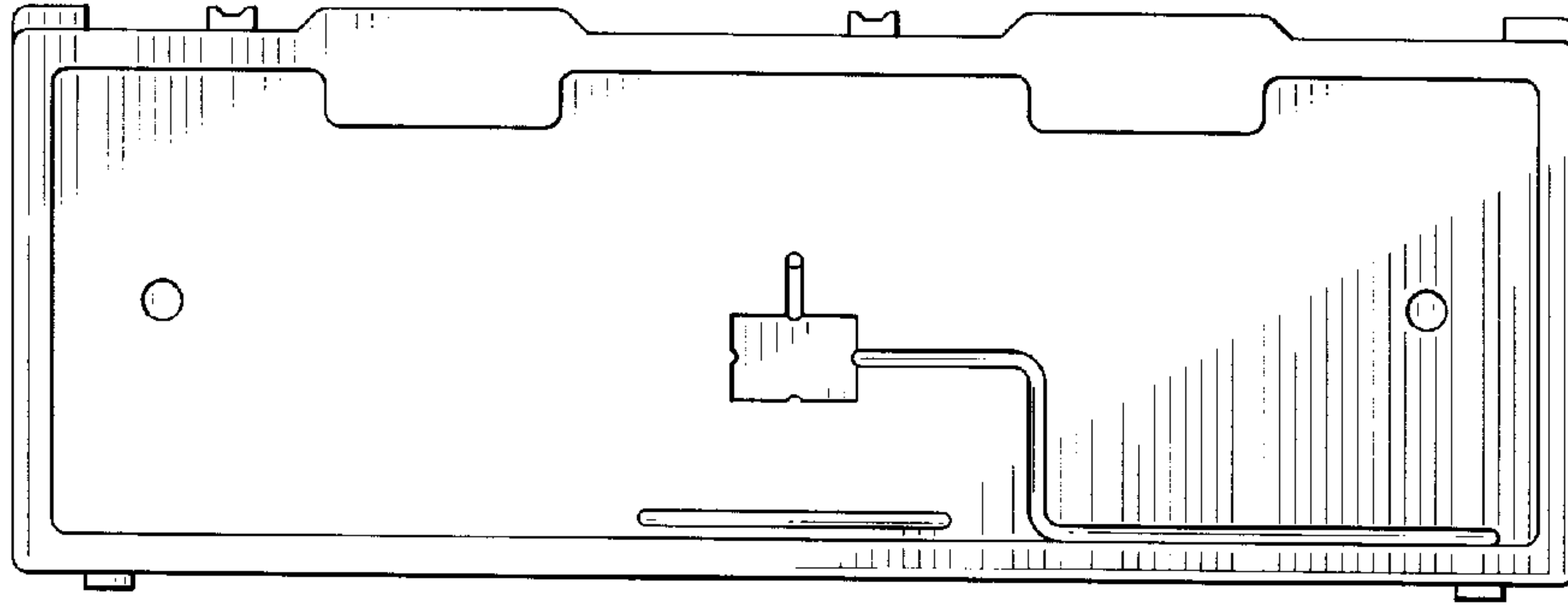

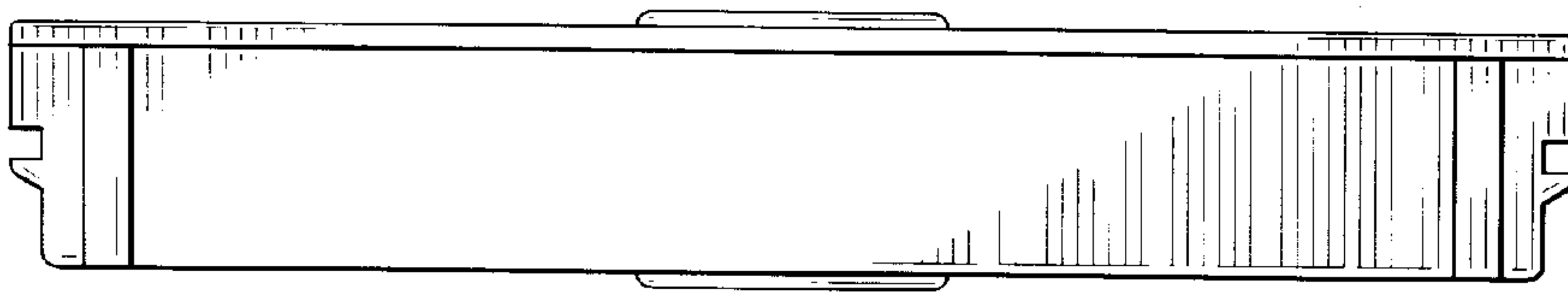

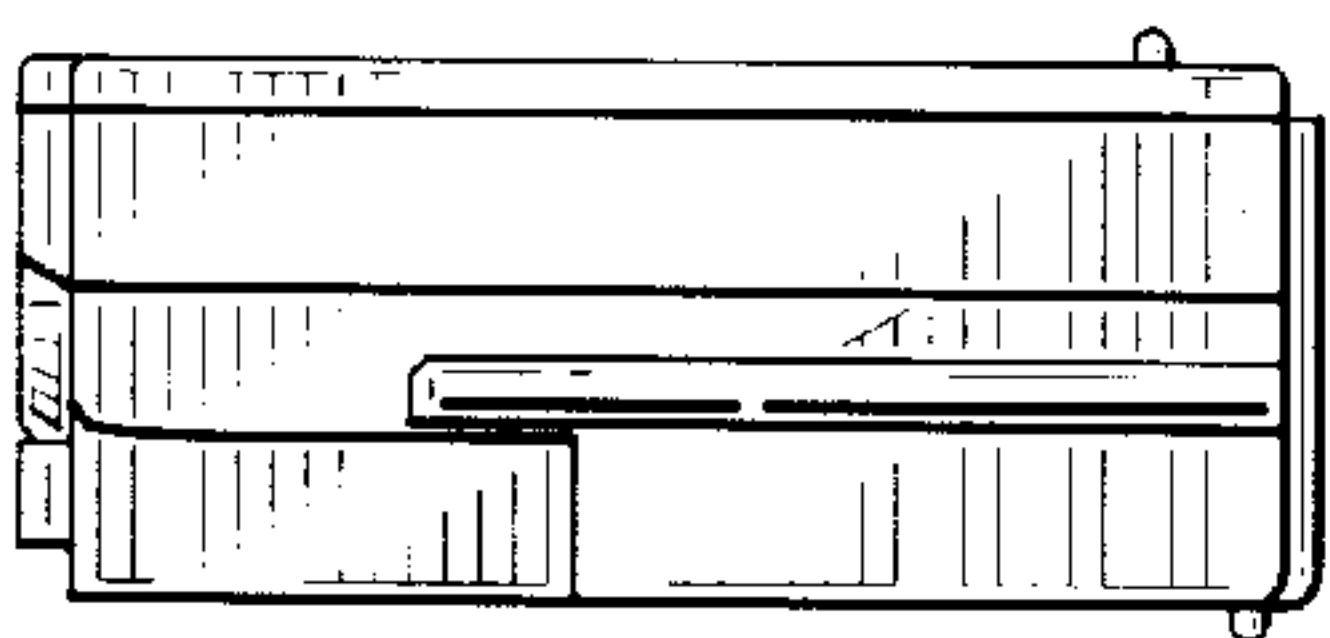

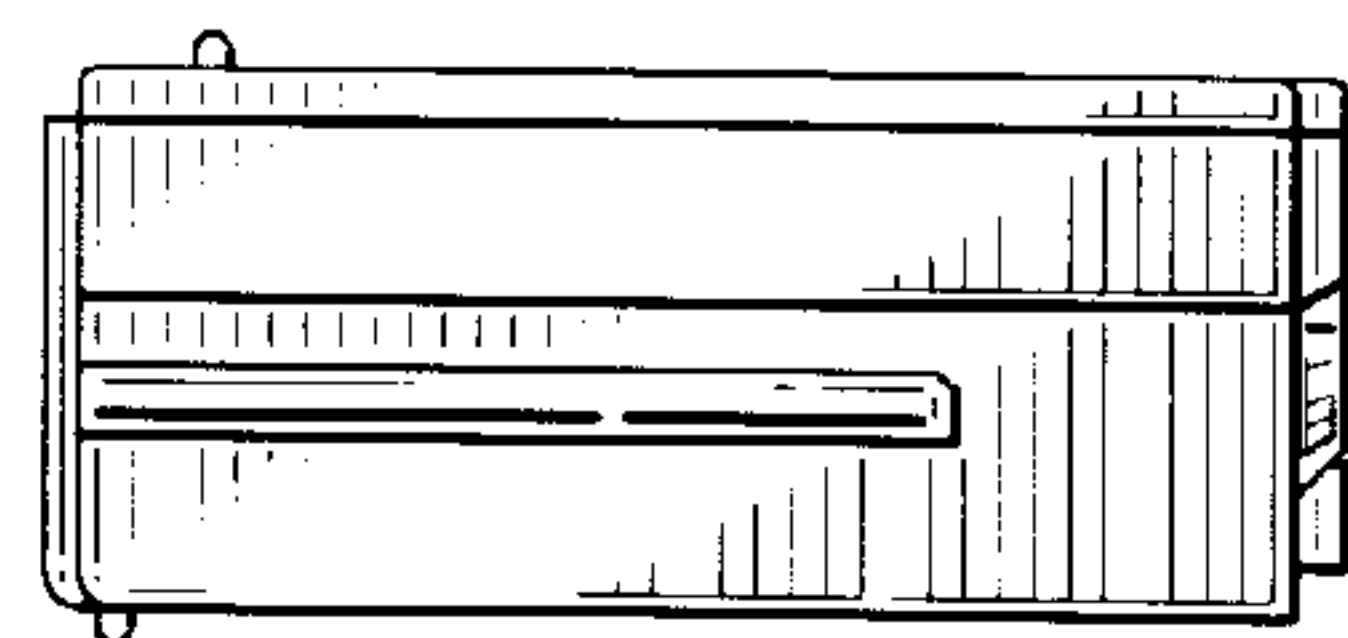

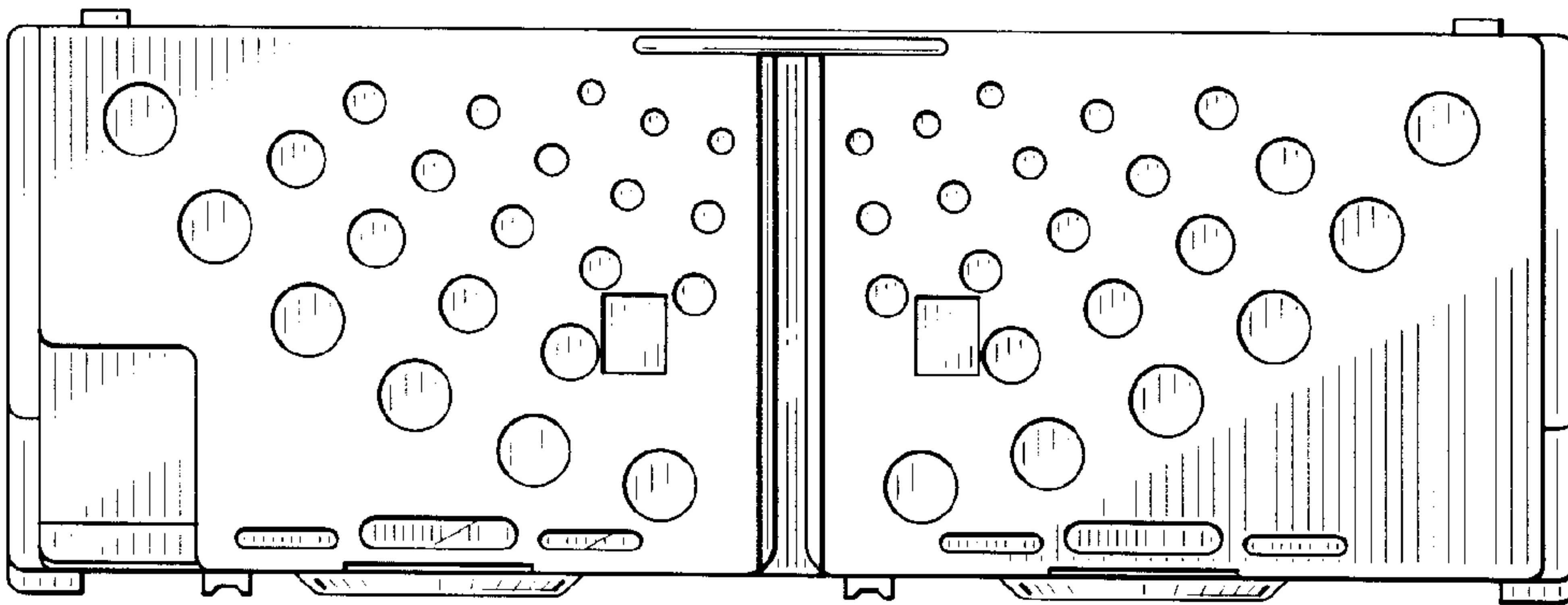

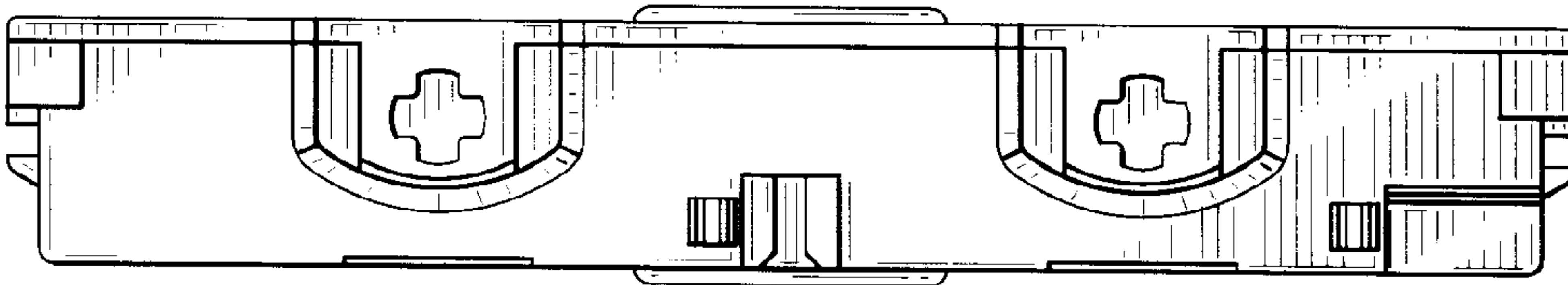
