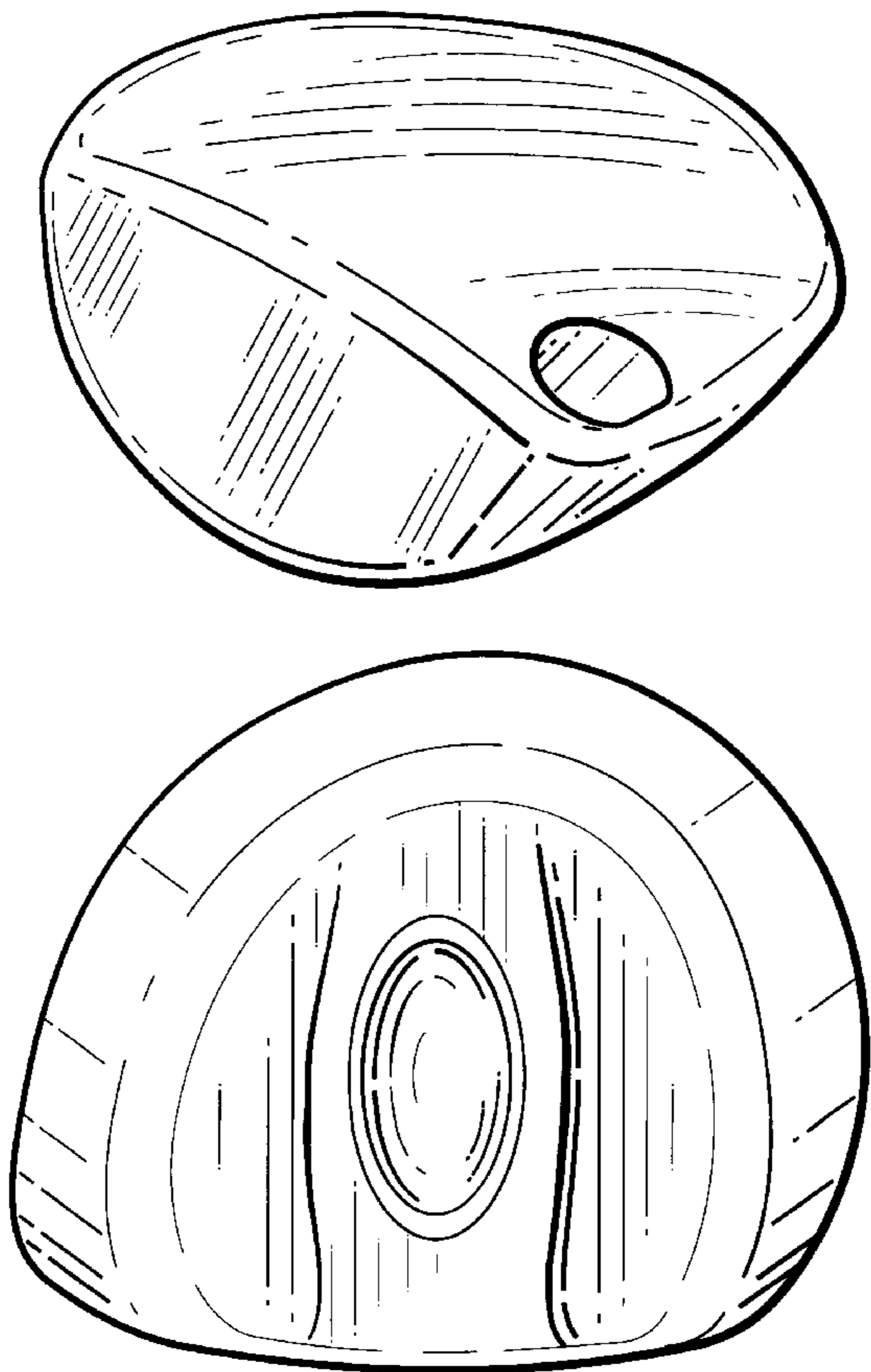

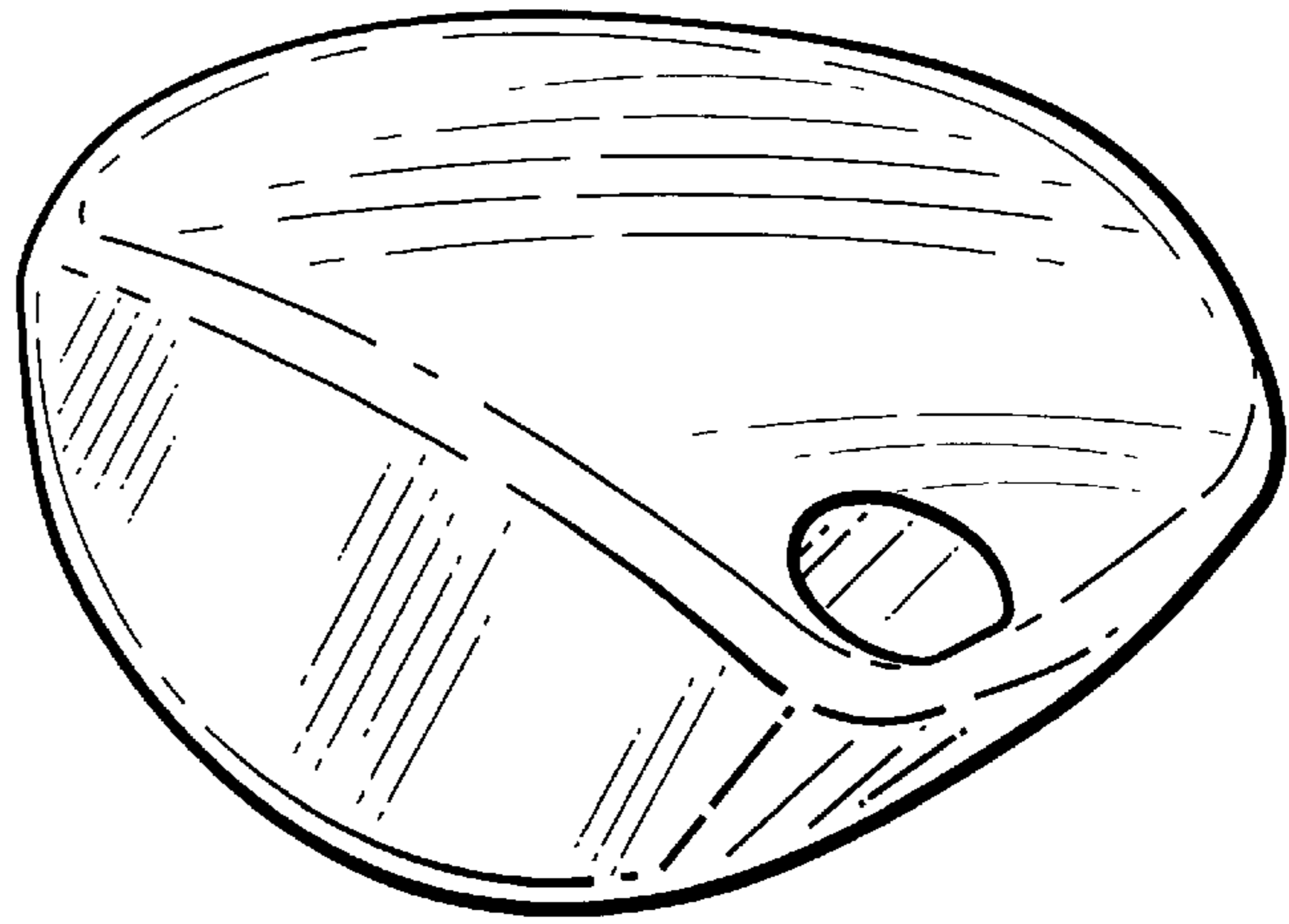
The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

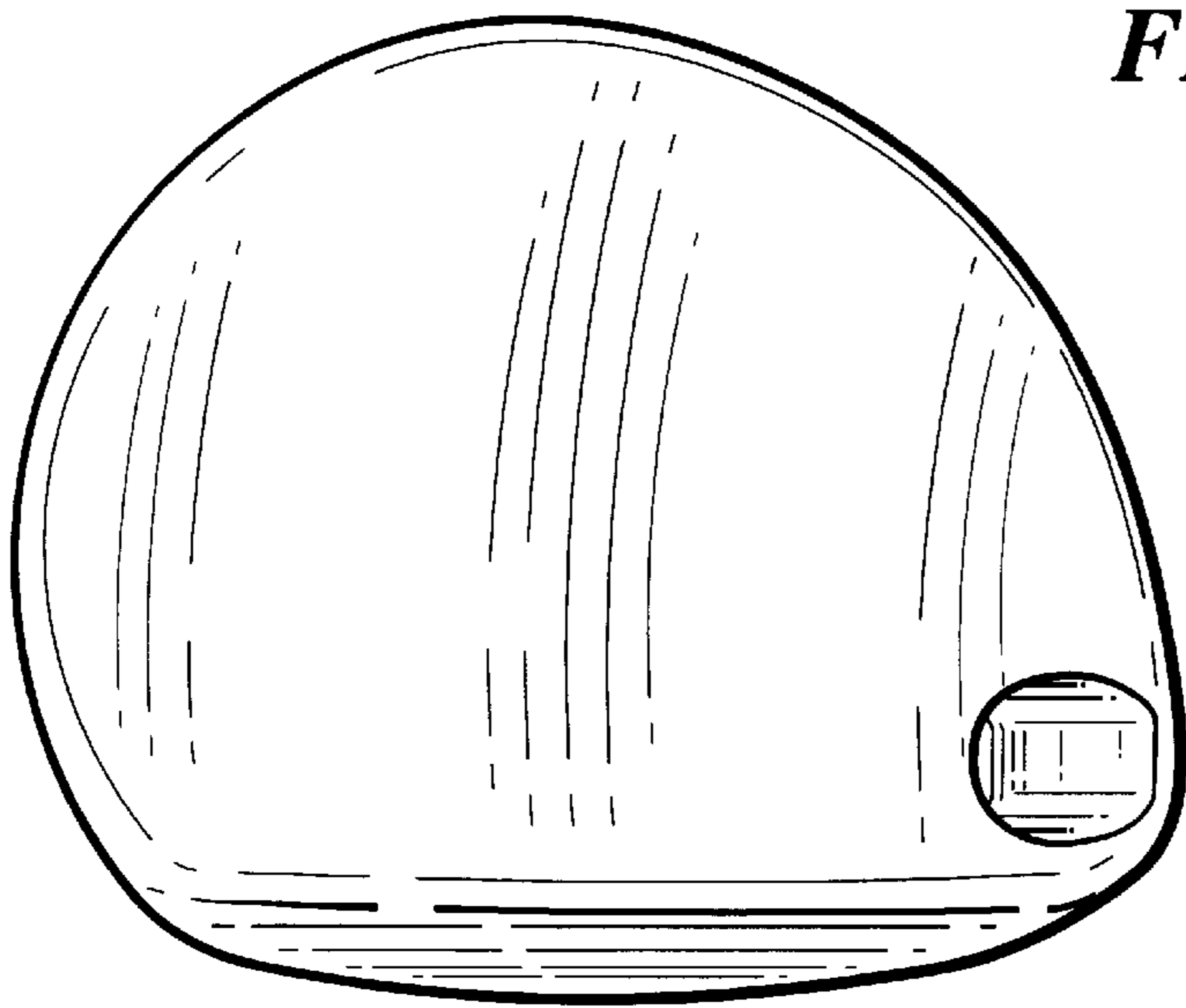
FIG. 1 is a perspective view of a golf club head showing our new design;

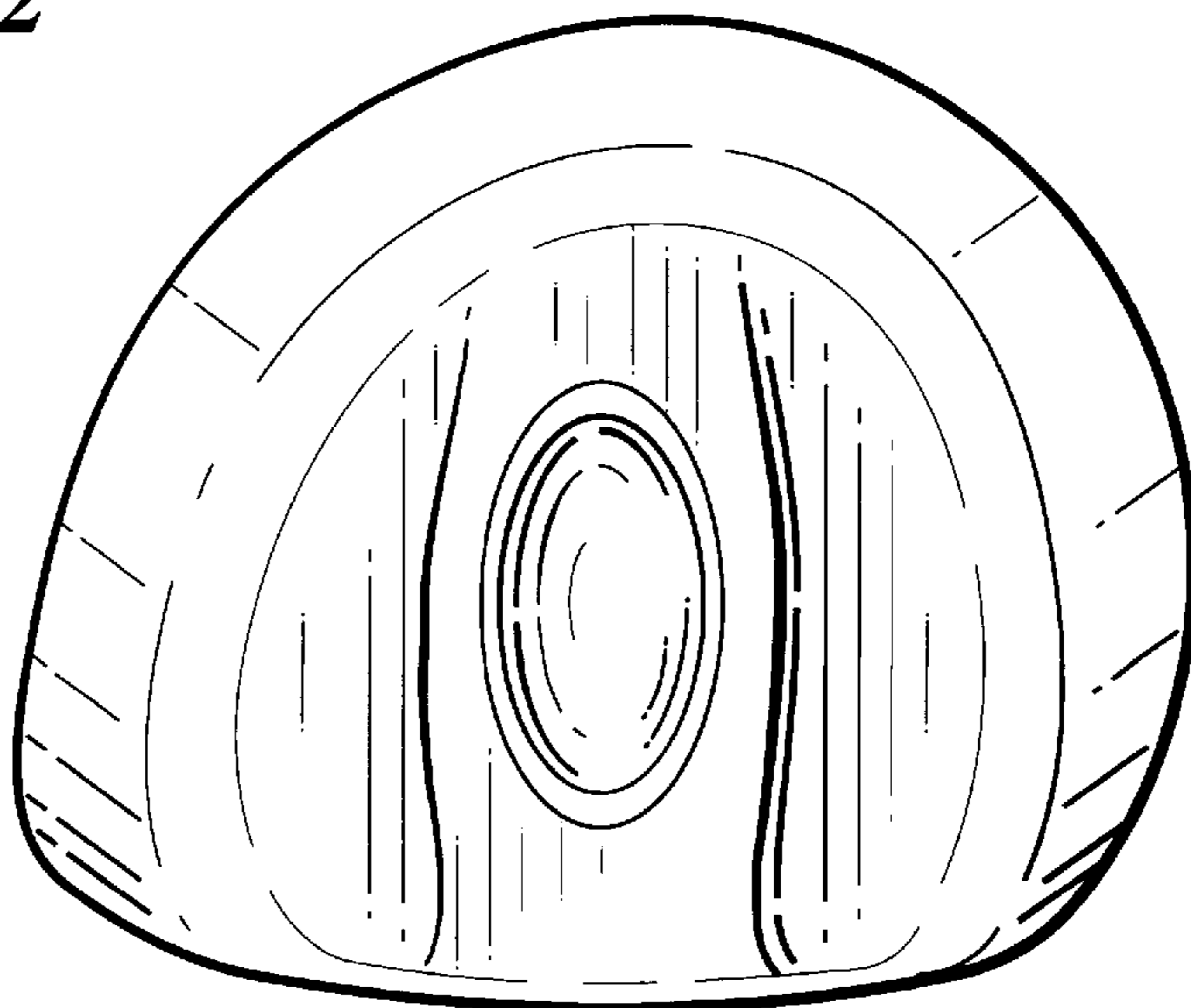




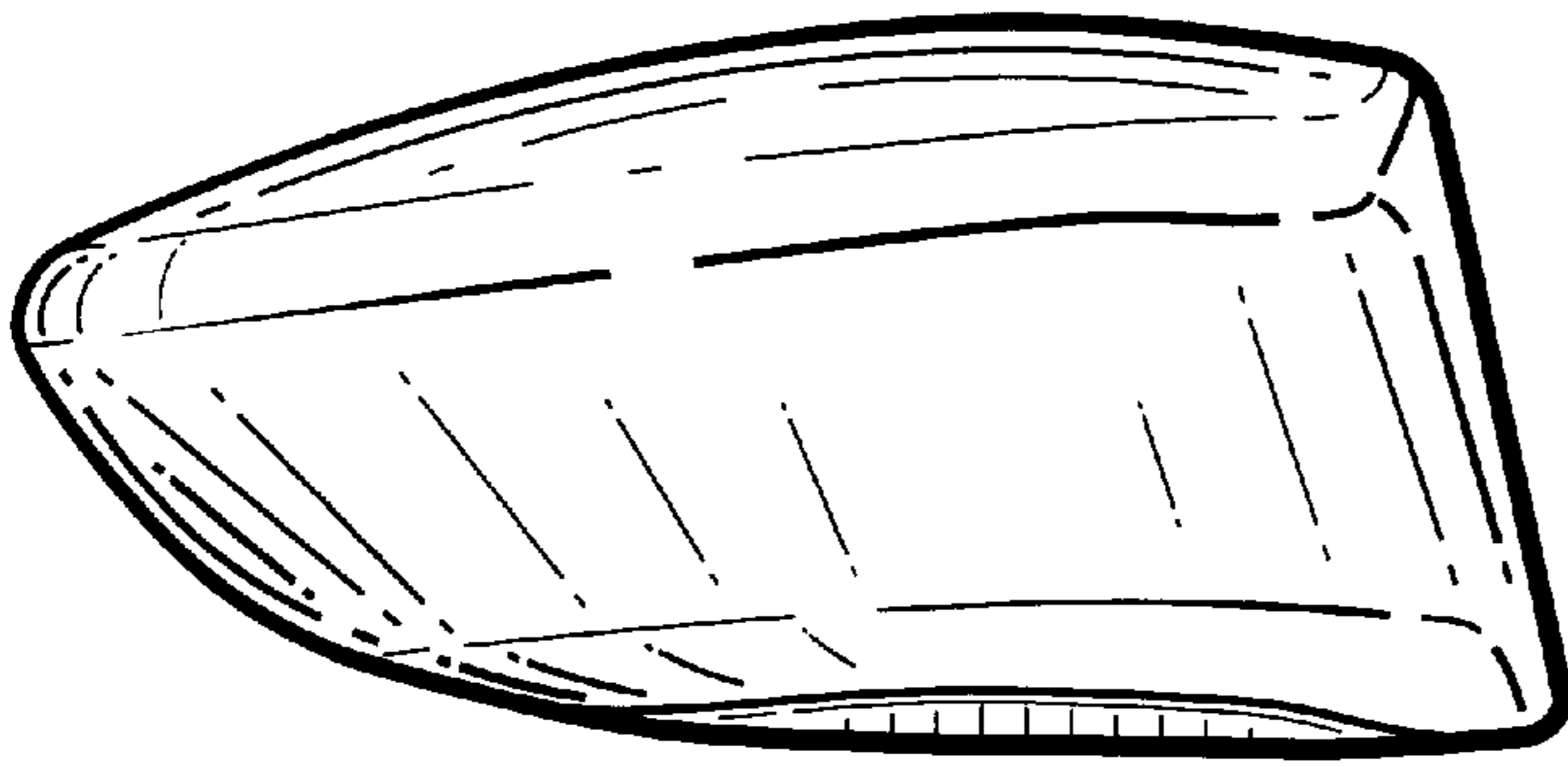

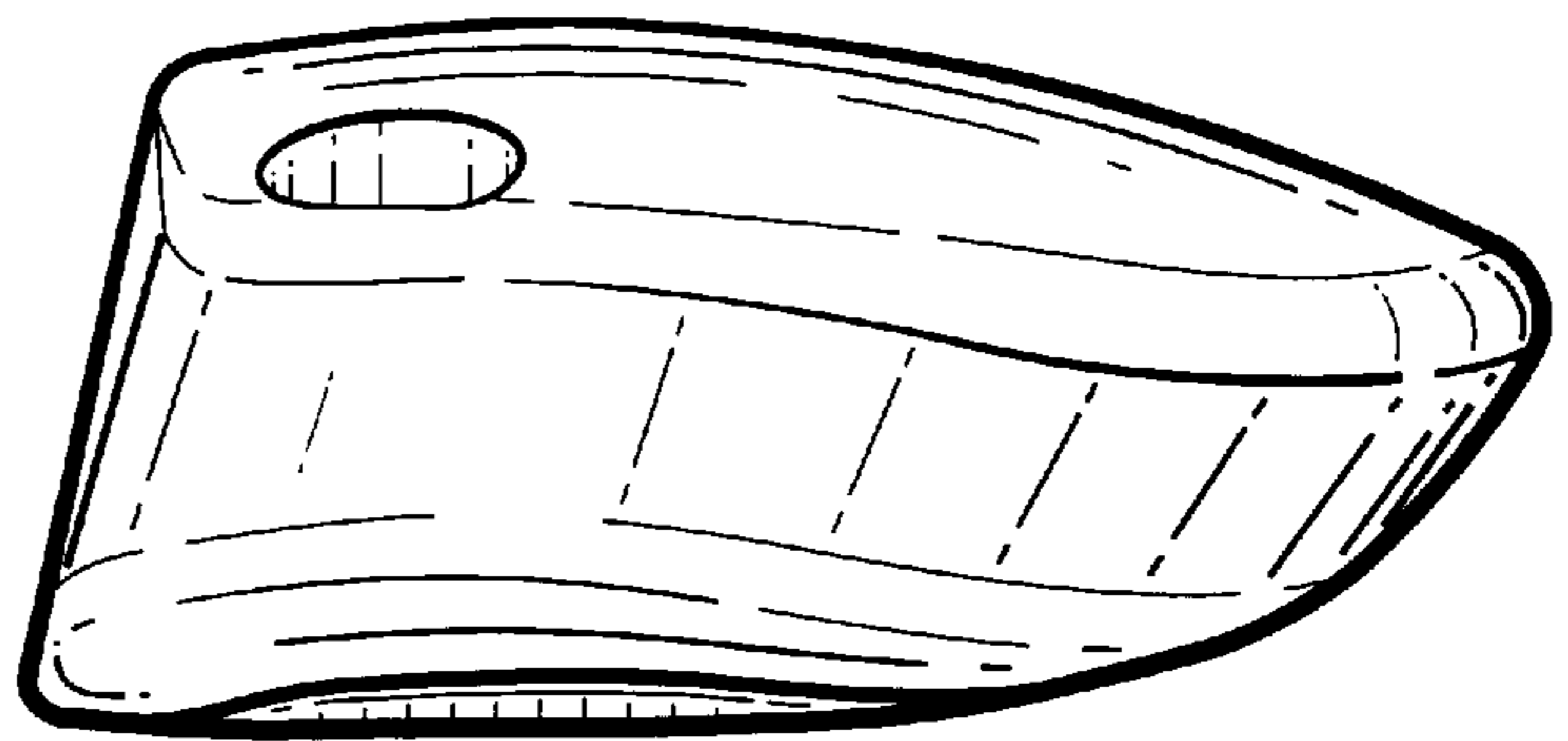

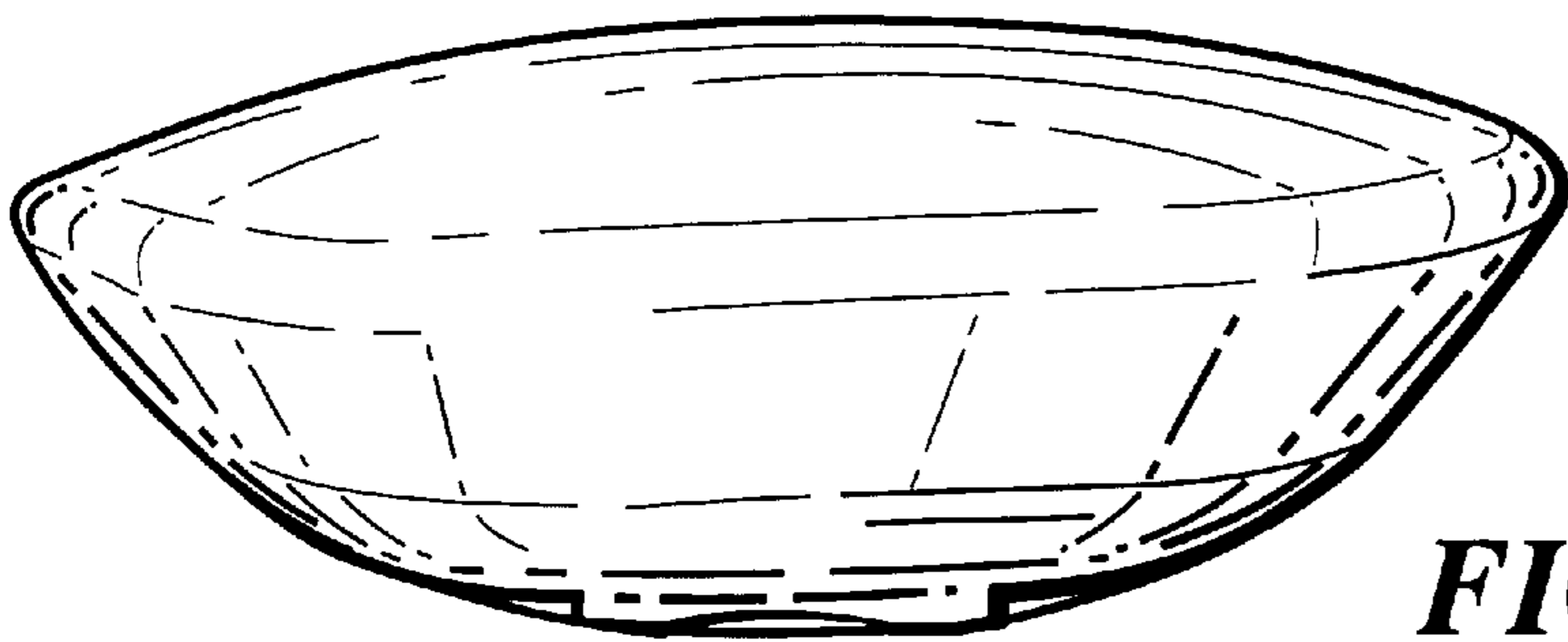

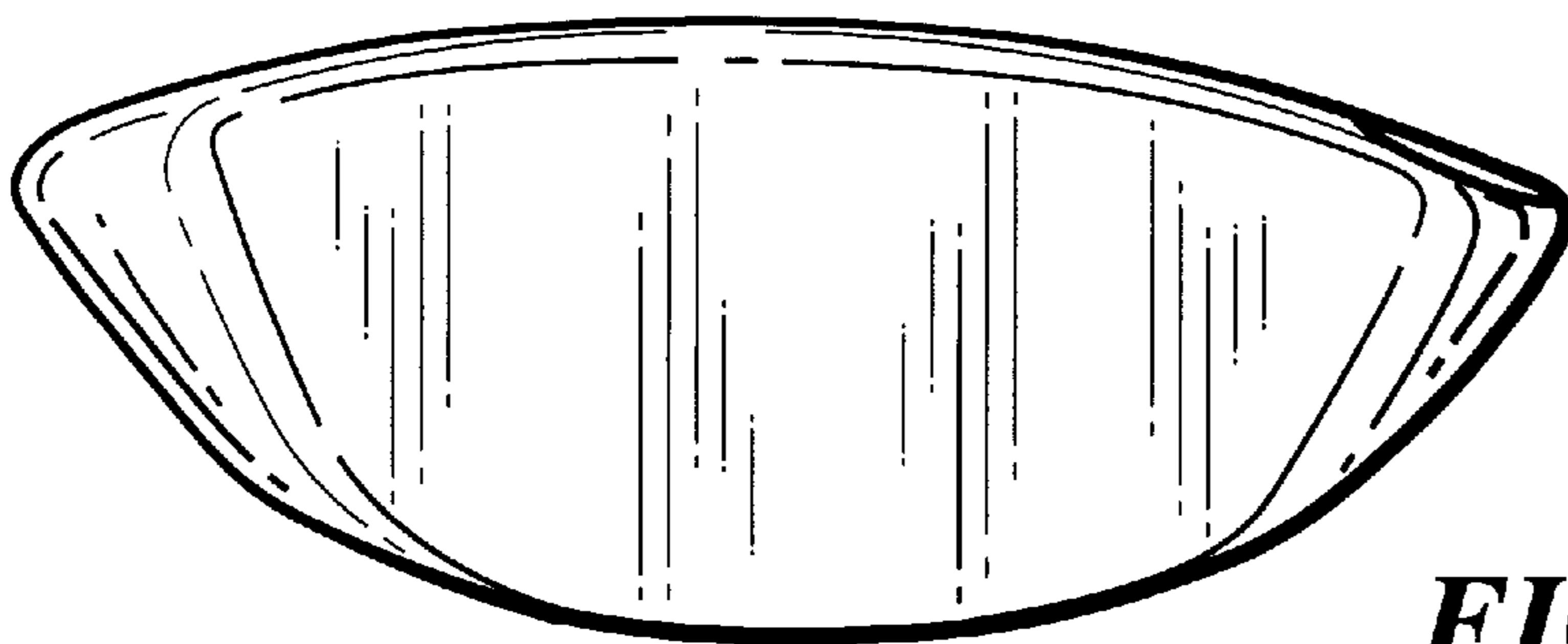
